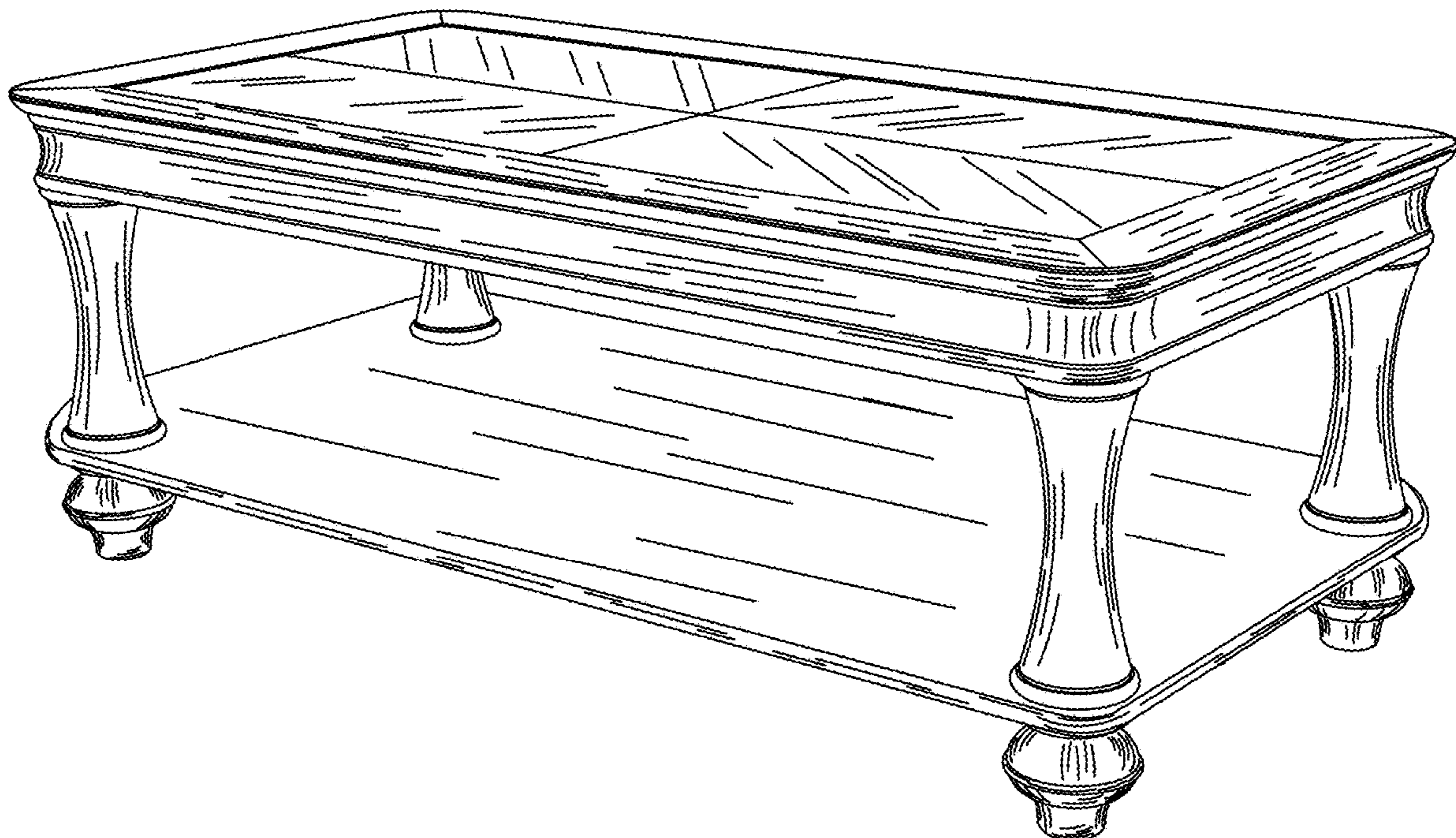
(57) **CLAIM**

The ornamental design for a coffee table, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right side perspective view of a coffee table showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a top, front, right side perspective view of a second embodiment of a coffee table shown broken away, that being the only difference from the embodiment shown in FIGS. 1-7. The appearance of any portion of the coffee table between the break lines forms no part of the claimed design.

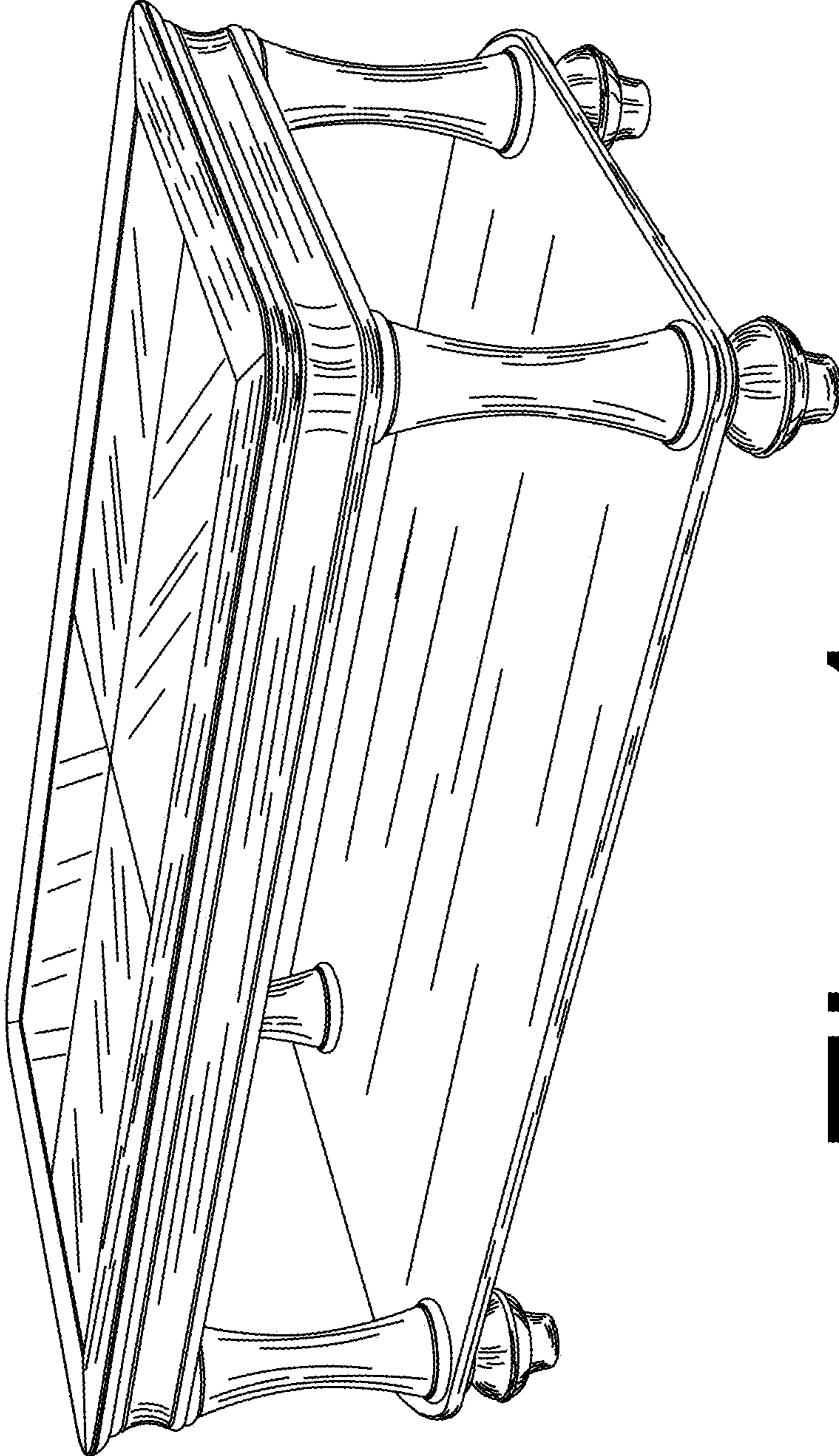

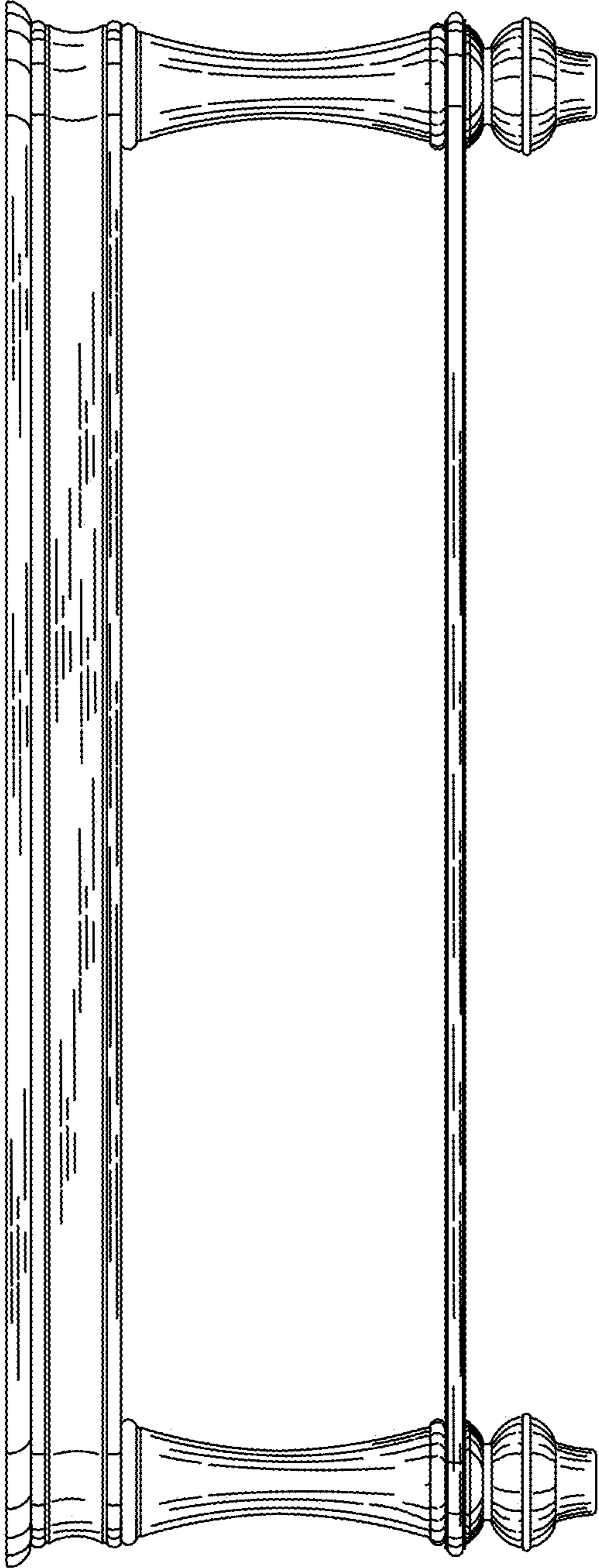

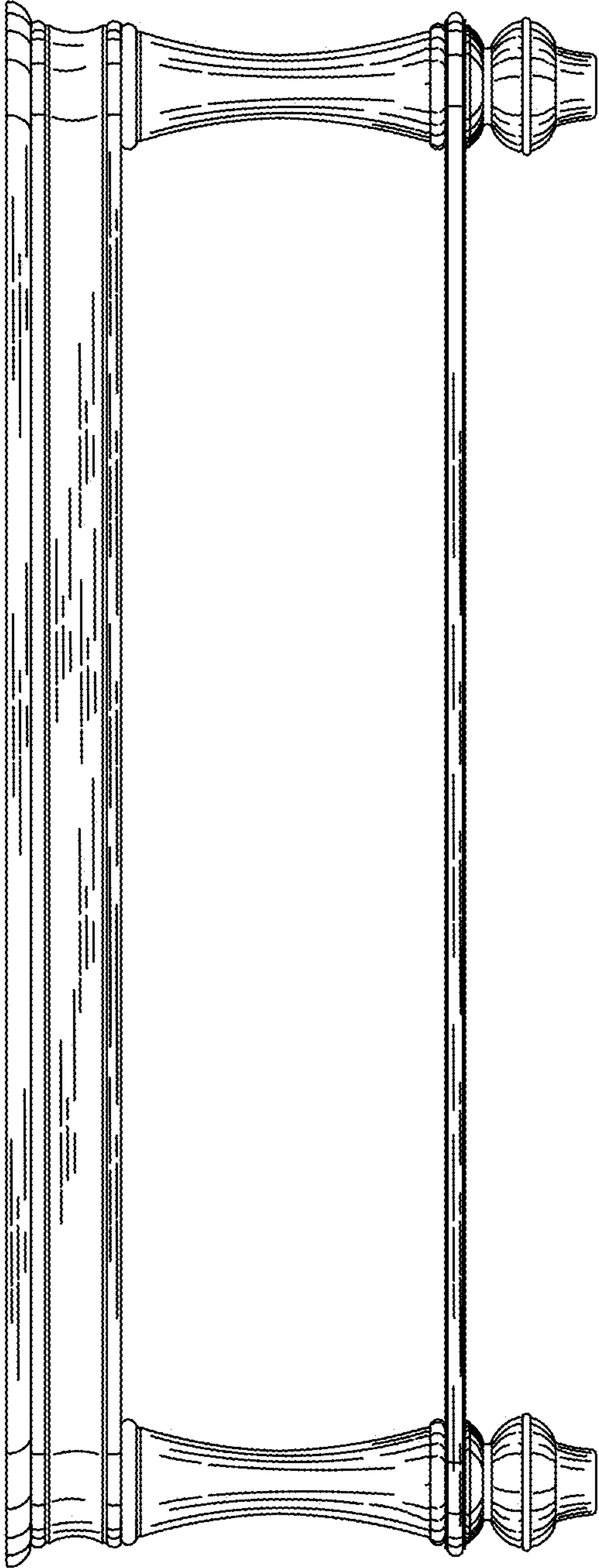

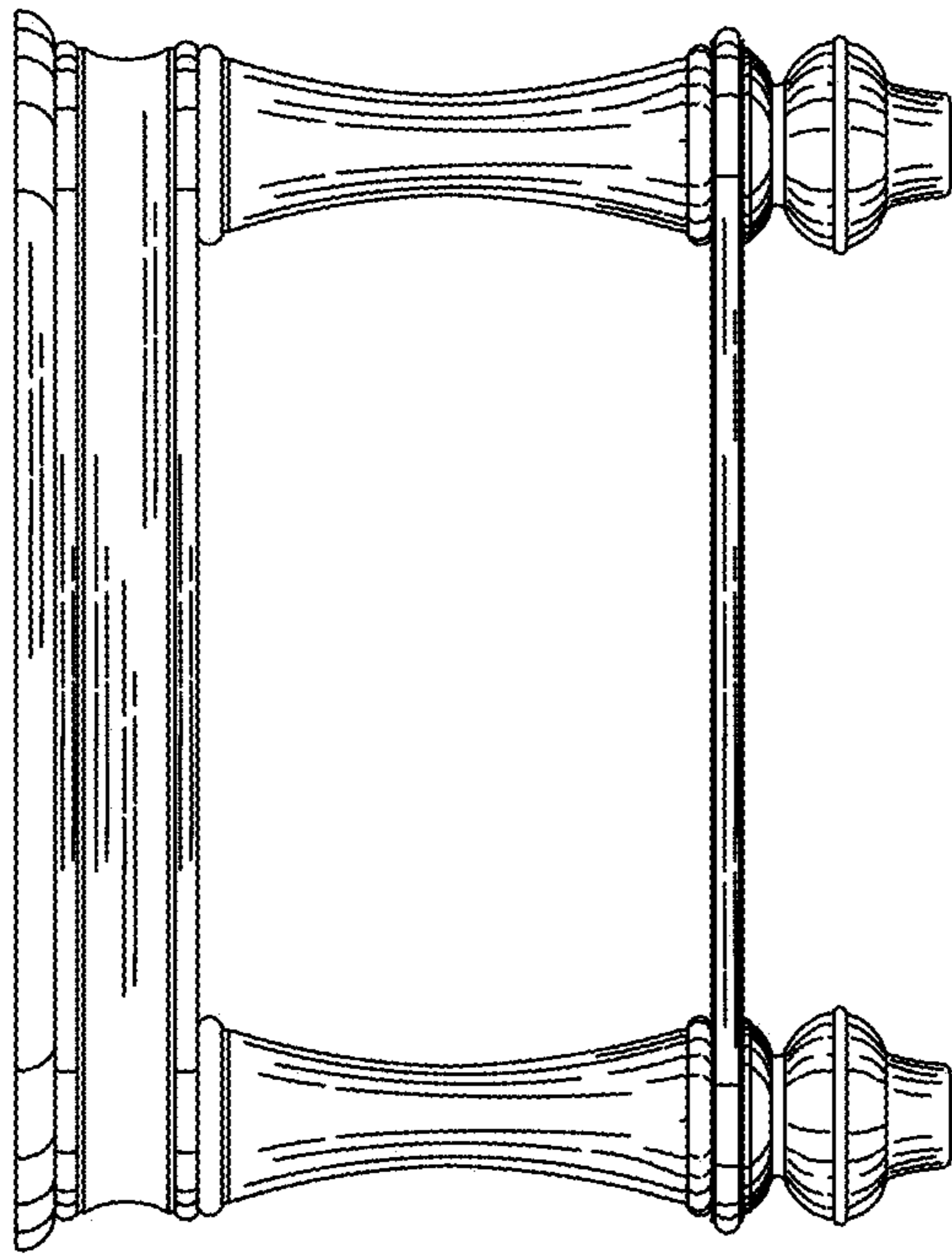

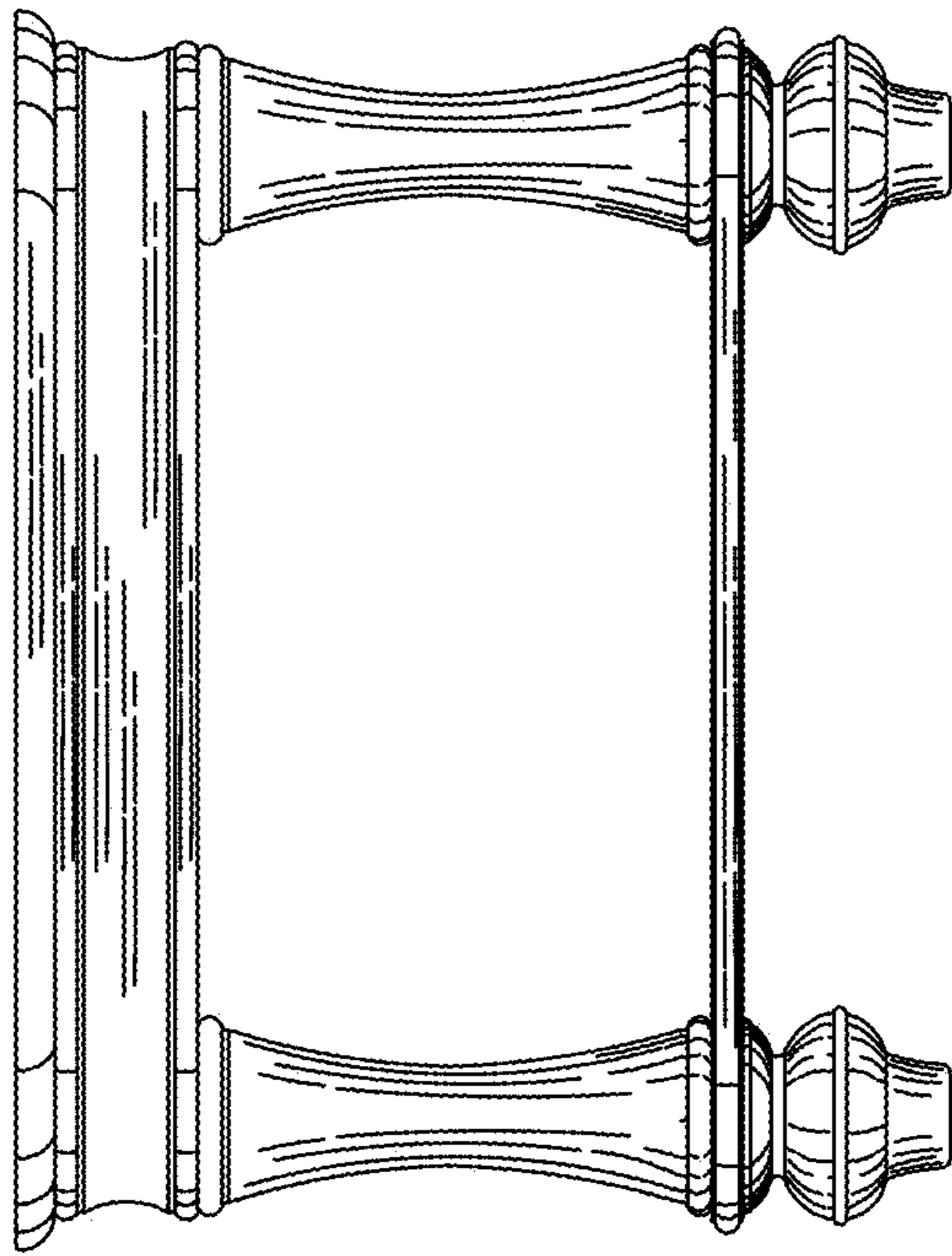

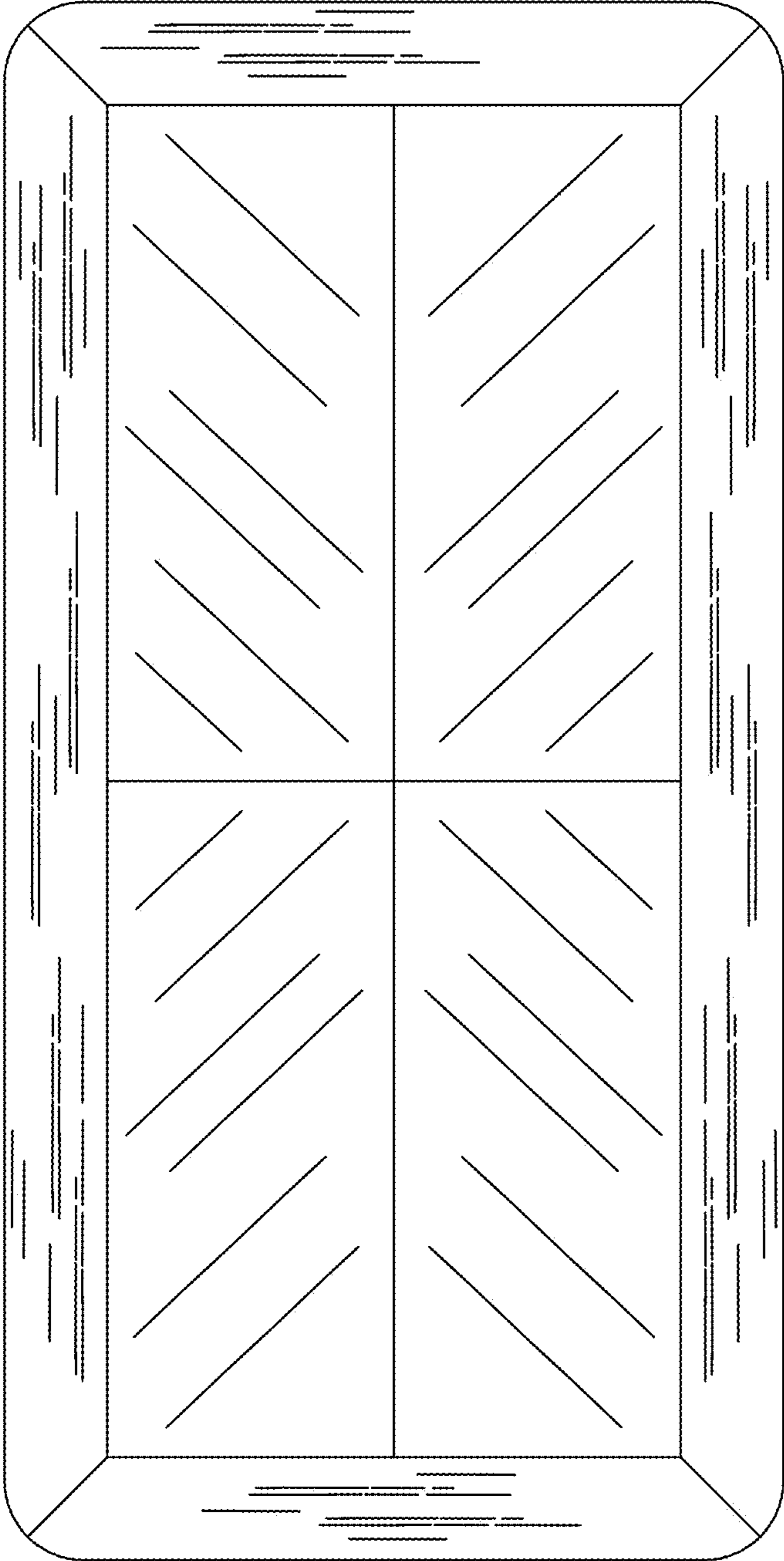

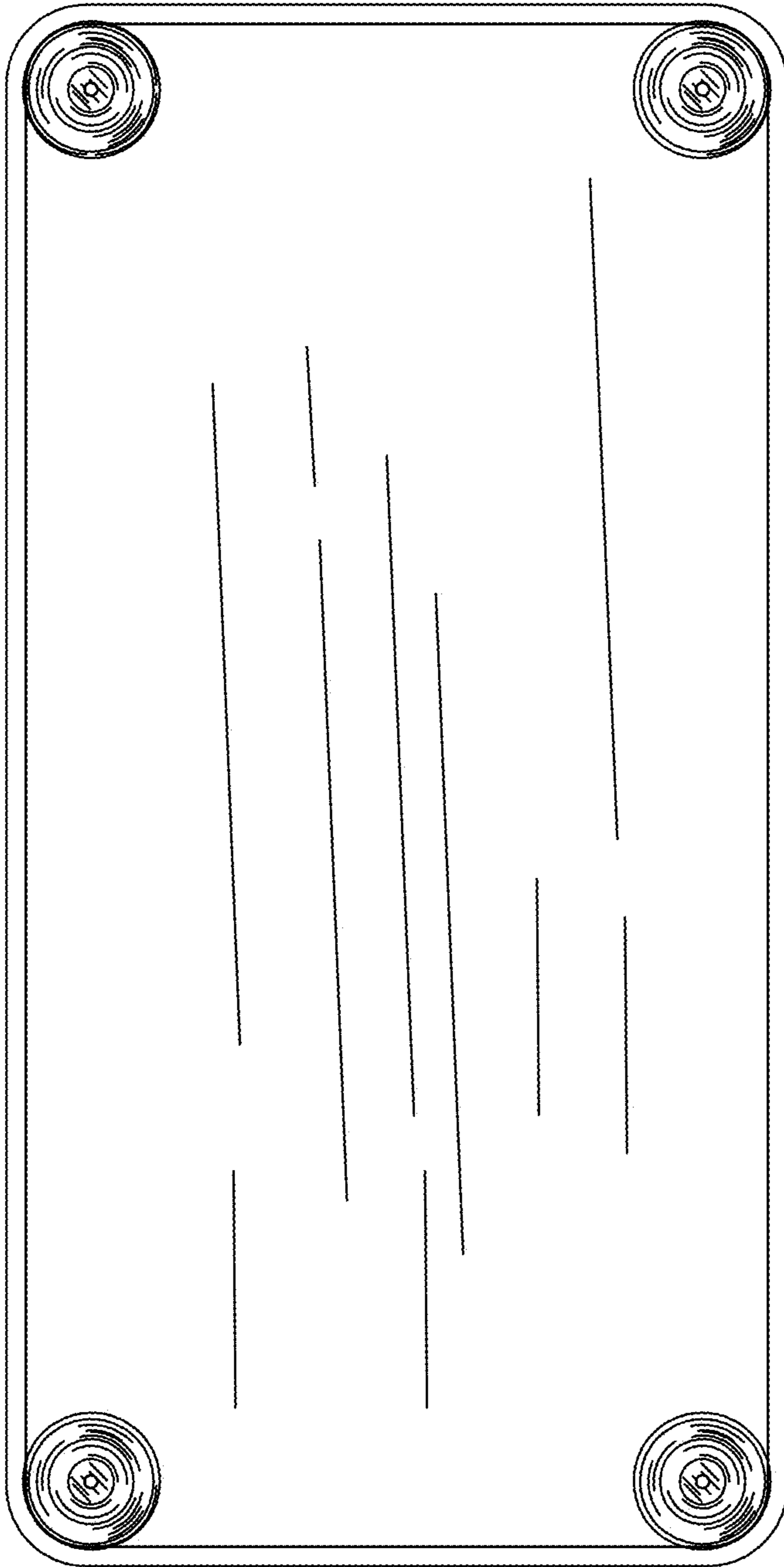

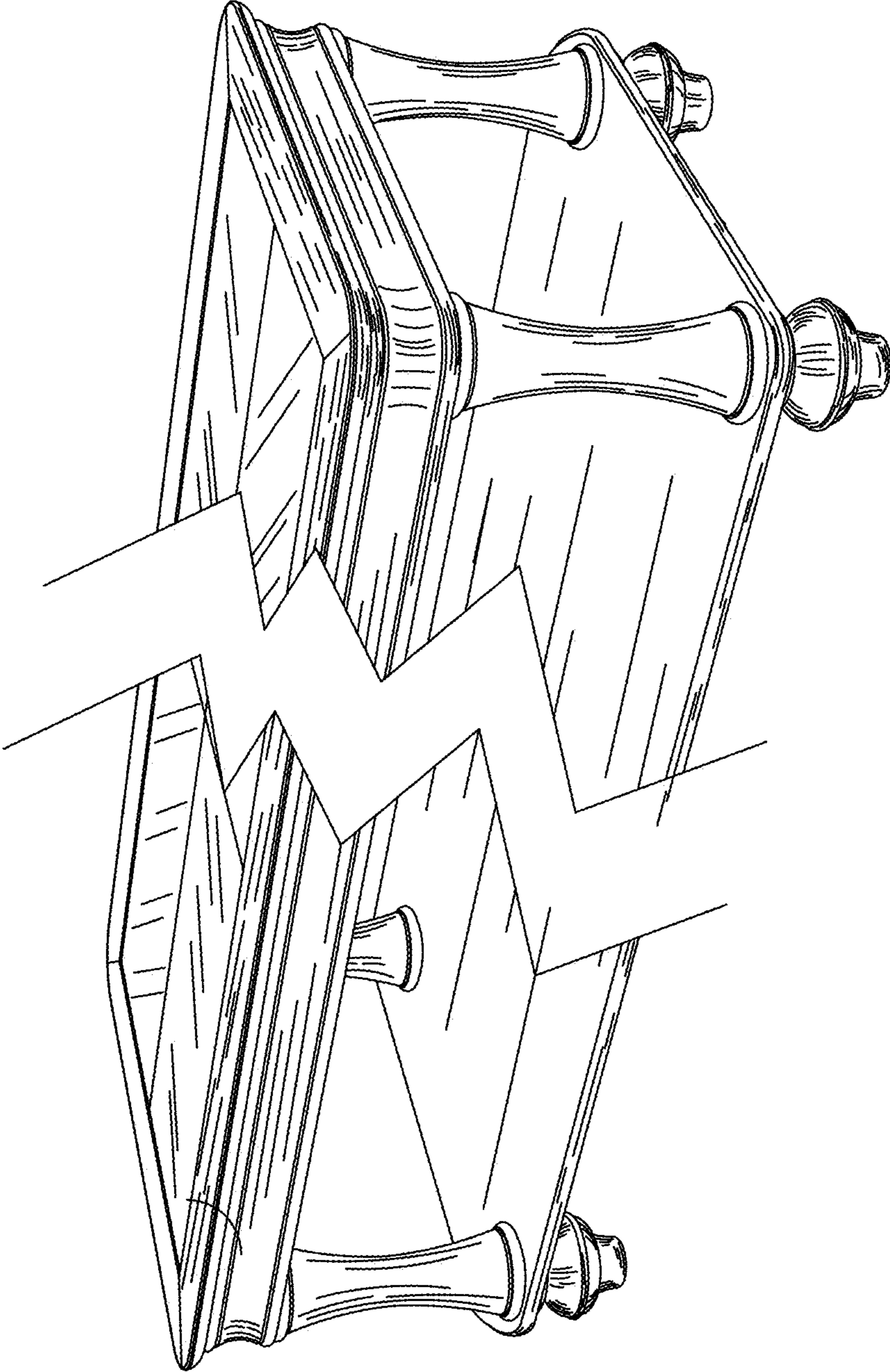
