The ornamental design for a rectangular baking pan, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of another embodiment of the rectangular baking pan.

FIG. 2 is a front view thereof, the opposite rear view being a mirror image thereof.

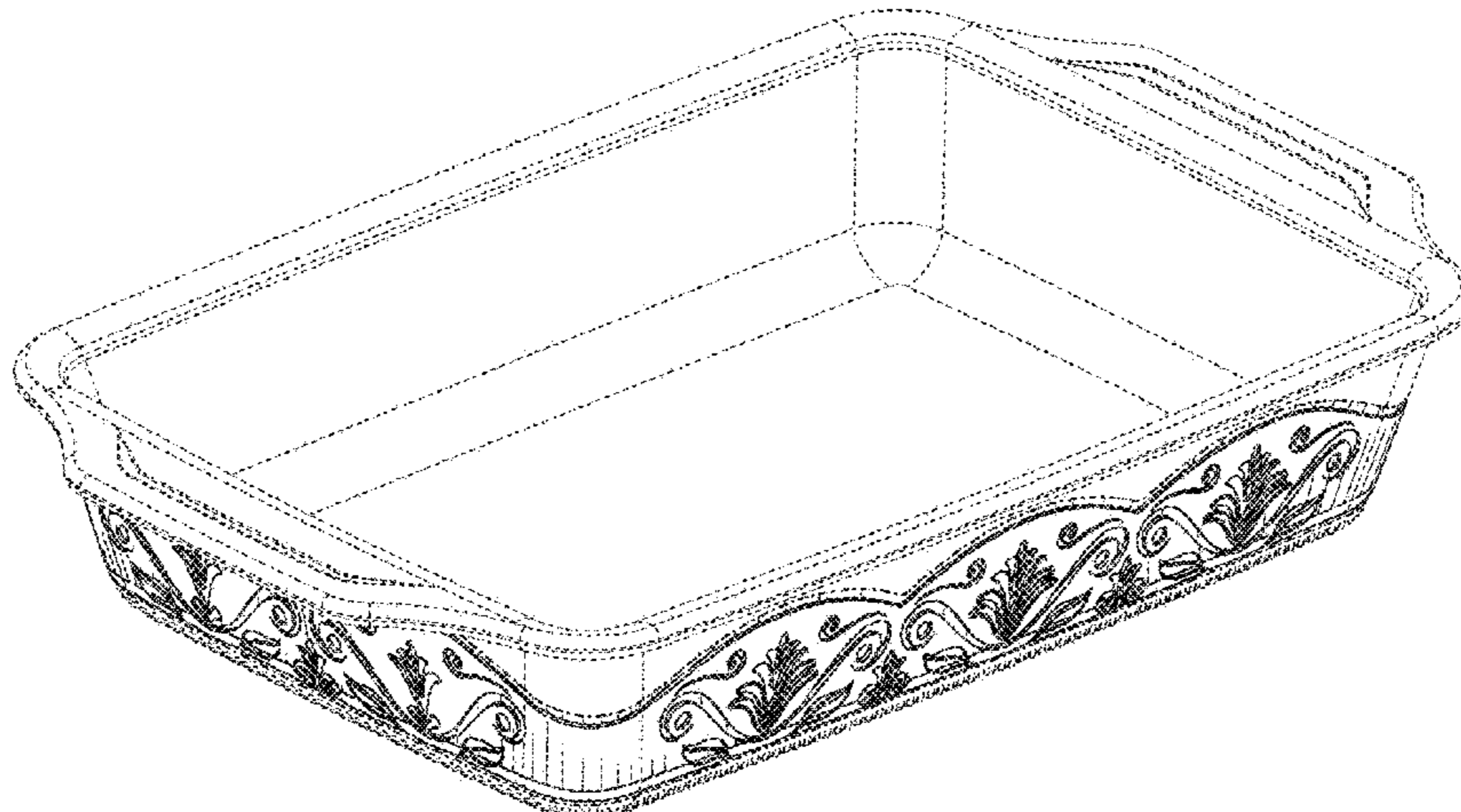
FIG. 3 is a side view thereof, the opposite side view being a mirror image thereof.

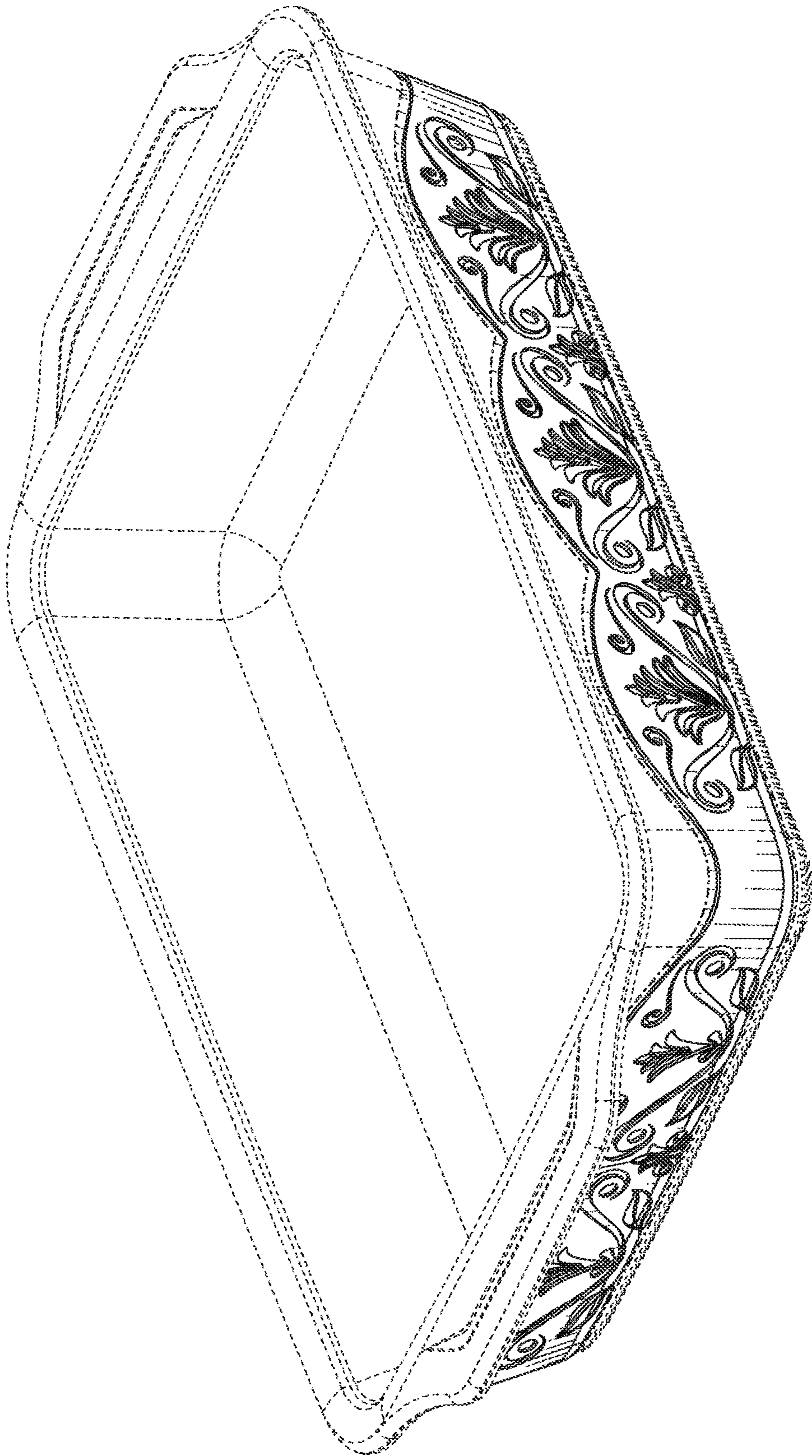

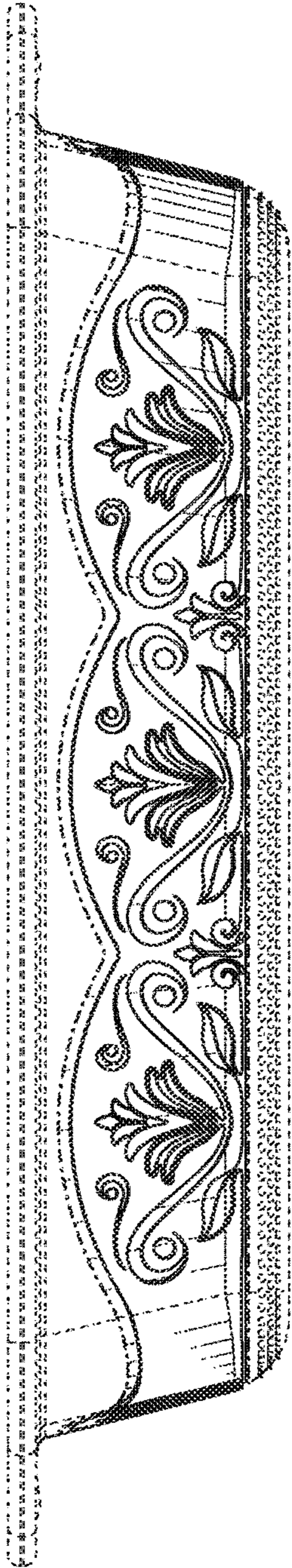

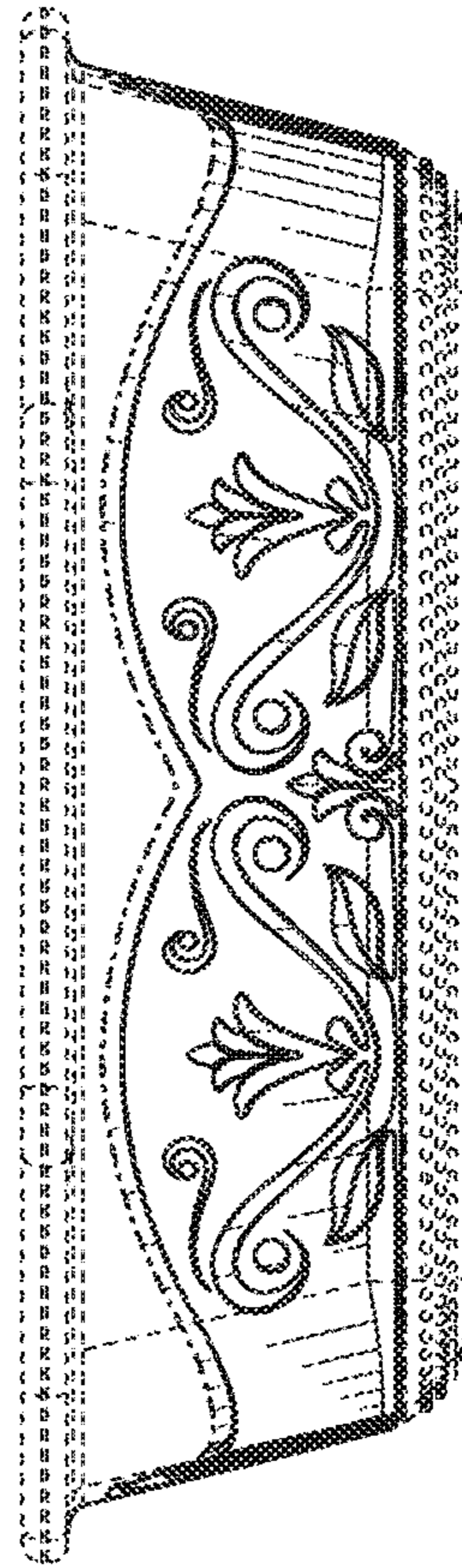

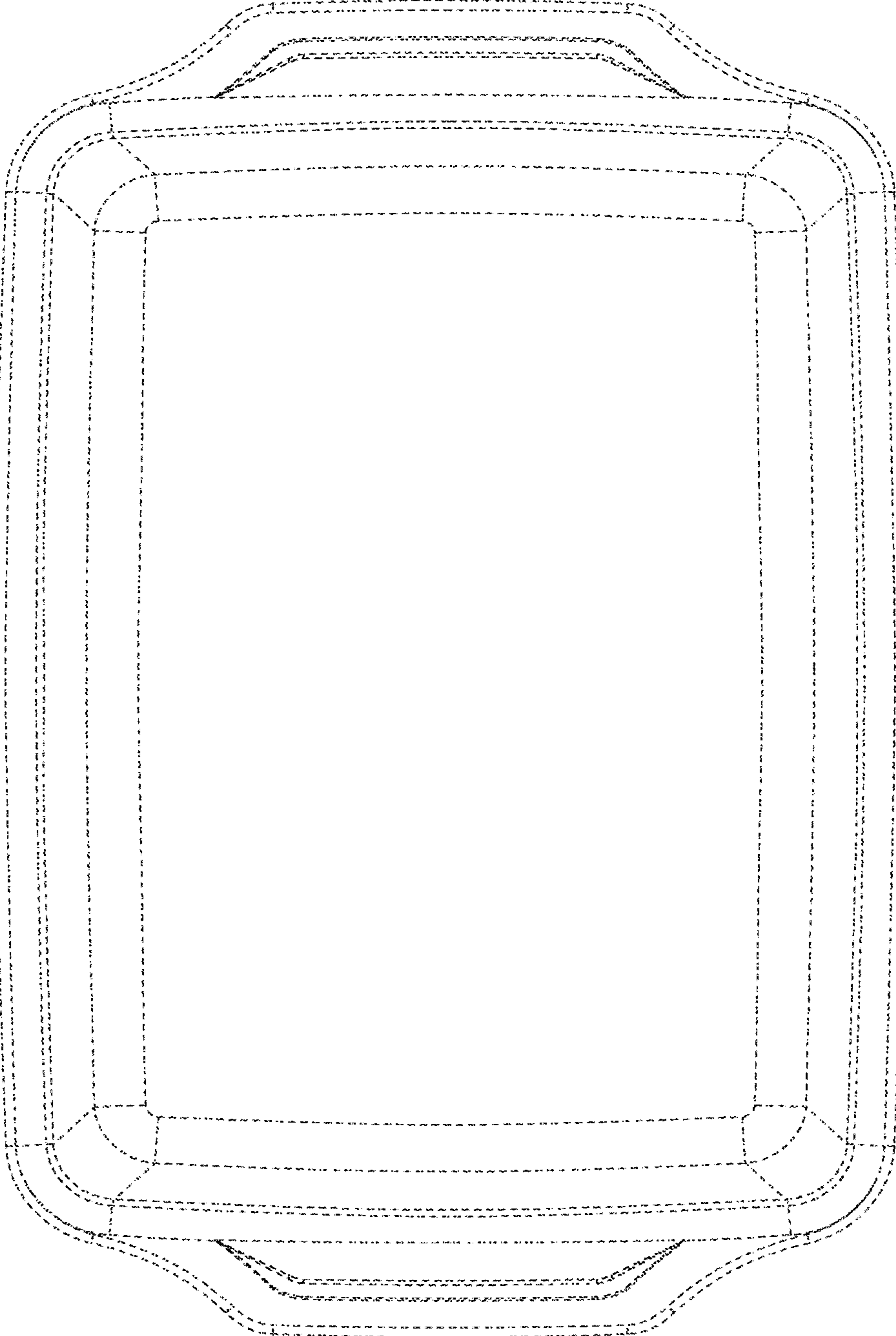

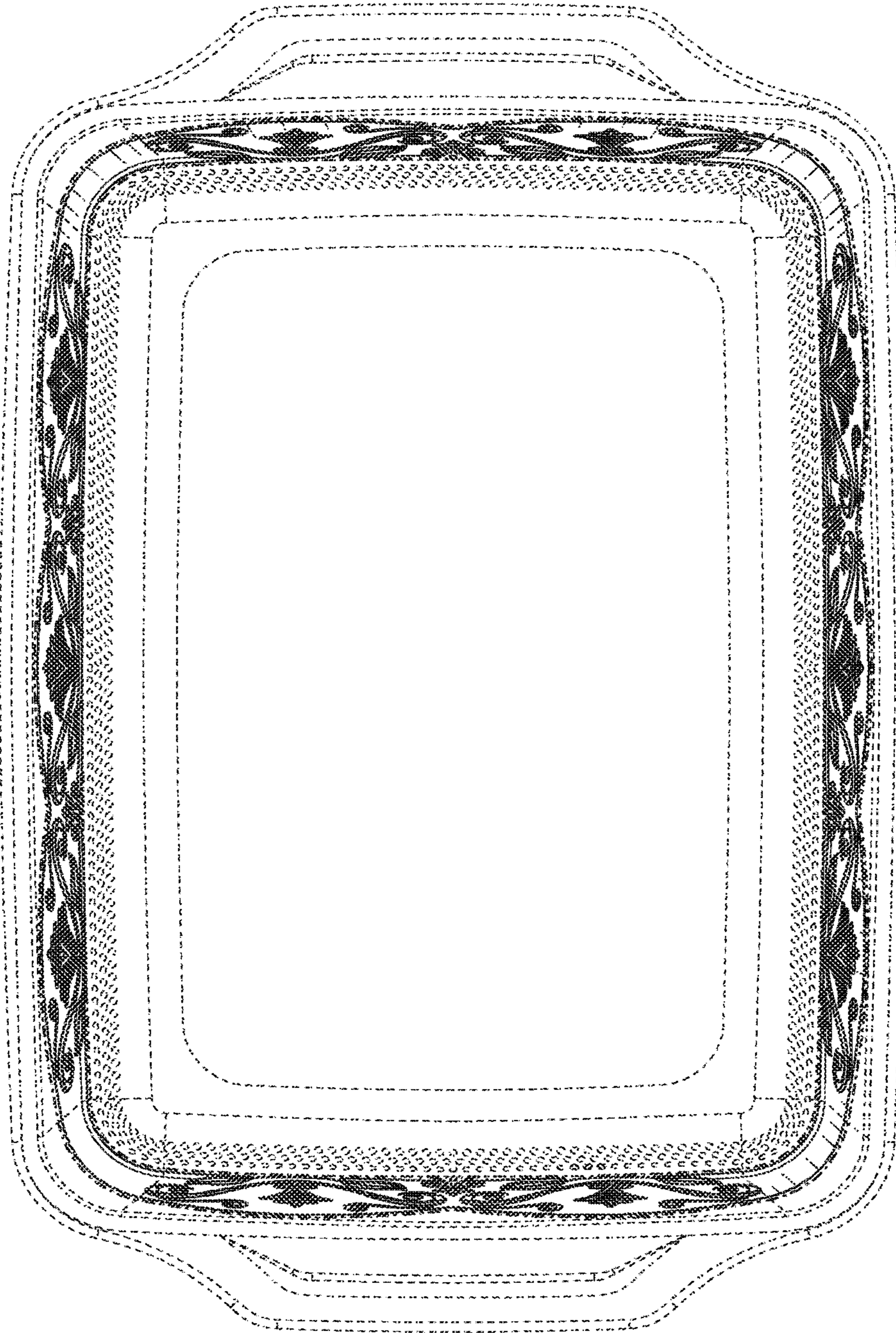
