The ornamental design for a plant sensor system, as shown and described.

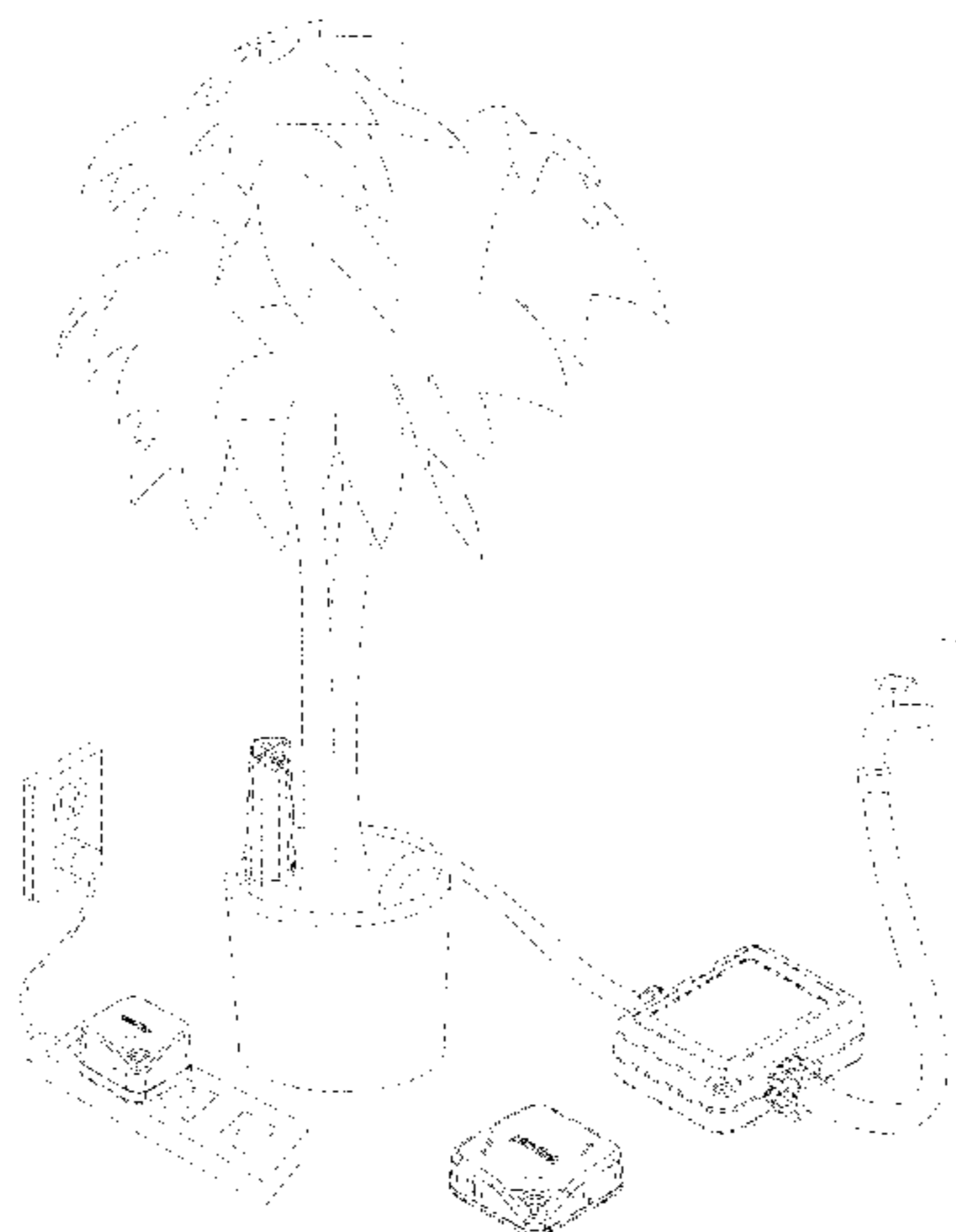
**DESCRIPTION**

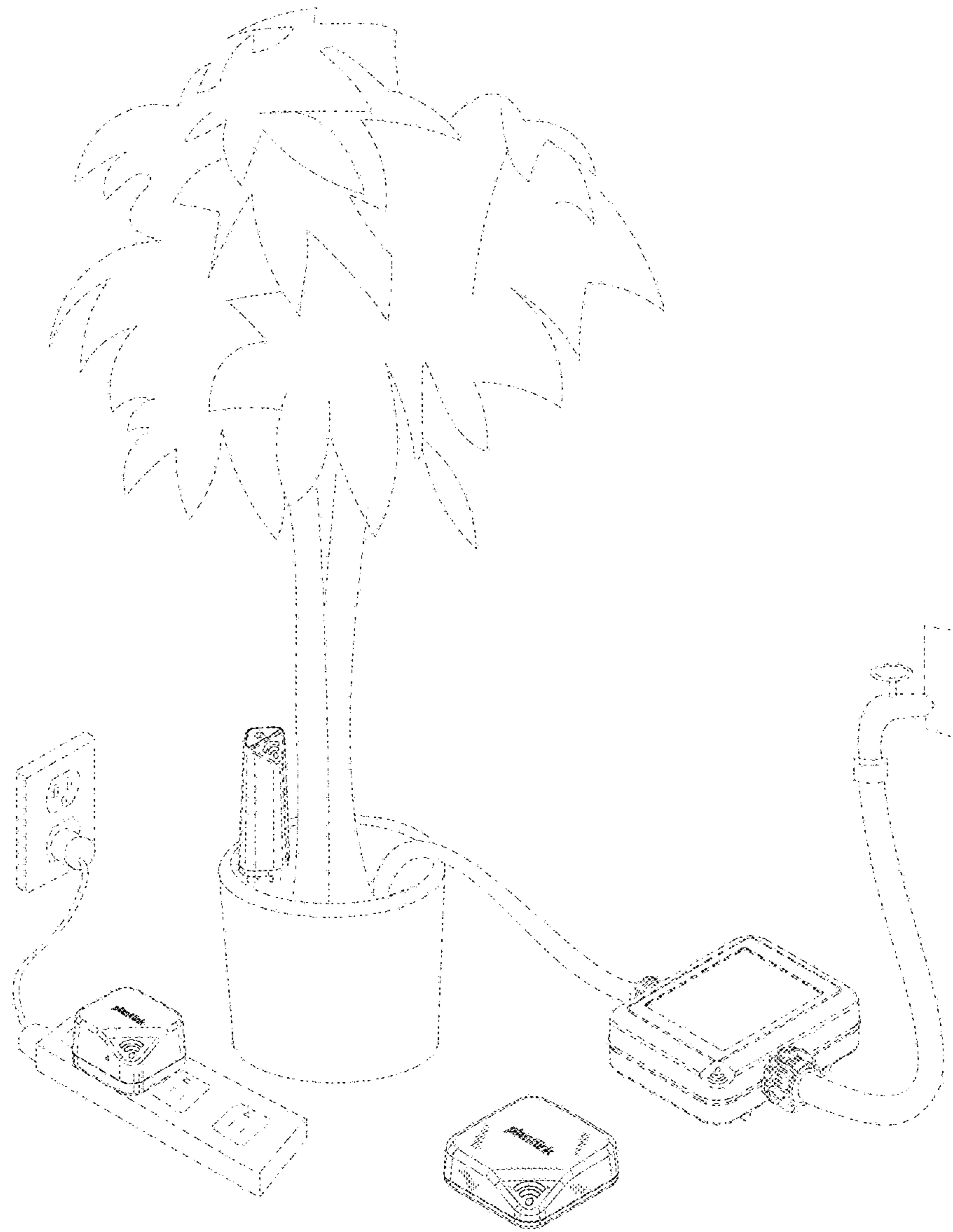

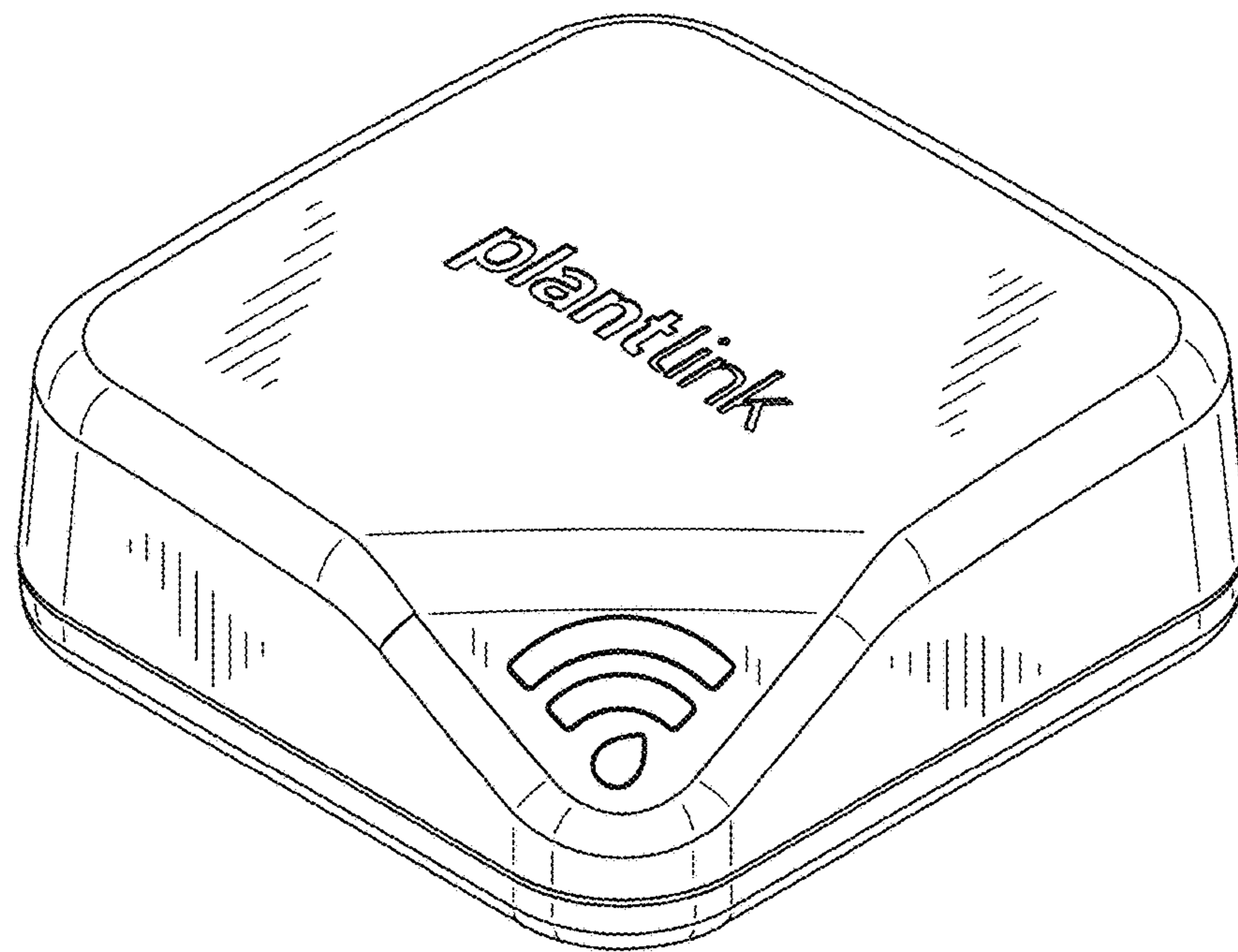

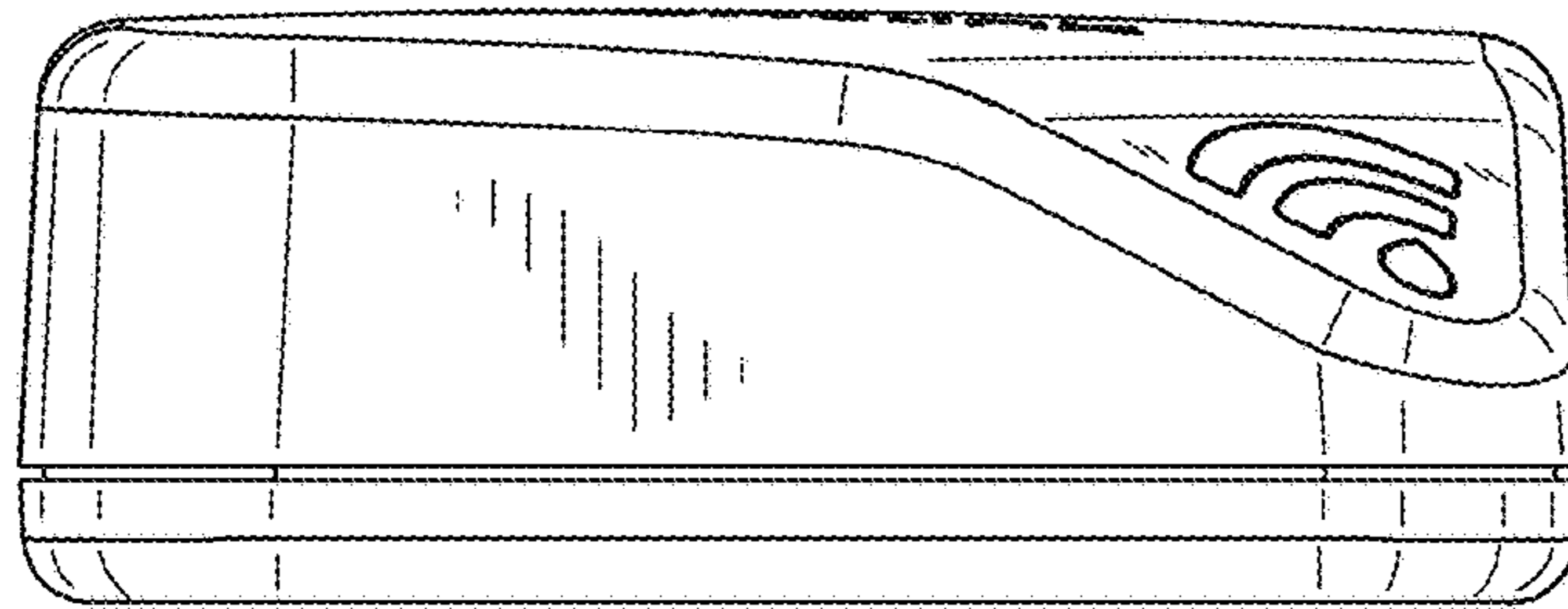

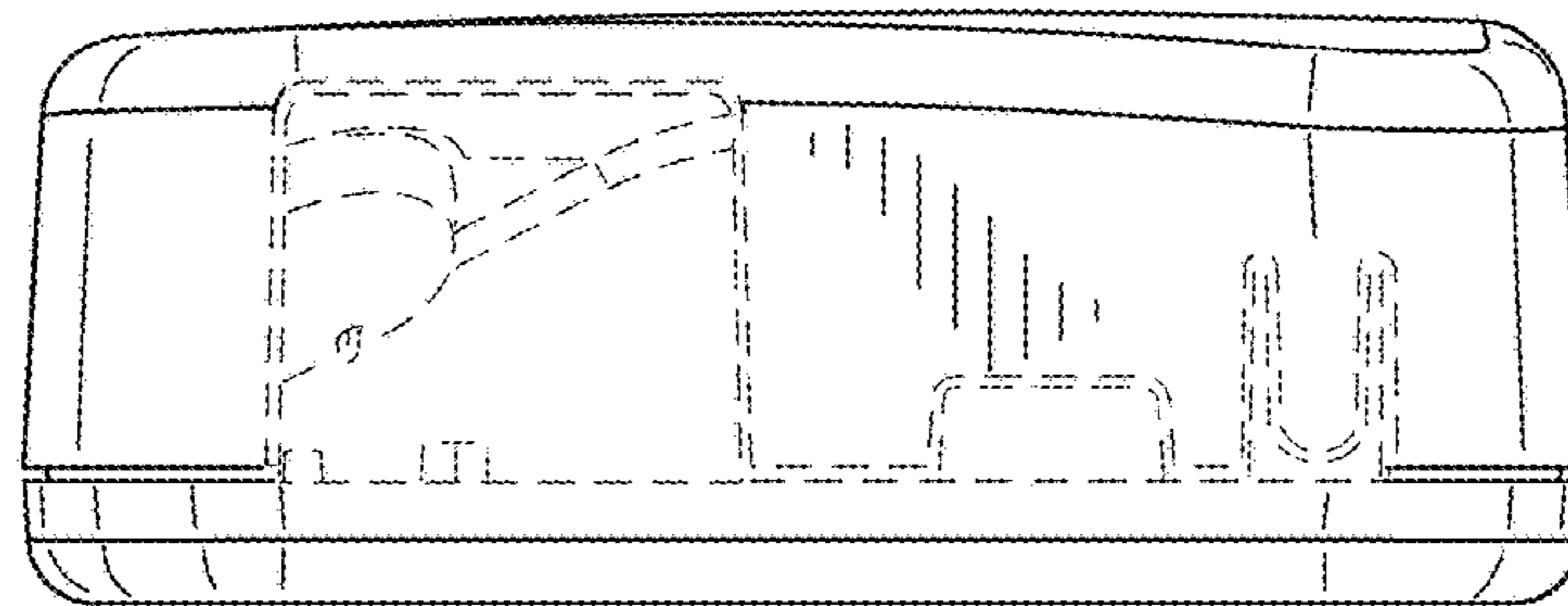

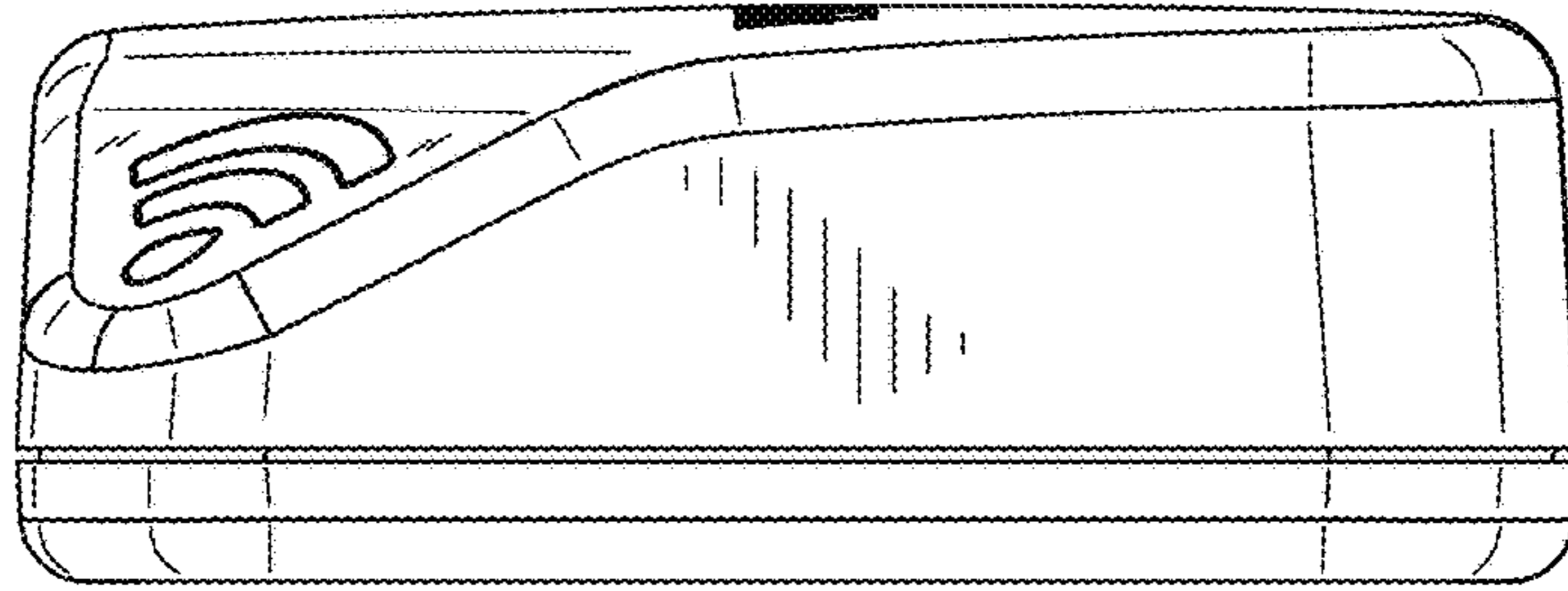

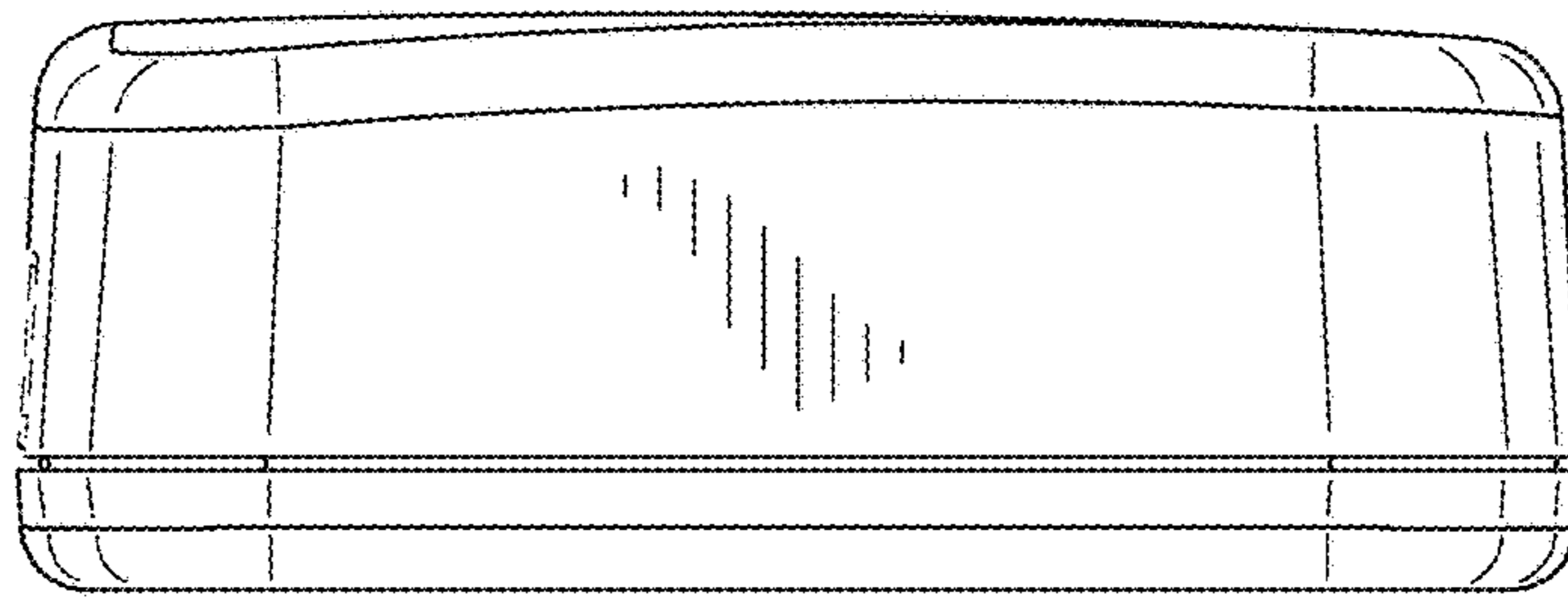

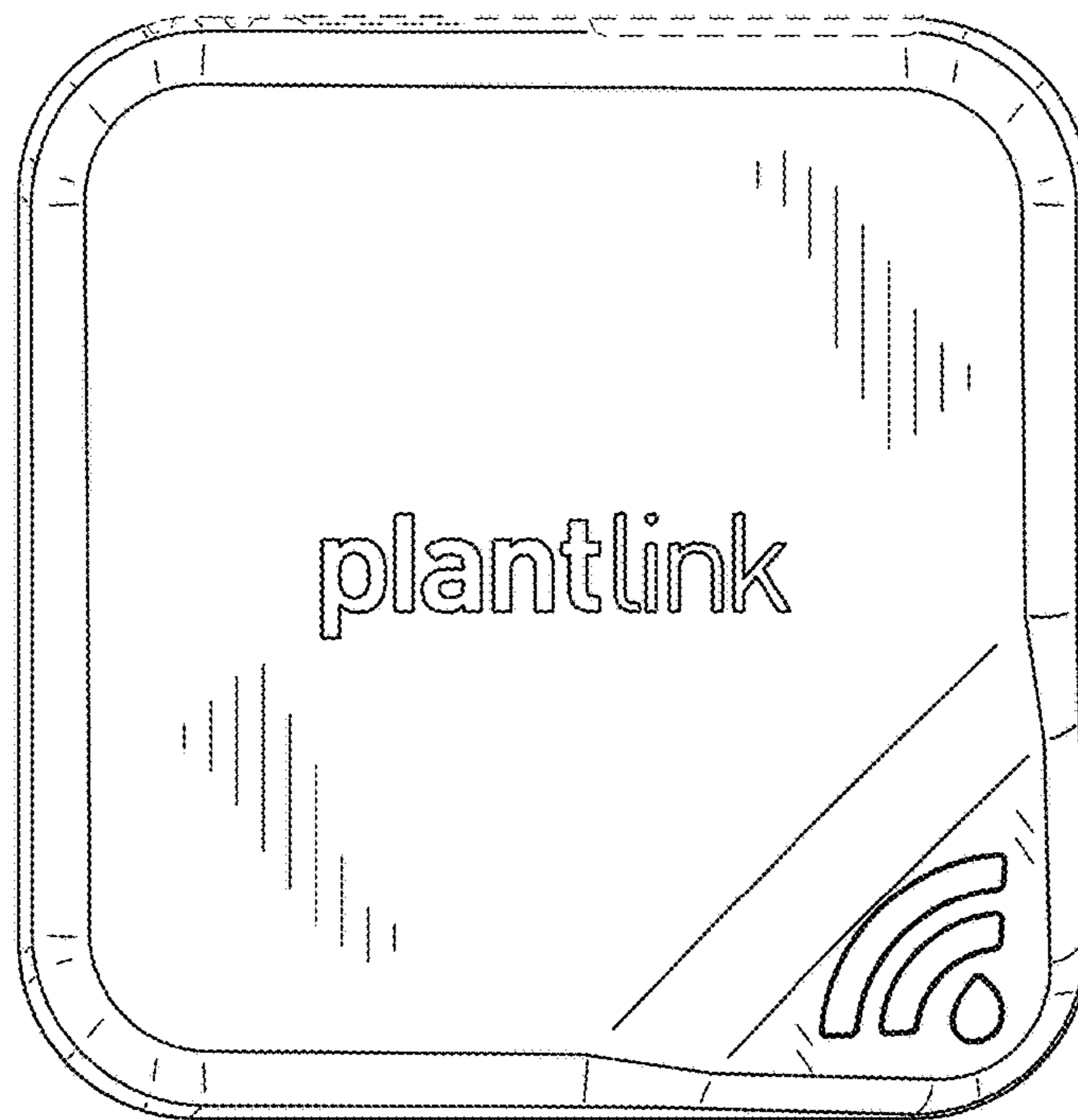

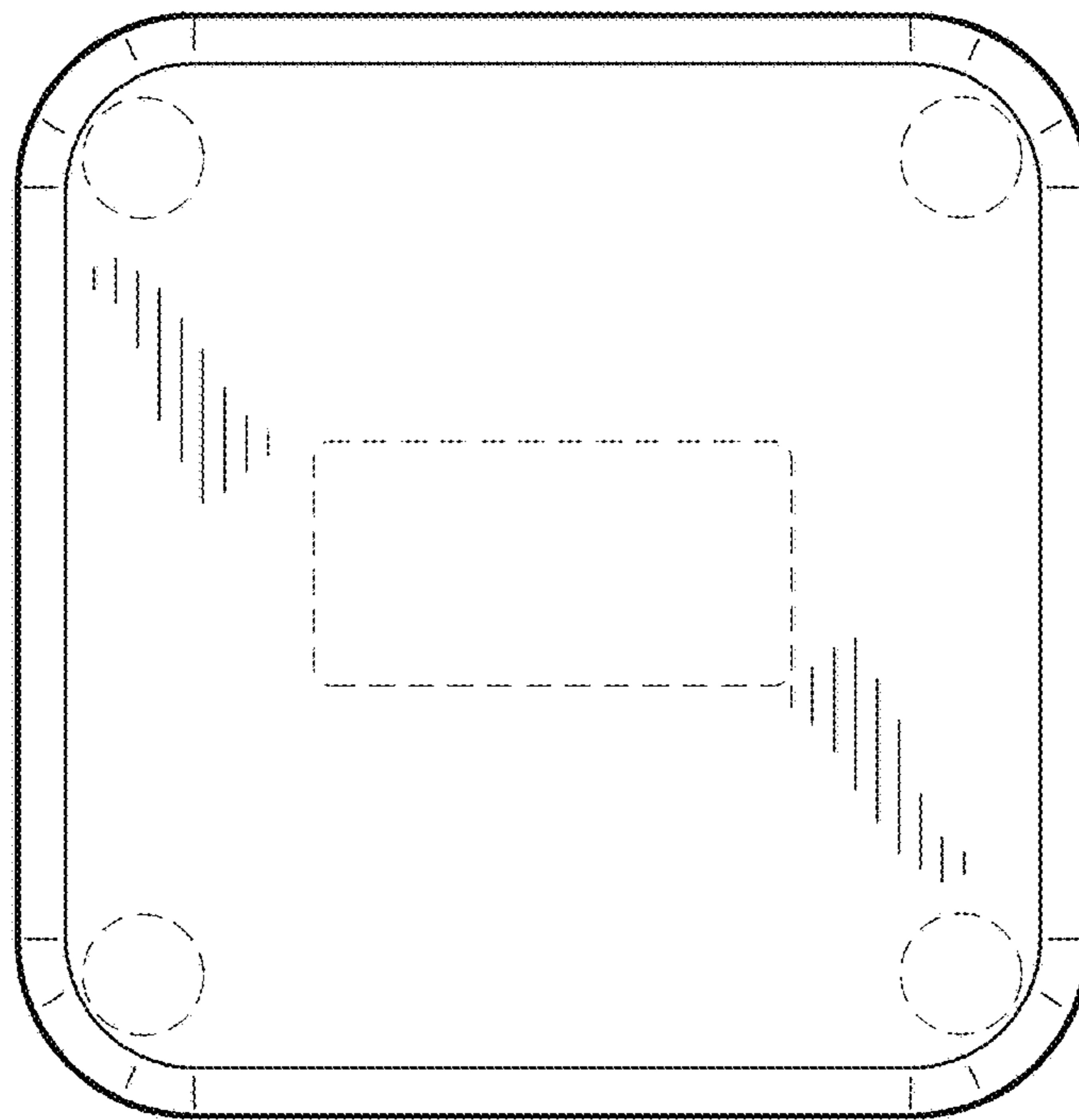

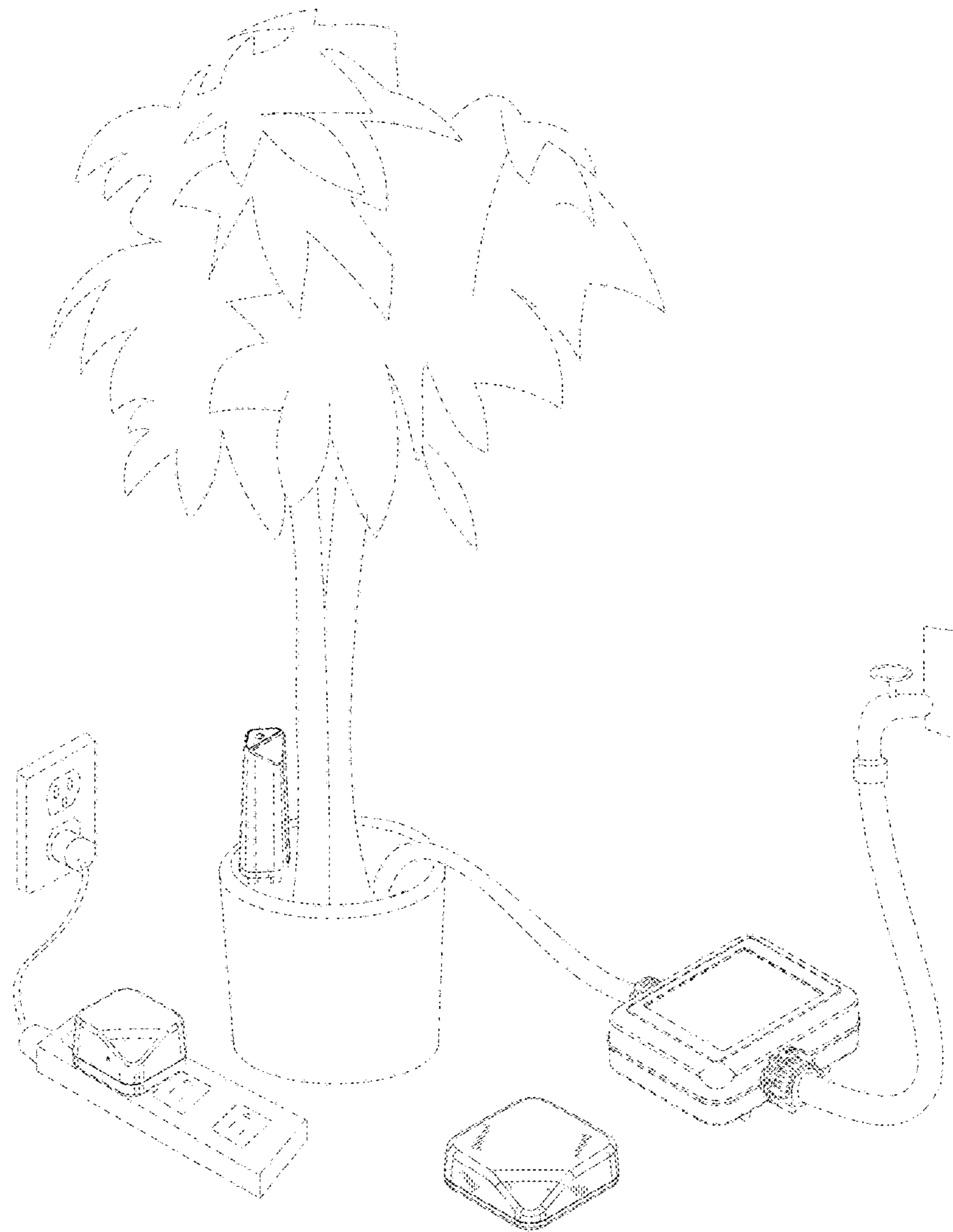

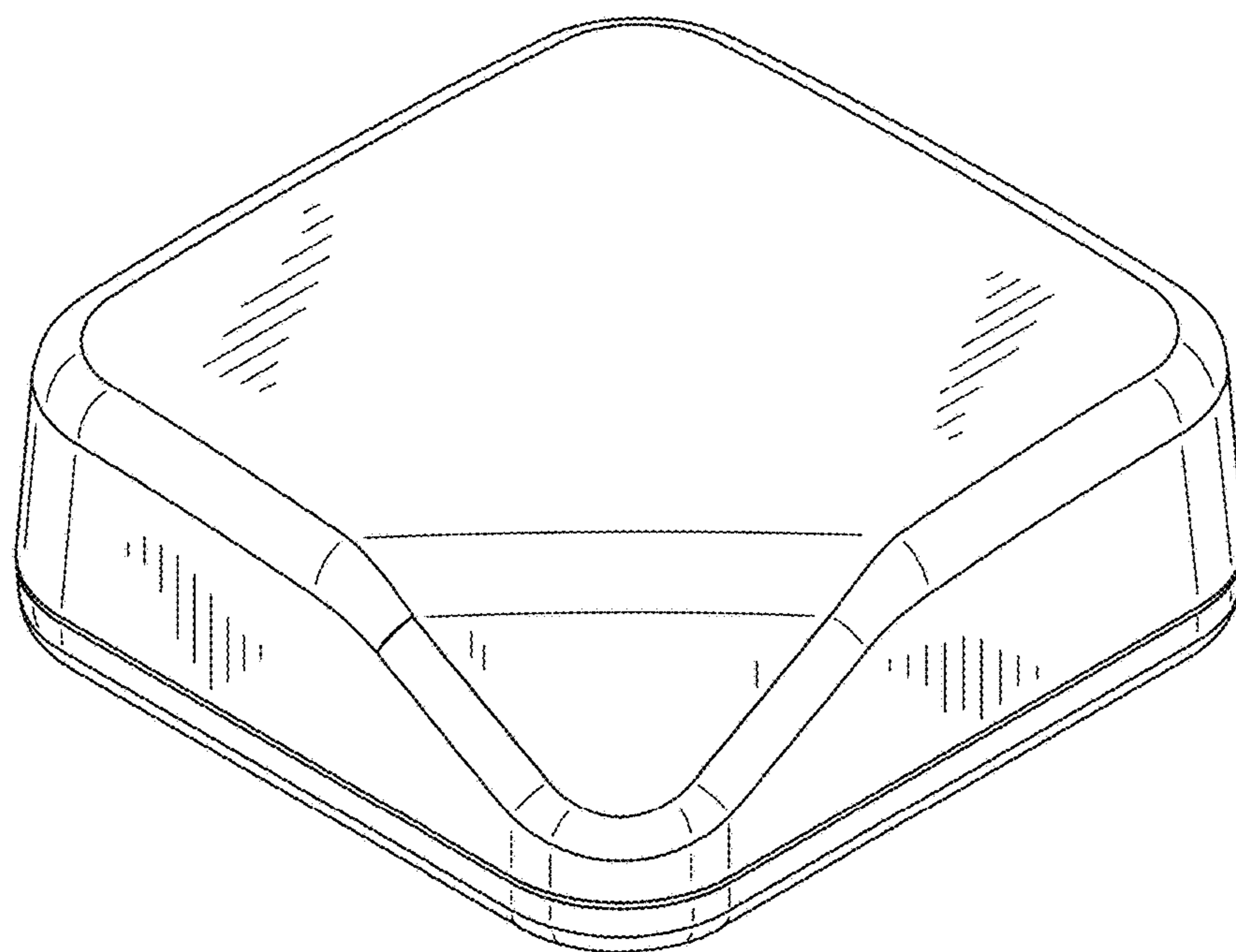

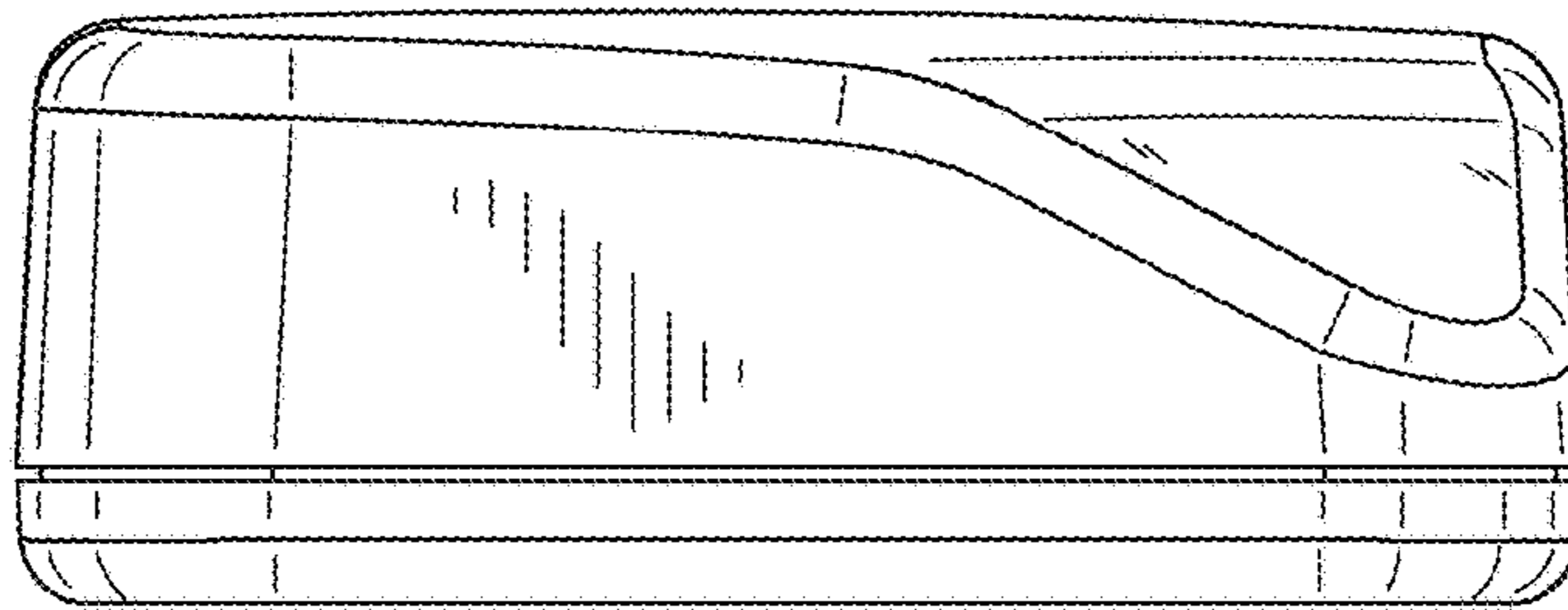

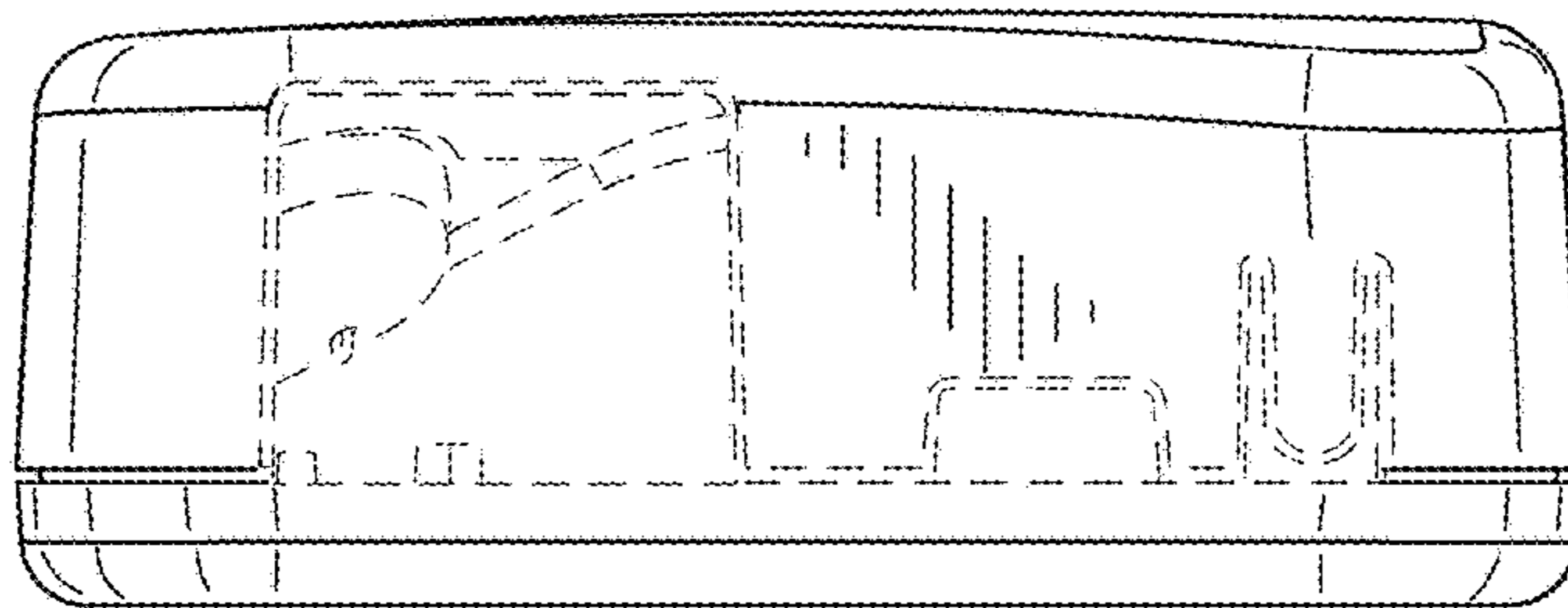

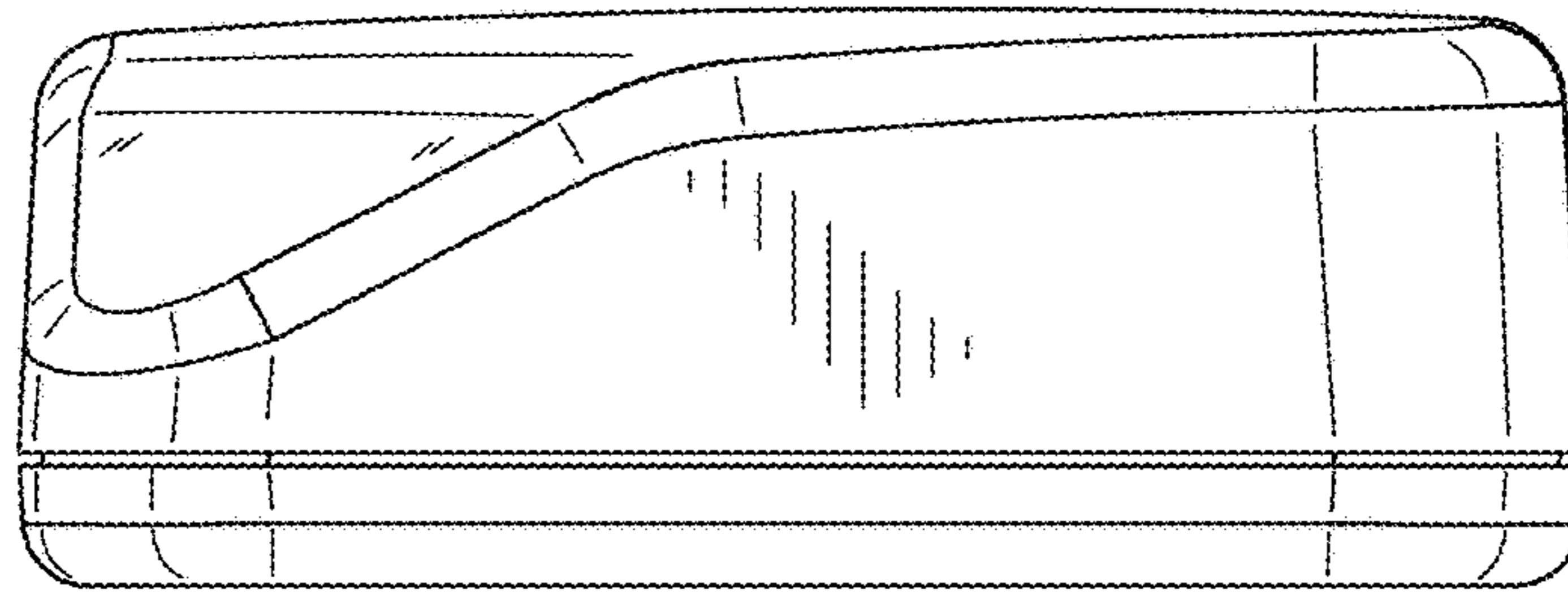

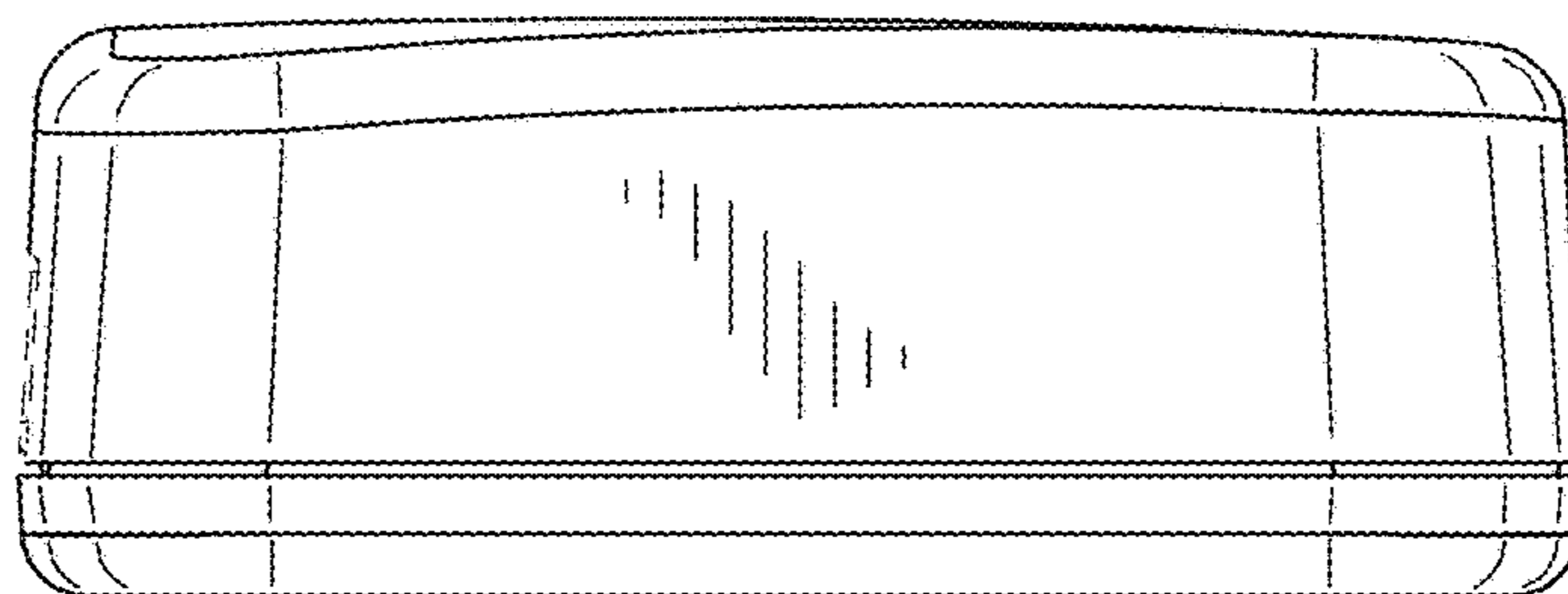

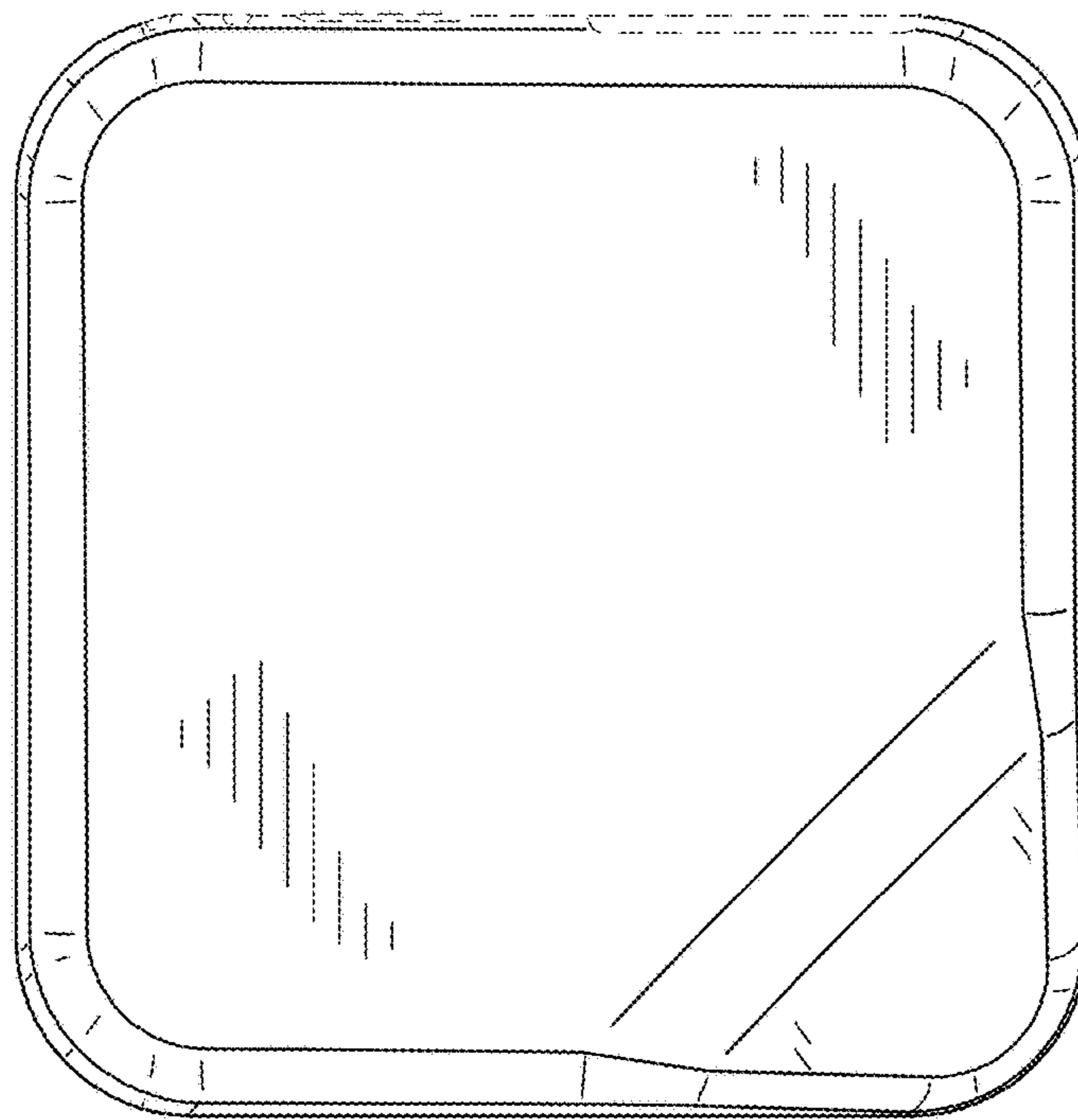

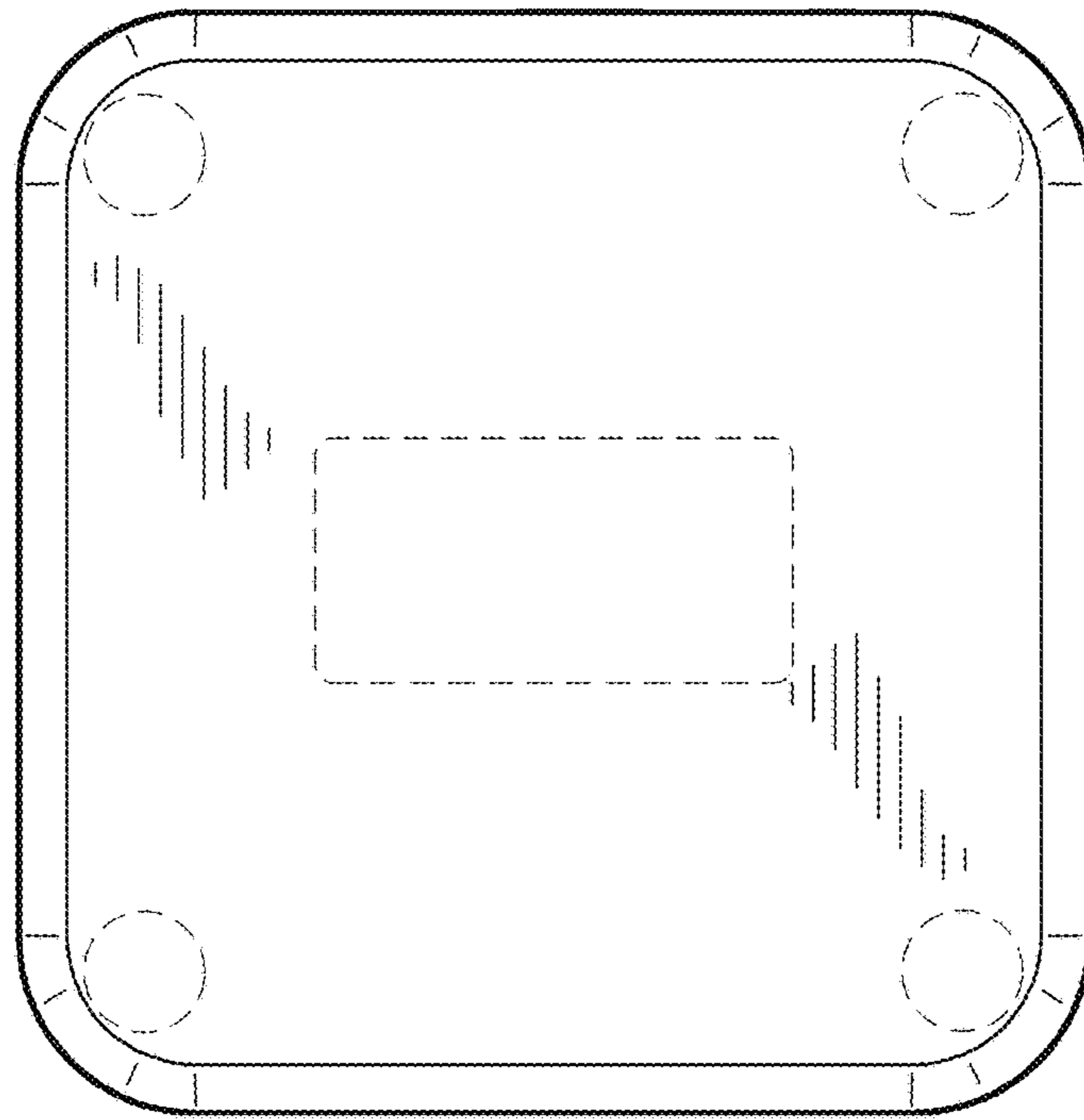
