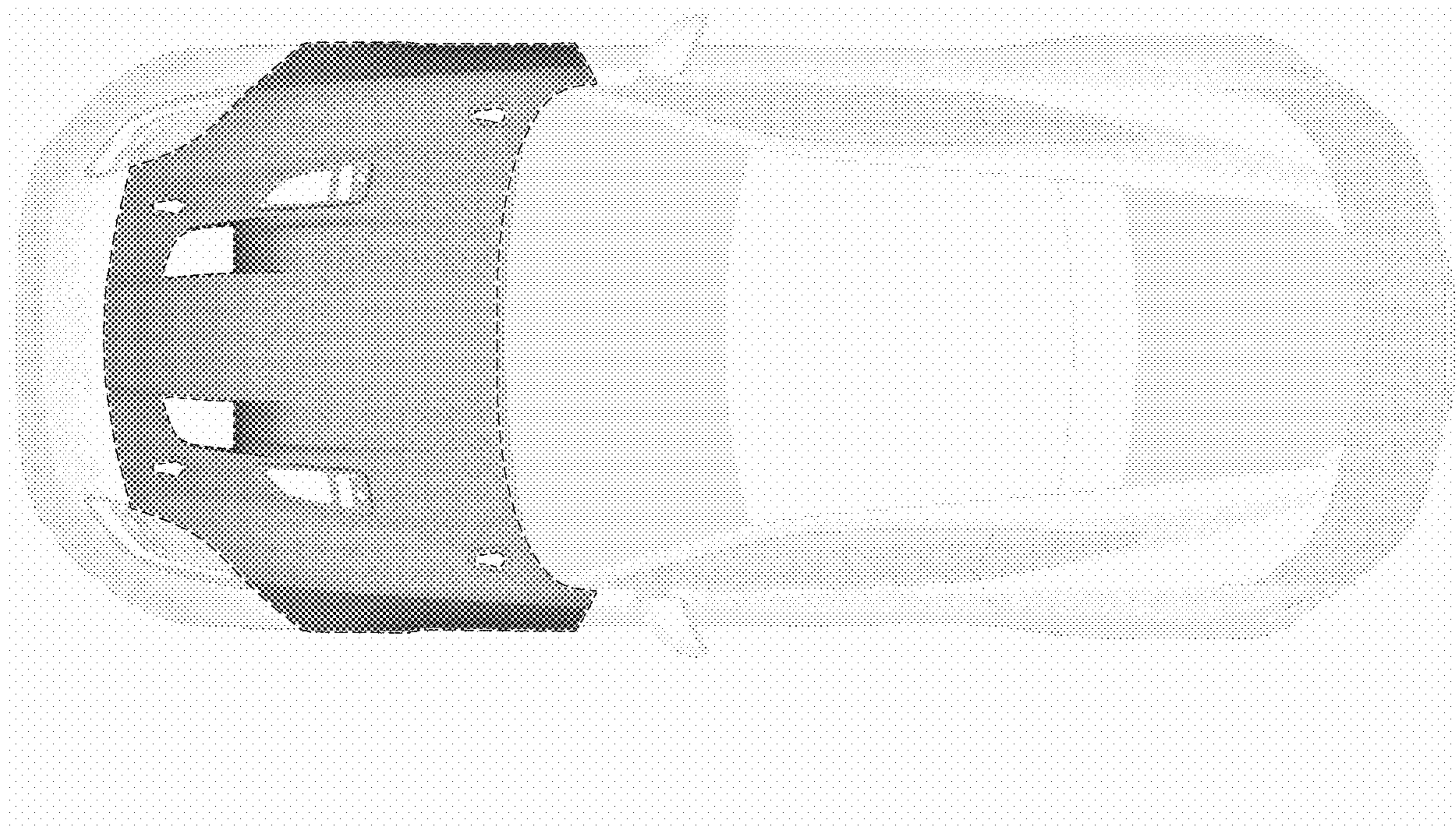
(57) **CLAIM**

The ornamental design for a vehicle hood, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front and left side perspective view of a vehicle hood showing our new design; FIG. 2 is a front and left side perspective view thereof; FIG. 3 is a top, rear and right side perspective view thereof; FIG. 4 is a rear and right side perspective view thereof; FIG. 5 is a front elevational view thereof; FIG. 6 is a rear elevational view thereof; FIG. 7 is a left side elevational view thereof; FIG. 8 is a right side elevational view thereof; FIG. 9 is a top plan view thereof; FIG. 10 is a bottom plan view thereof; FIG. 11 is another top plan view thereof shown mounted on a vehicle; FIG. 12 is a top, front and left side perspective view of a vehicle hood showing a second embodiment of our new design; FIG. 13 is a front and left side perspective view of FIG. 12; FIG. 14 is a top, rear and right side perspective view of FIG. 12; FIG. 15 is a rear and right side perspective view of FIG. 12; FIG. 16 is a front elevational view of FIG. 12; FIG. 17 is a rear elevational view of FIG. 12; FIG. 18 is a left side elevational view of FIG. 12; FIG. 19 is a right side elevational view of FIG. 12; FIG. 20 is a top plan view of FIG. 12; FIG. 21 is a bottom plan view of FIG. 12; and, FIG. 22 is another top plan view of FIG. 12. The portions of the vehicle shown in the FIG. 11 and FIG. 22 drawing views in a de-emphasized and half-tone form outside the broken lines and the broken lines representing the boundary and configuration of what is claimed as the design are all for environmental and illustrative purposes only and form no part of the claimed design.

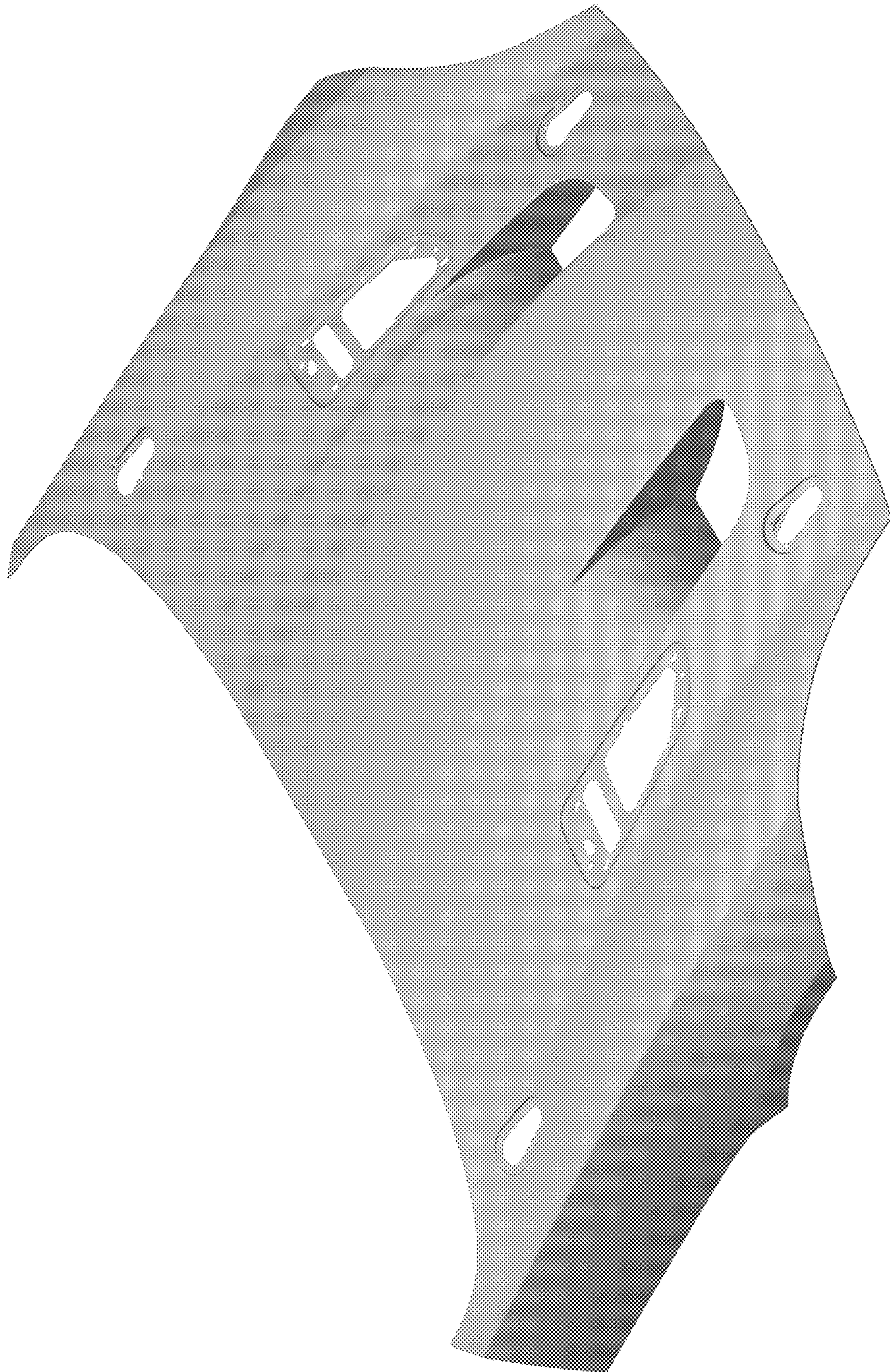

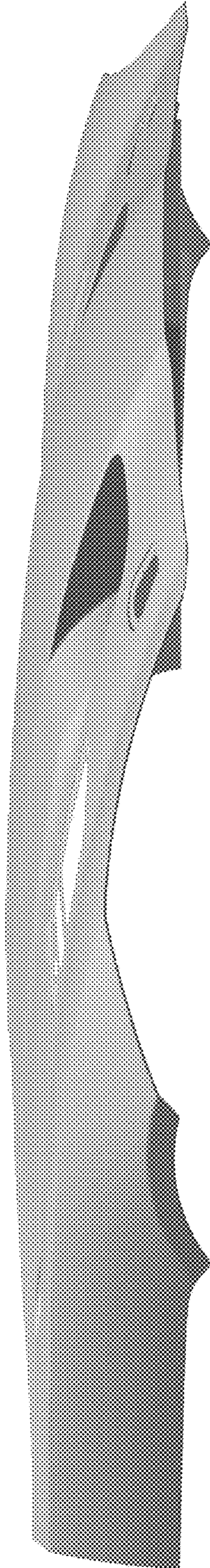

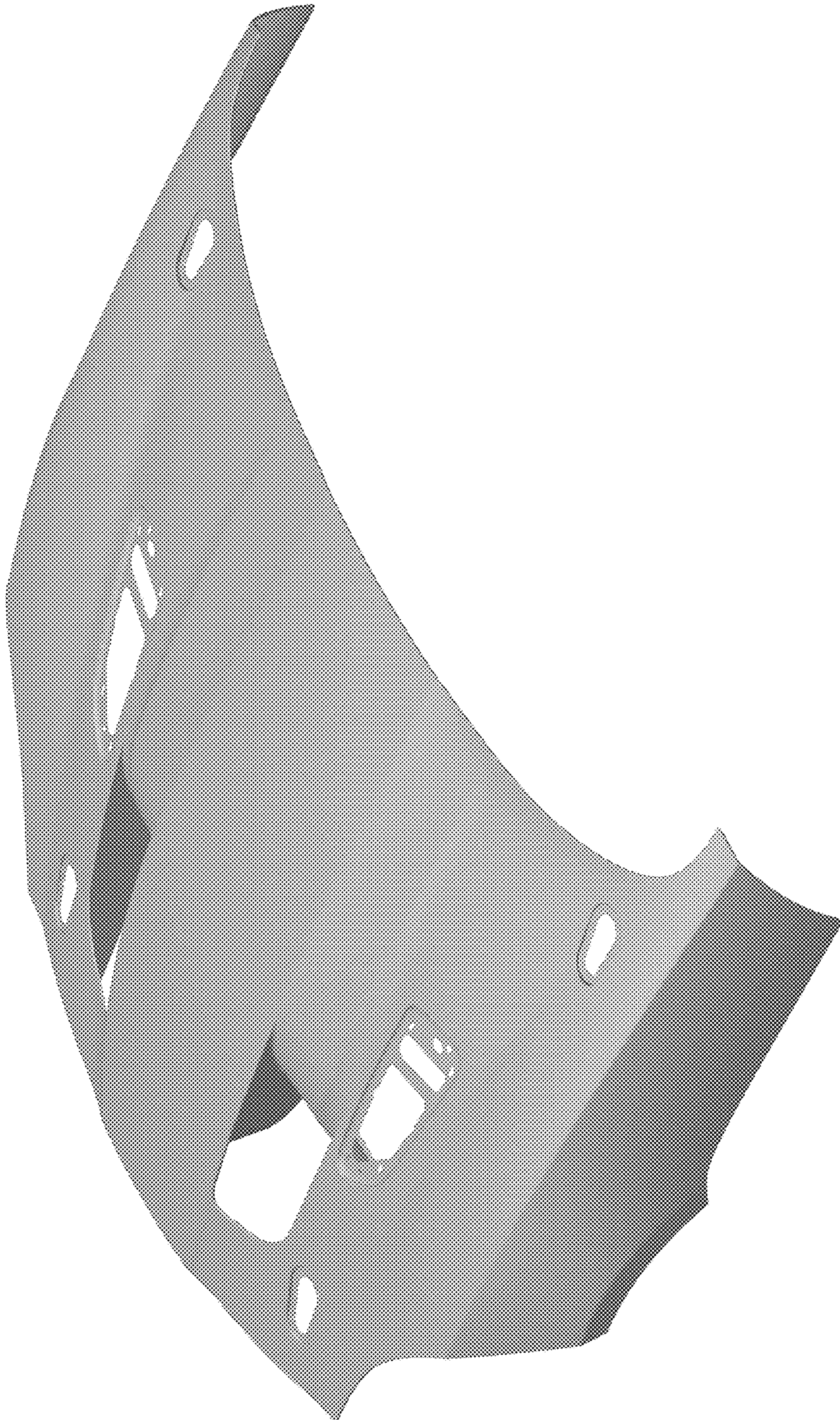

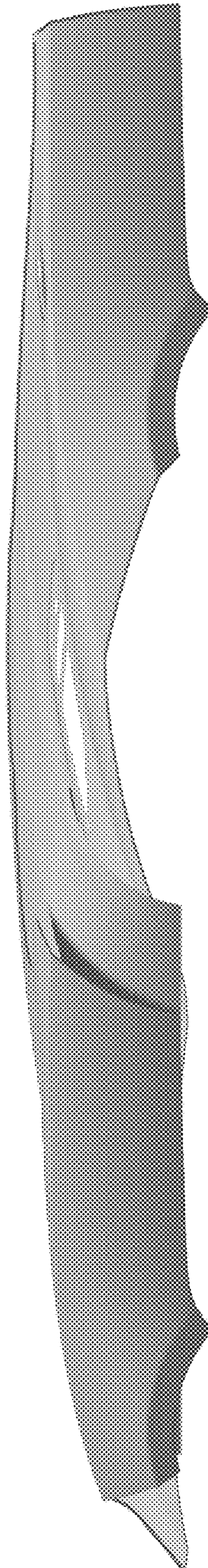

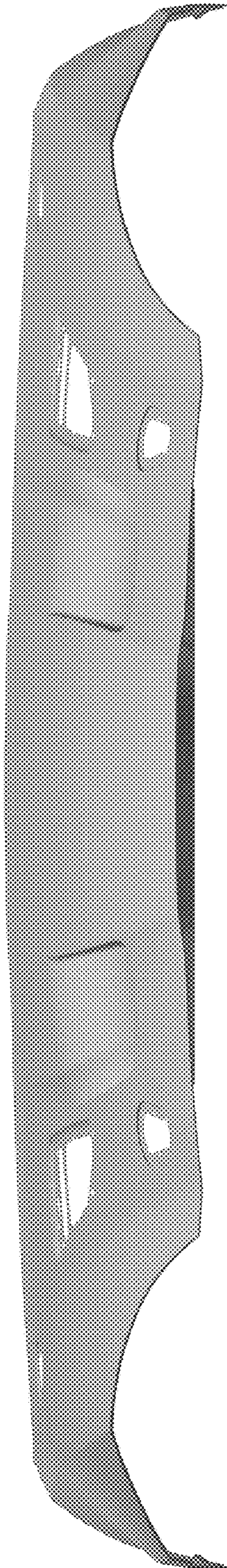

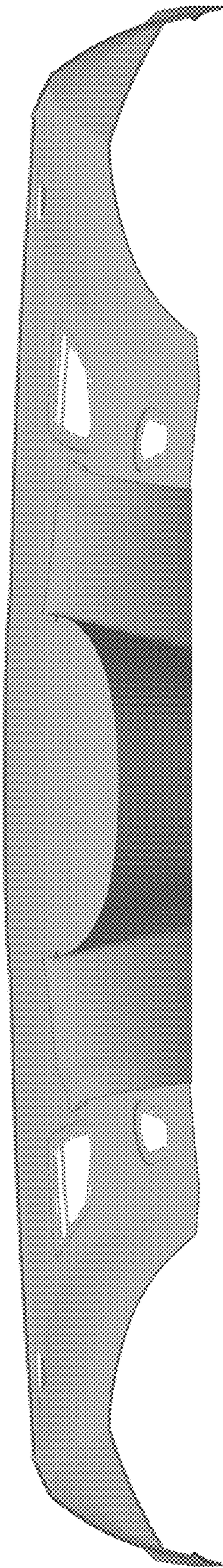

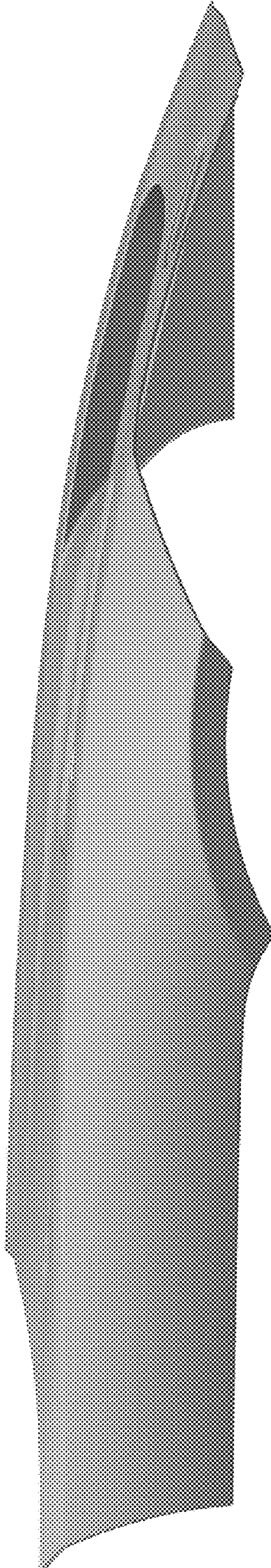

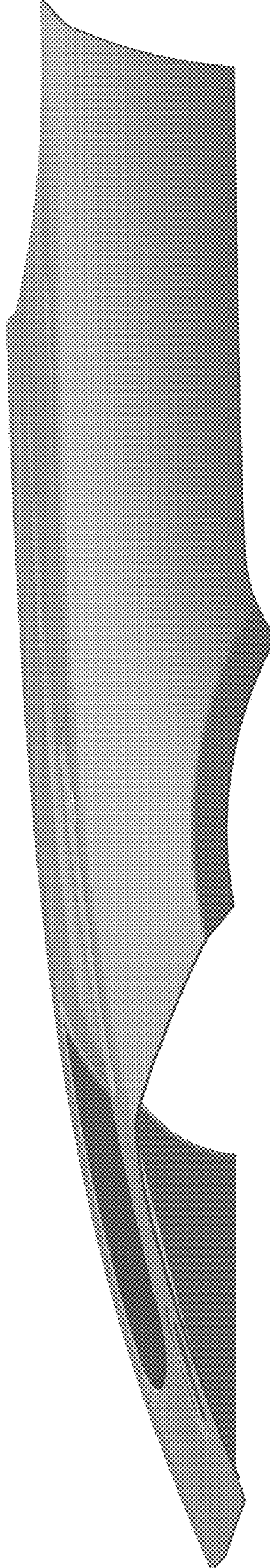

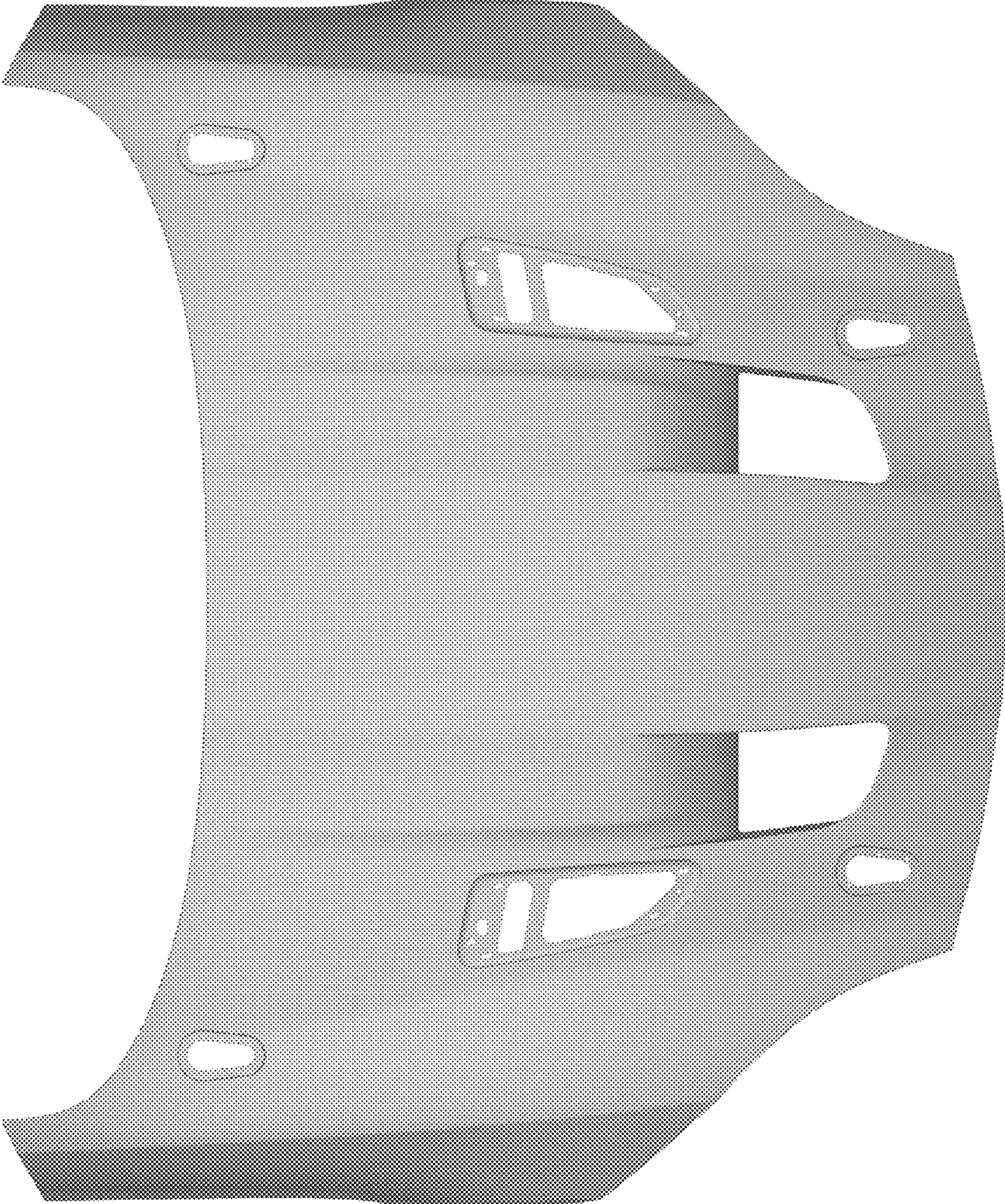

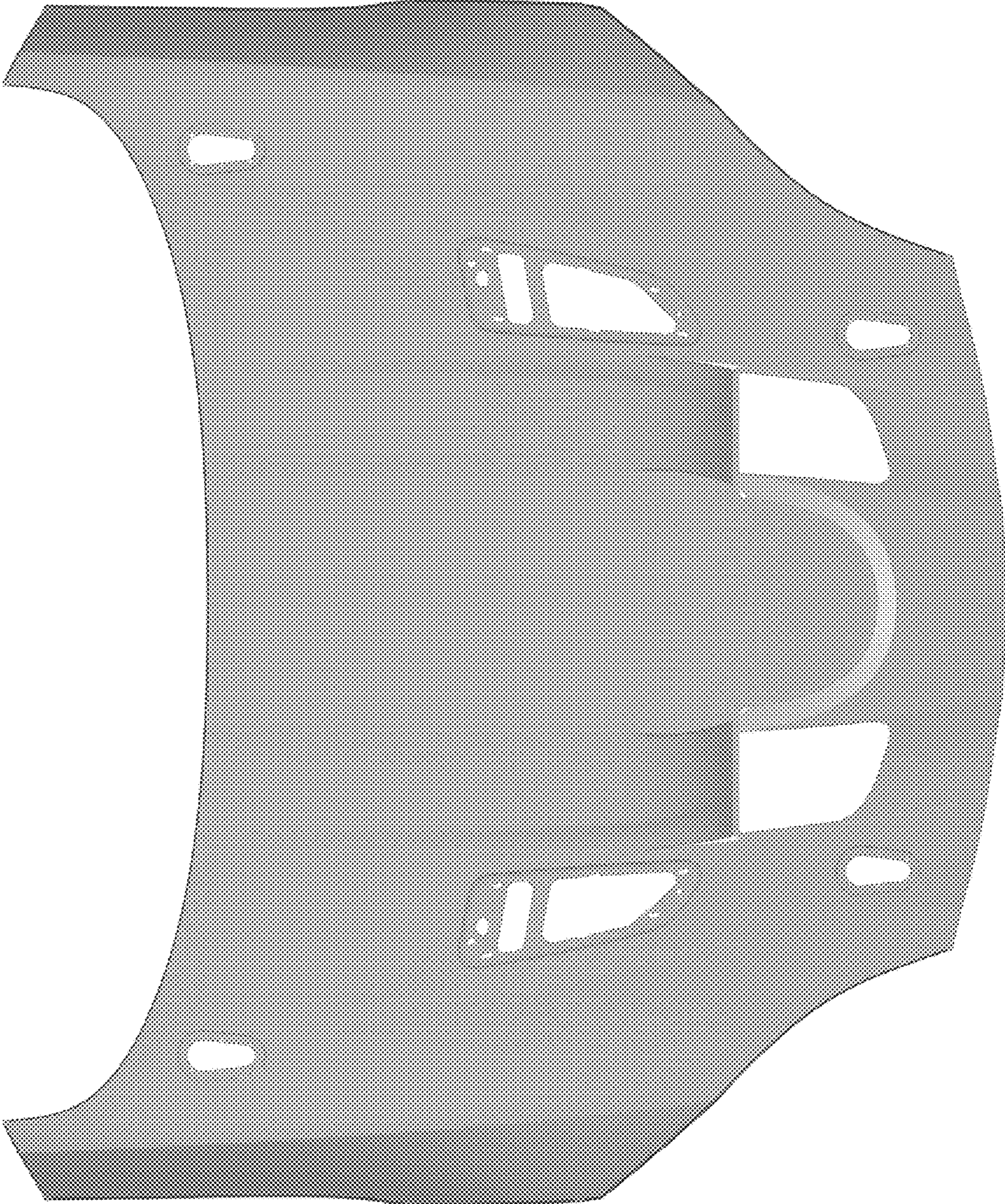

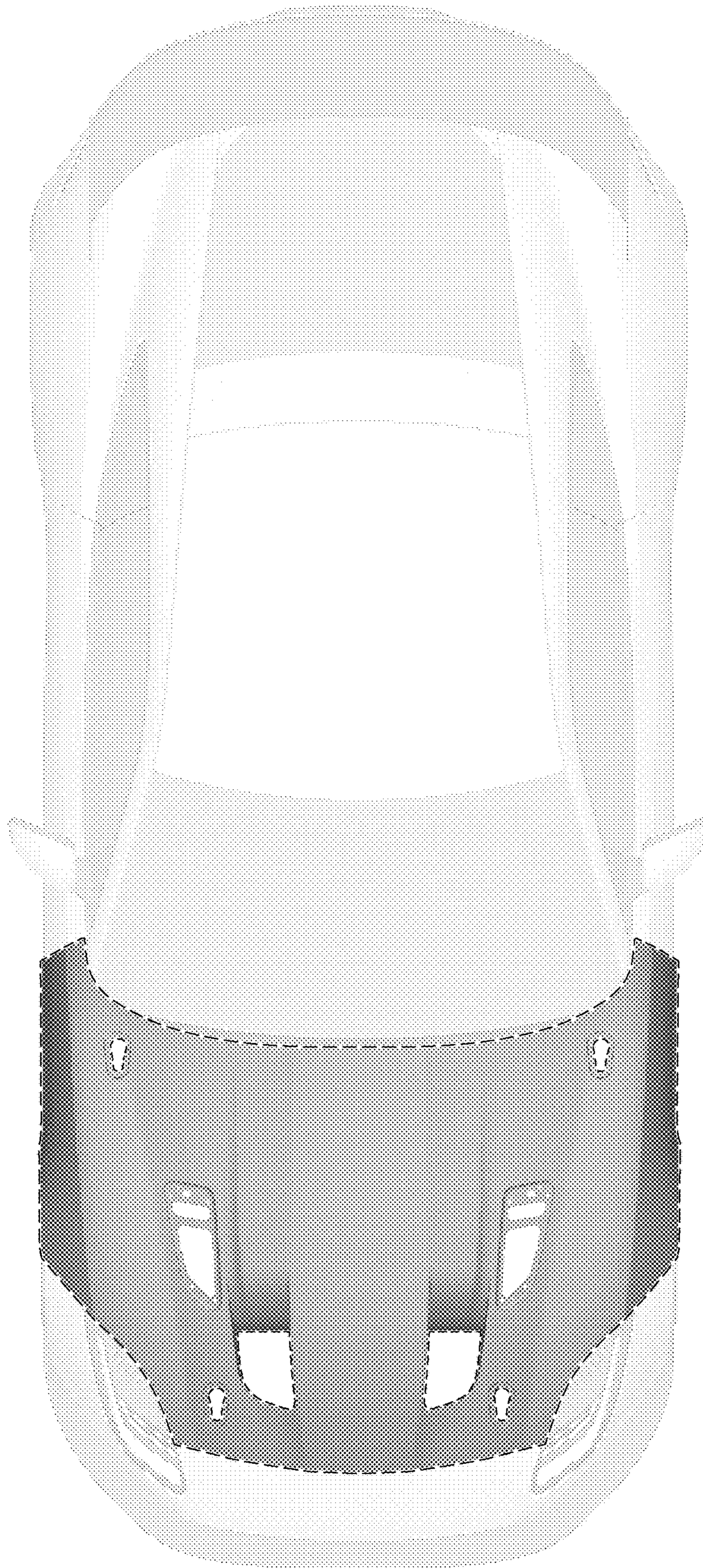

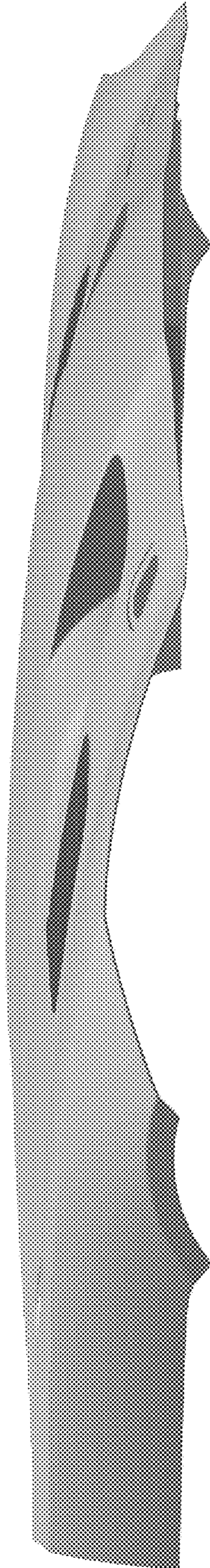

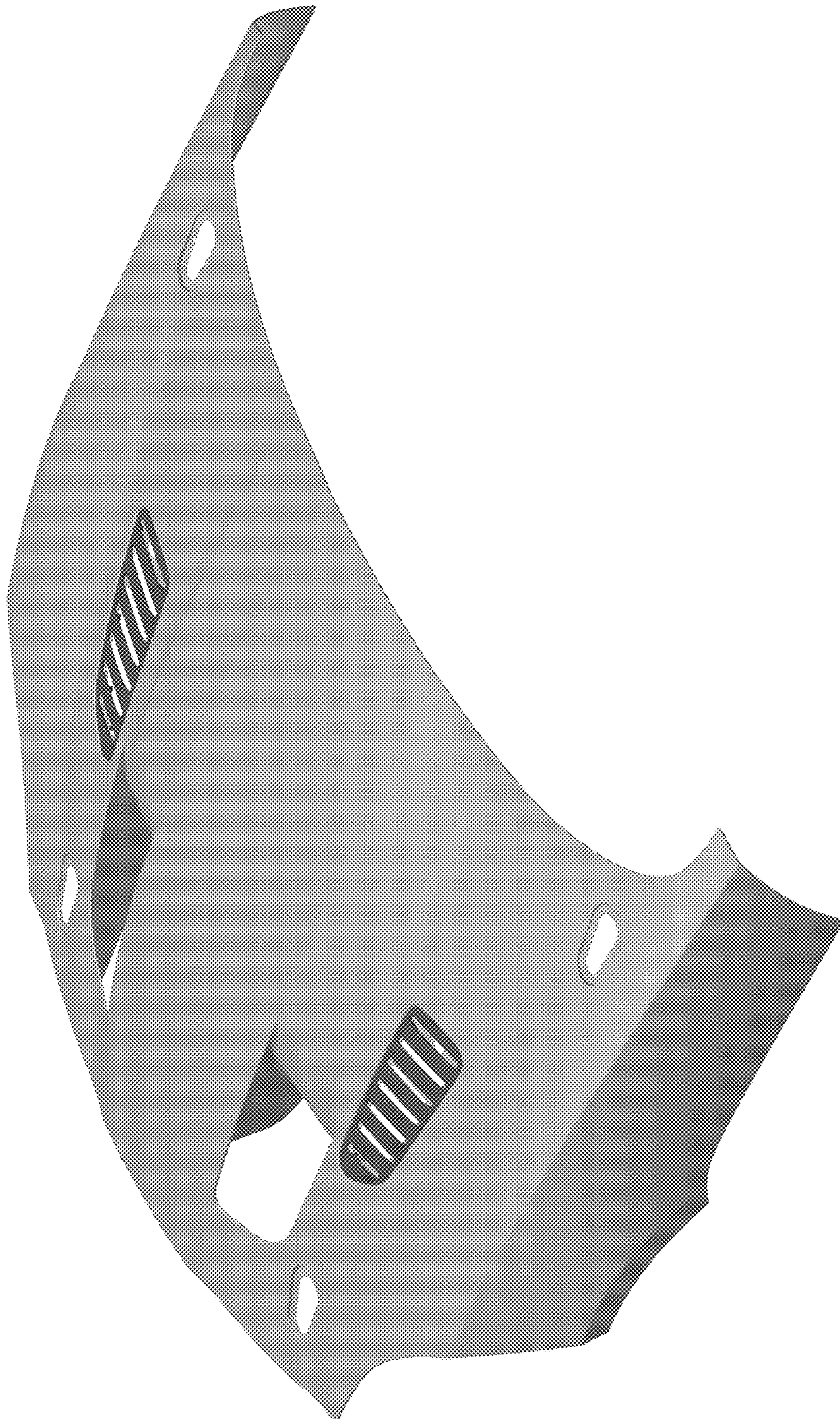

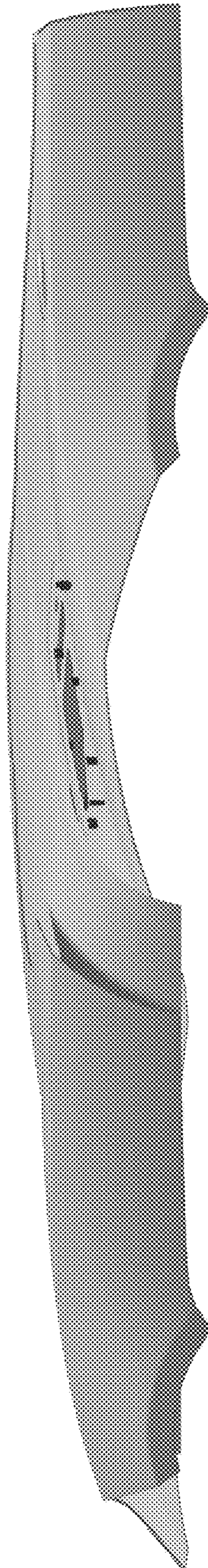

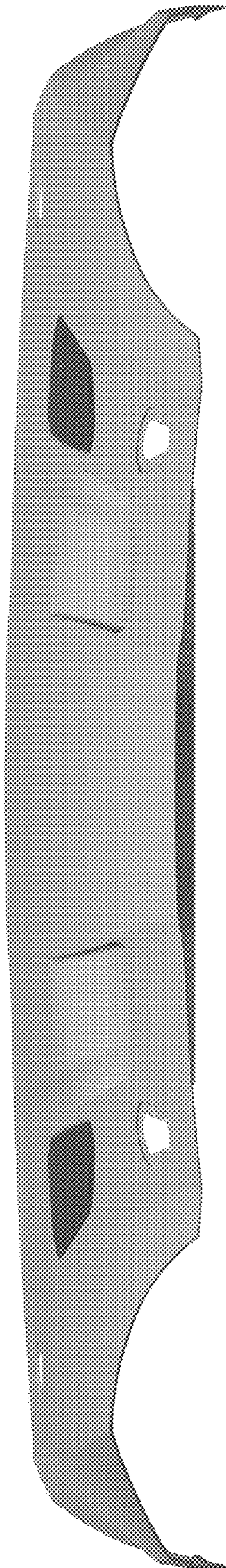

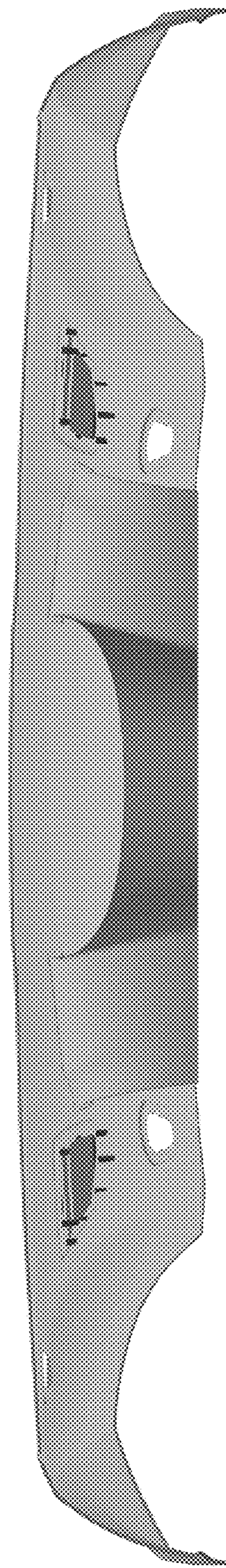

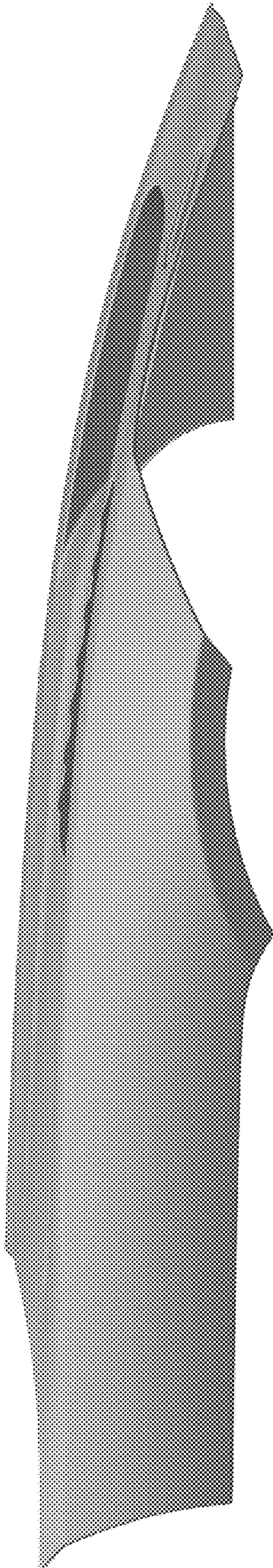

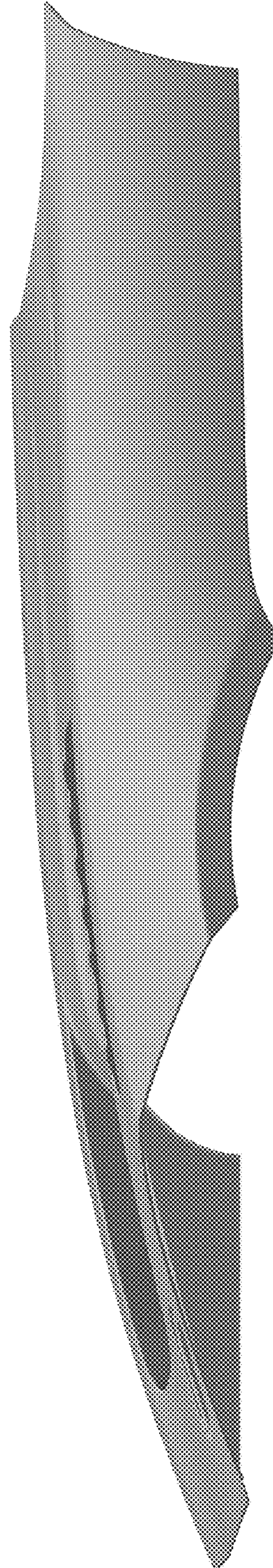

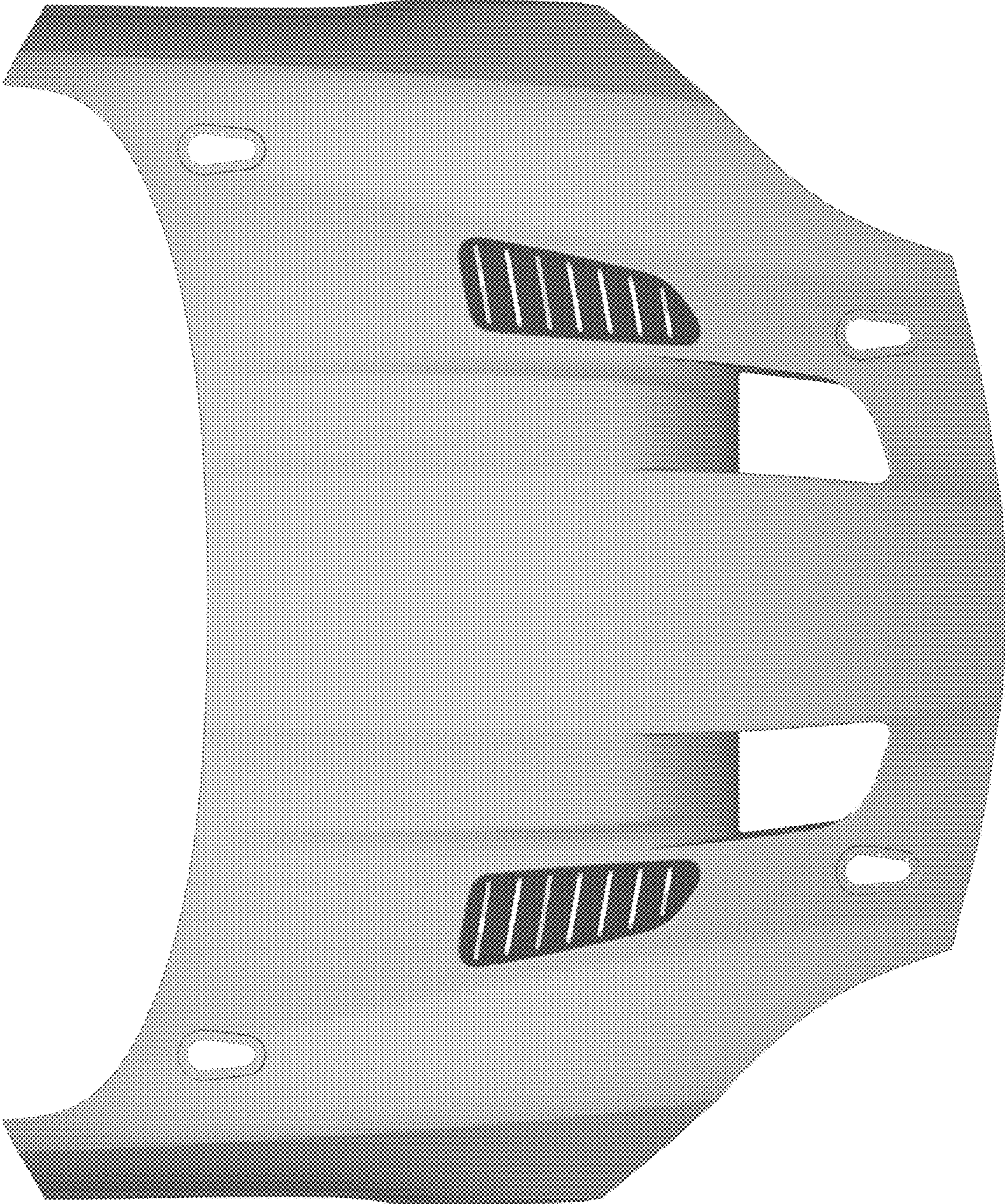

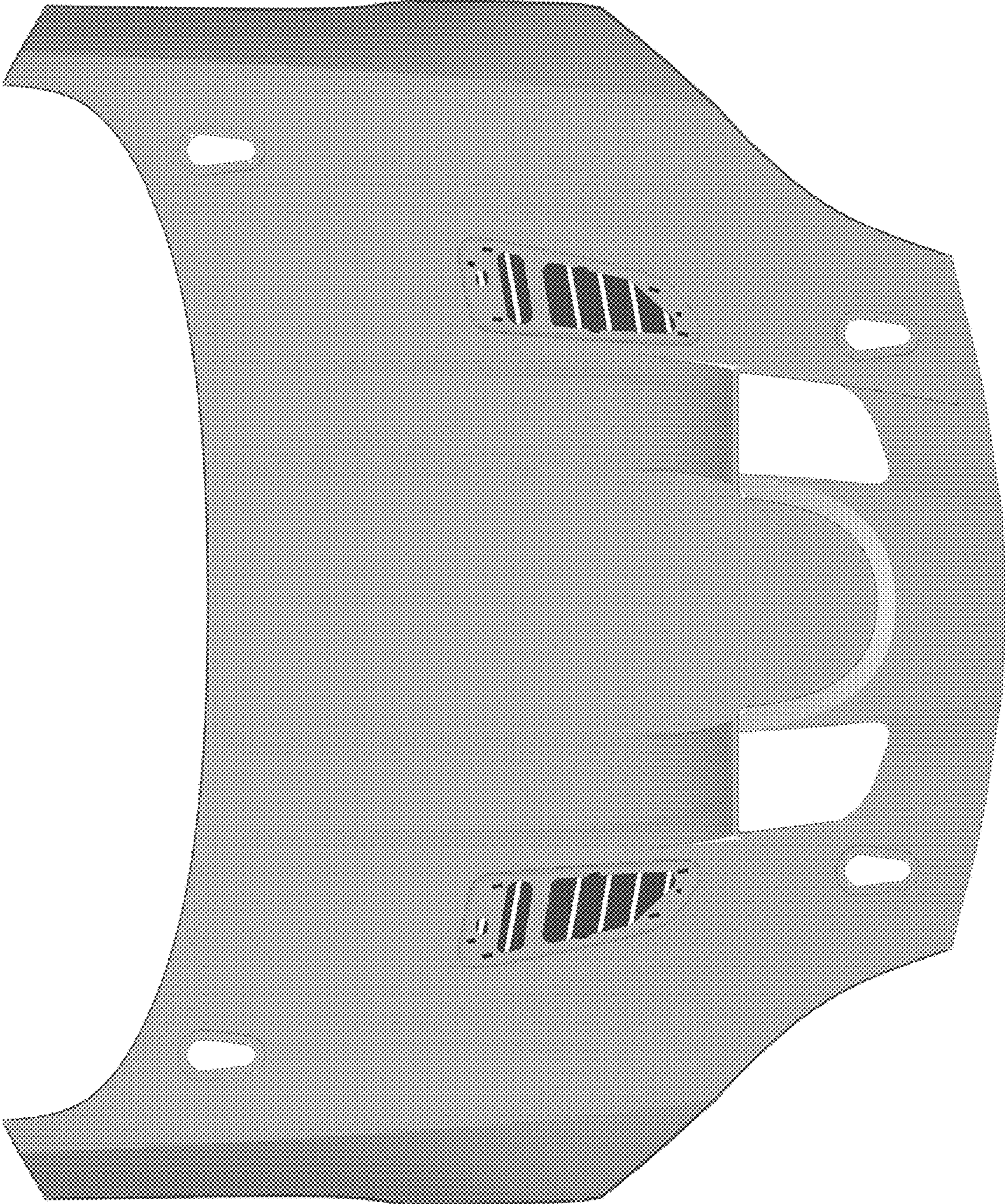

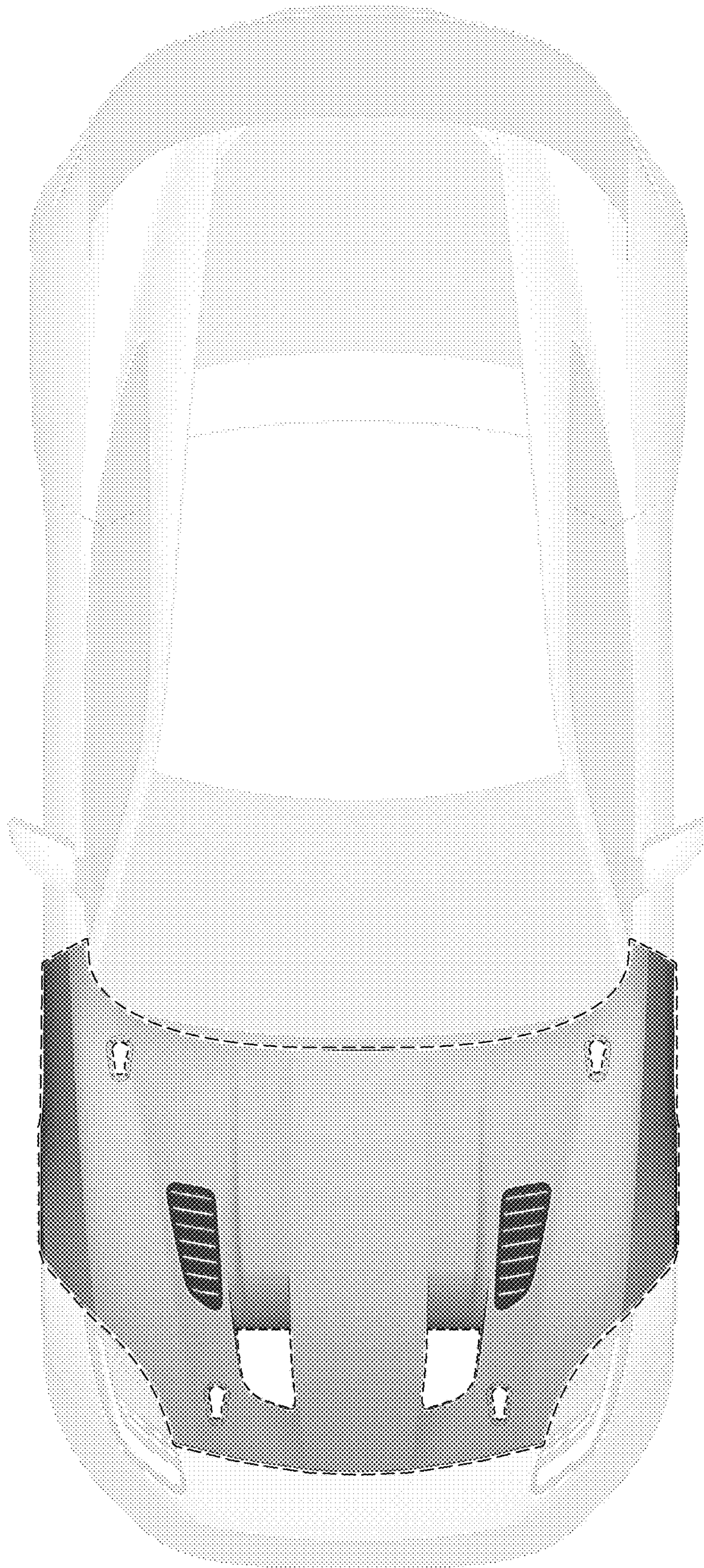
