(57) **CLAIM**

The ornamental design for a center console for an automob-  
ile, as shown and described.

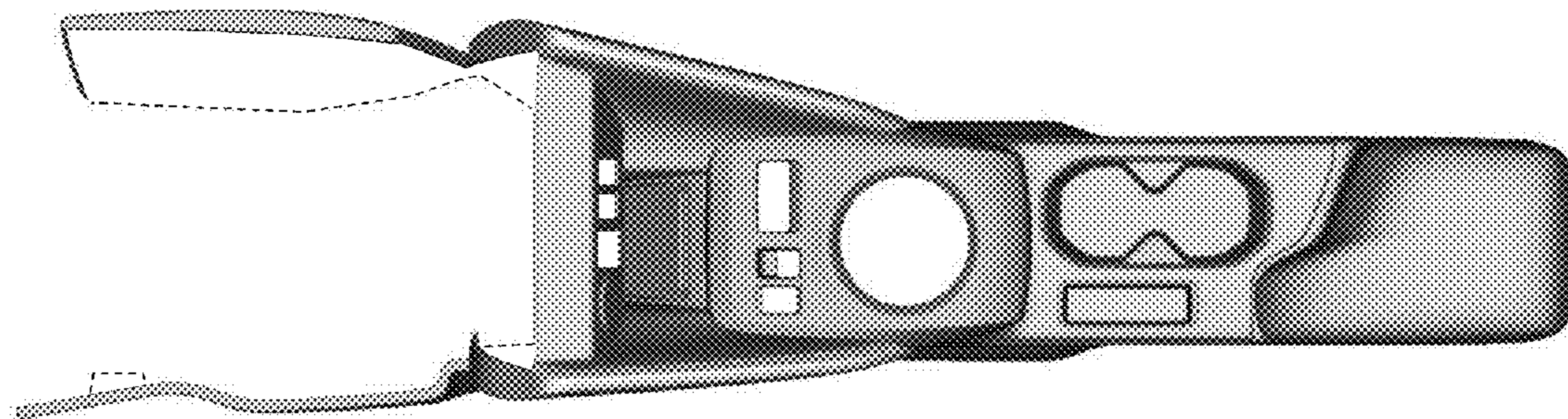
**DESCRIPTION**

FIG. 1 is a front elevational view of a center console for an  
automobile in accordance with our new design;  
FIG. 2 is a rear elevational view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is a left side elevational view thereof;  
FIG. 6 is a right side elevational view thereof;  
FIG. 7 is a first perspective view thereof; and,  
FIG. 8 is a second perspective view thereof.

The center console is configured to be mounted to an  
automobile. The inside surfaces of the center console, shown  
in broken lines in FIGS. 1 to 8, form no part of the claimed  
design since the inside surfaces are hidden when the center  
console is mounted to the automobile.

A second embodiment of our new design includes the mirror  
image of the center console shown in FIGS. 1 to 8.

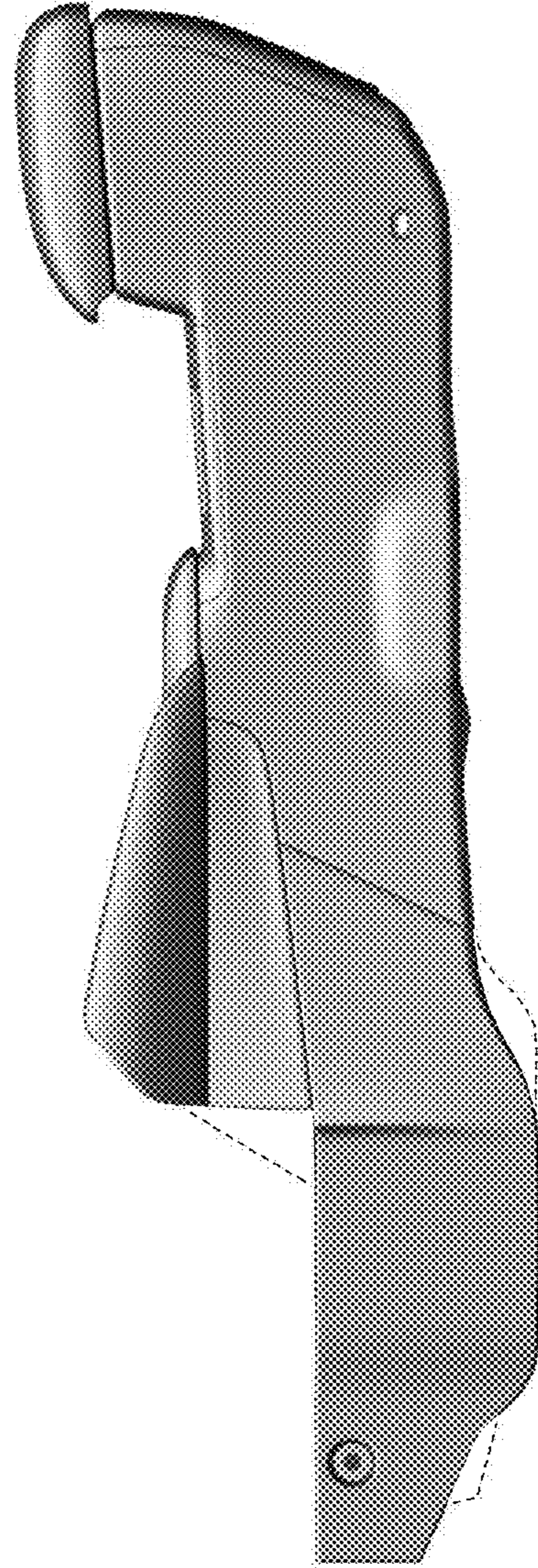

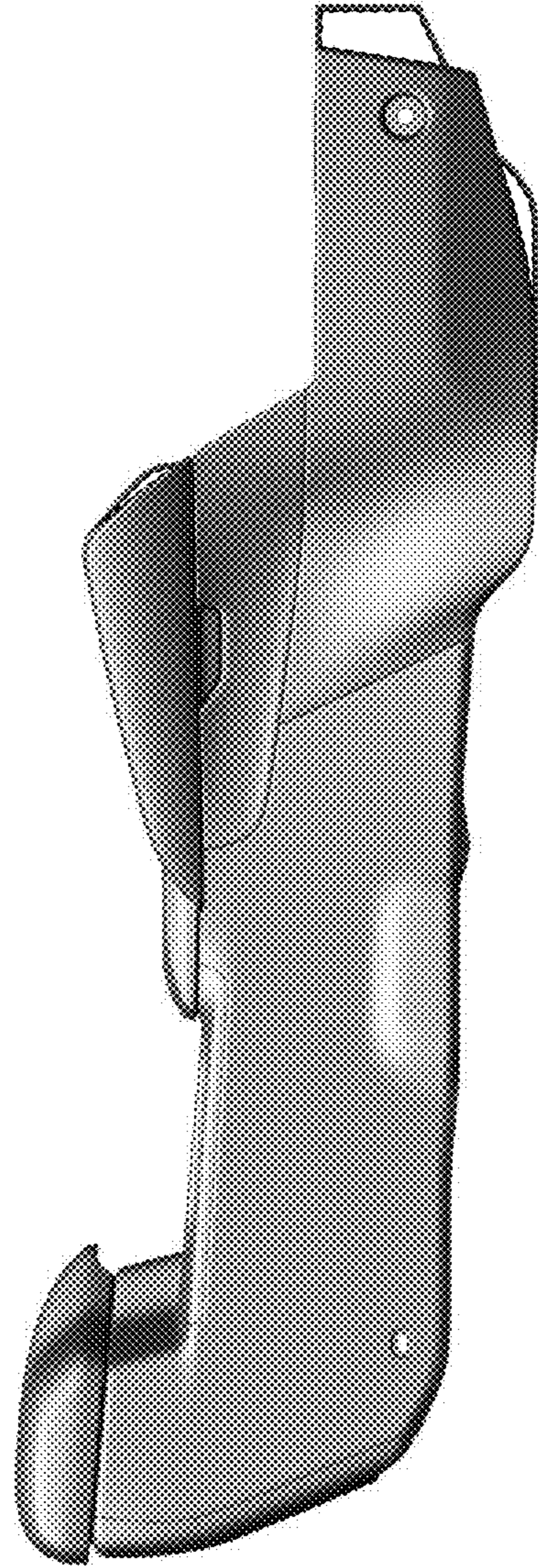

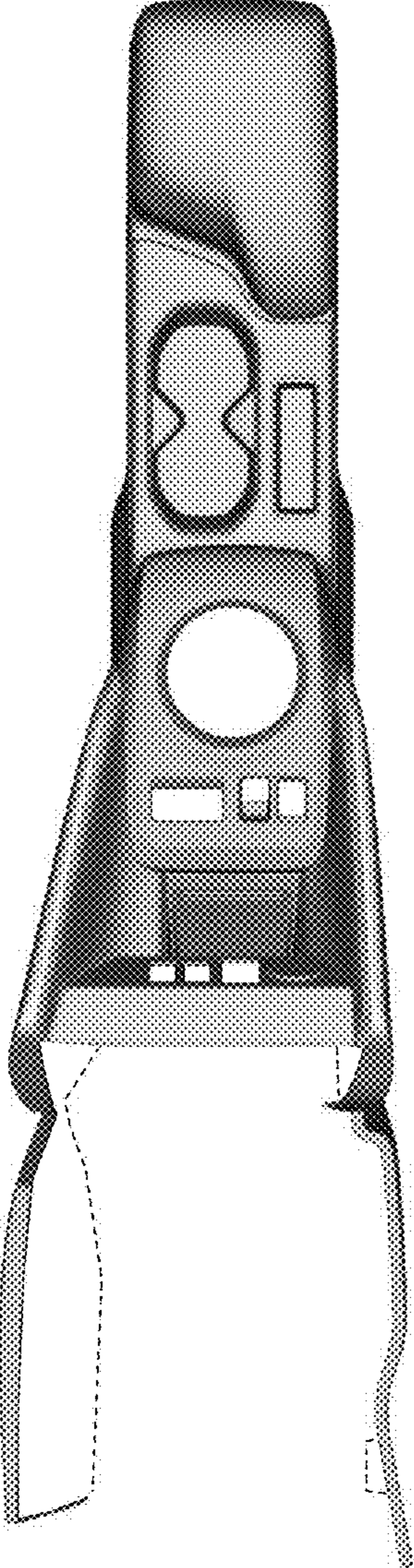

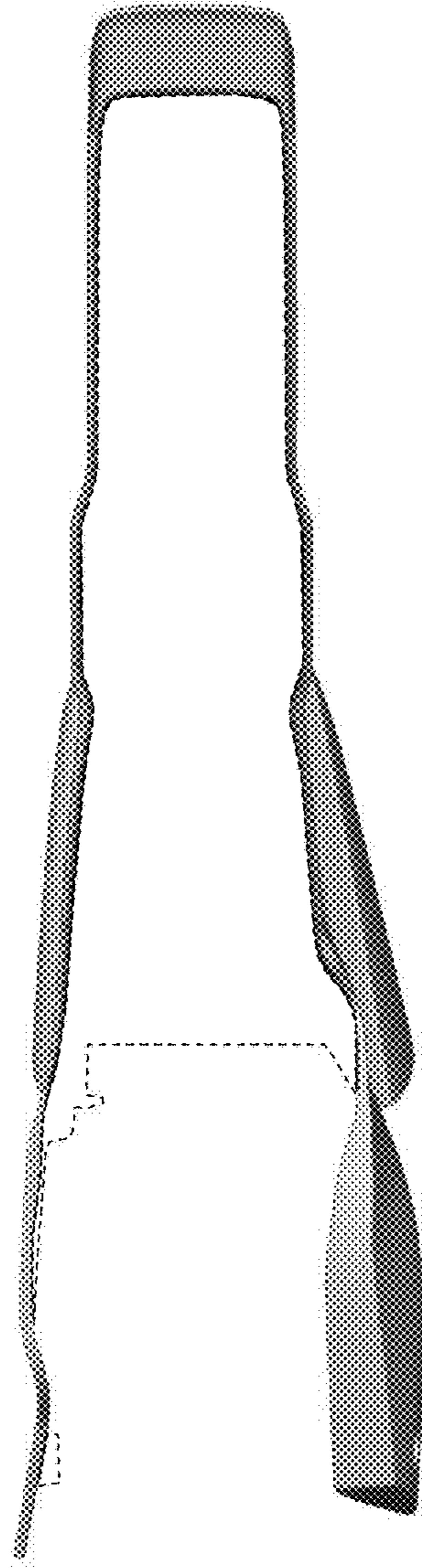

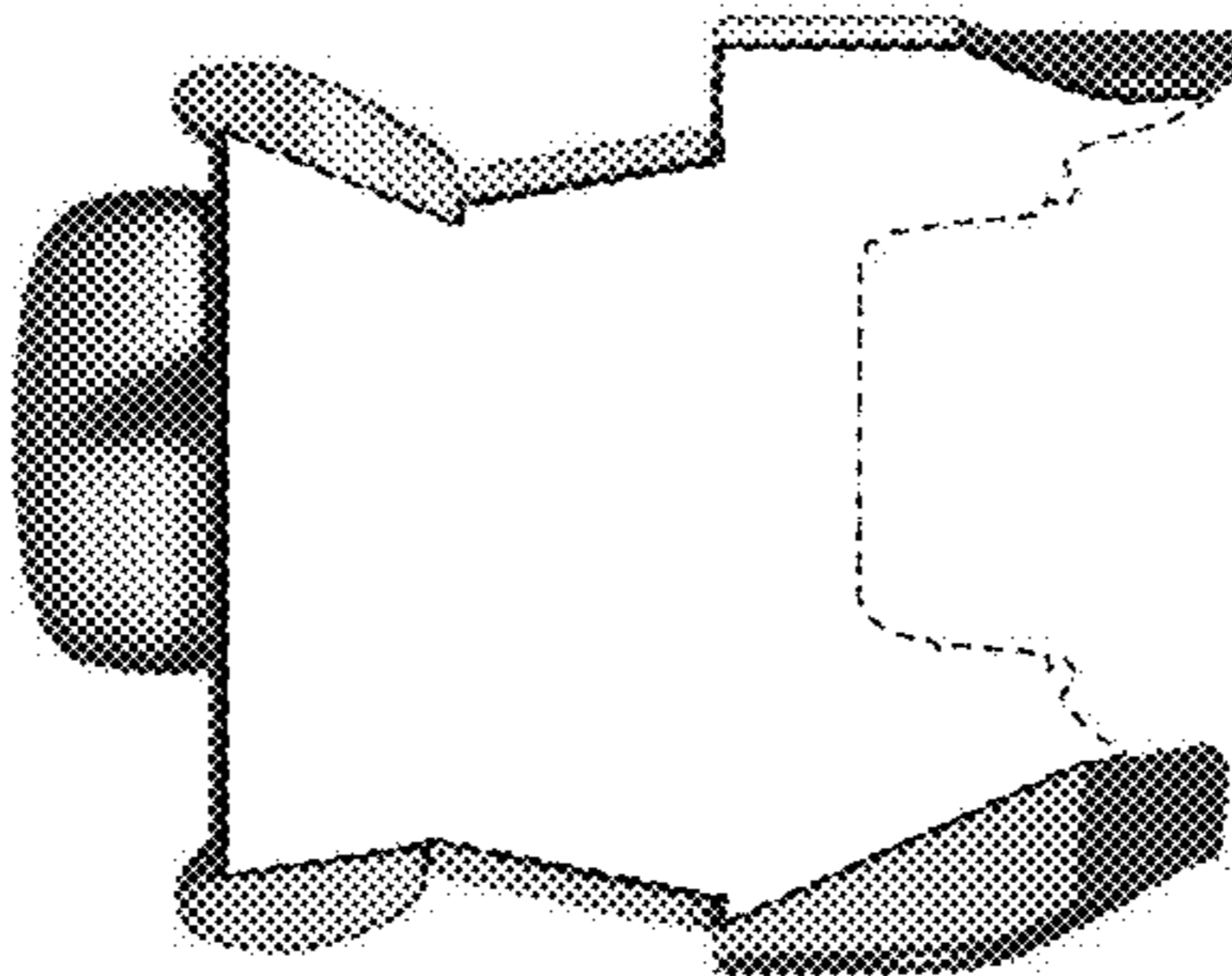

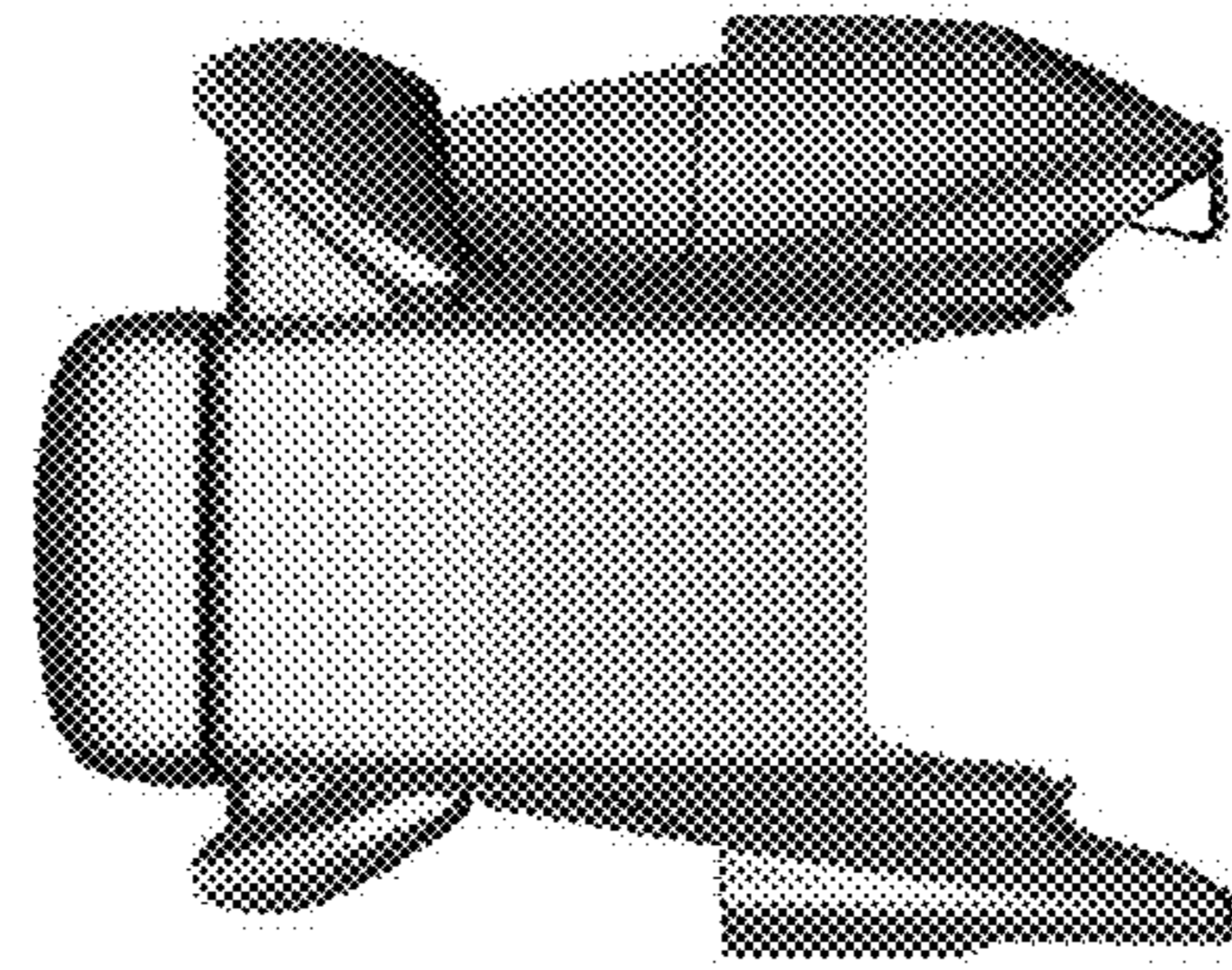

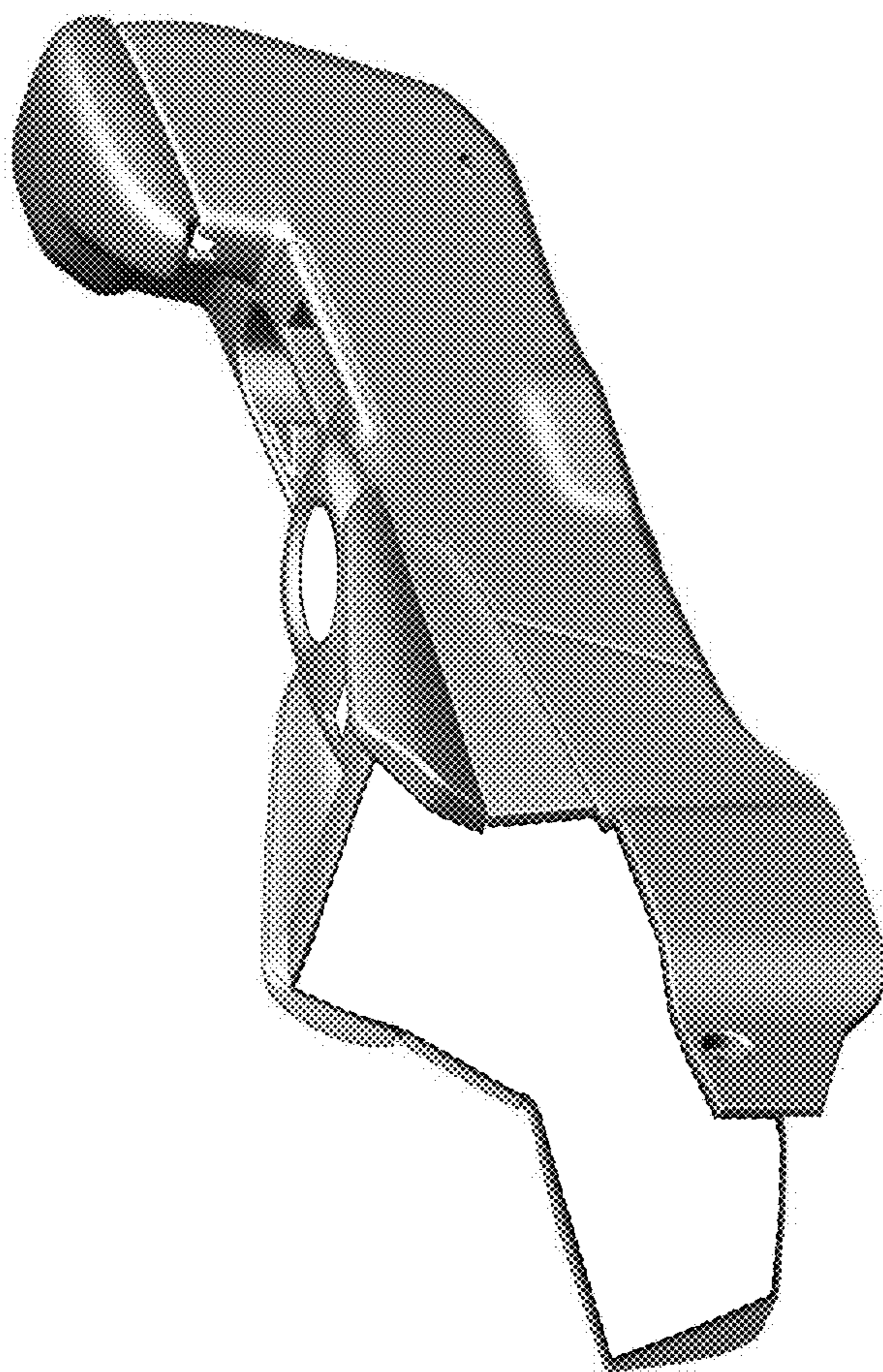

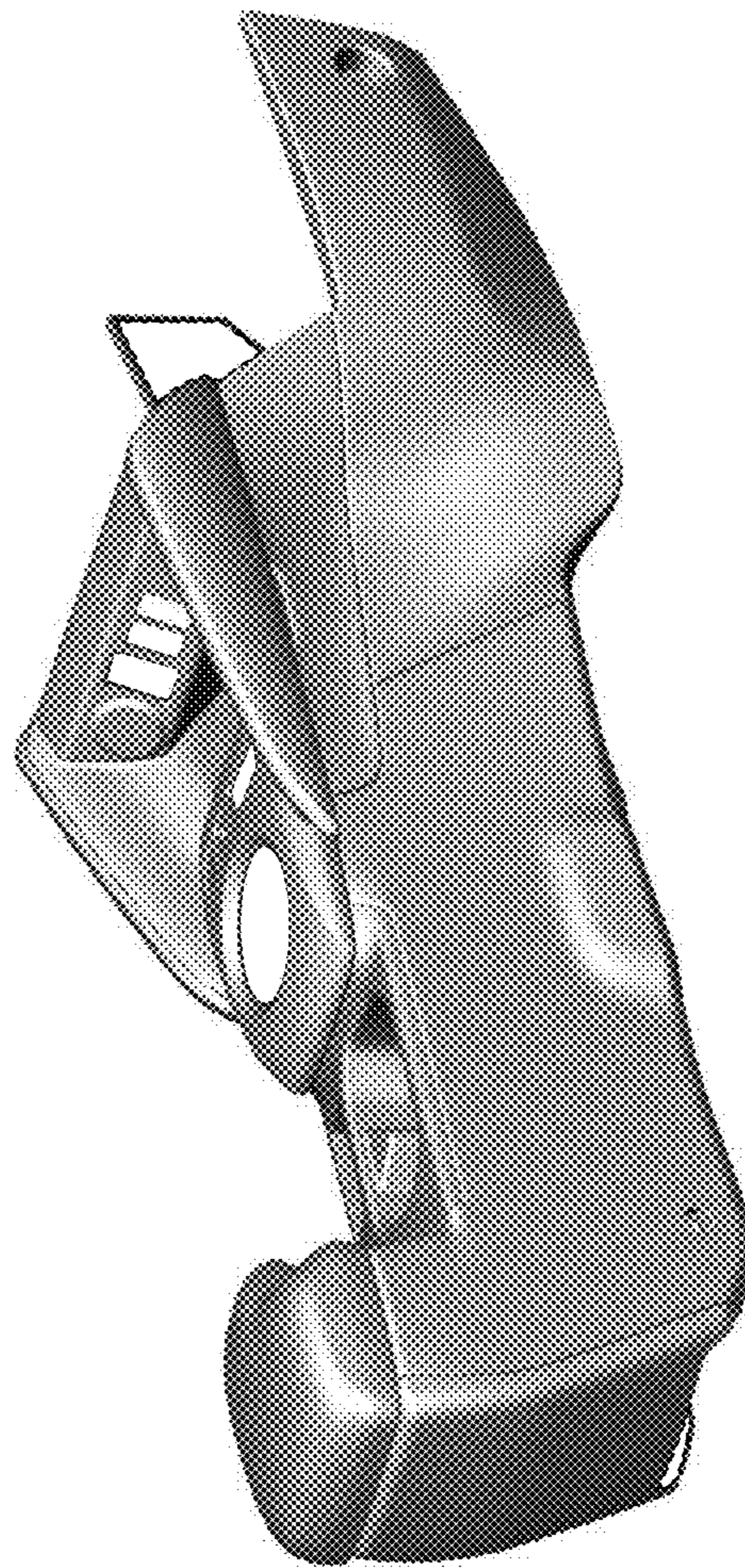
