The ornamental design for an intercom, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of an intercom showing our new design;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is a left side elevational view thereof, the right side being a mirror image;
FIG. 4 is a top plan view thereof, the bottom view being a mirror image; and,
FIG. 5 is a front perspective view thereof.

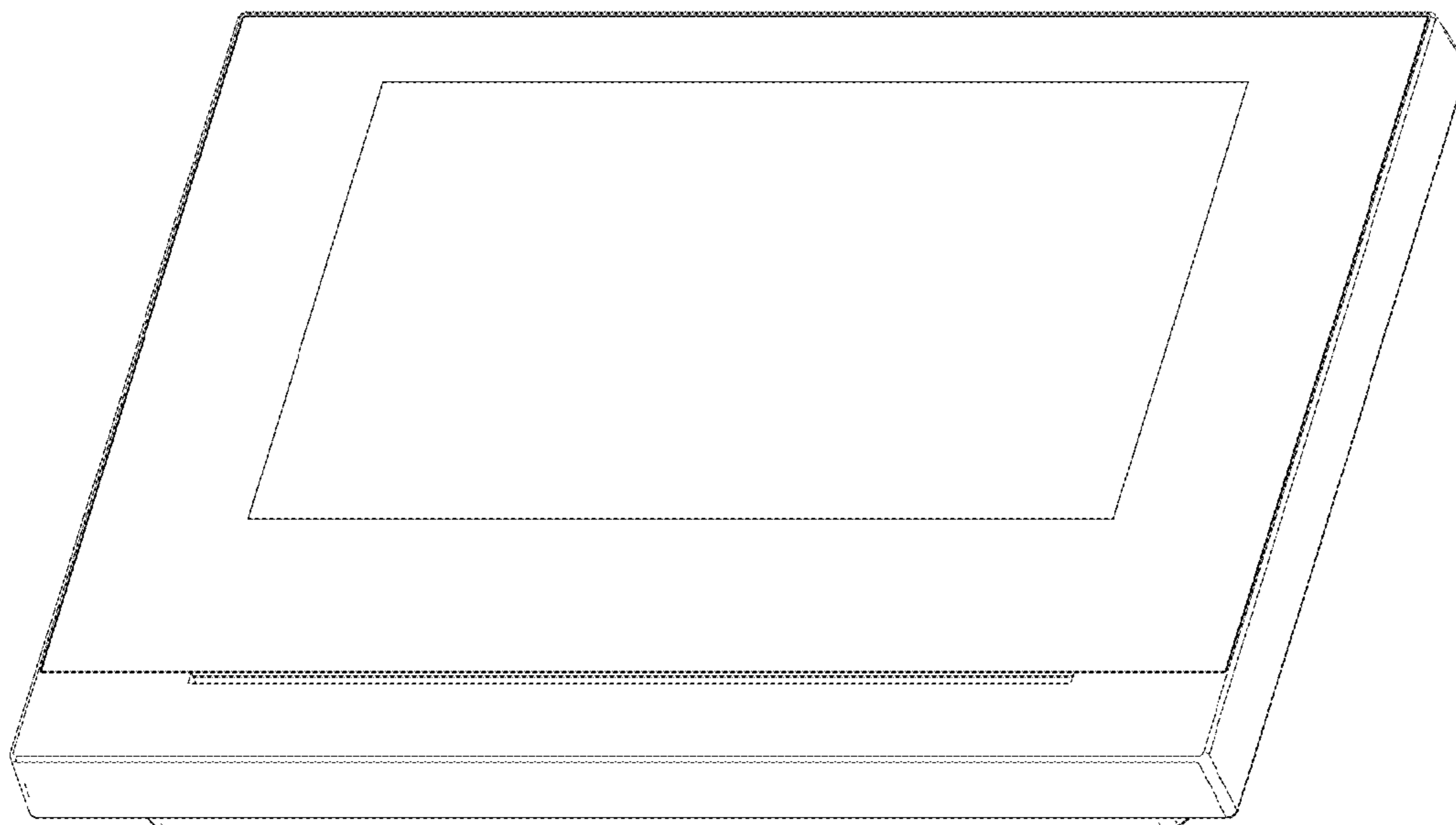

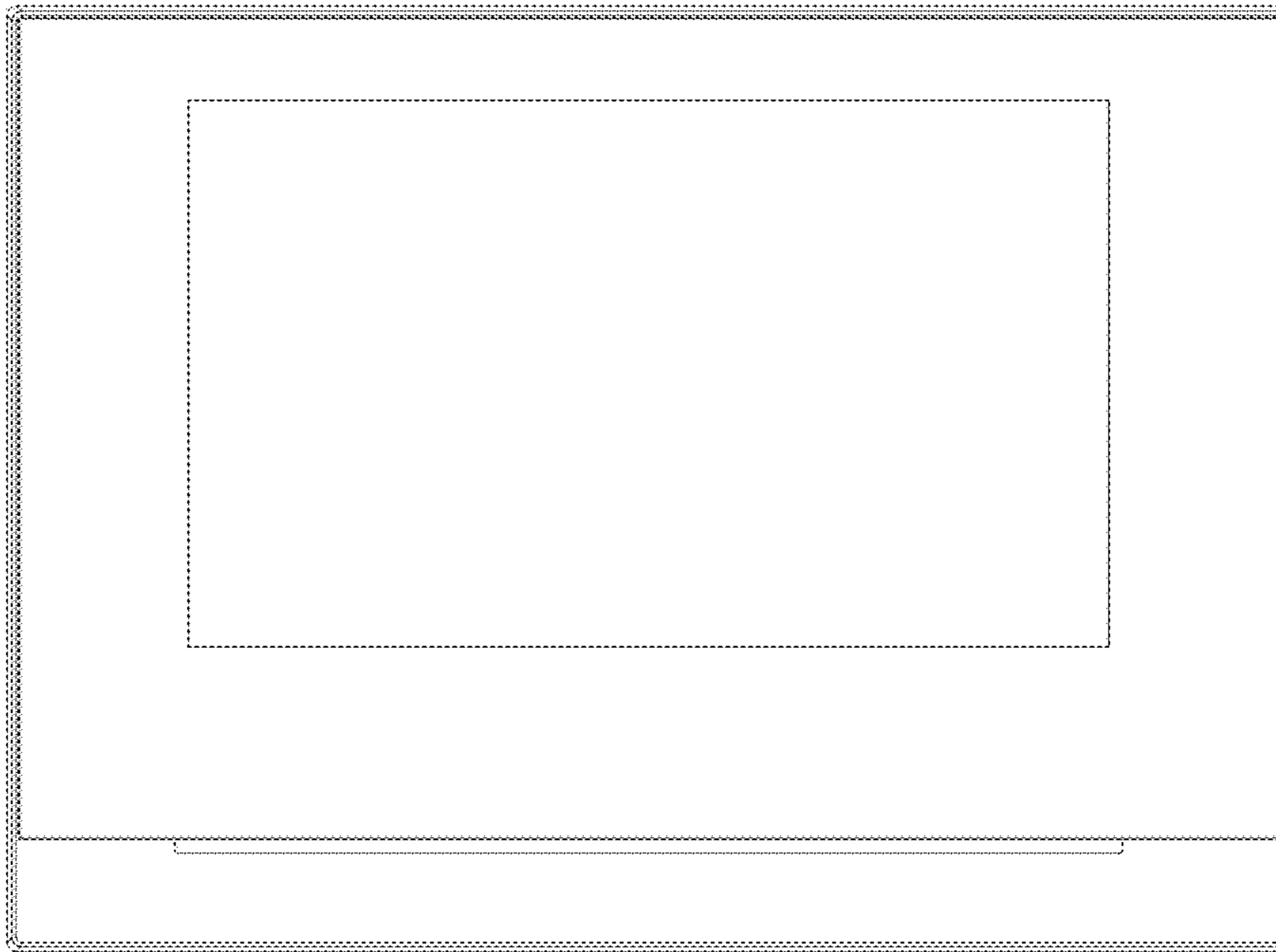

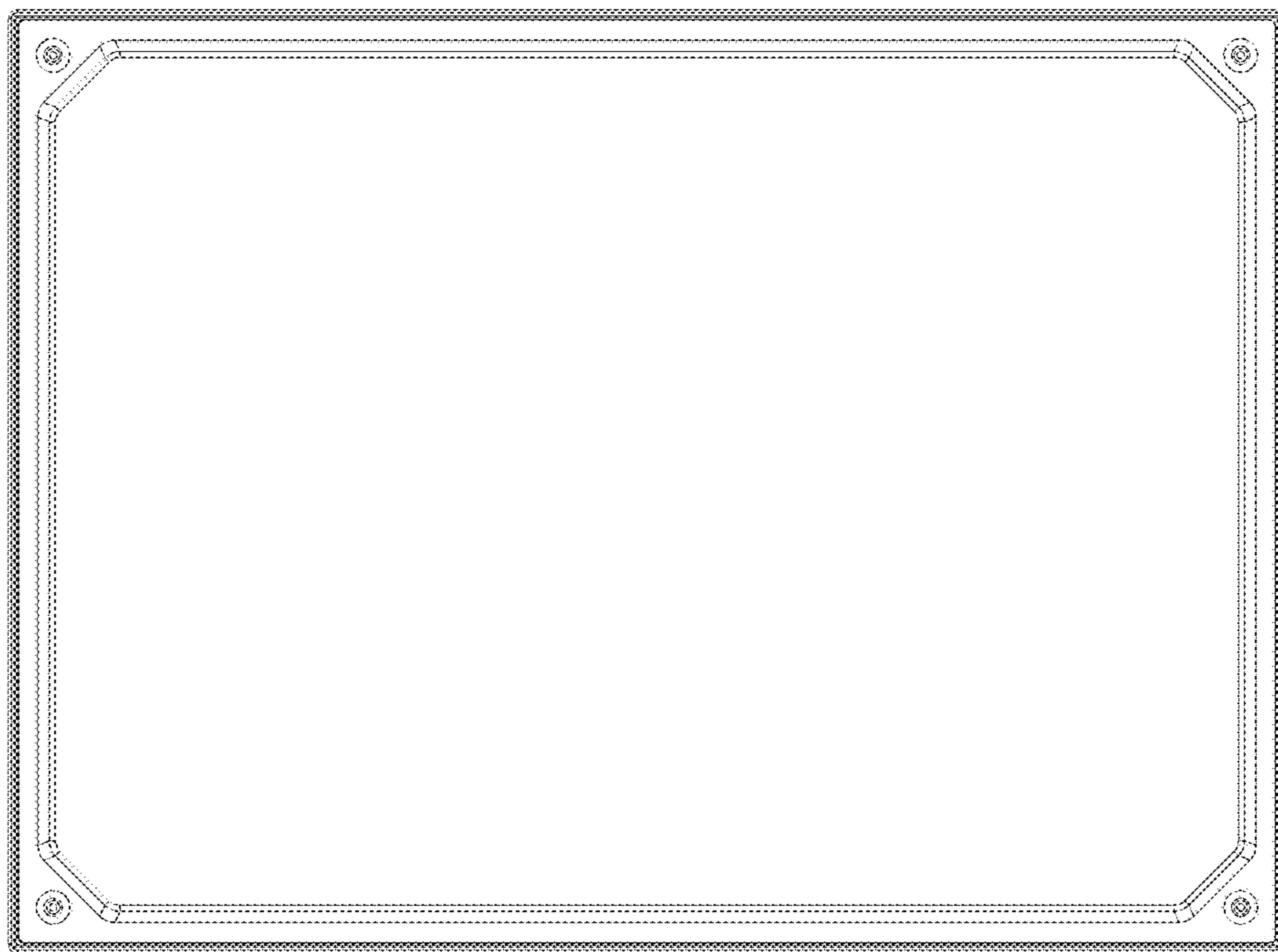

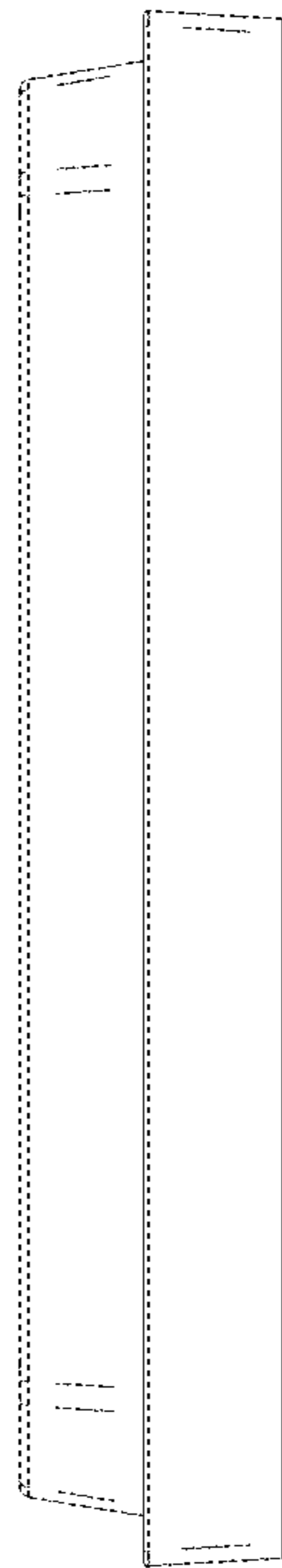

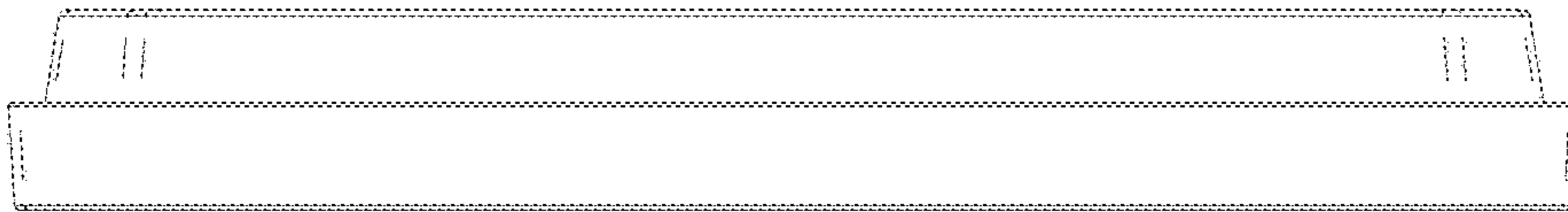
