DESCRIPTION

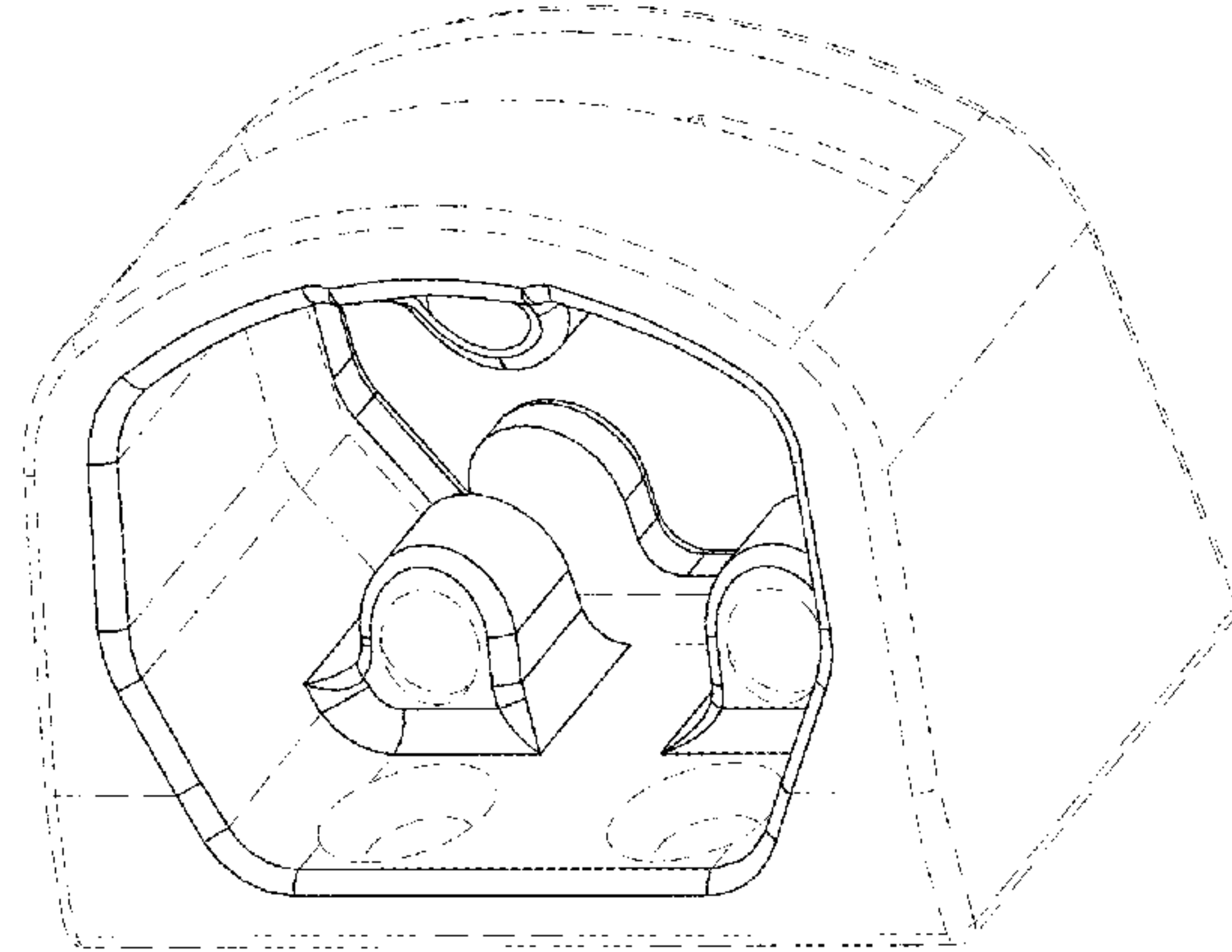
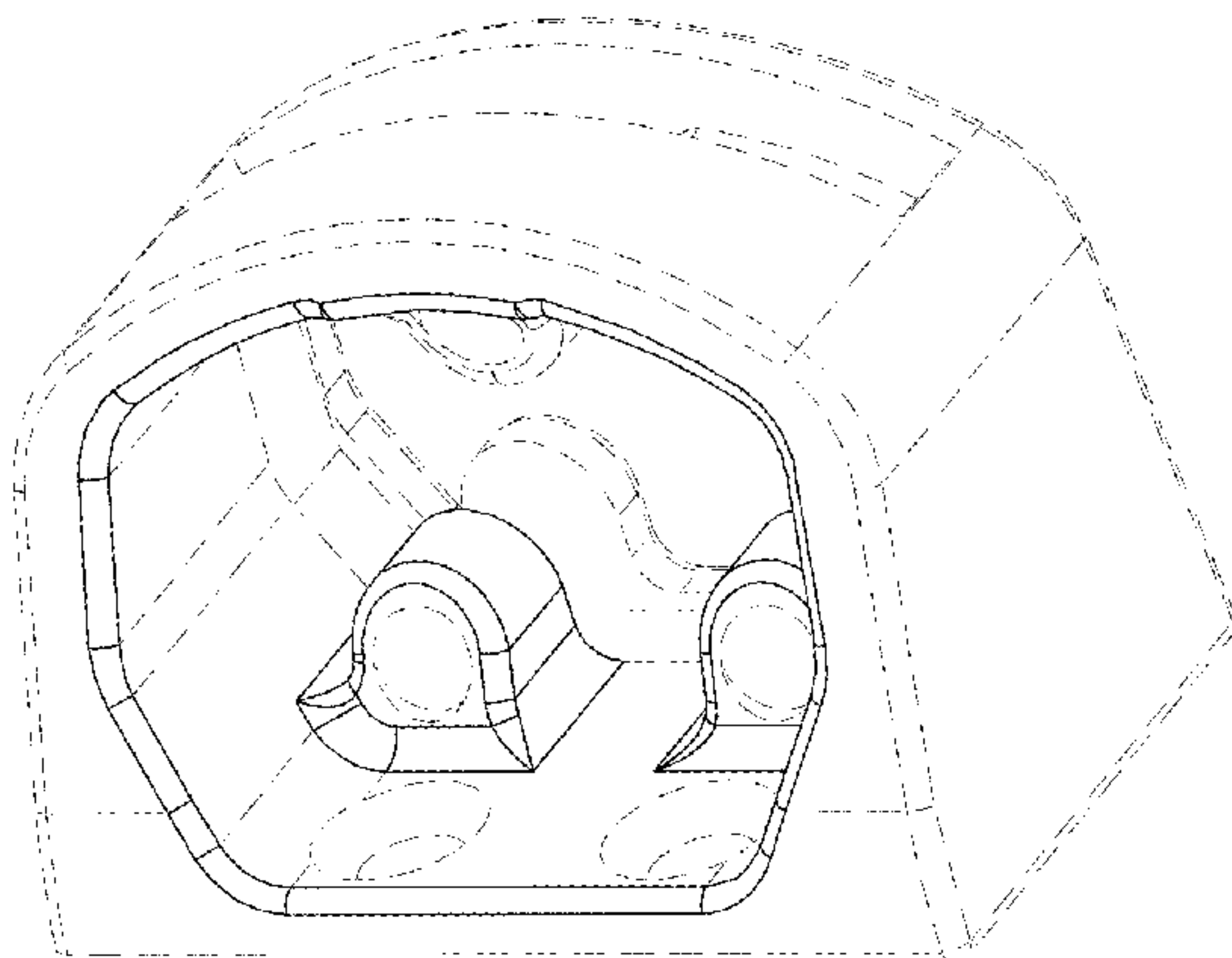
FIG. 1 is a perspective view of the firearm receiver showing my new design in a first embodiment;

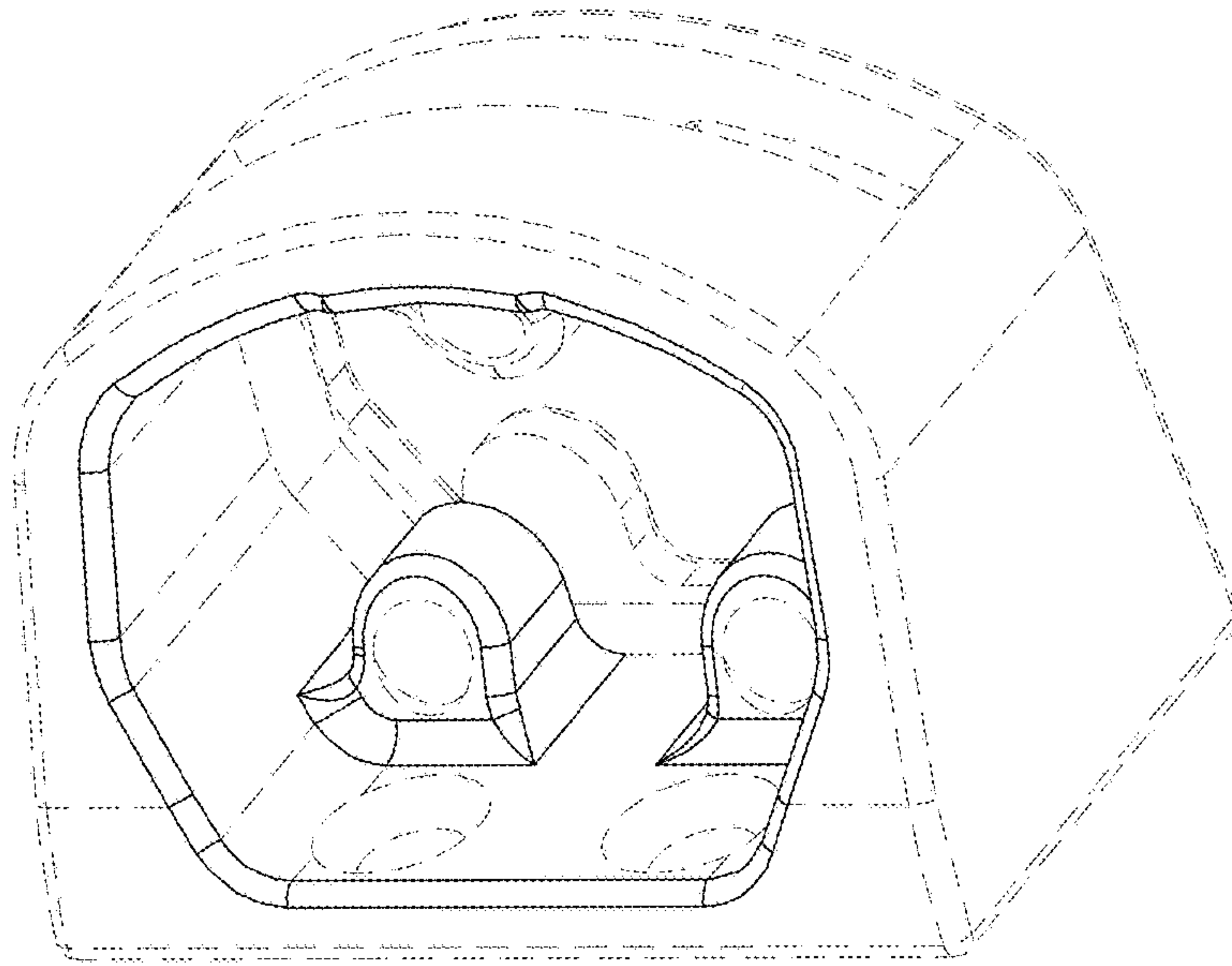

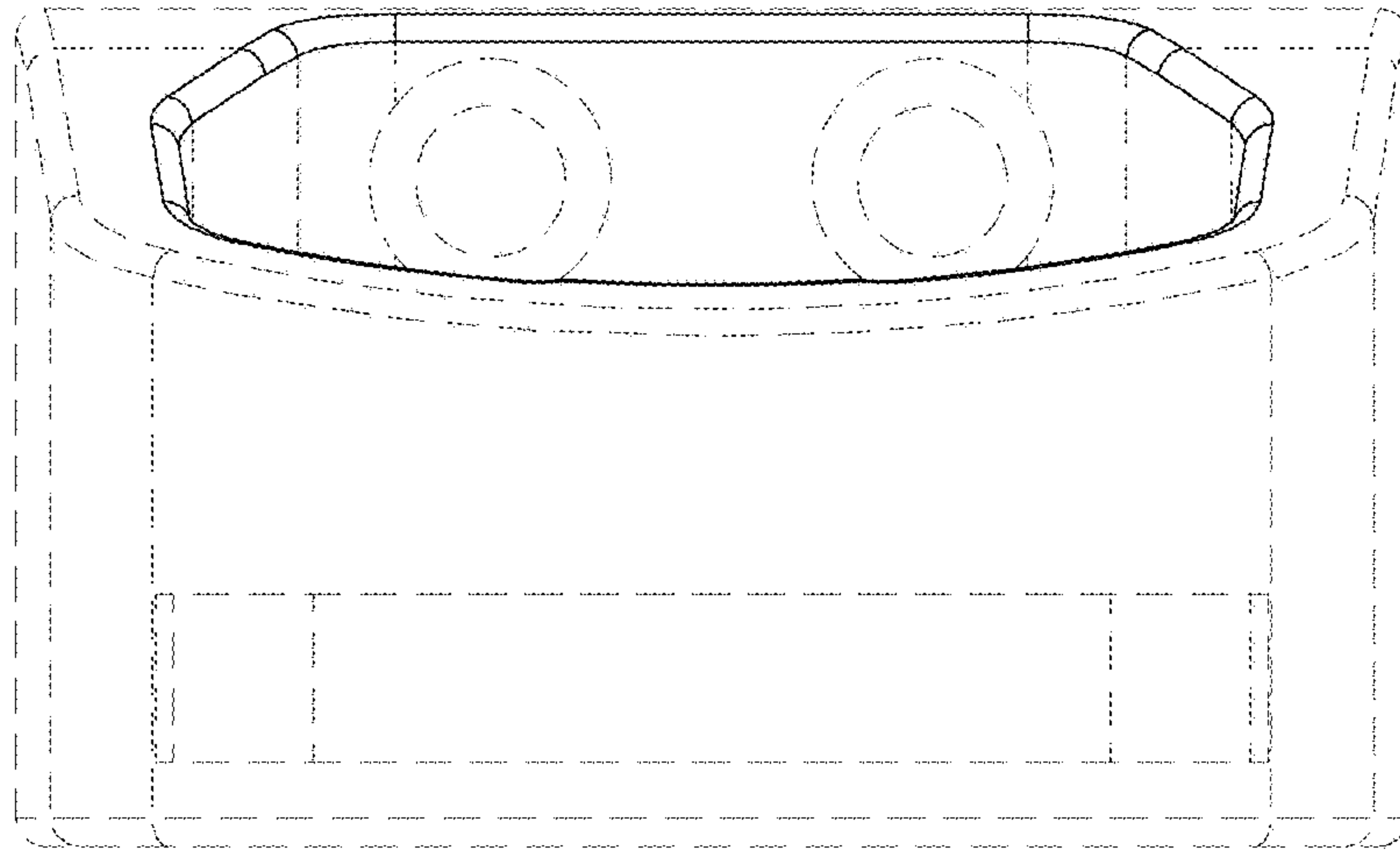

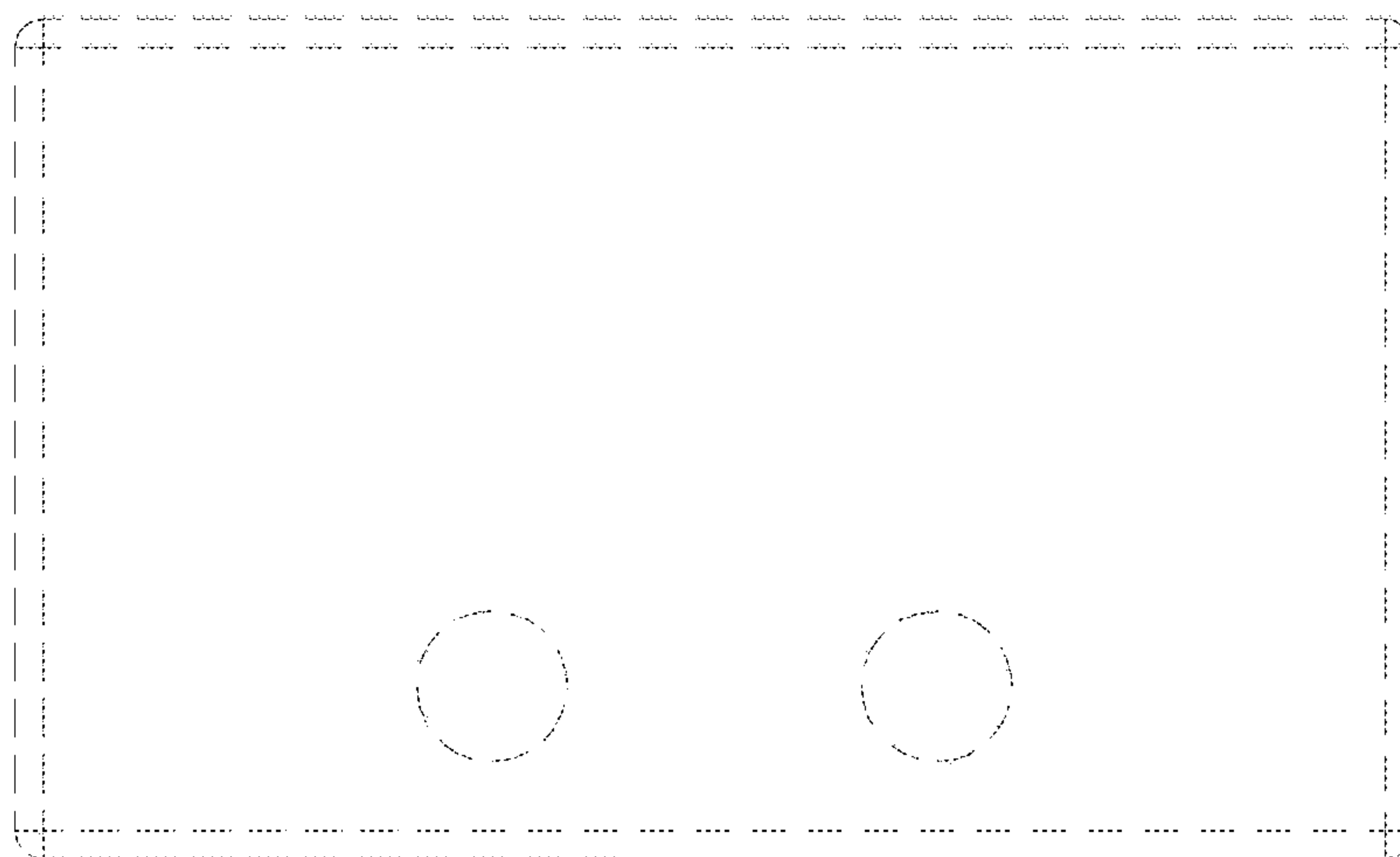

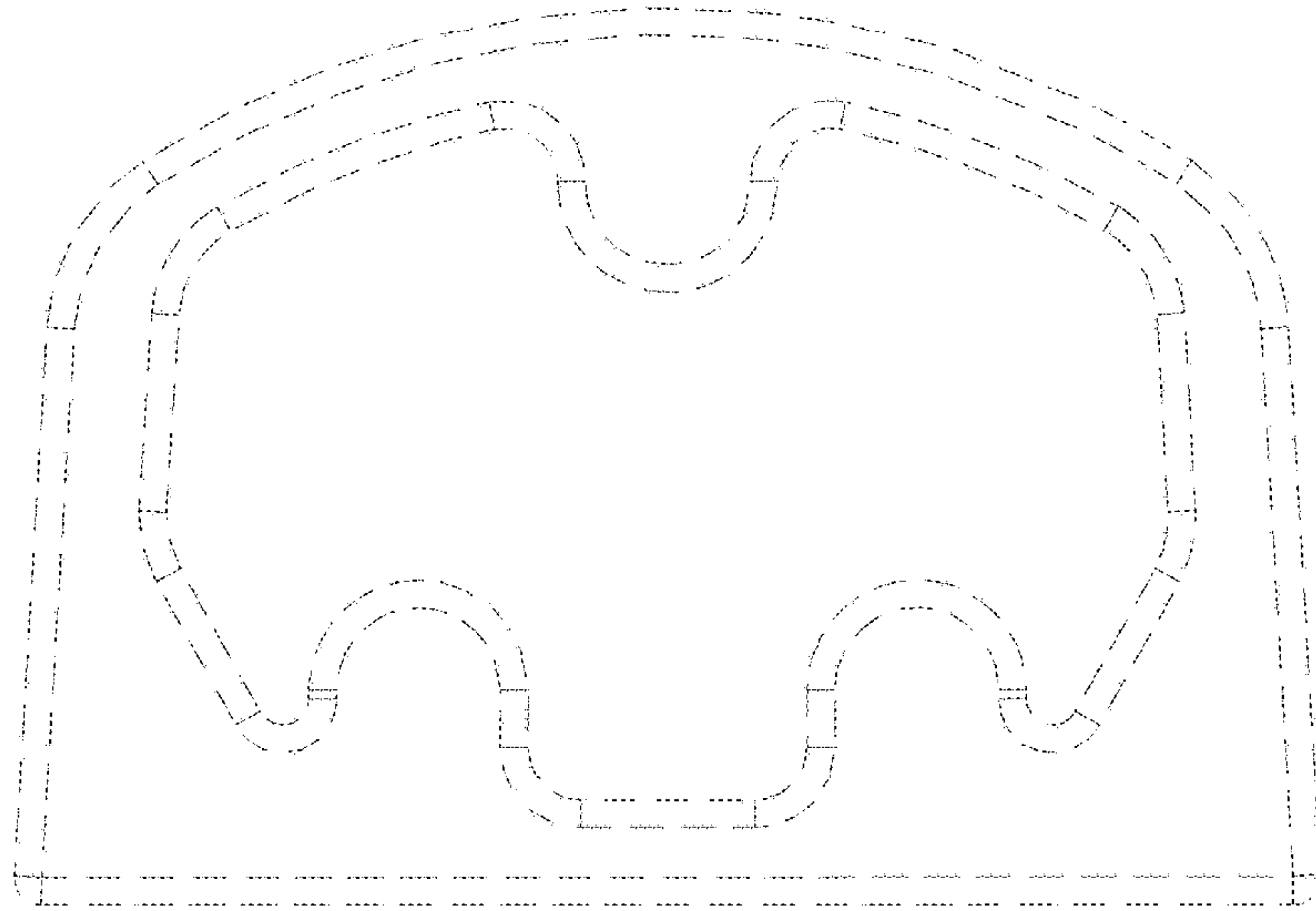

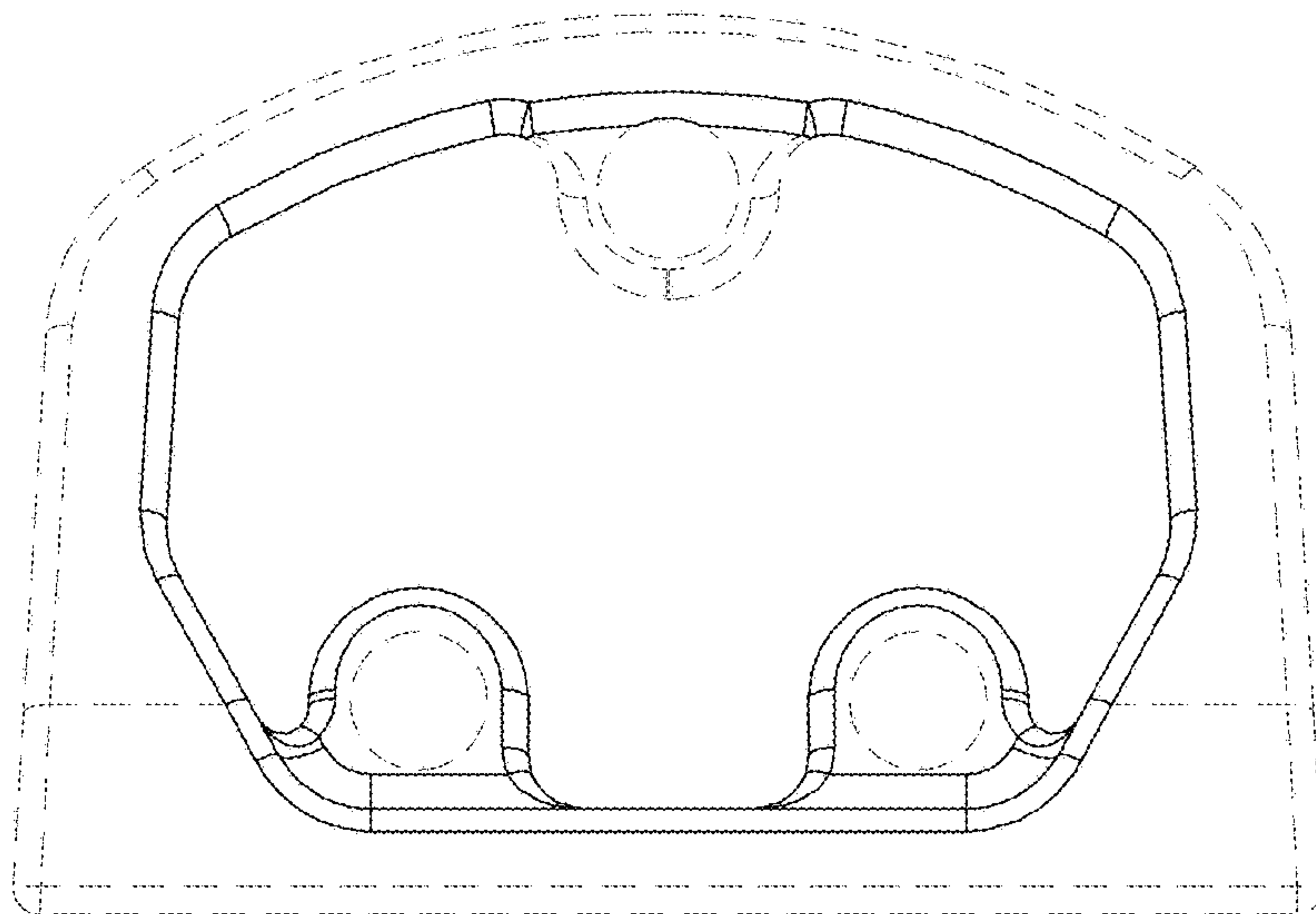

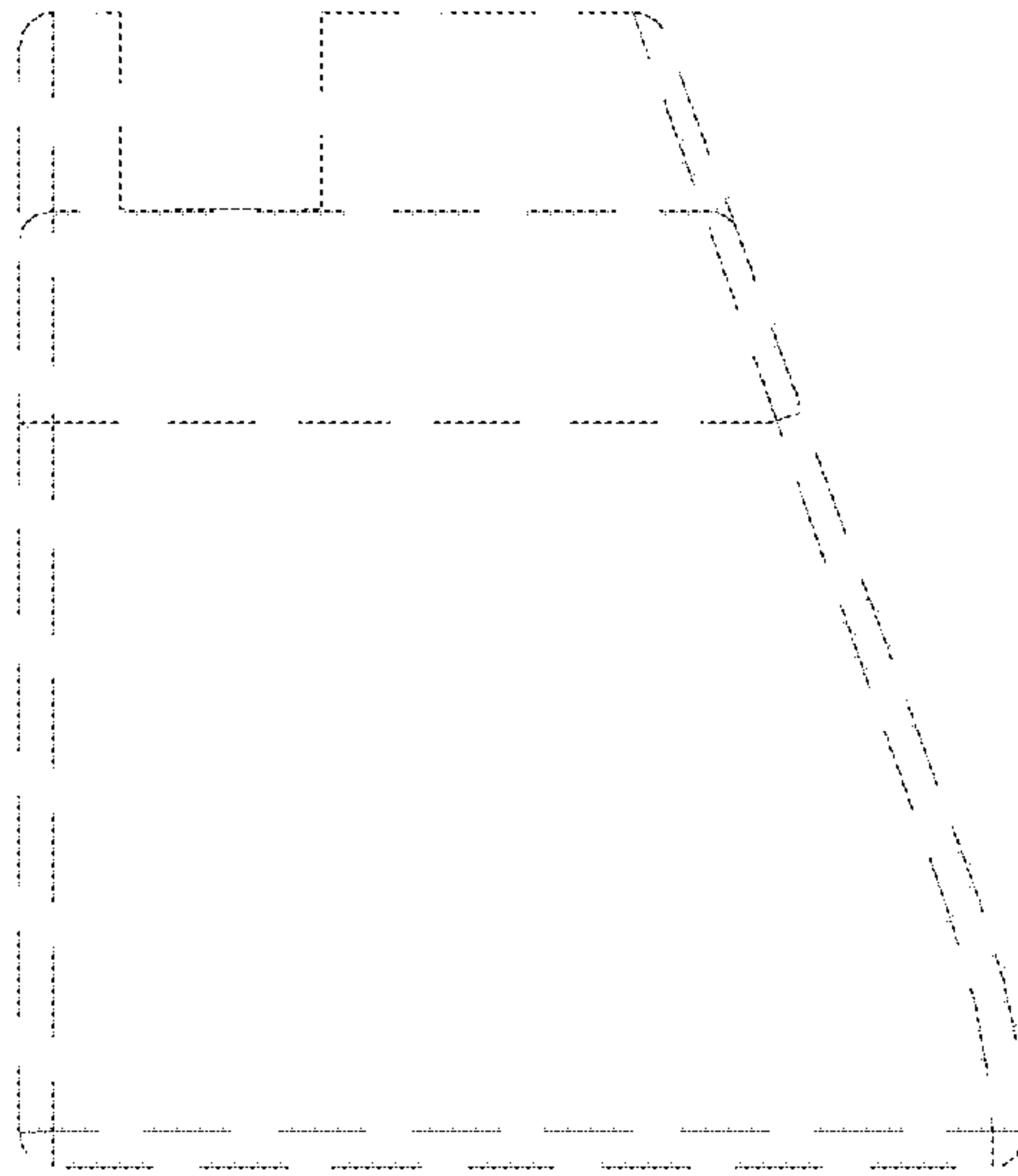

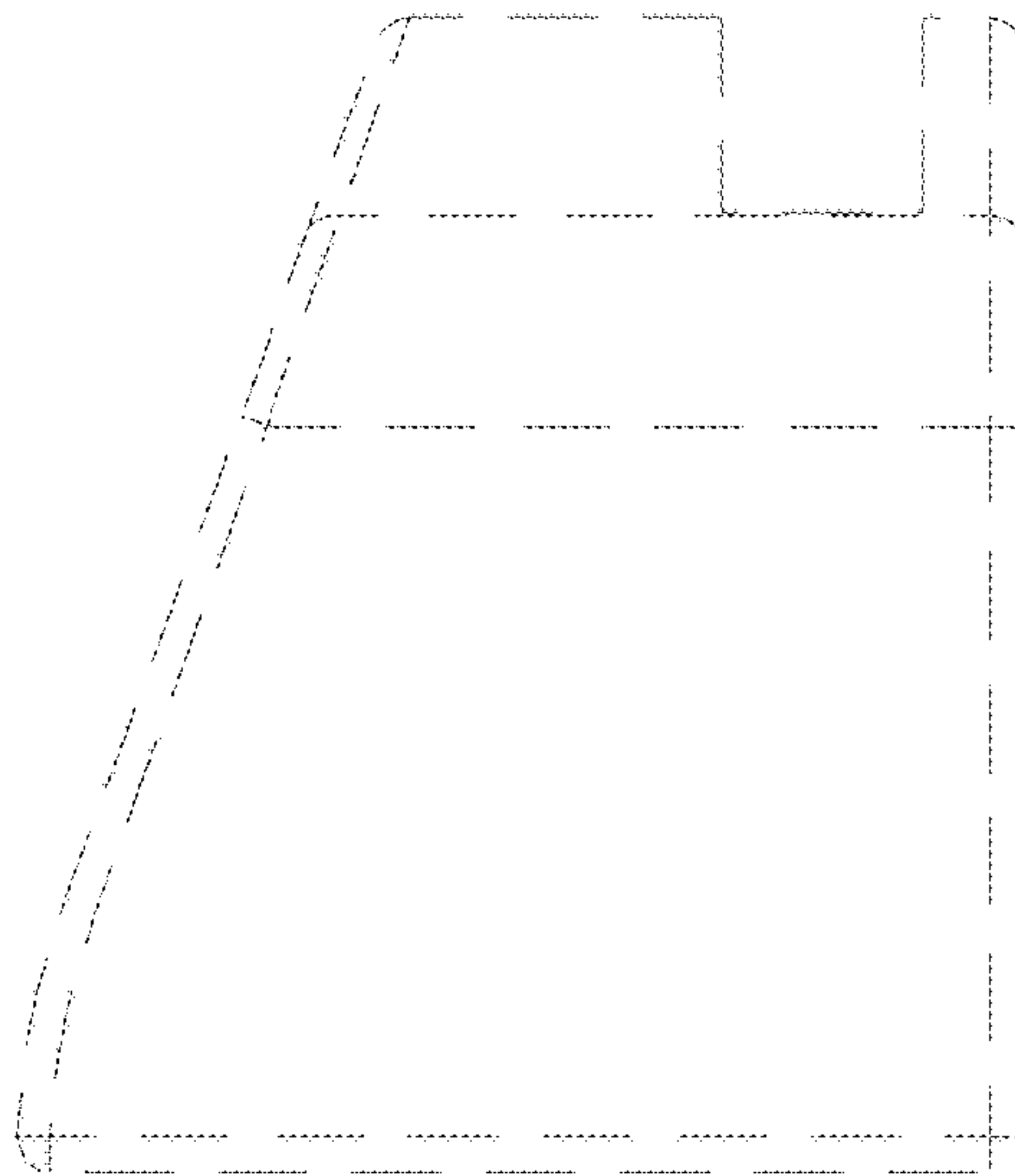

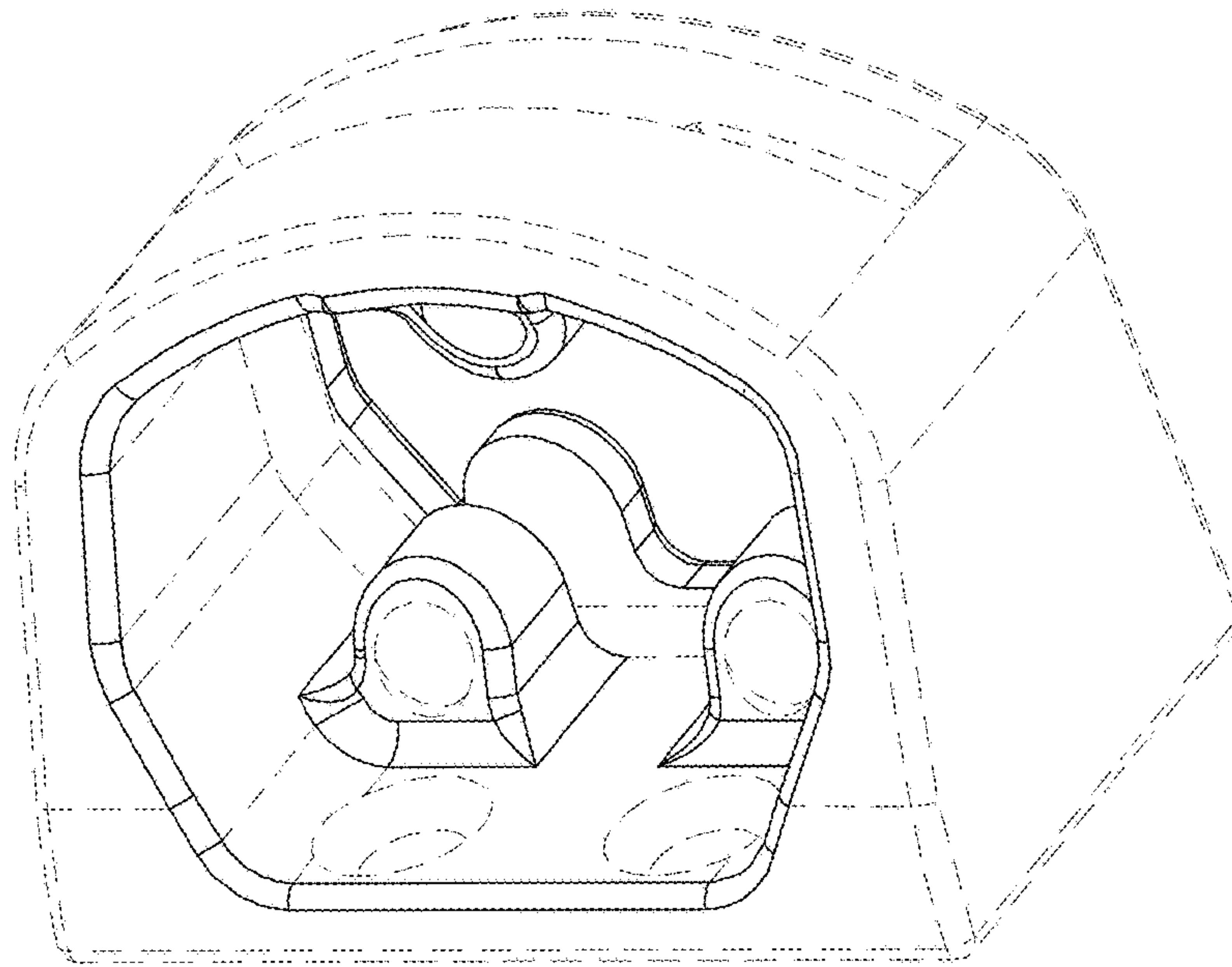

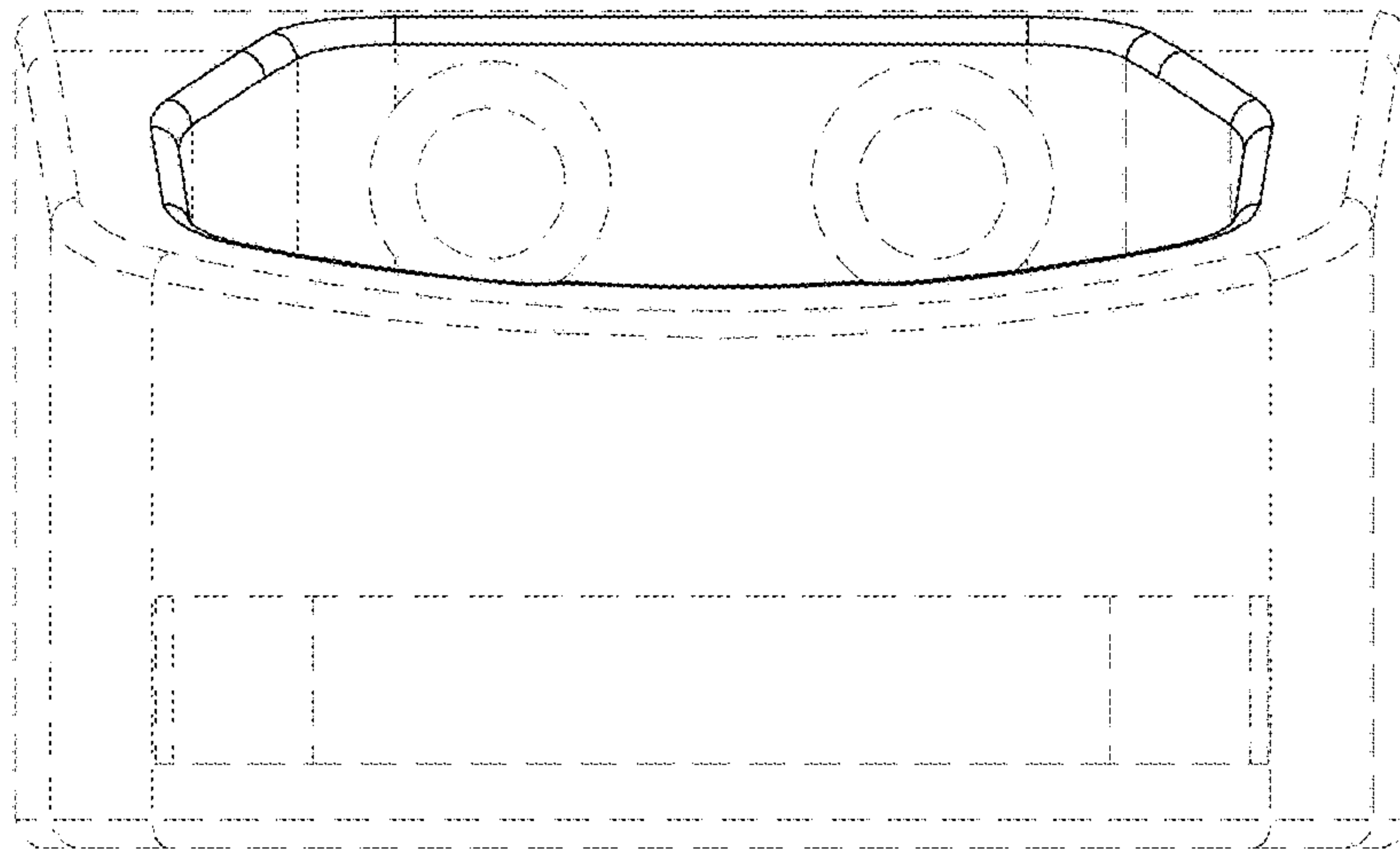

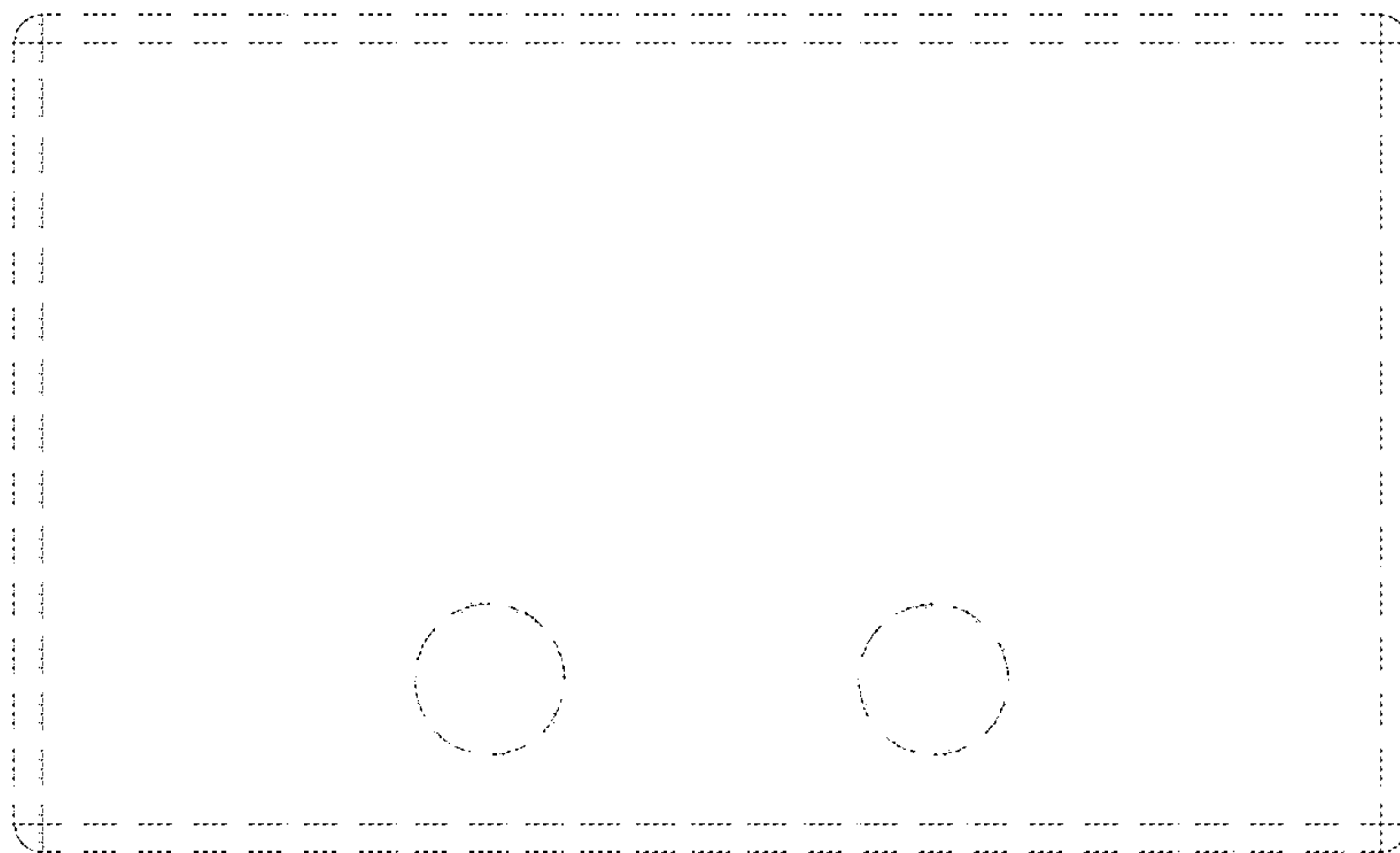

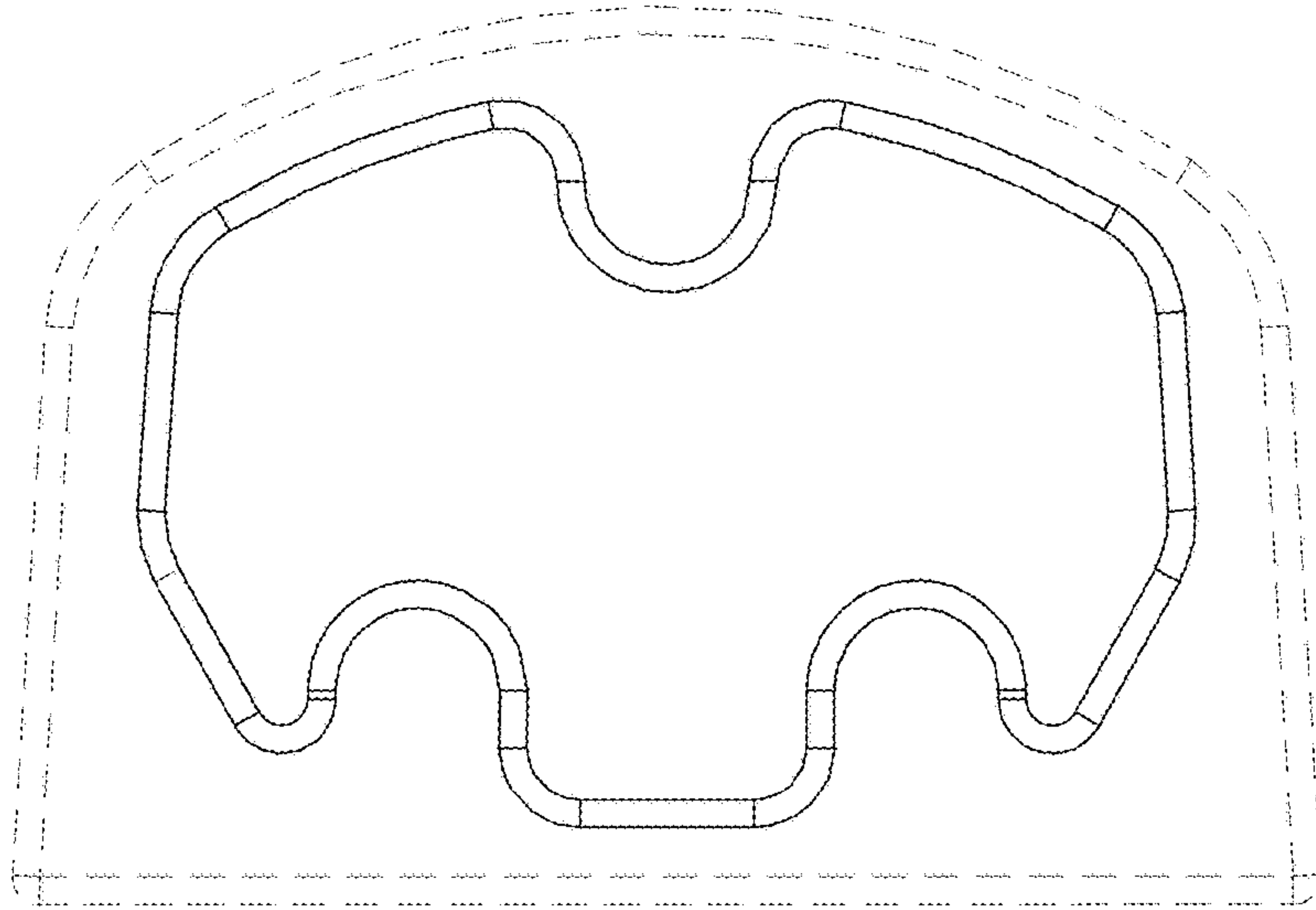

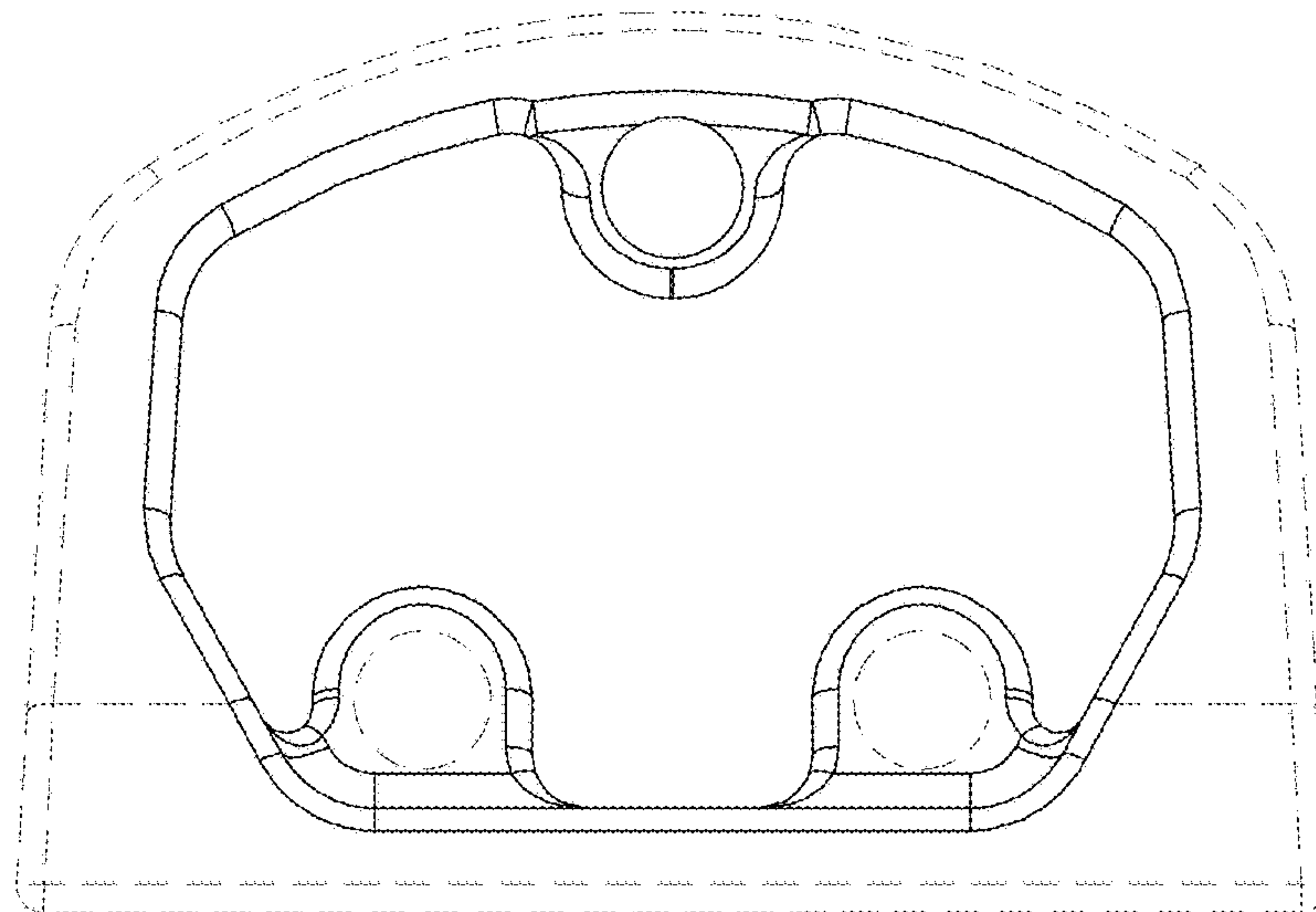

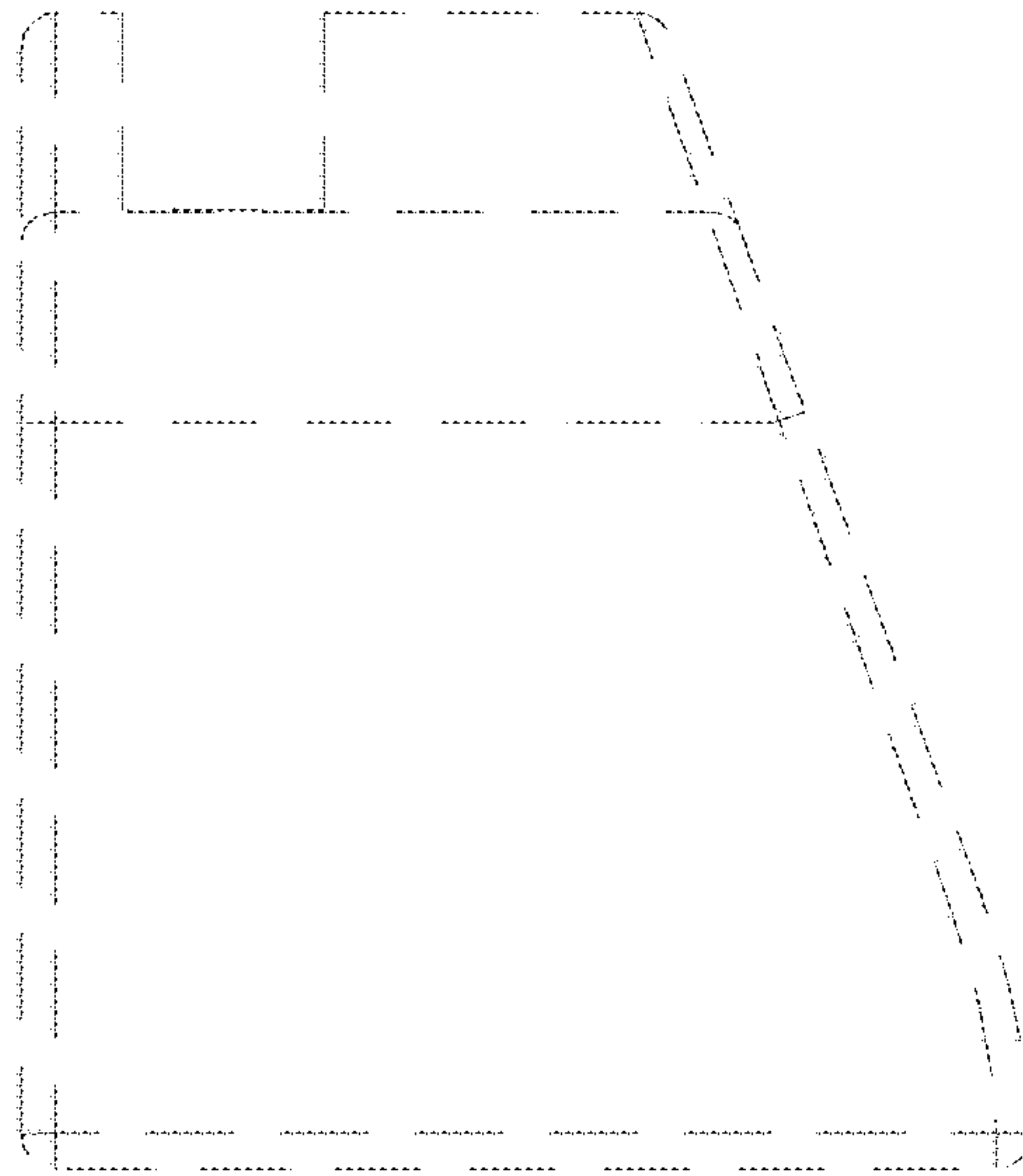

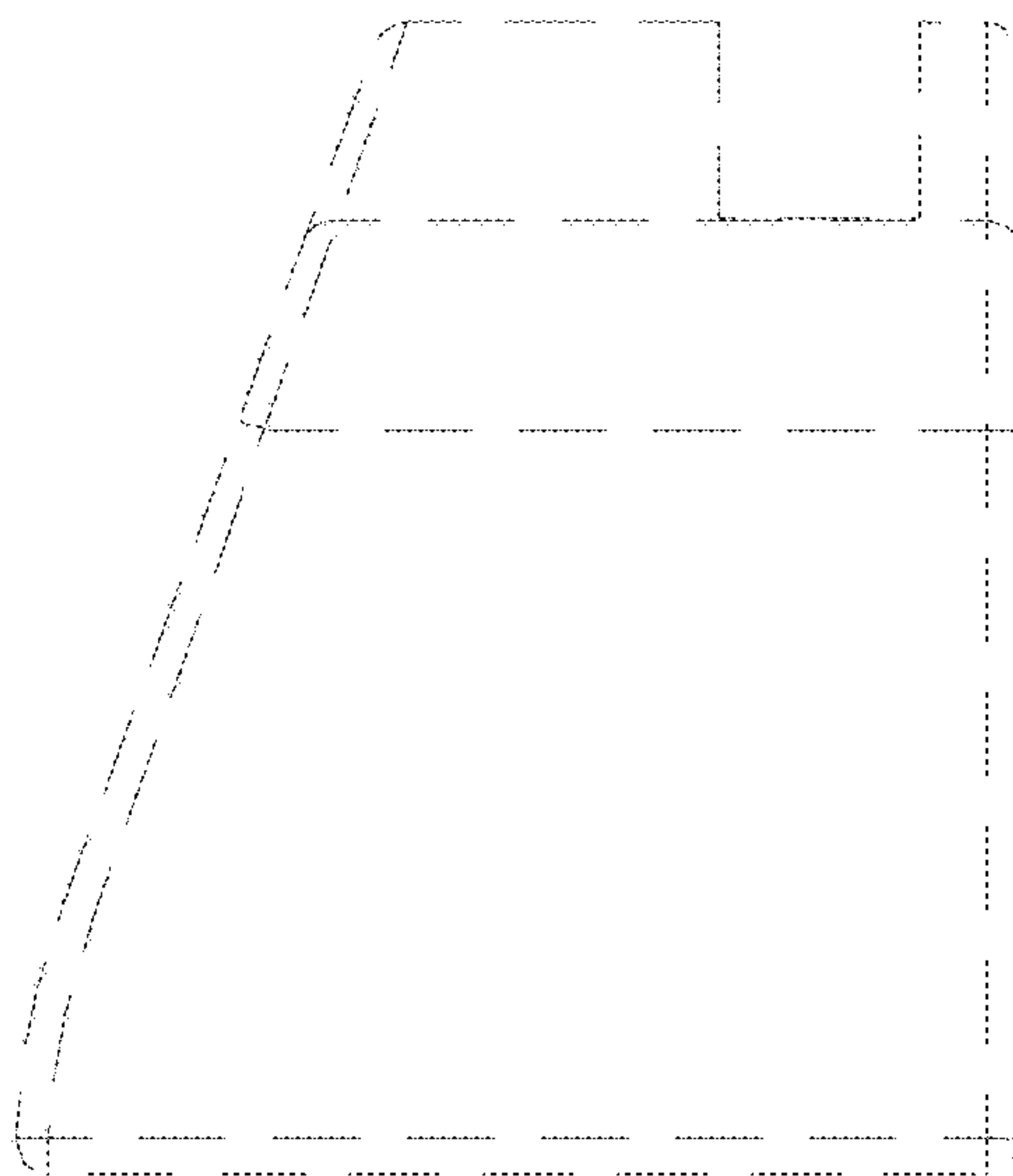
