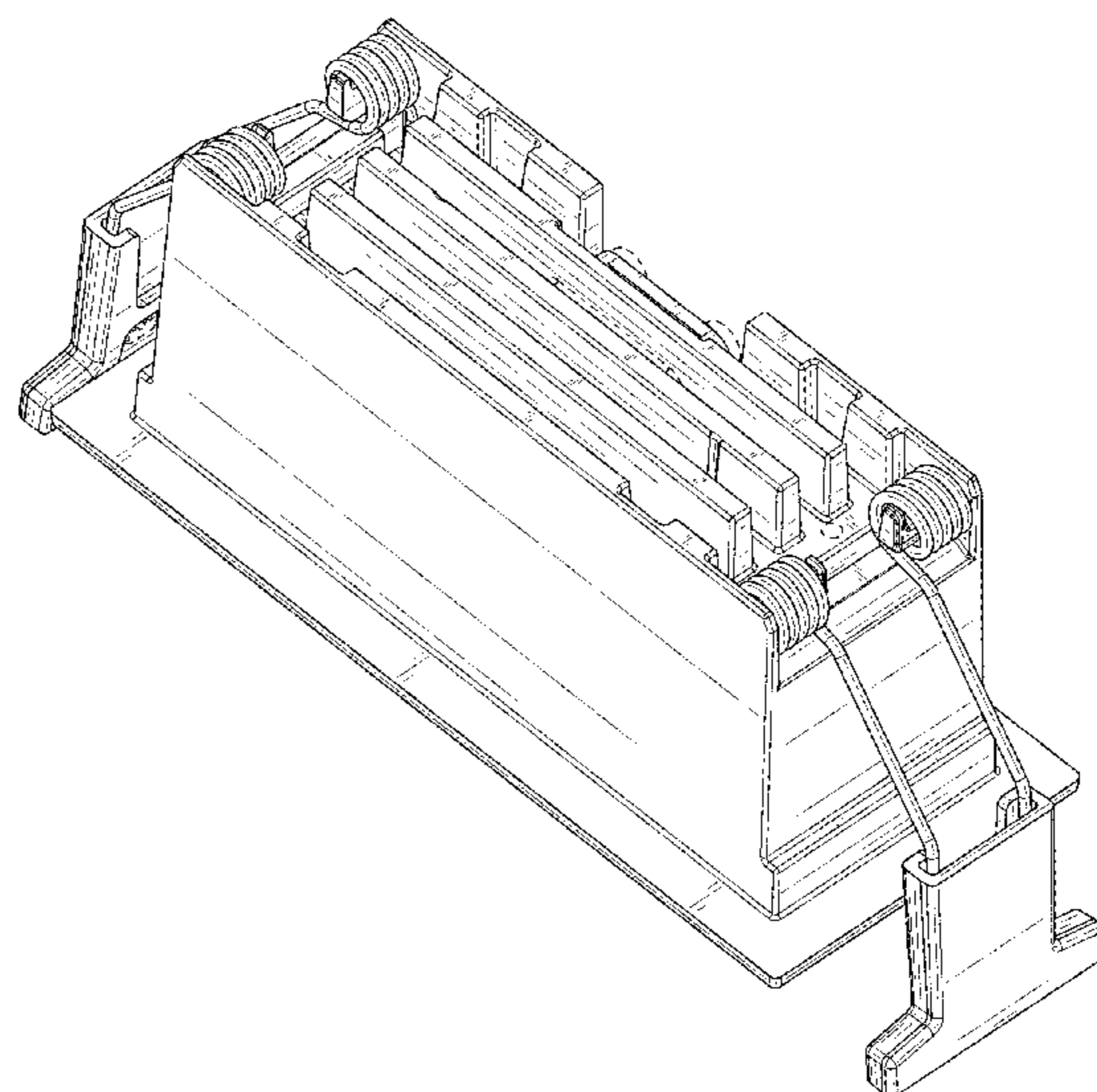
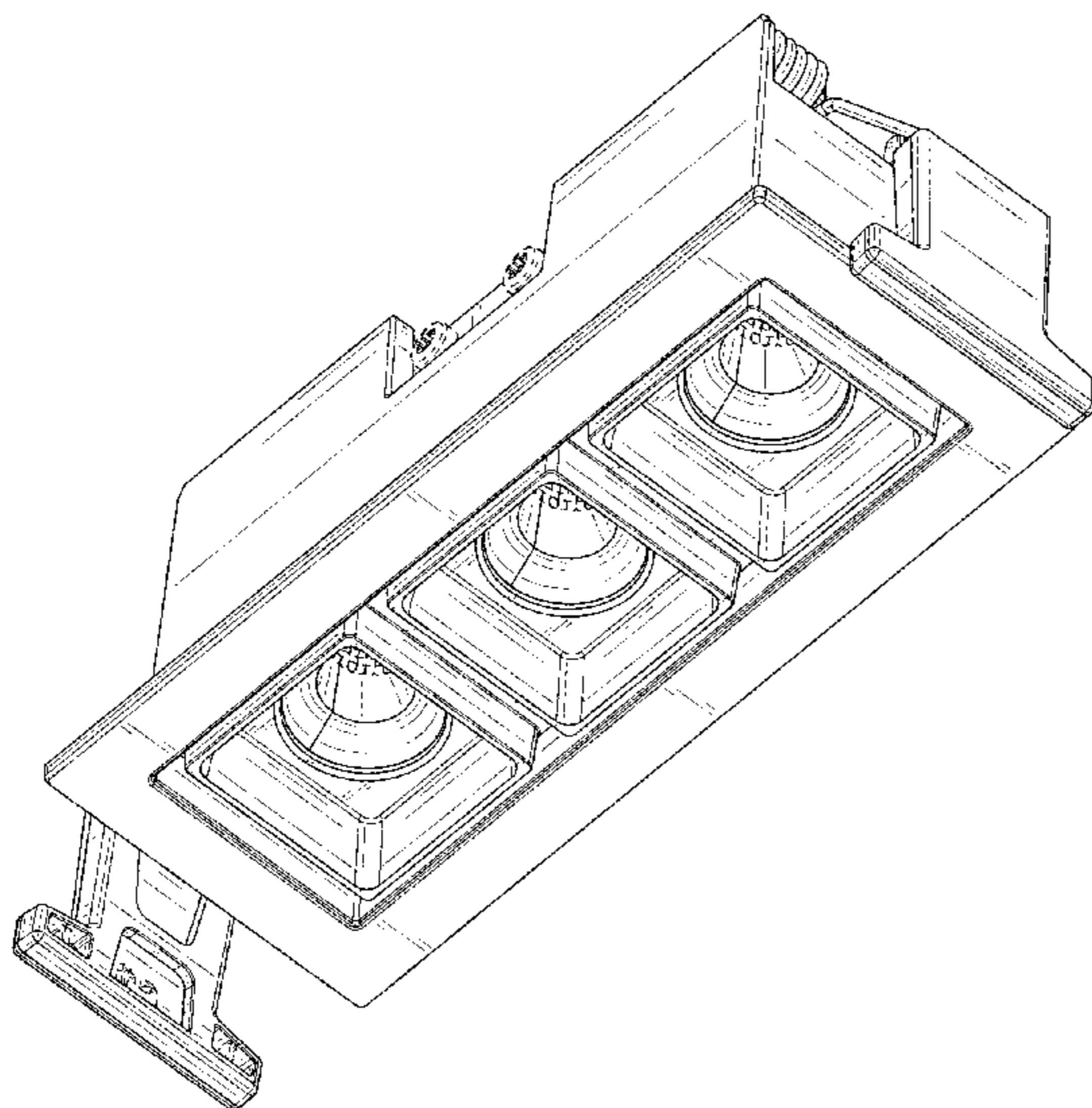
The ornamental design for a luminaire, as shown and described.

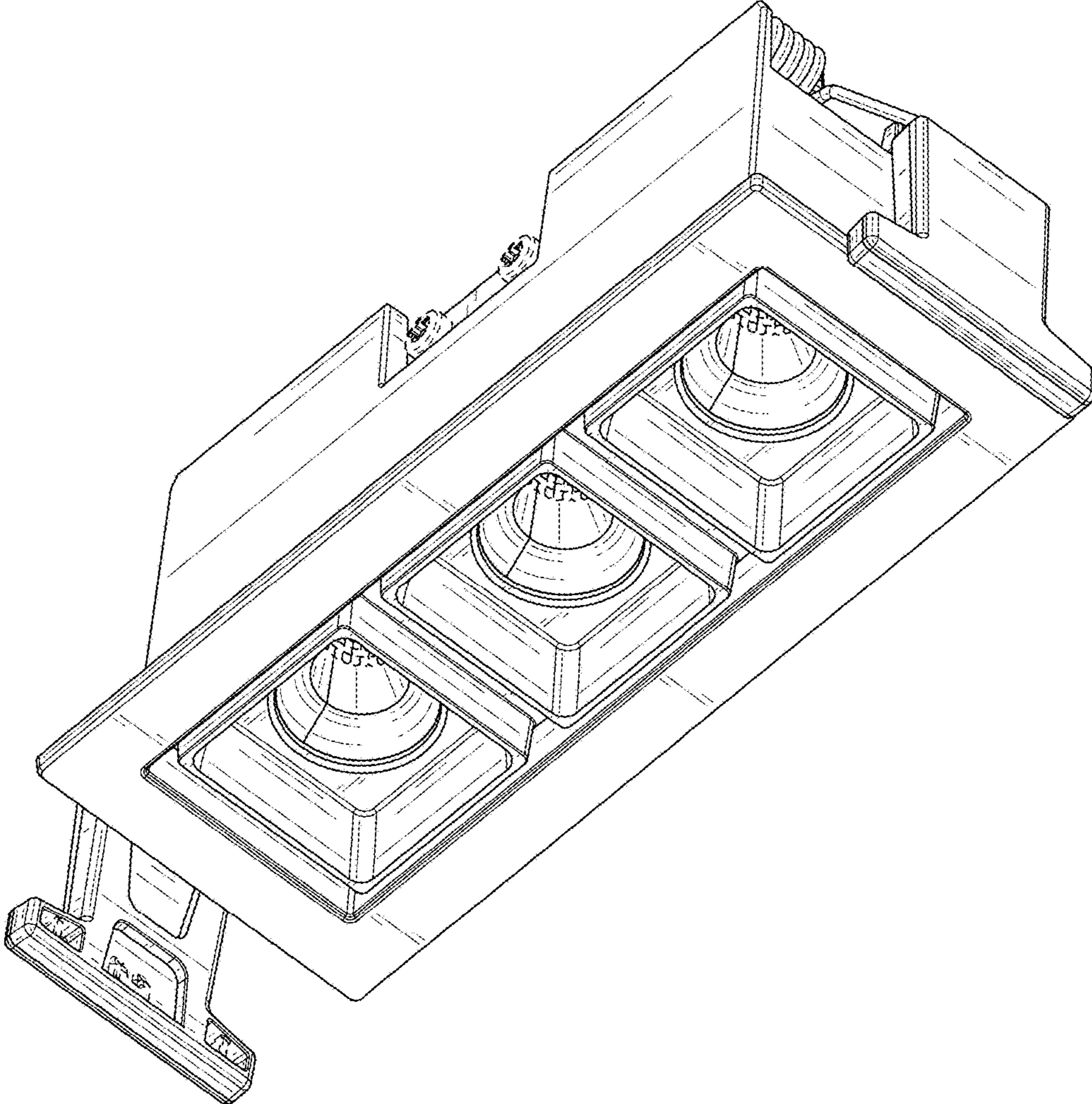

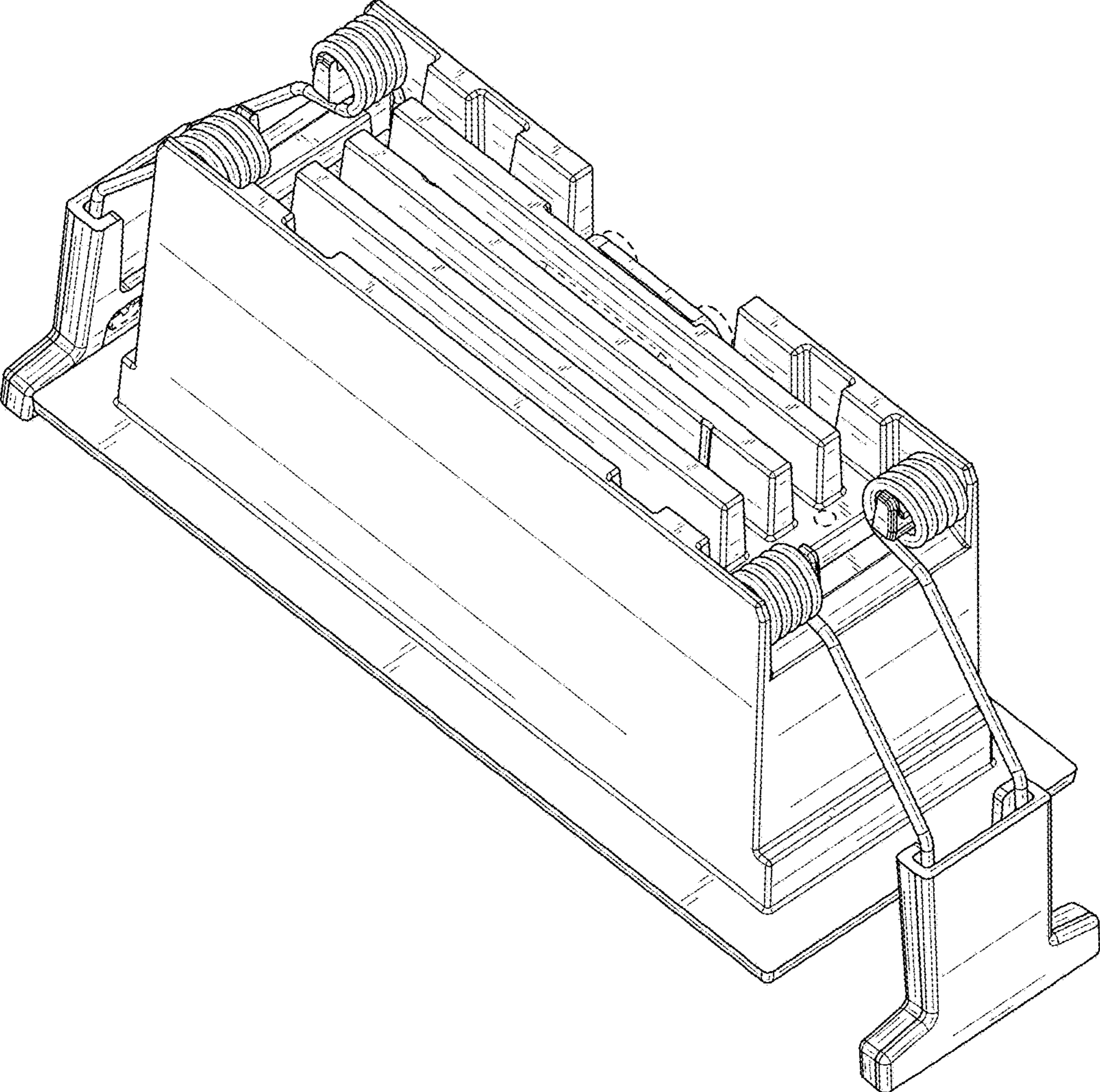

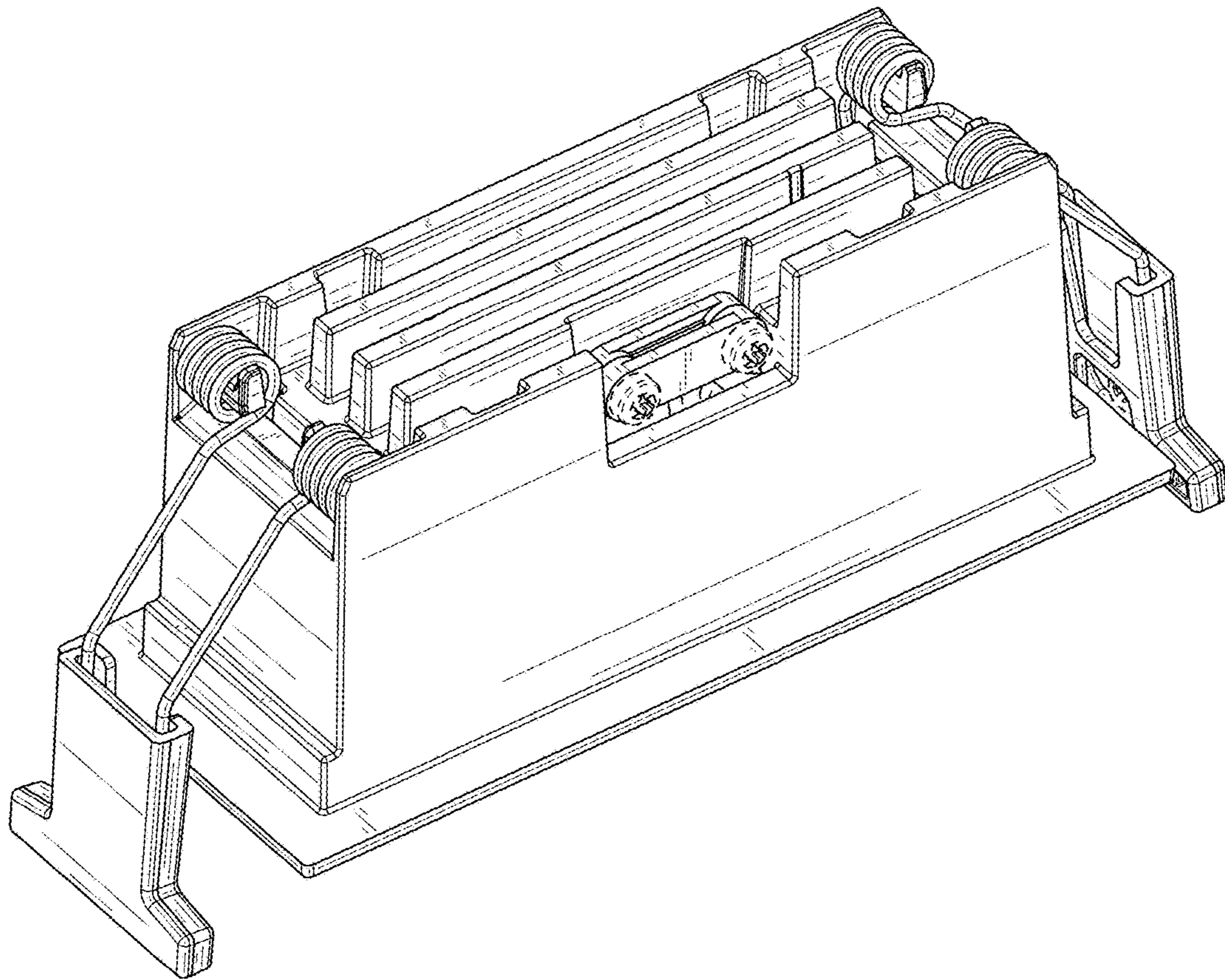

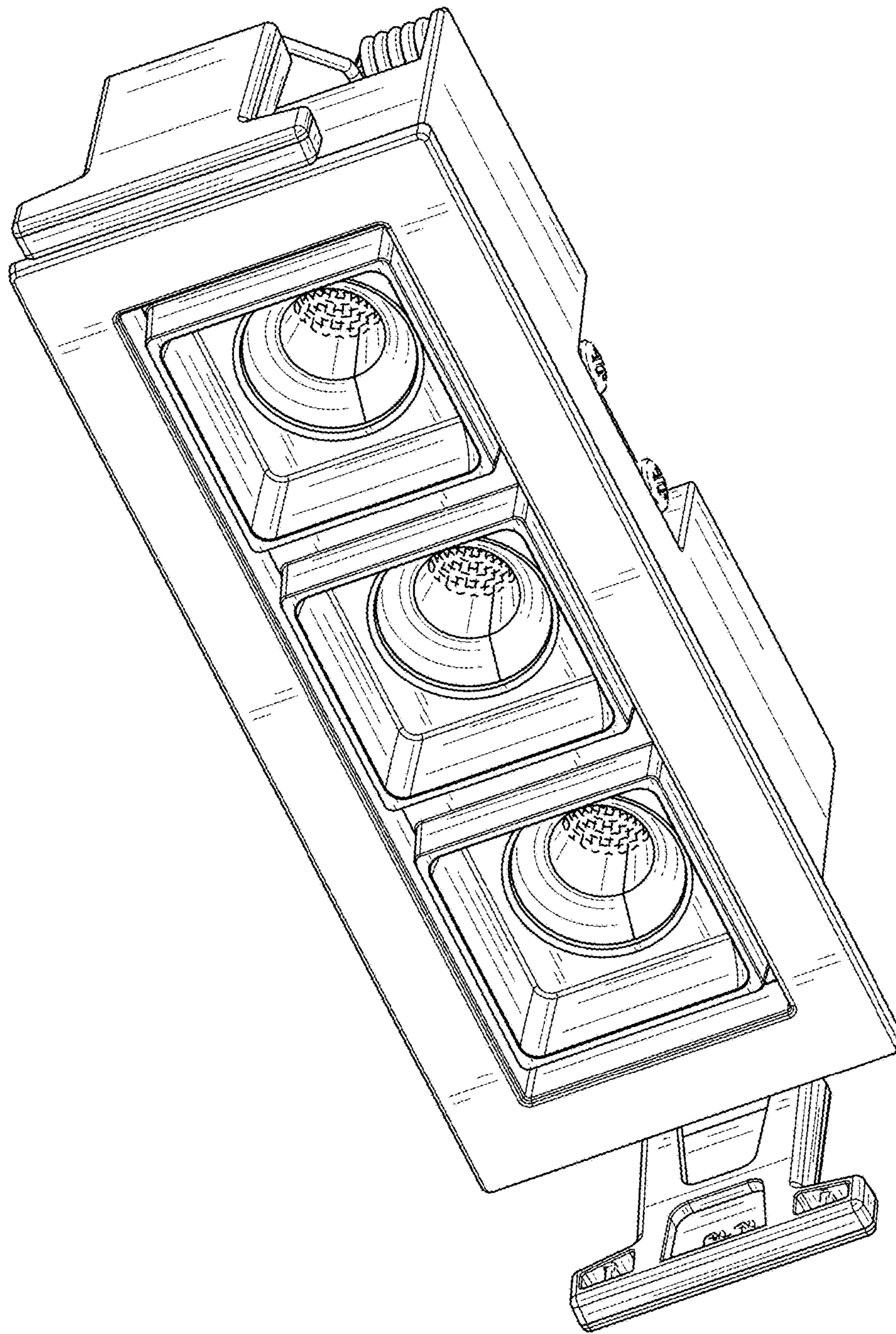

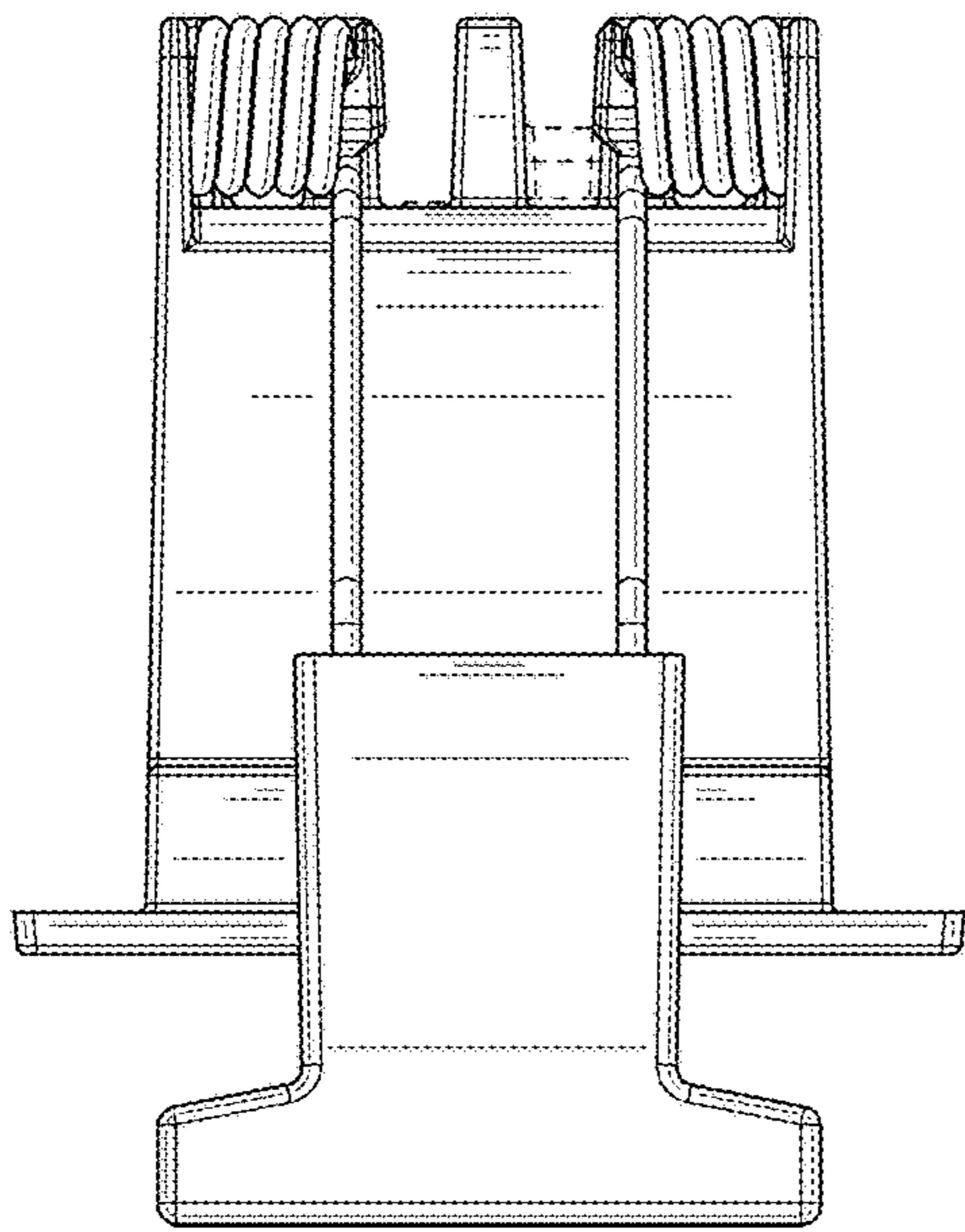

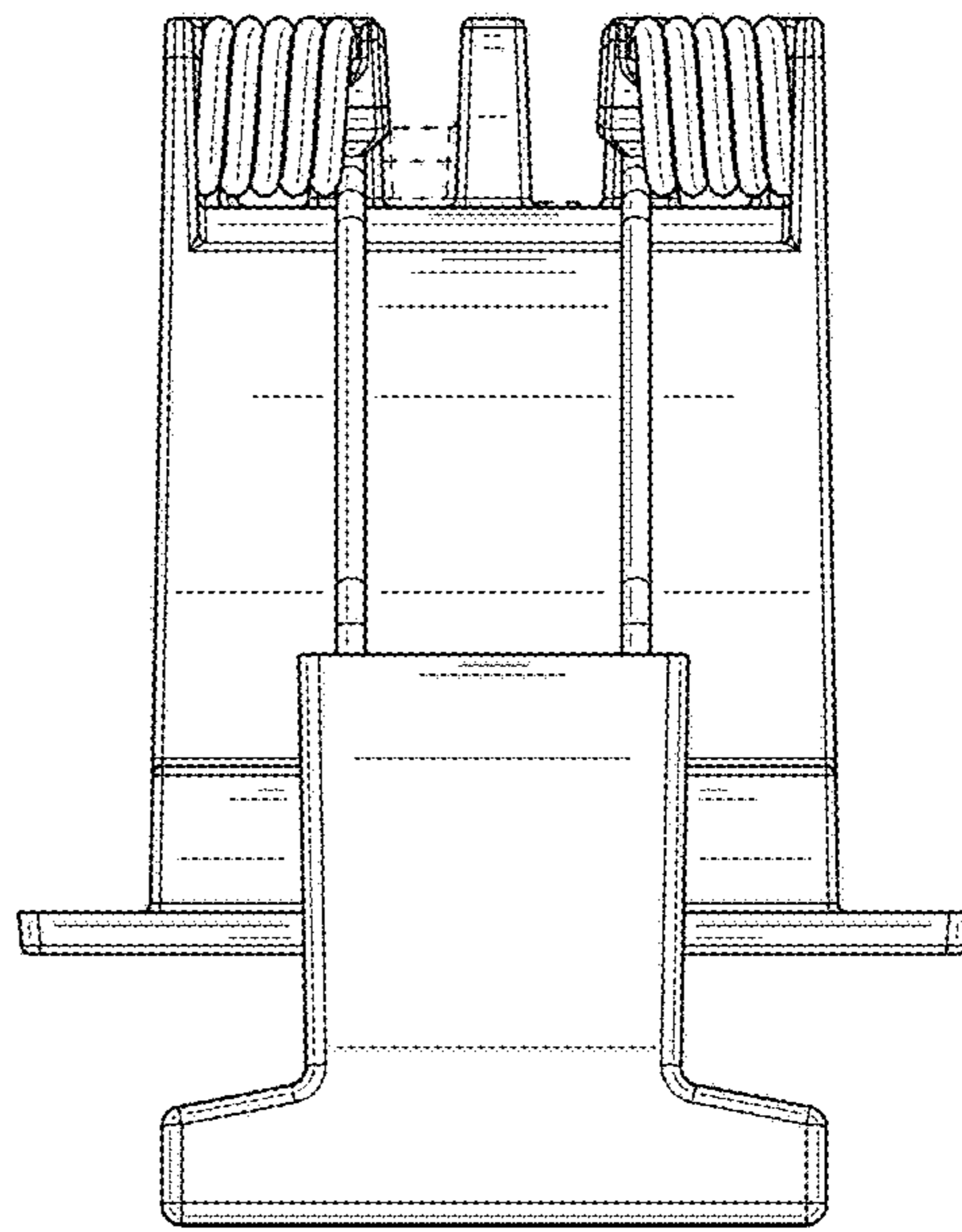

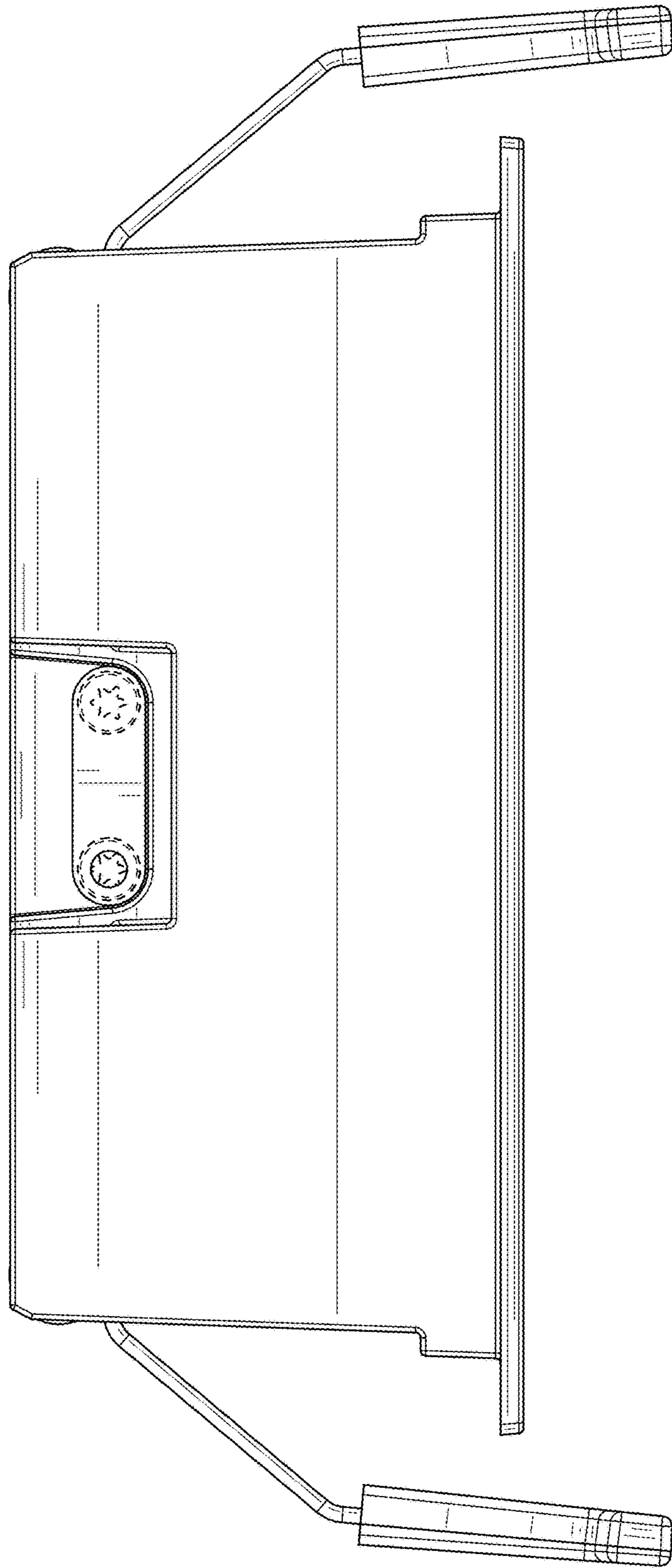

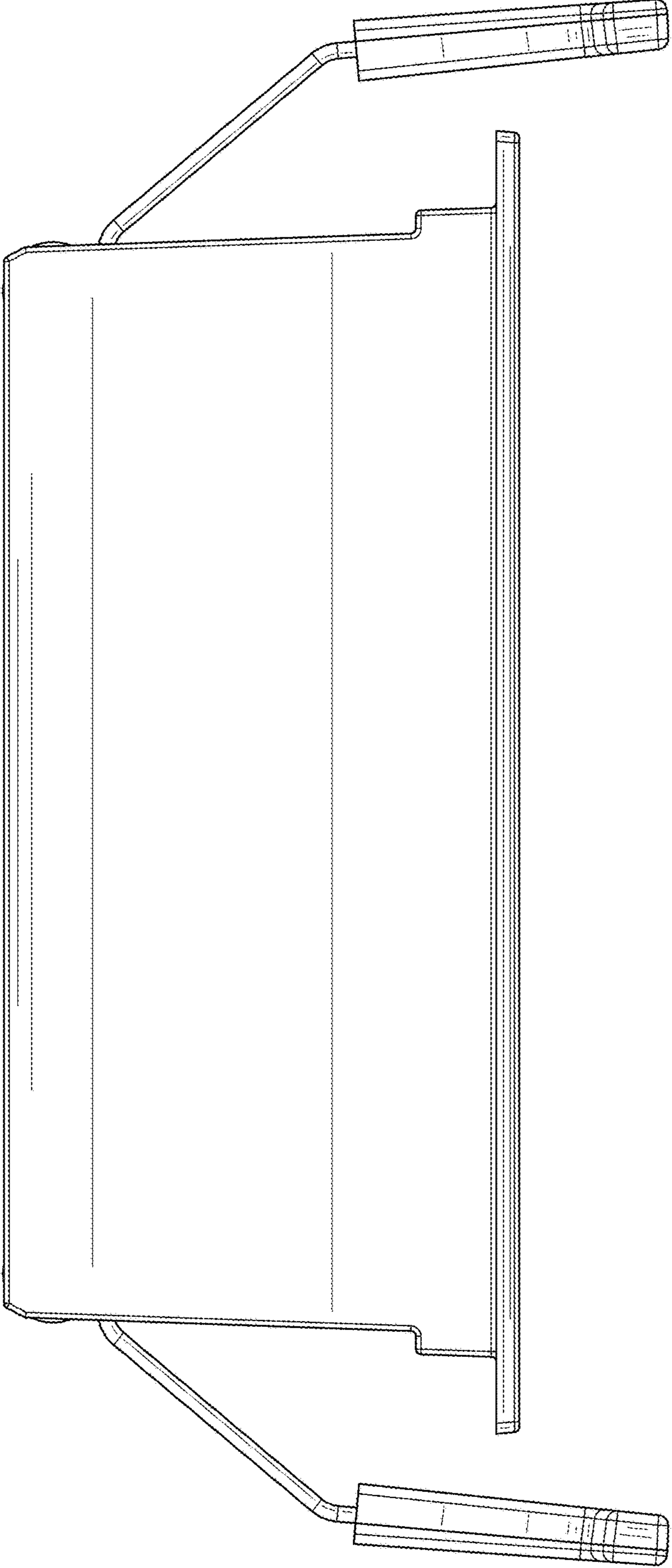

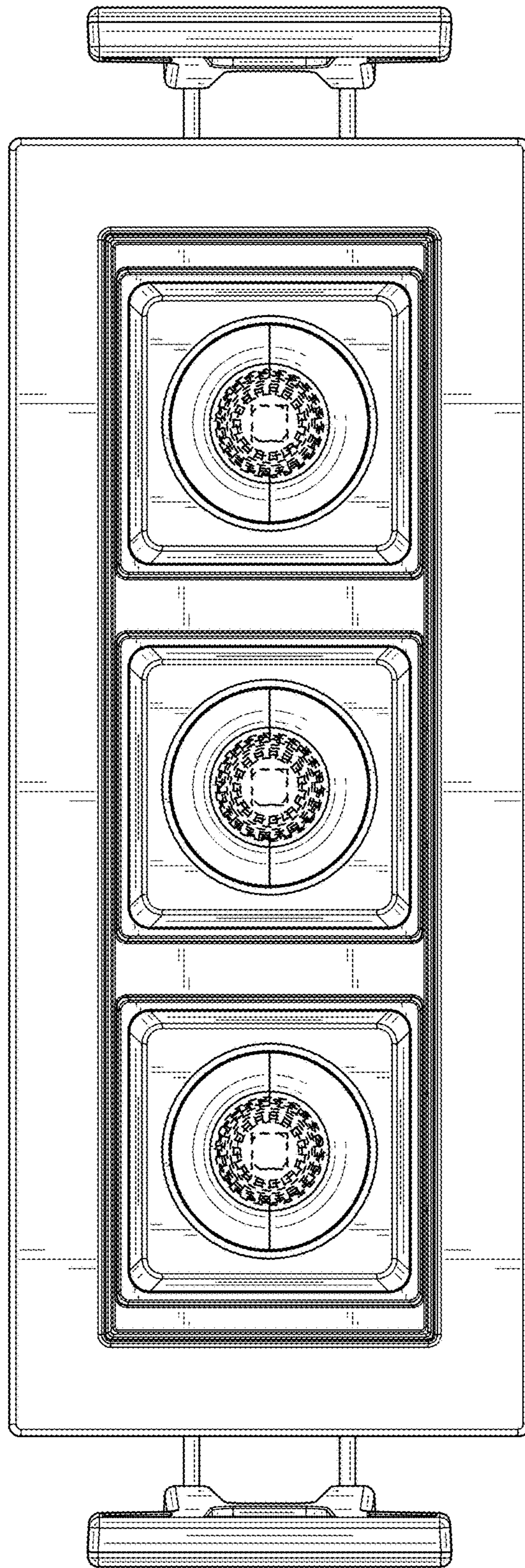

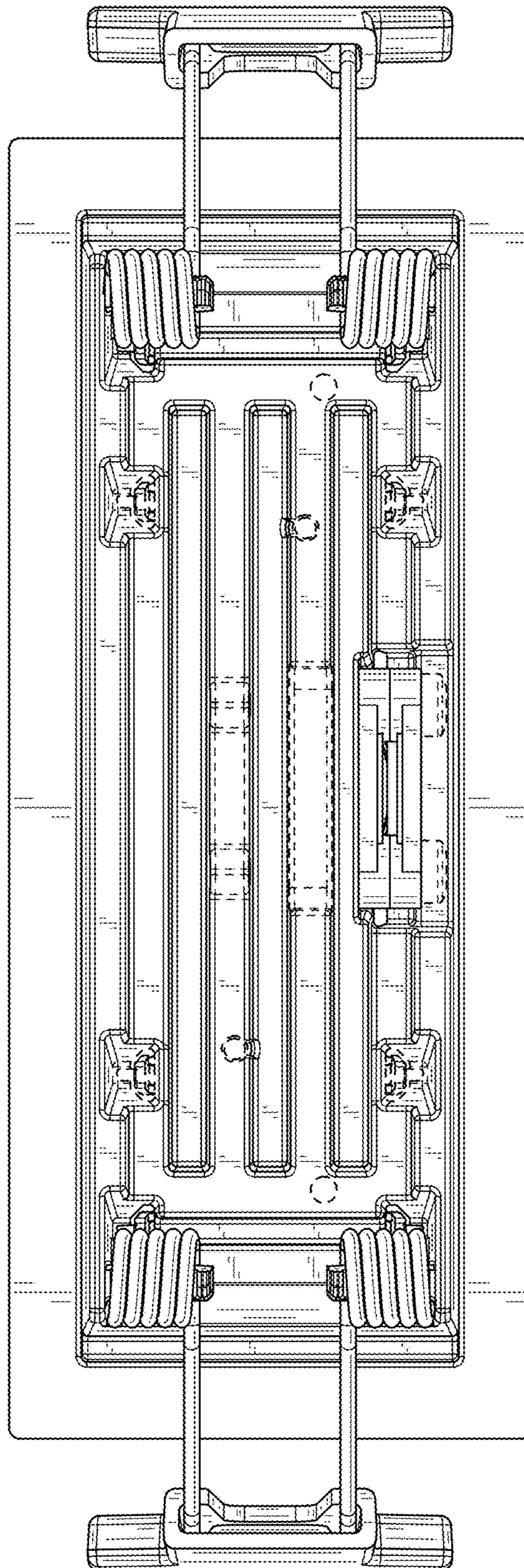
