(57) **CLAIM**

I claim the ornamental design for an light fixture, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom front perspective view of an light fixture showing the new design;

FIG. 2 is a top front perspective view of the light fixture thereof;

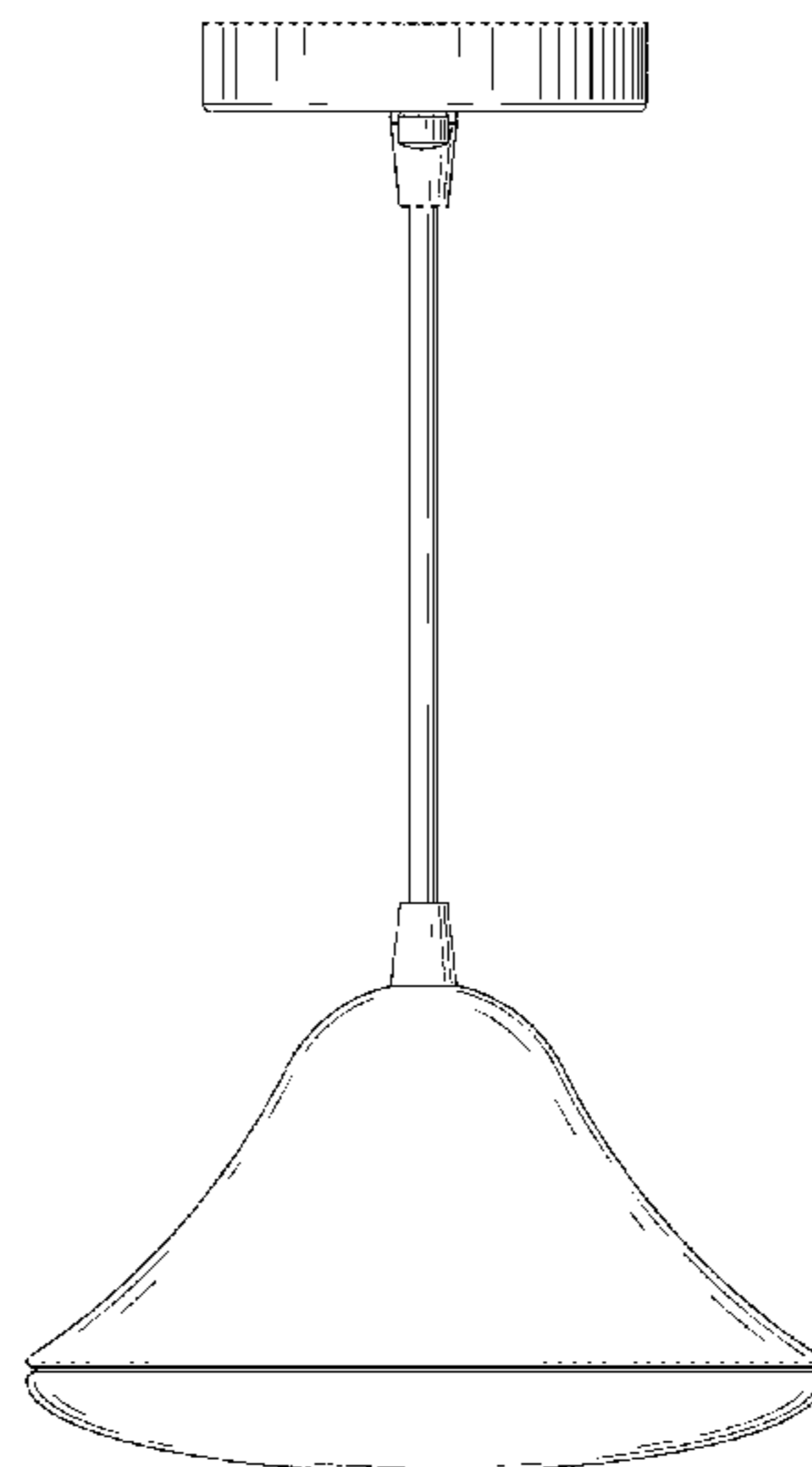
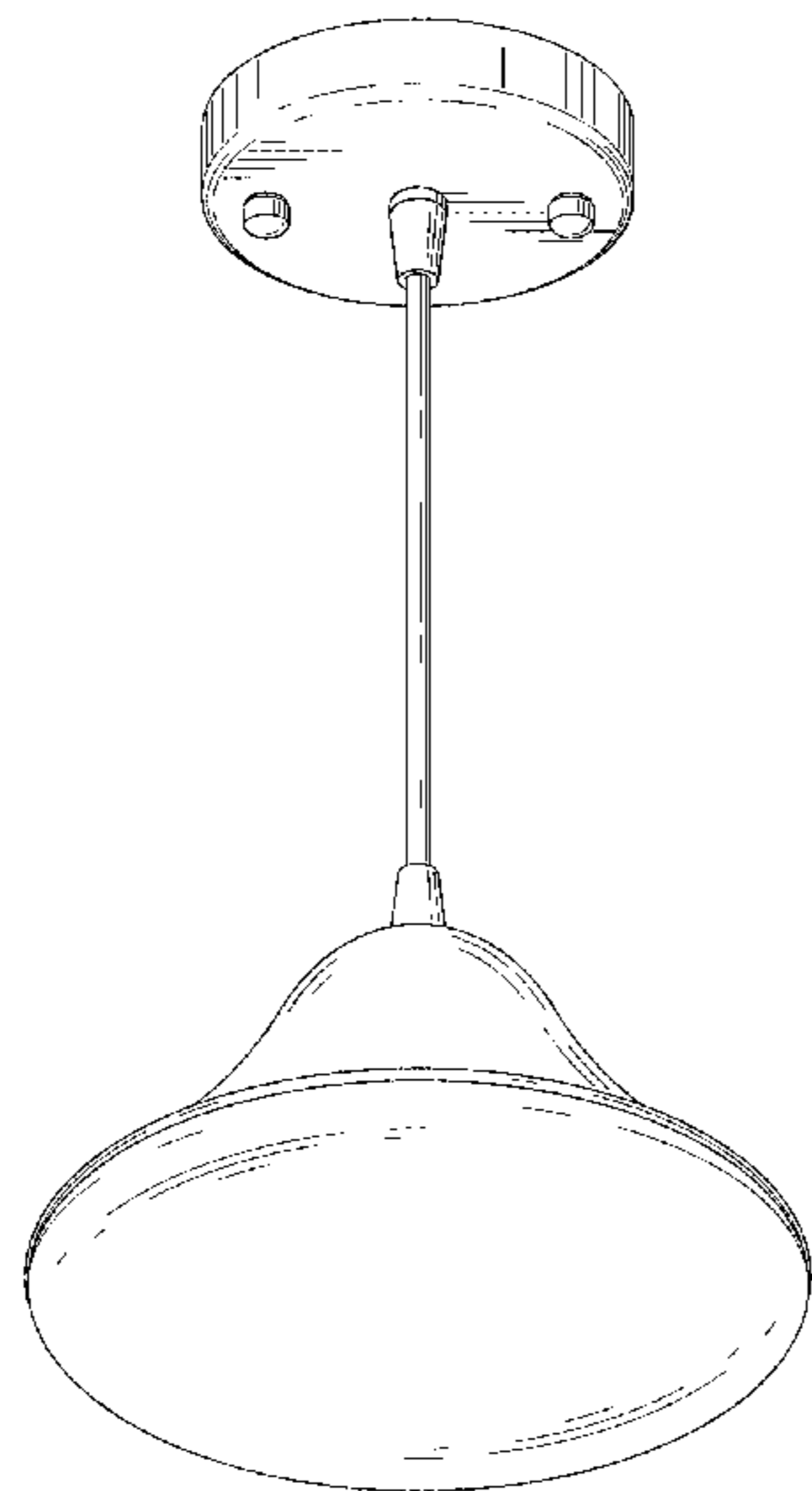
FIG. 3 is a left side elevation view of the light fixture thereof, which is identical to the right side elevation view;

FIG. 4 is a front side elevation view of the light fixture thereof, which is identical to the back side elevation view;

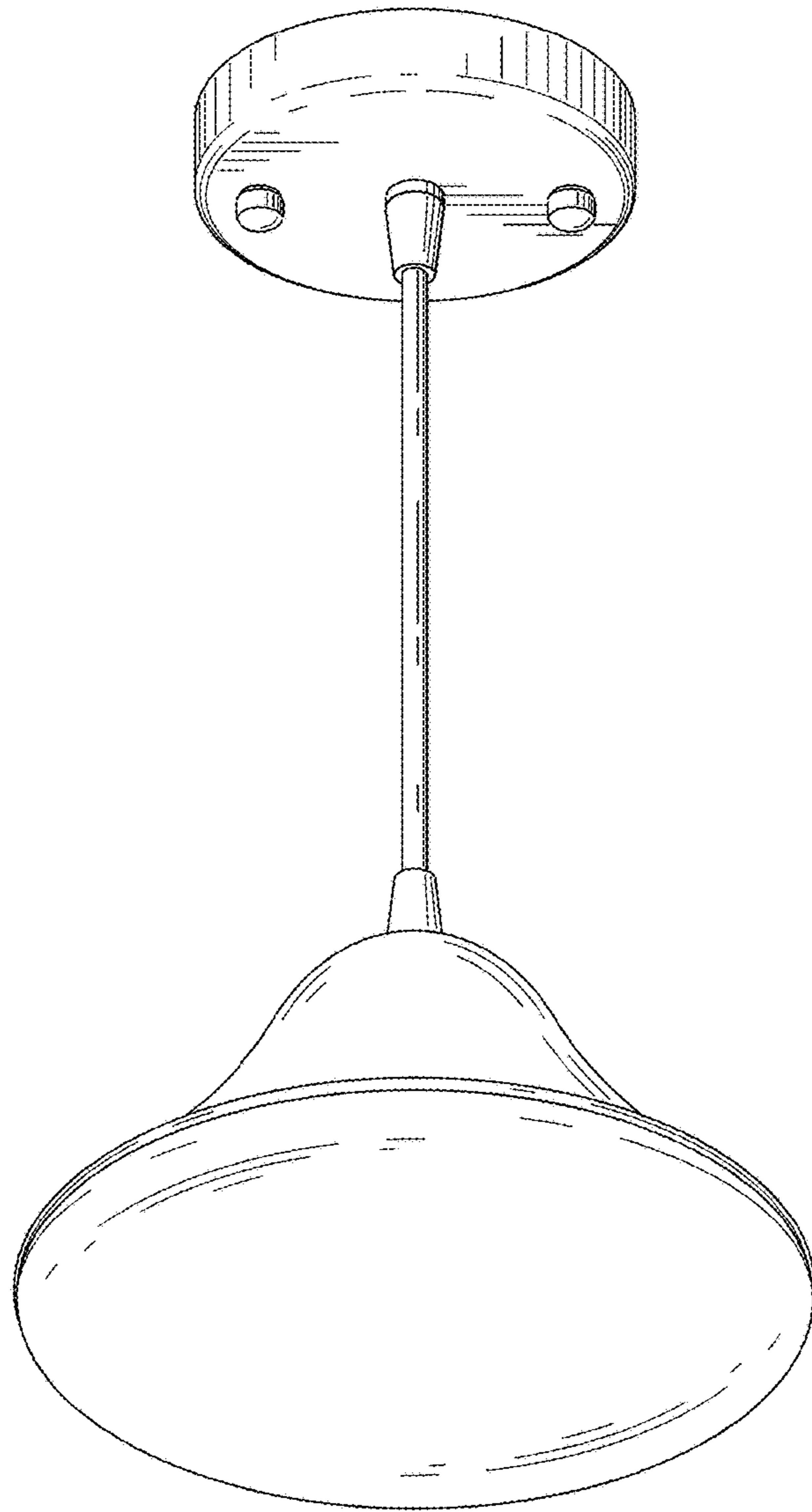

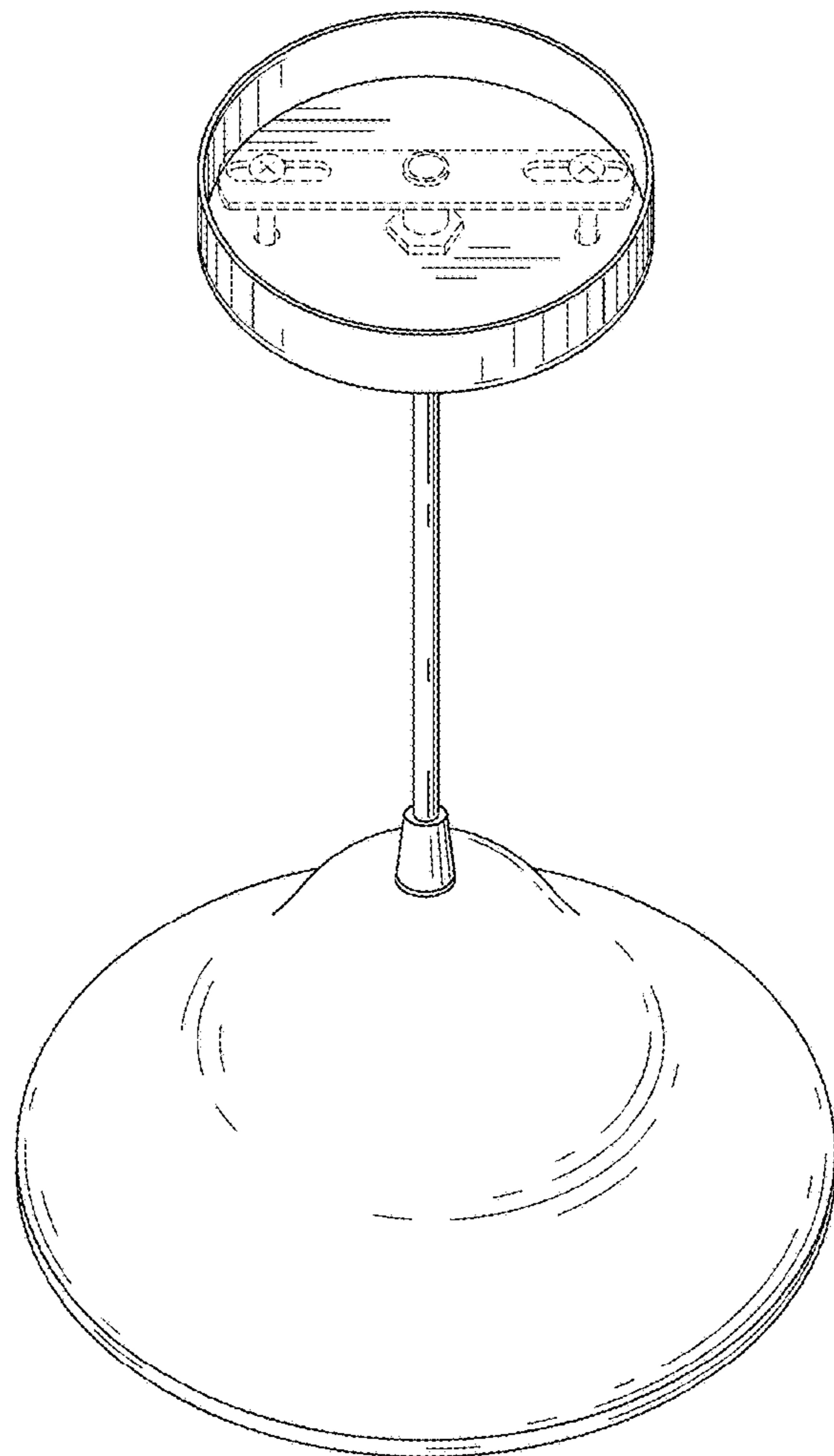

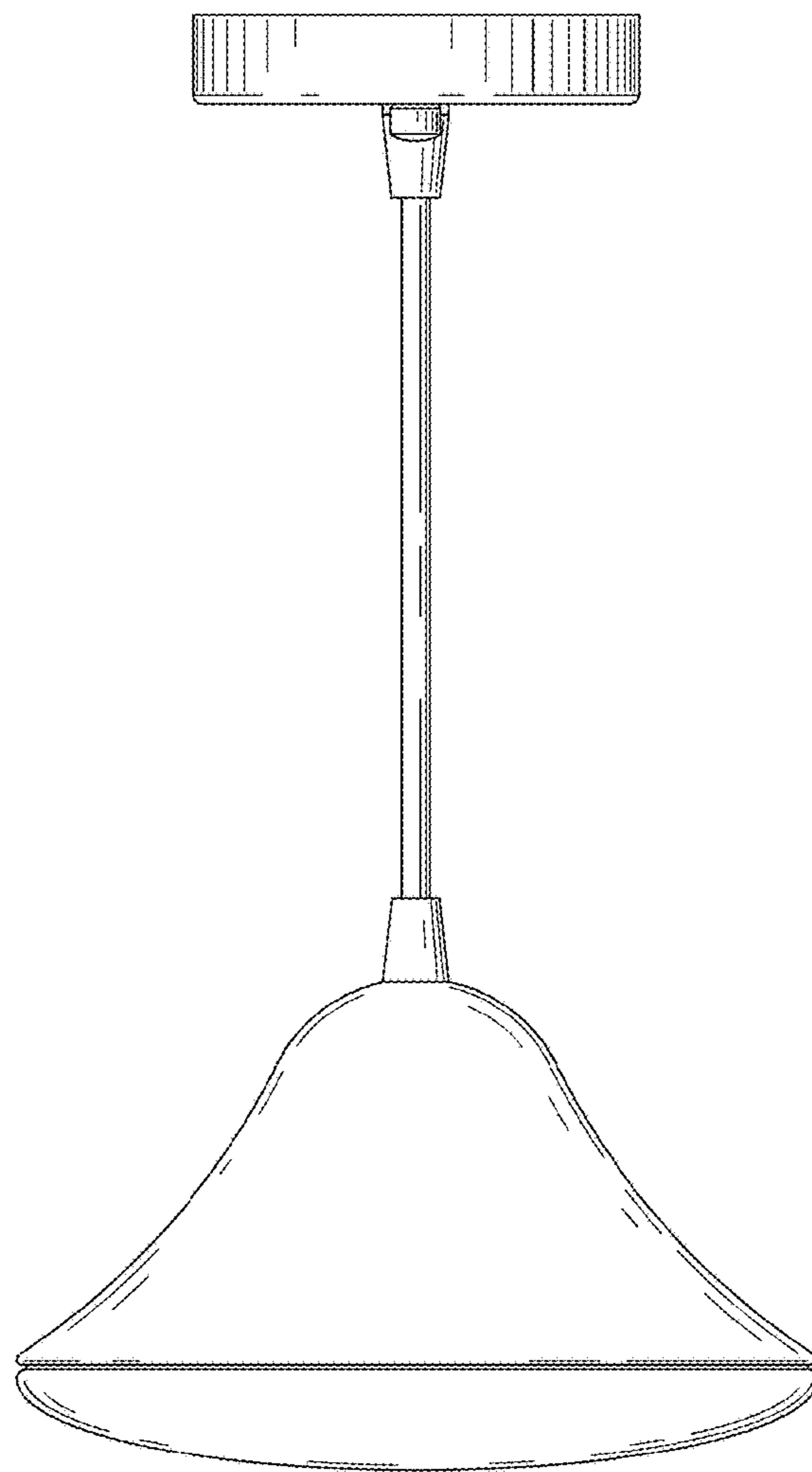

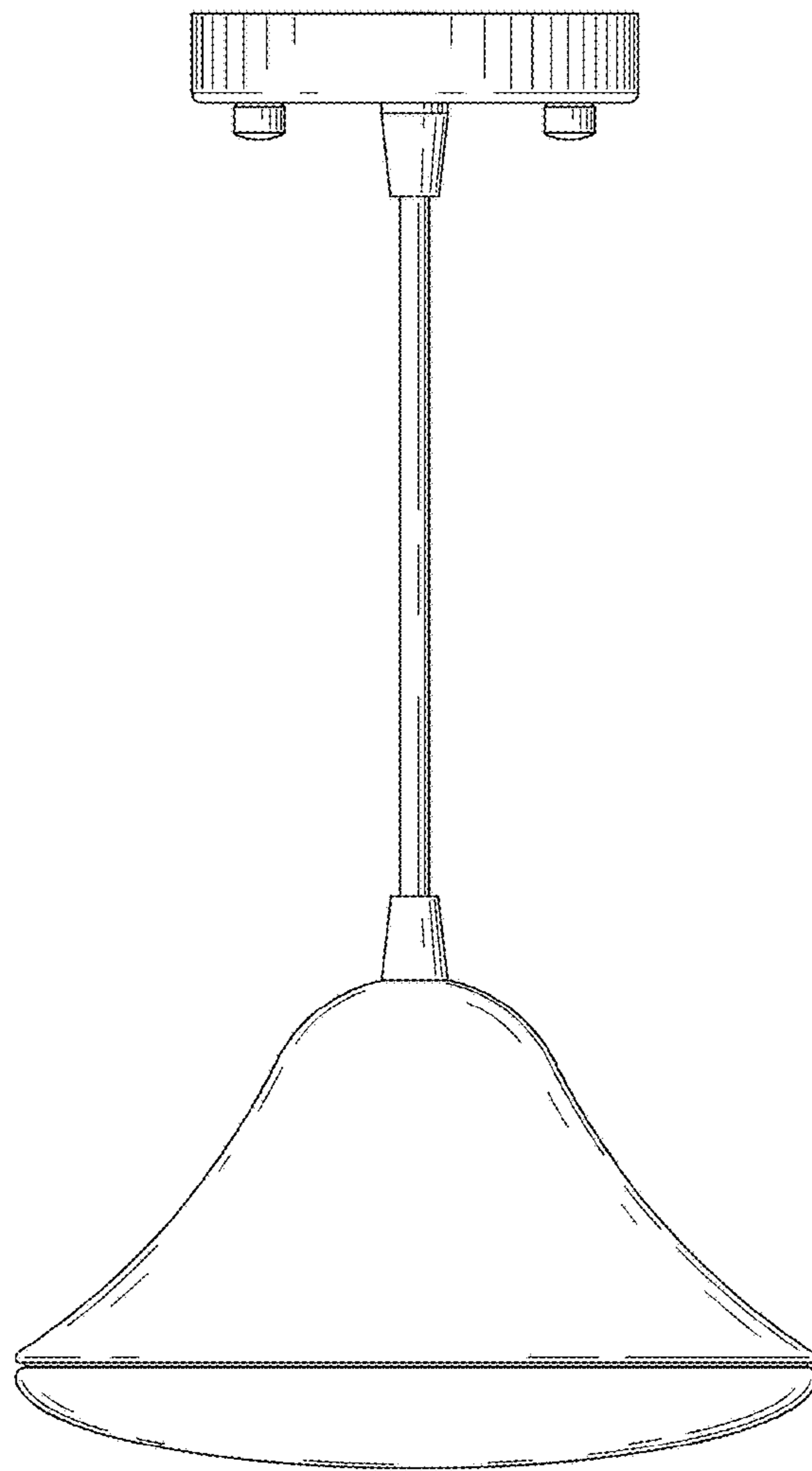

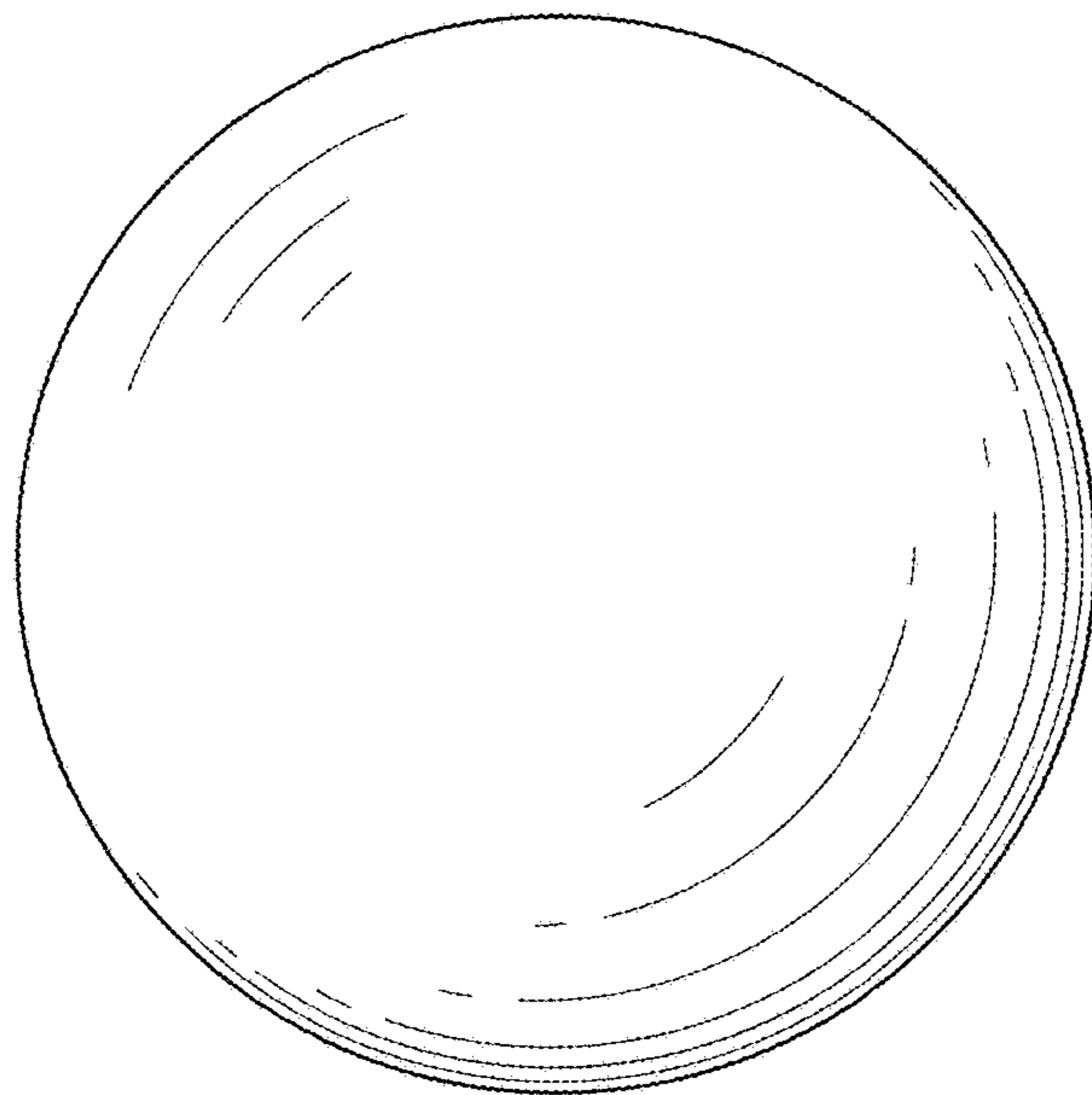

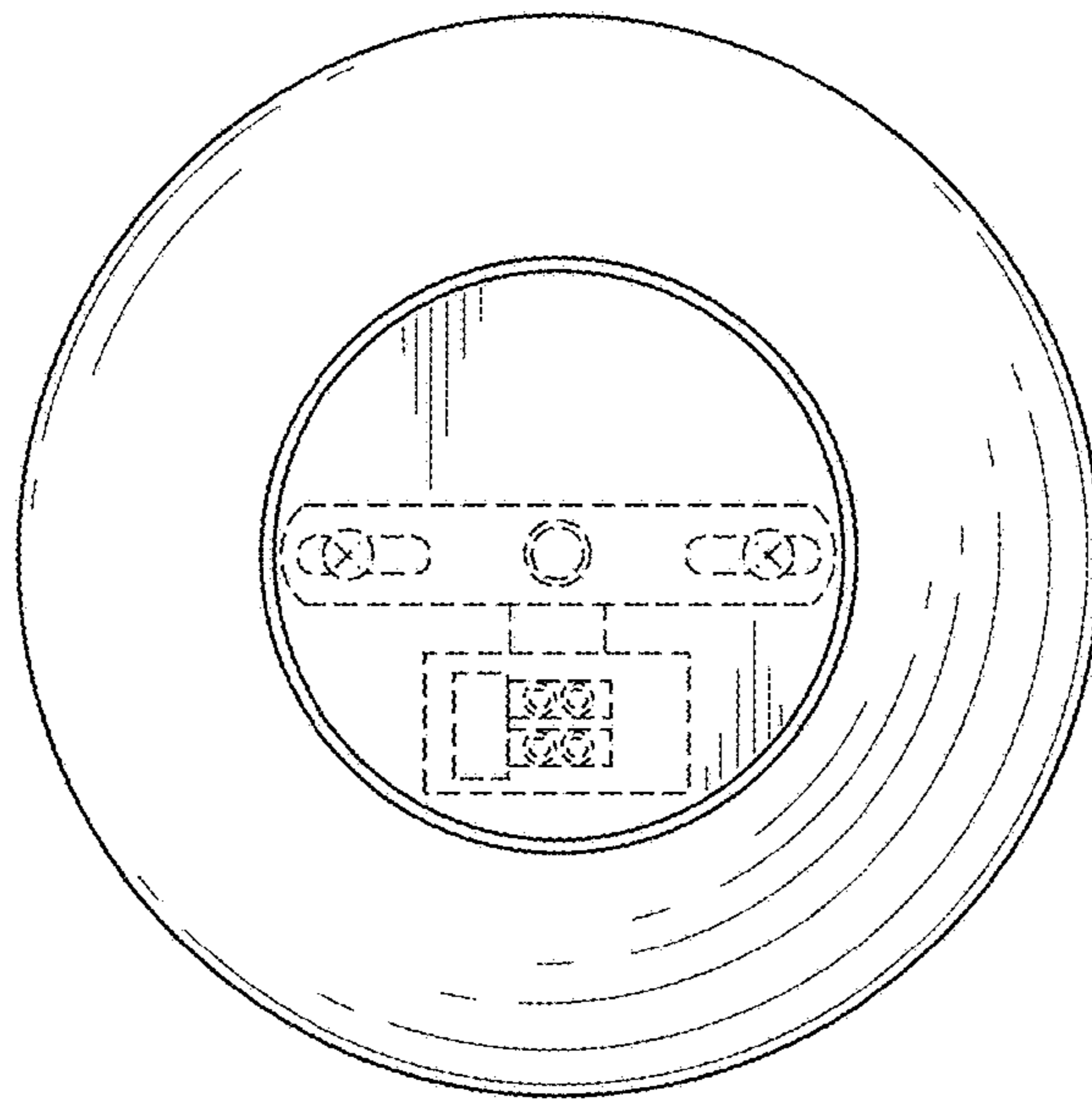
