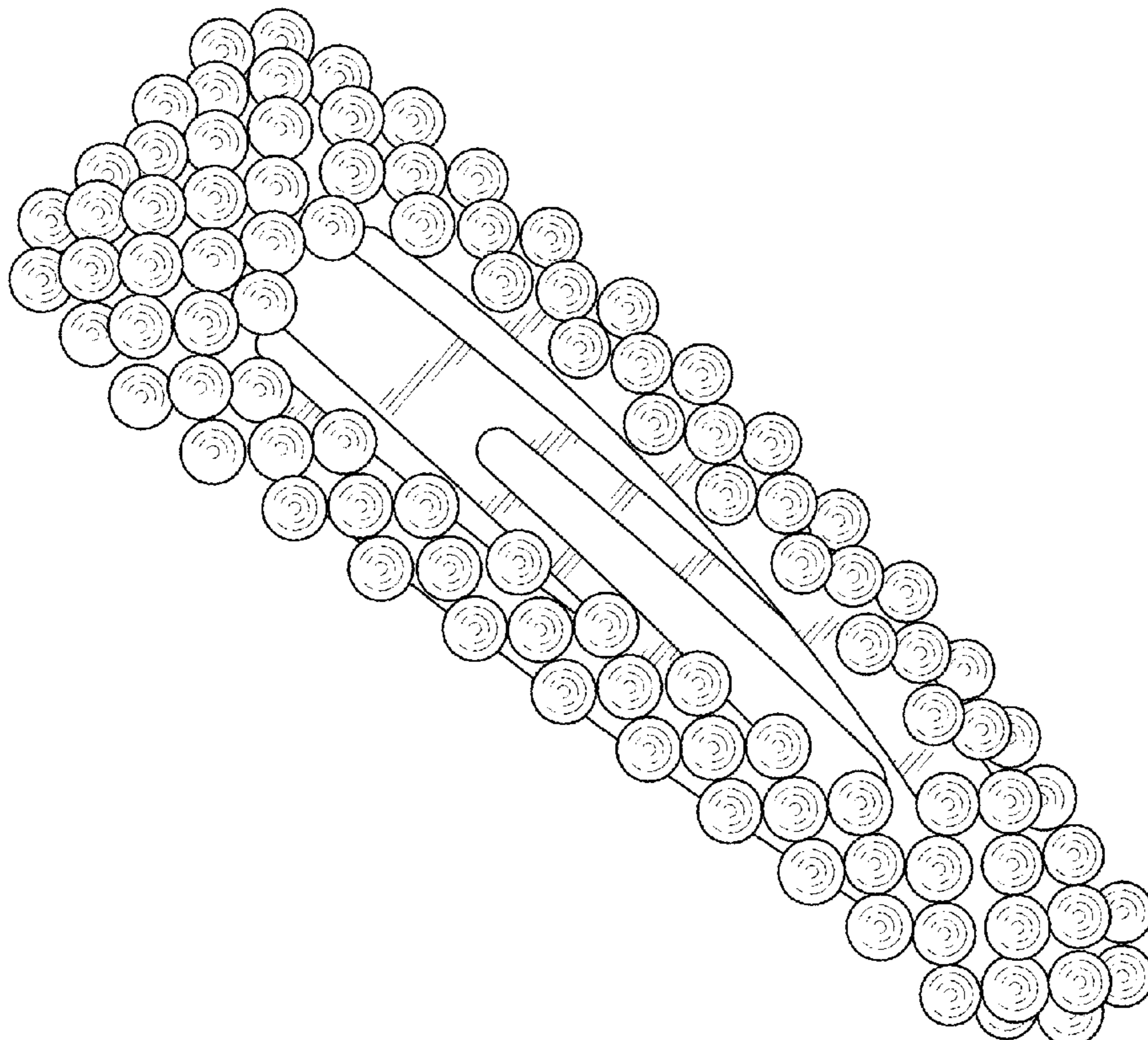
(57) **CLAIM**

I claim the ornamental design for a hair clip, as shown and described.

DESCRIPTION

FIG. 1 is a Perspective view of a hair clip showing my new design;
FIG. 2 is a Top view of the hair clip as shown in FIG. 1;

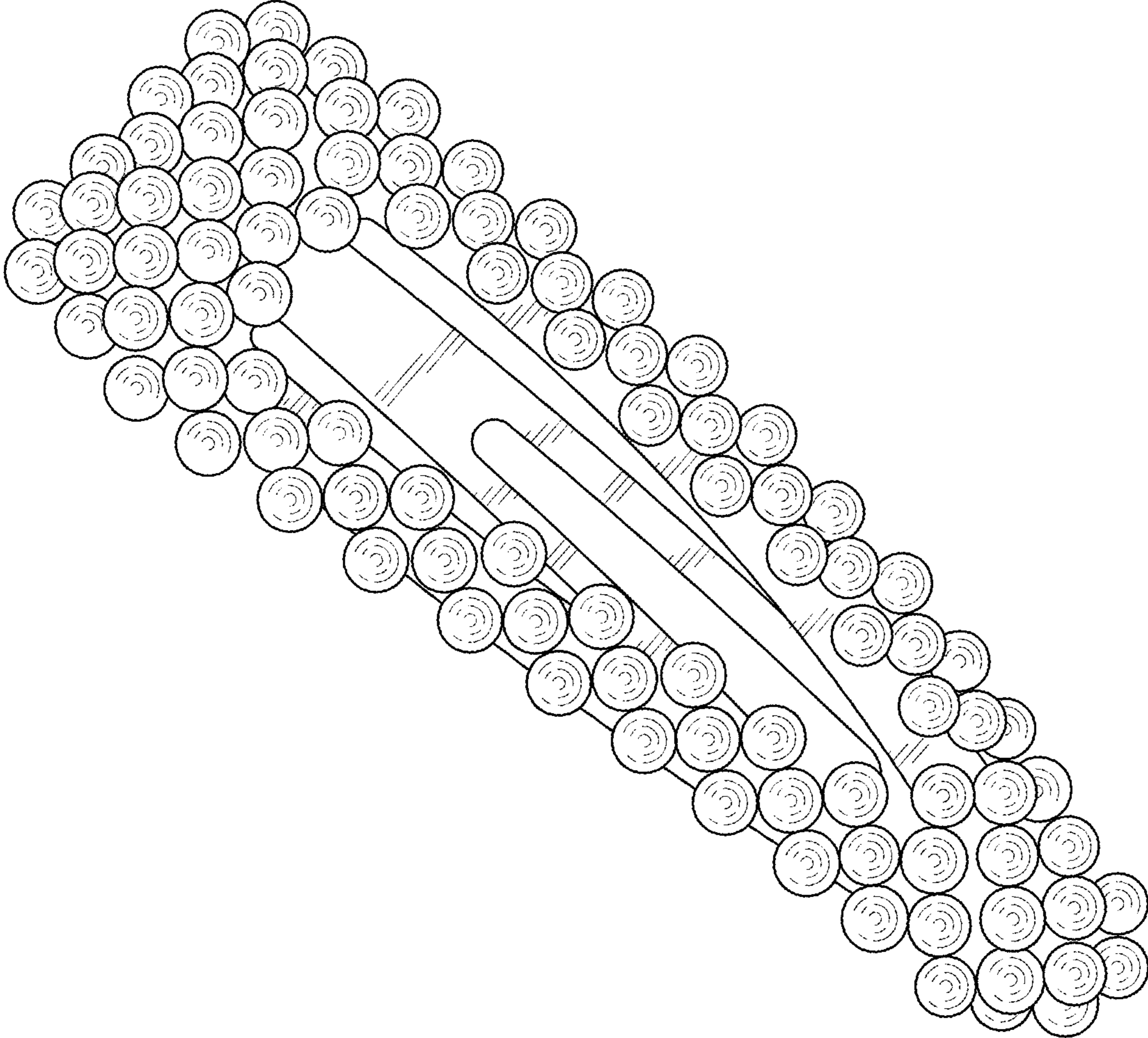

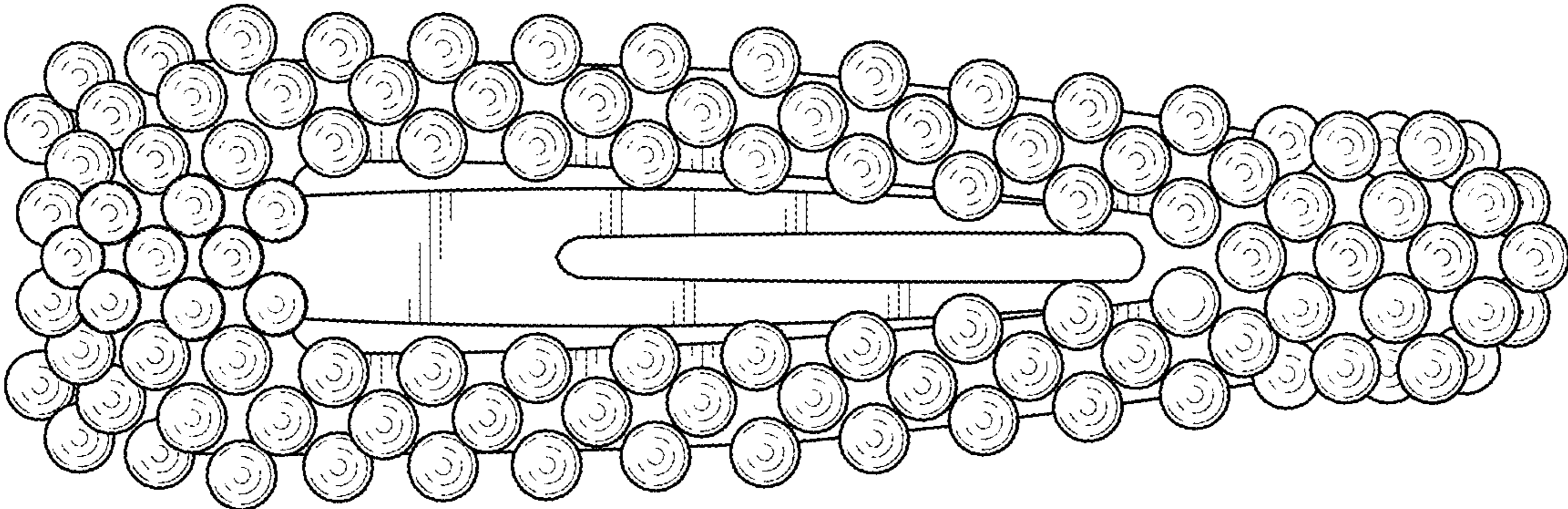

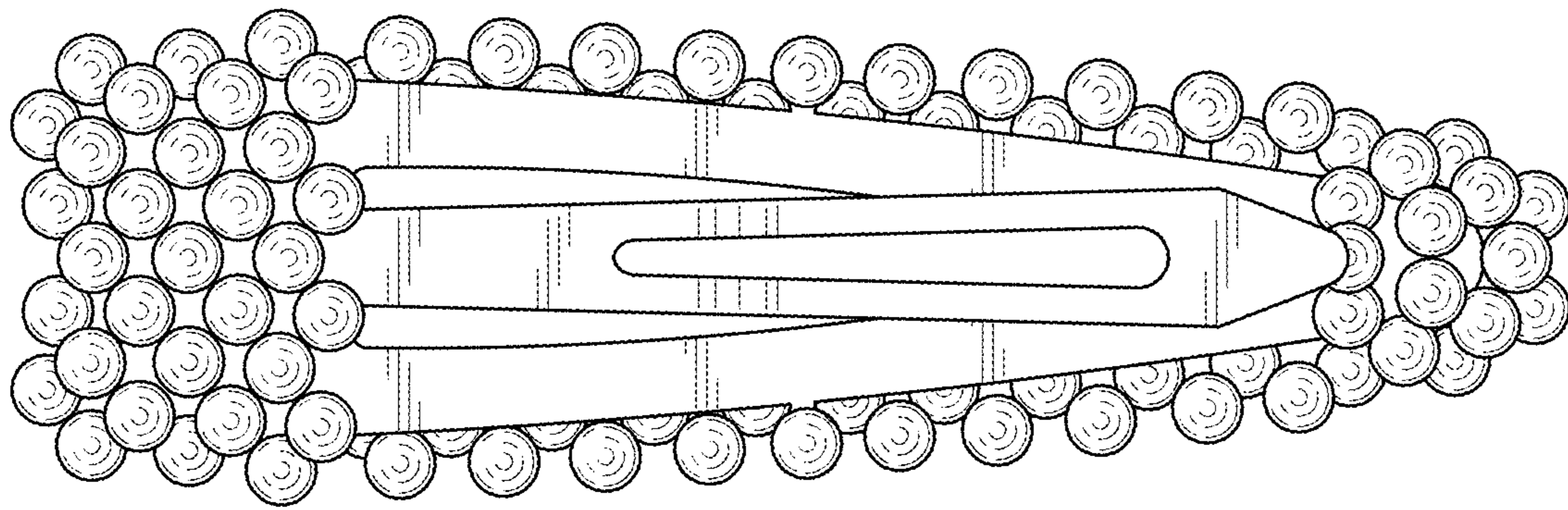

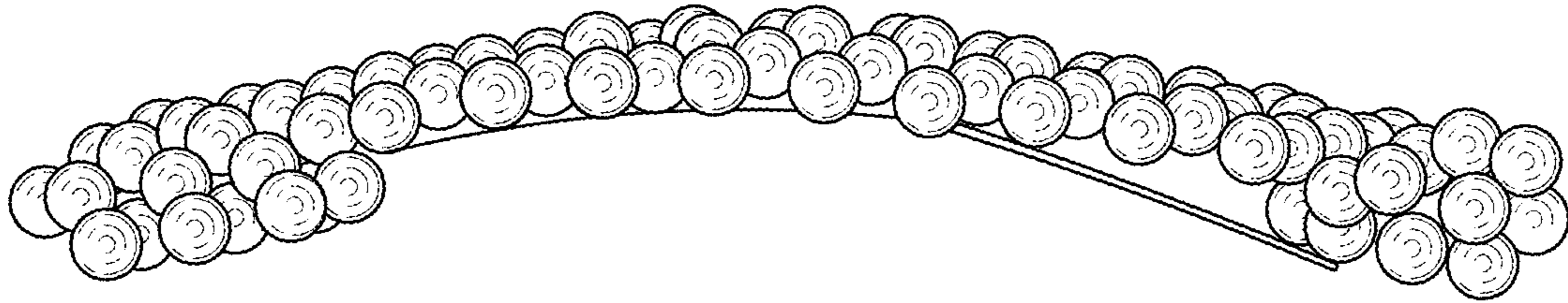

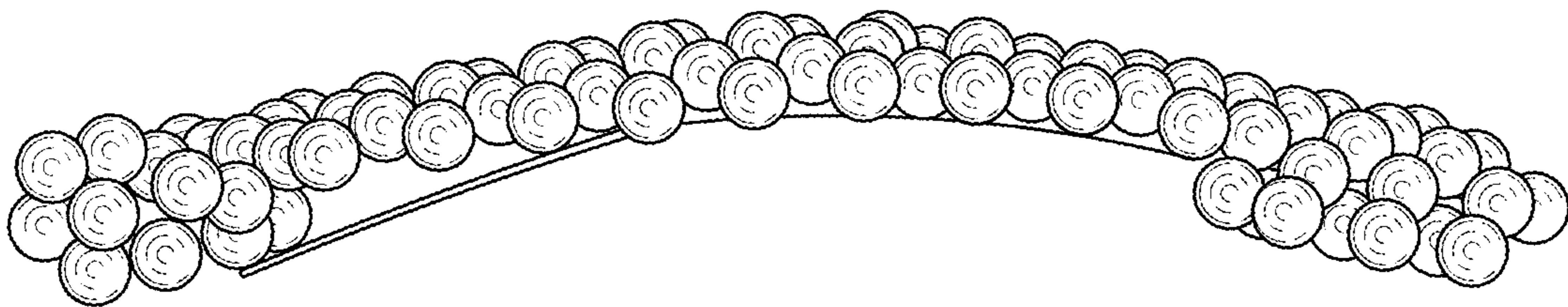

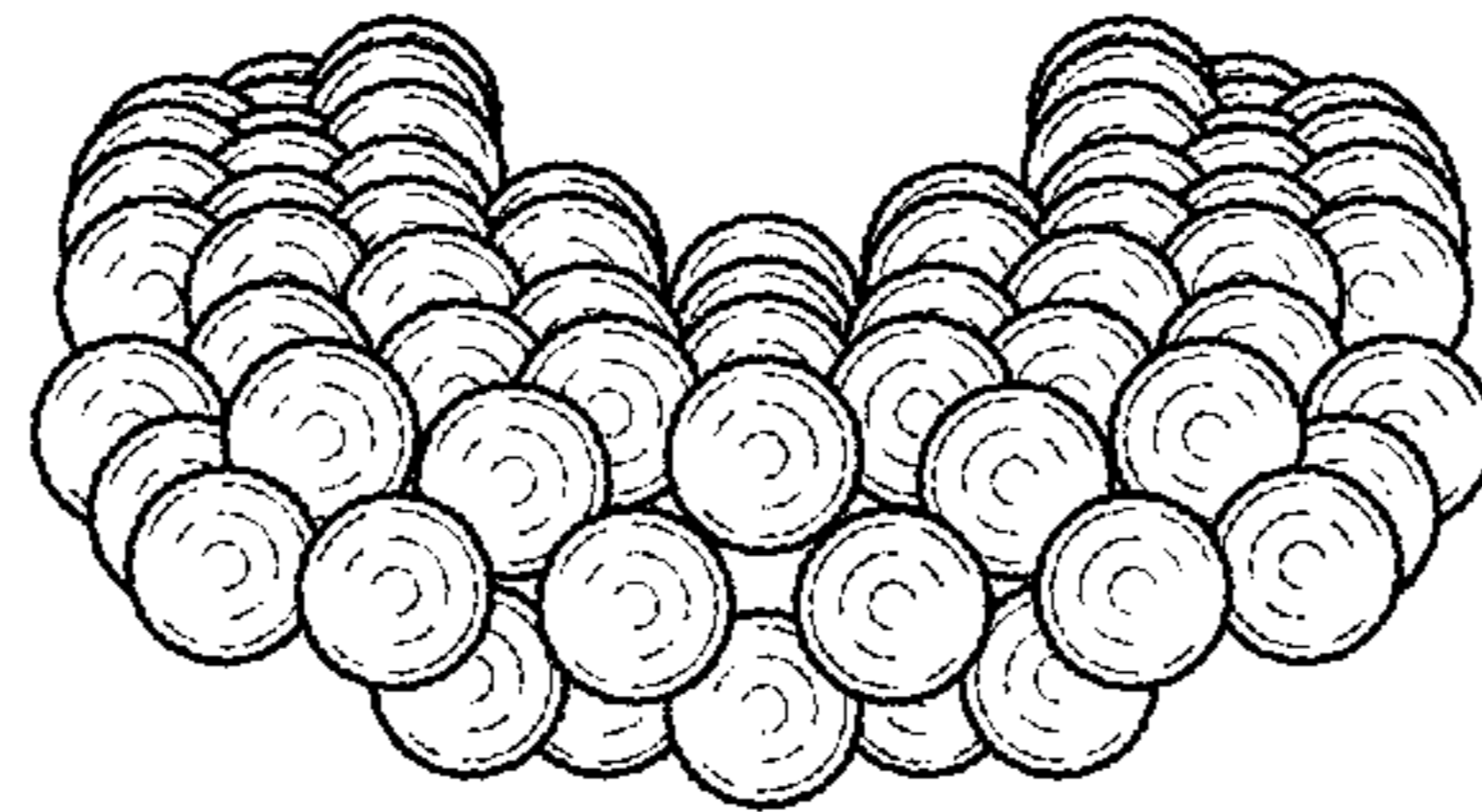

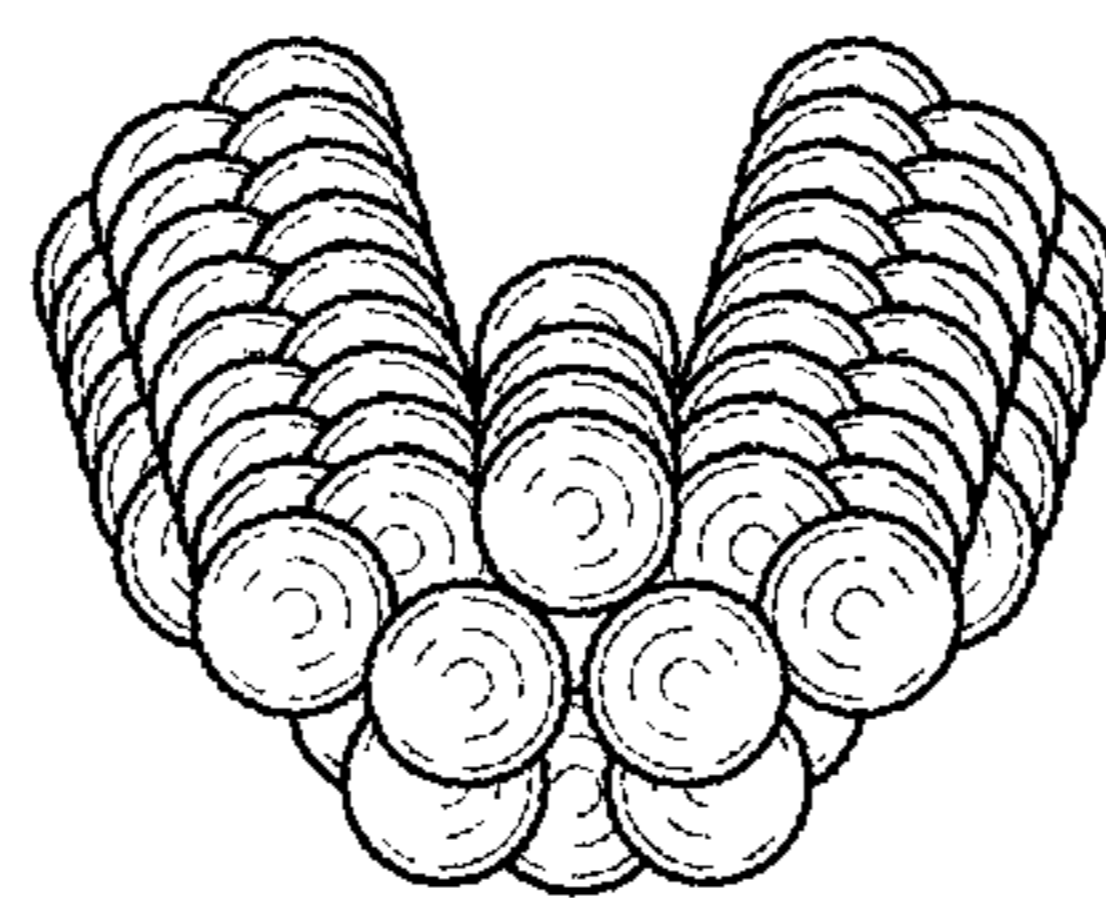
