The ornamental design for a wader sock, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a wader sock showing my new design;

FIG. 2 is a front view thereof;

FIG. 4 is a right side view thereof;

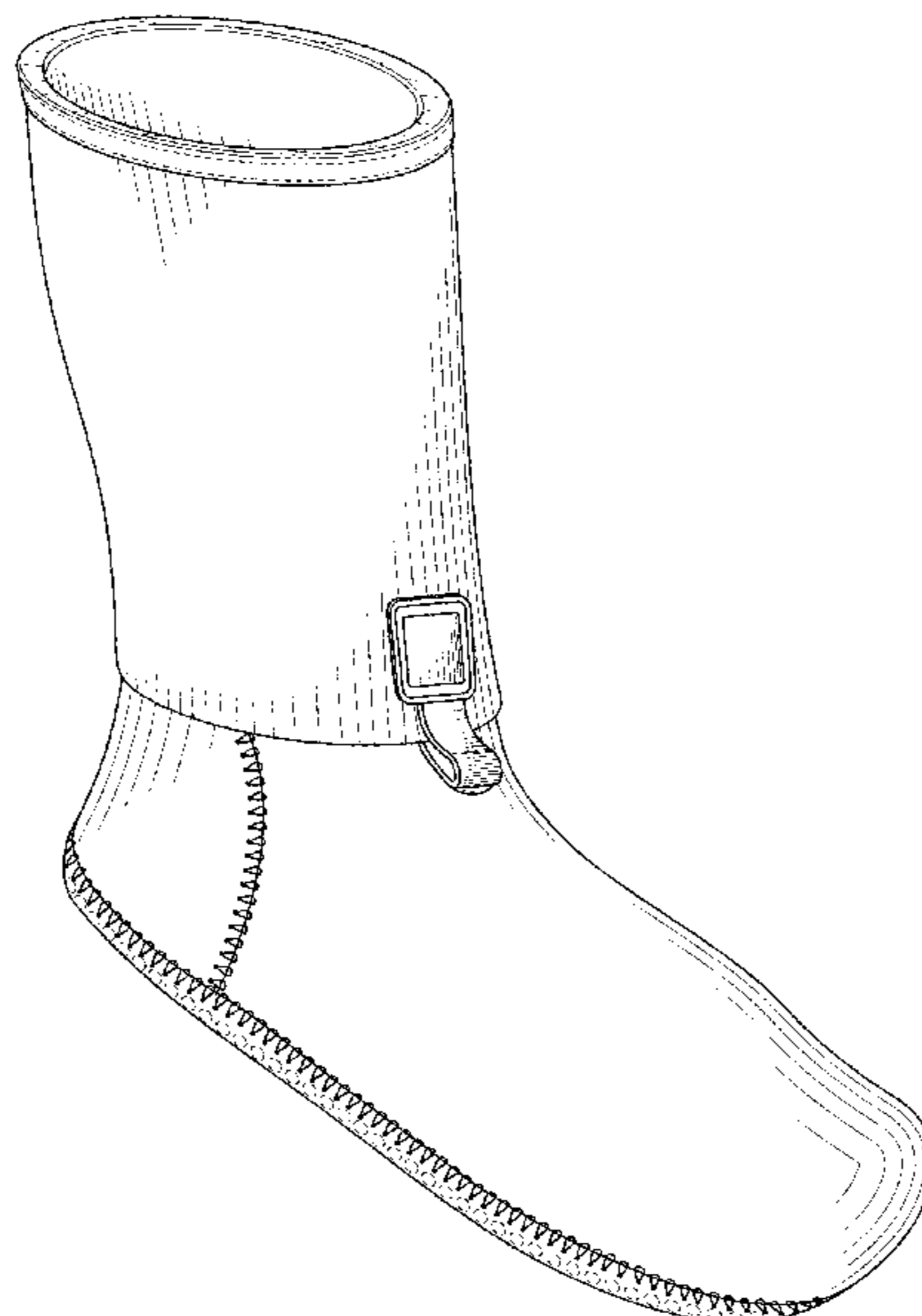
FIG. 5 is a left side view thereof;

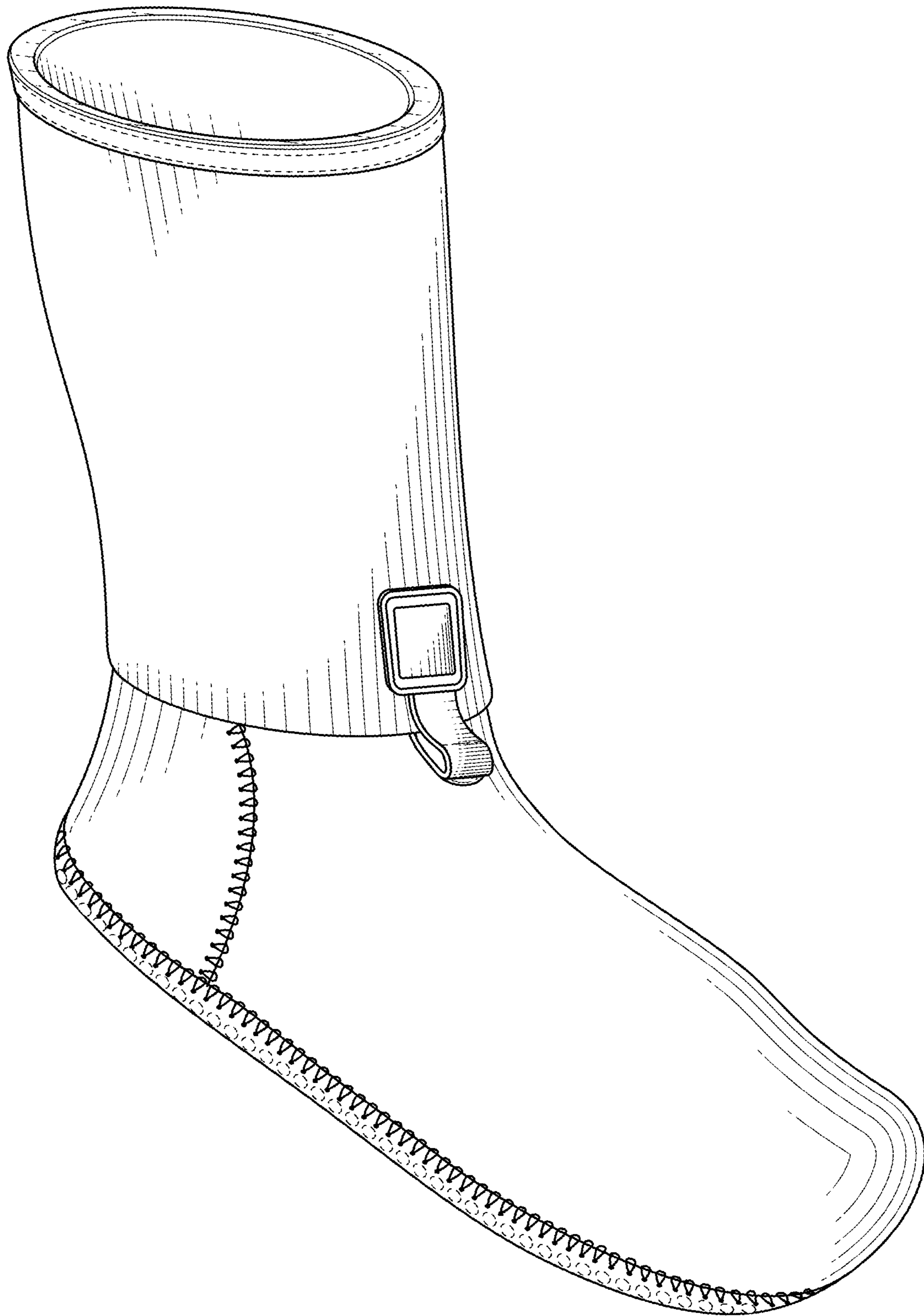

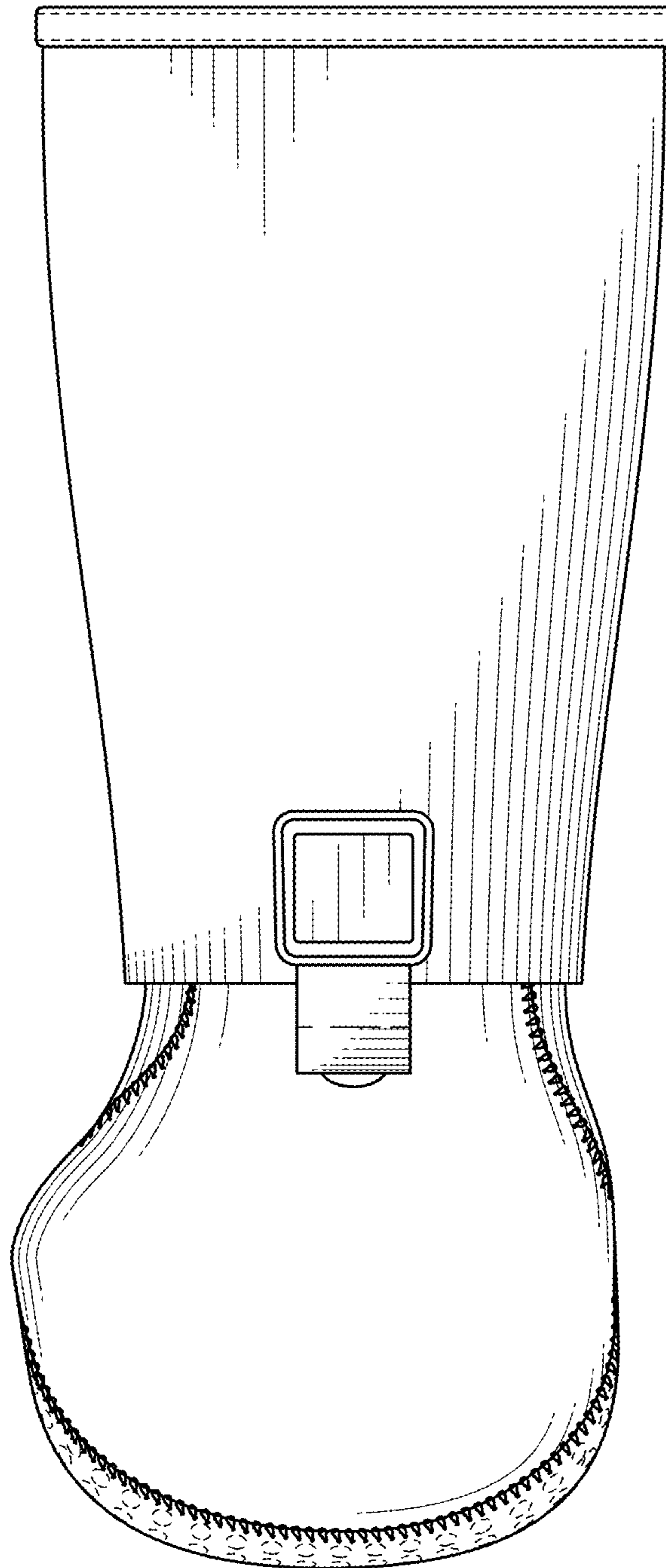

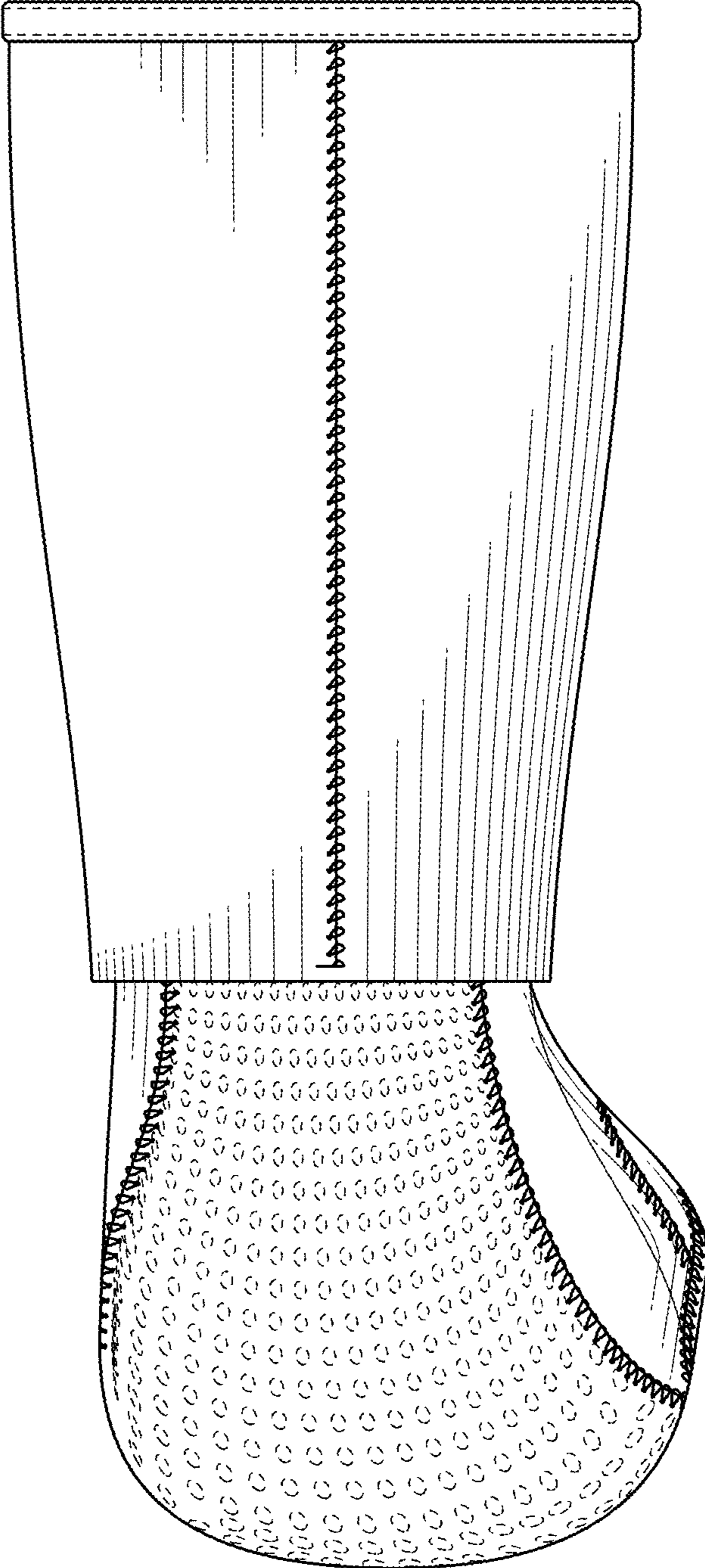

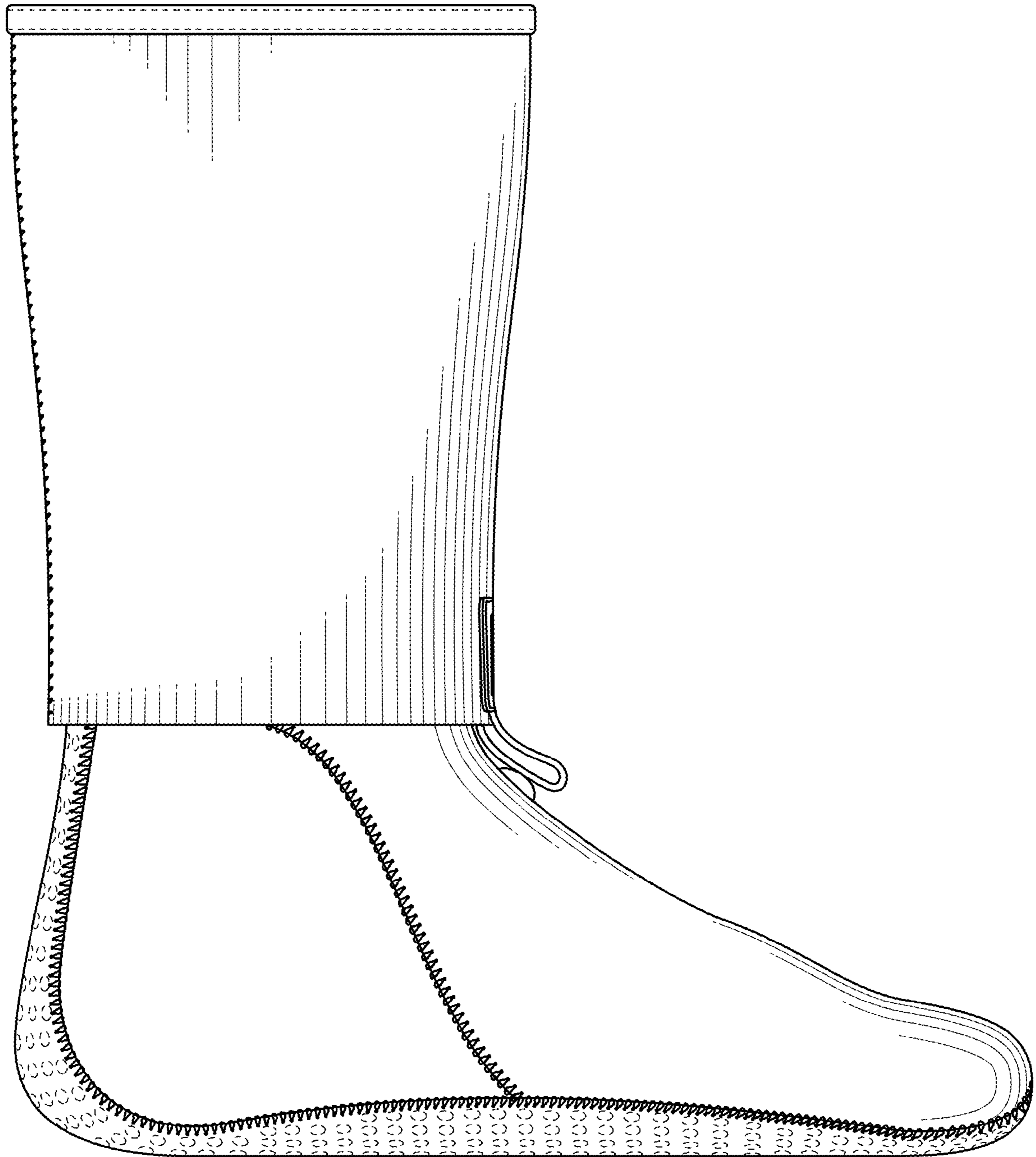

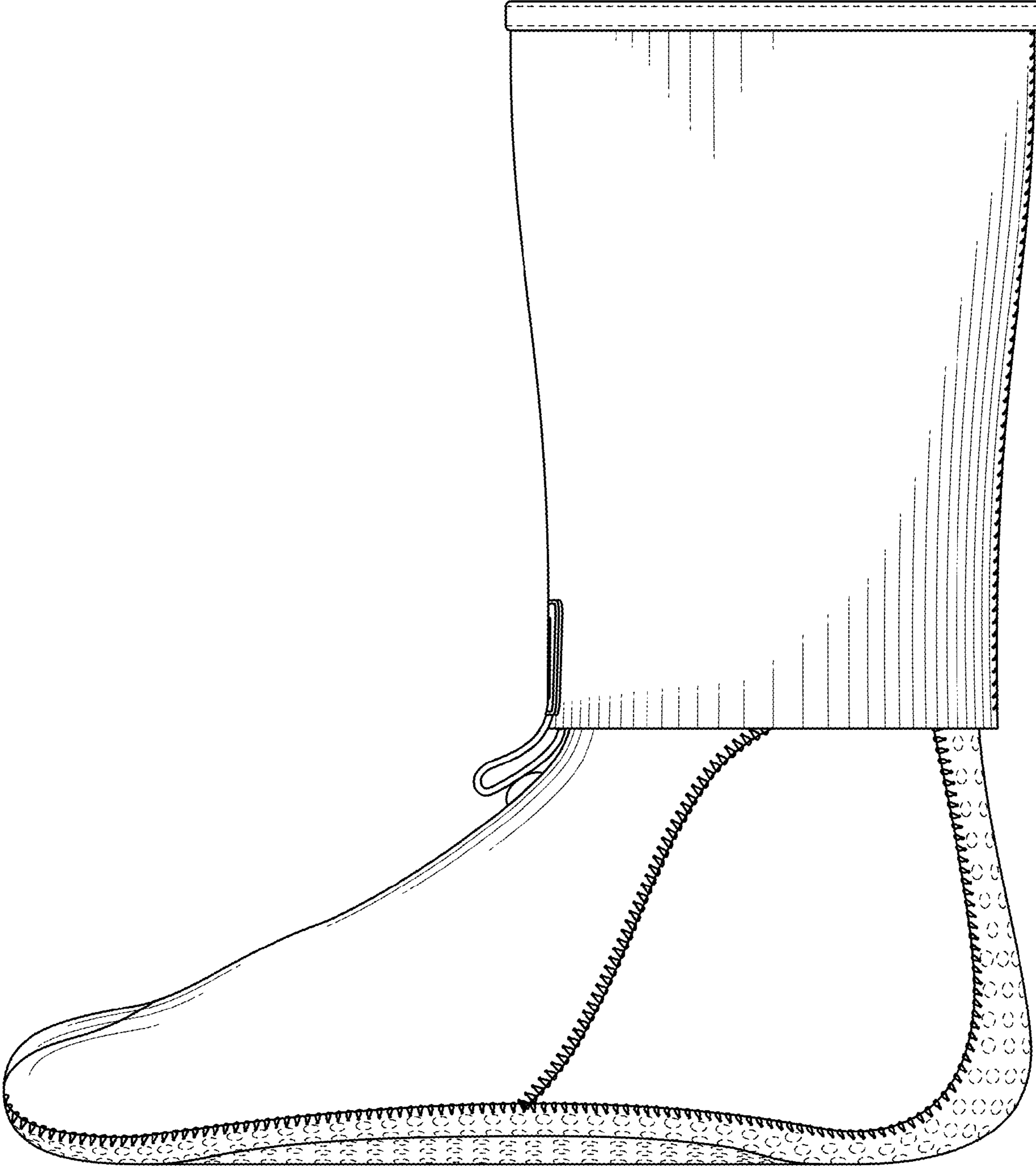

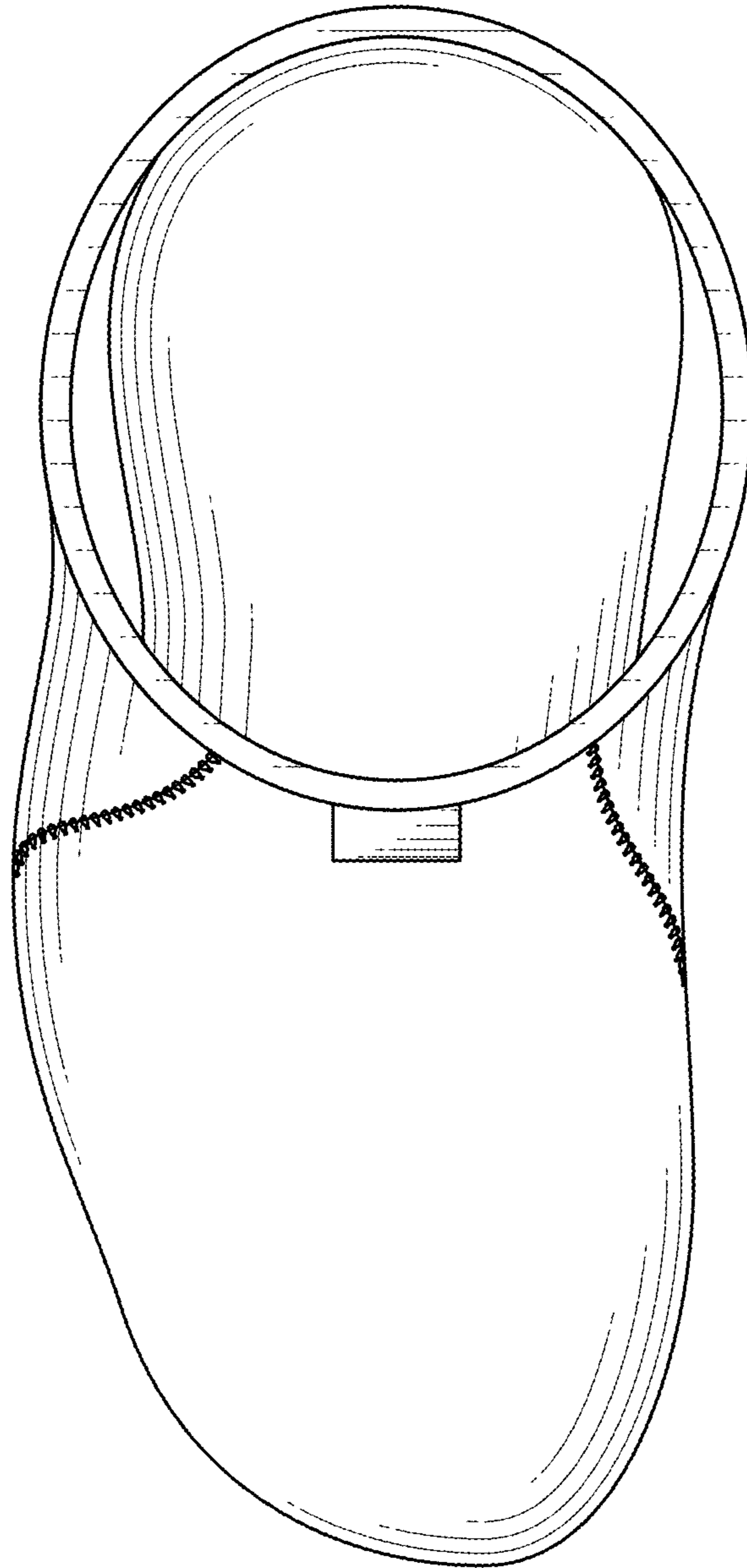

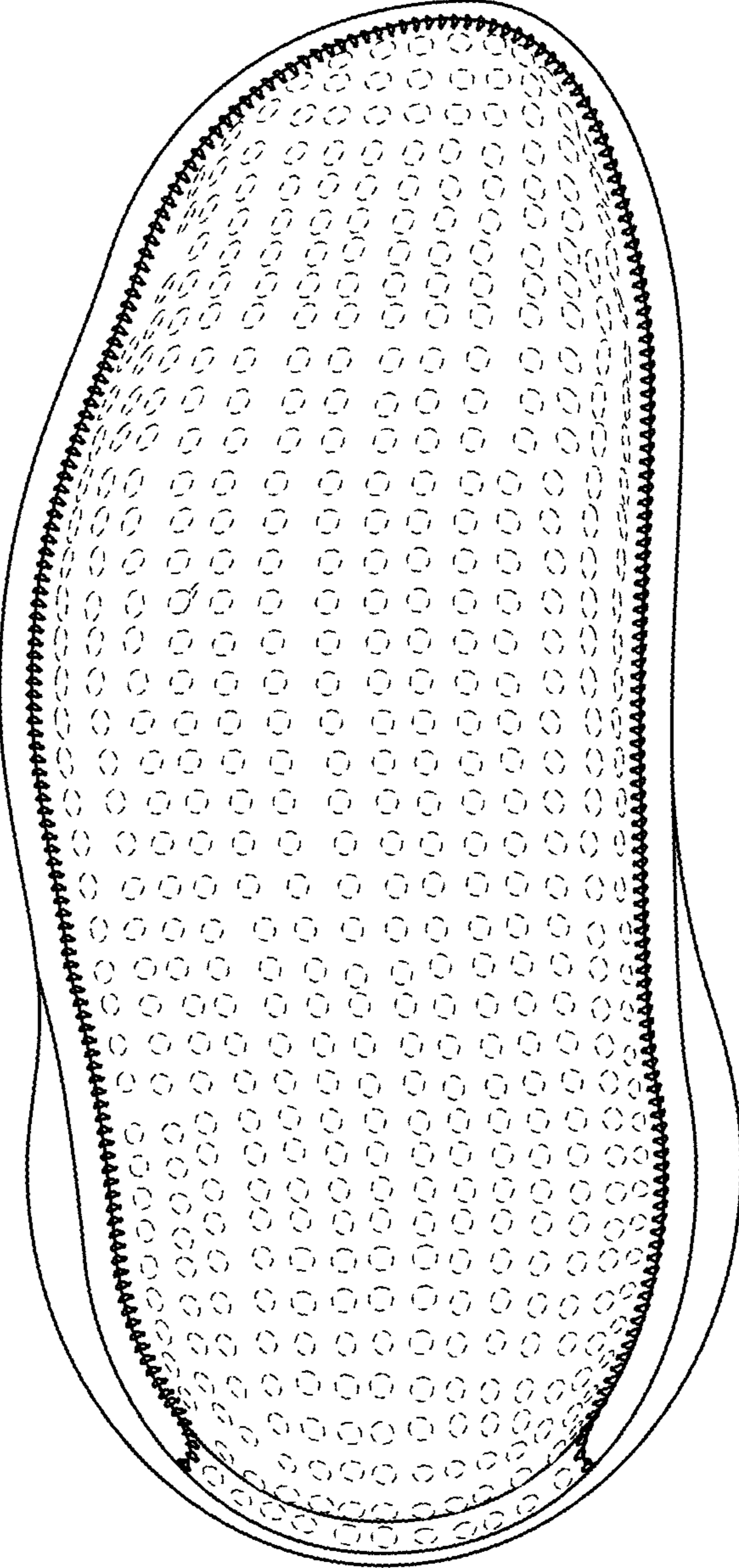
