(57) **CLAIM**

We claim the ornamental design for a non-folding car seat for a child, as shown and described.

DESCRIPTION

FIG. 1 is a rear view of the inventive non-folding car seat for a child.

FIG. 2 is a front view of the inventive non-folding car seat for a child.

FIG. 3 is a right side view of the non-folding car seat for a child.

FIG. 4 is a left side view of the non-folding car seat for a child.

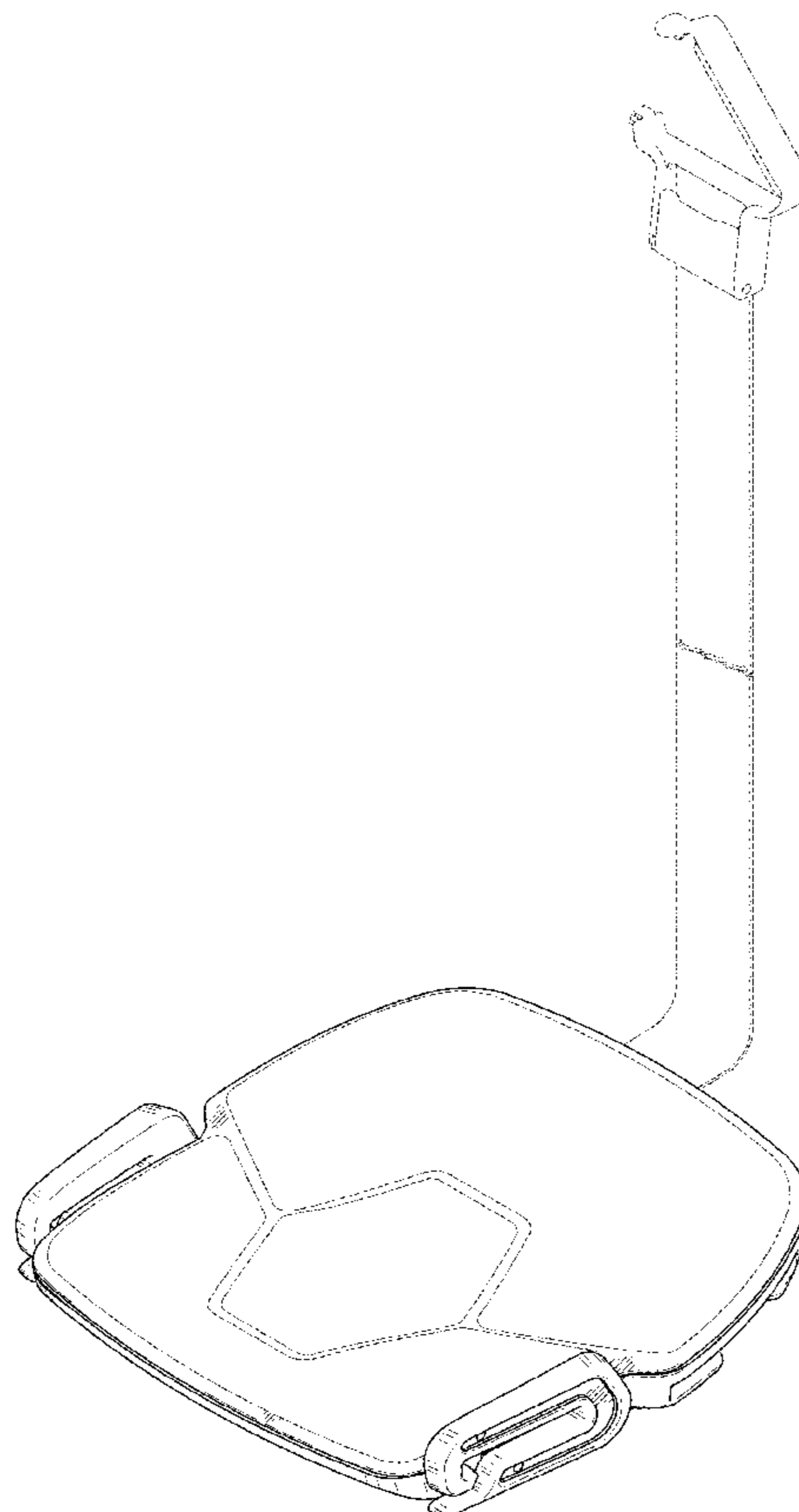
FIG. 5 is a top view of the non-folding car seat for a child.

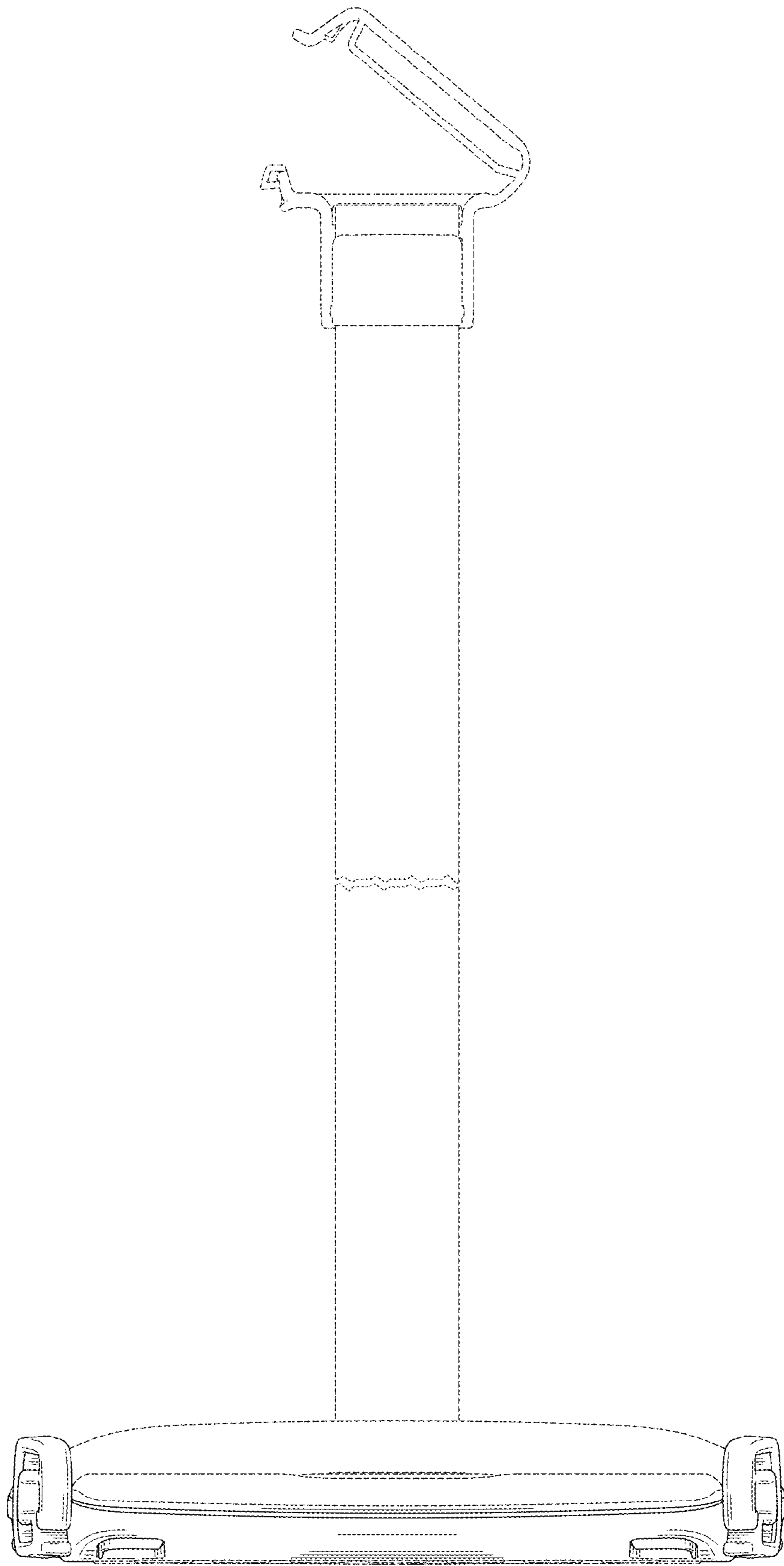

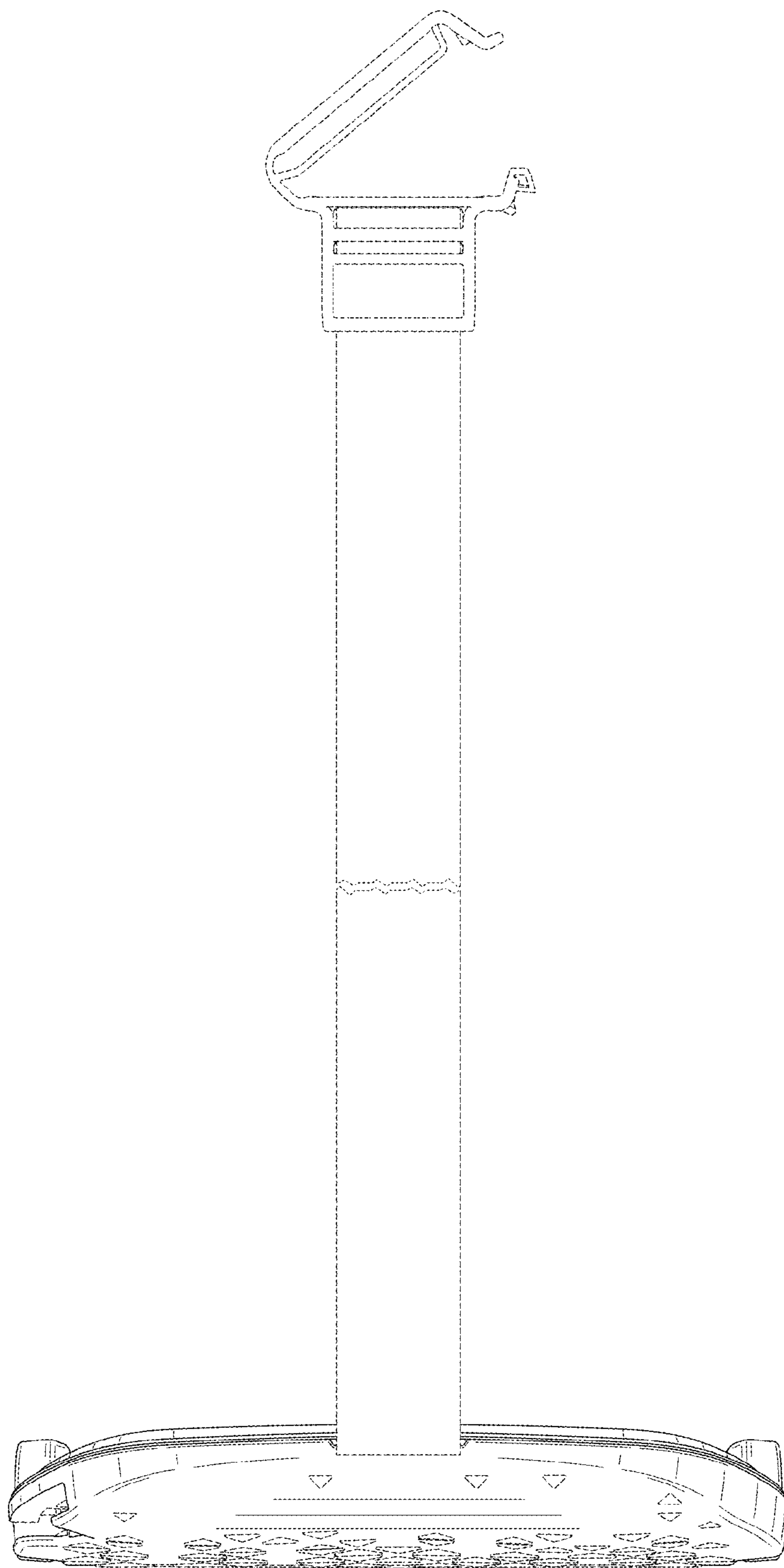

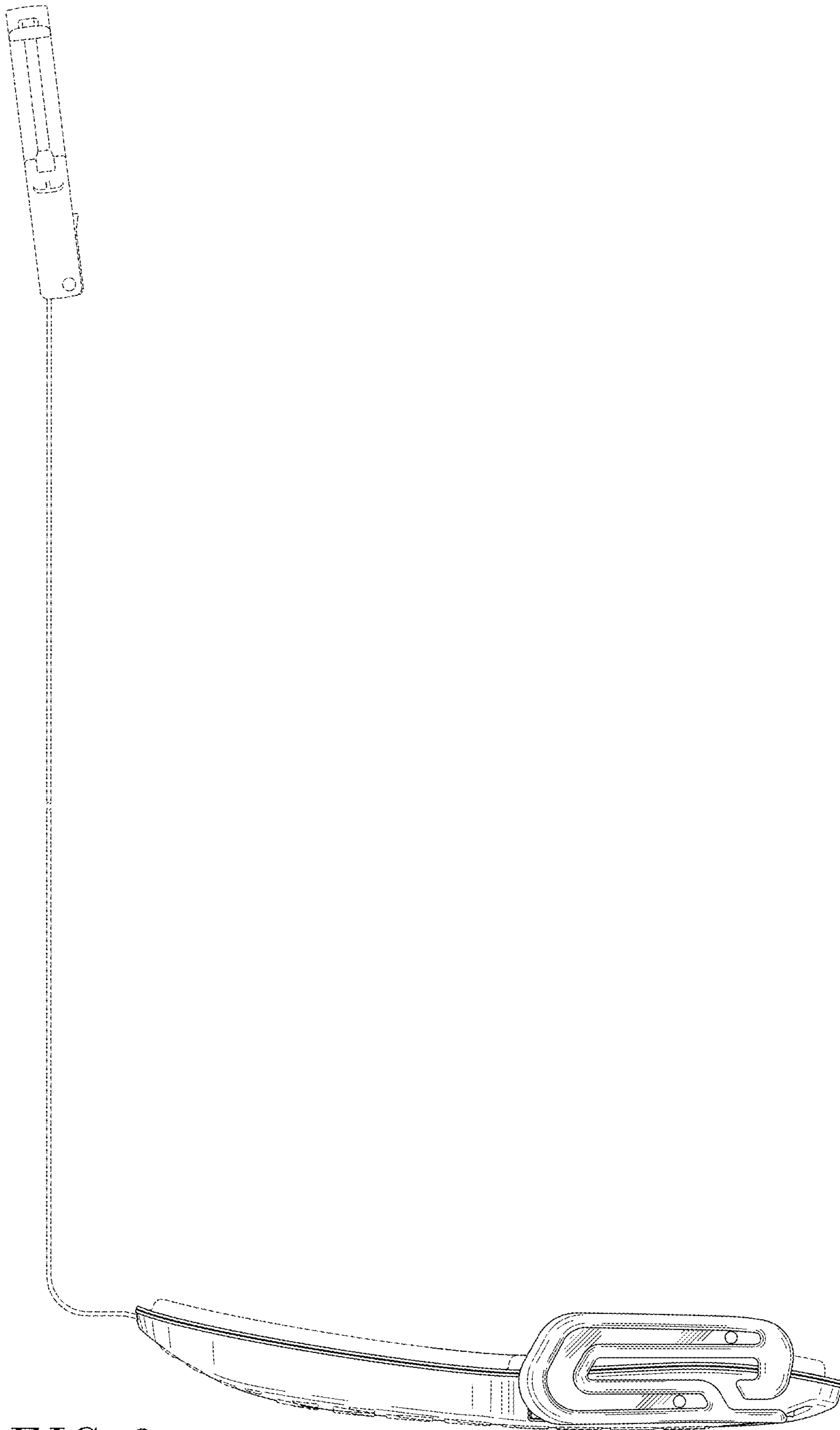

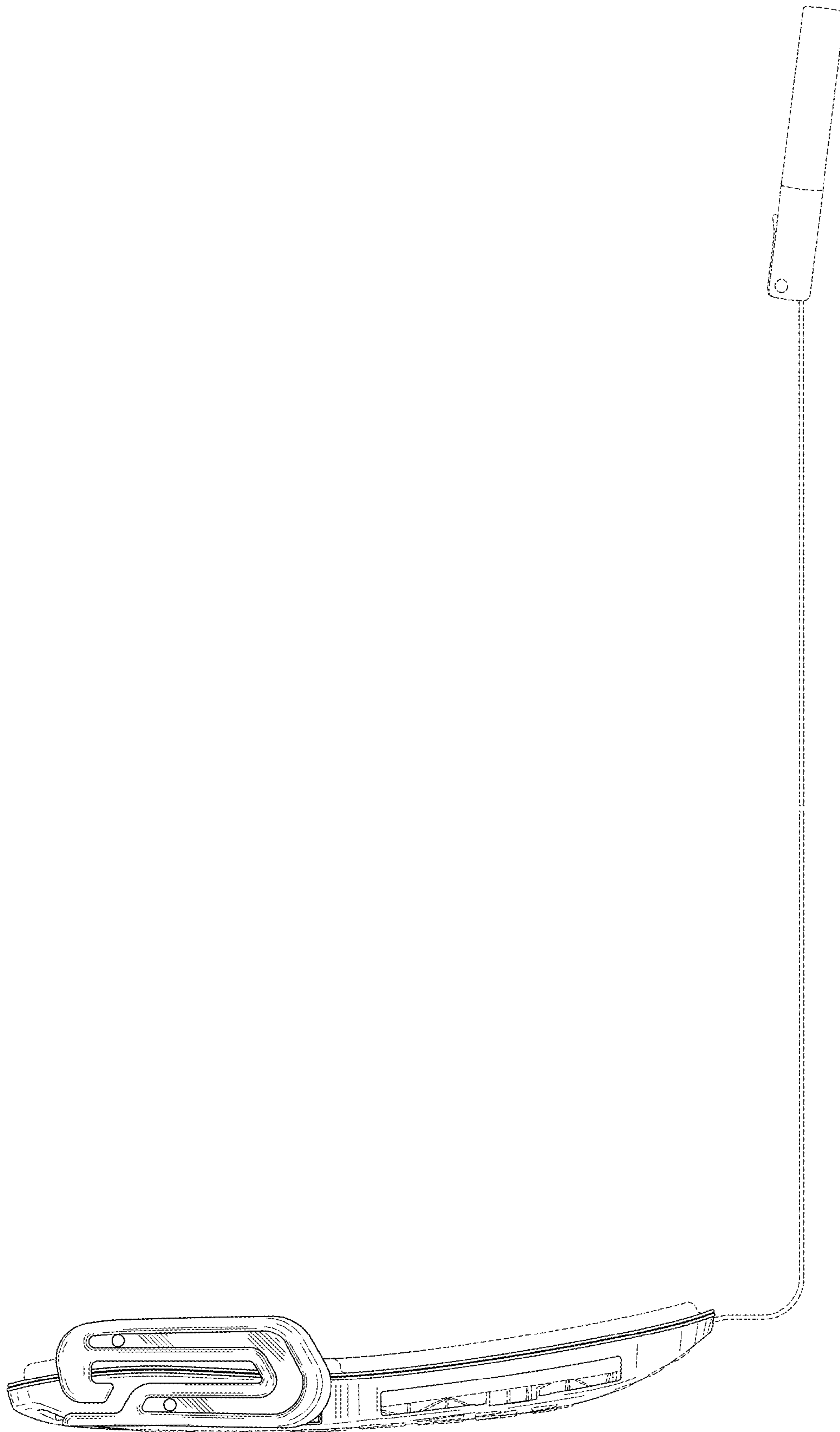

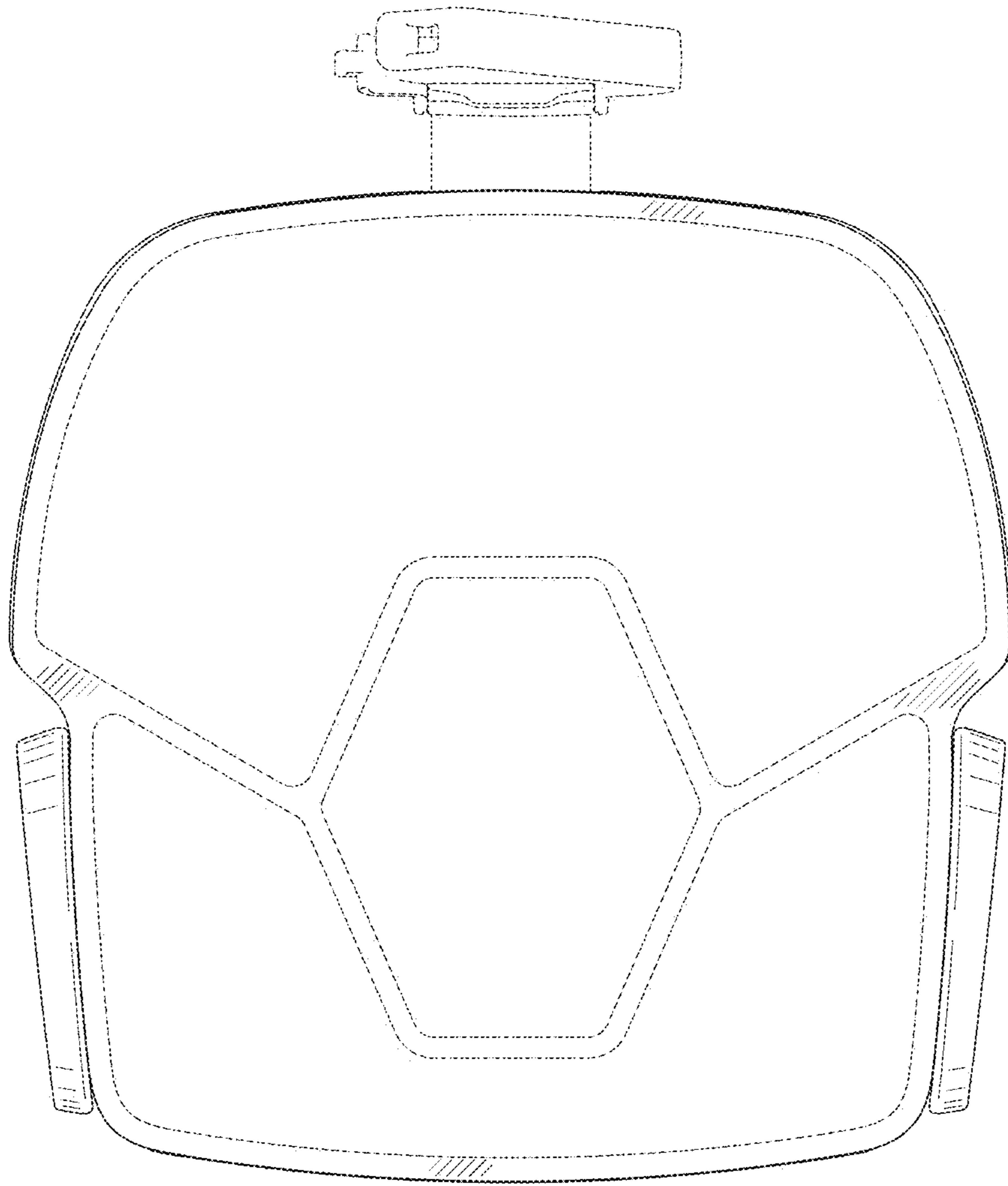

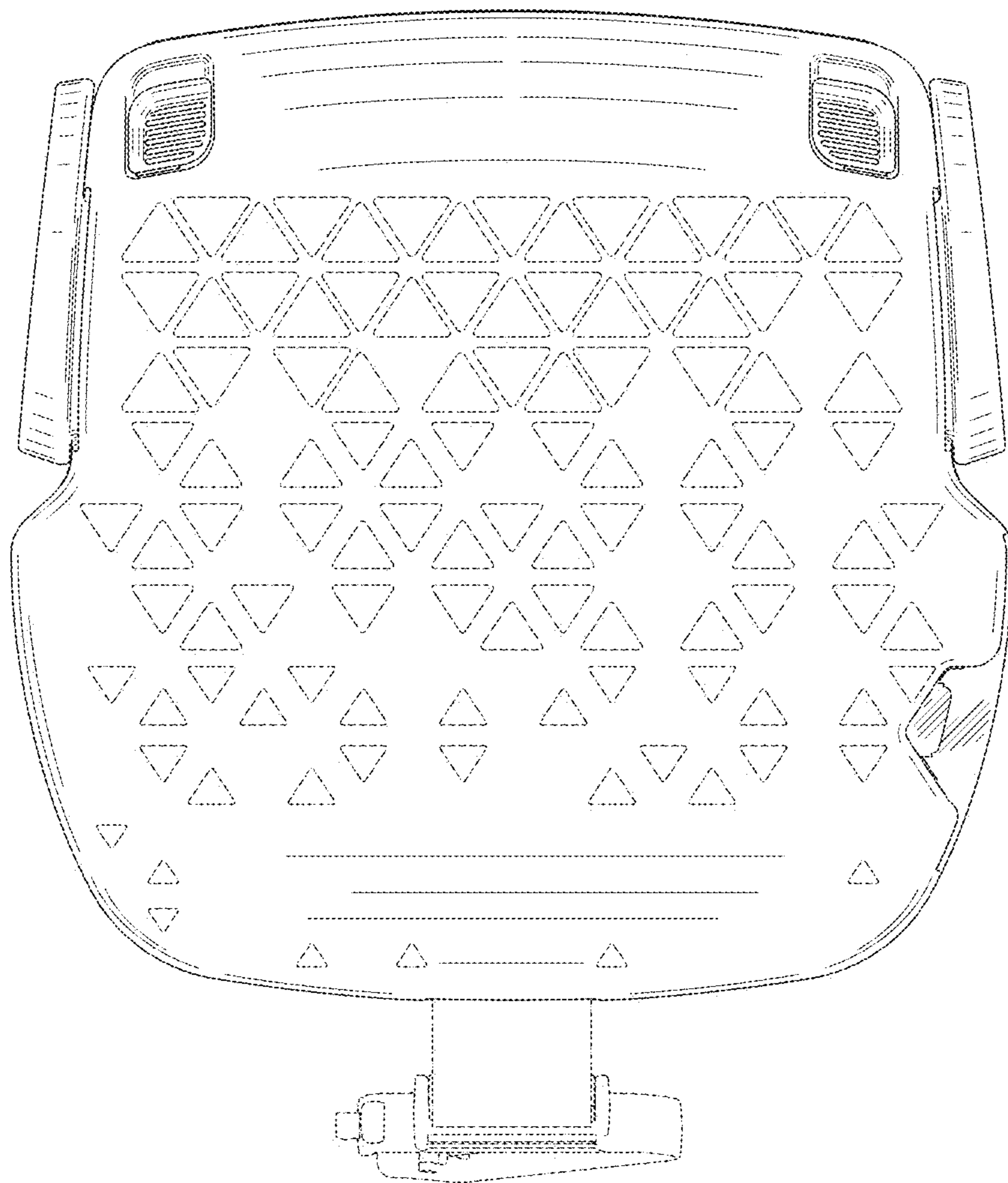

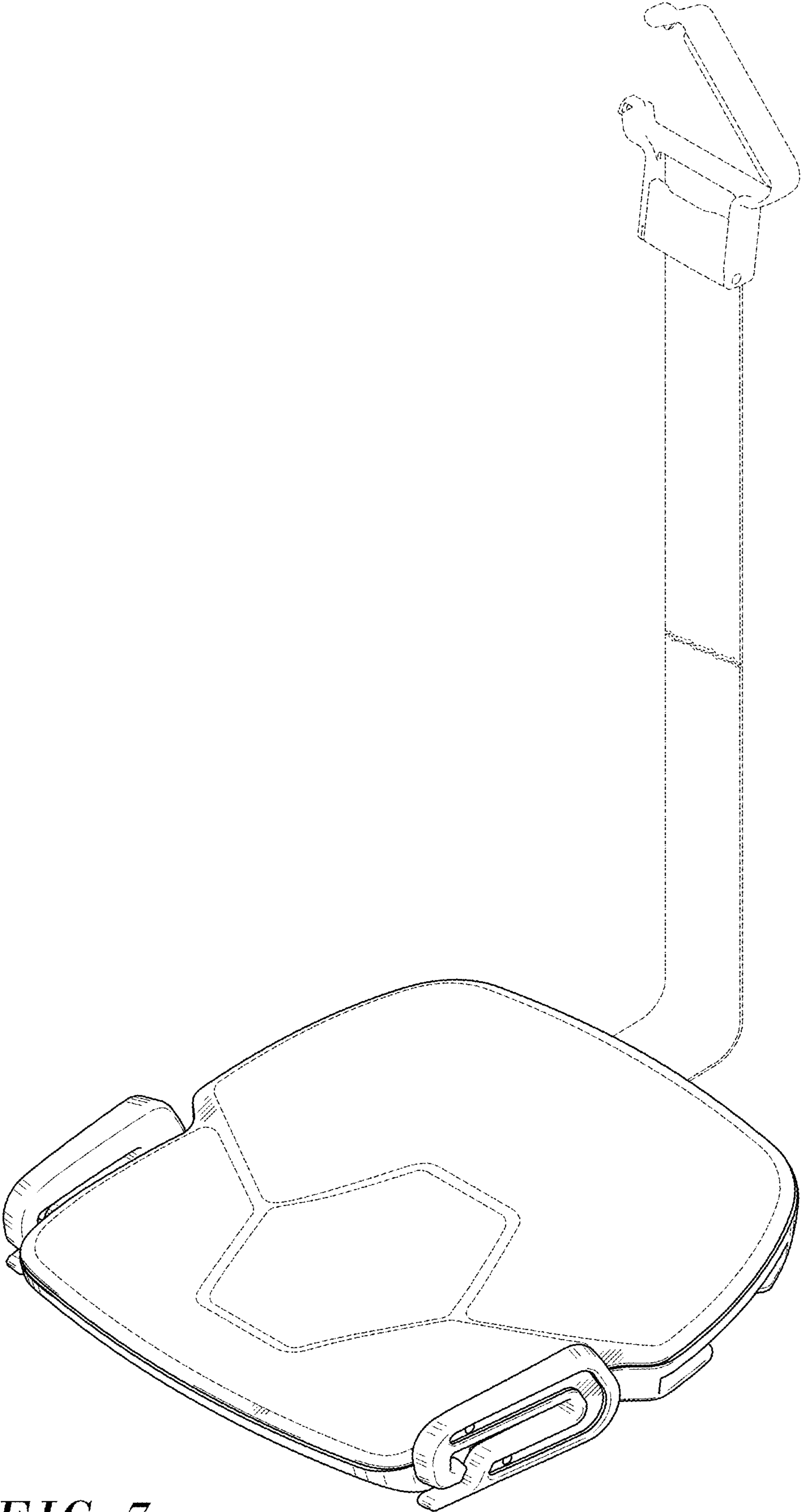
