DESCRIPTION

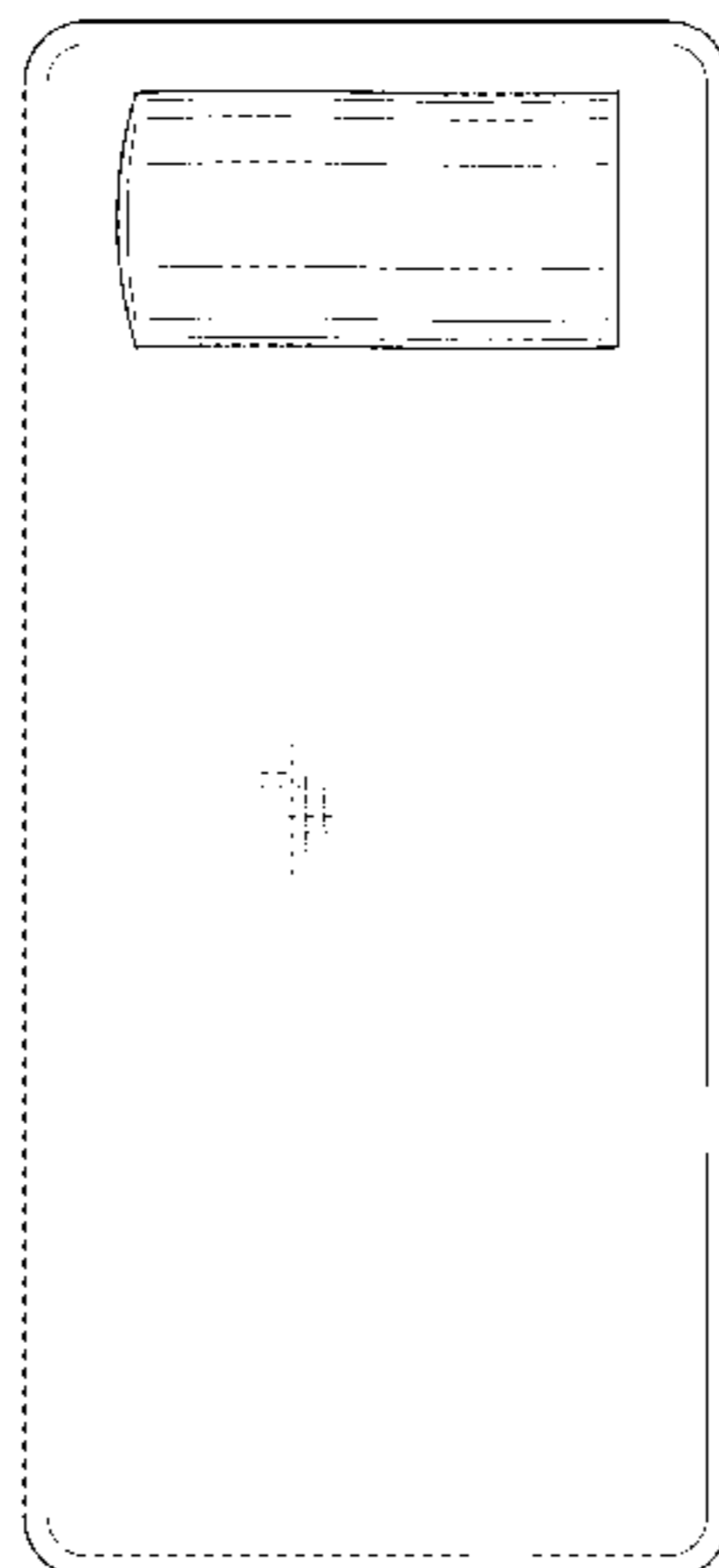
FIG. 1 is a front view of a sheet with integrated pillow pocket showing my new design;
FIG. 2 is a rear view of the sheet with integrated pillow pocket;
FIG. 3 is a left side view of the sheet with integrated pillow pocket;
FIG. 4 is a right side view of the sheet with integrated pillow pocket;
FIG. 5 is a top view of the sheet with integrated pillow pocket, a bottom view being a mirror image thereof;
FIG. 6 is a bottom front side perspective view of the sheet with integrated pillow pocket; and,
FIG. 7 is a top rear side perspective view of the sheet with integrated pillow pocket.

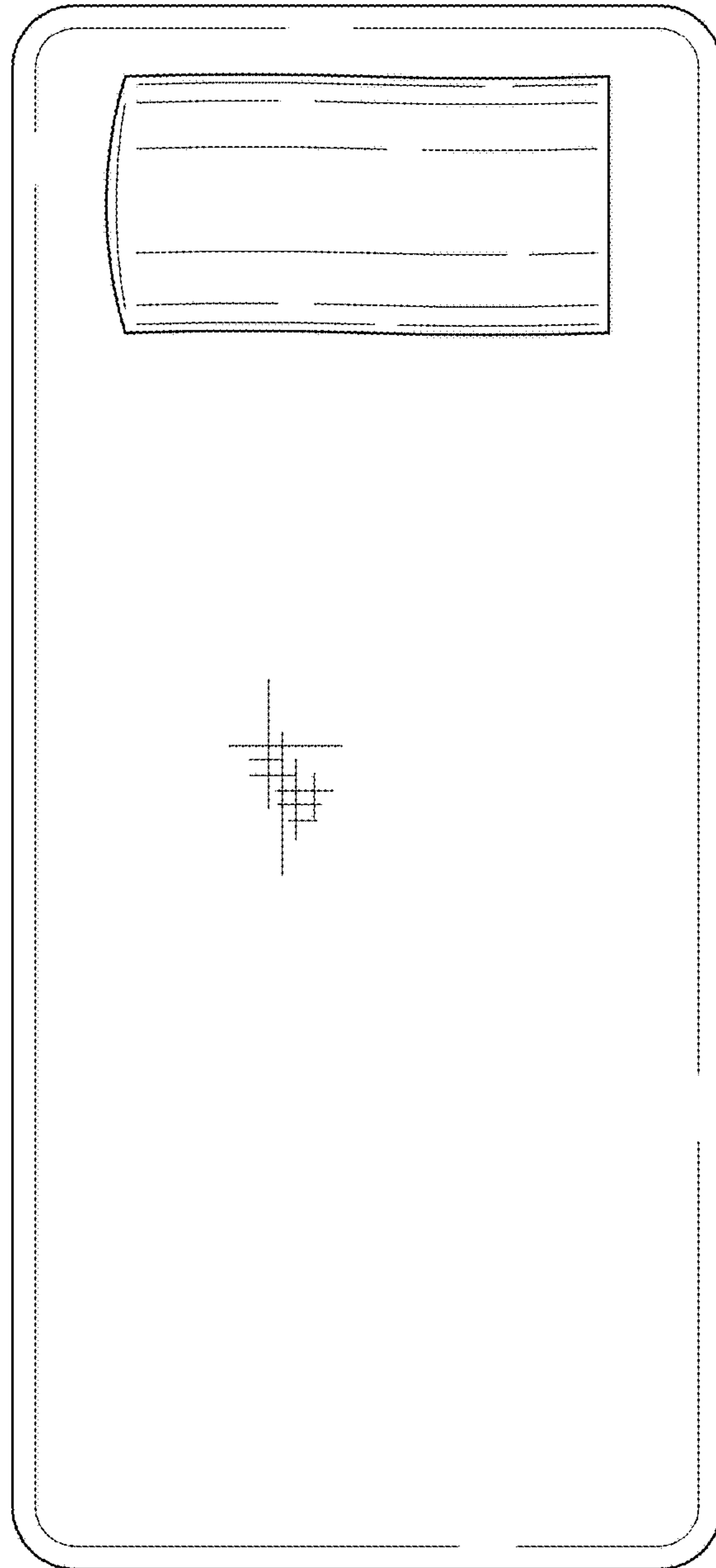

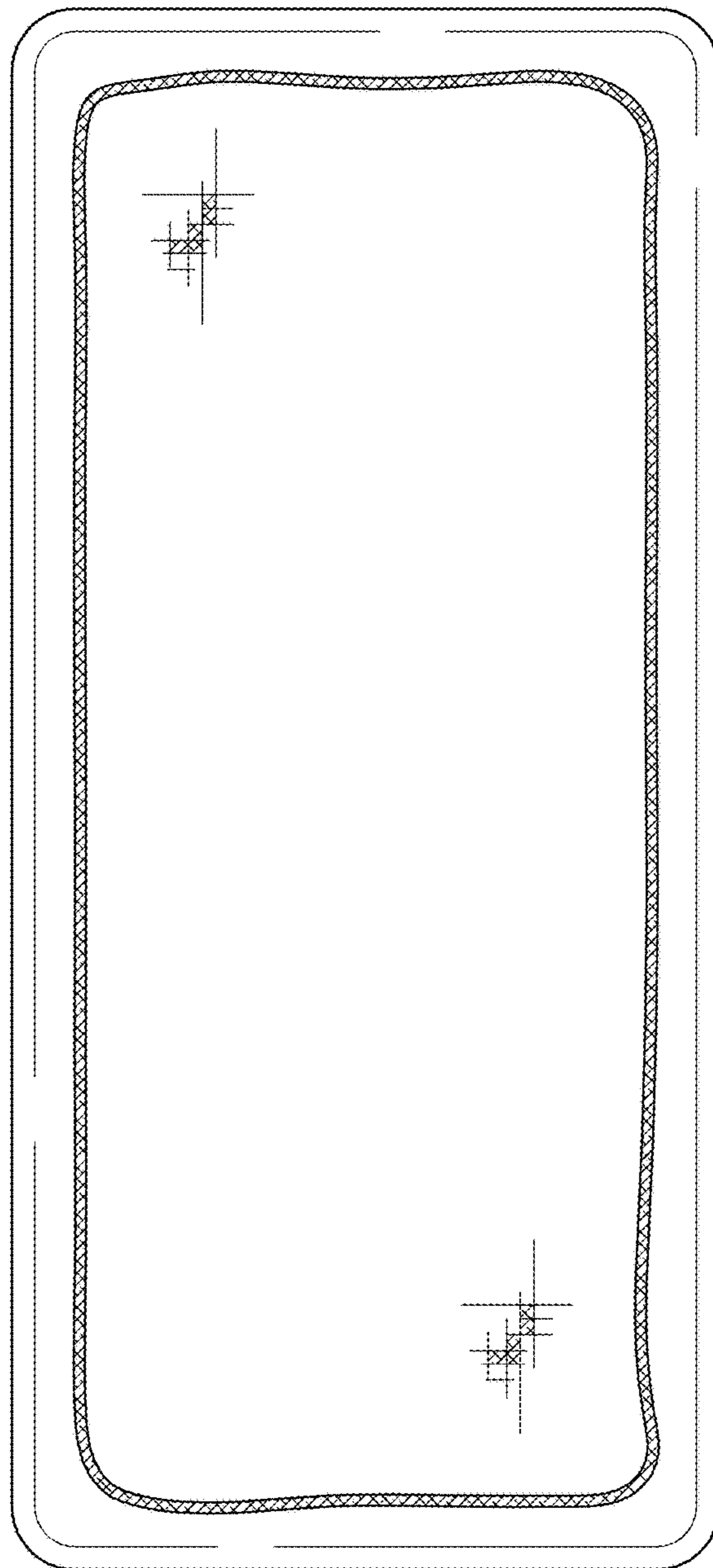

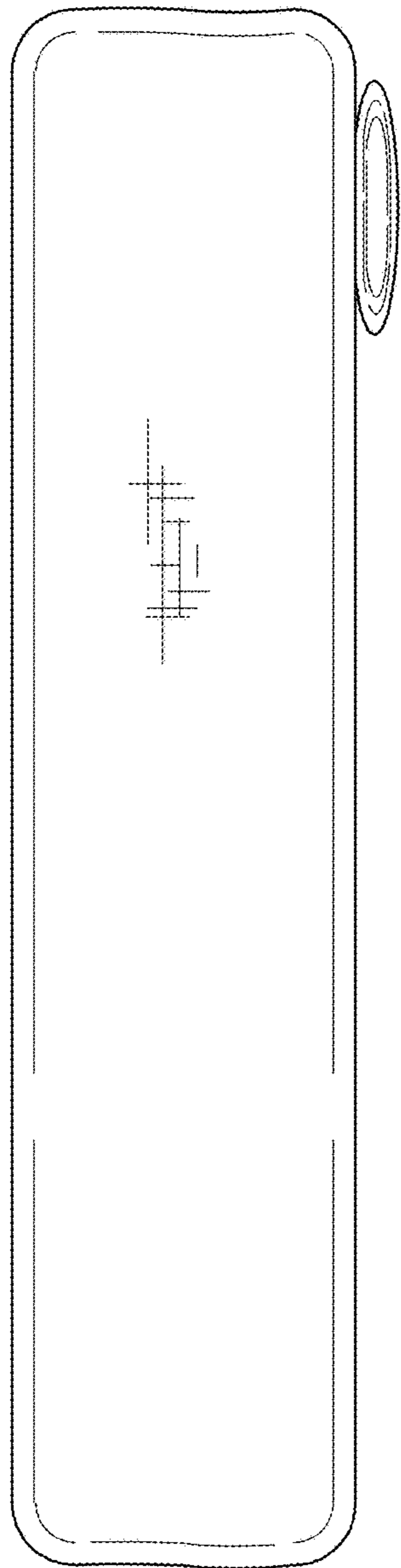

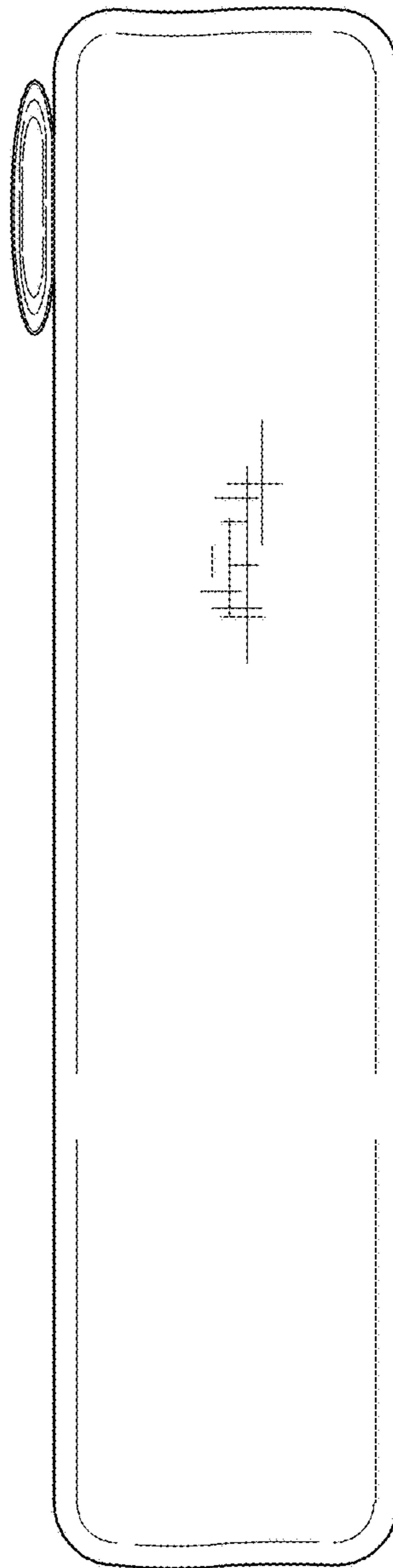

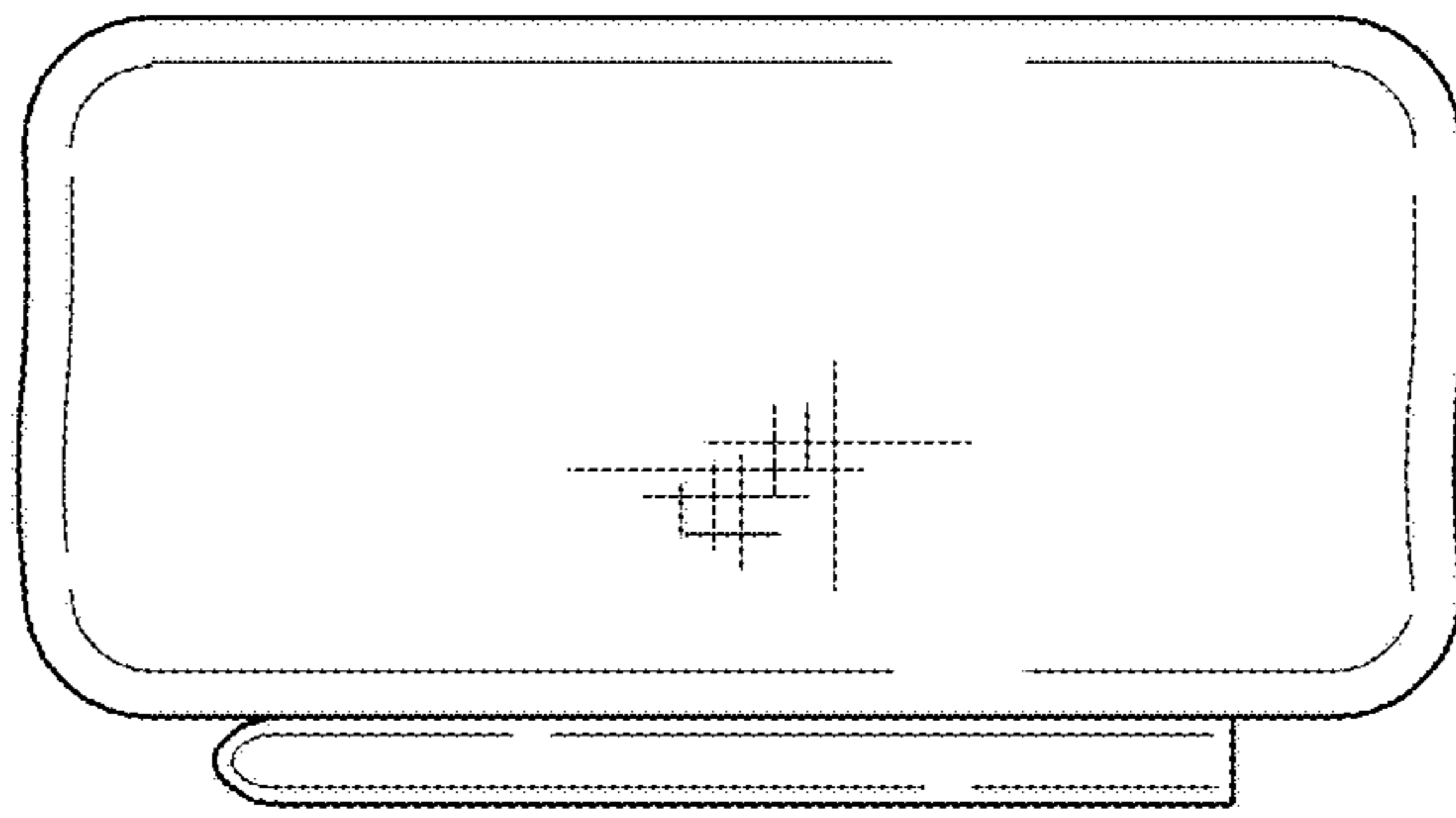

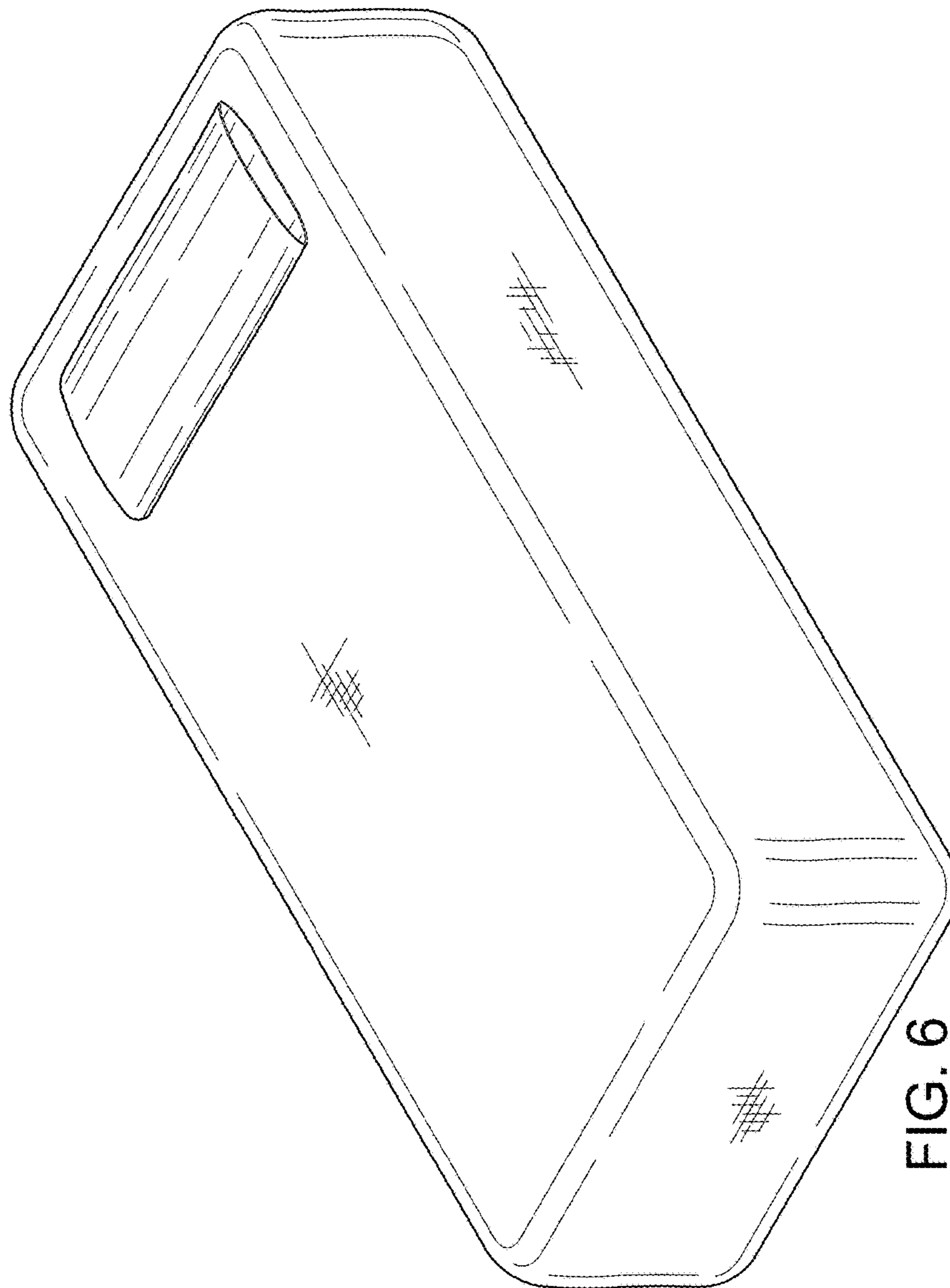

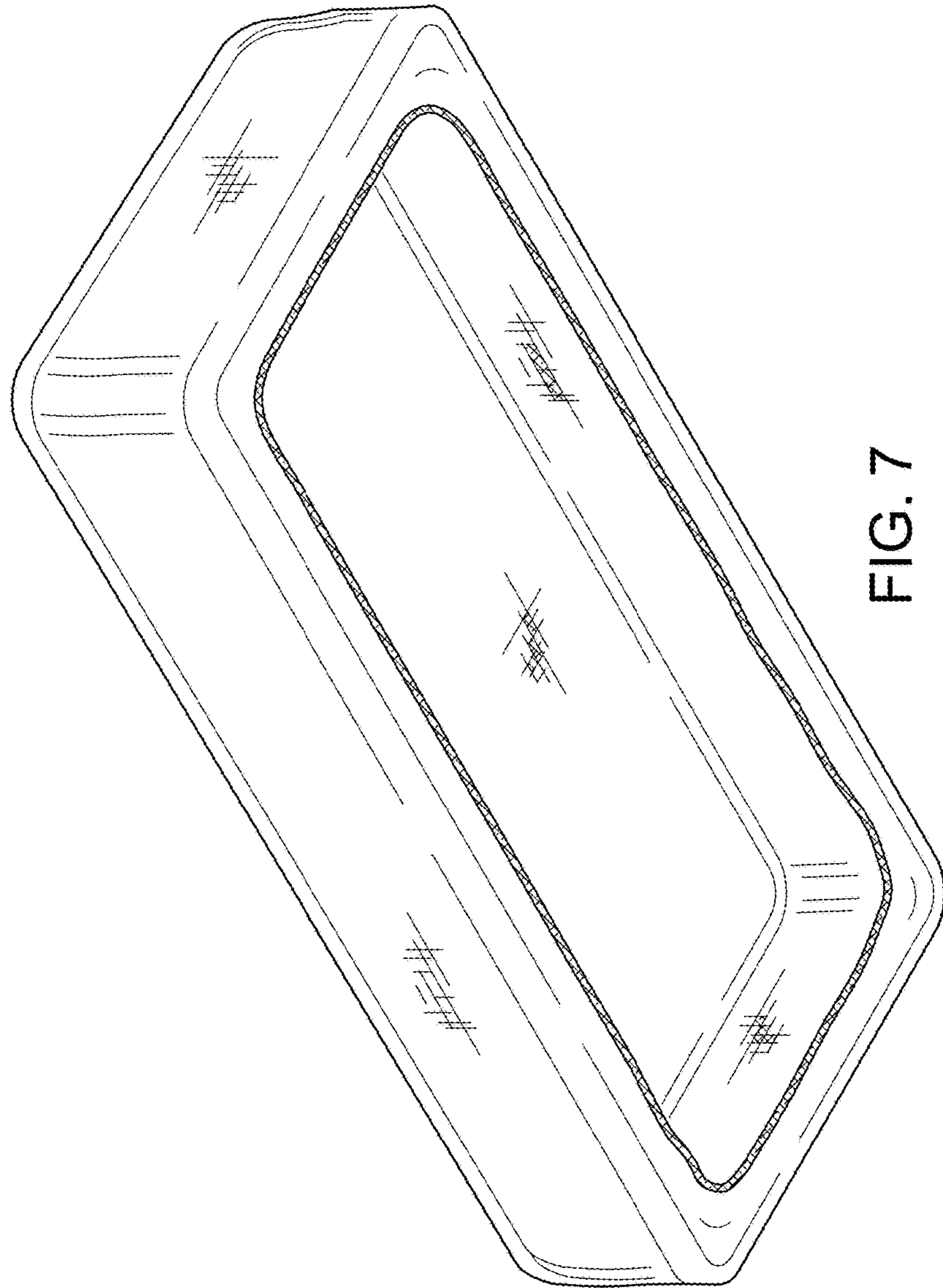
