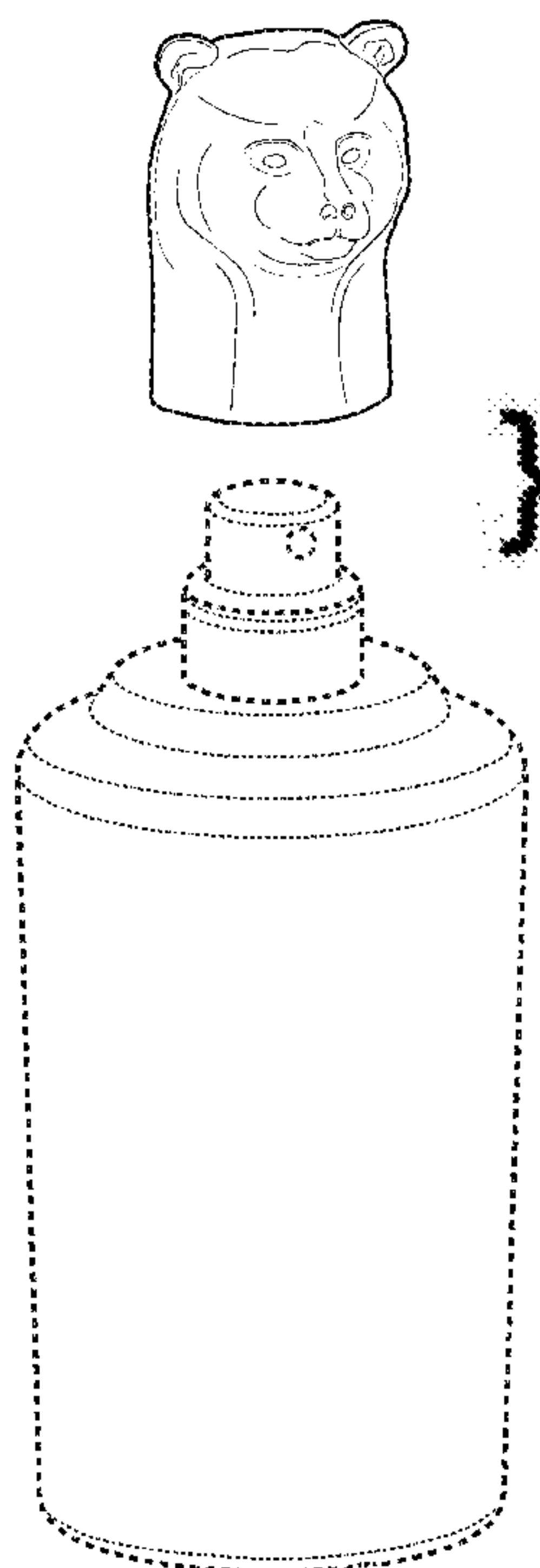
(57) **CLAIM**

The ornamental design for a perfume bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front exploded view of my ornamental design for a perfume bottle with cap removed from the bottle; FIG. 2 is top plan view thereof; FIG. 3 is rear elevational view thereof; FIG. 4 is left side view thereof; FIG. 5 is a front elevational view thereof; and, FIG. 6 is right side view thereof. The broken lines in each of the figures are for environmental purposes only and form no part of the claimed design.

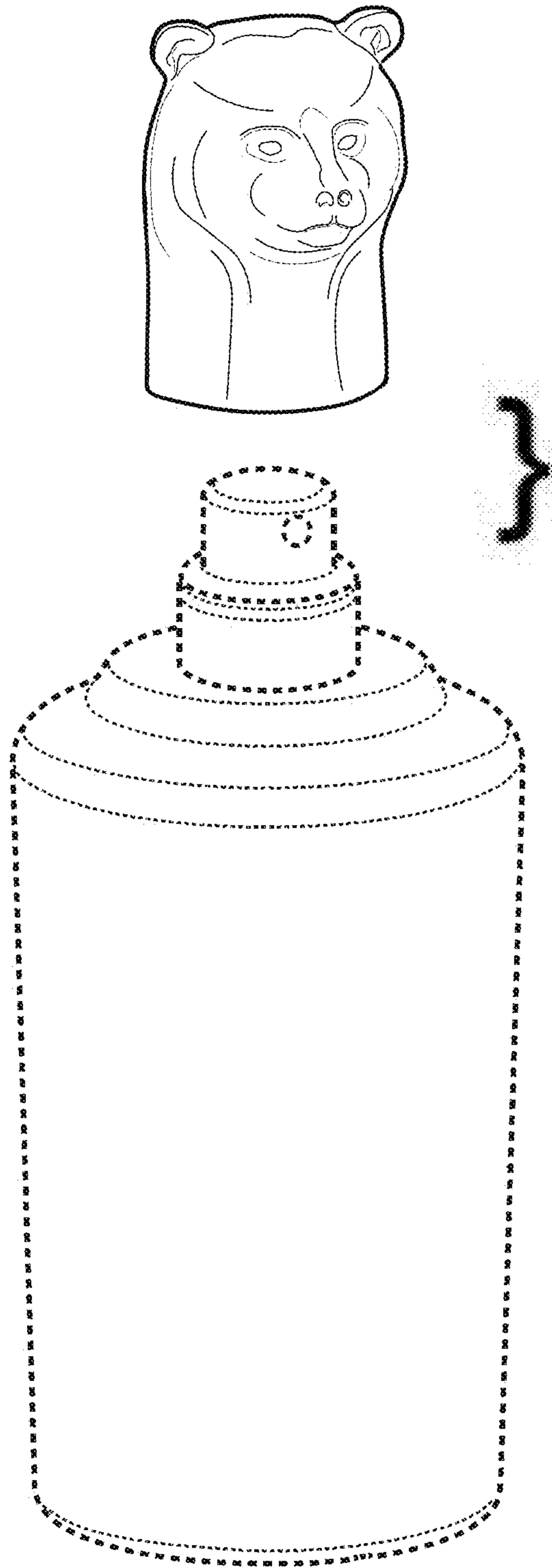

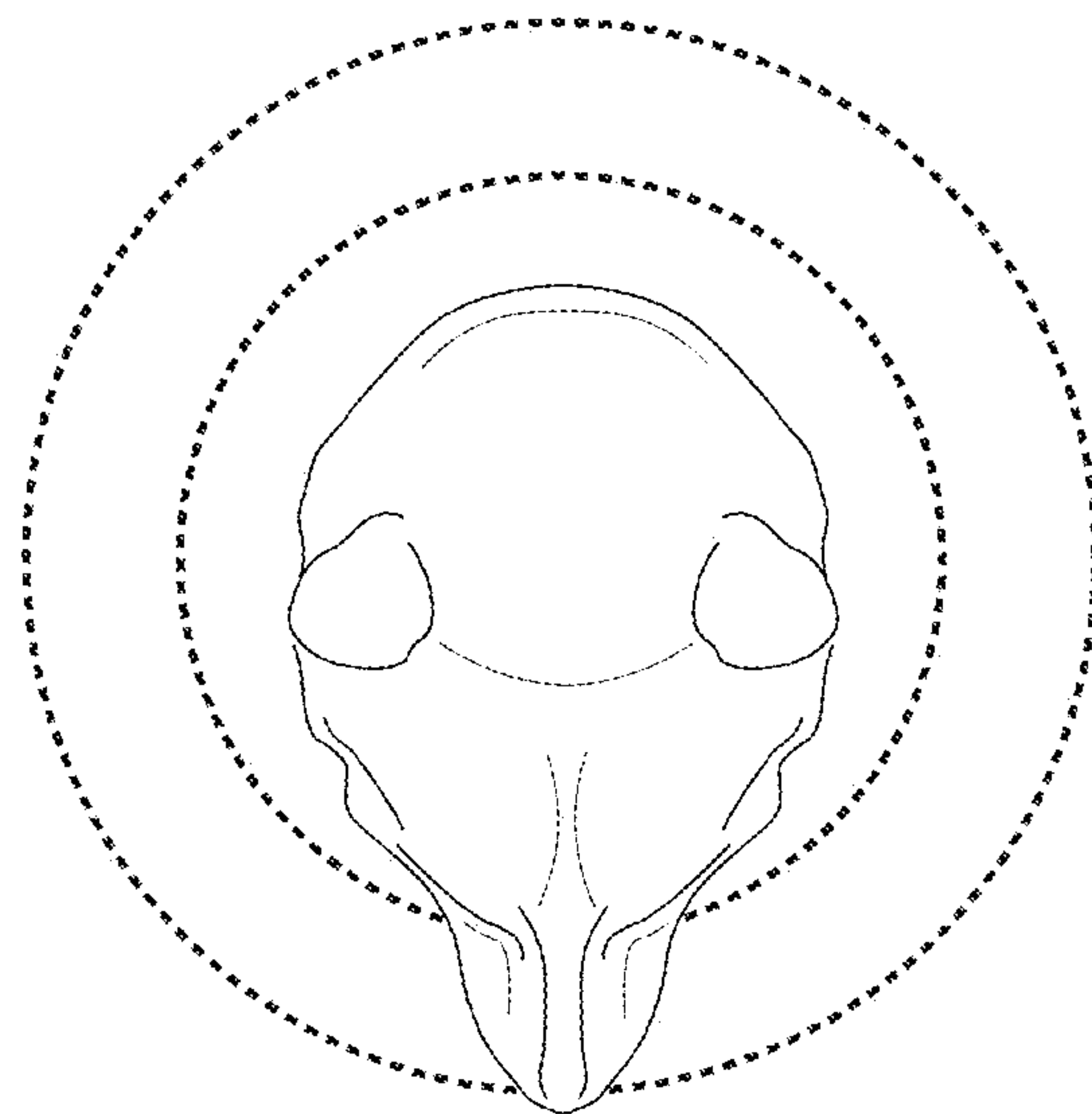

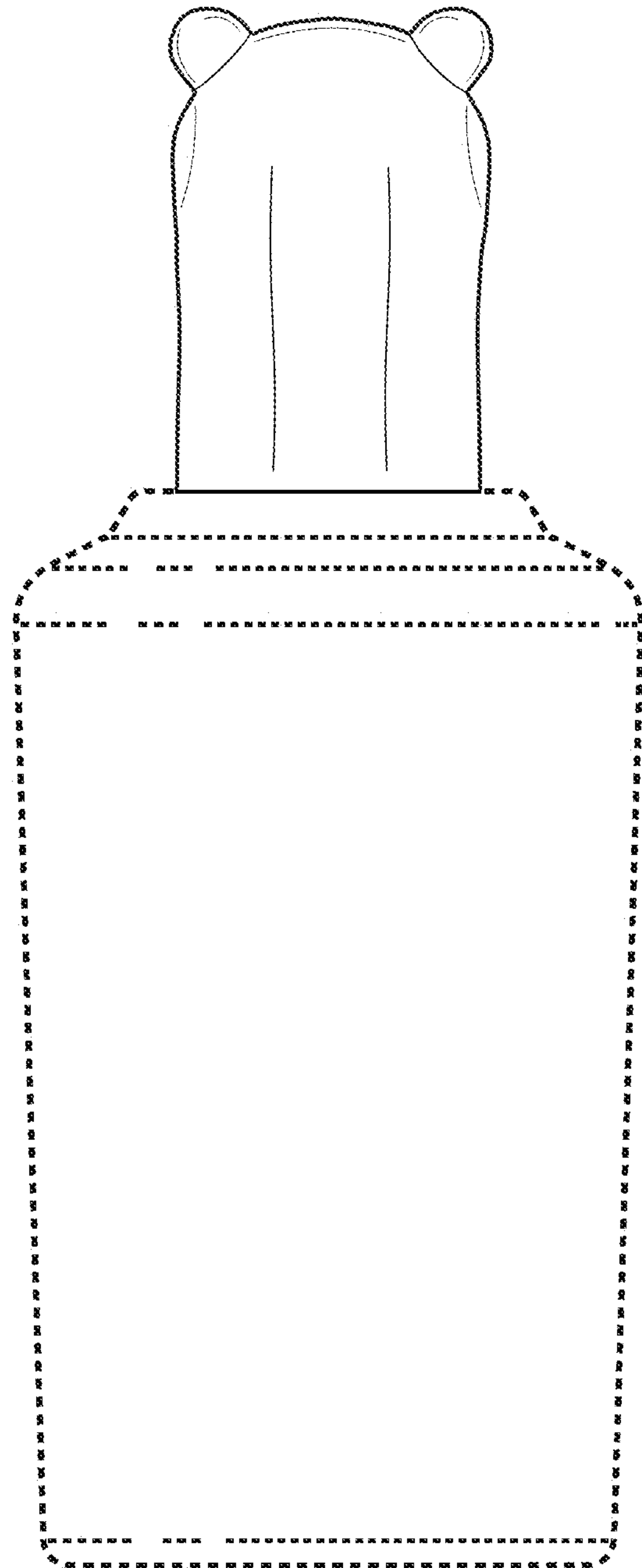

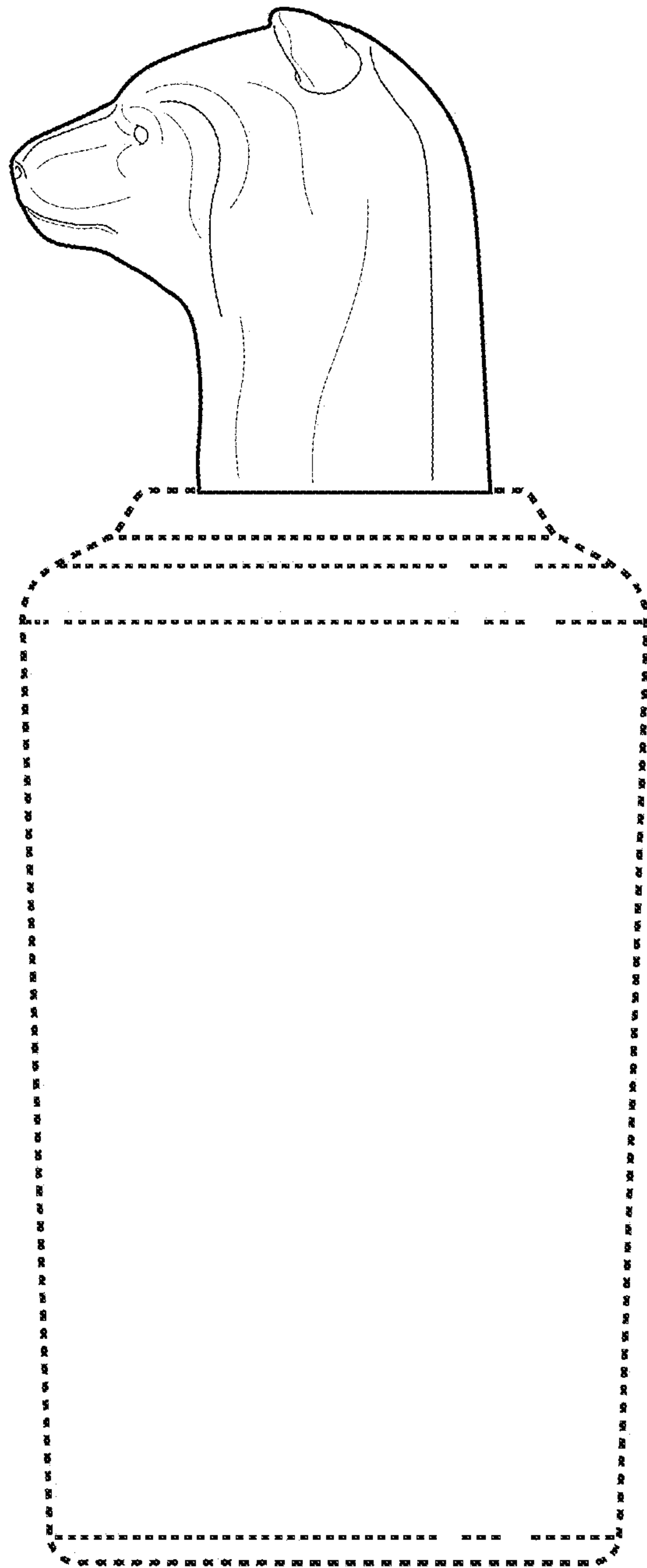

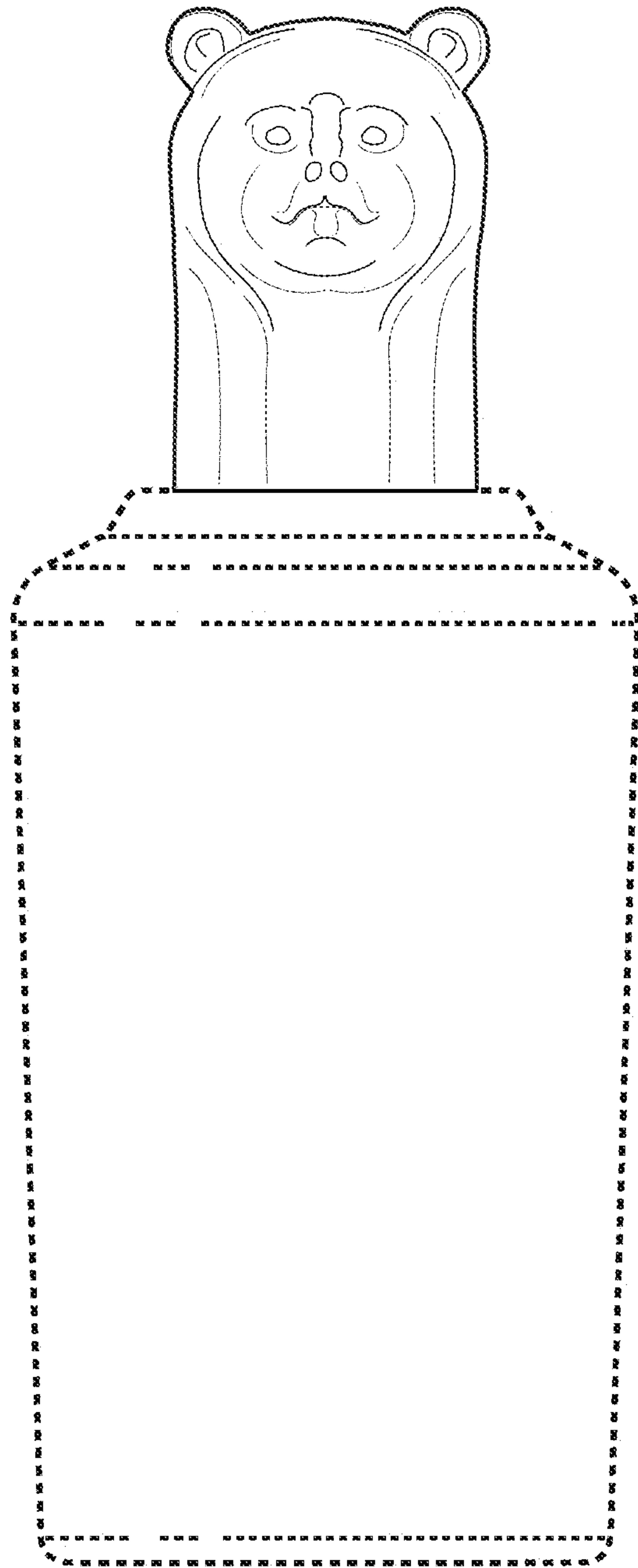

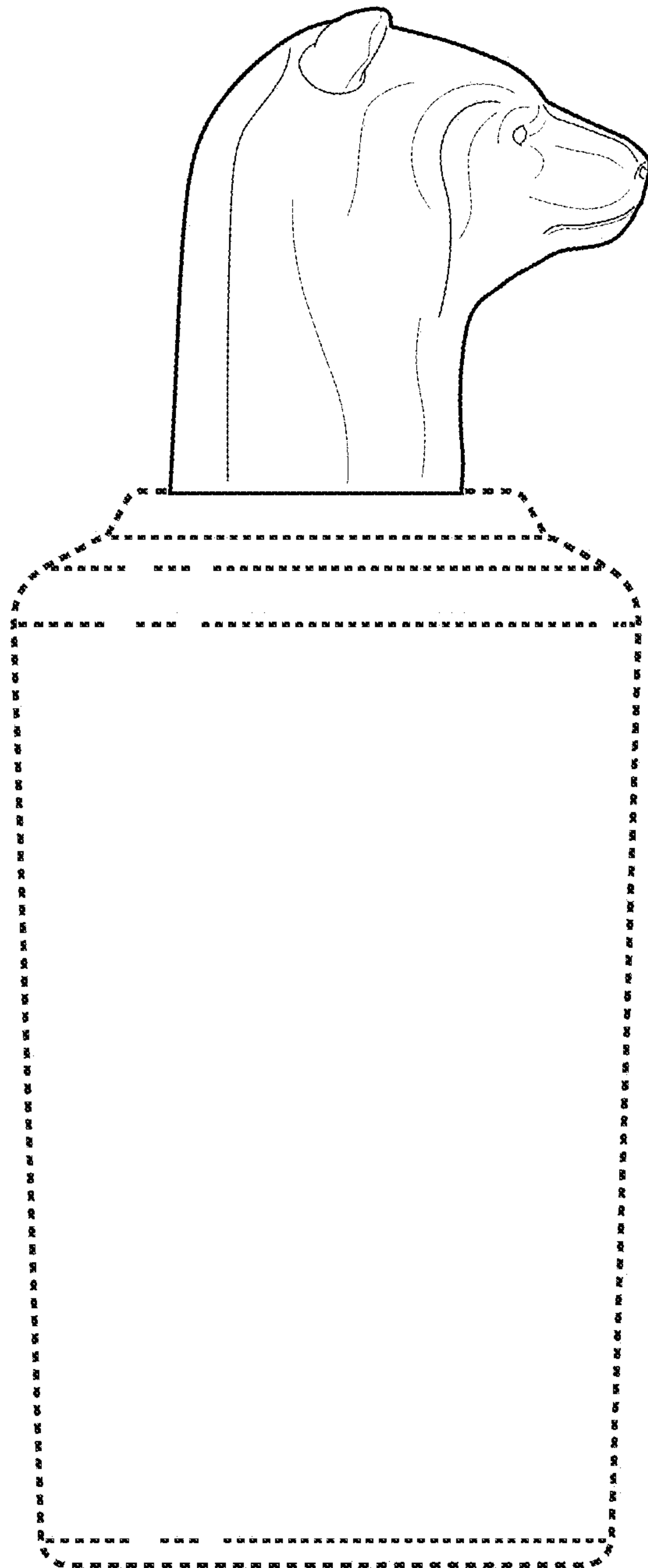
