(57) **CLAIM**

The ornamental design for a thick, inflexible bag, in particular a silicone bag, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, left-side perspective view of a thick, inflexible bag, in particular a silicone bag, showing my new design;

FIG. 2 is an front elevational view thereof; a rear elevational view being identical thereof;

FIG. 3 is a right-side elevational view thereof; a left-side elevational view being identical thereof;

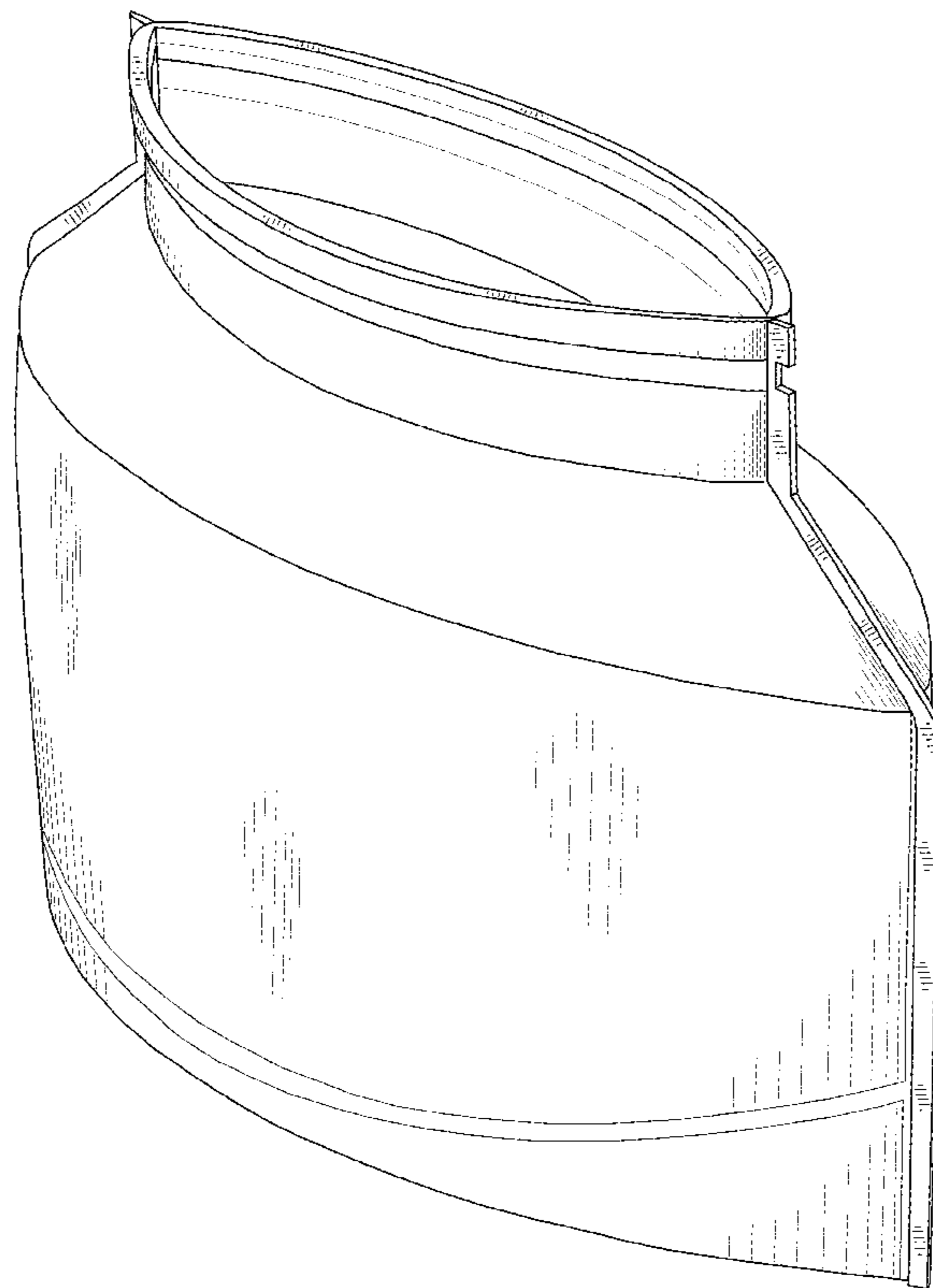
FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof; and,

FIG. 6. is a bottom, left-side perspective view thereof.

The new design for a thick, inflexible bag, in particular for a silicone bag, is characterized by a large, foldable bottom and a smaller top opening.

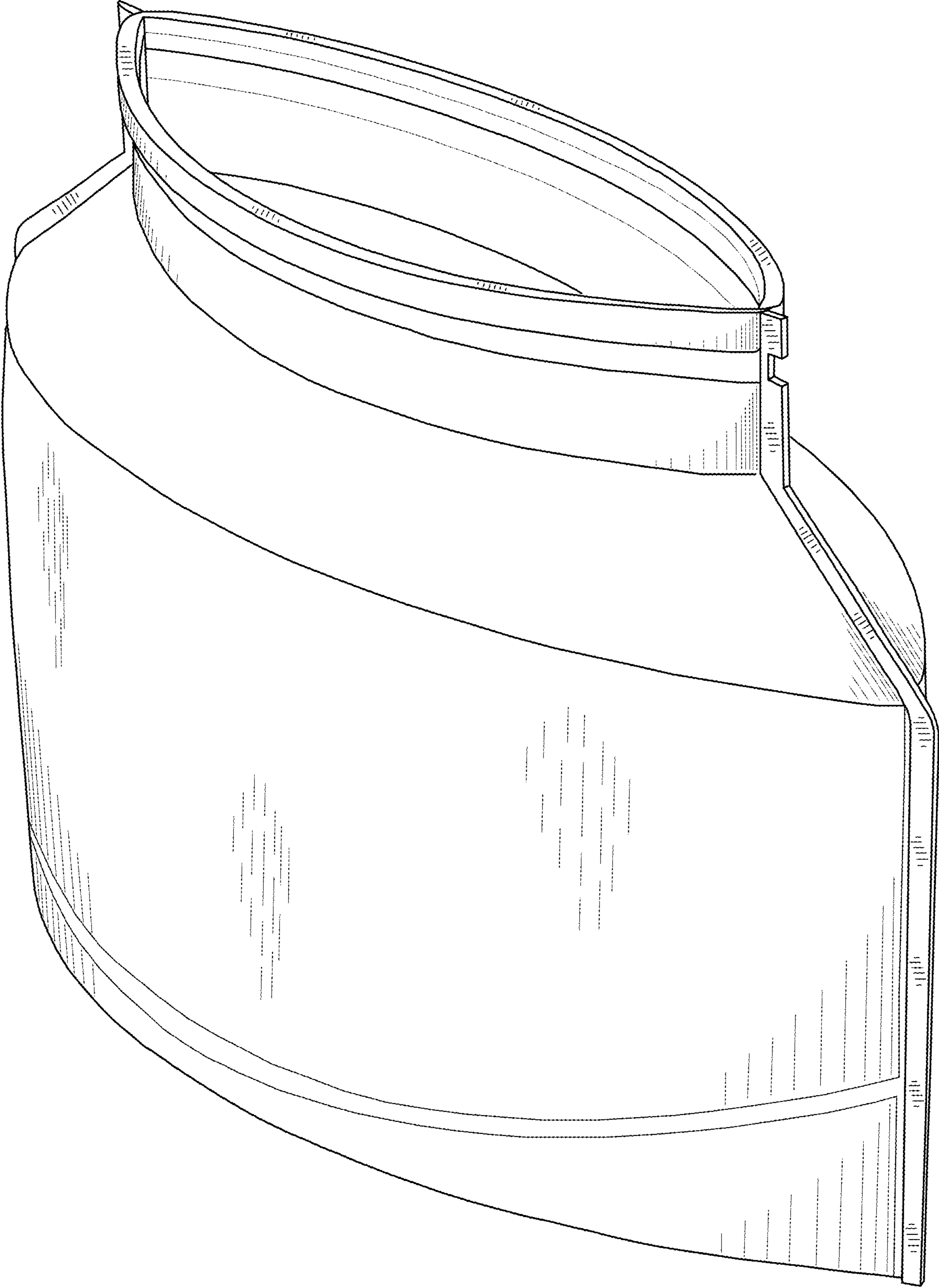

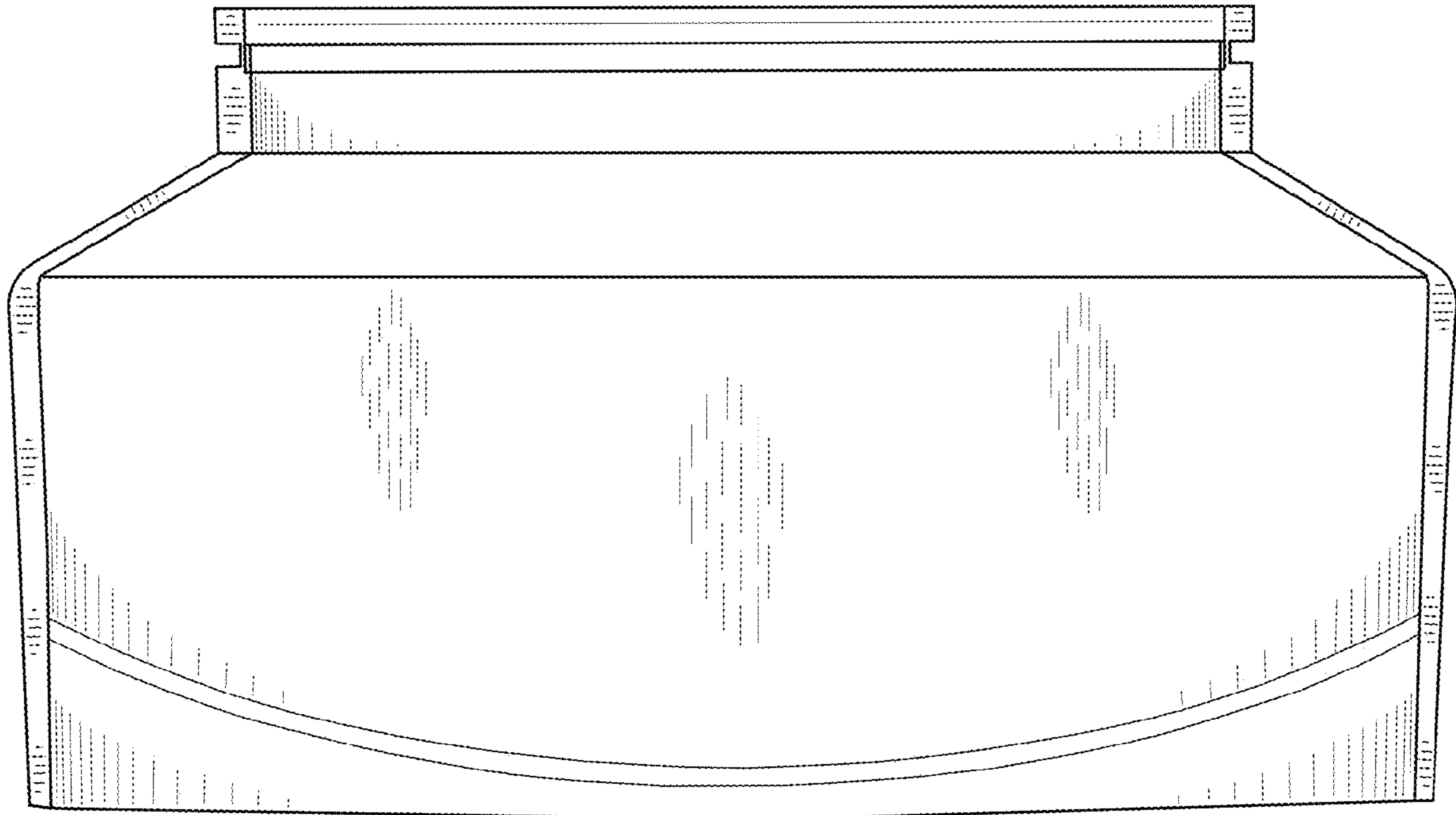

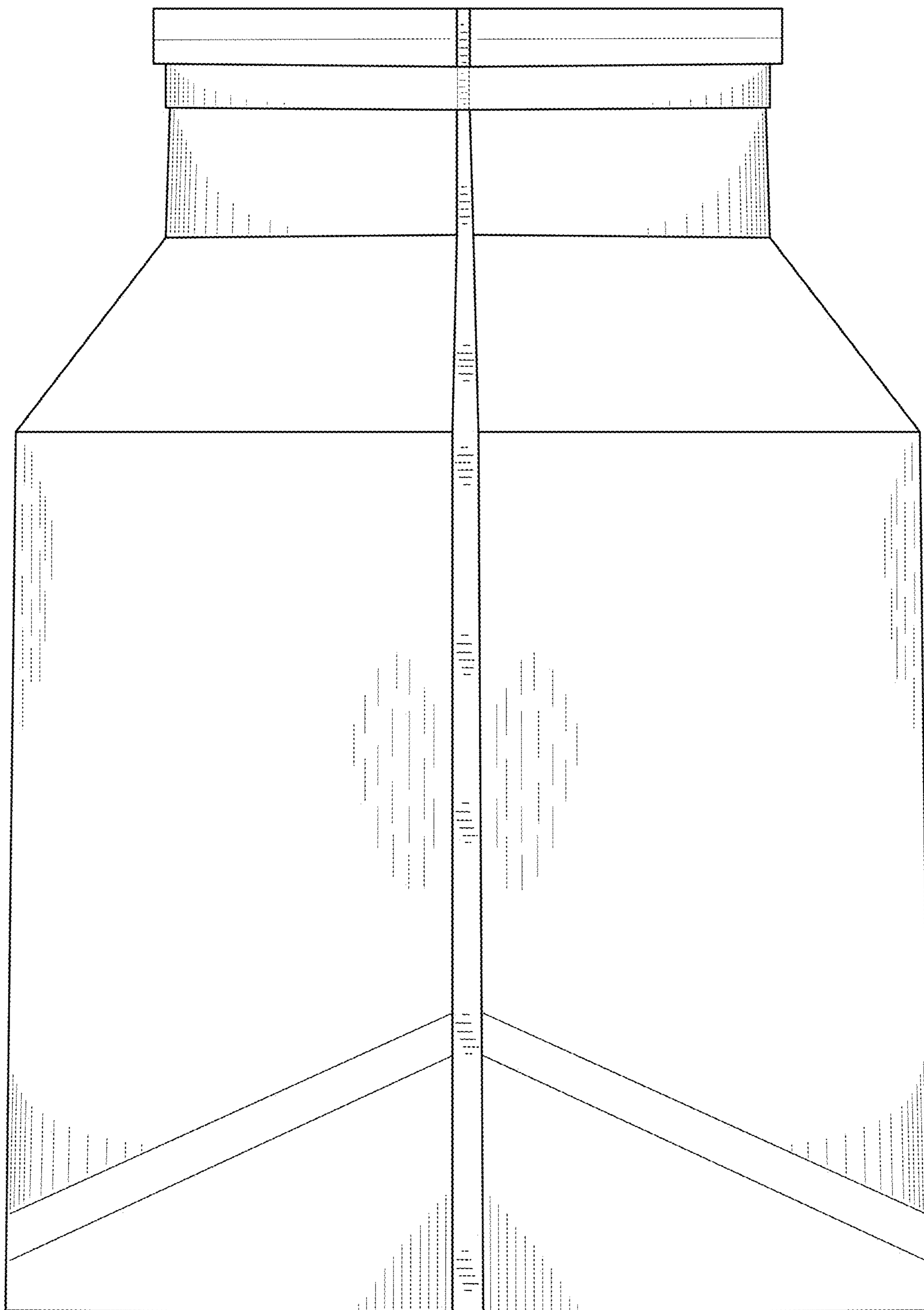

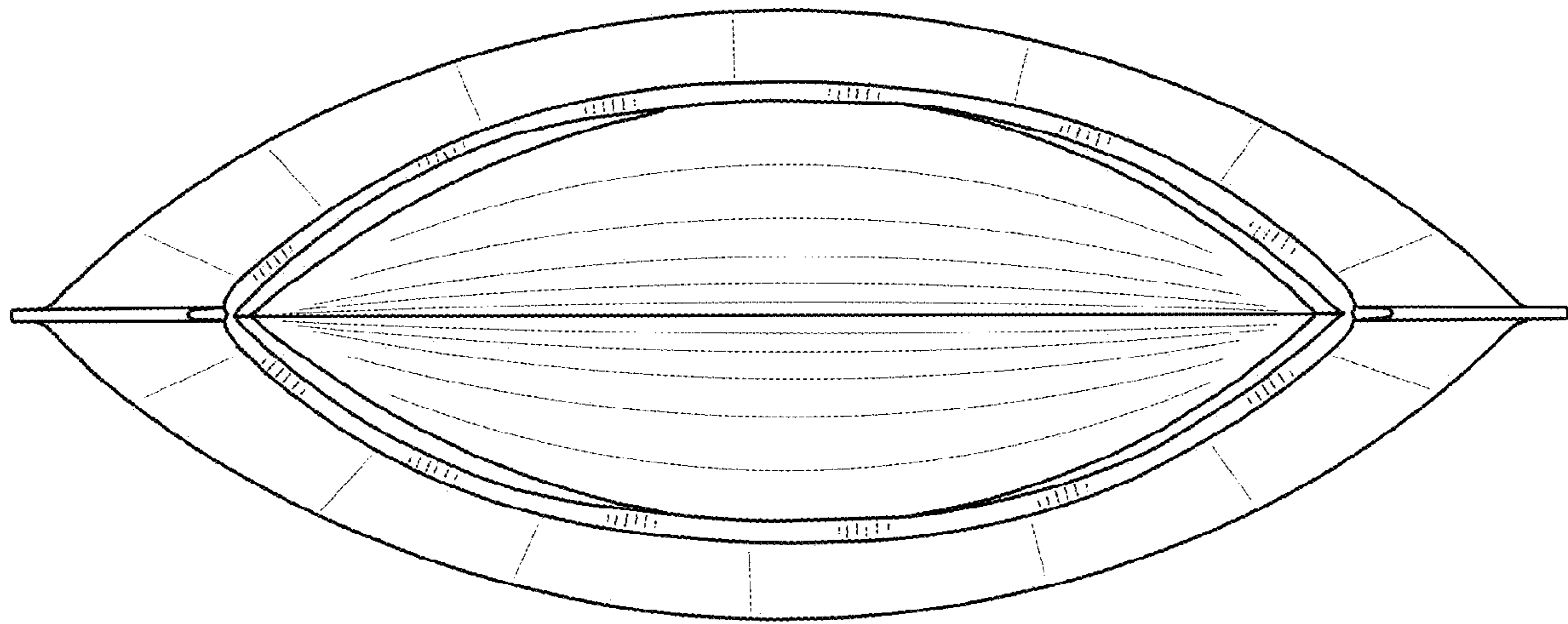

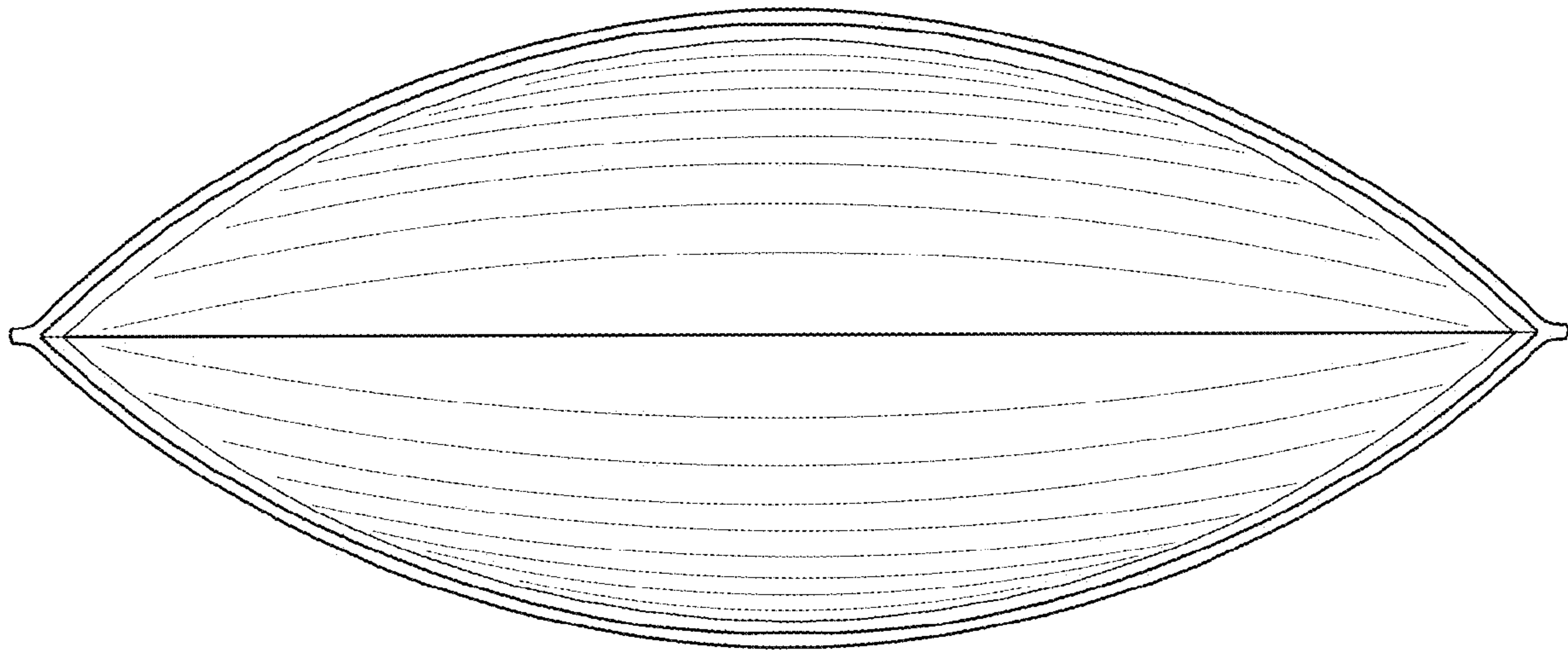

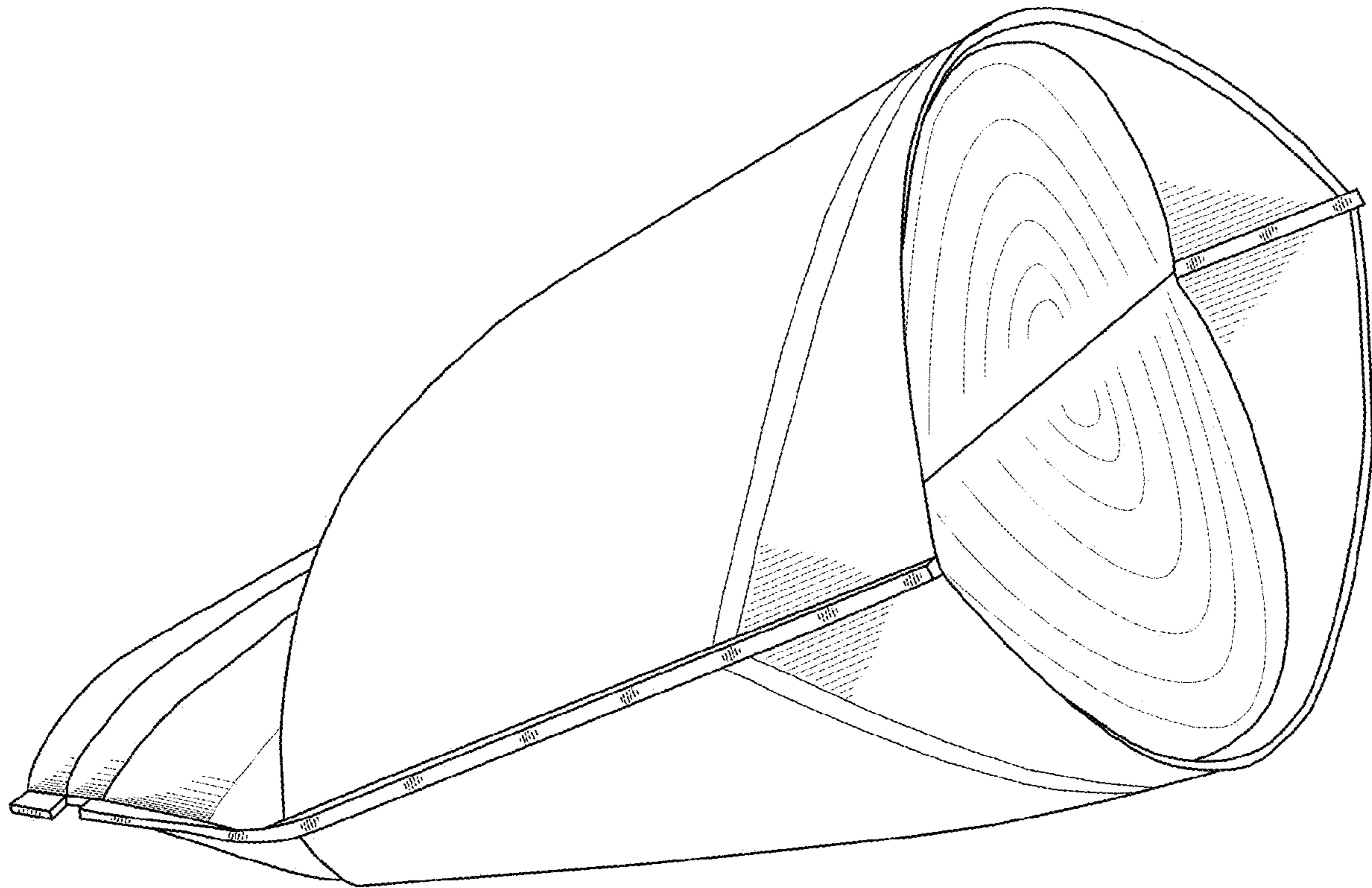
