(57) **CLAIM**

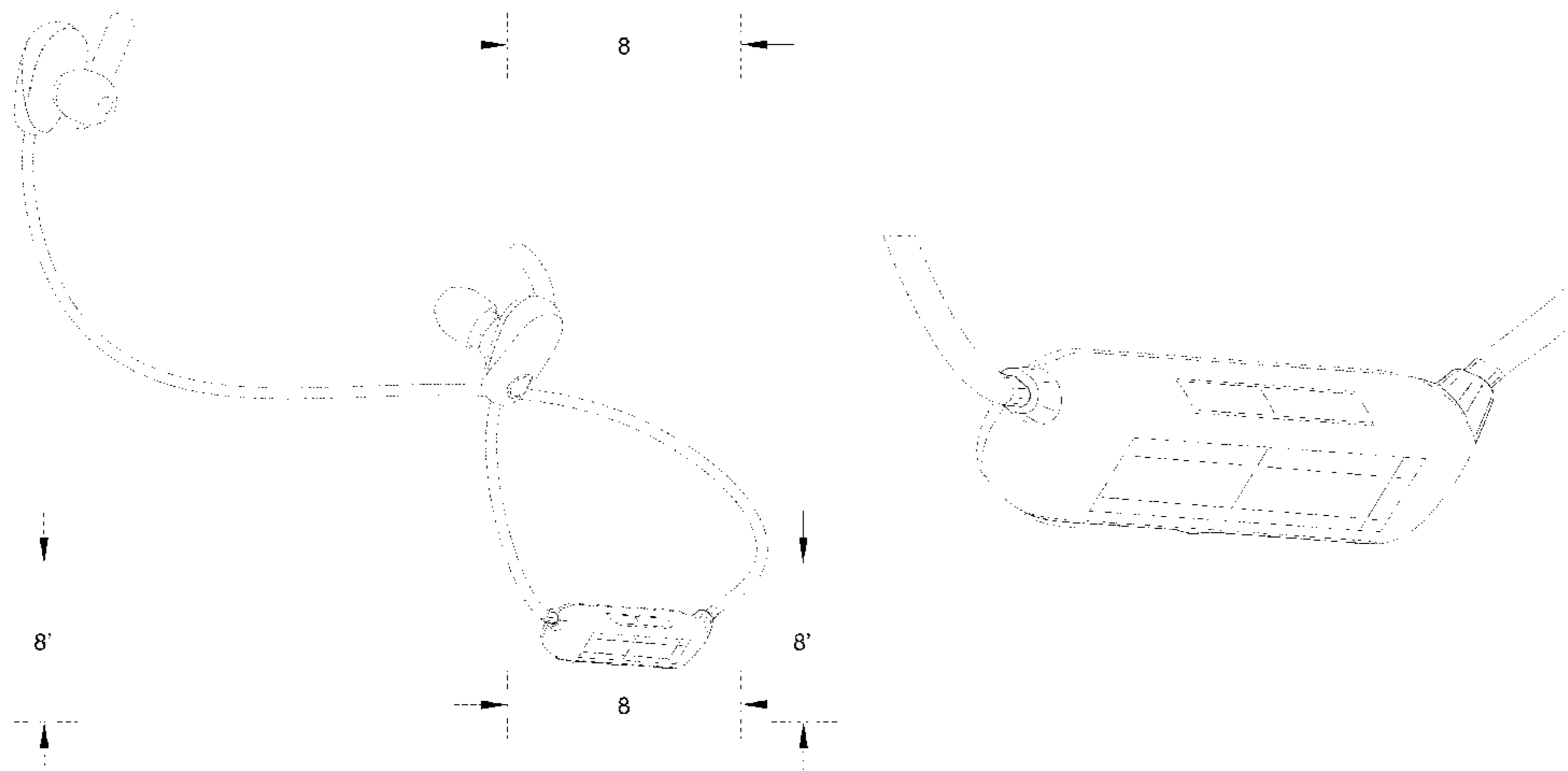
The ornamental design for an earphone, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of an earphone showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a top plan view thereof; and FIG. 7 is a bottom plan view thereof. FIG. 8 is a partially enlarged perspective view along the lines 8-8 and 8'-8' of FIG. 1. FIG. 9 is a perspective view of a second embodiment of an earphone showing my new design; FIG. 10 is a front elevational view thereof; FIG. 11 is a rear elevational view thereof; FIG. 12 is a left side elevational view thereof; FIG. 13 is a right side elevational view thereof; FIG. 14 is a top plan view thereof; and FIG. 15 is a bottom plan view thereof; and, FIG. 16 is a partially enlarged perspective view along the lines 16-16 and 16'-16' of FIG. 9.

The broken lines illustrating the unclaimed portions of the earphone form no part of the claimed design. Dot-dash broken lines define the boundaries of the claimed design and form no part of the claimed design.

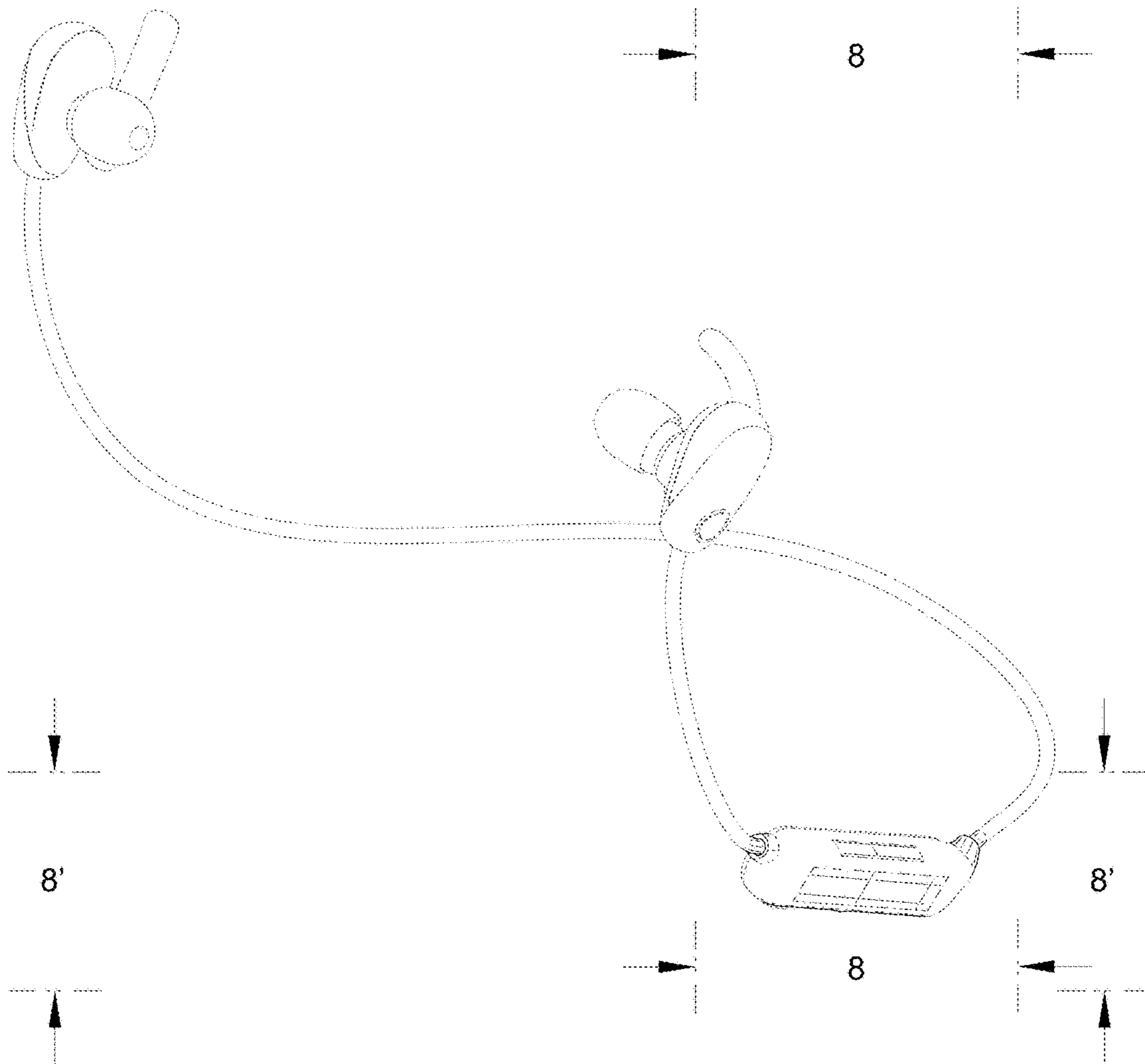

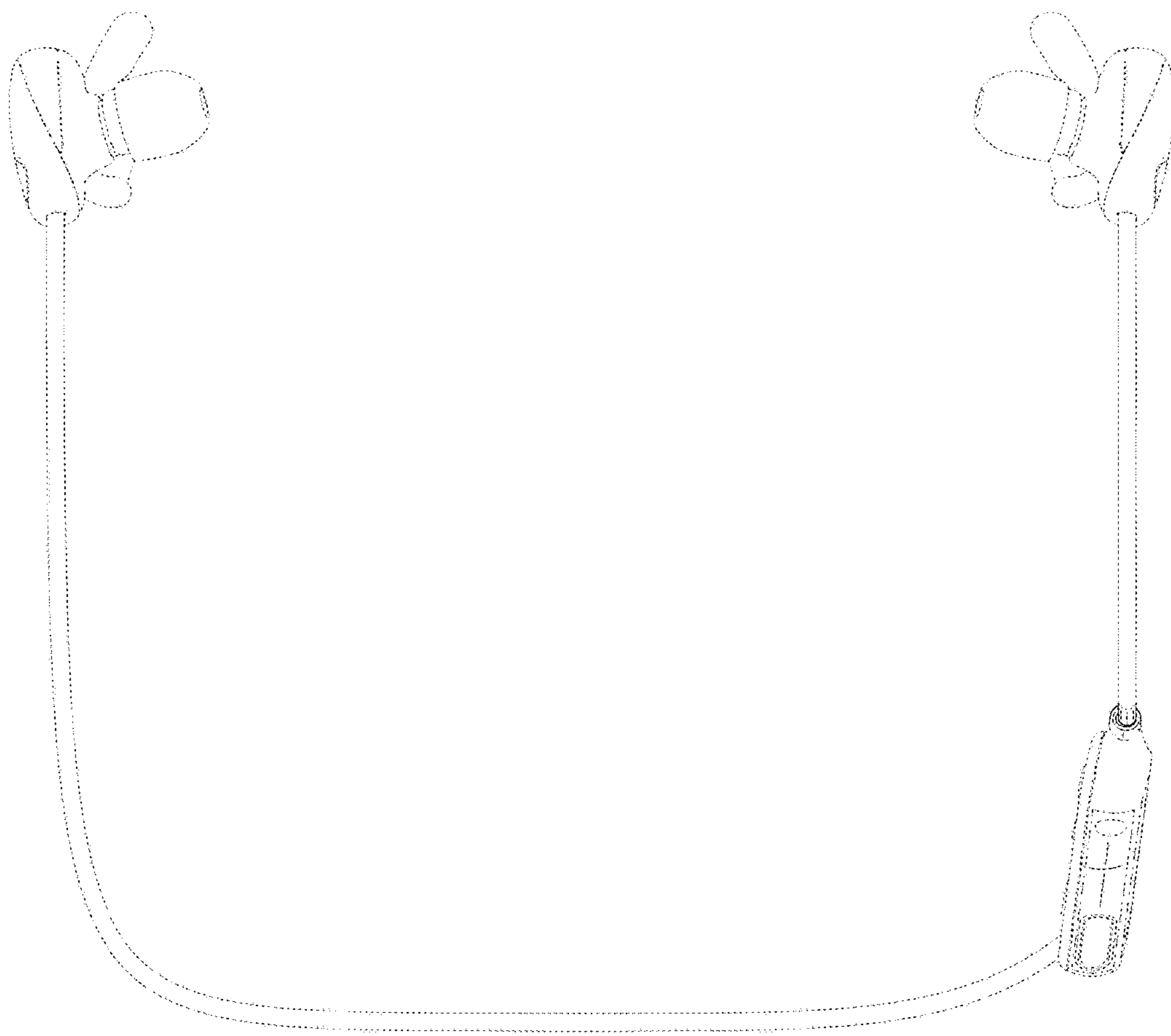

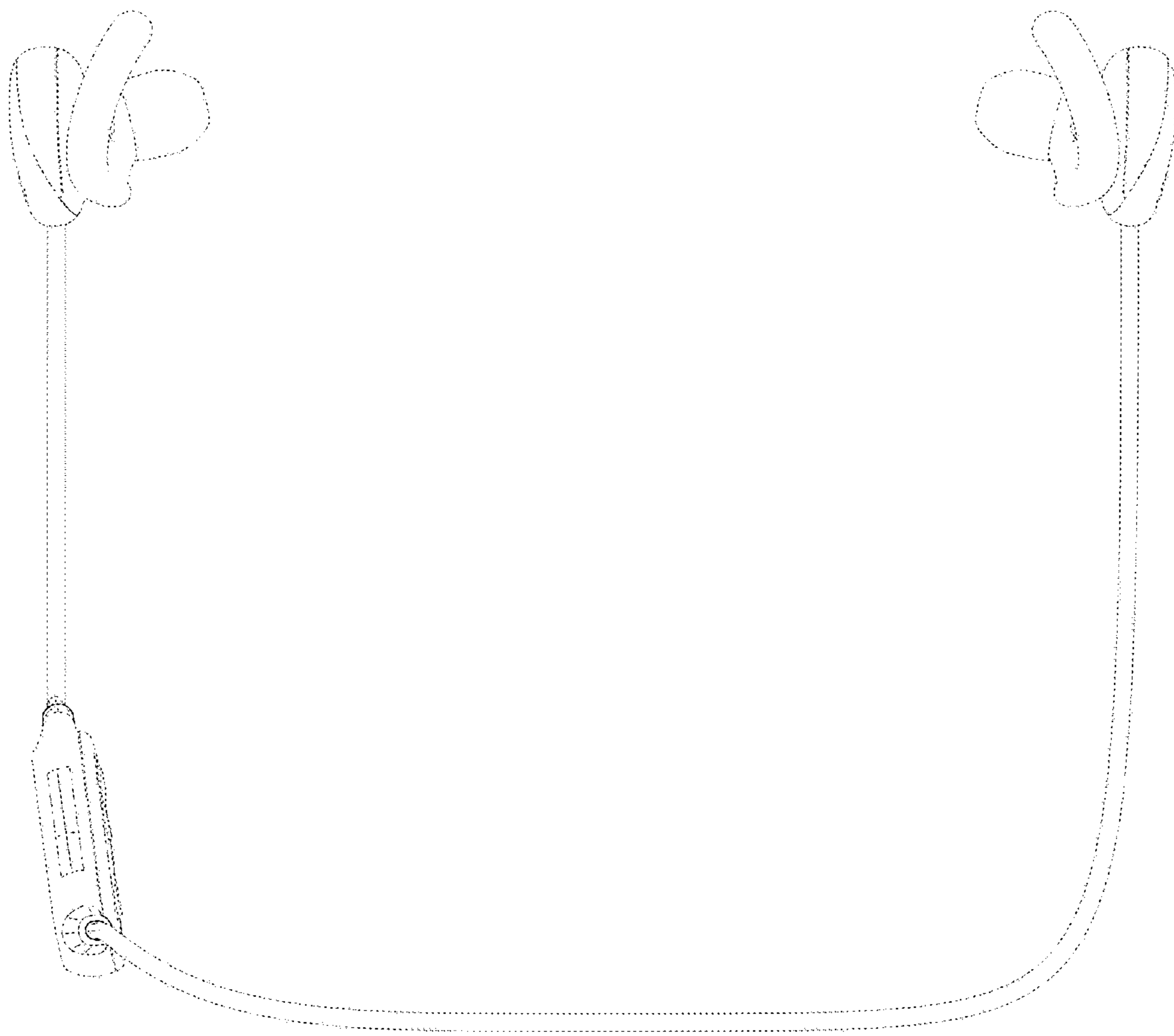

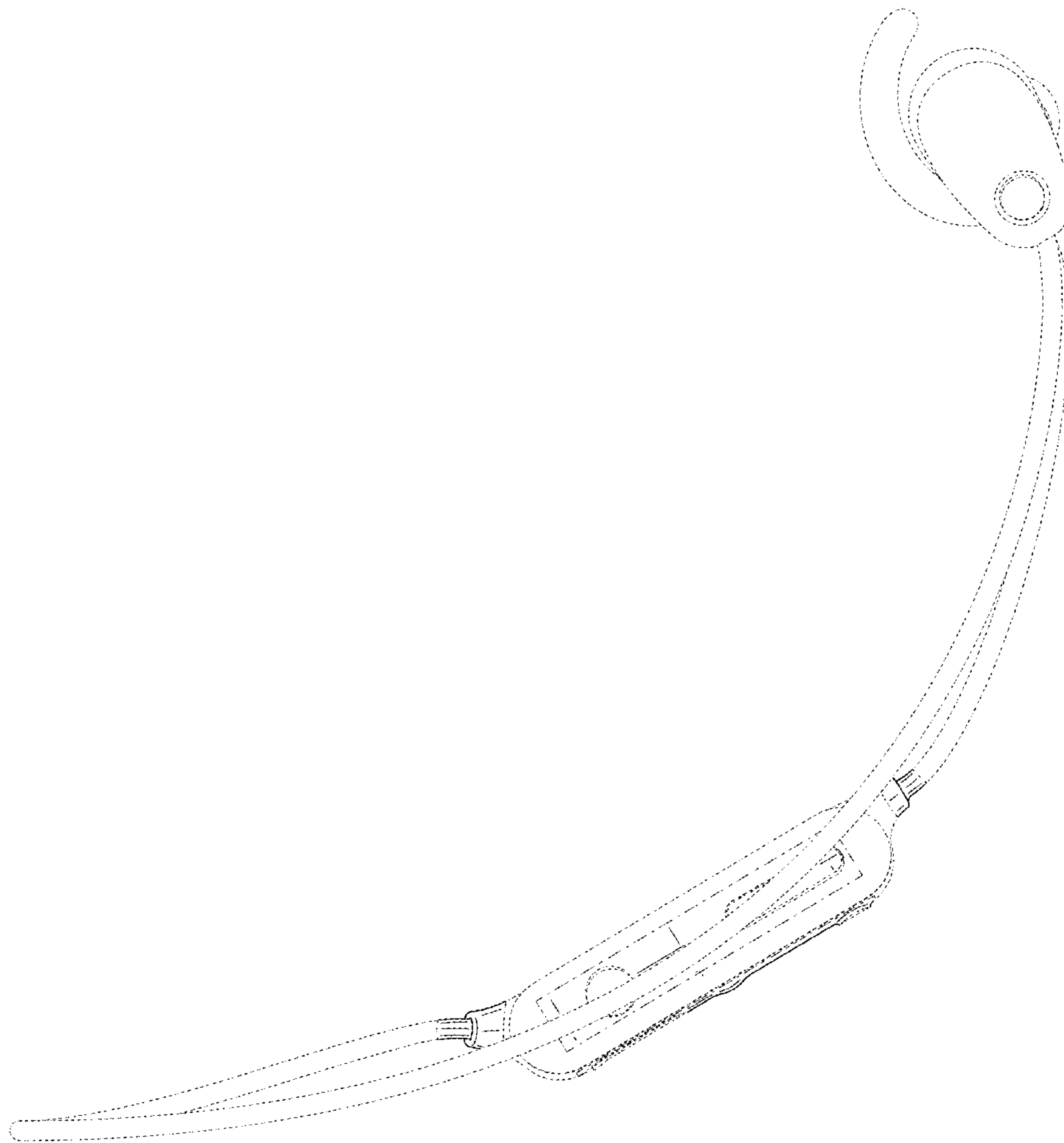

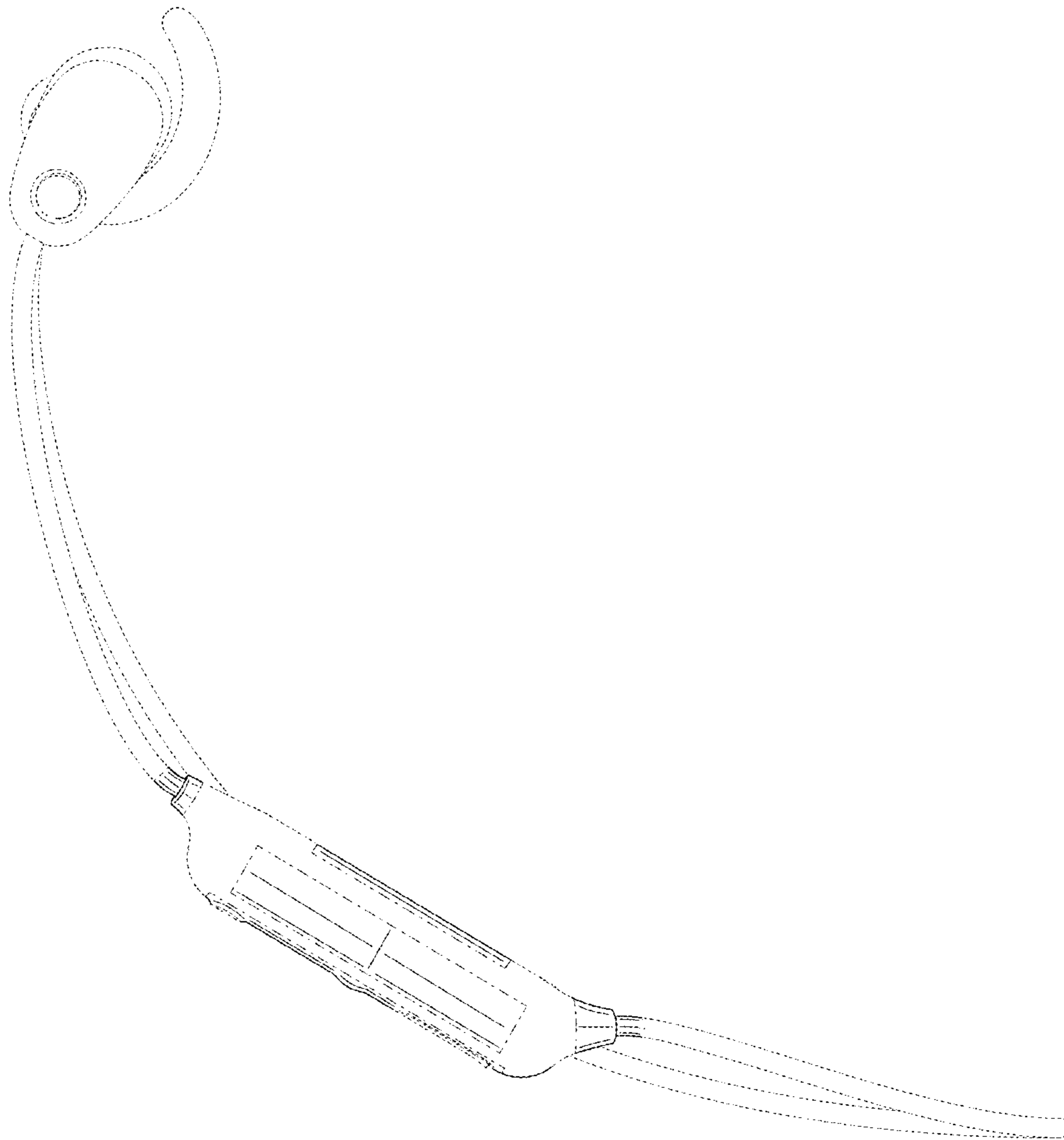

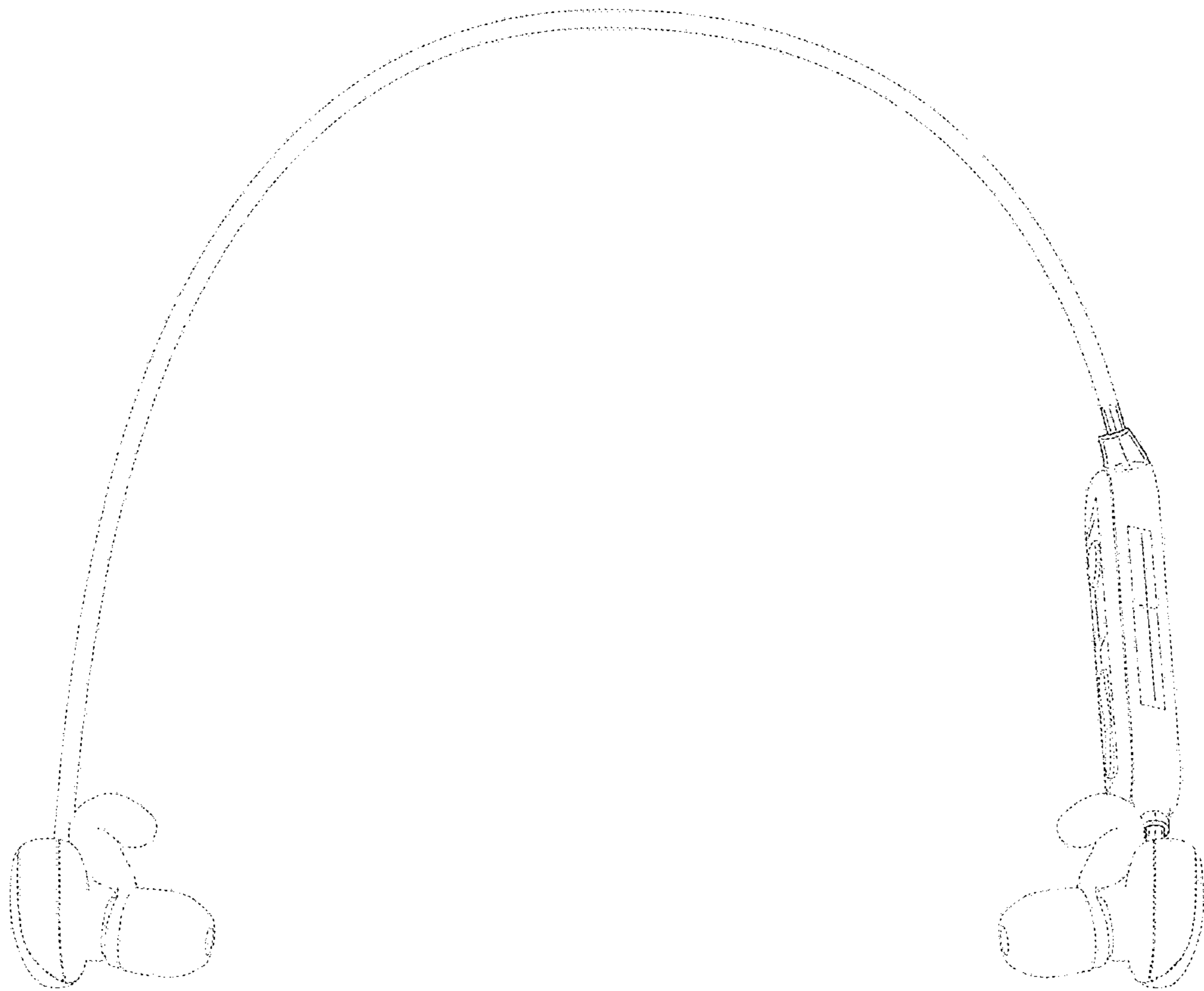

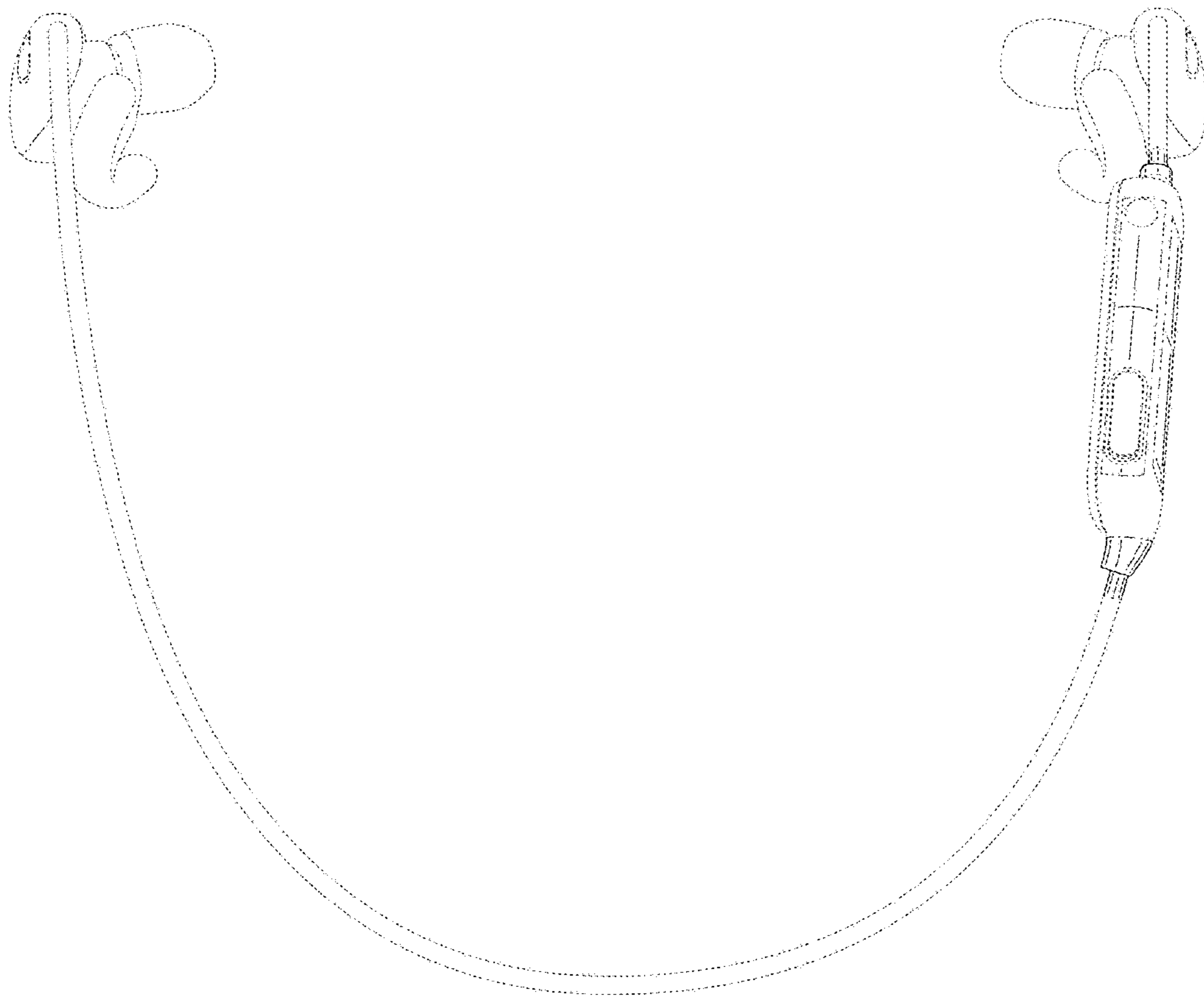

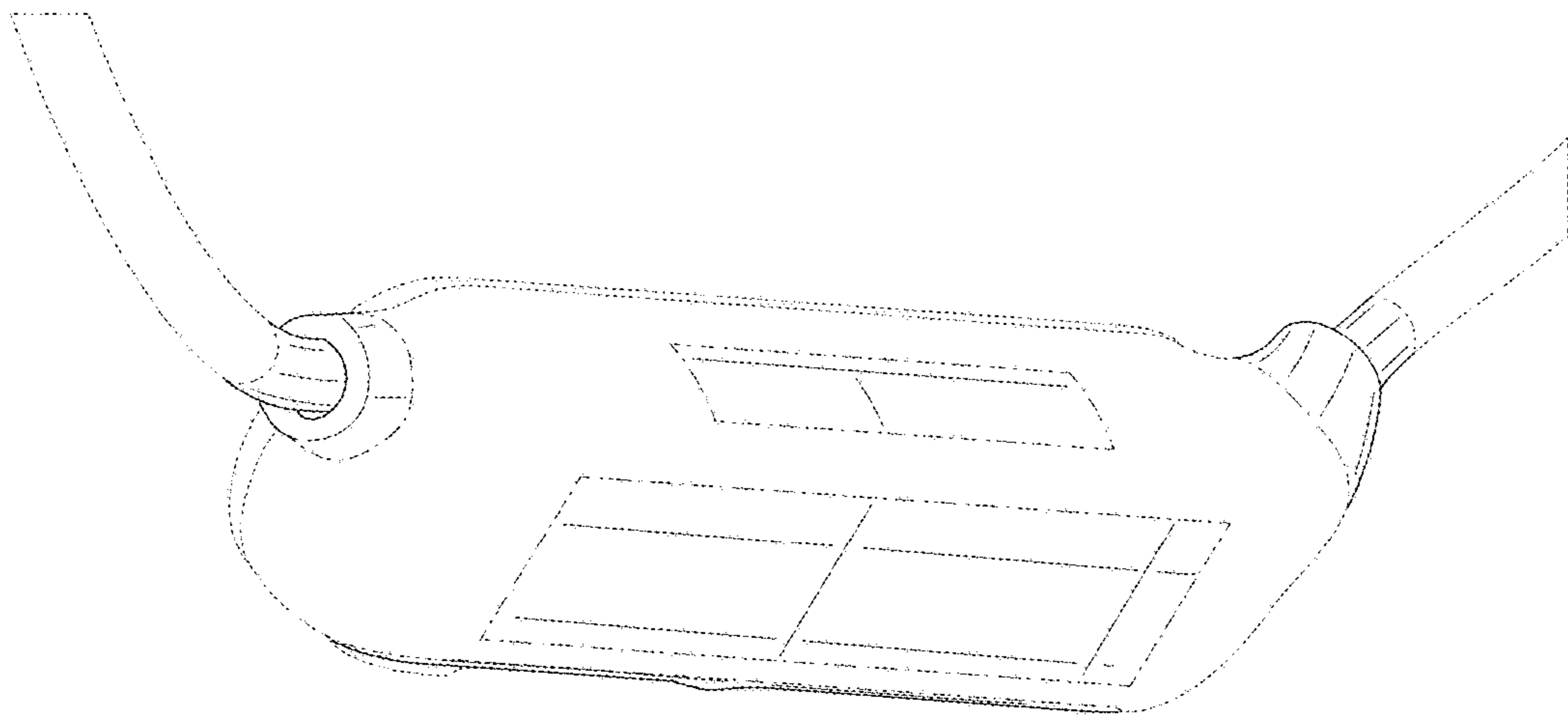

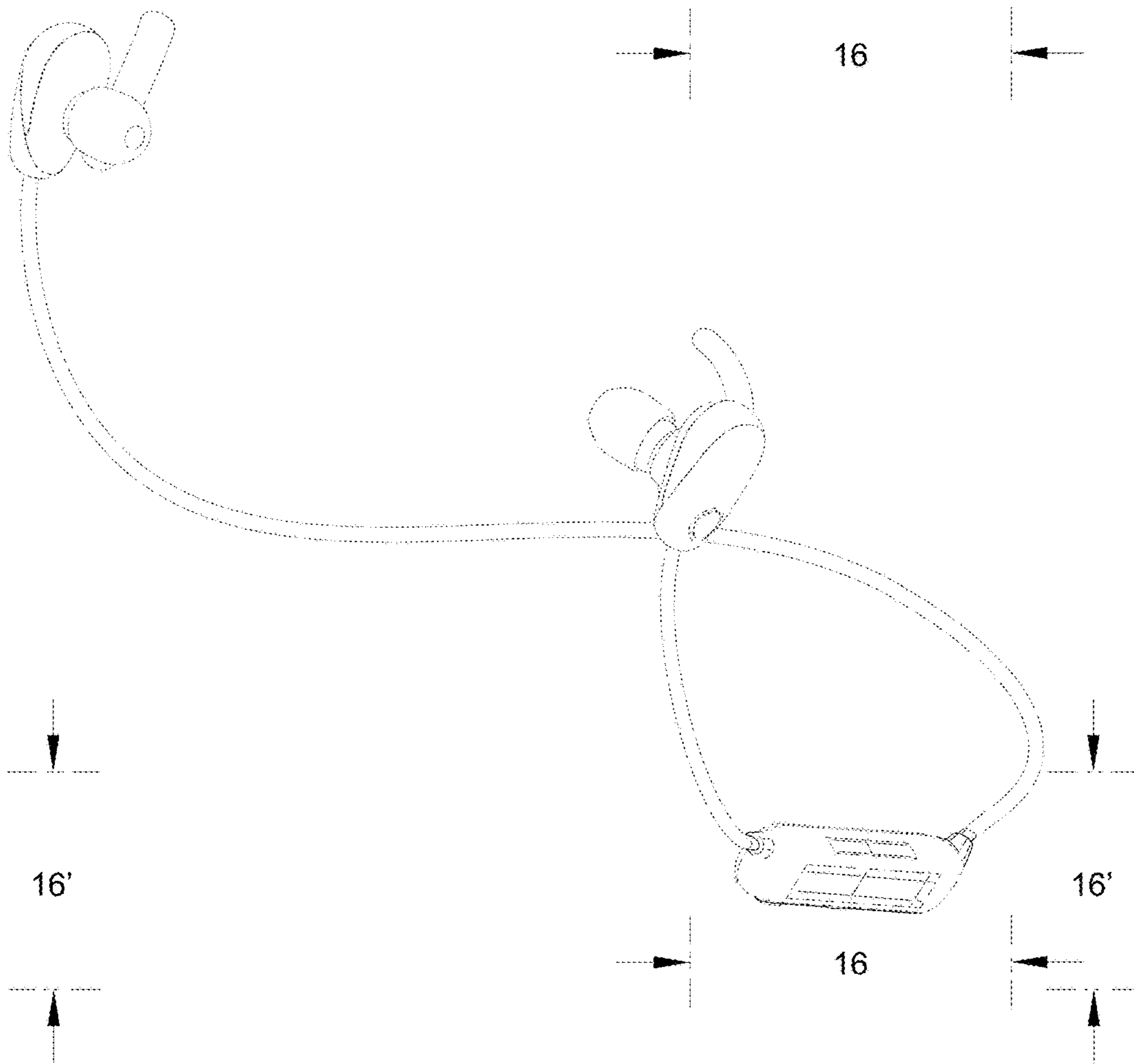

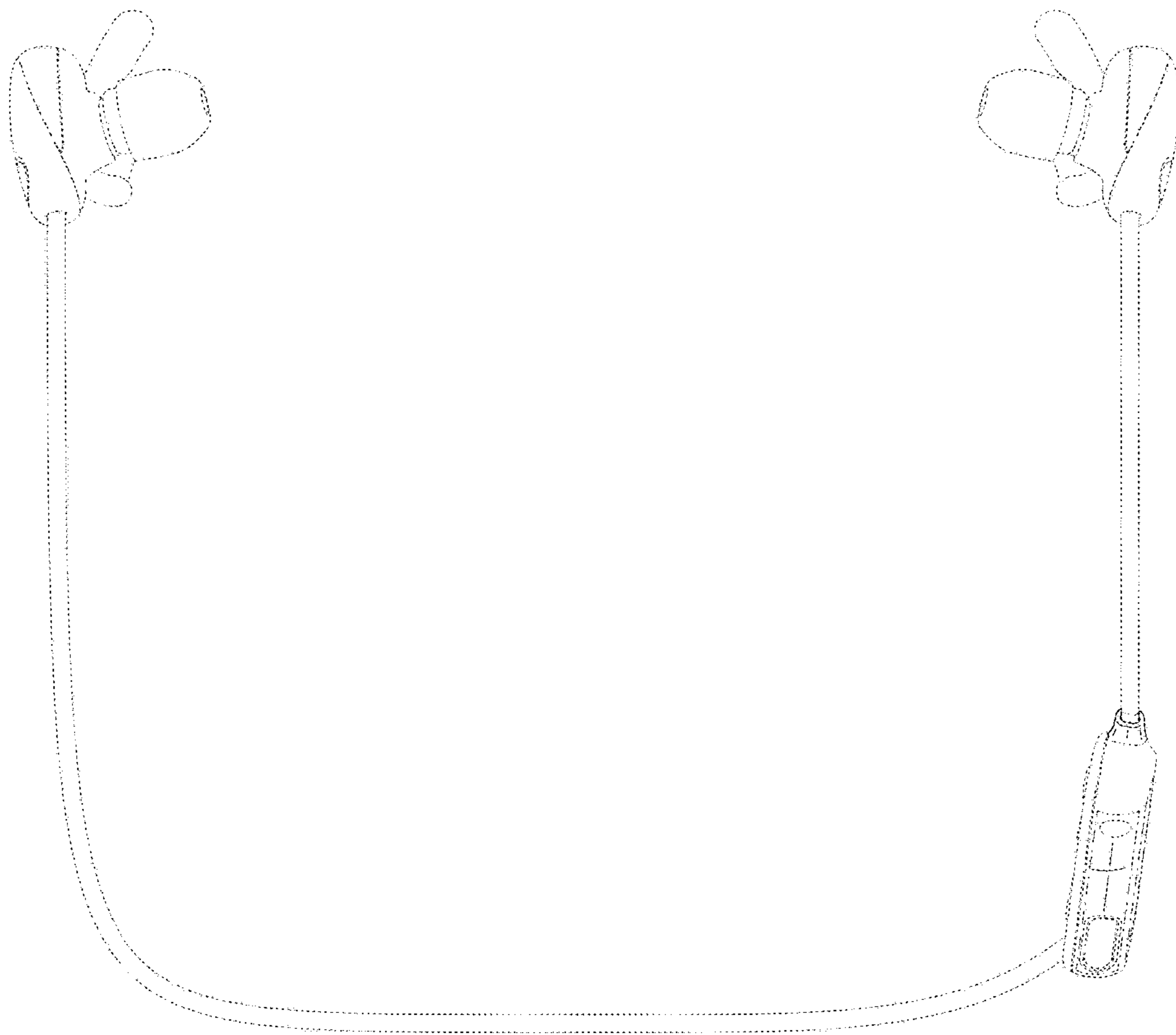

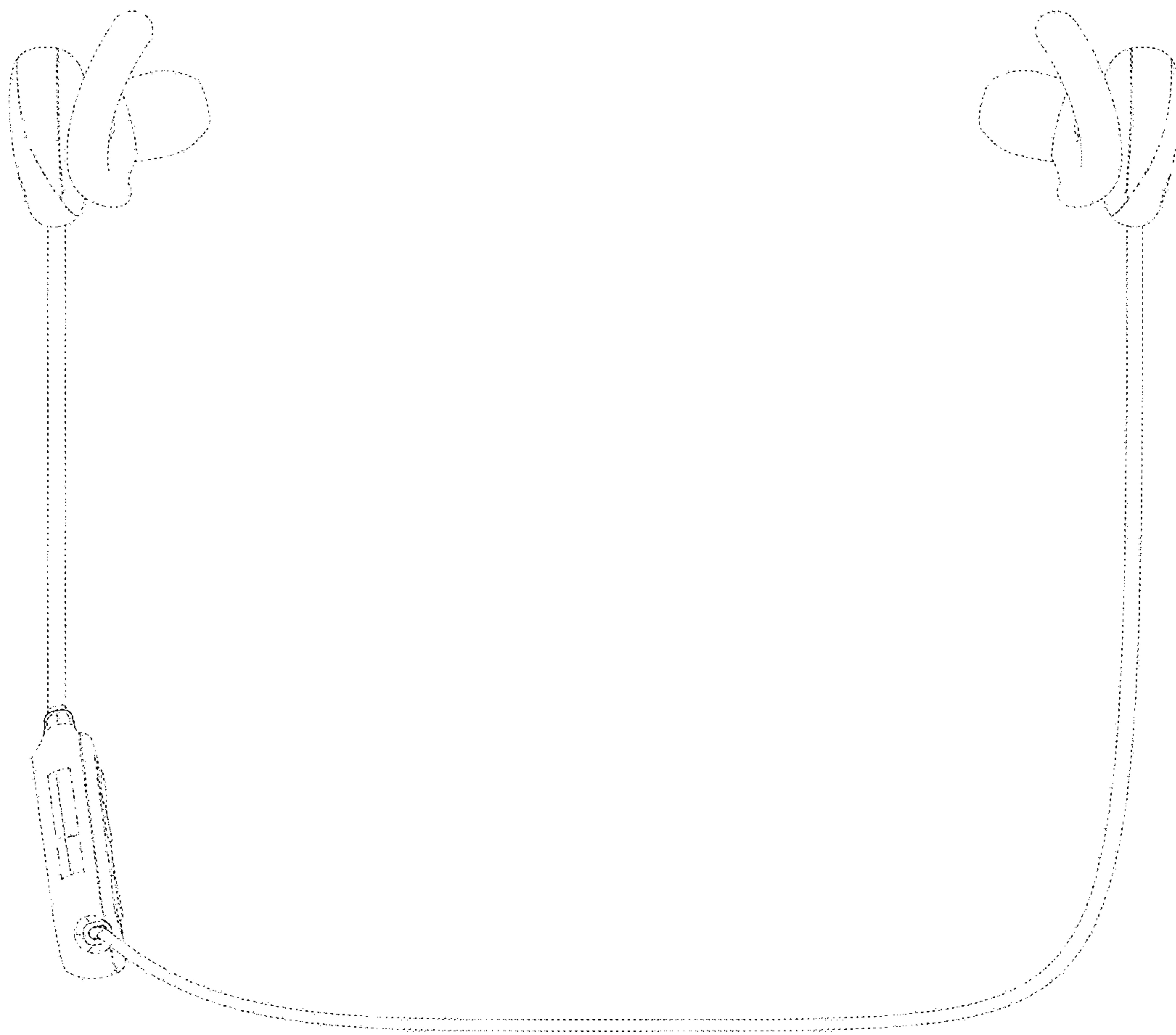

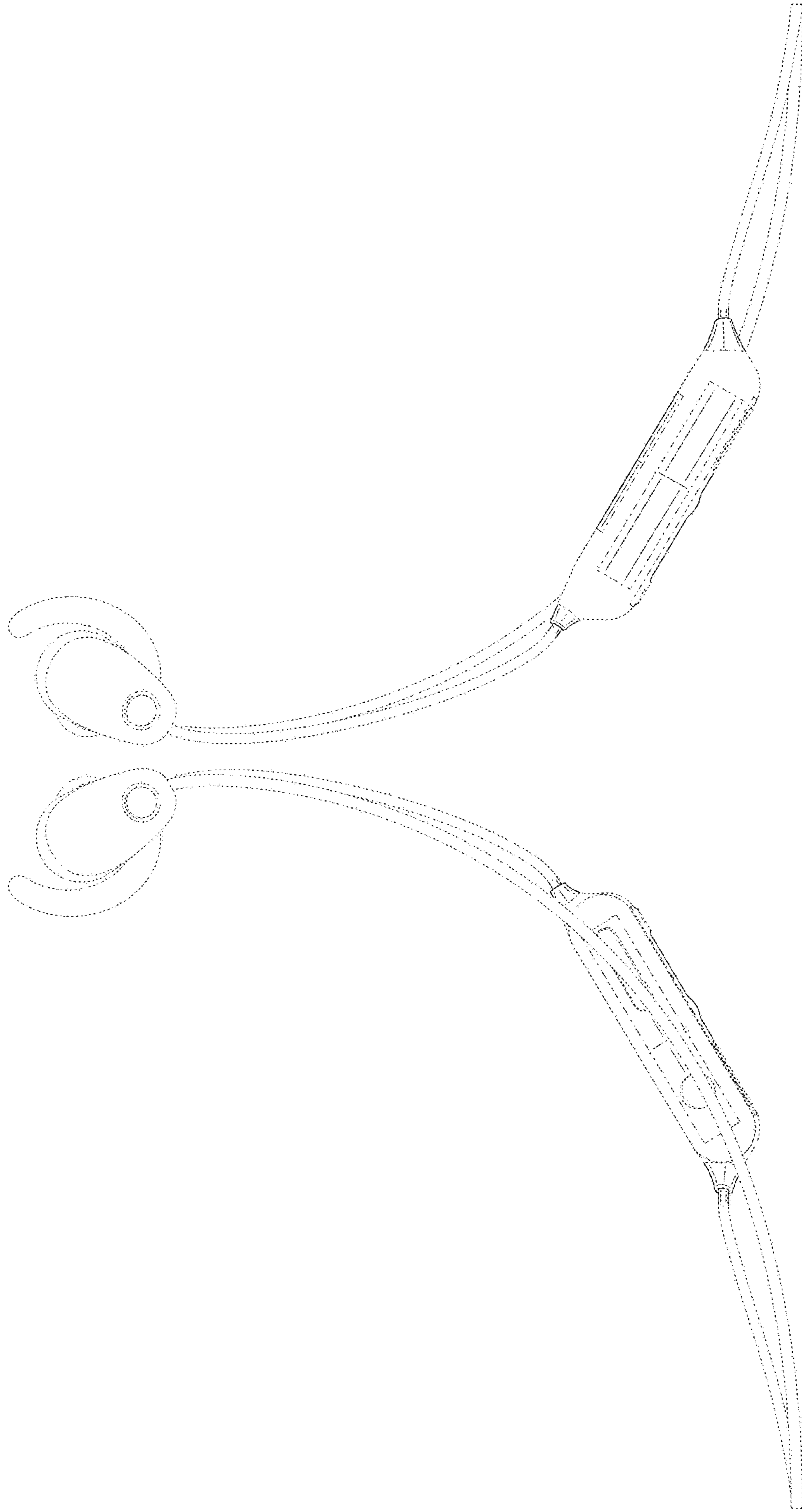

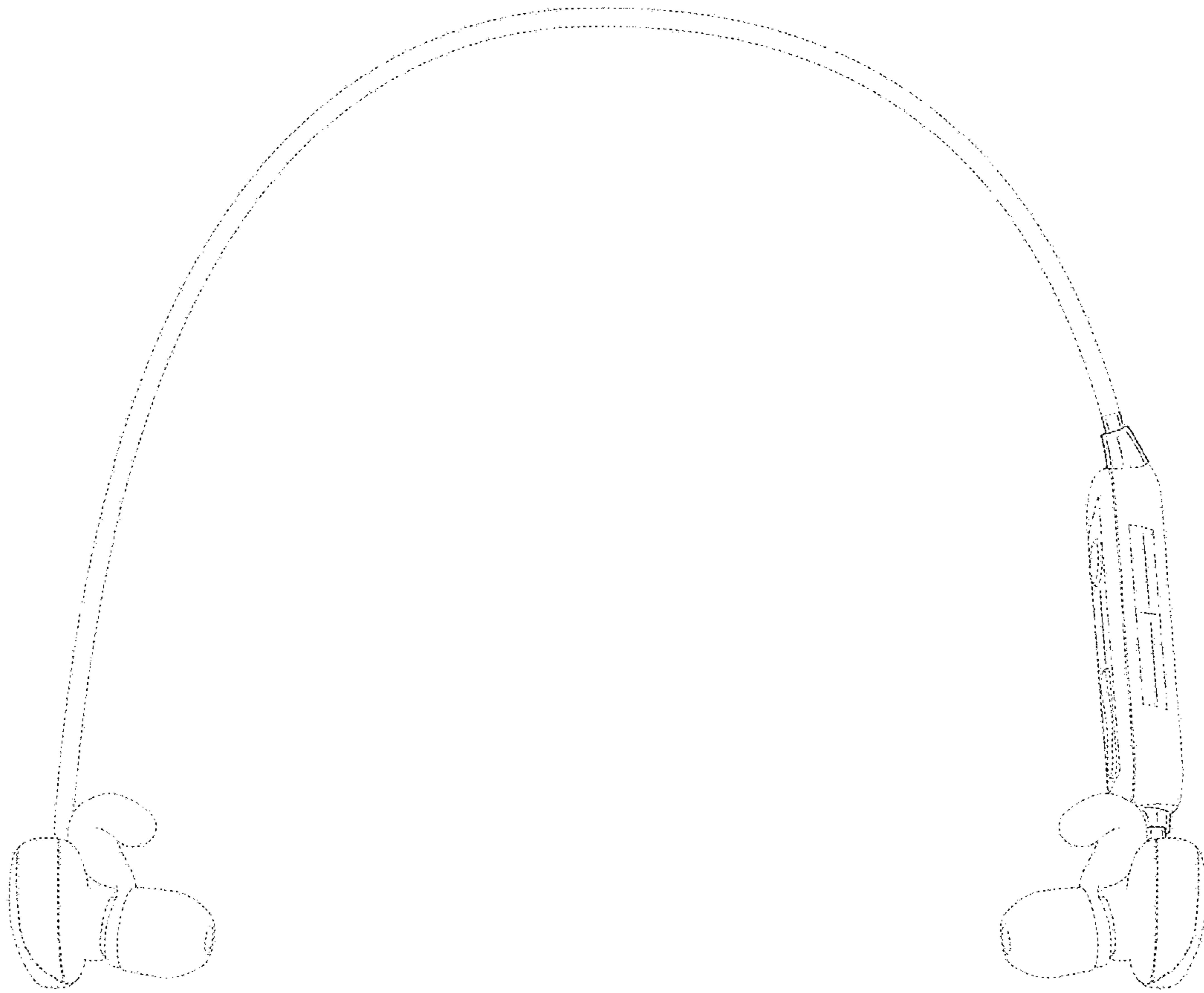

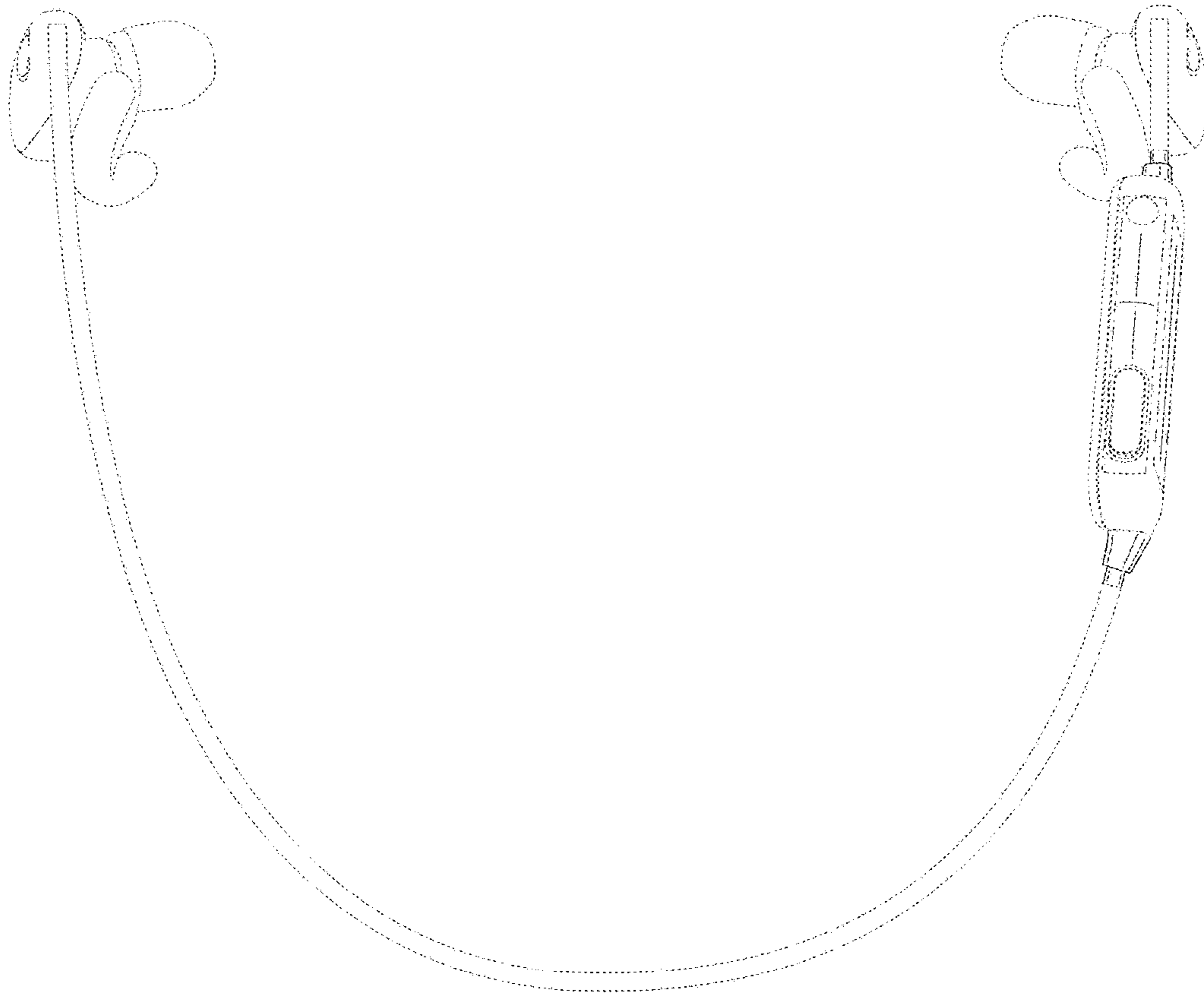
