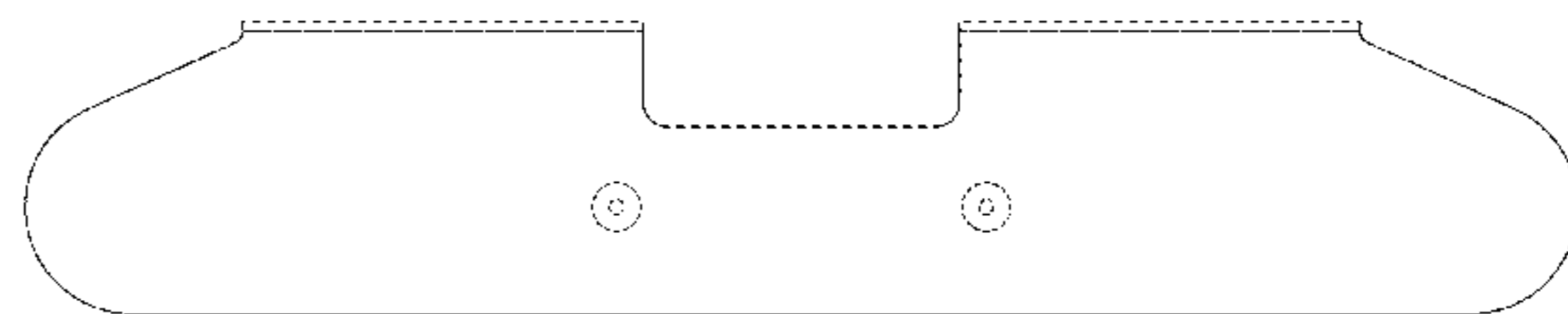
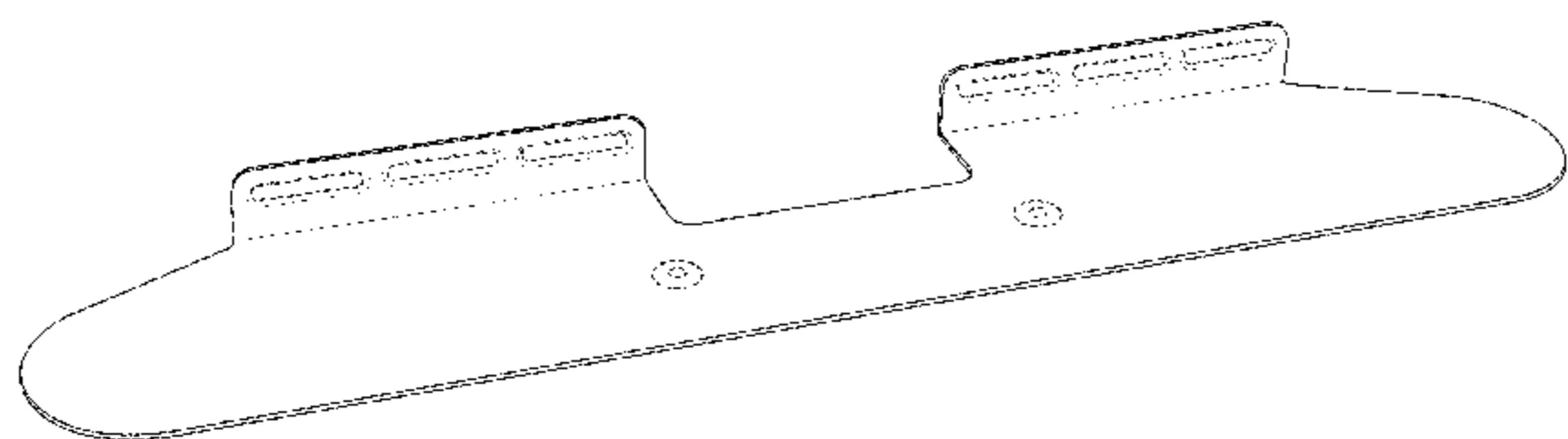
The ornamental design for a wall mount for an audio device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a wall mount for an audio device, showing the new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a front elevation view thereof;
FIG. 5 is a rear elevation view thereof;
FIG. 6 is a side view thereof; and,
FIG. 7 is another side view thereof.

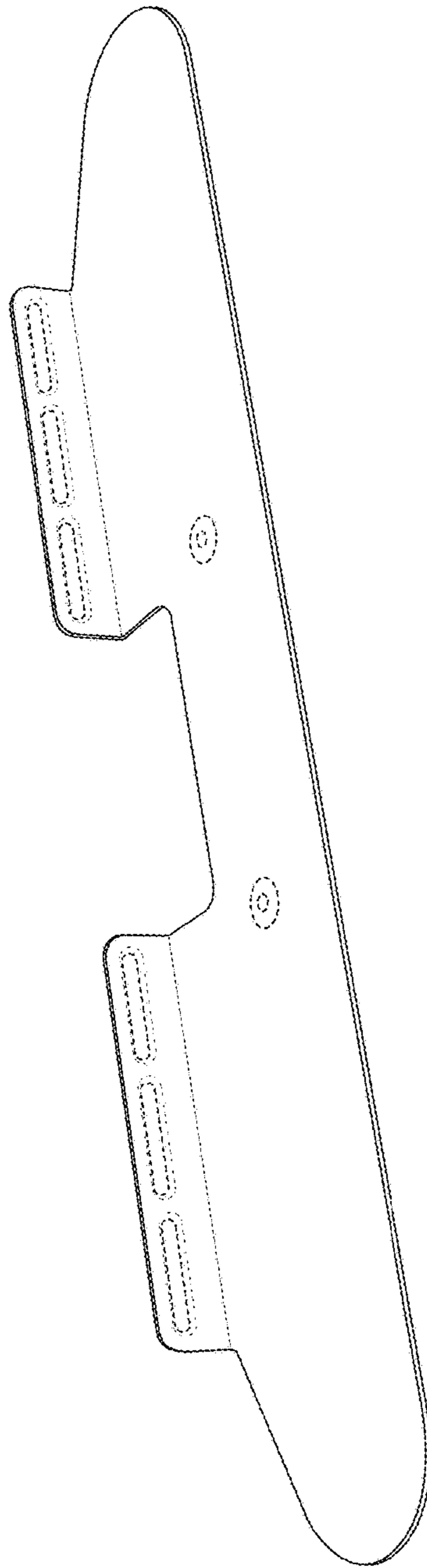

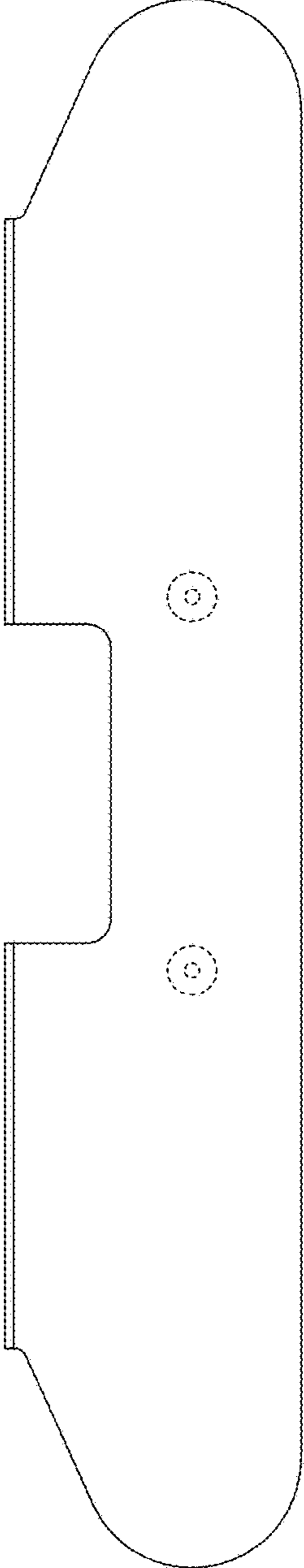

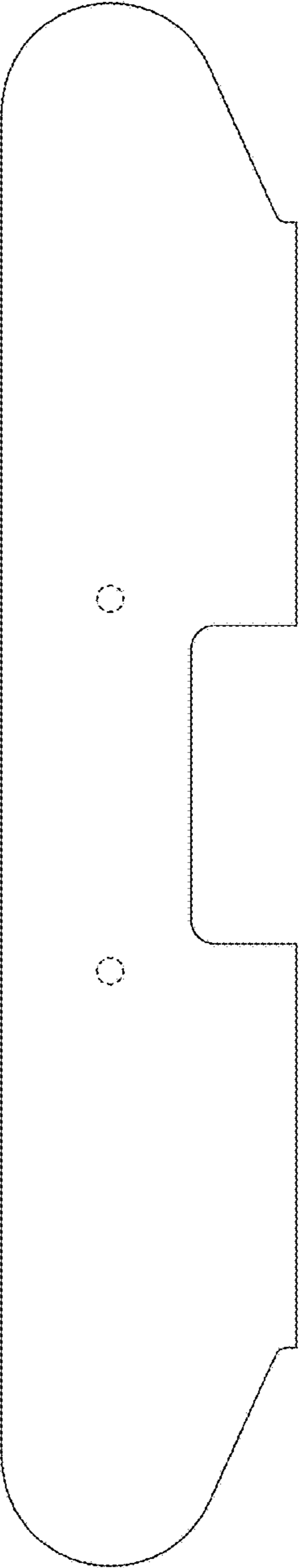

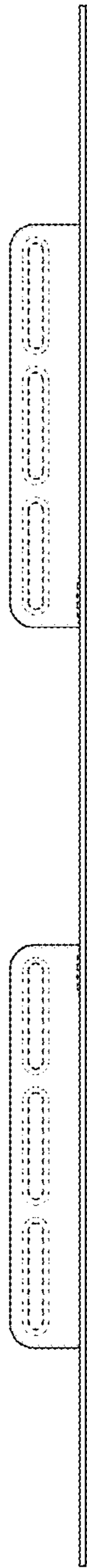

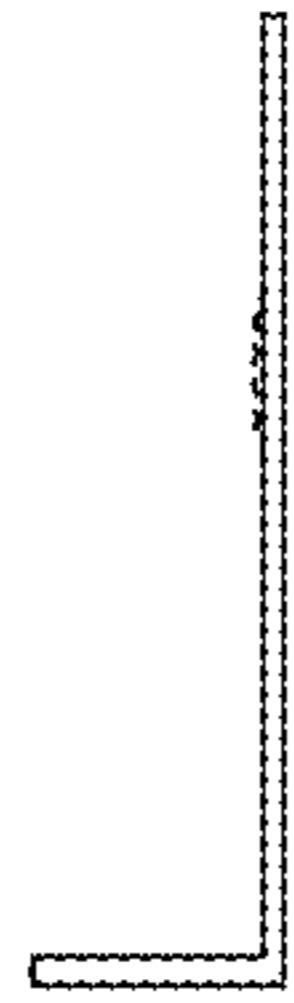
