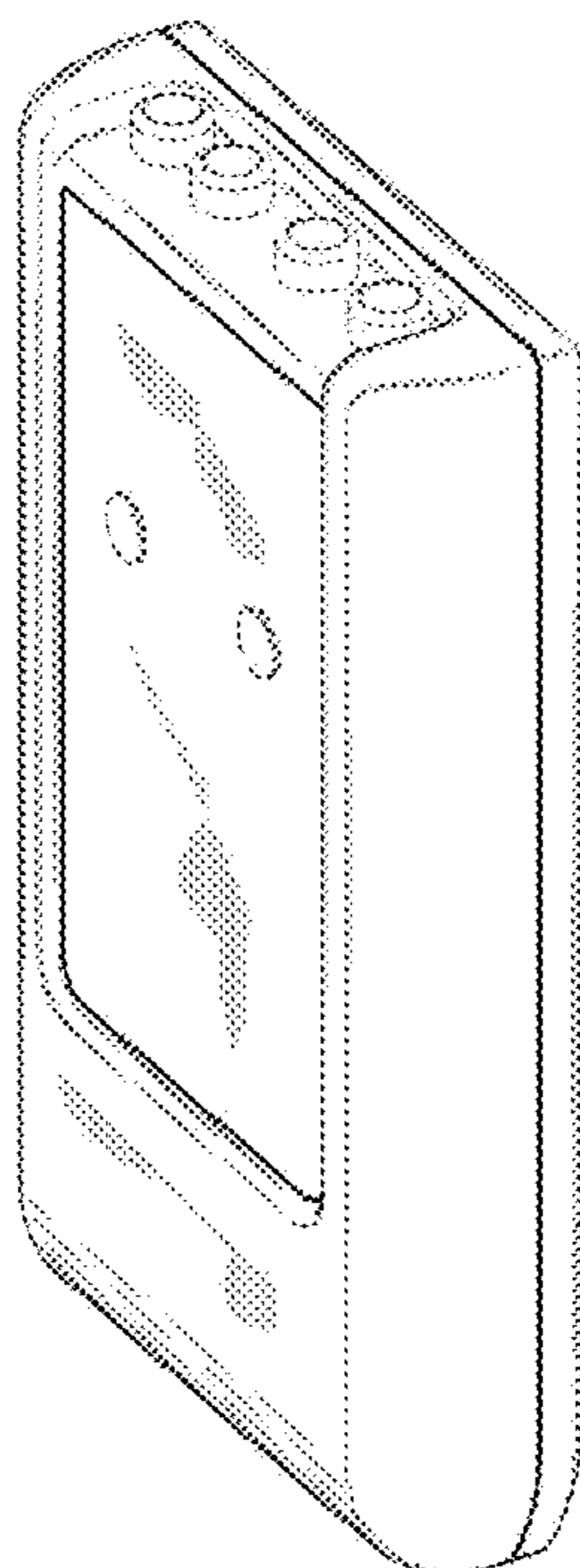

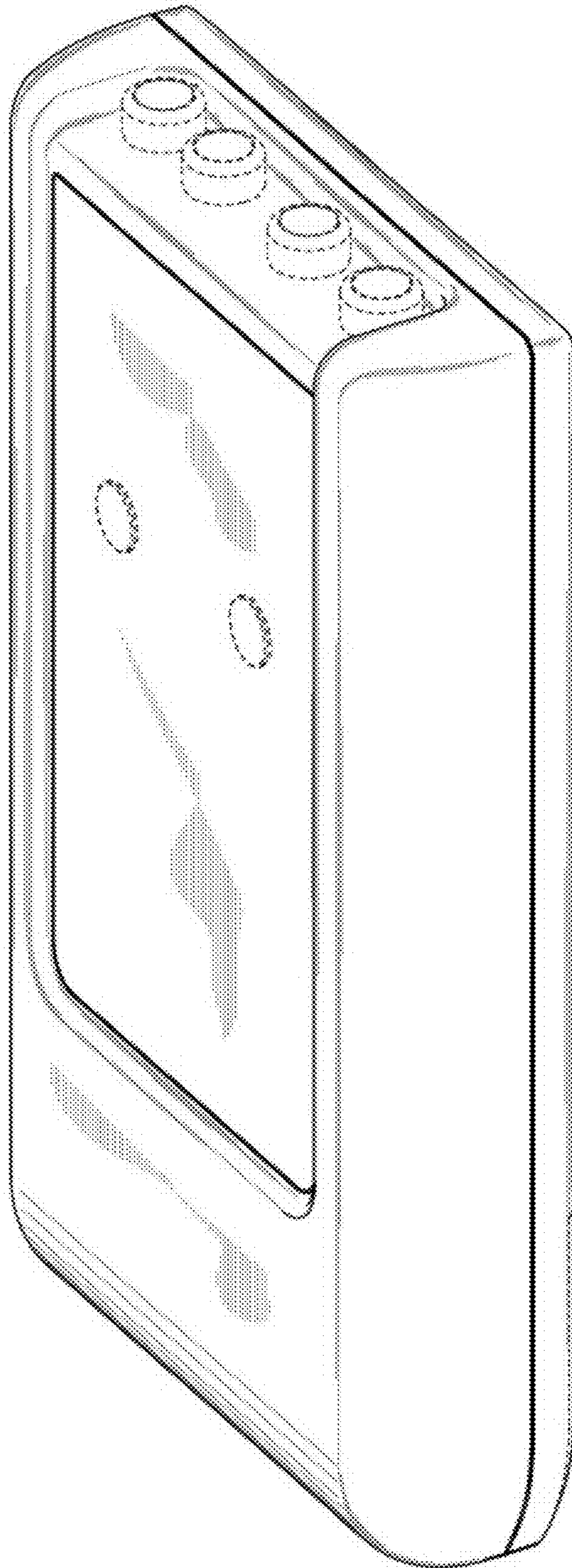

The broken lines shown in the drawings illustrate portions of the modem that form no part of the claimed design.

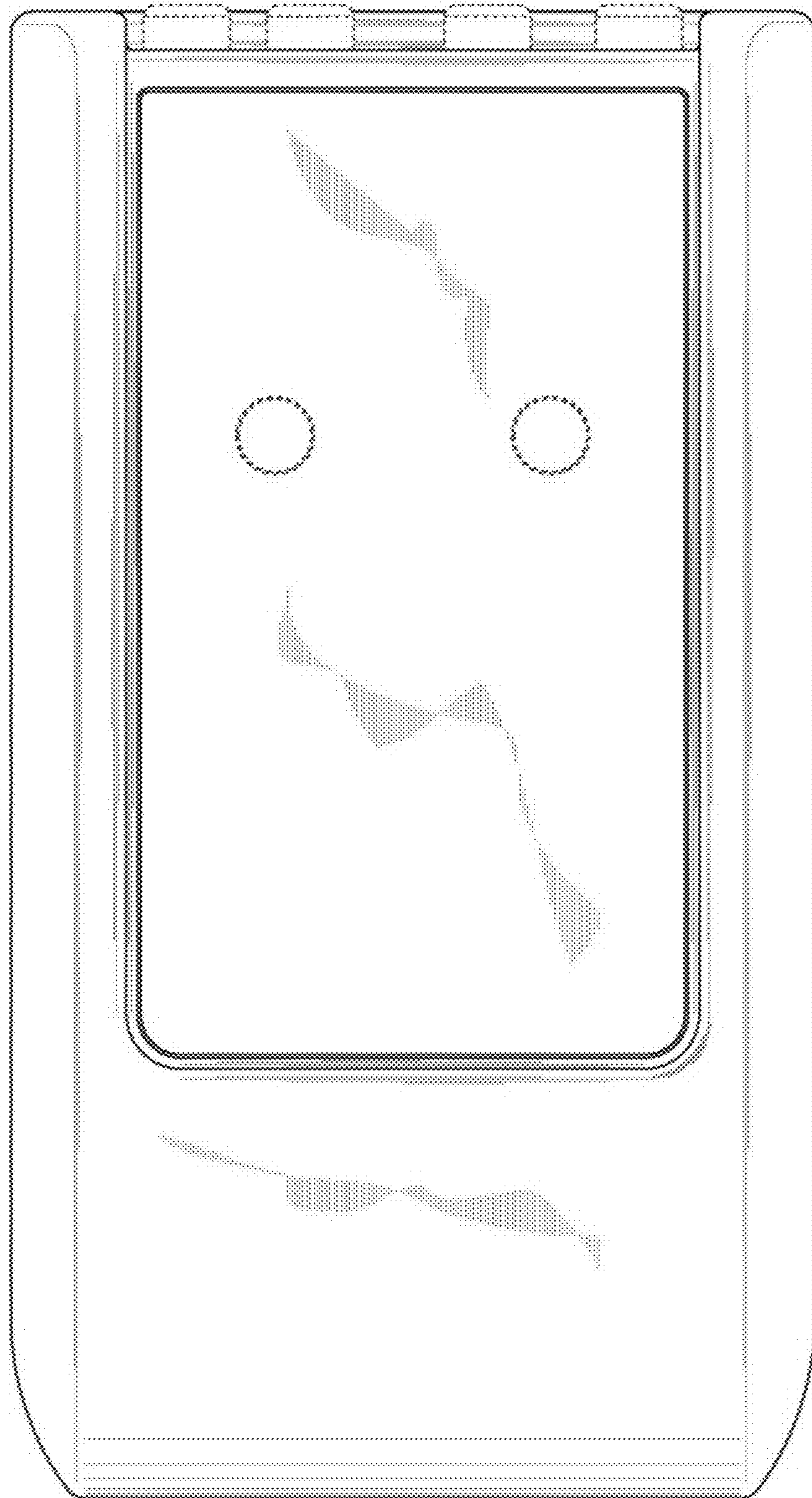

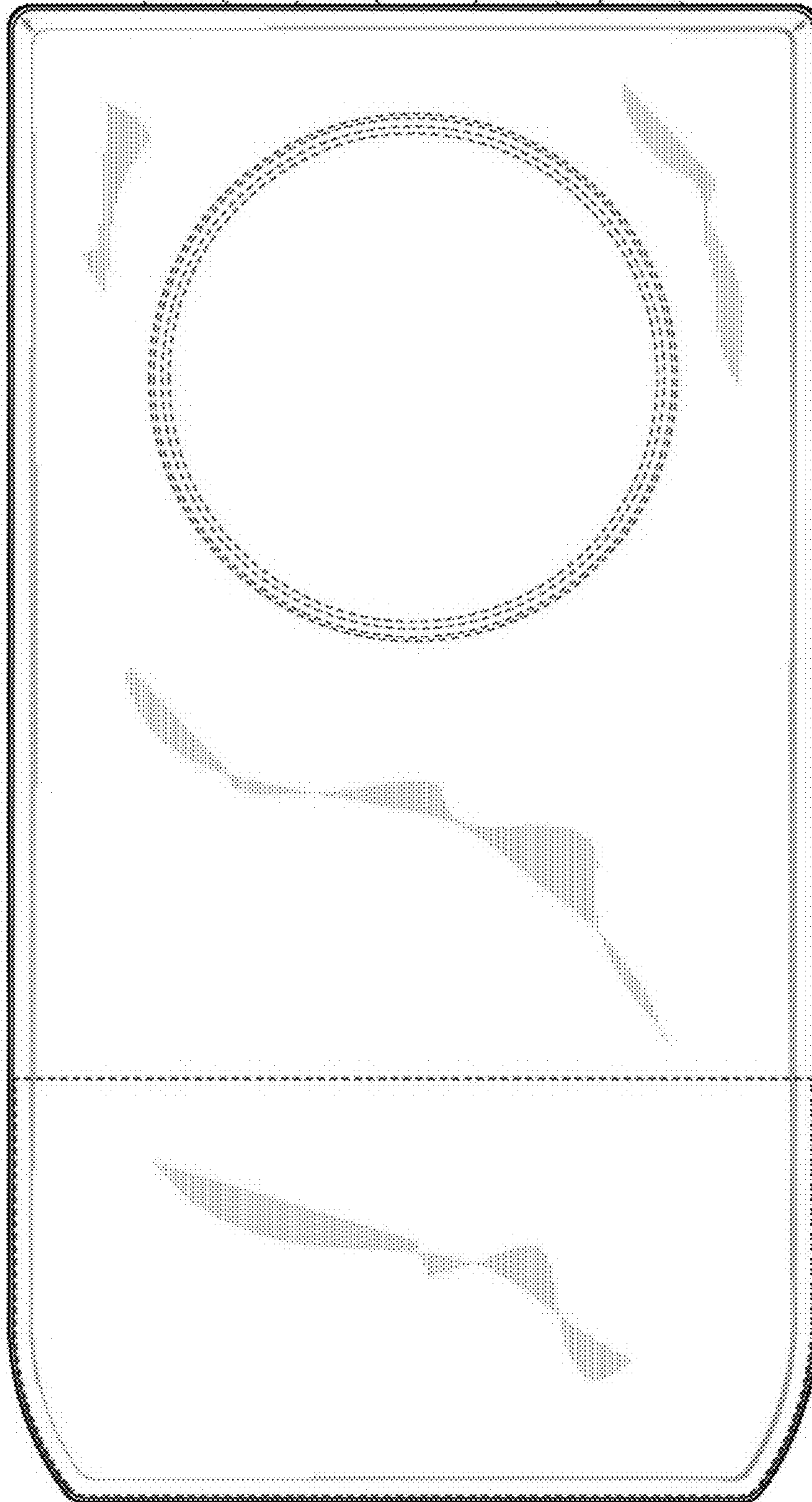

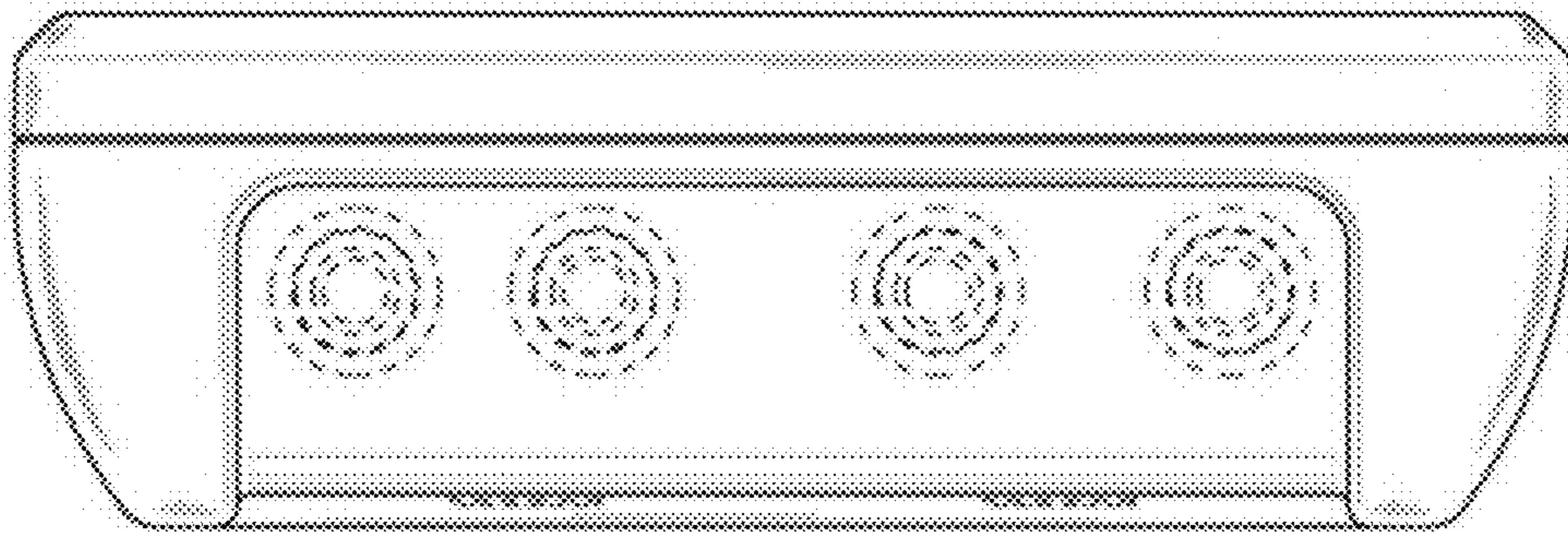

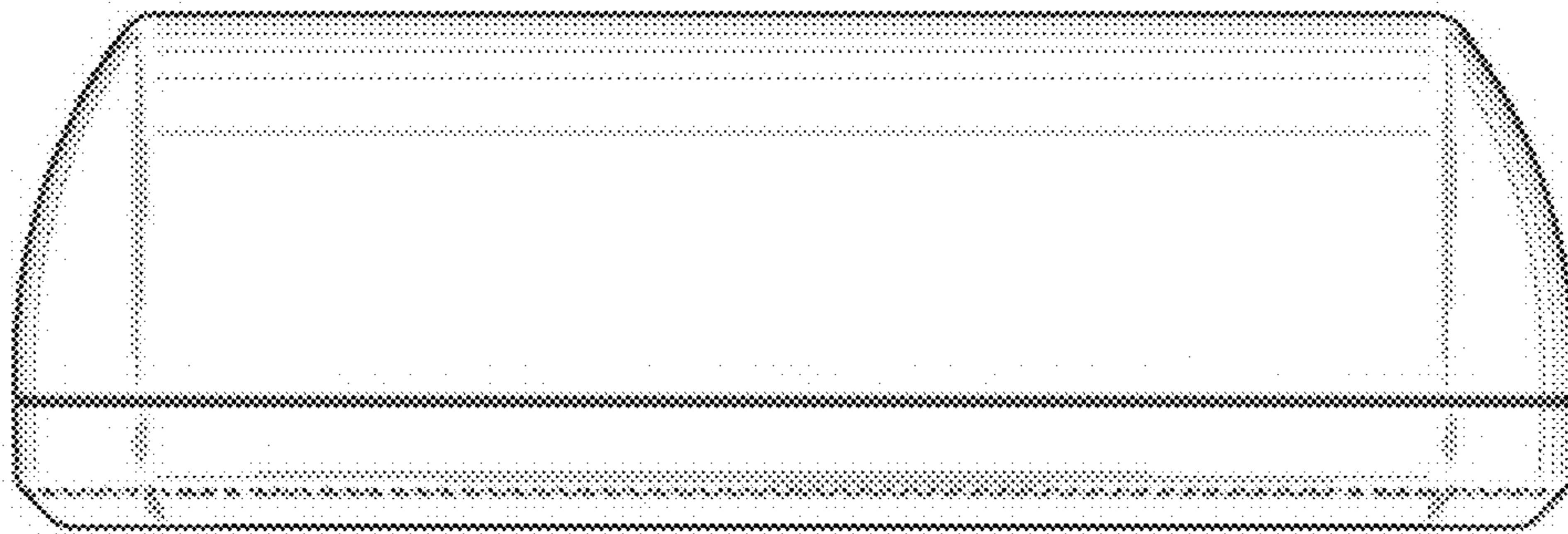

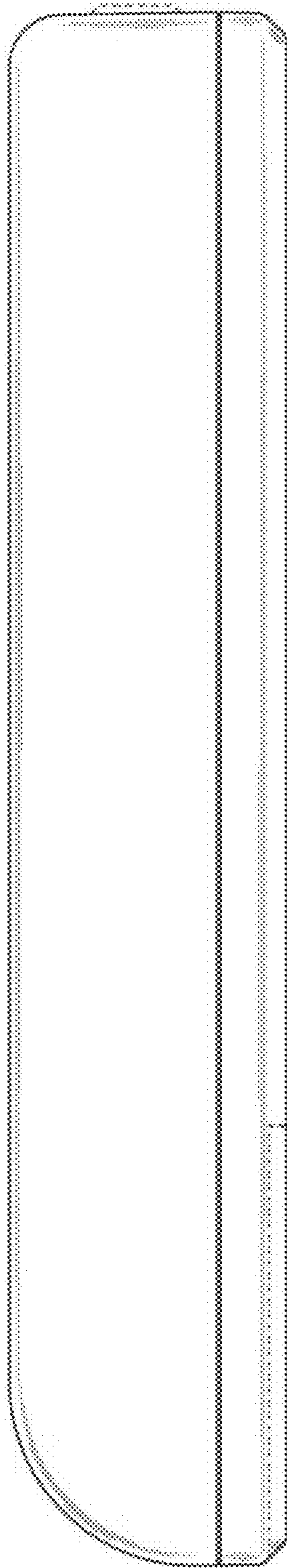
