(57) **CLAIM**

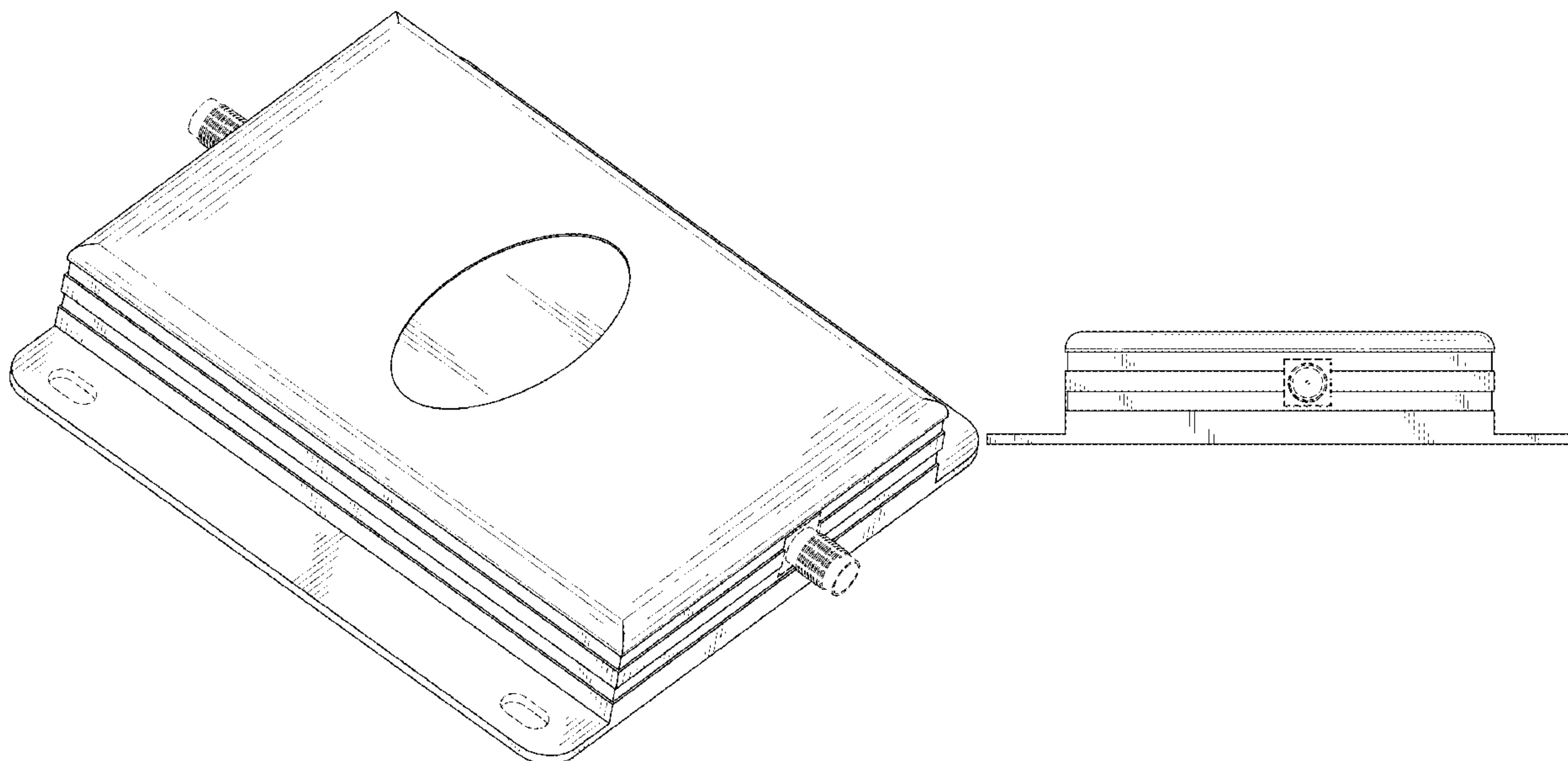
The ornamental design for a signal amplifier for mobile phone, as shown and described.

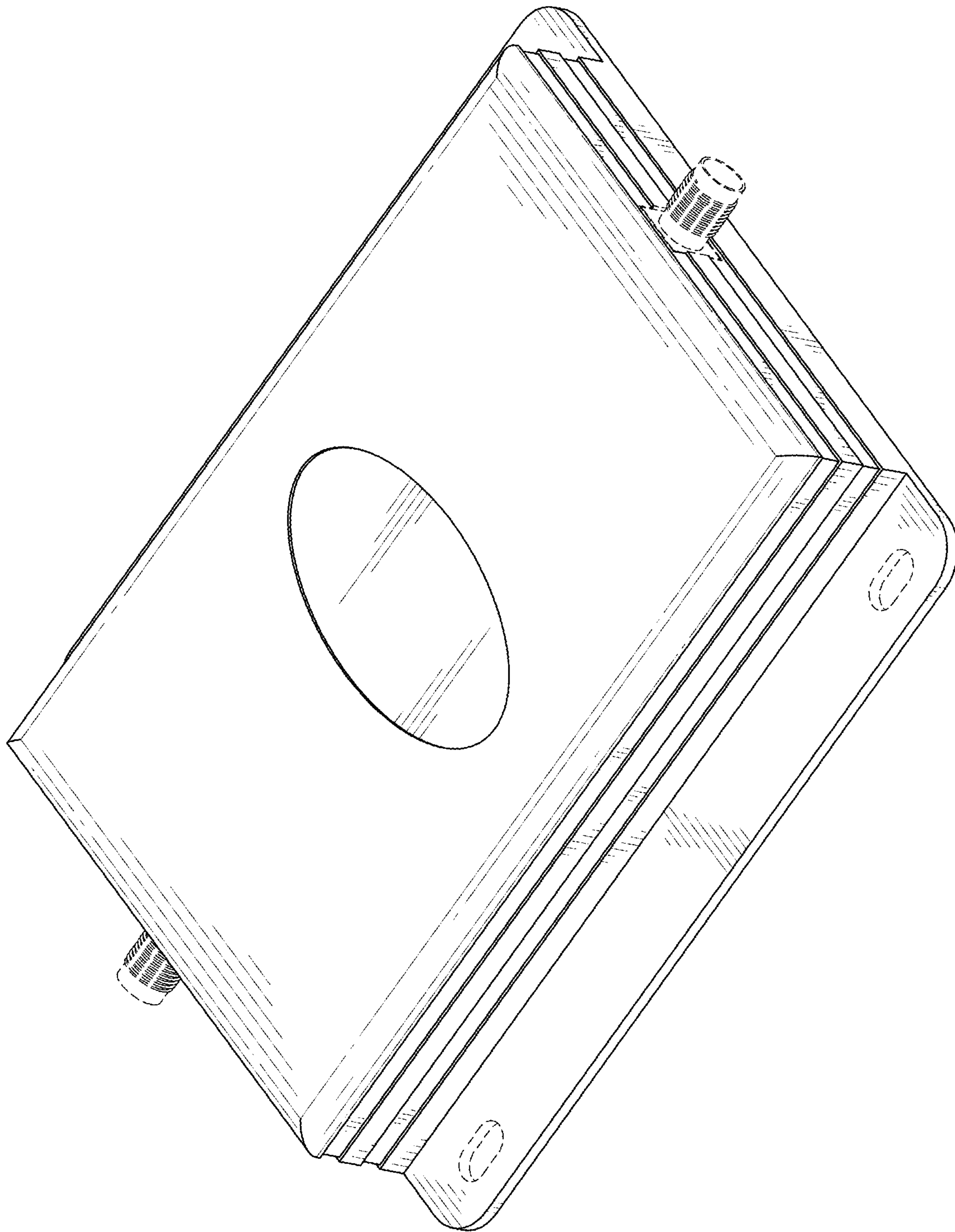

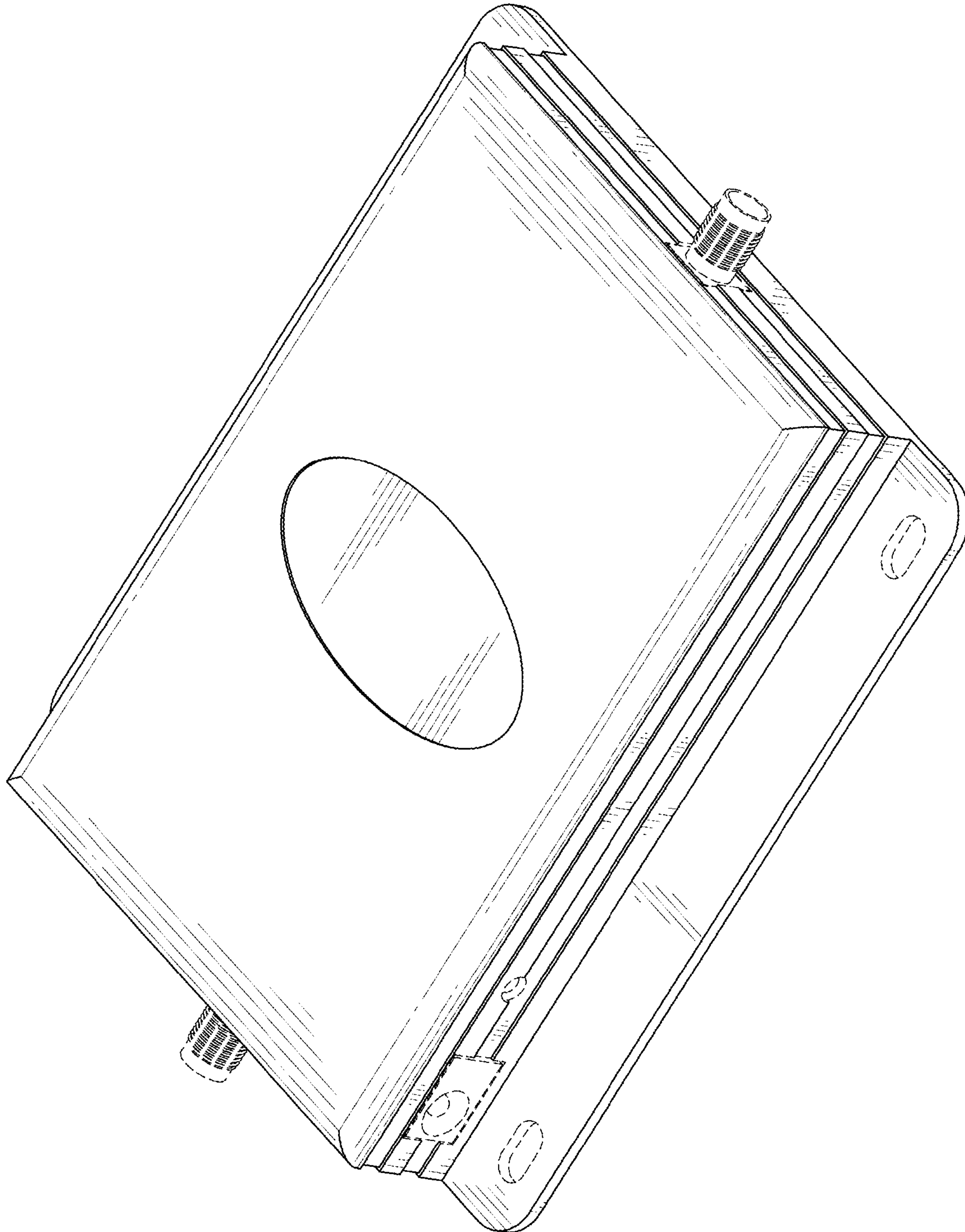

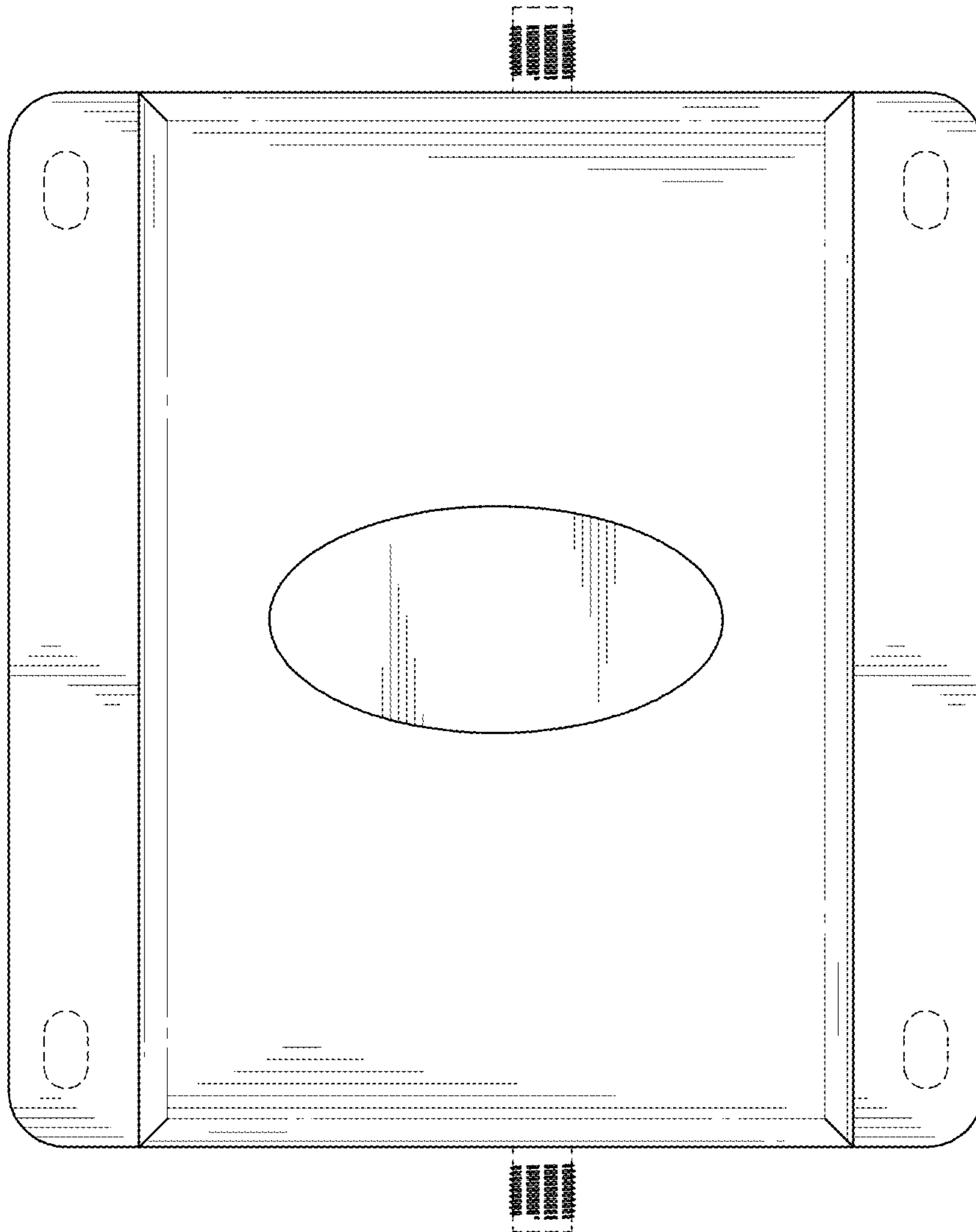

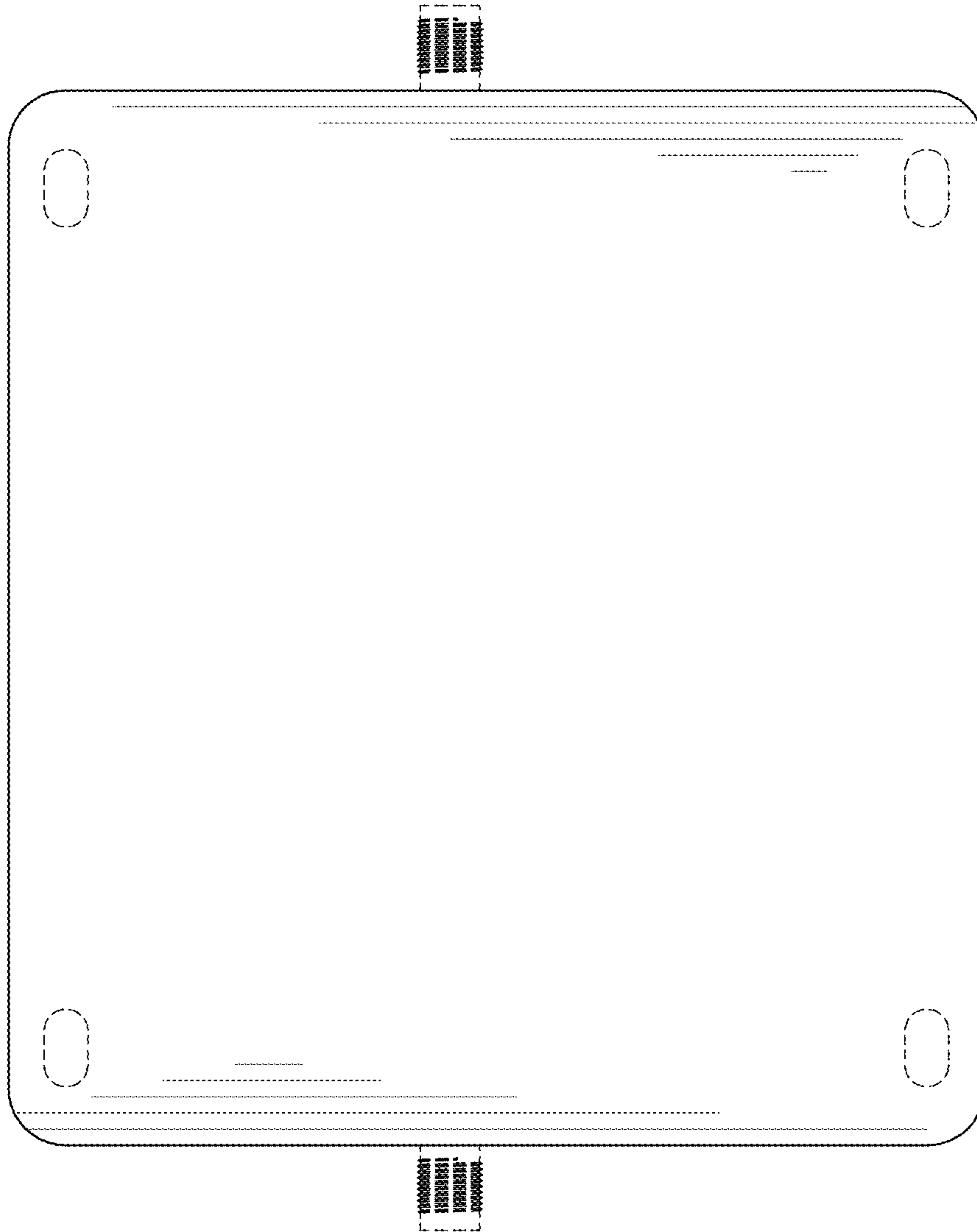

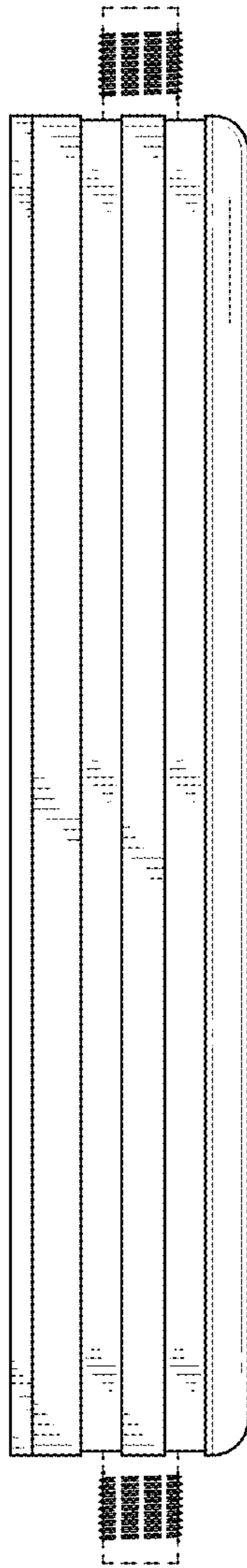

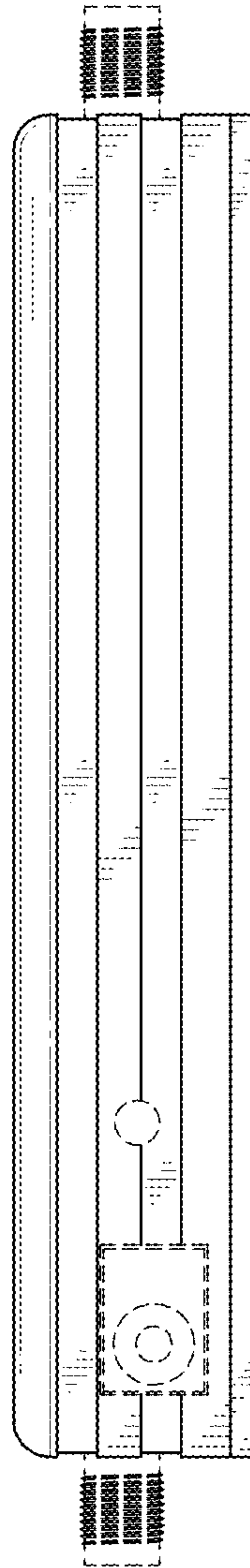

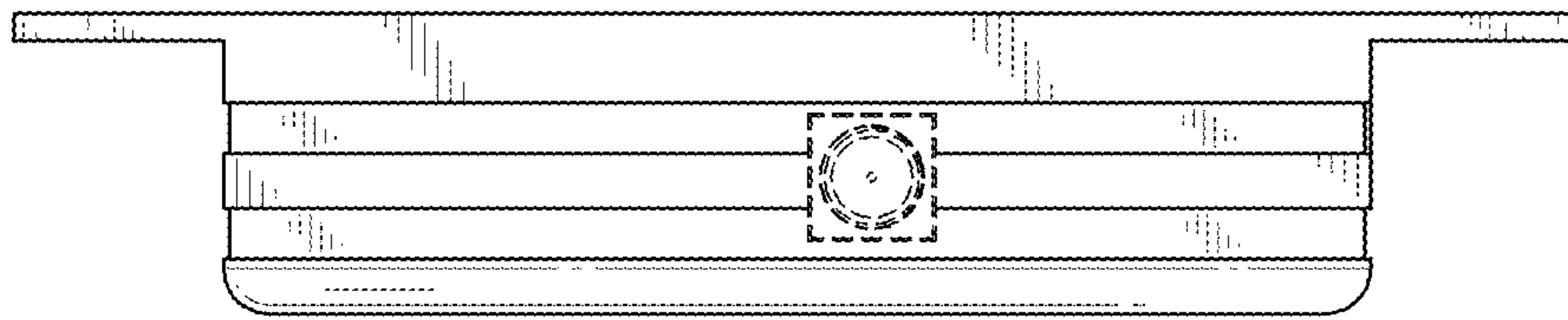

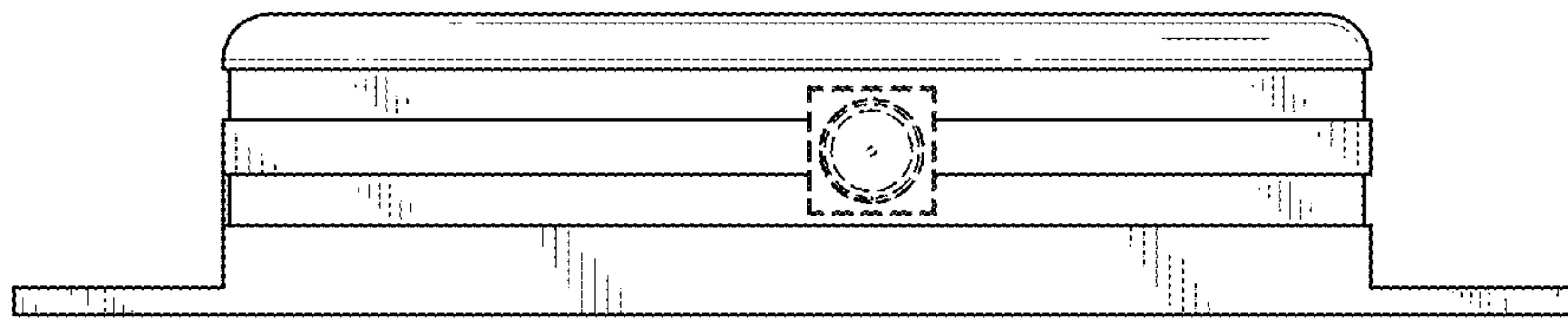
