The dot-dash broken lines in the figures represent an unclaimed boundary line and form no part of the claimed design.

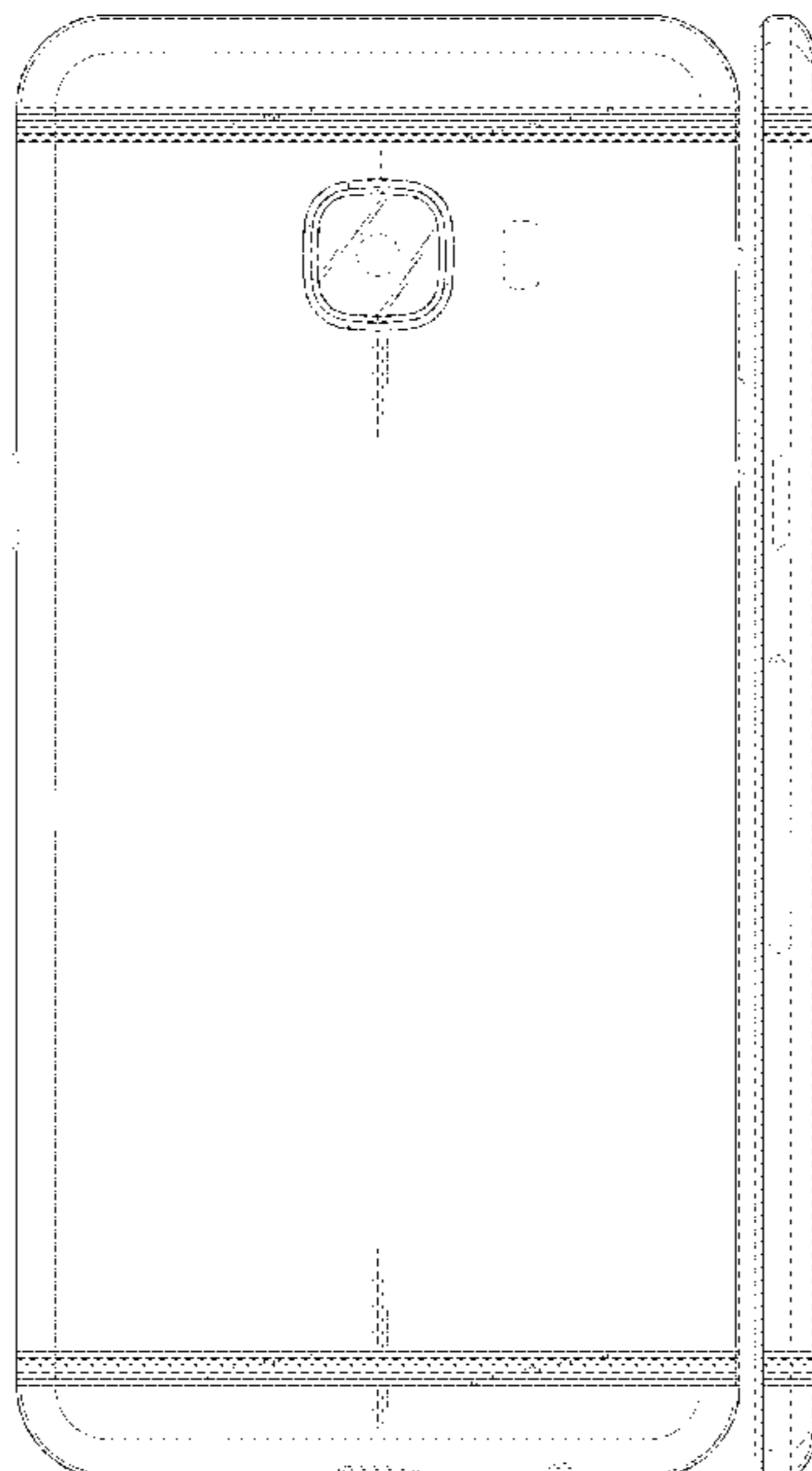

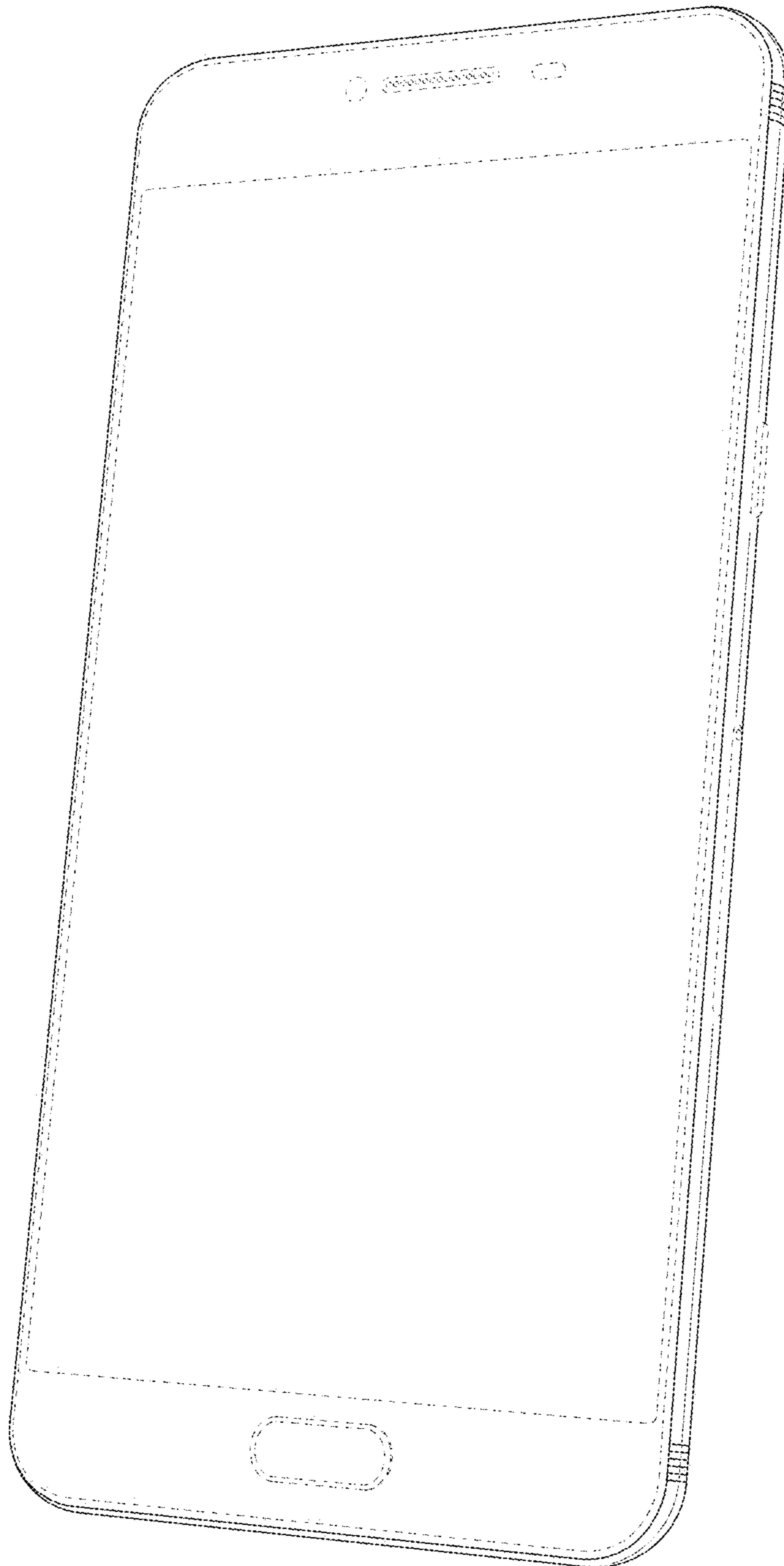

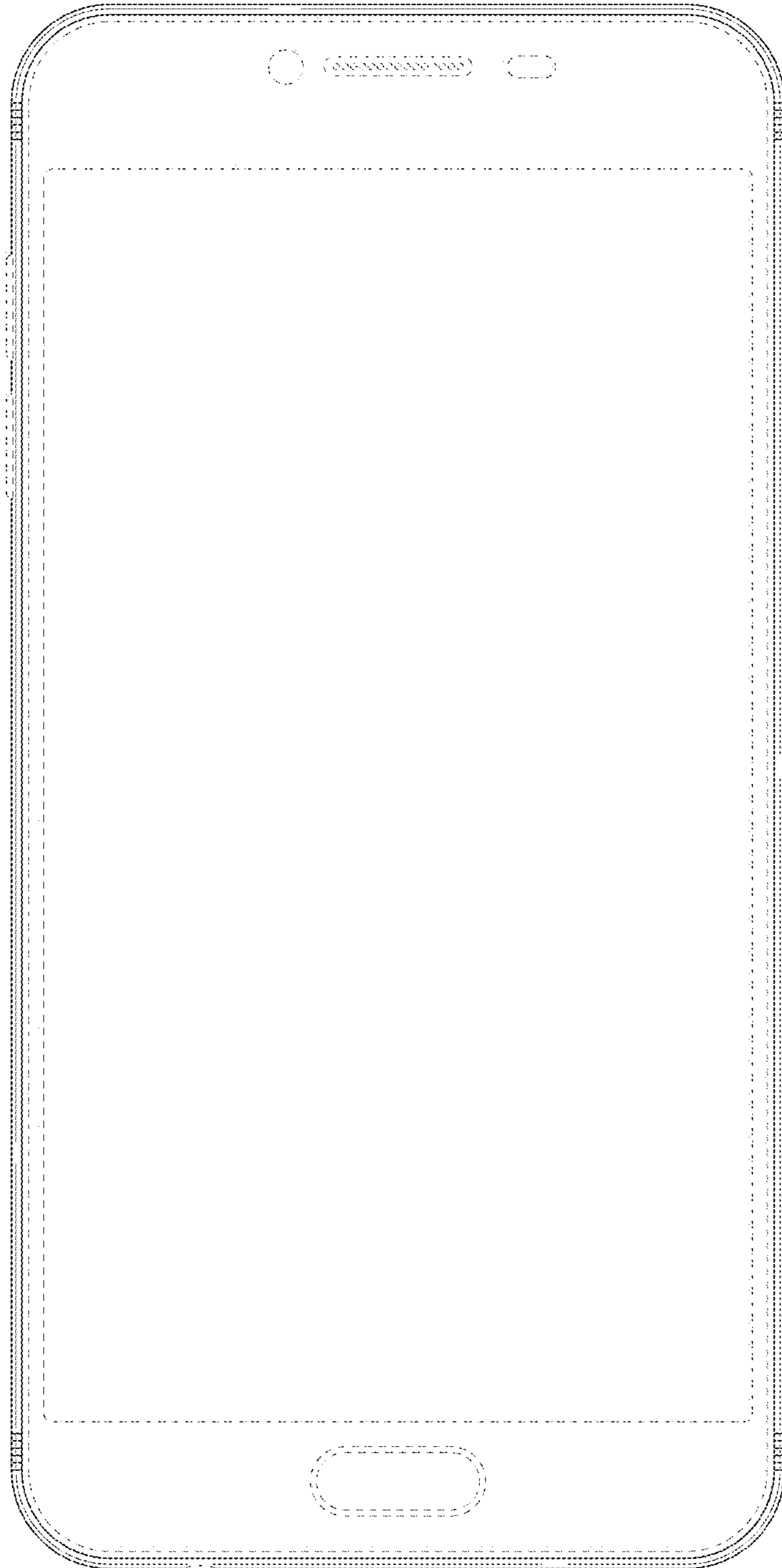

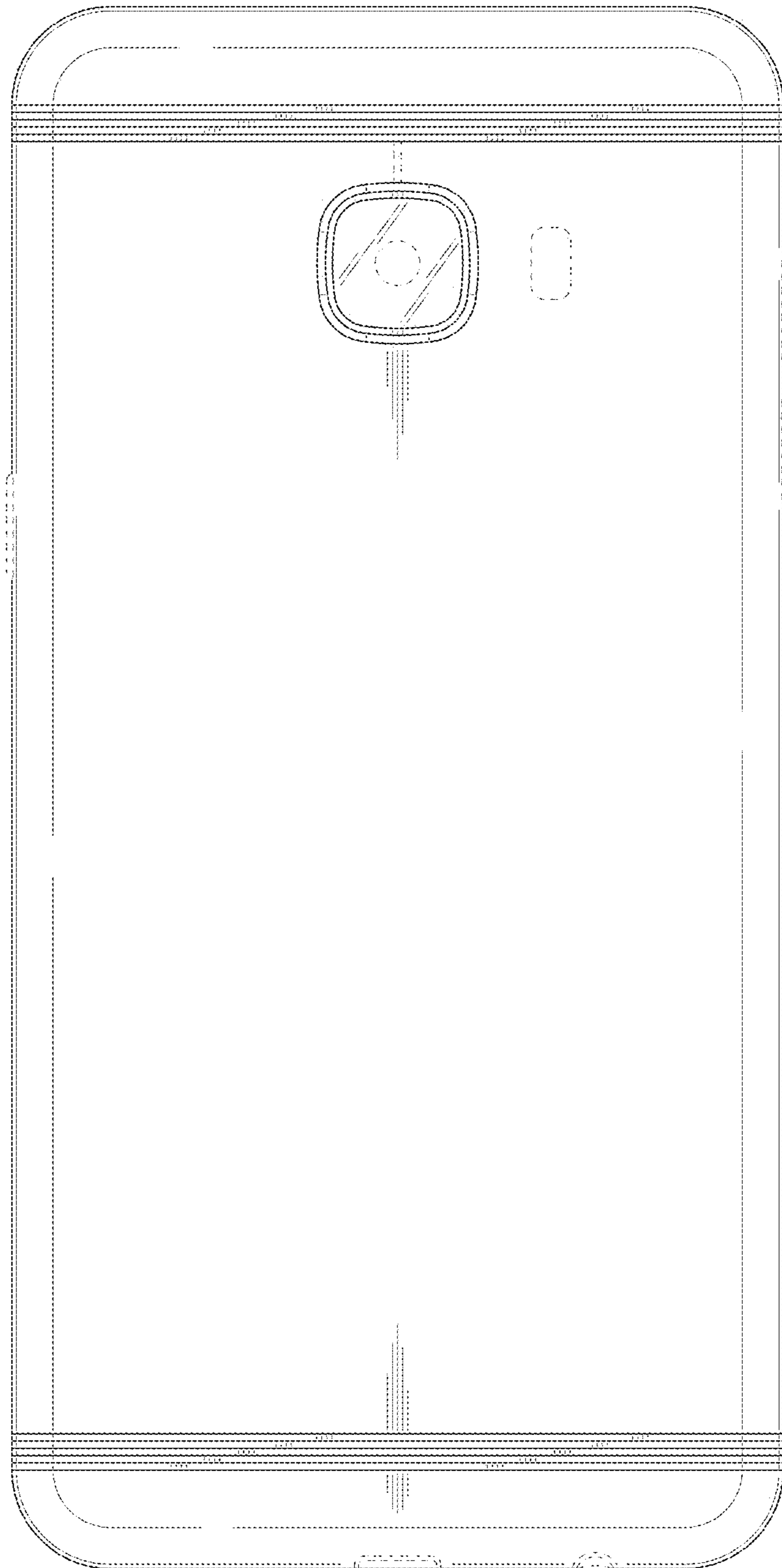

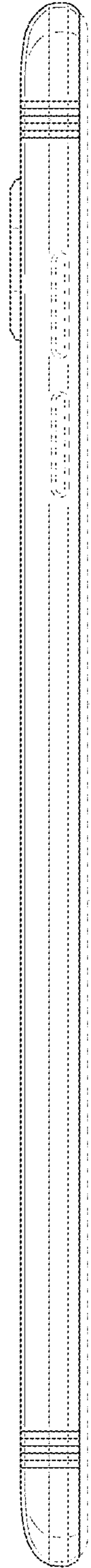

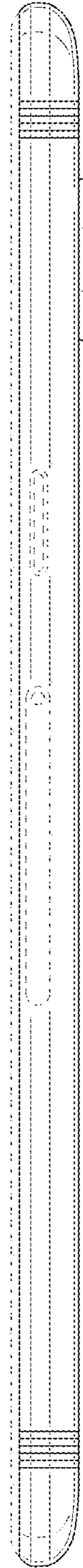

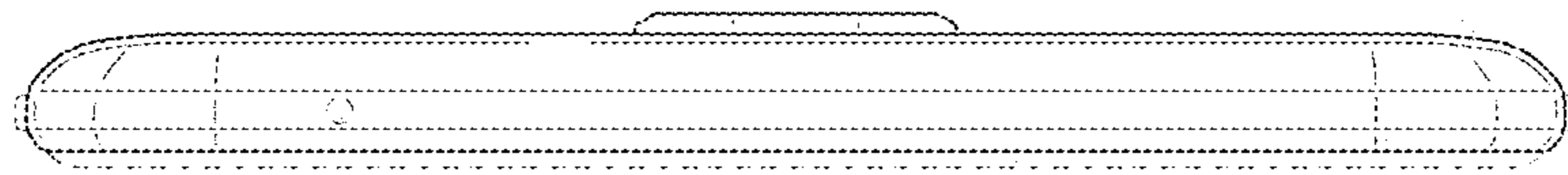

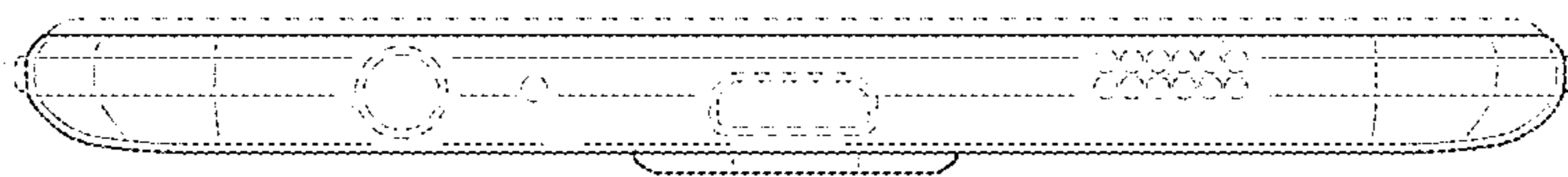
