(57) **CLAIM**

The ornamental design for an accessory for head-mounted display, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of front, top and left side of an accessory for head-mounted display showing our new design;

FIG. 8 is a bottom view thereof;

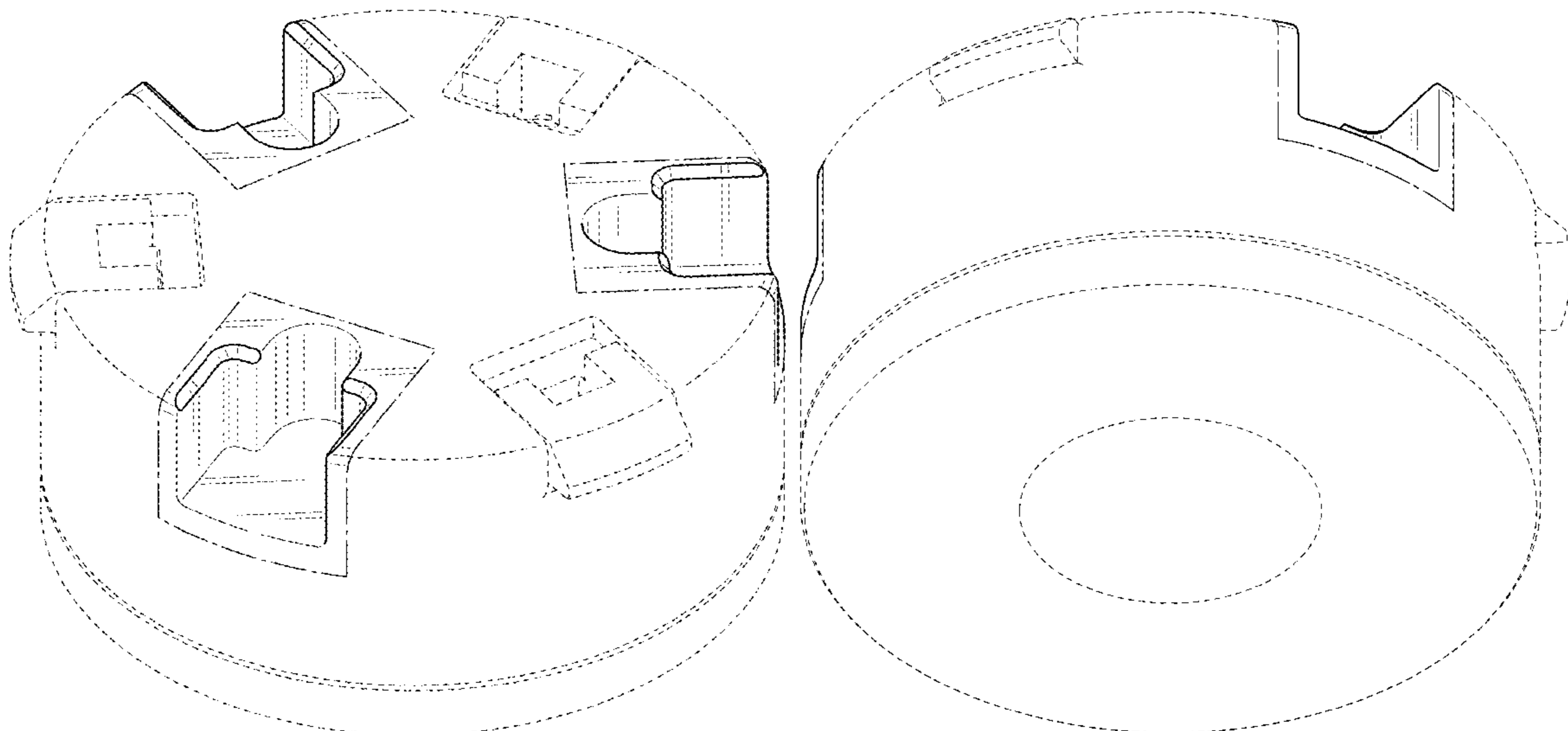
FIG. 9 is a reference view of usage thereof;

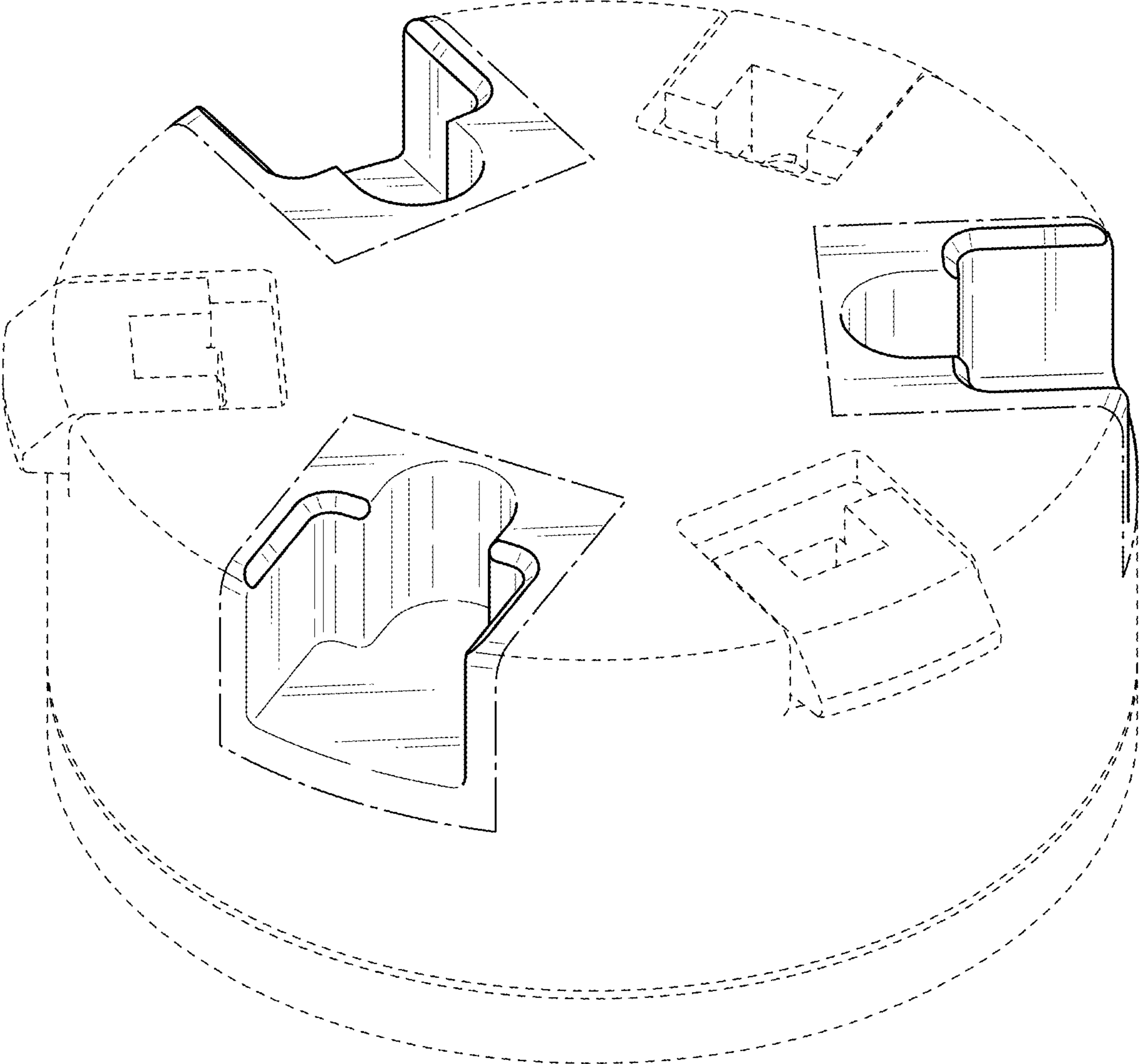

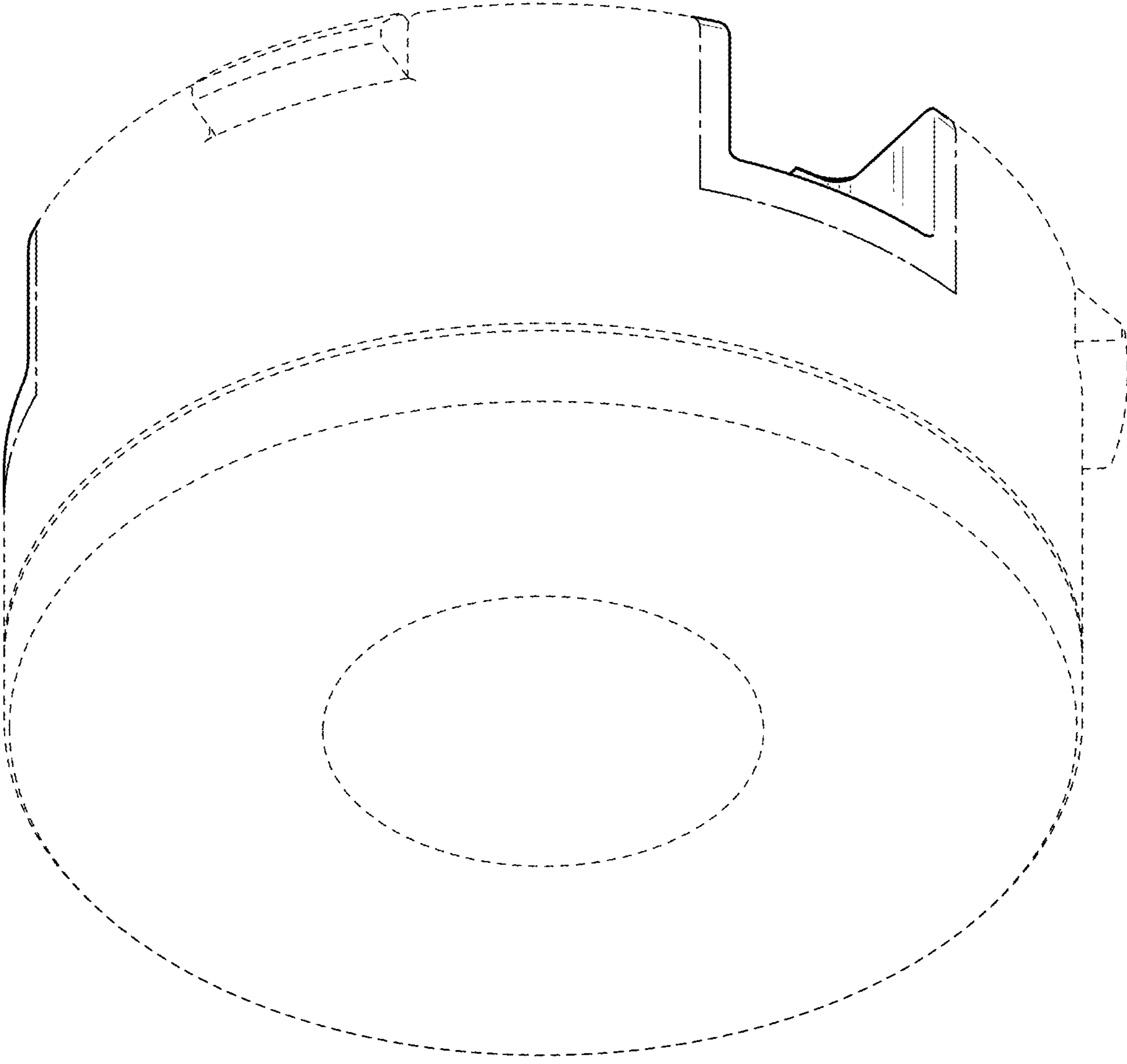

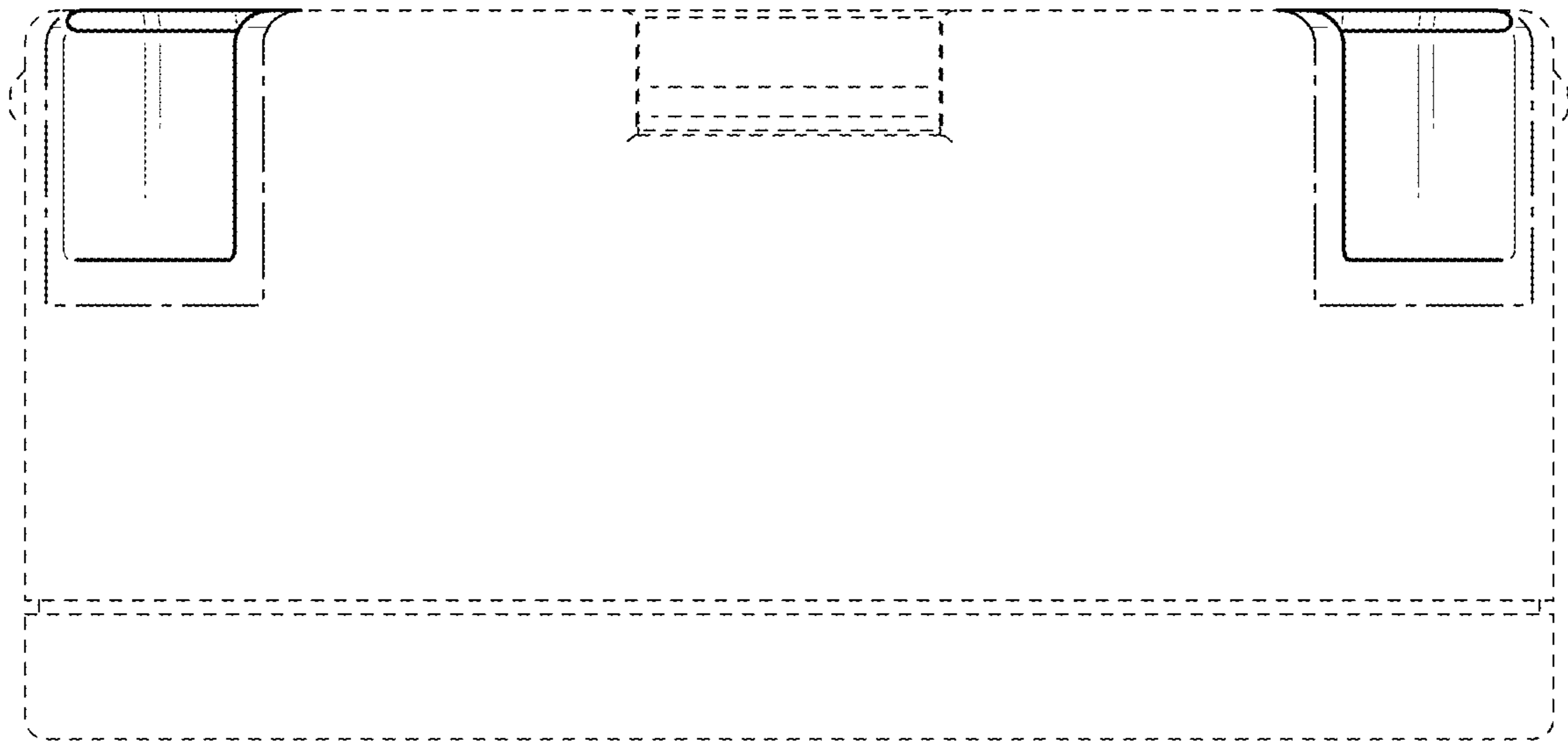

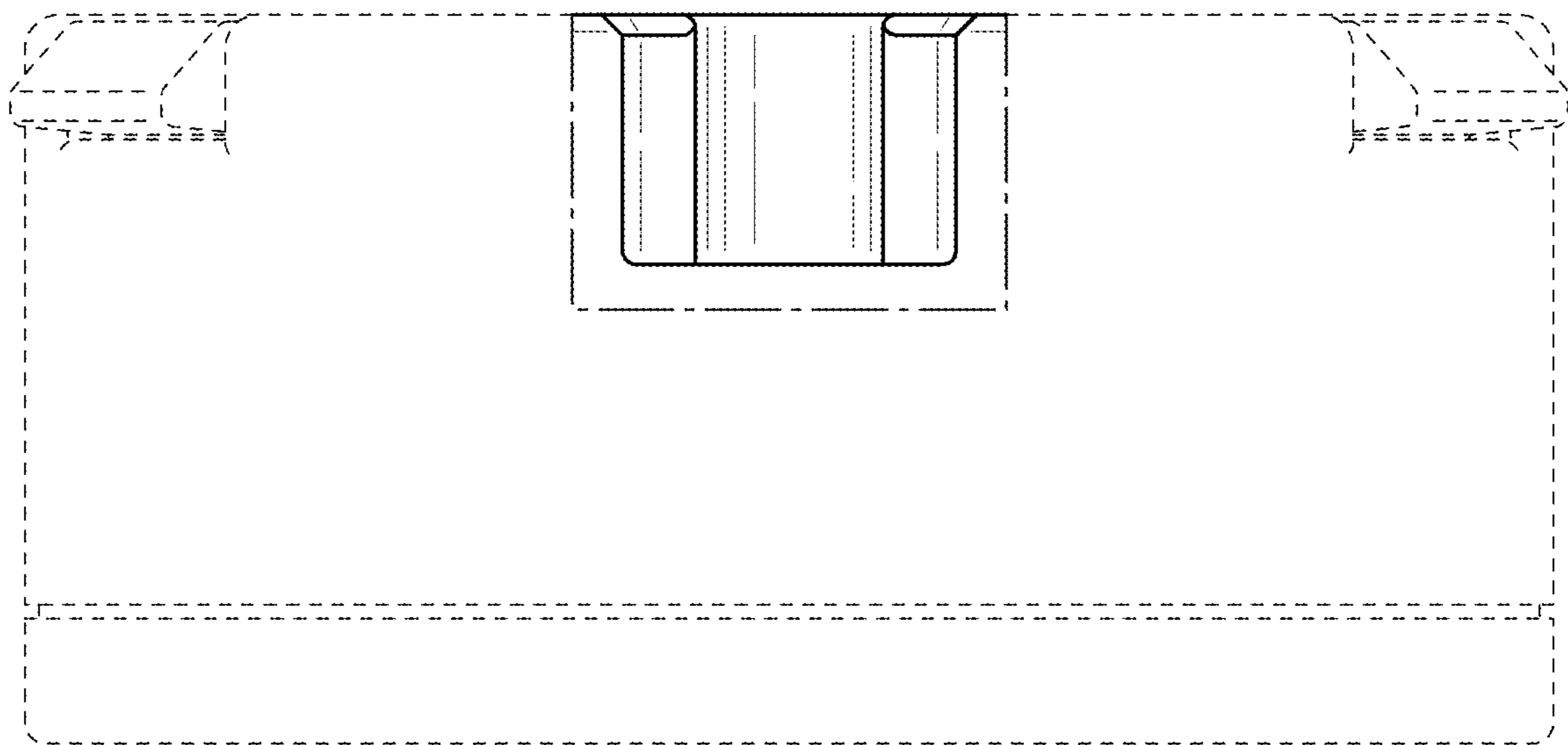

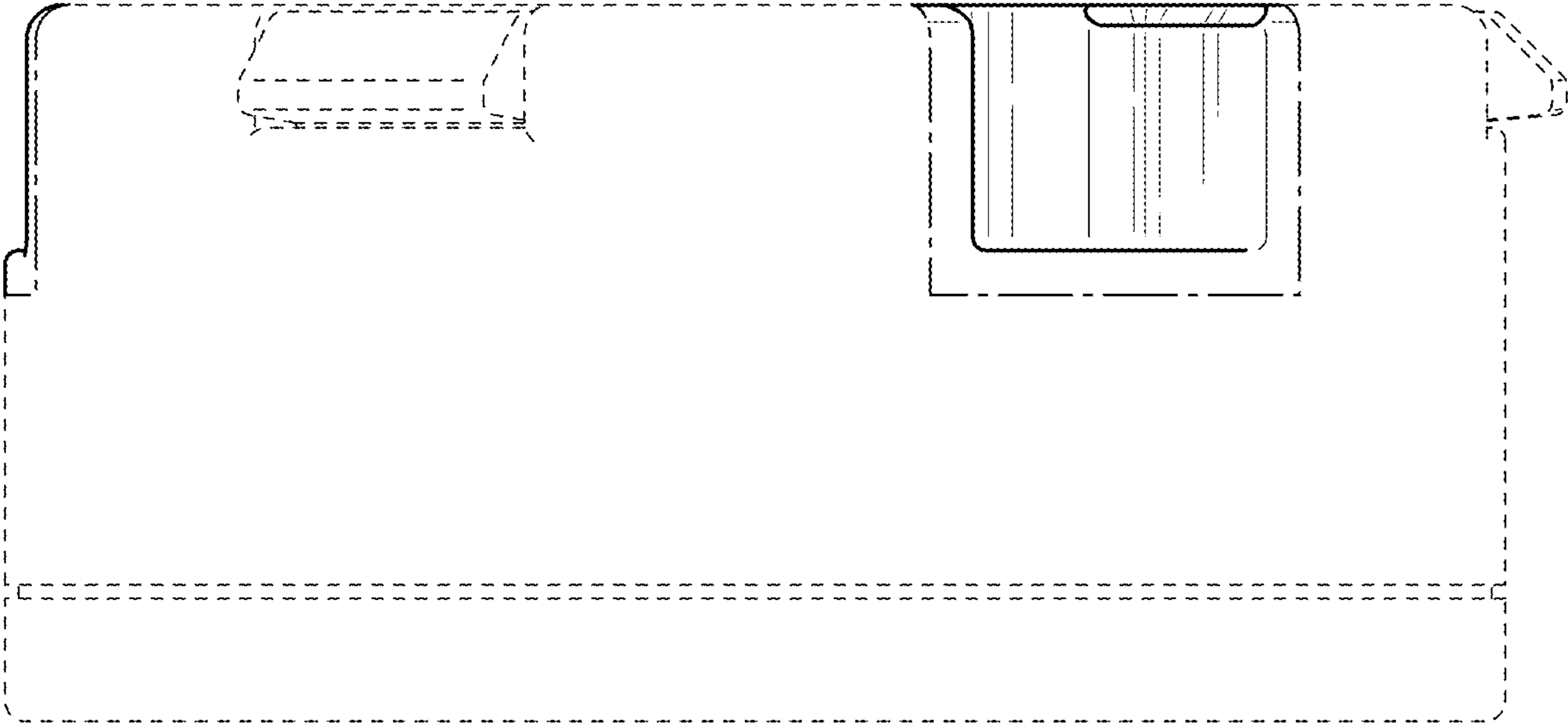

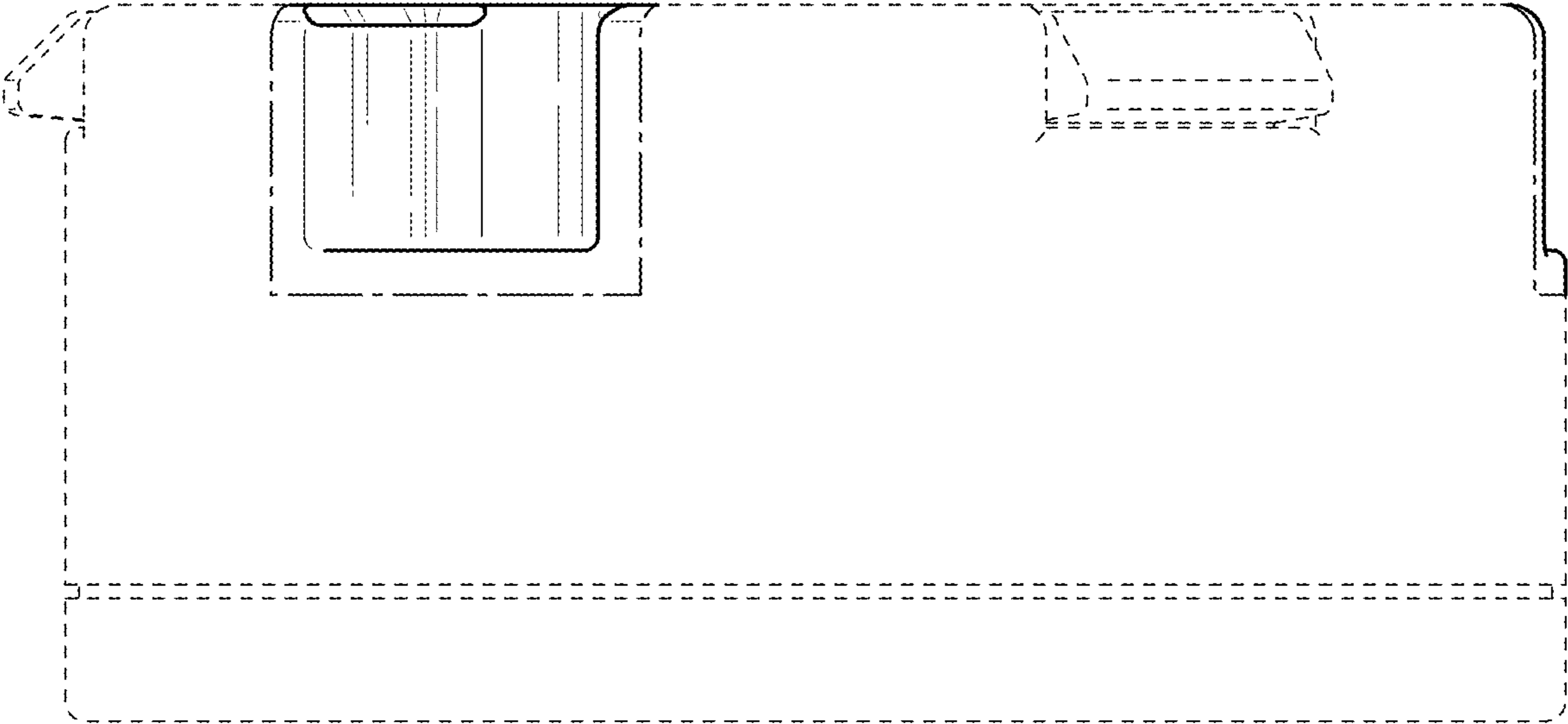

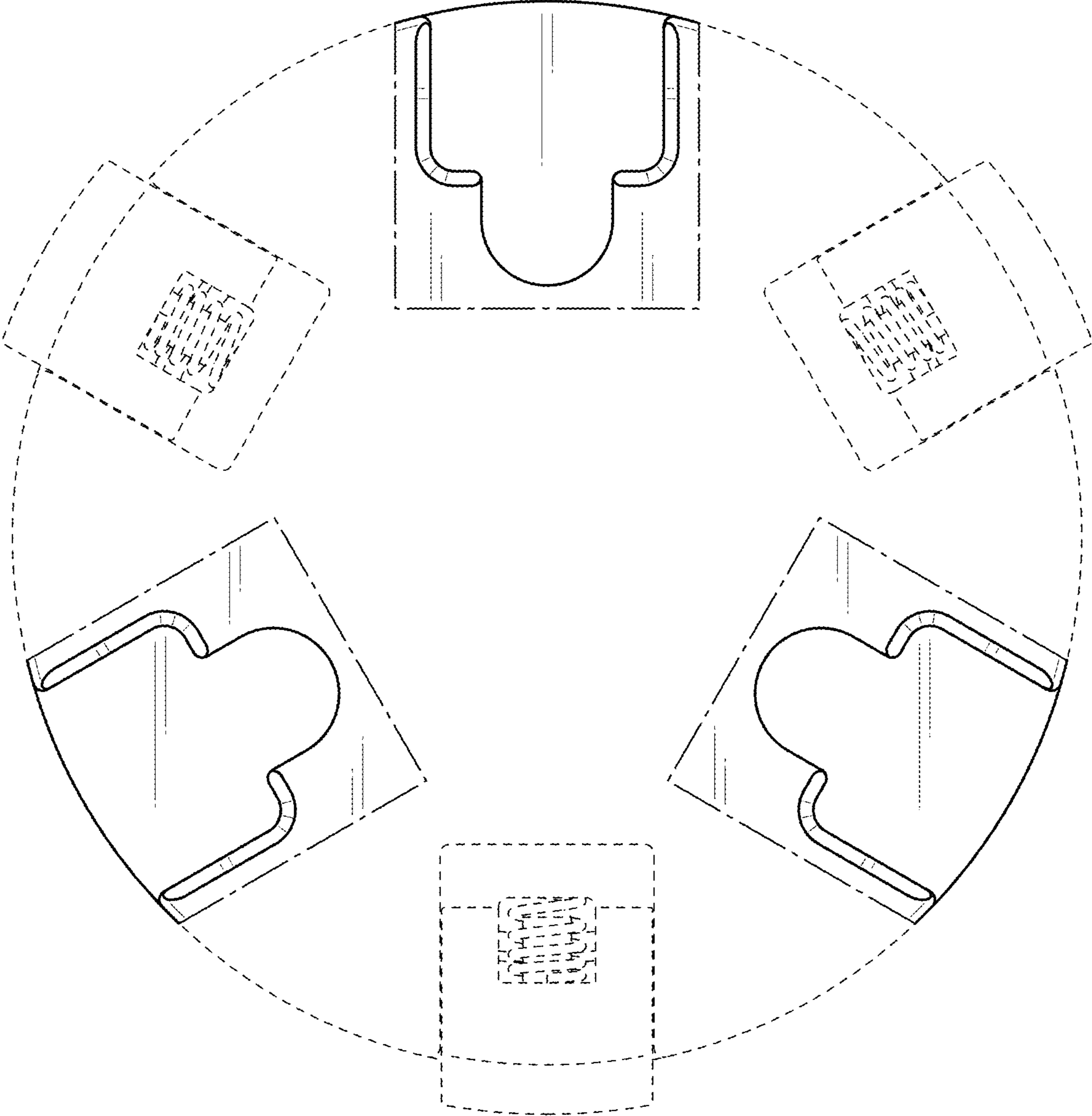

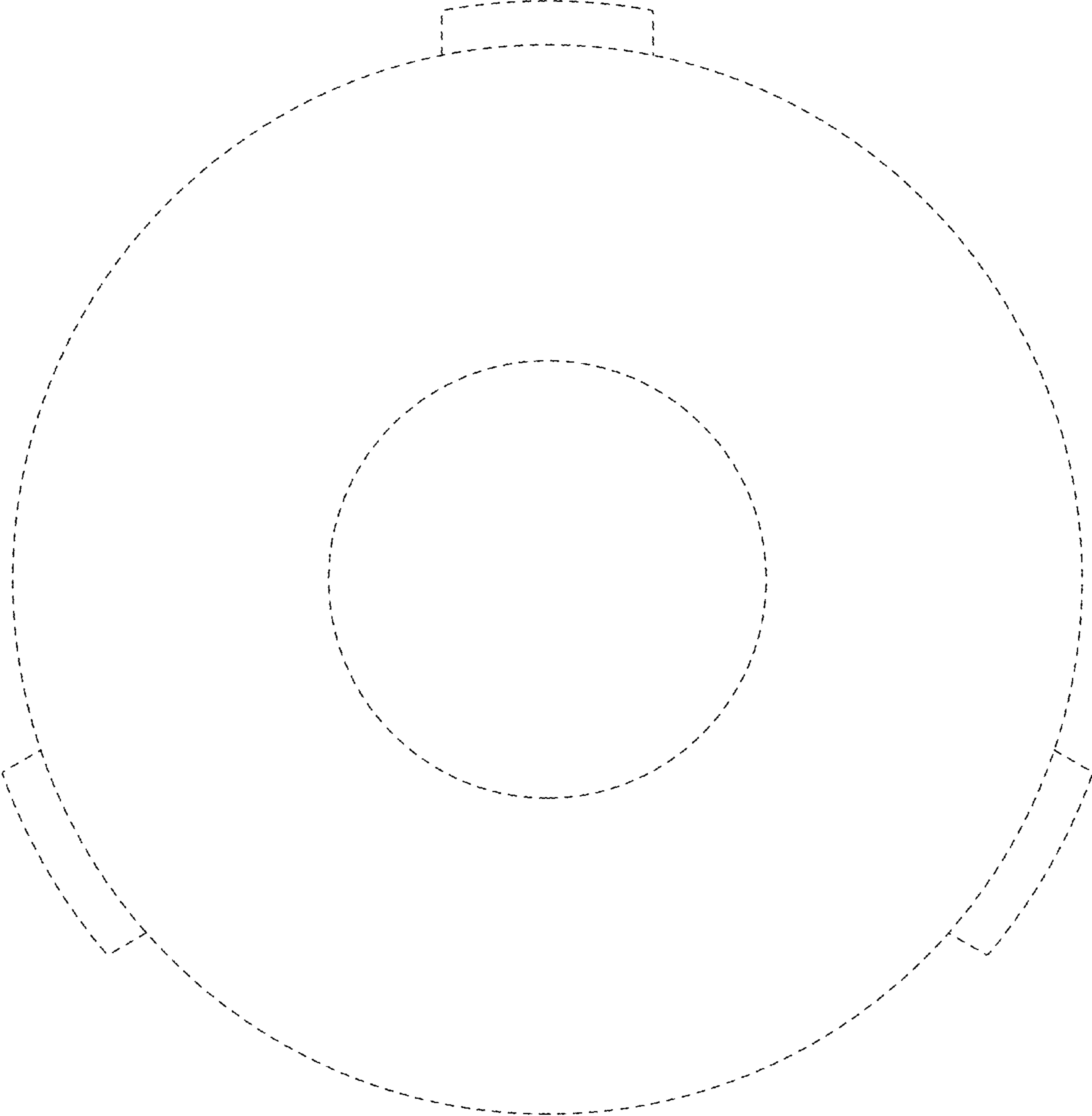

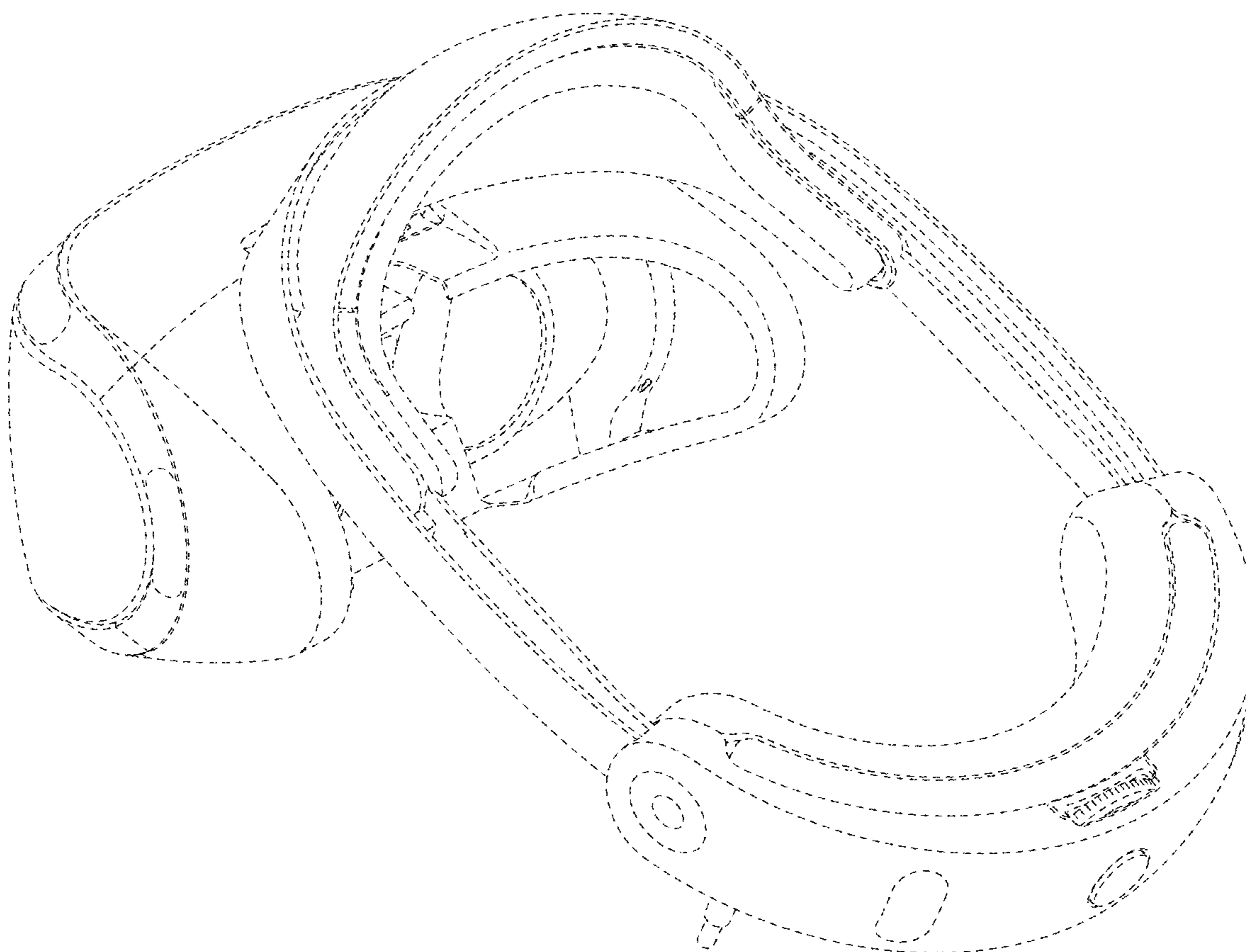

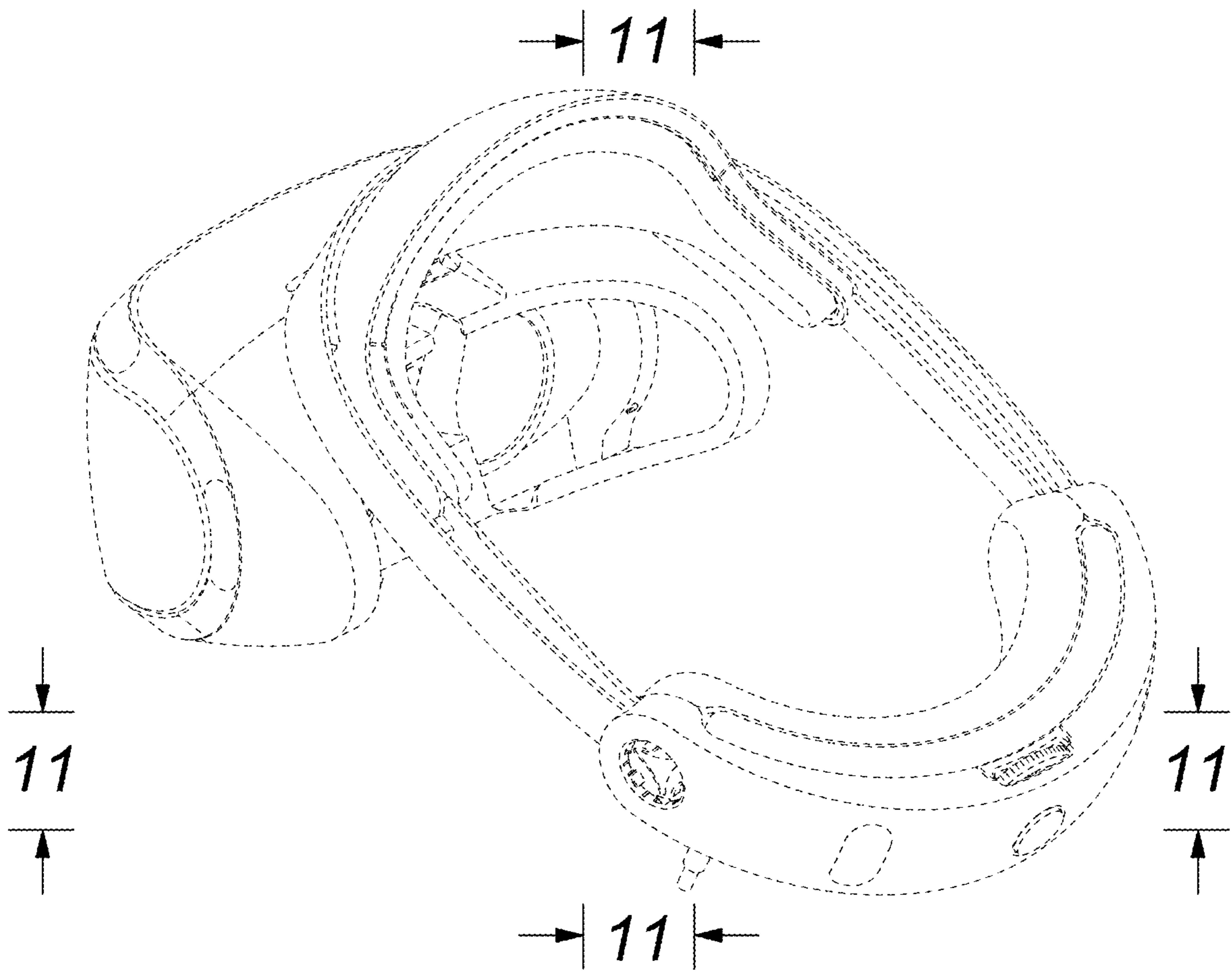

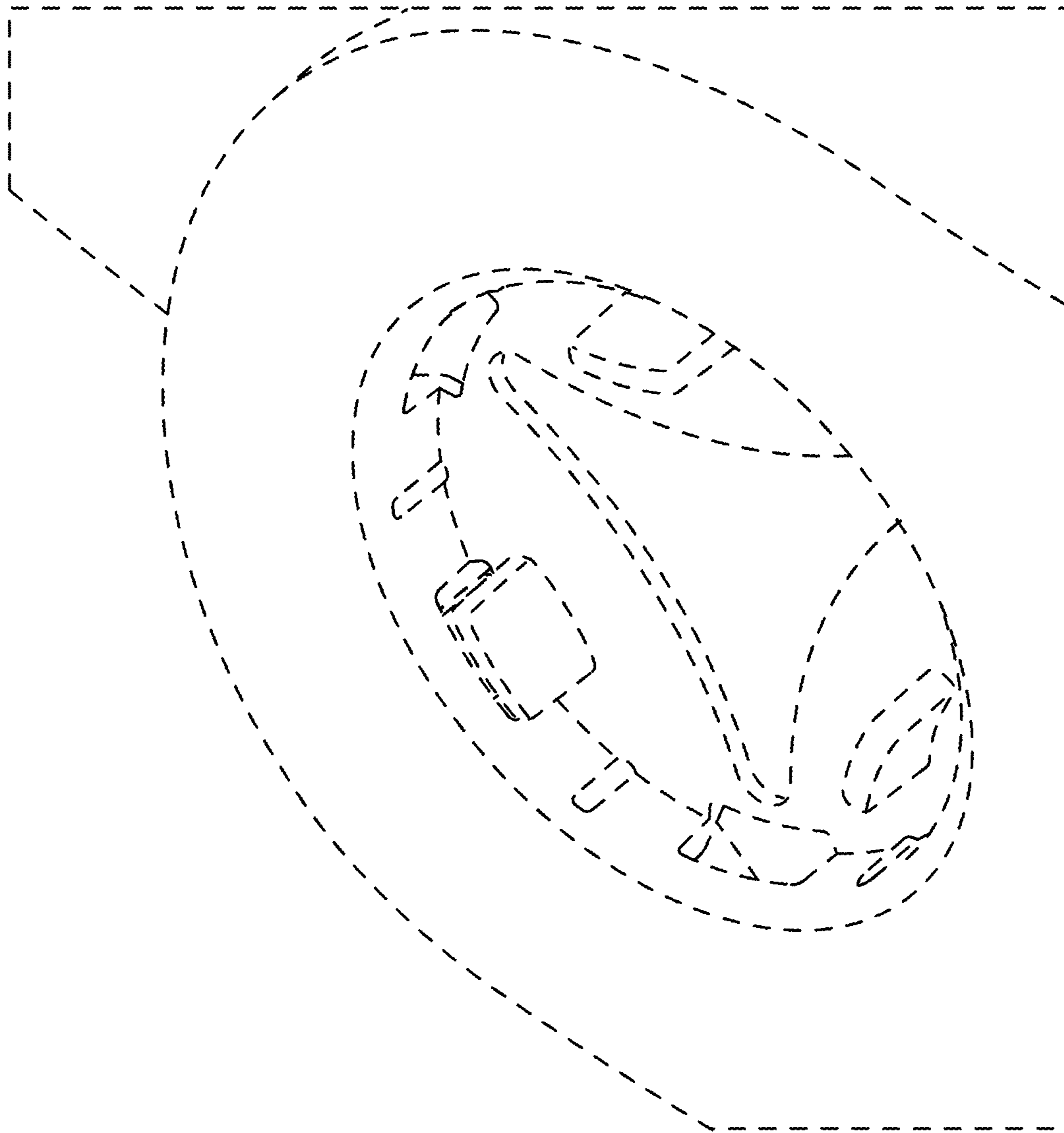
