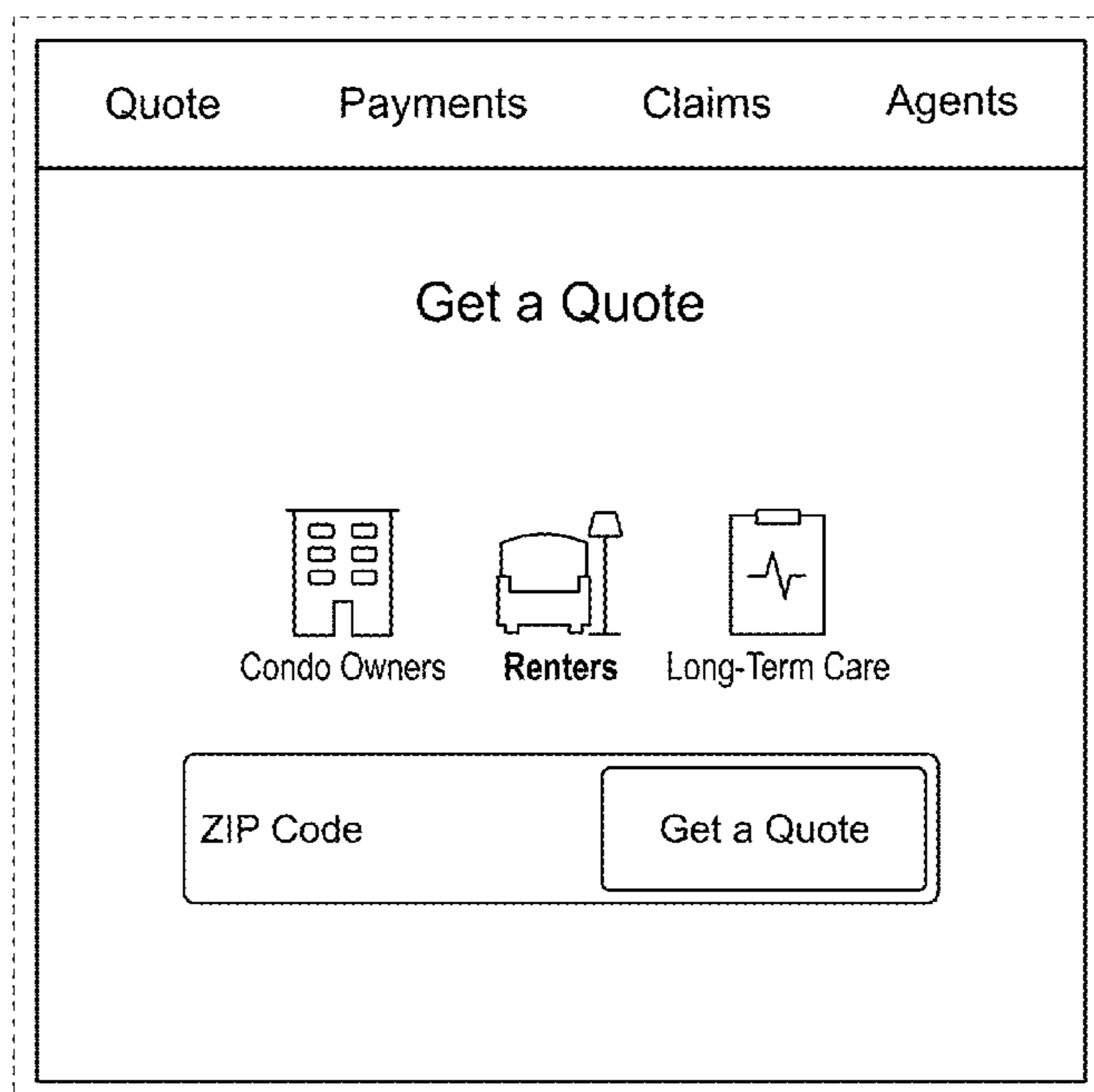




The FIGURE is a front view of a display screen with a graphical user interface for menu of insurance offerings. The broken line showing the display screen forms no part of the claimed design.
