The ornamental design for a blast chiller, as shown and described.

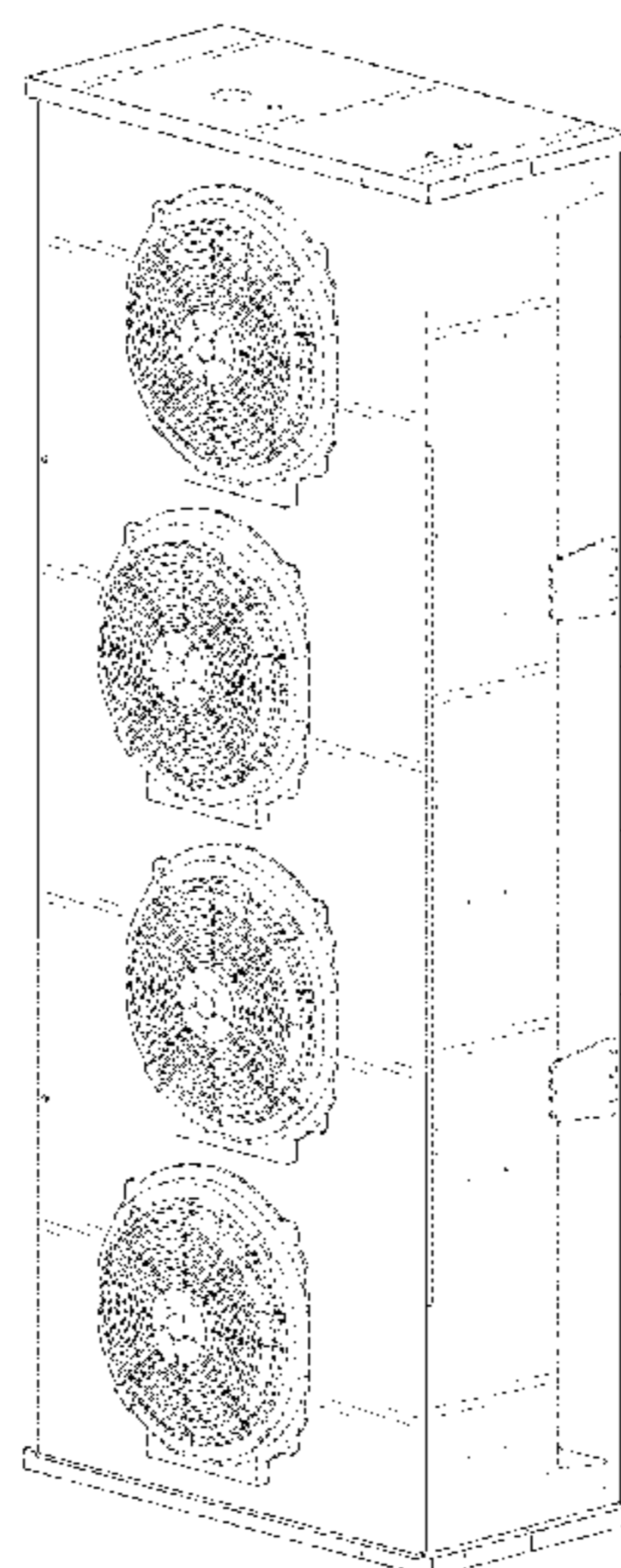
**DESCRIPTION**

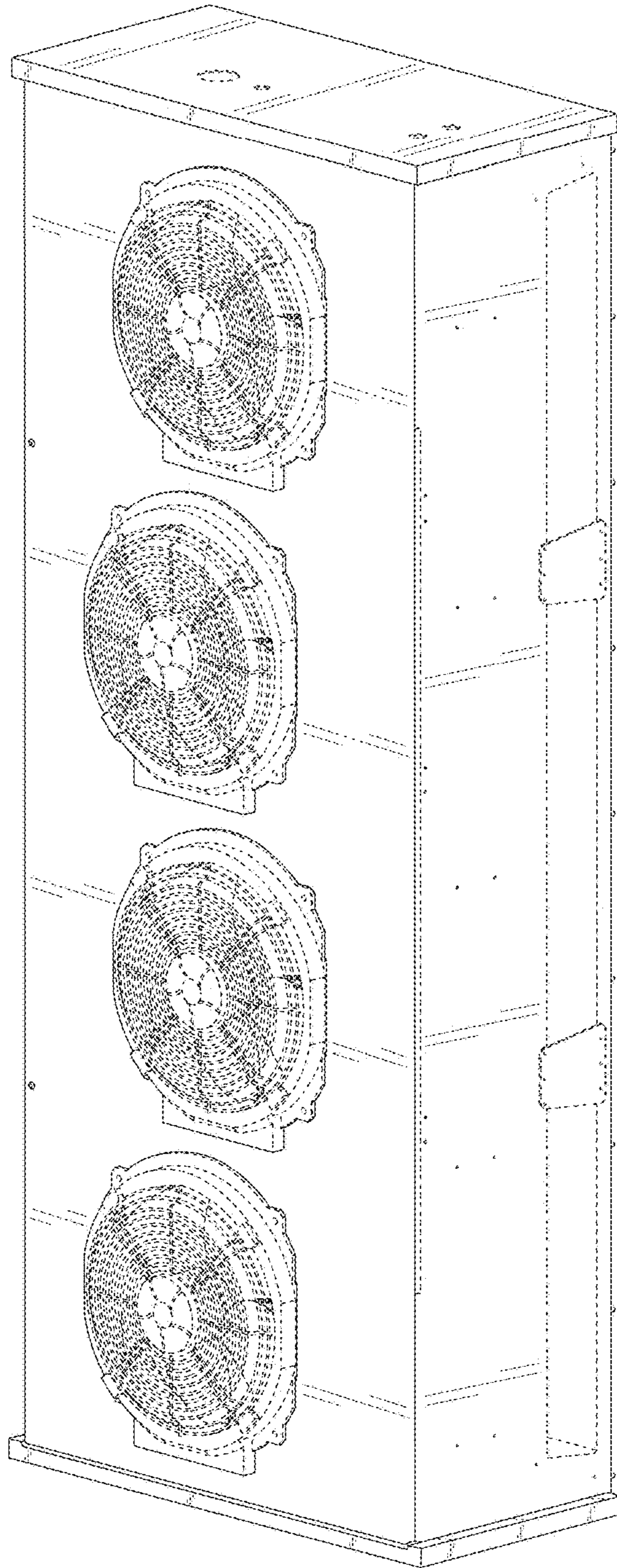

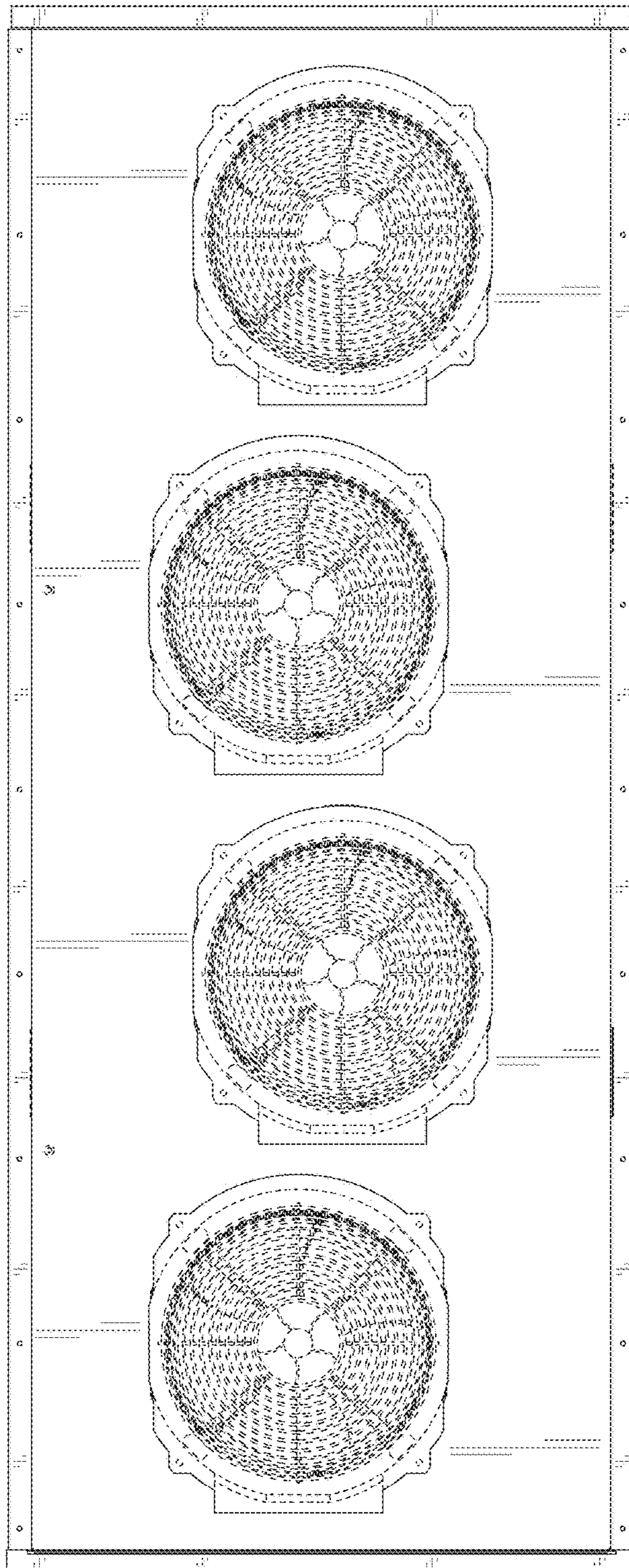

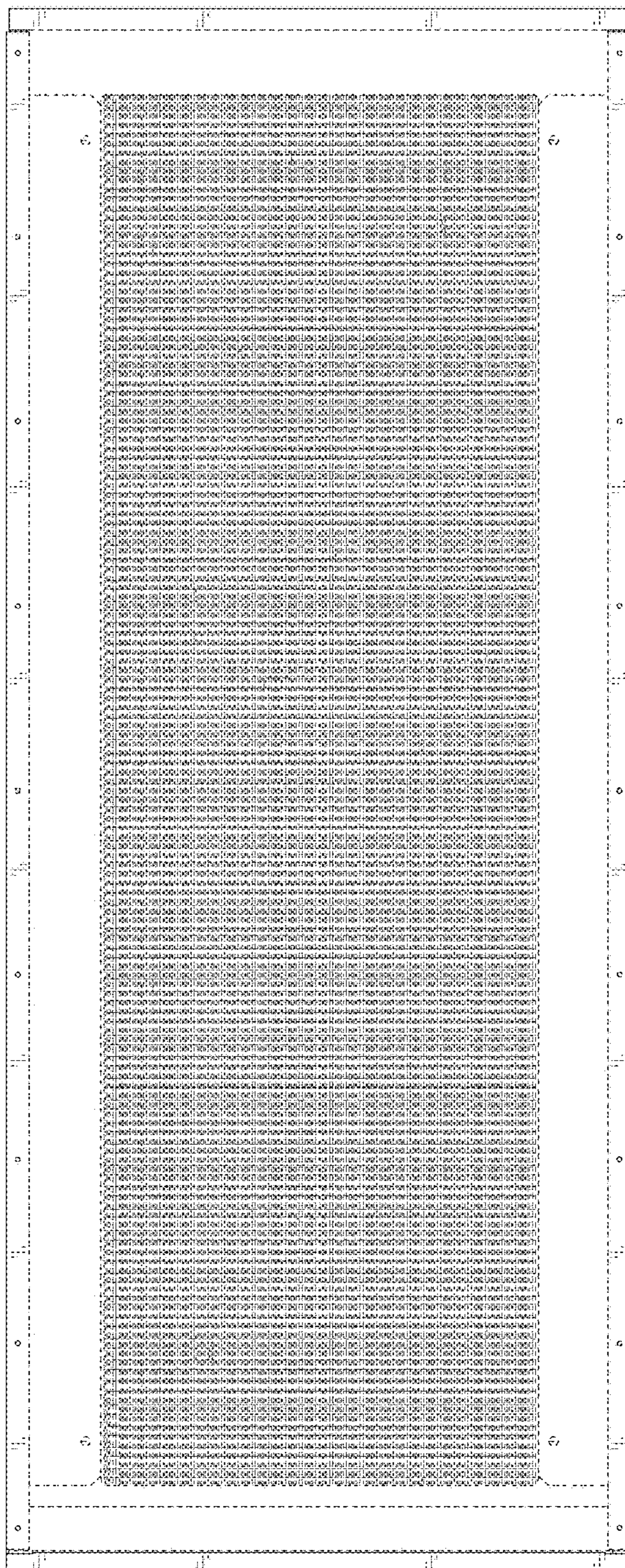

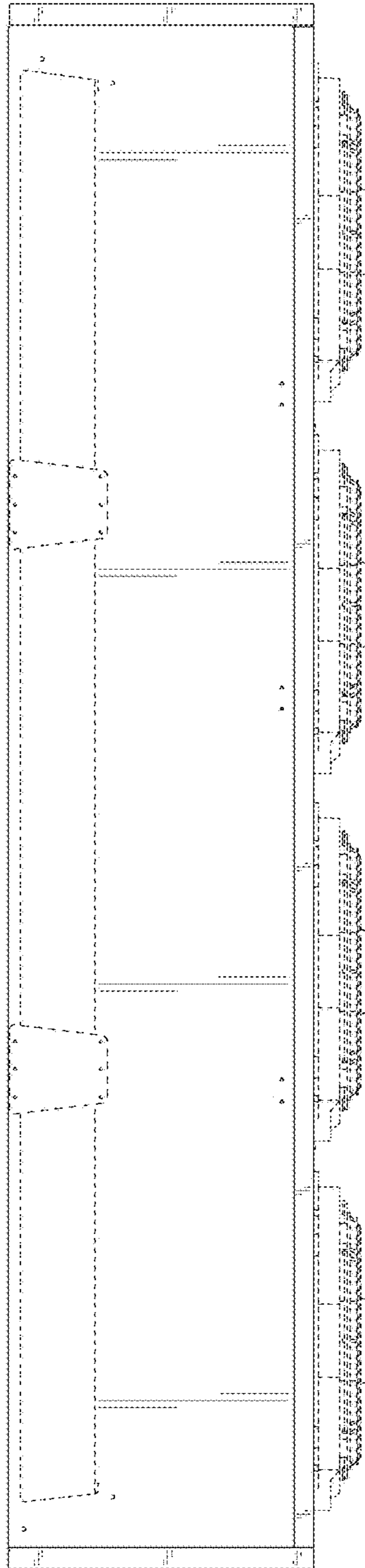

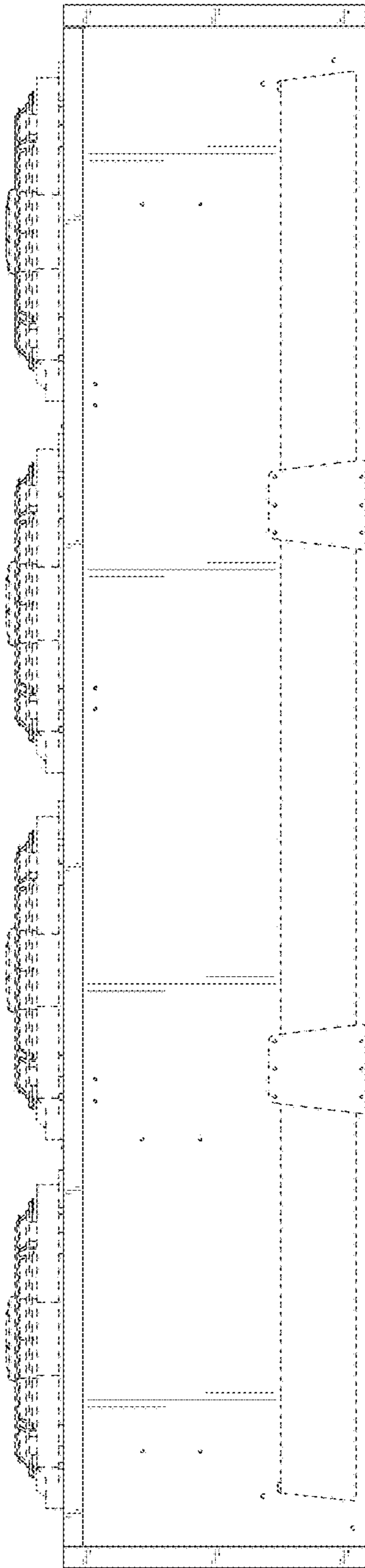

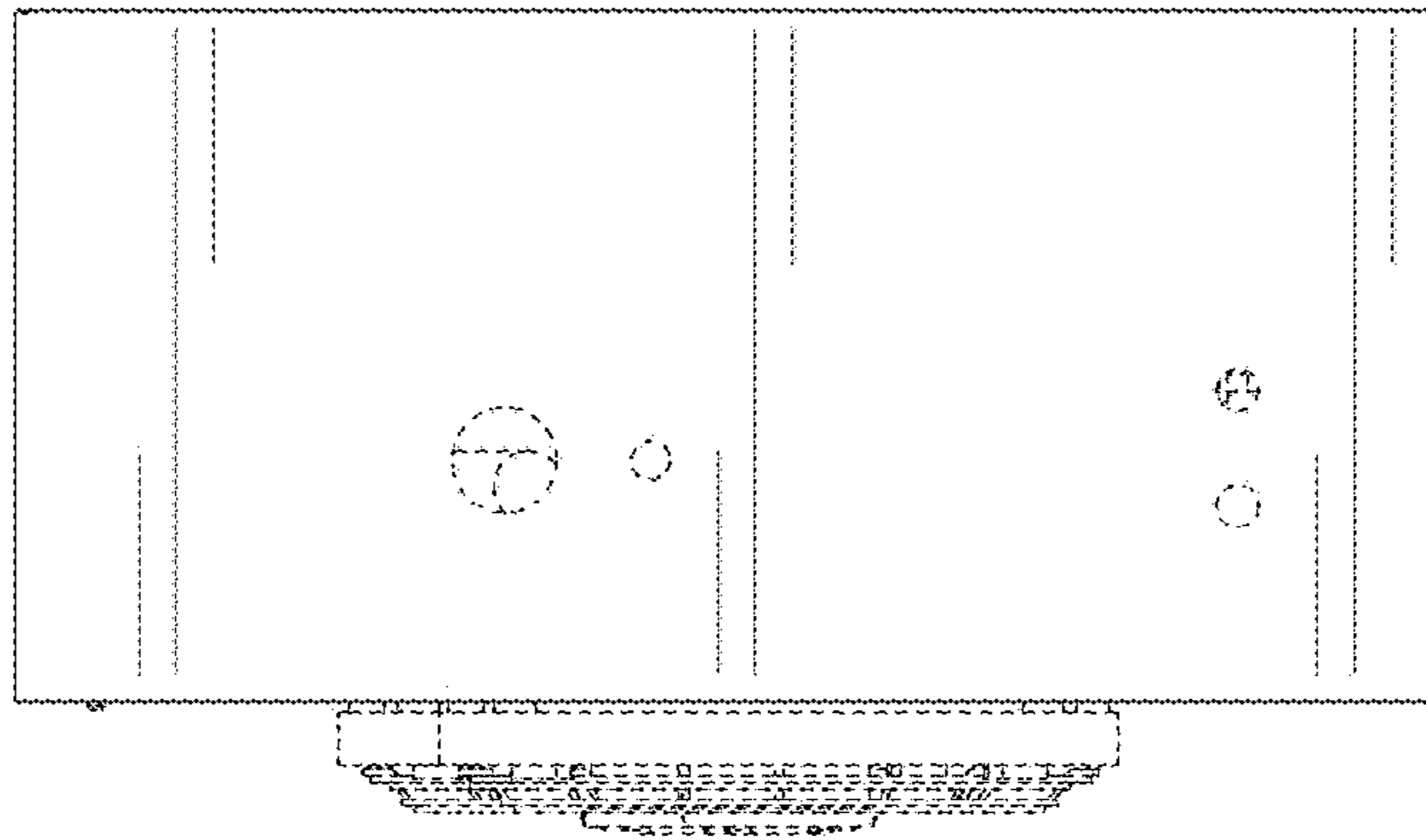

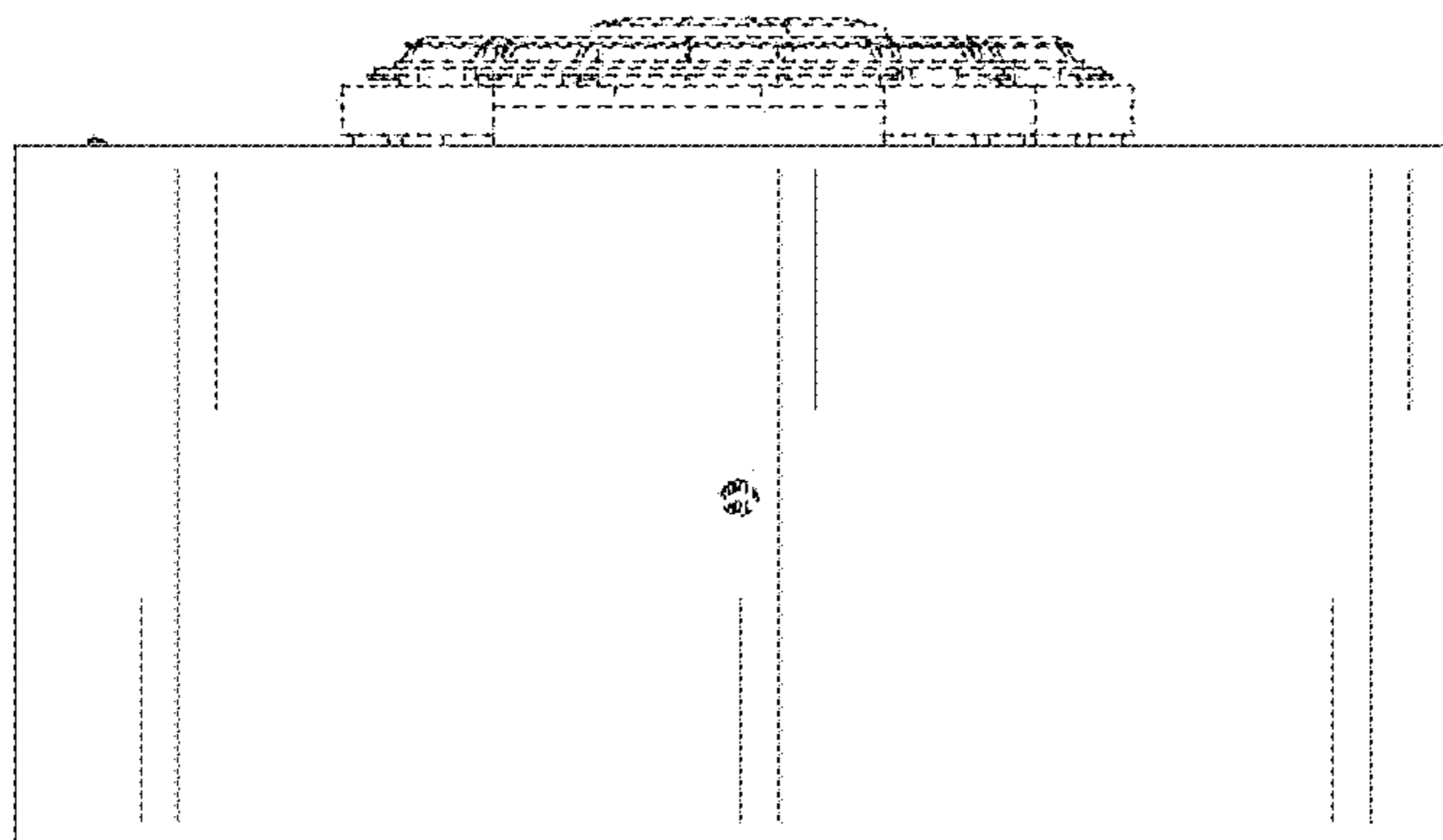
