(57) **CLAIM**

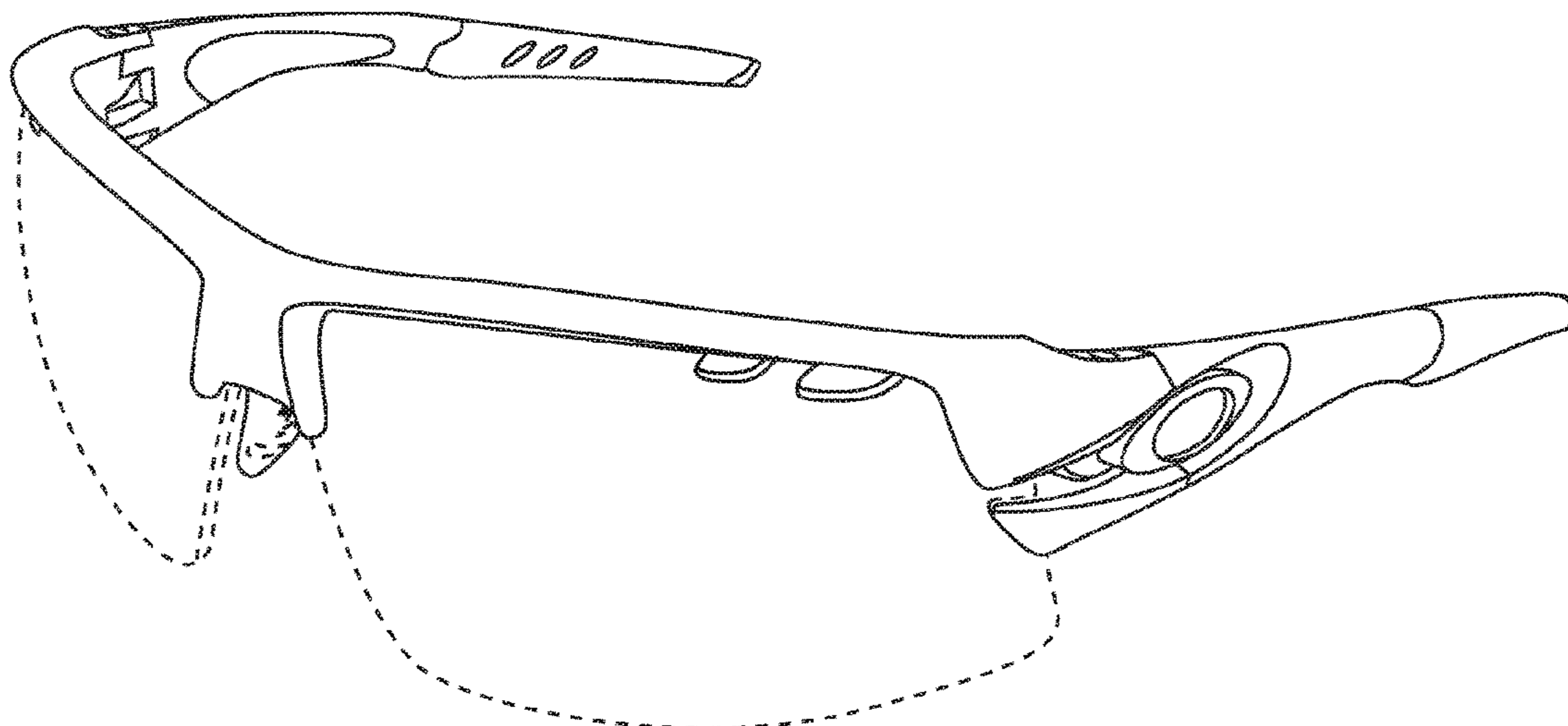
The ornamental design for sport glasses, as shown and described.

DESCRIPTION

FIG. 1 is perspective view of the sport glasses;
FIG. 2 is a left side-elevation view of the sport glasses, the right side-elevation view being a mirror image thereof;
FIG. 3 is a bottom-plan view of the sport glasses;
FIG. 4 is a top-plan view of the sport glasses;
FIG. 5 is a front-elevation view of the sport glasses;
FIG. 6 is a rear-elevation view of the sport glasses; and,
FIG. 7 is a cross-sectional view of the sport glasses taken at line 7-7 of FIG. 3 and FIG. 6.

The broken lines in the drawings illustrate portions of the sport glasses that form no part of the claimed design. The broken lines in FIG. 7 that take the form of a long line followed by two short lines form no part of the claimed design but are used to delineate a magnified section of the drawing.

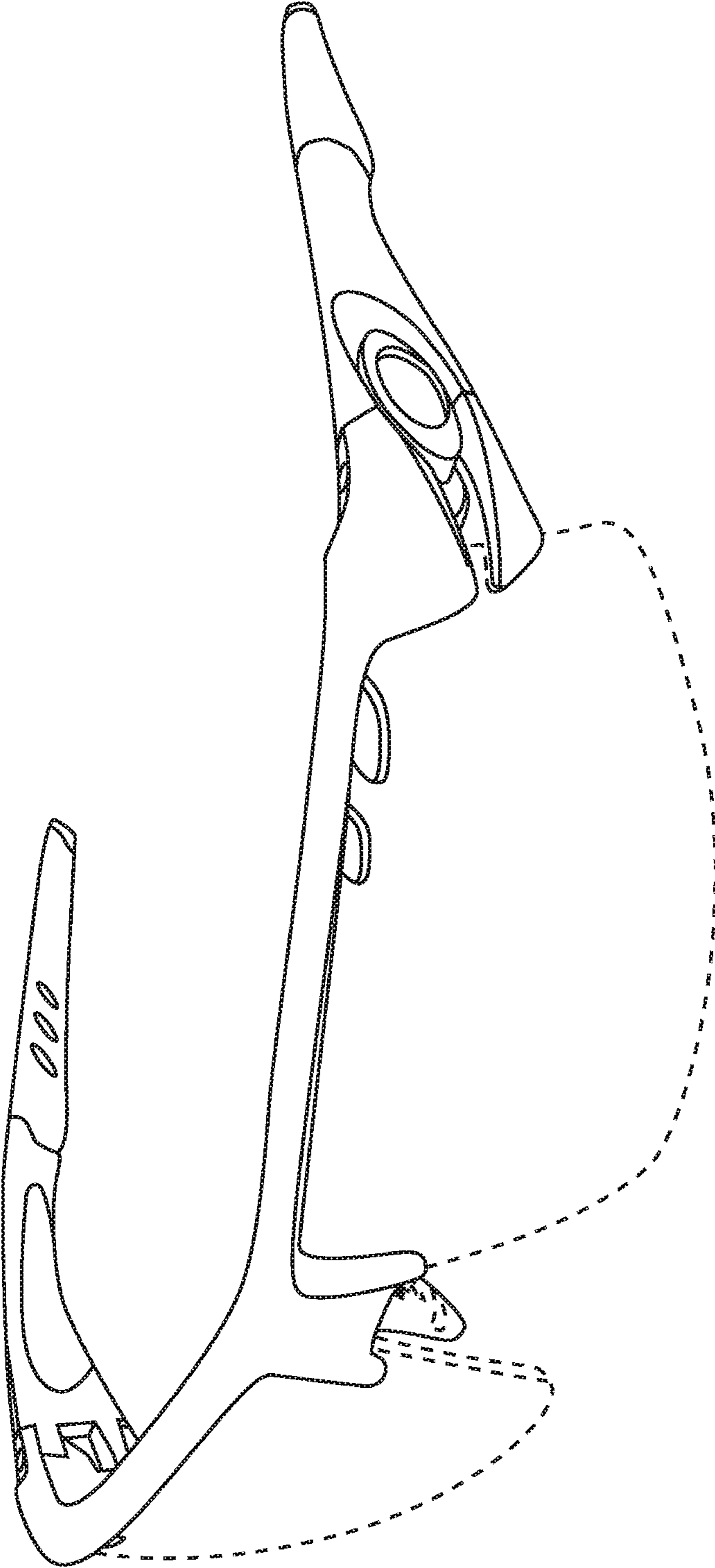

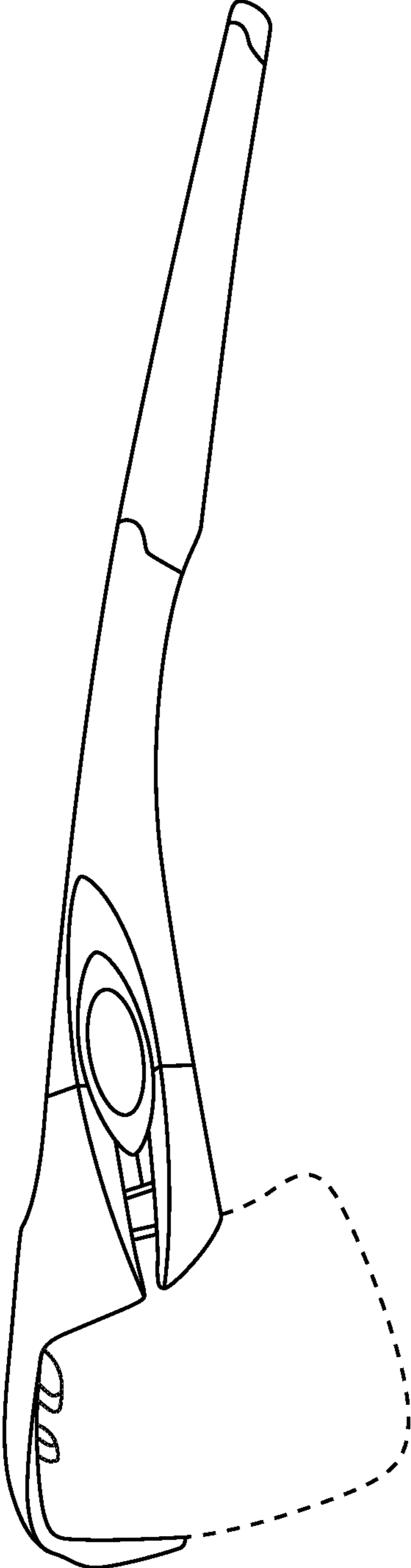

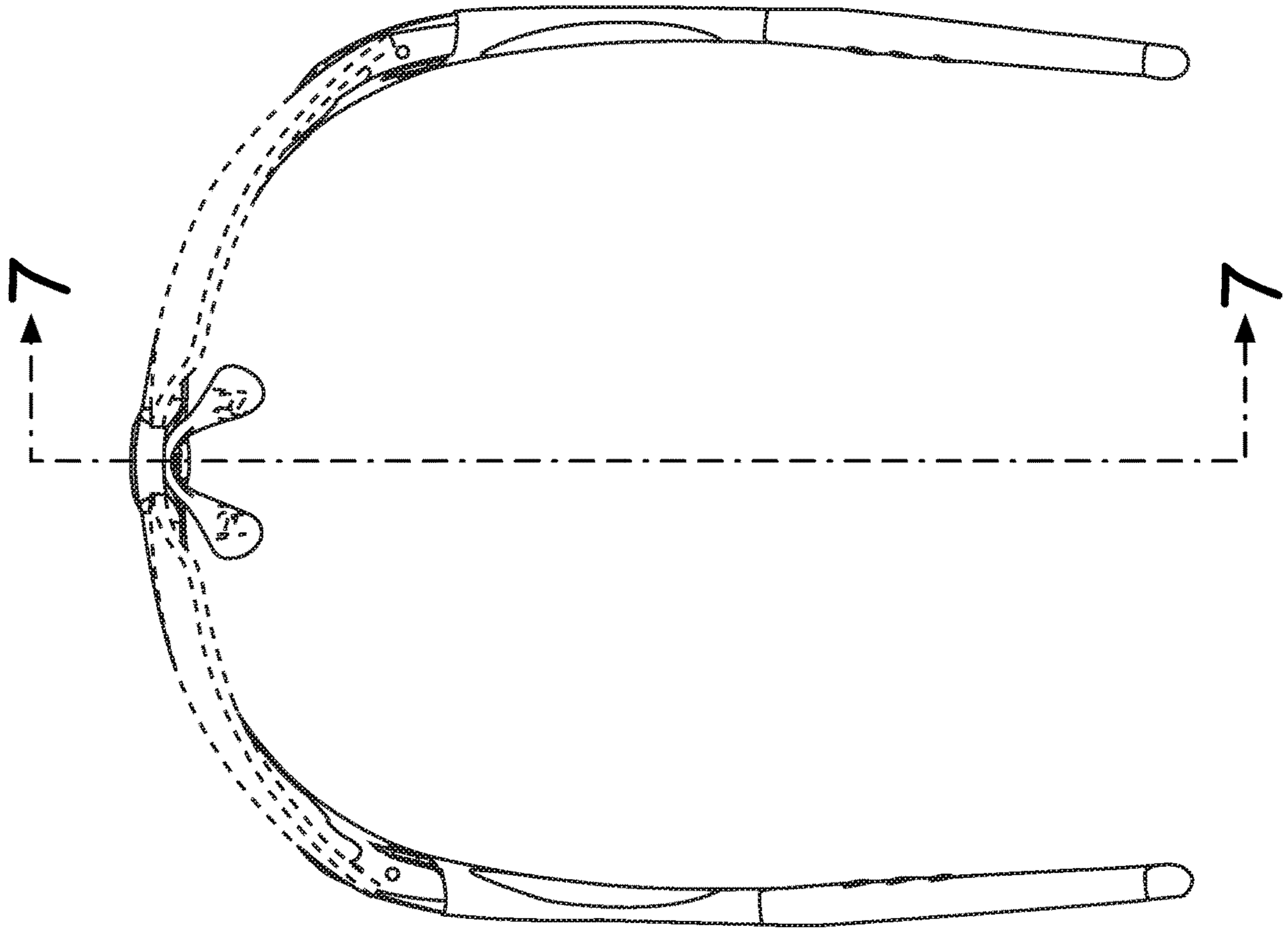

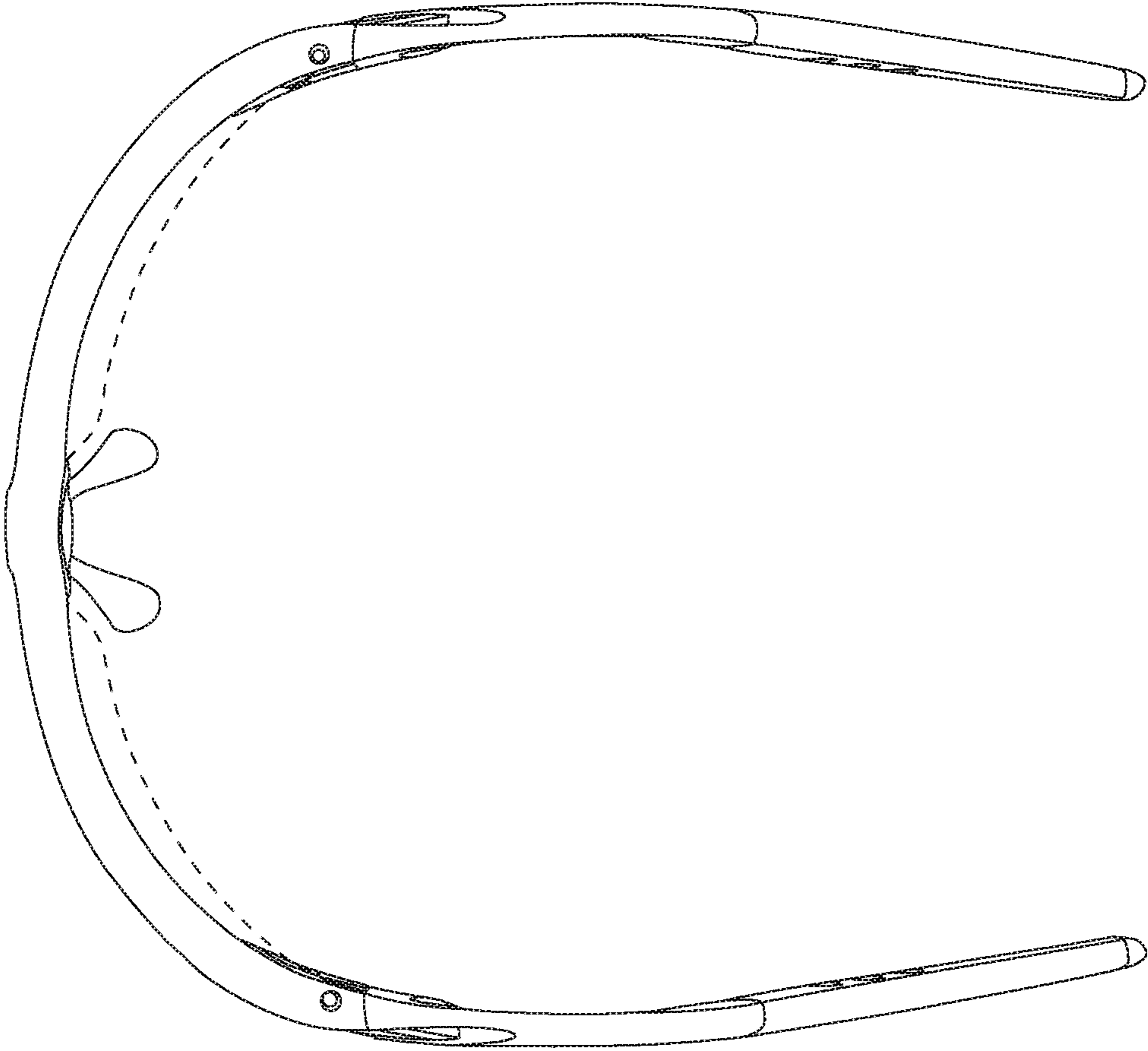

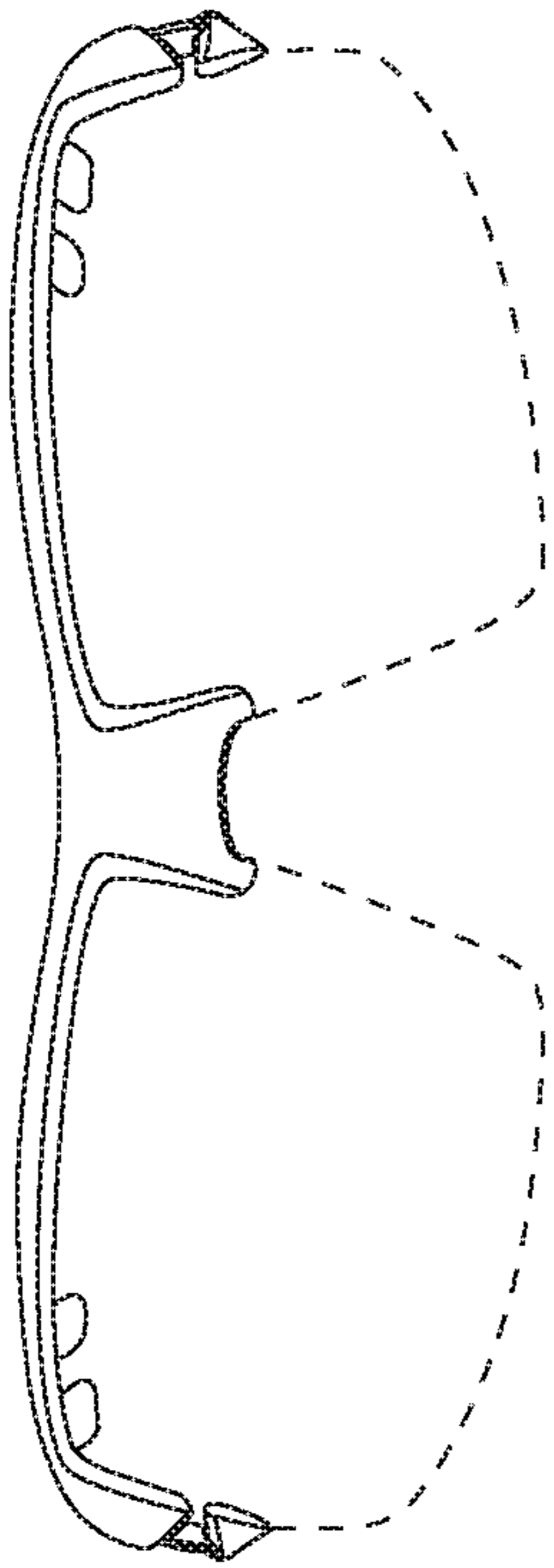

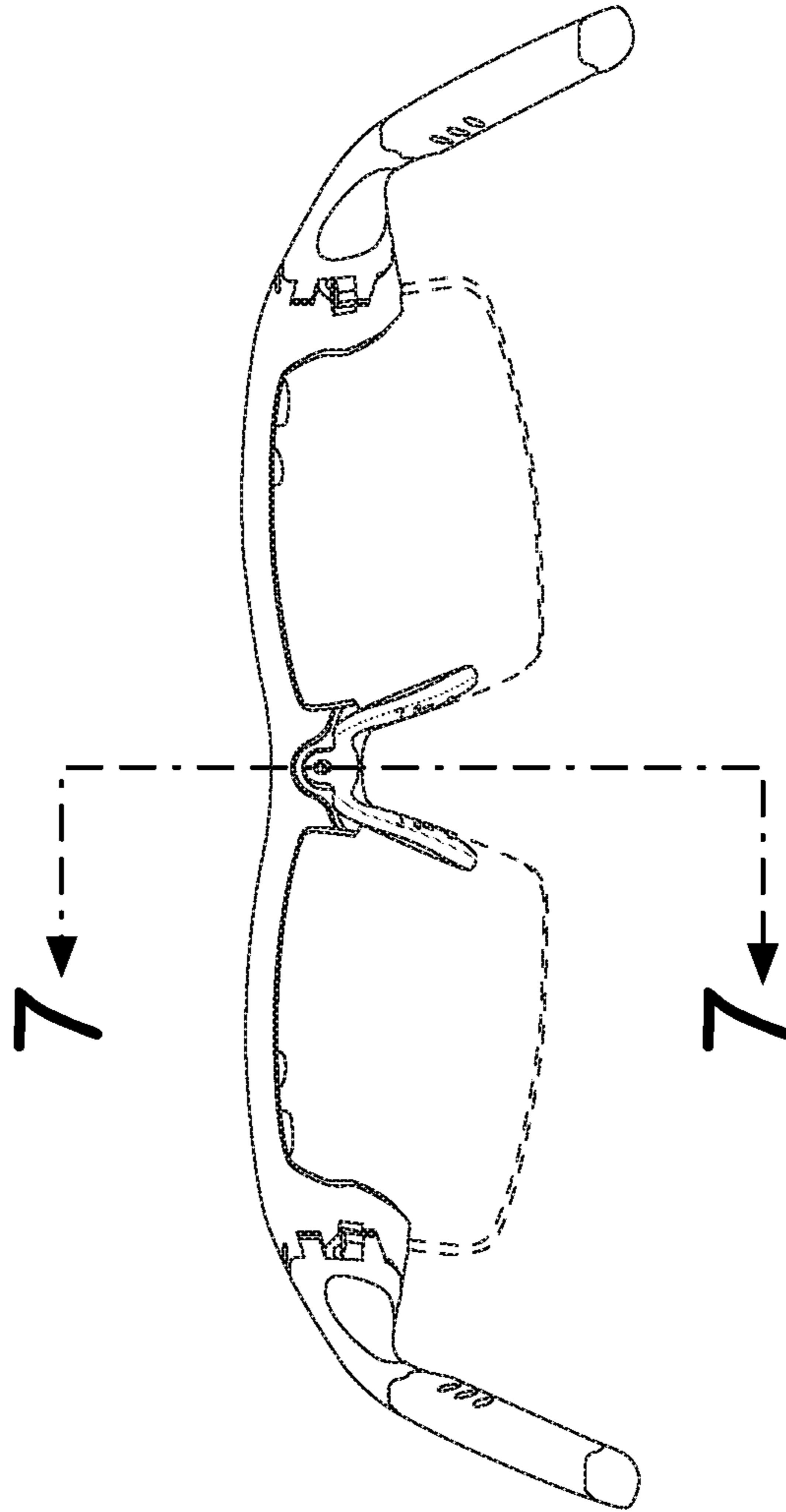

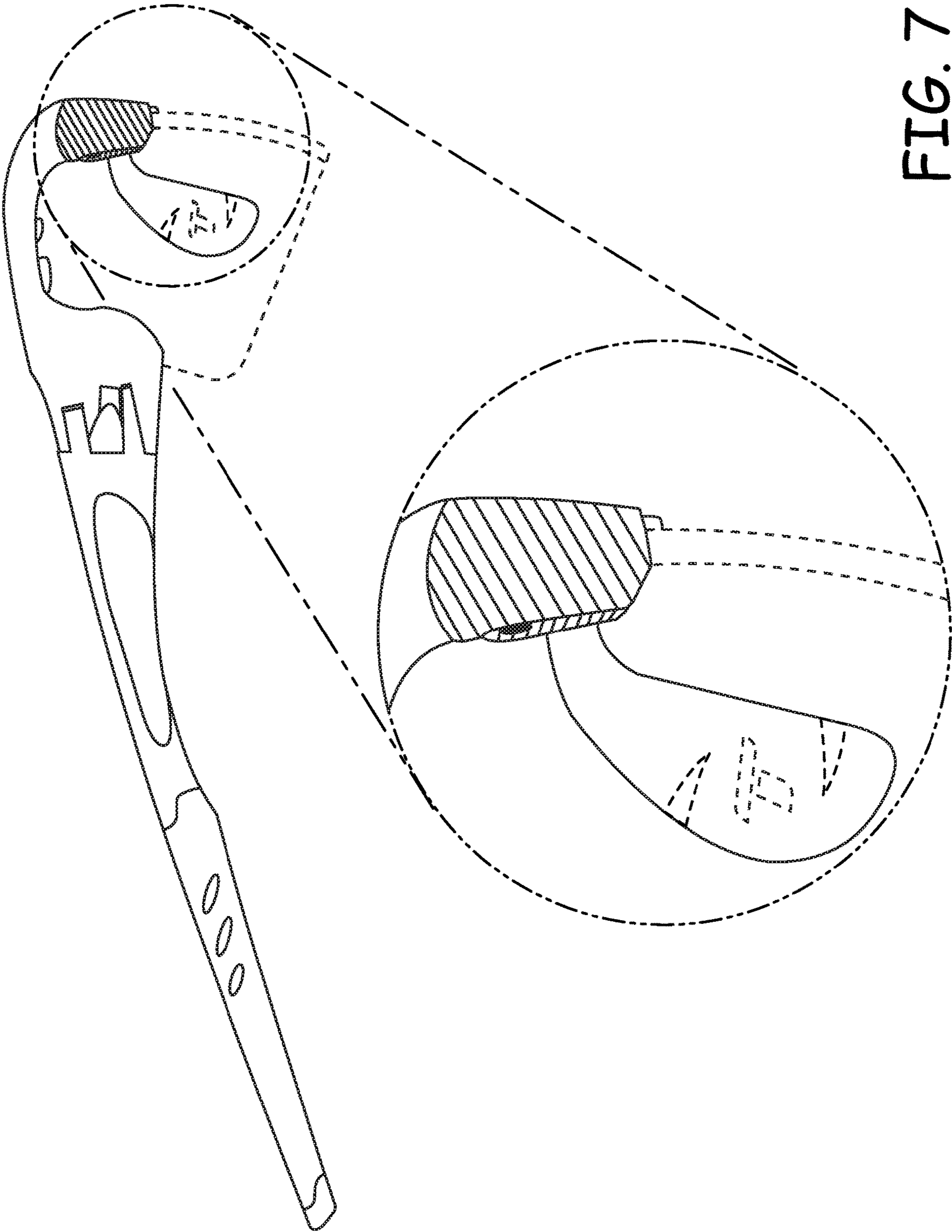
