**DESCRIPTION**

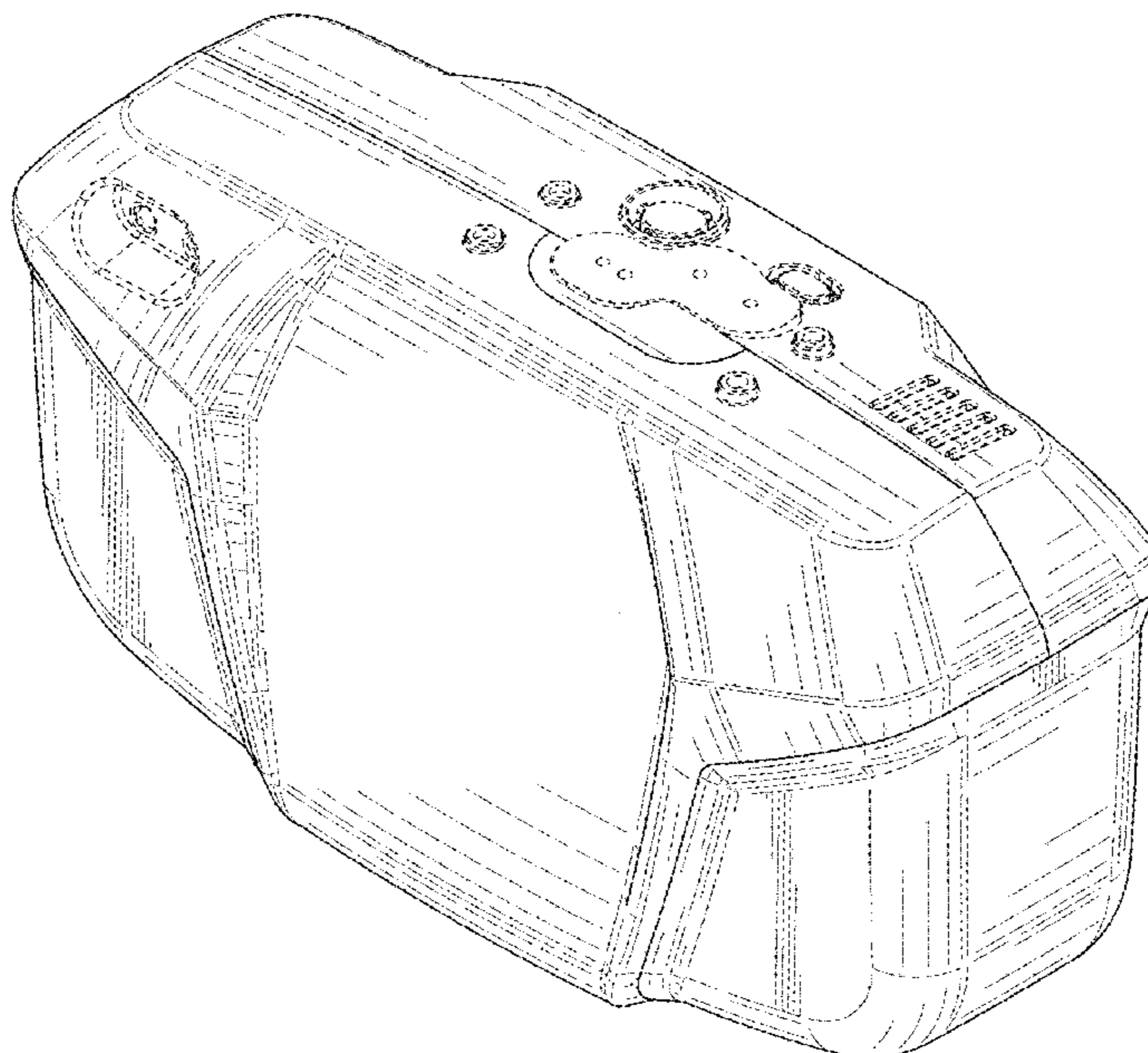
FIG. 1 is a top perspective view of the compact emergency light of the present invention;

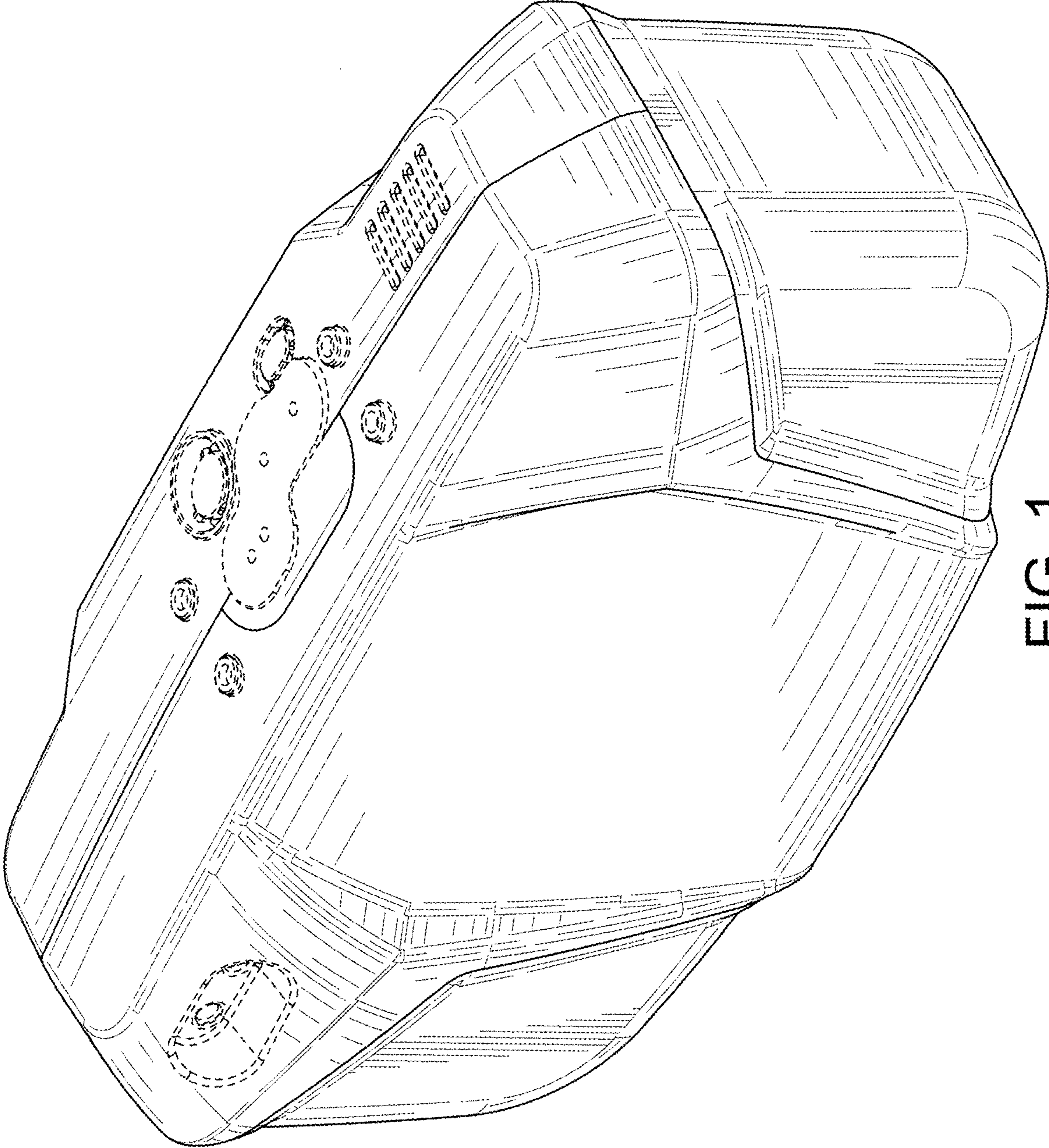

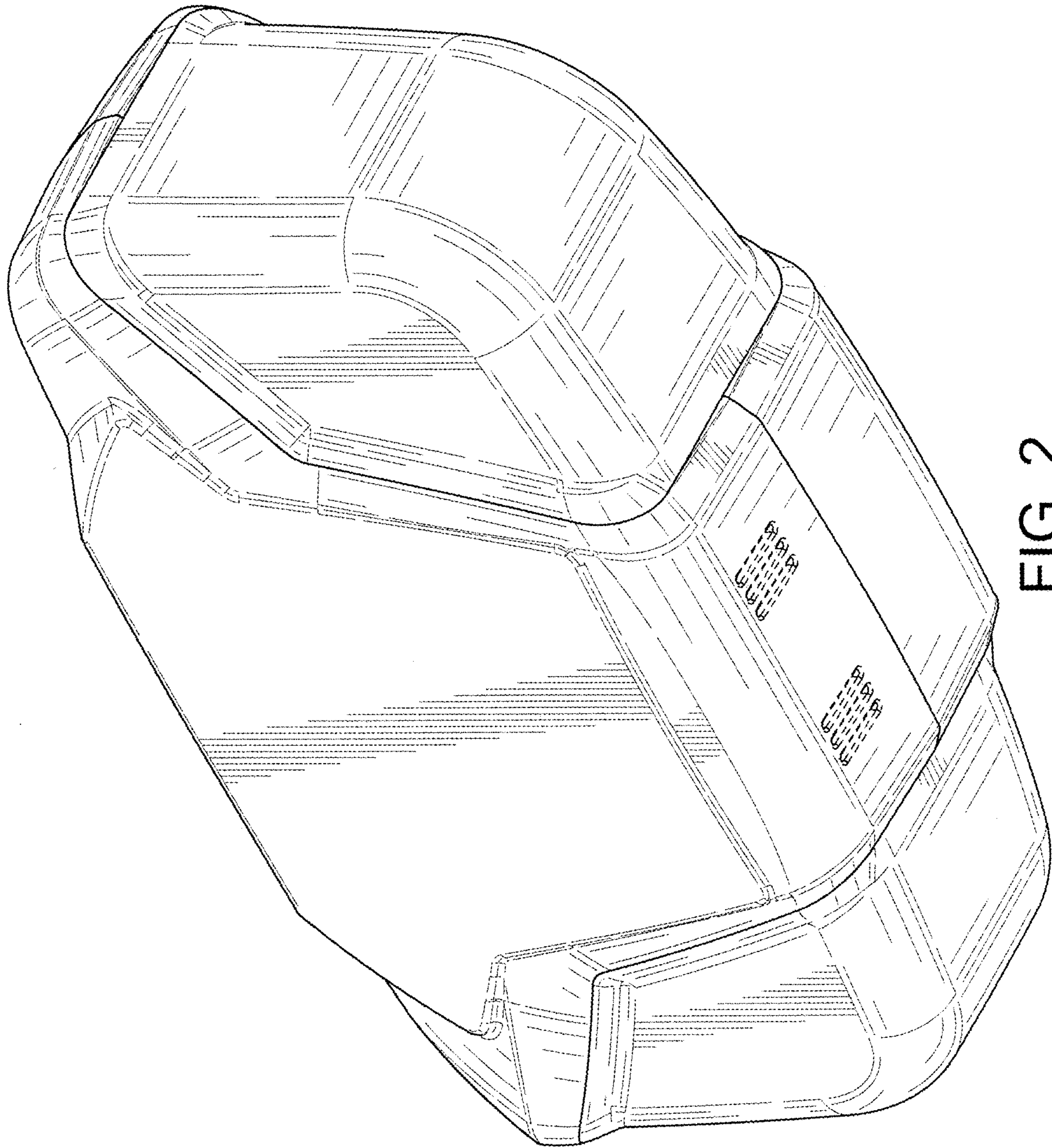

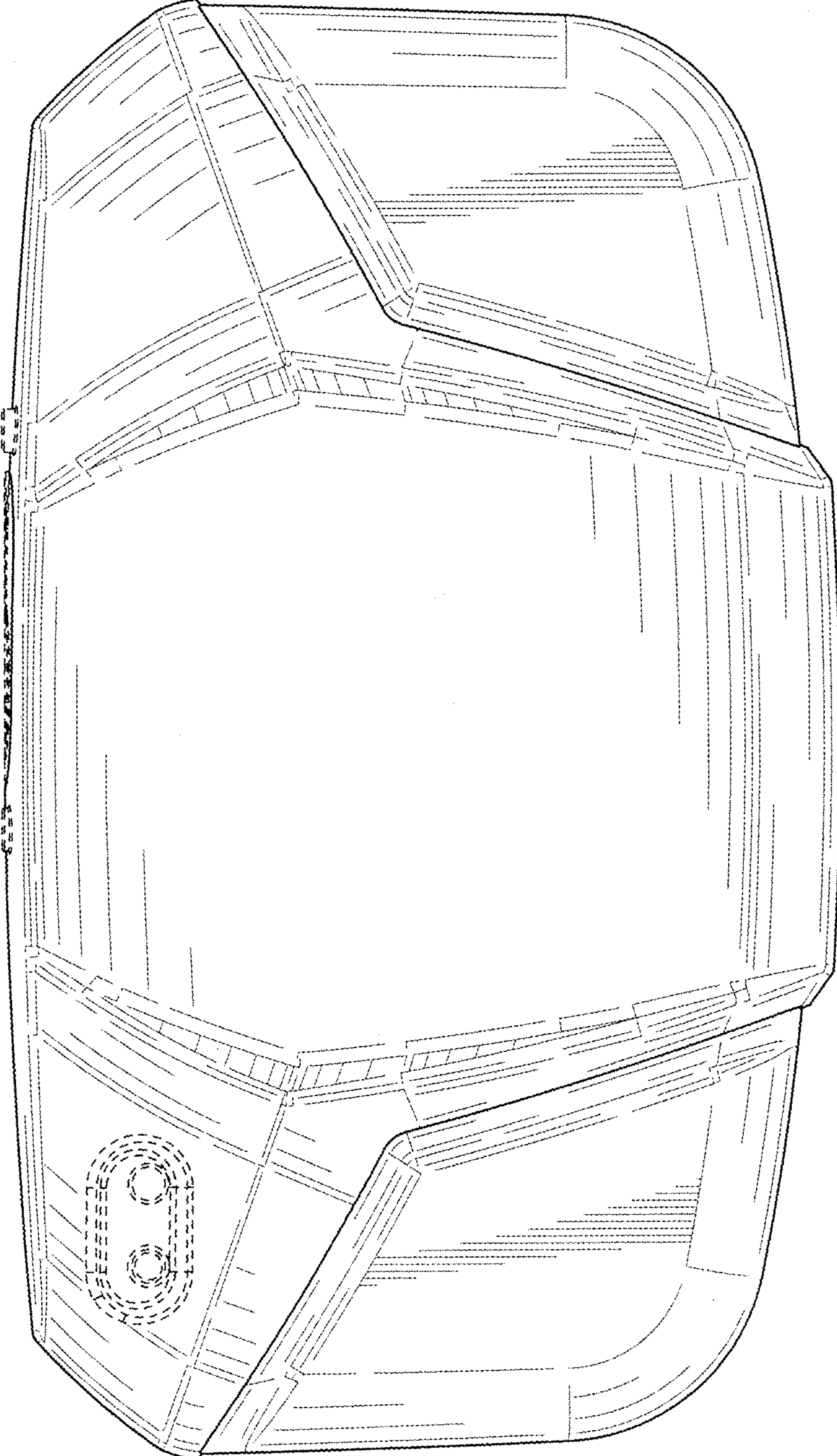

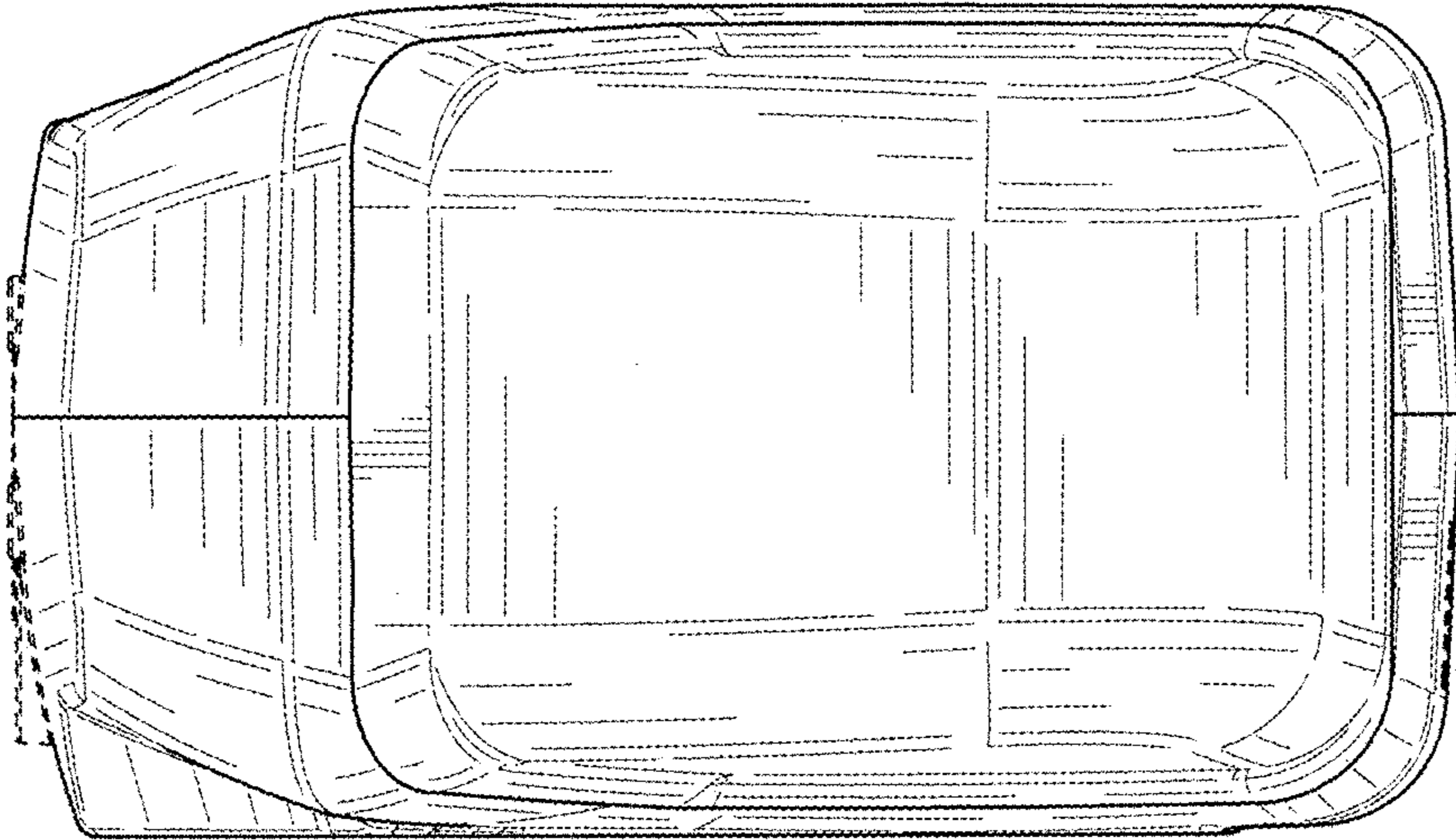

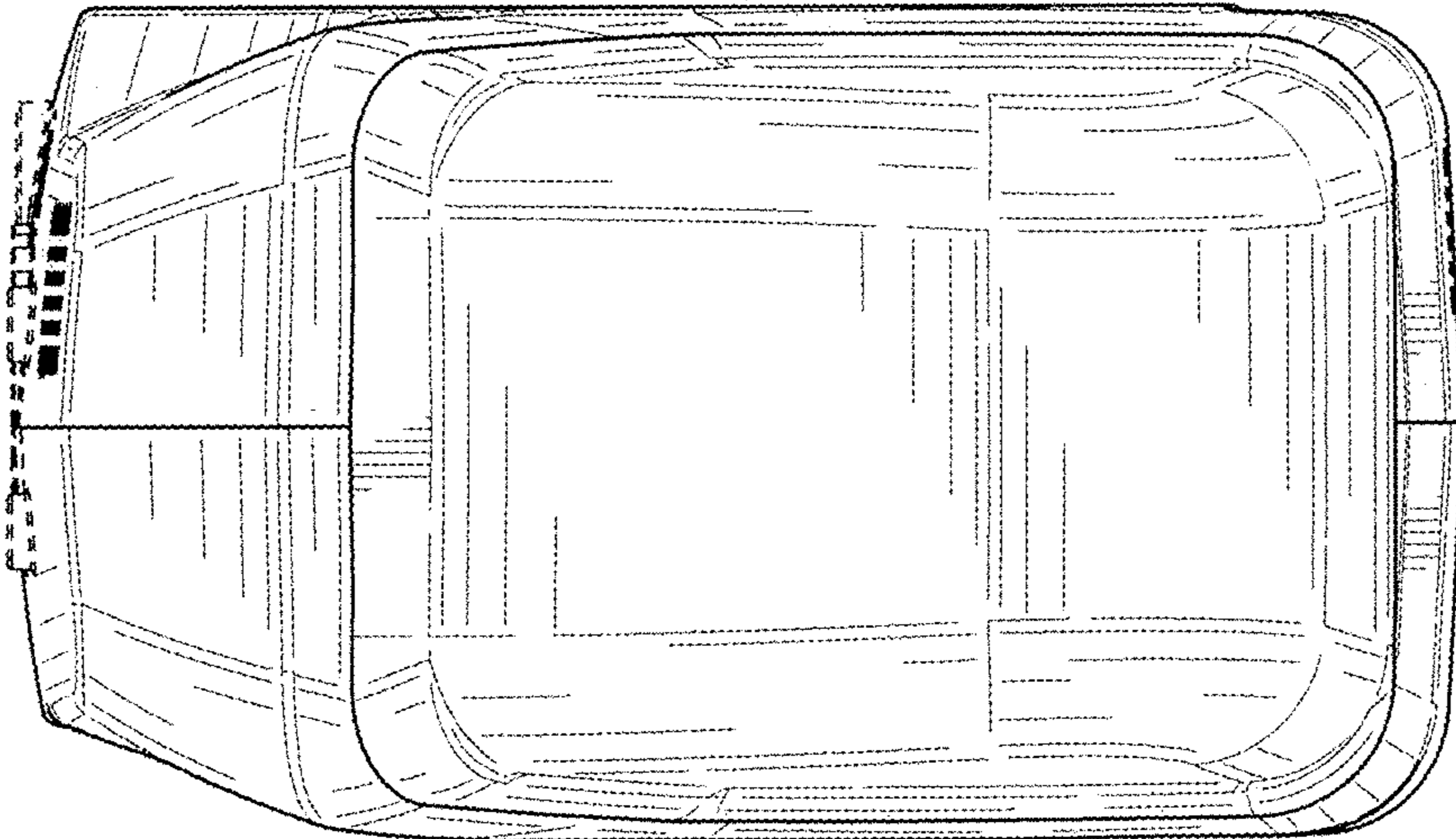

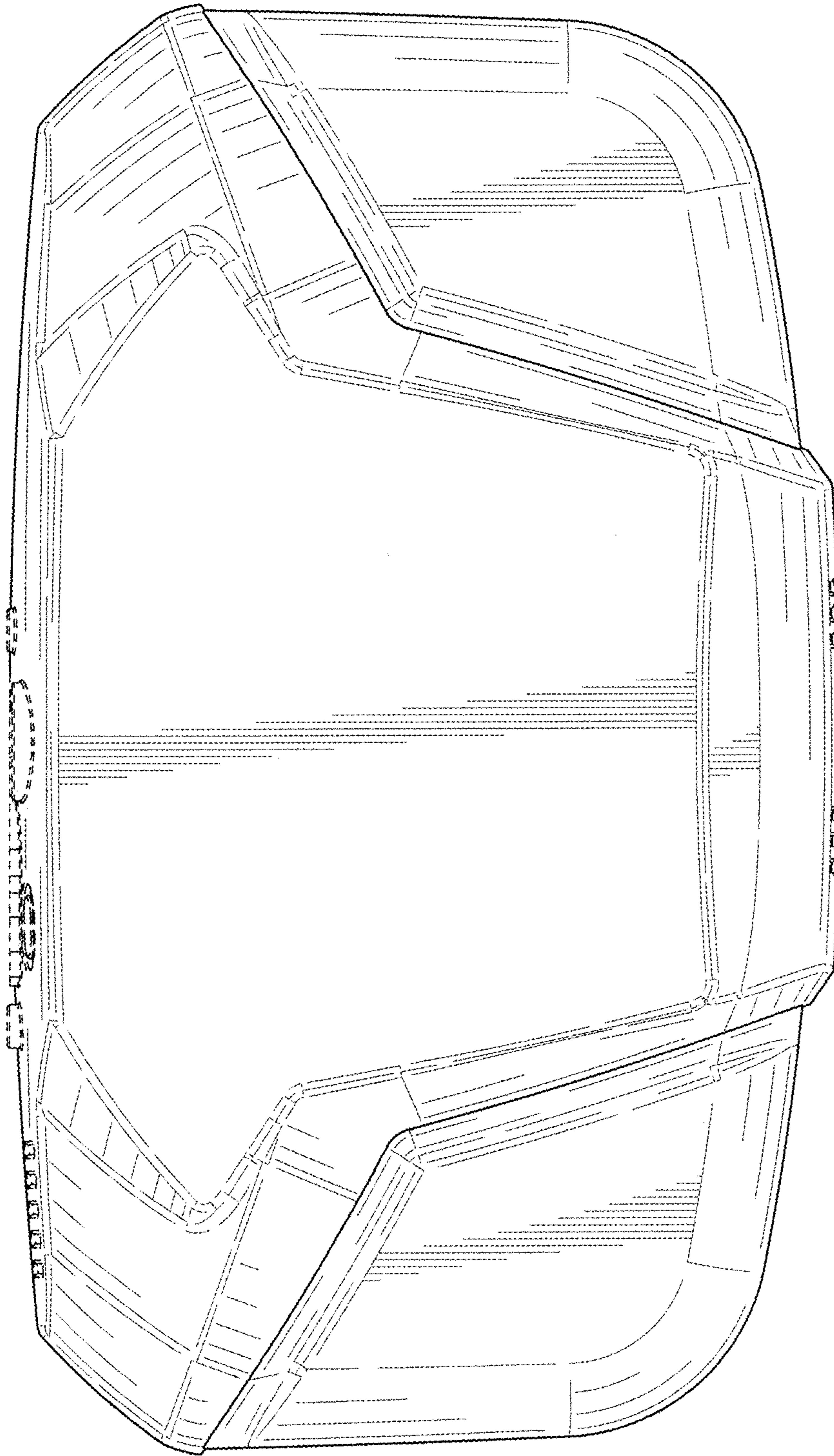

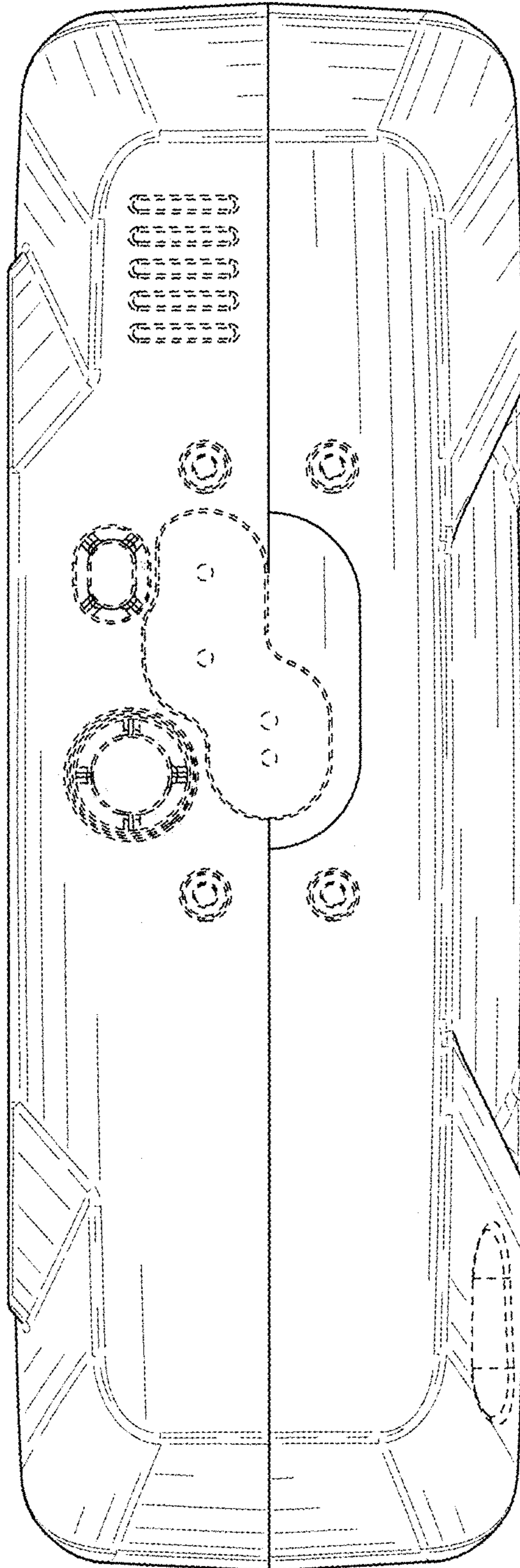

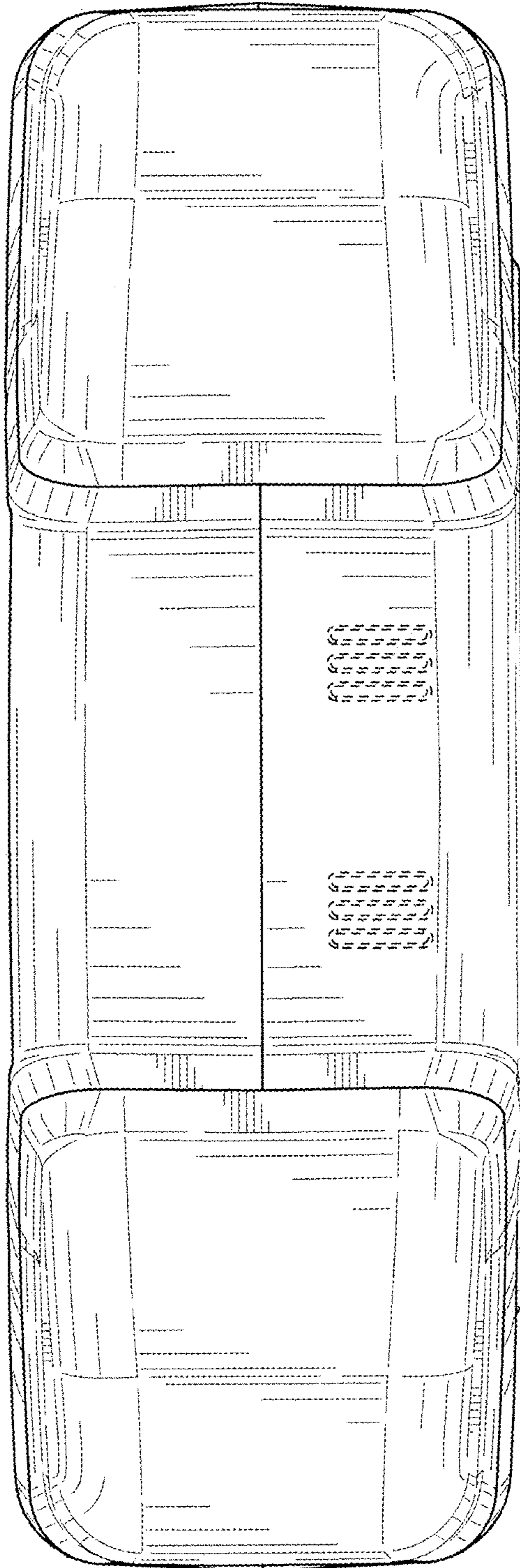
