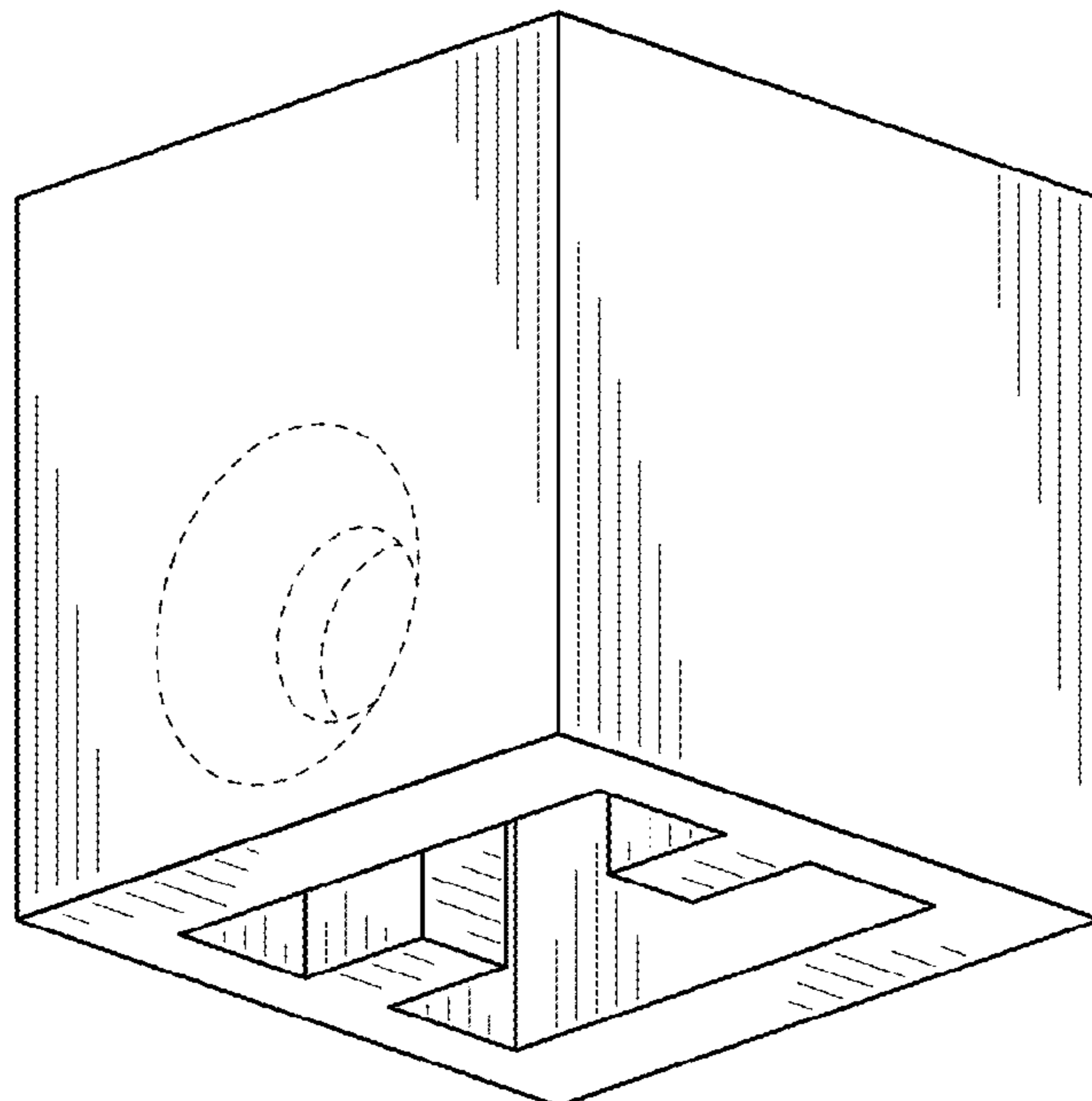
The ornamental design for a connector, as shown and

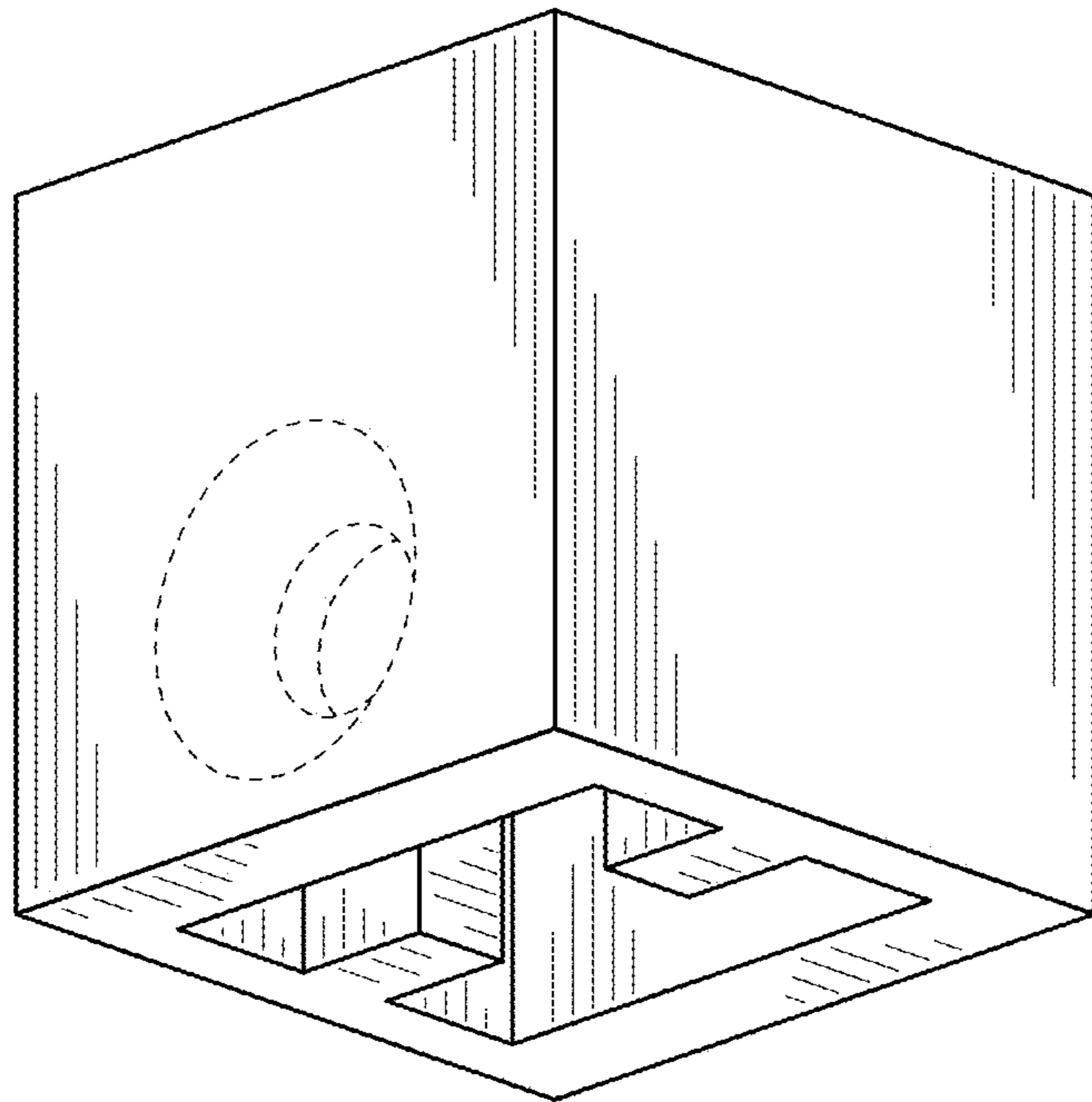

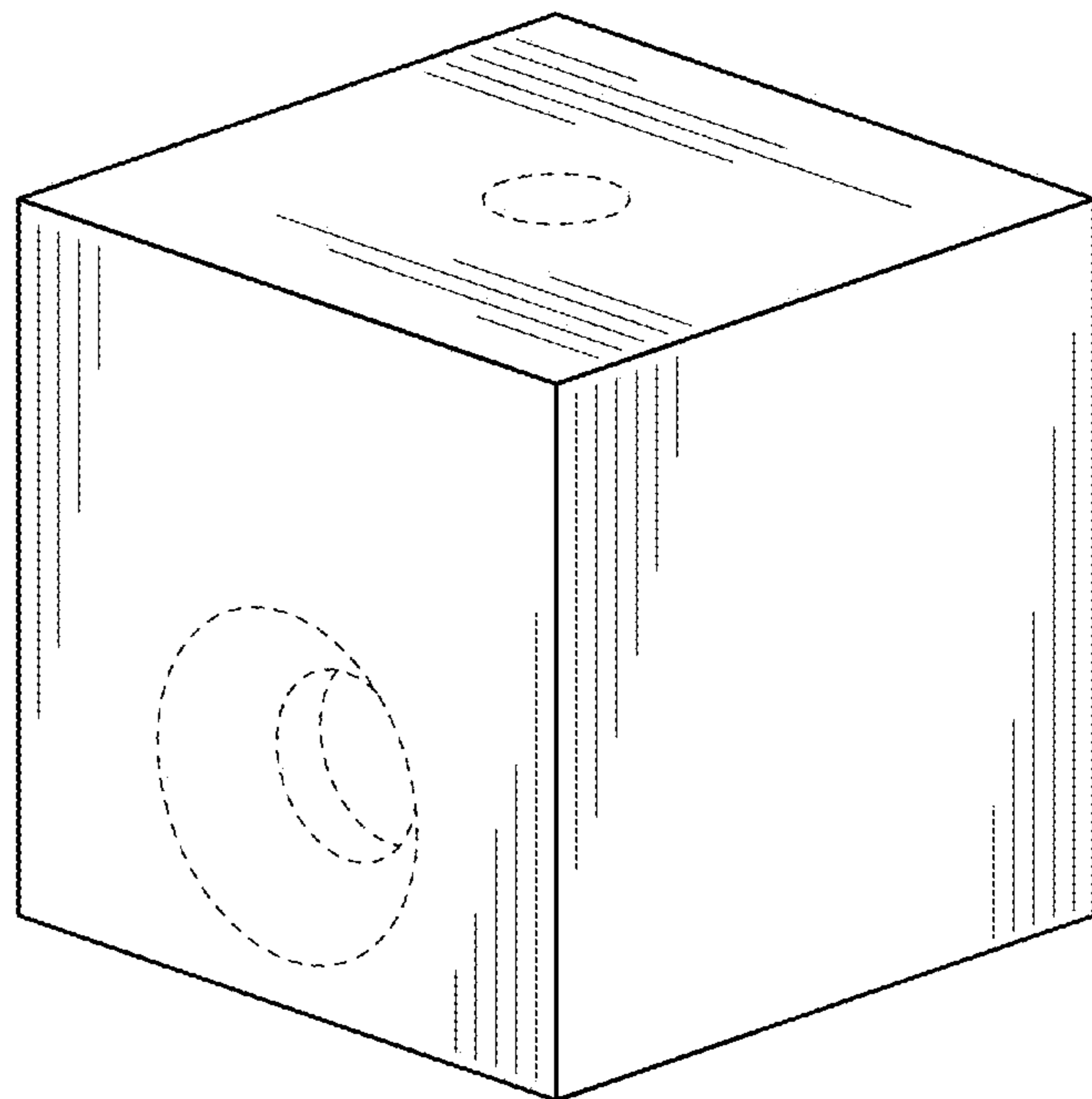

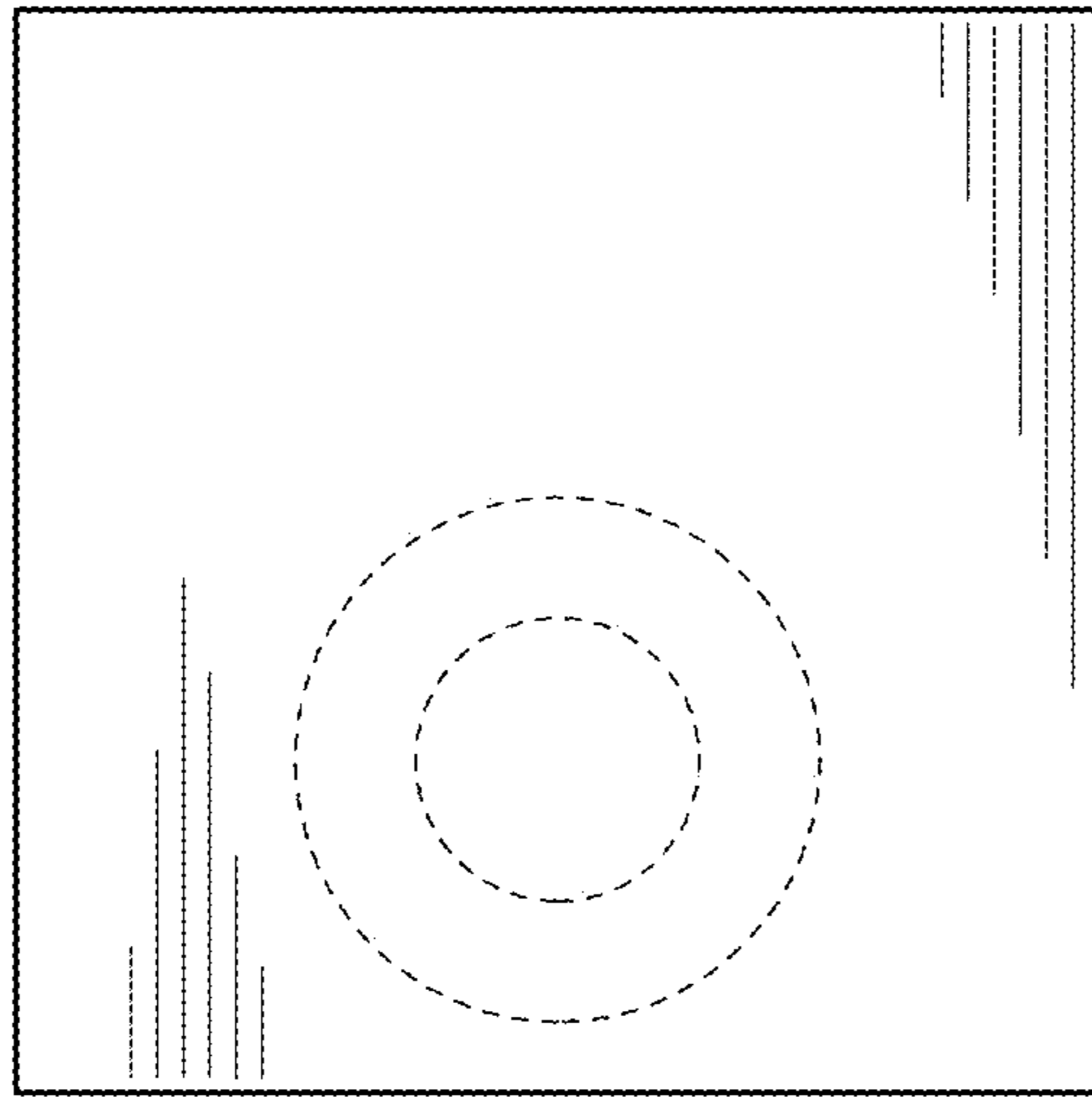

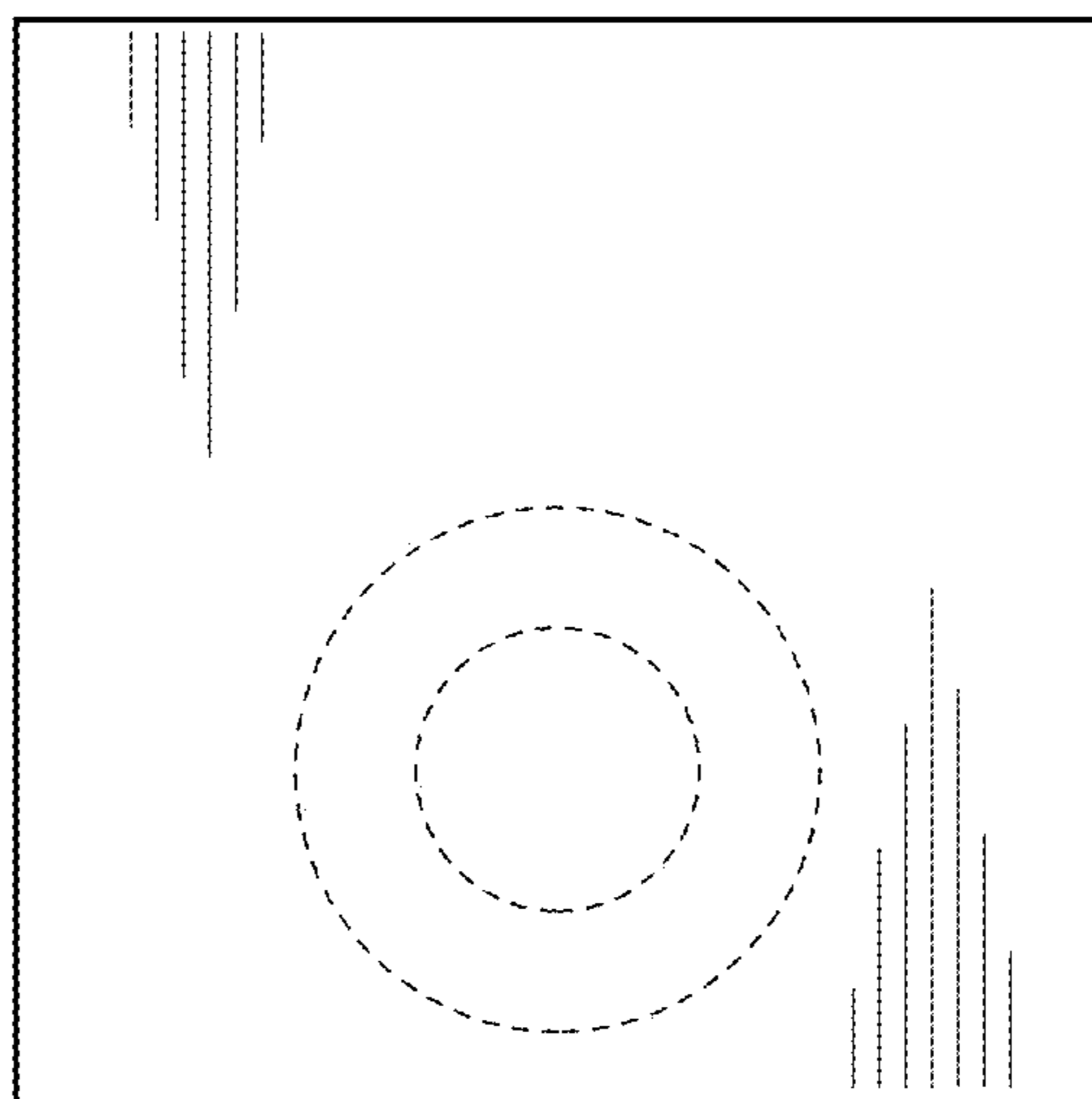

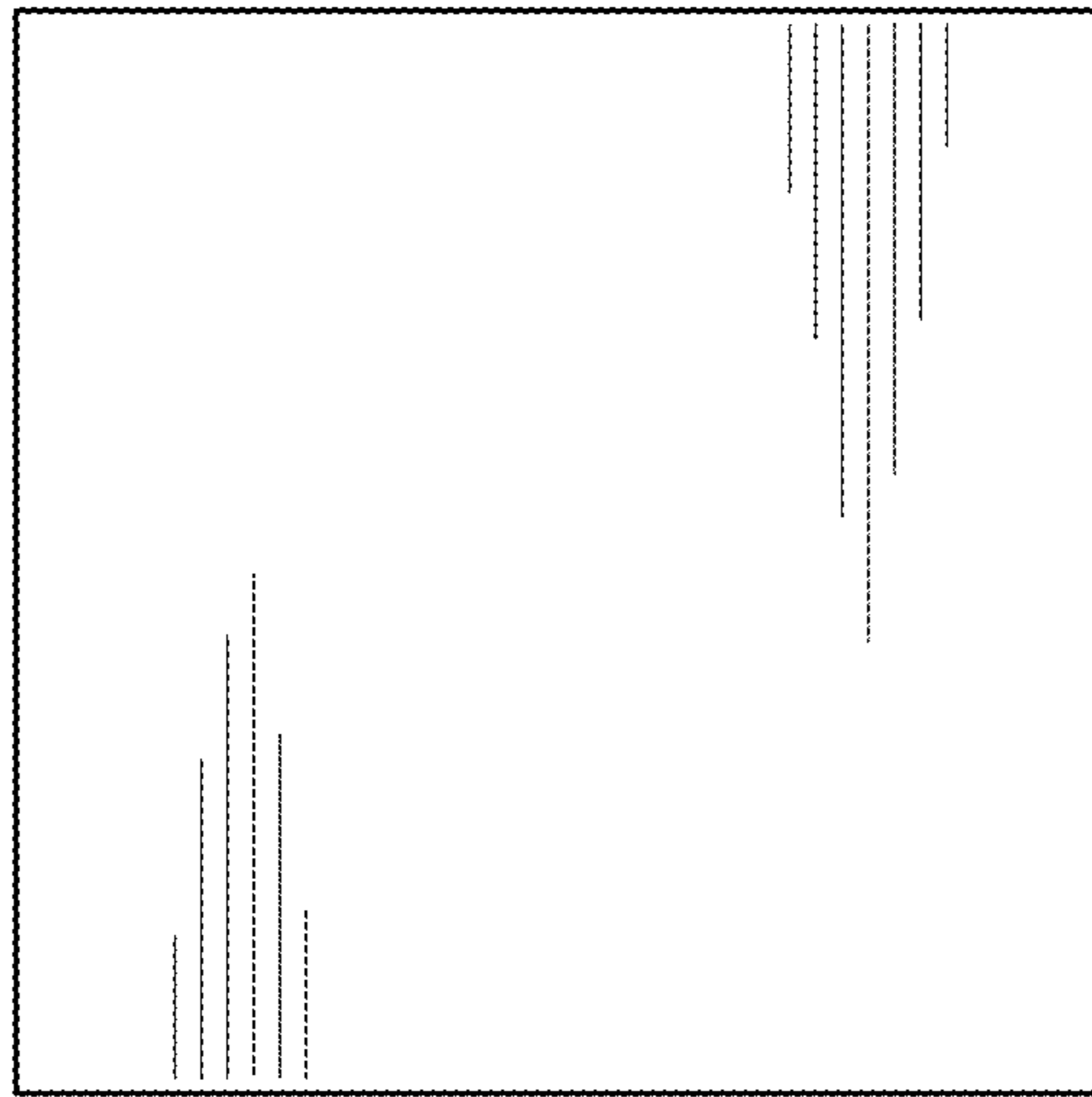

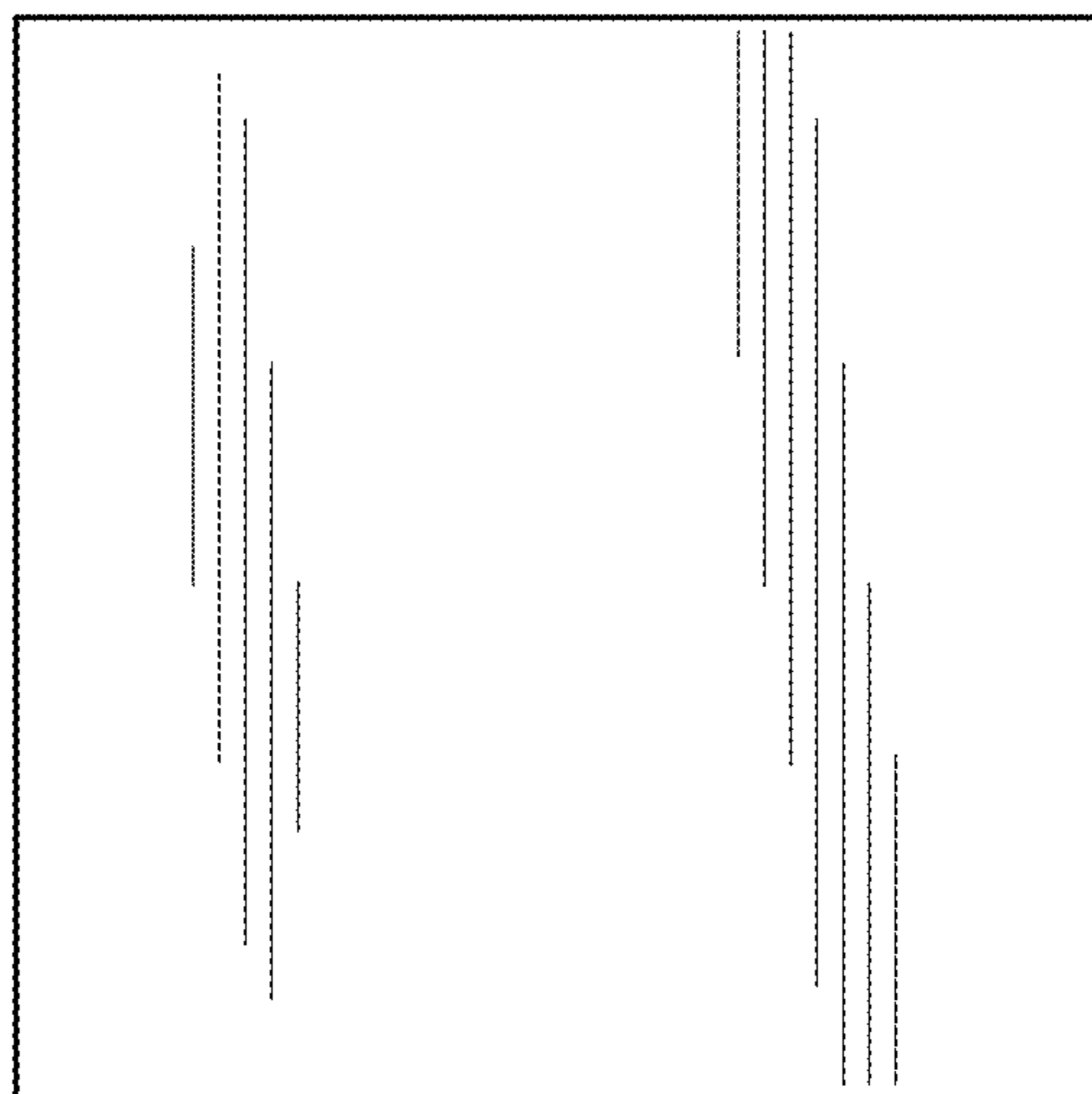

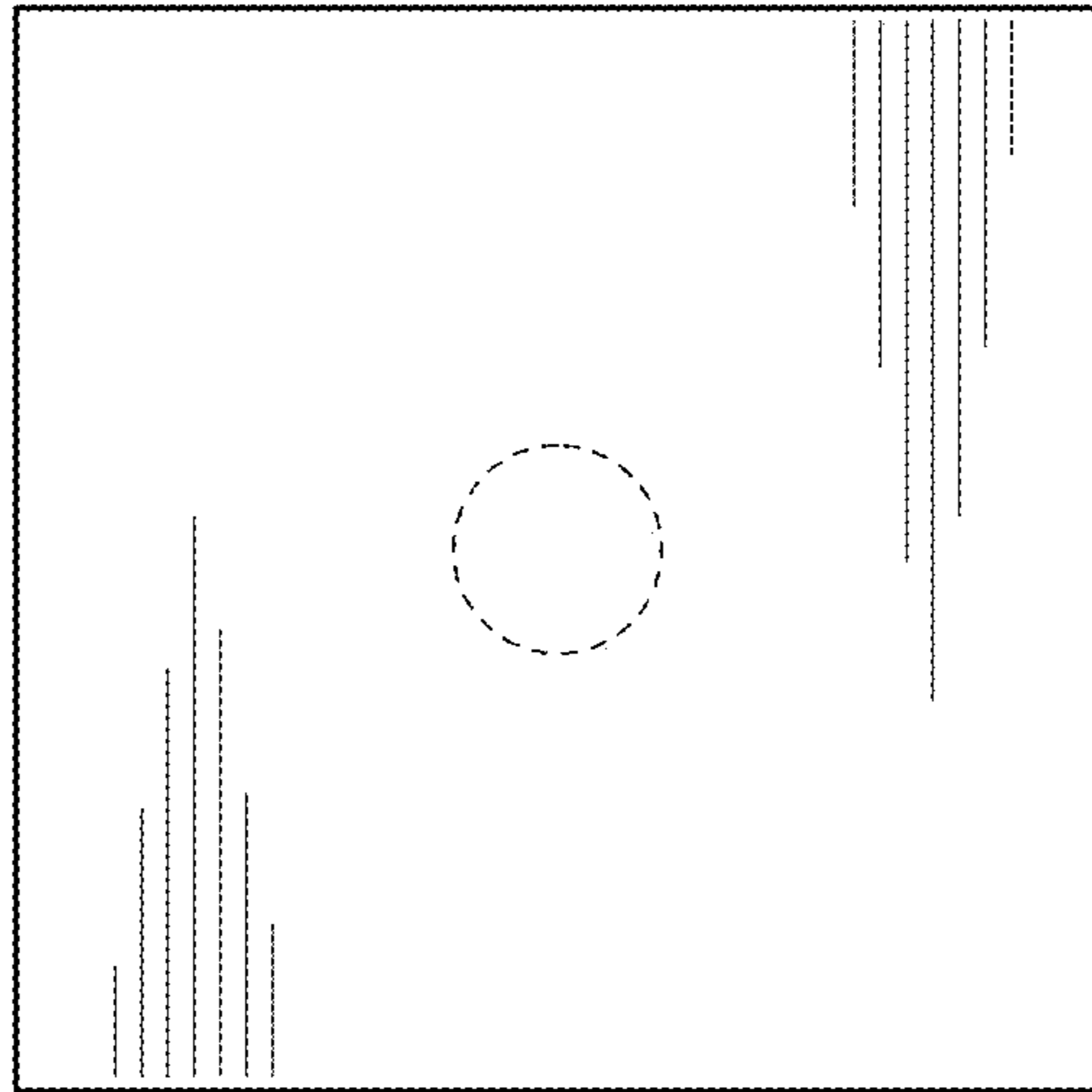

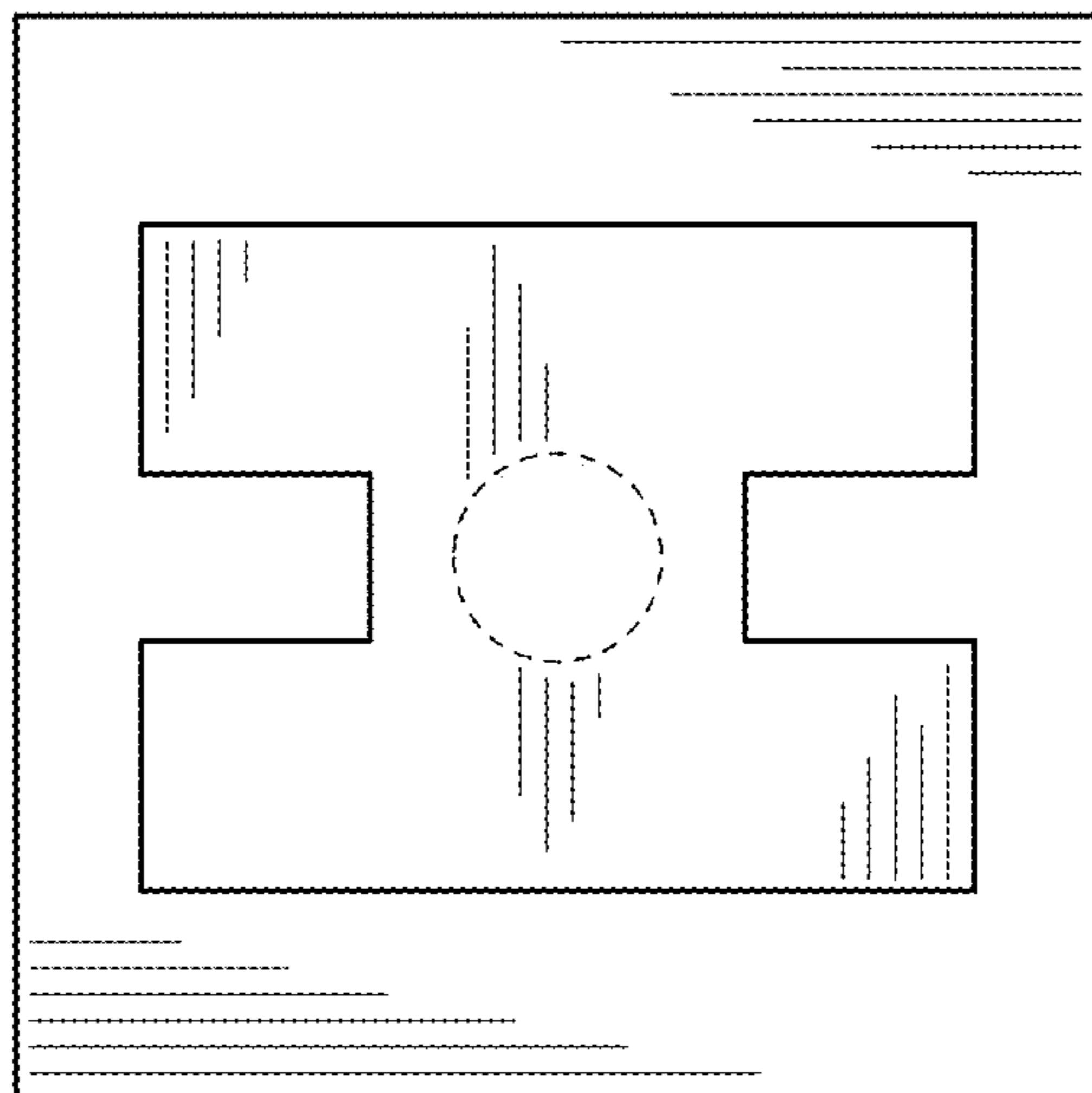
