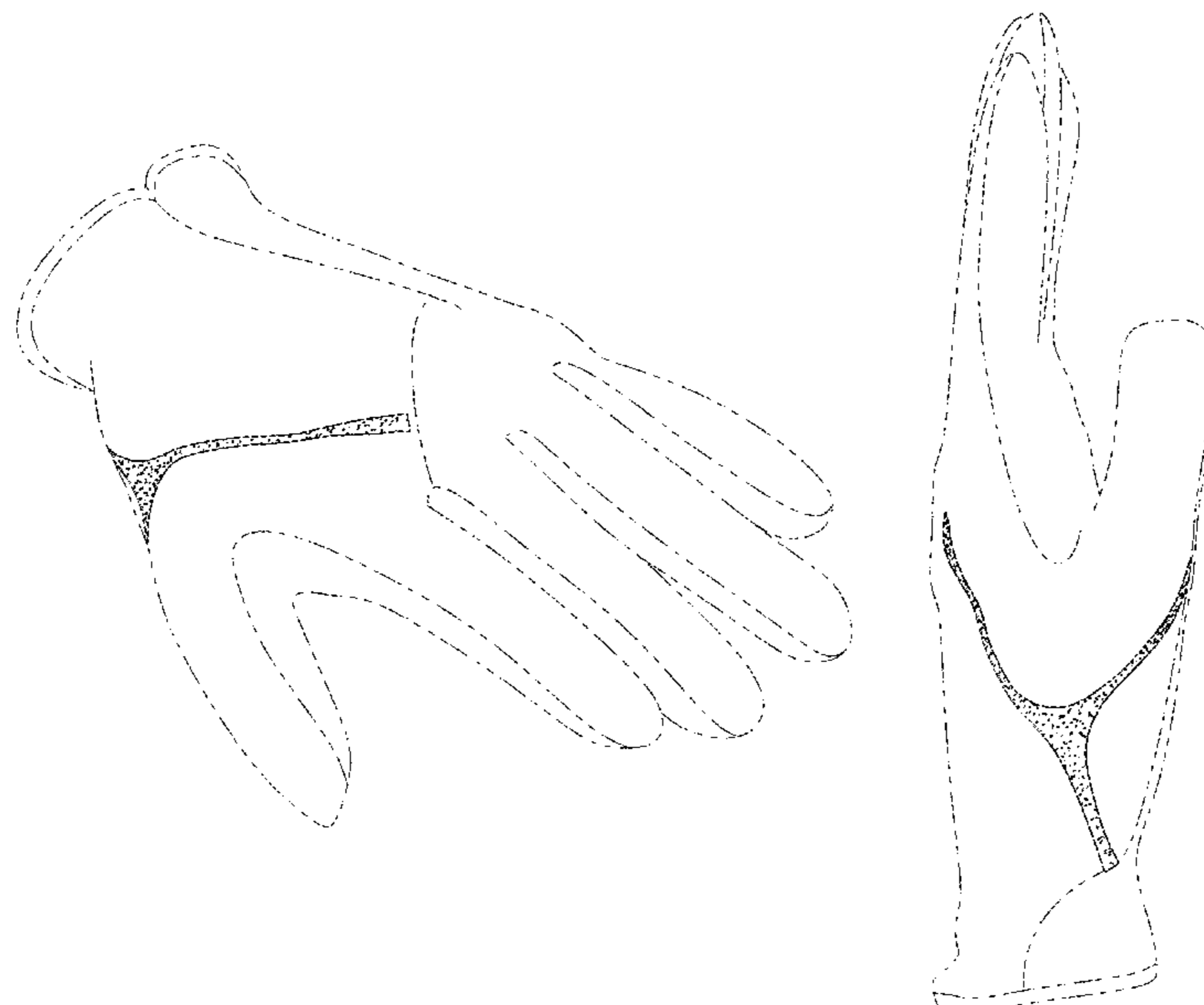
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top perspective view of the golf glove of this invention;
 FIG. 2 is an elevation view of an open wrist end portion of the golf glove of this invention;
 FIG. 3 is a plan view of a back portion of the golf glove of this invention;
 FIG. 4 is a medial side elevation view of the golf glove of this invention; and,
 FIG. 5 is a plan view of a front portion of the golf glove of this invention.
 The dash-dot-dot broken lines show portions of the golf glove and form no part of the claimed design.

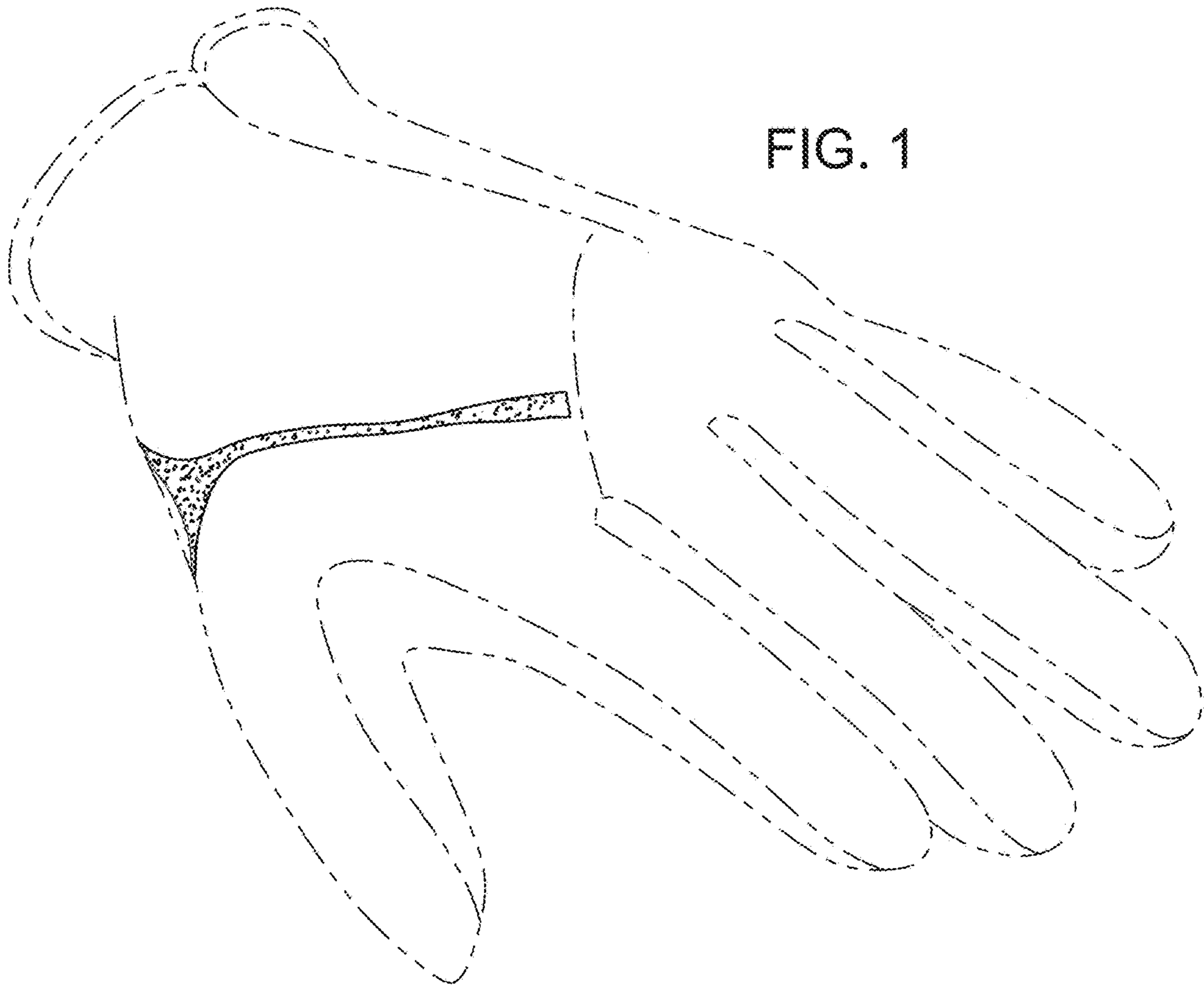

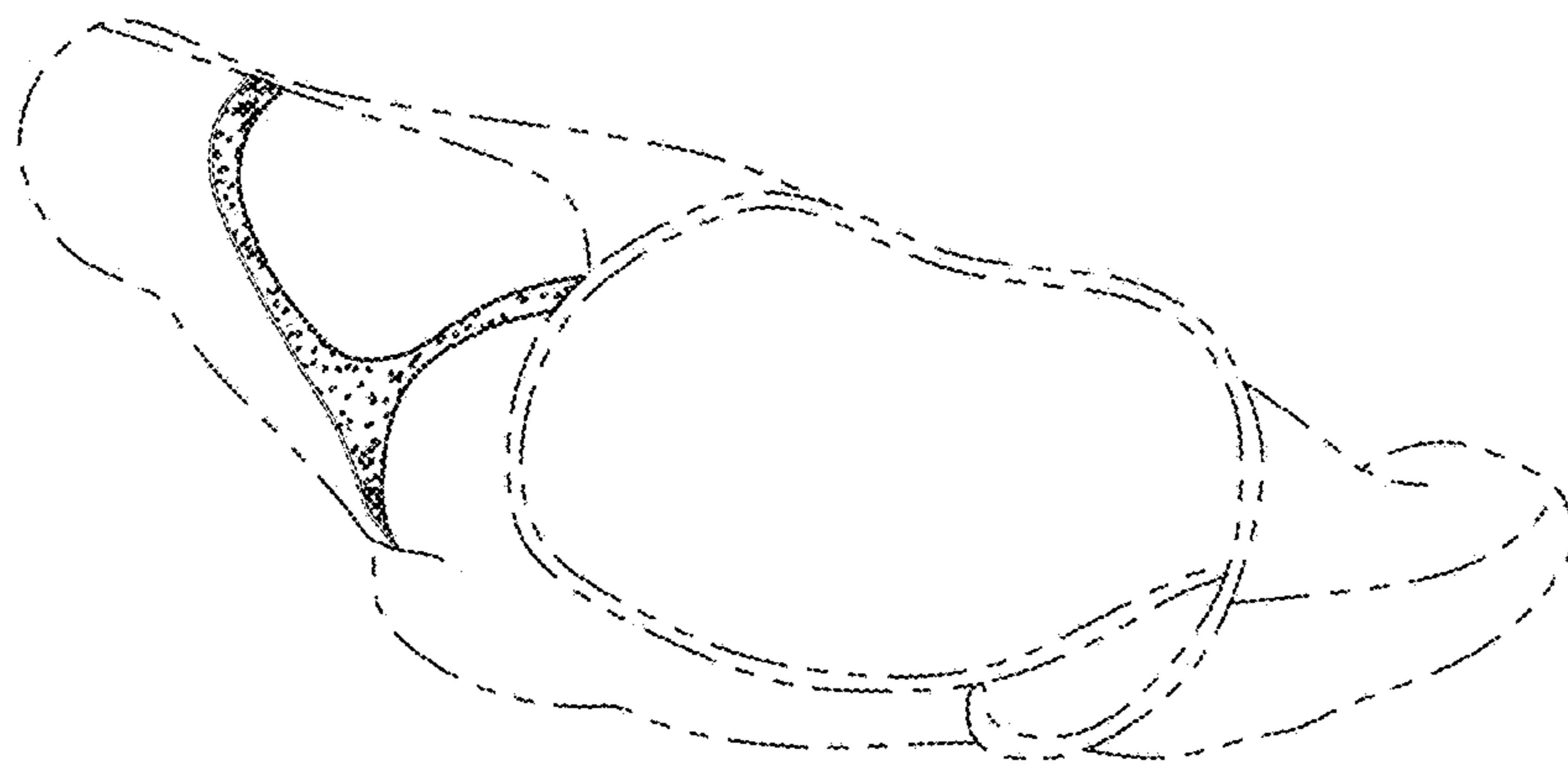

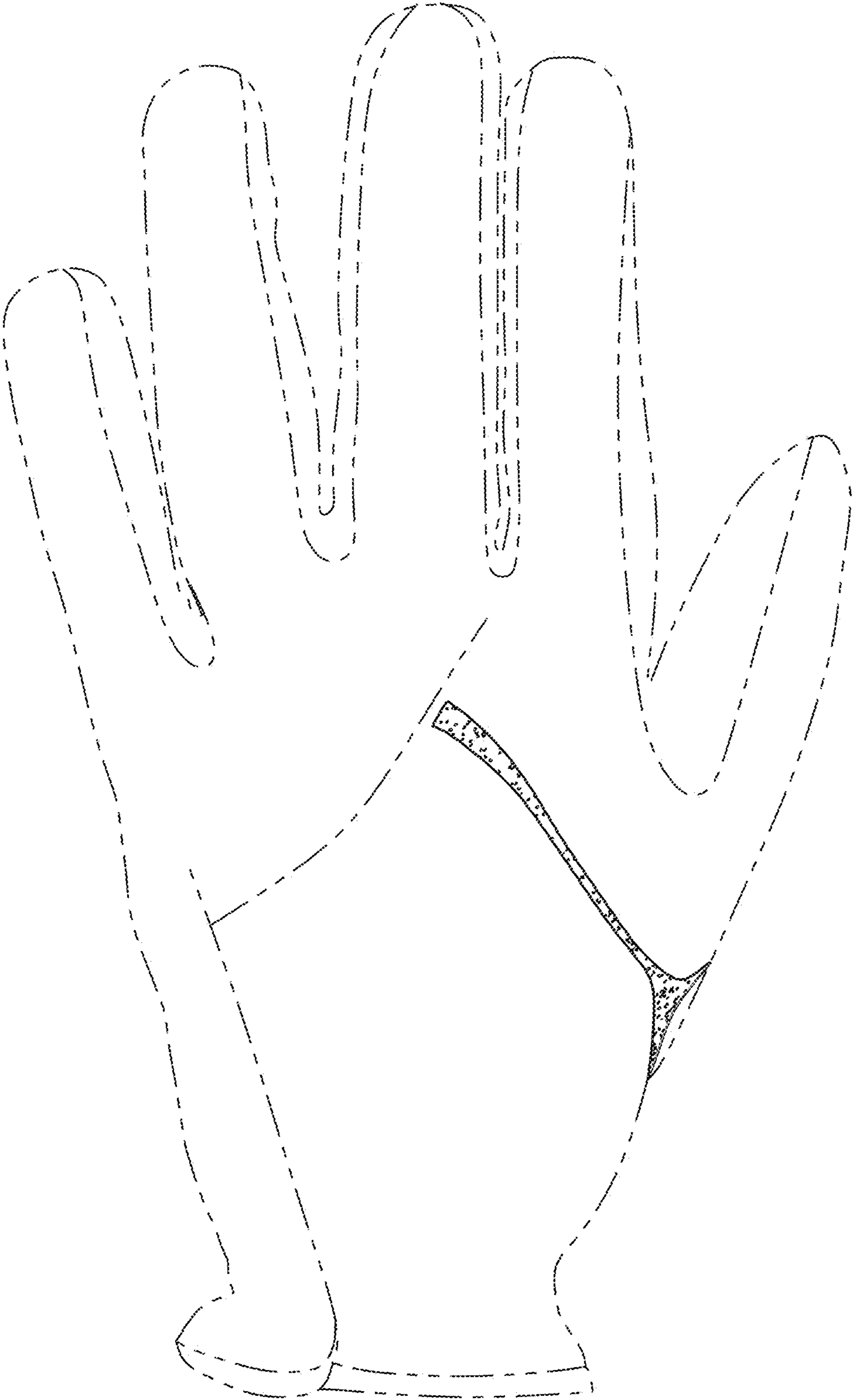

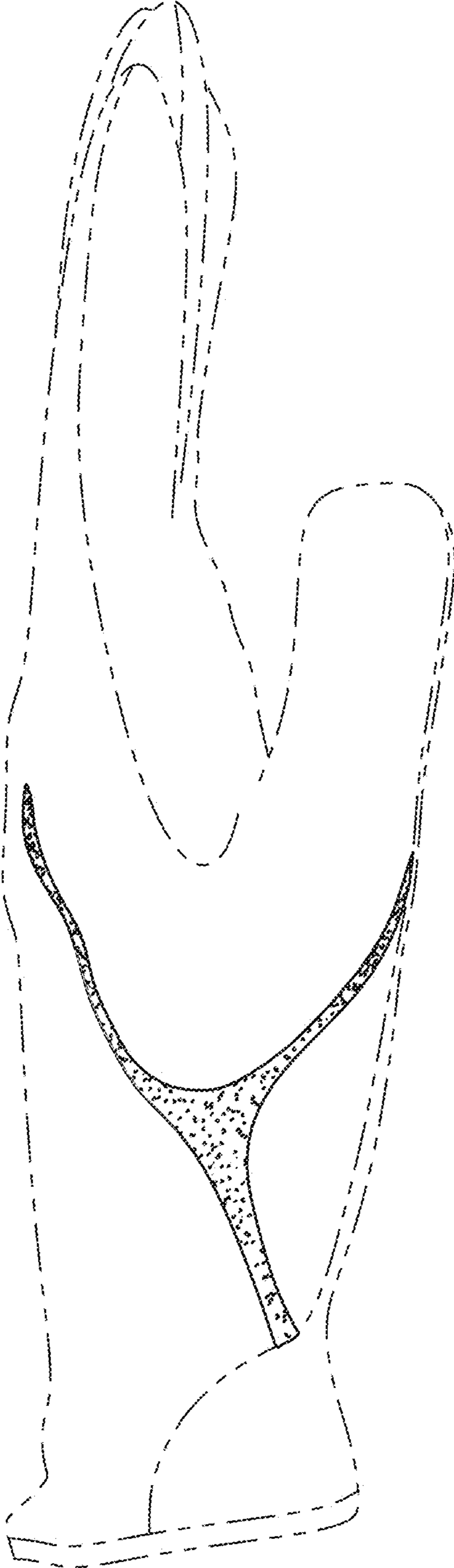

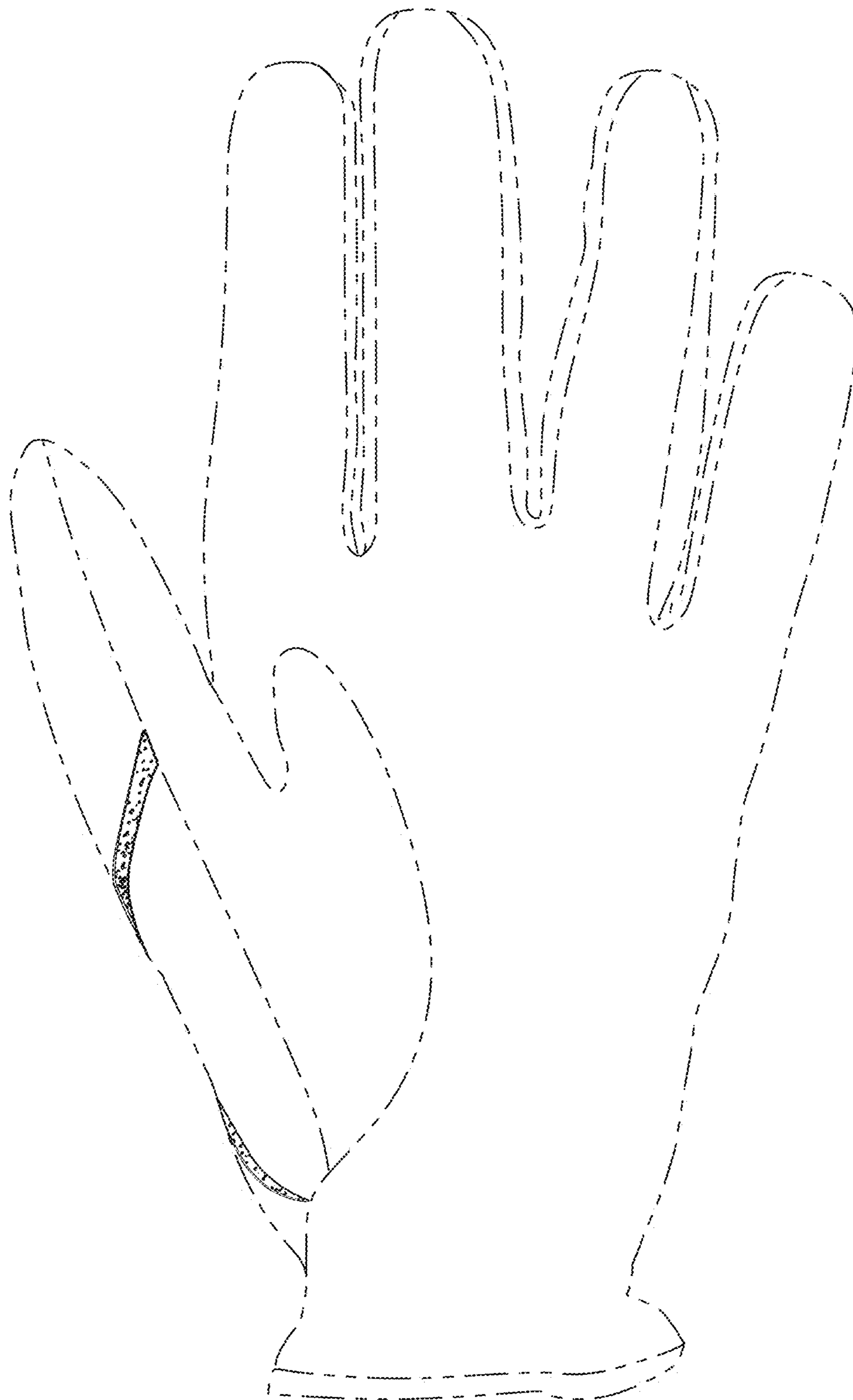
