**DESCRIPTION**

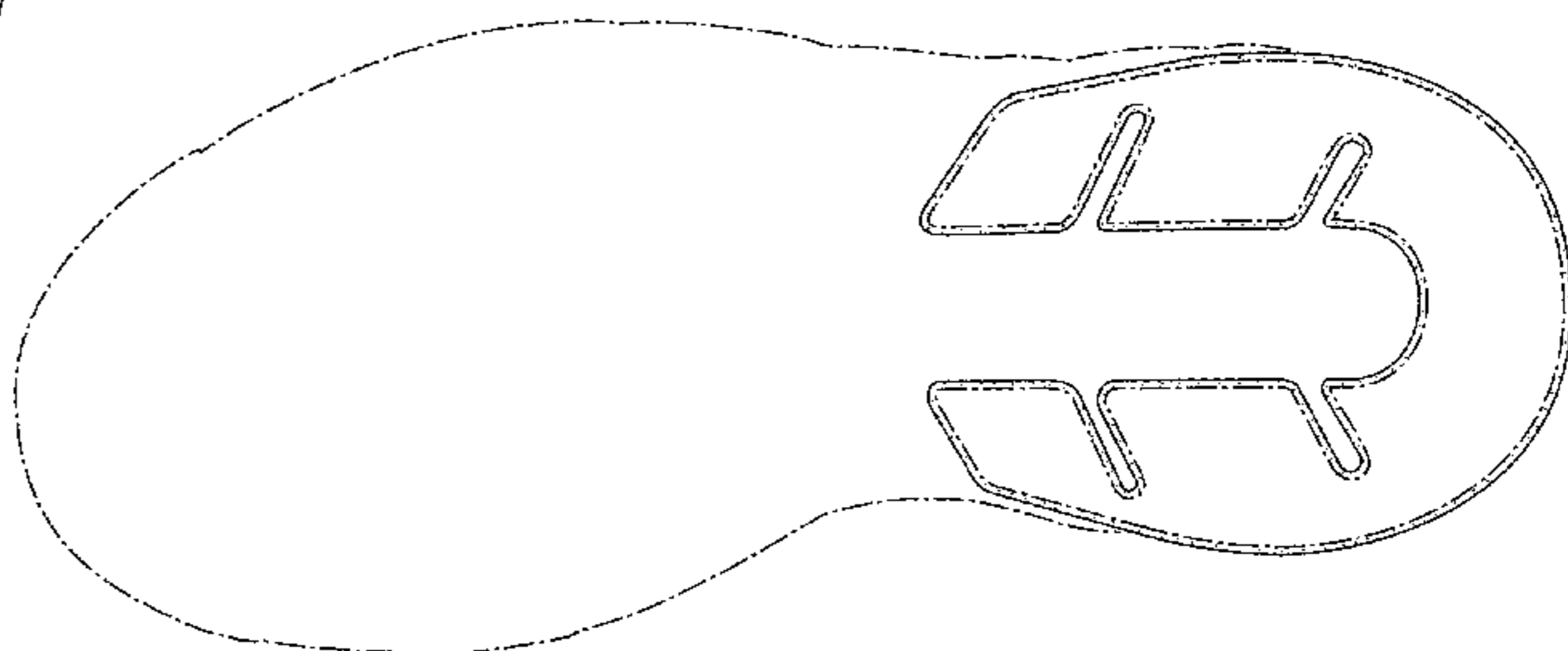
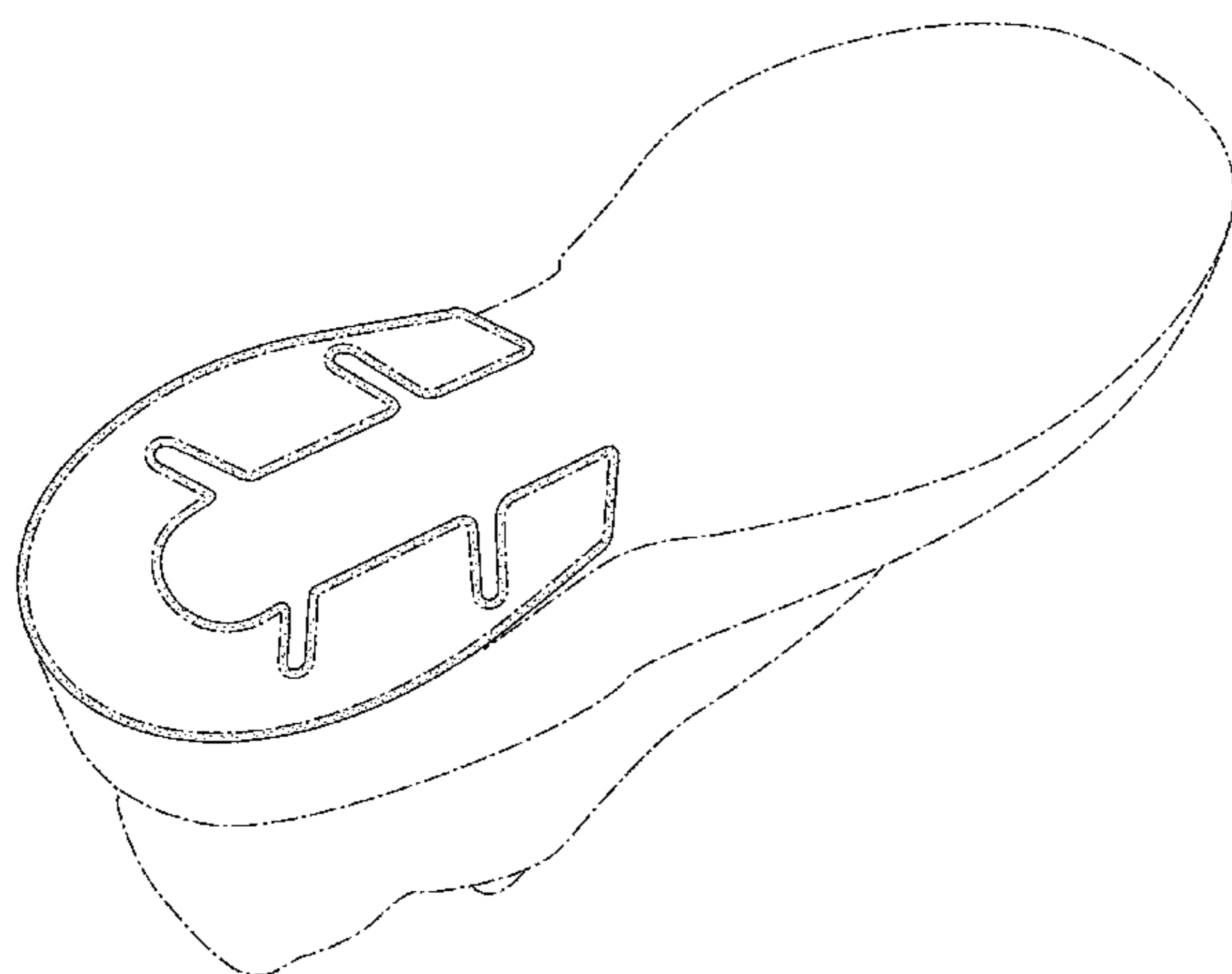
FIG. 1 is a rear perspective view of a shoe showing our new design;

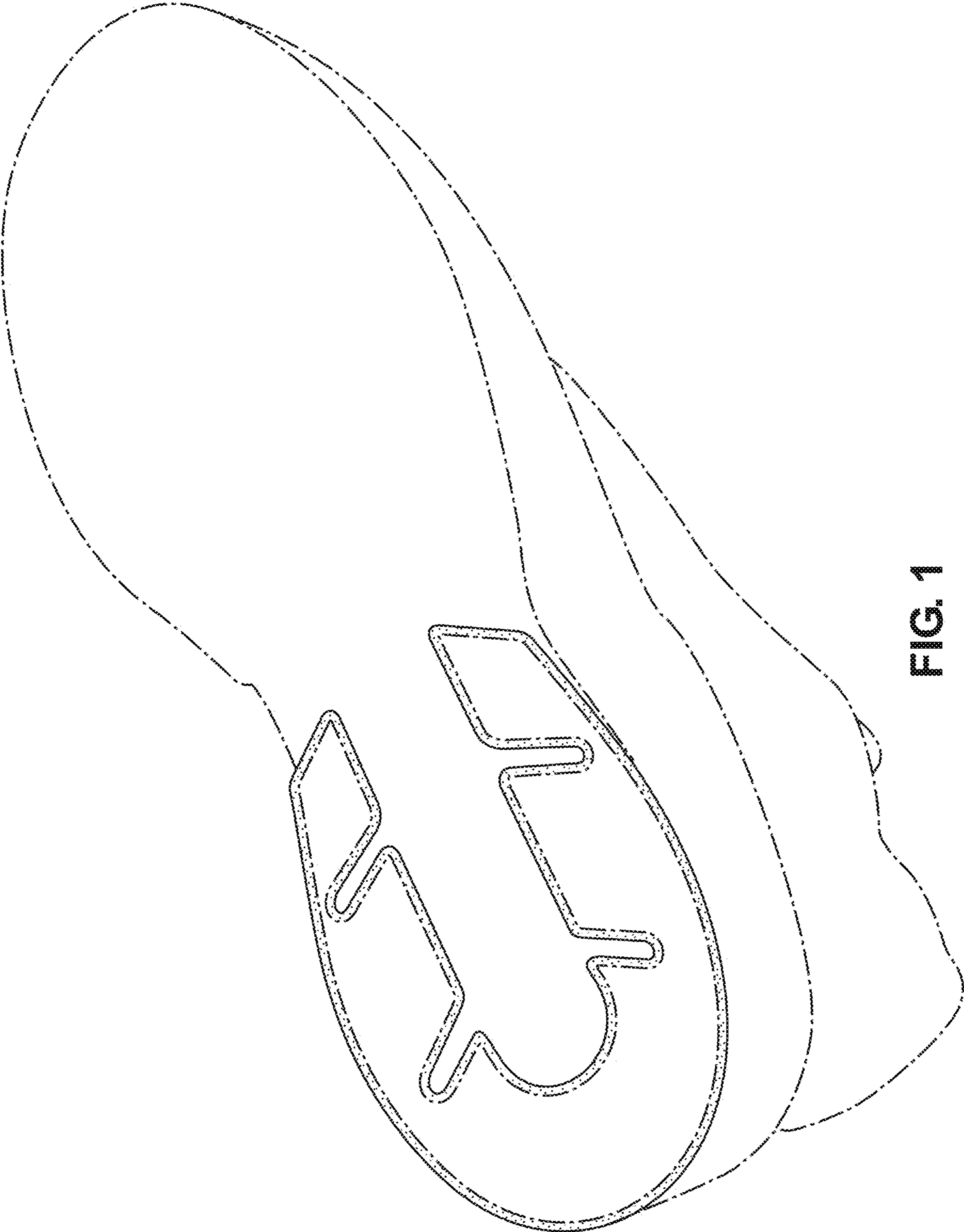

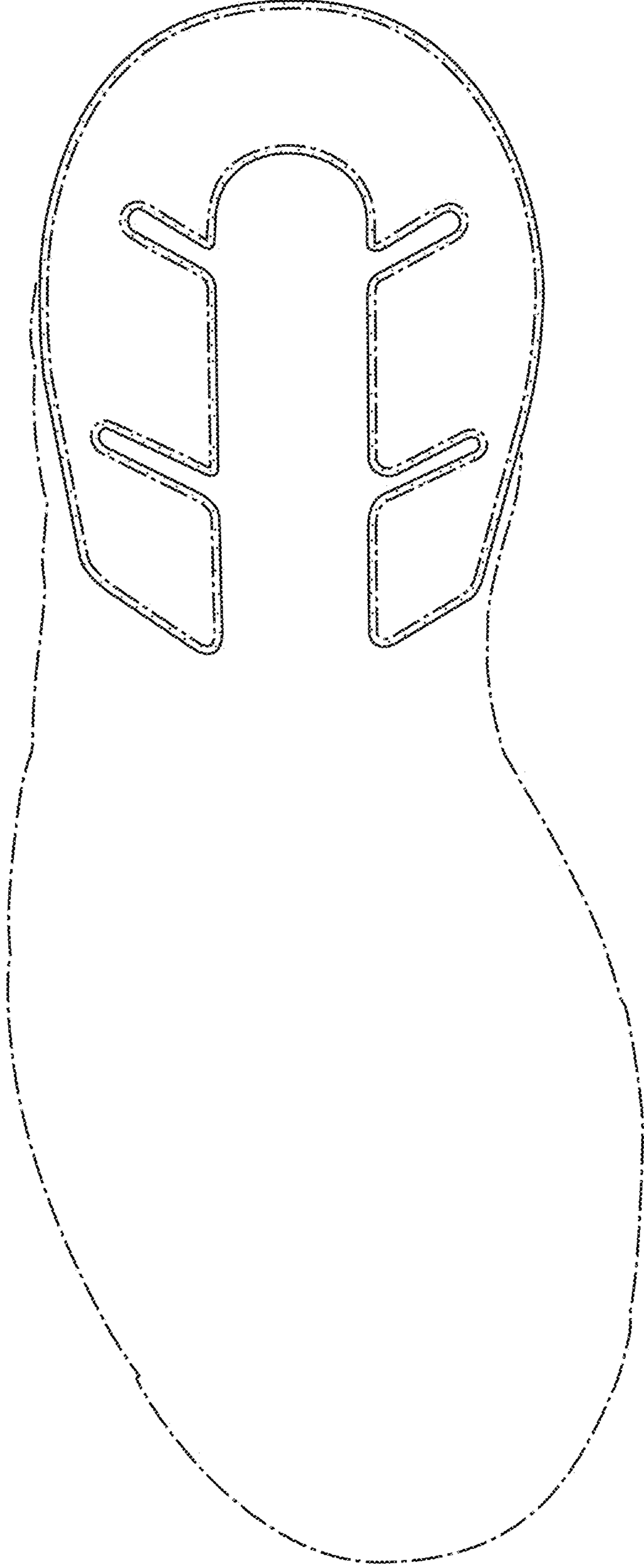

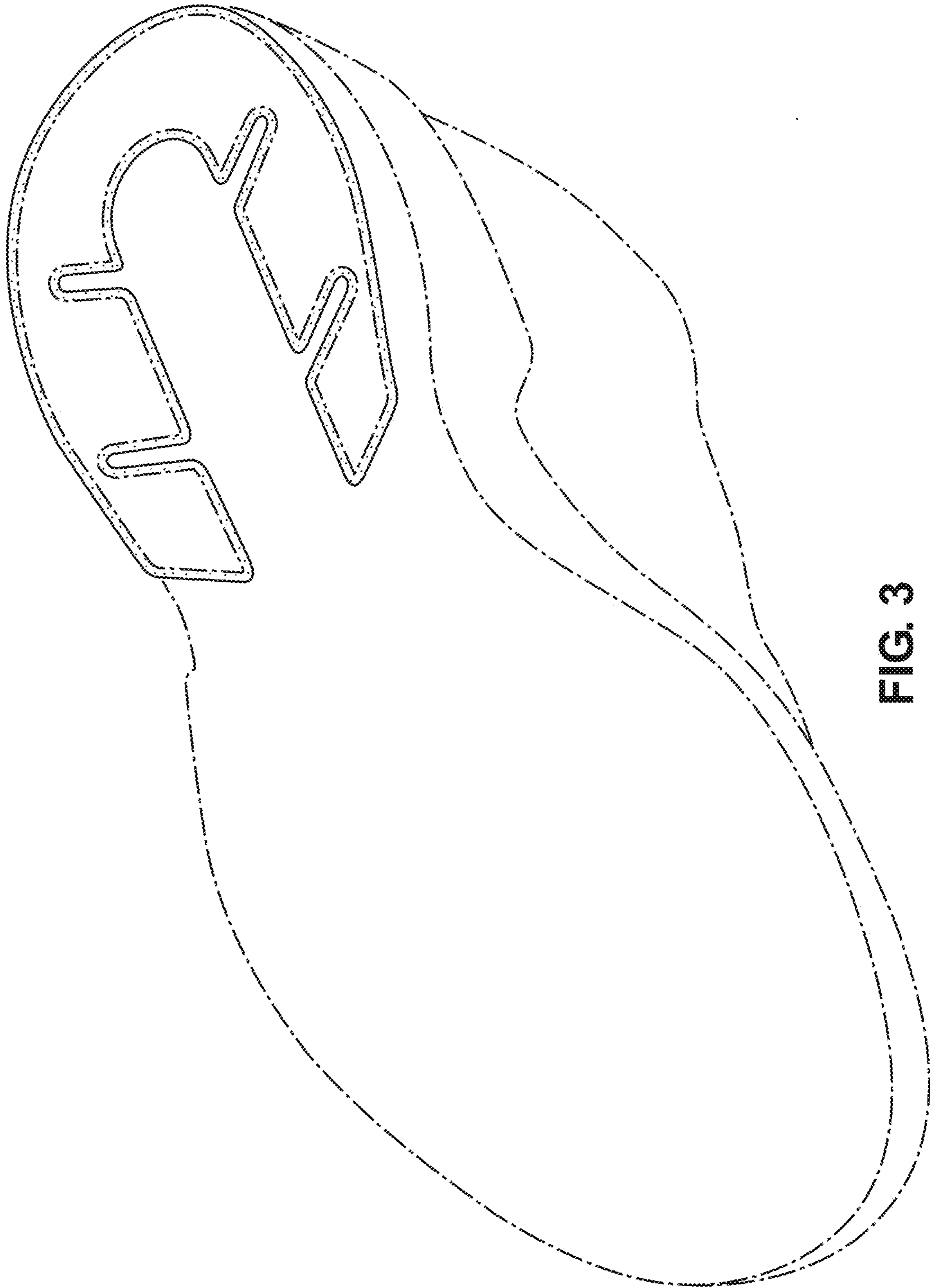
