(57) **CLAIM**

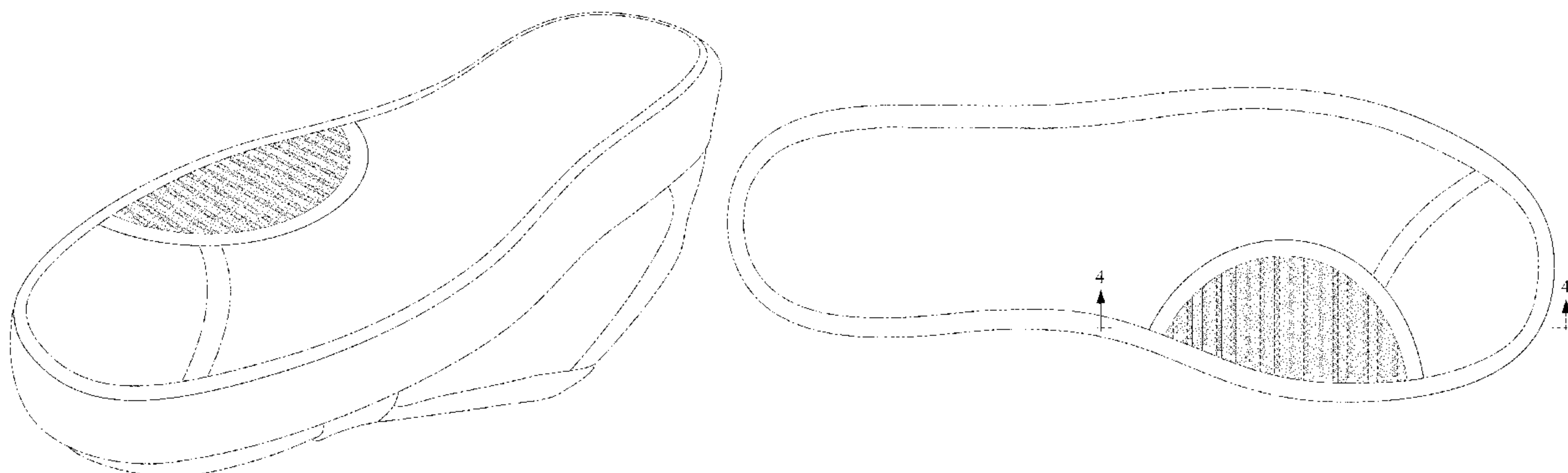
The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing my new design;
FIG. 2 is a bottom view thereof;
FIG. 3 is a rear perspective view thereof; and,
FIG. 4 is a cross section taken through line 4-4 of FIG. 2.
The broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof. The solid lines that are not immediately adjacent to the shaded area are claimed. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

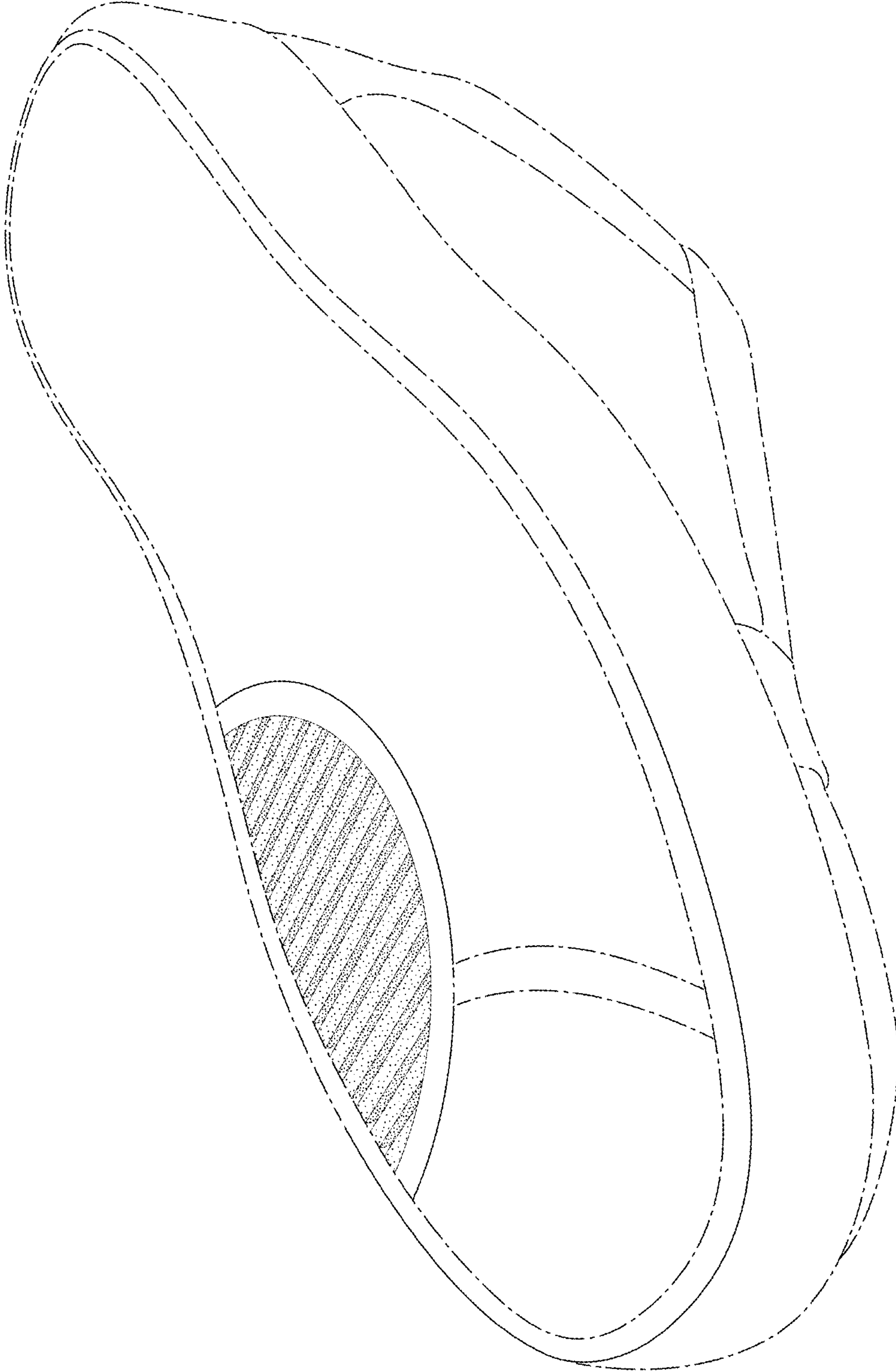

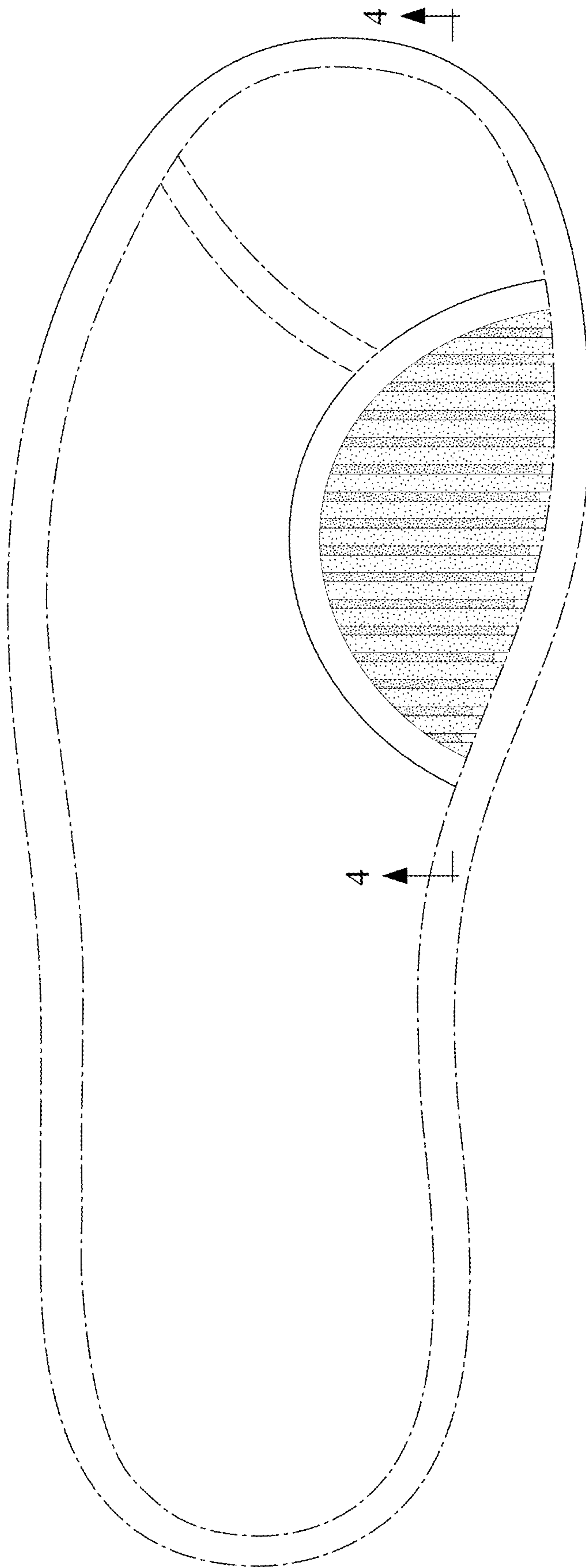

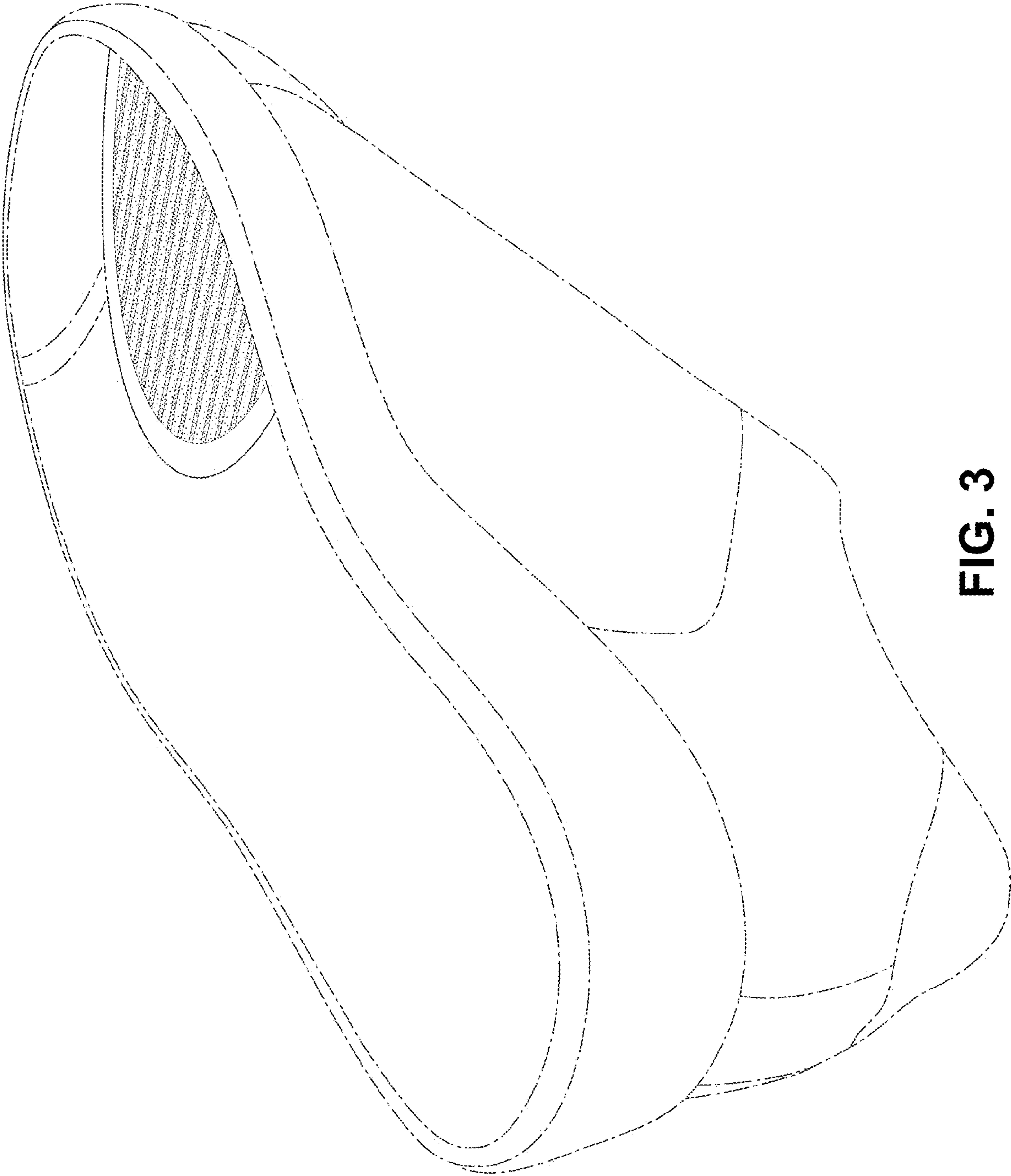

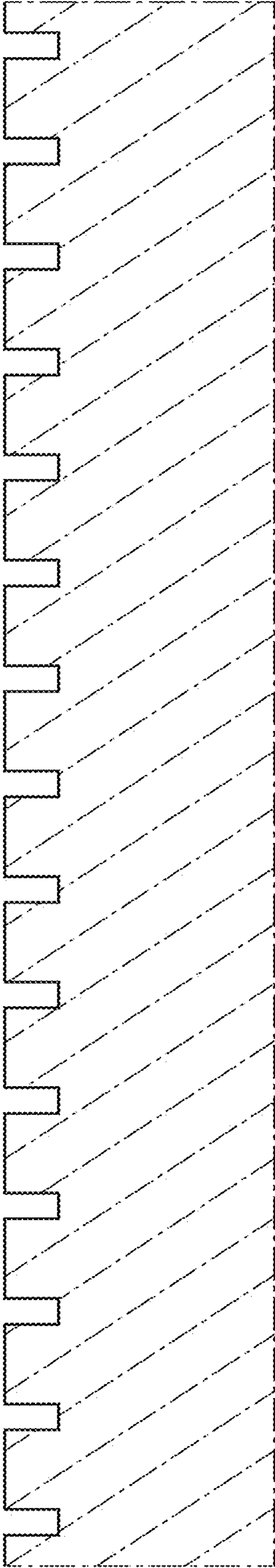
