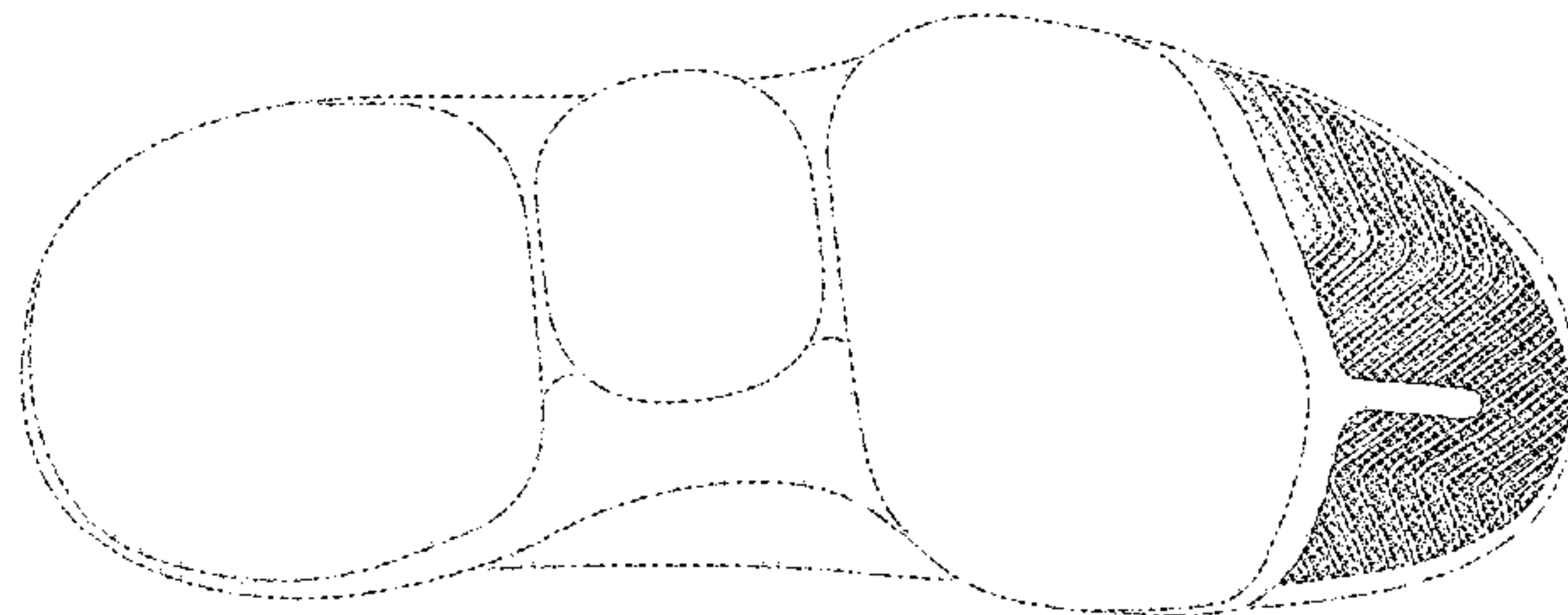
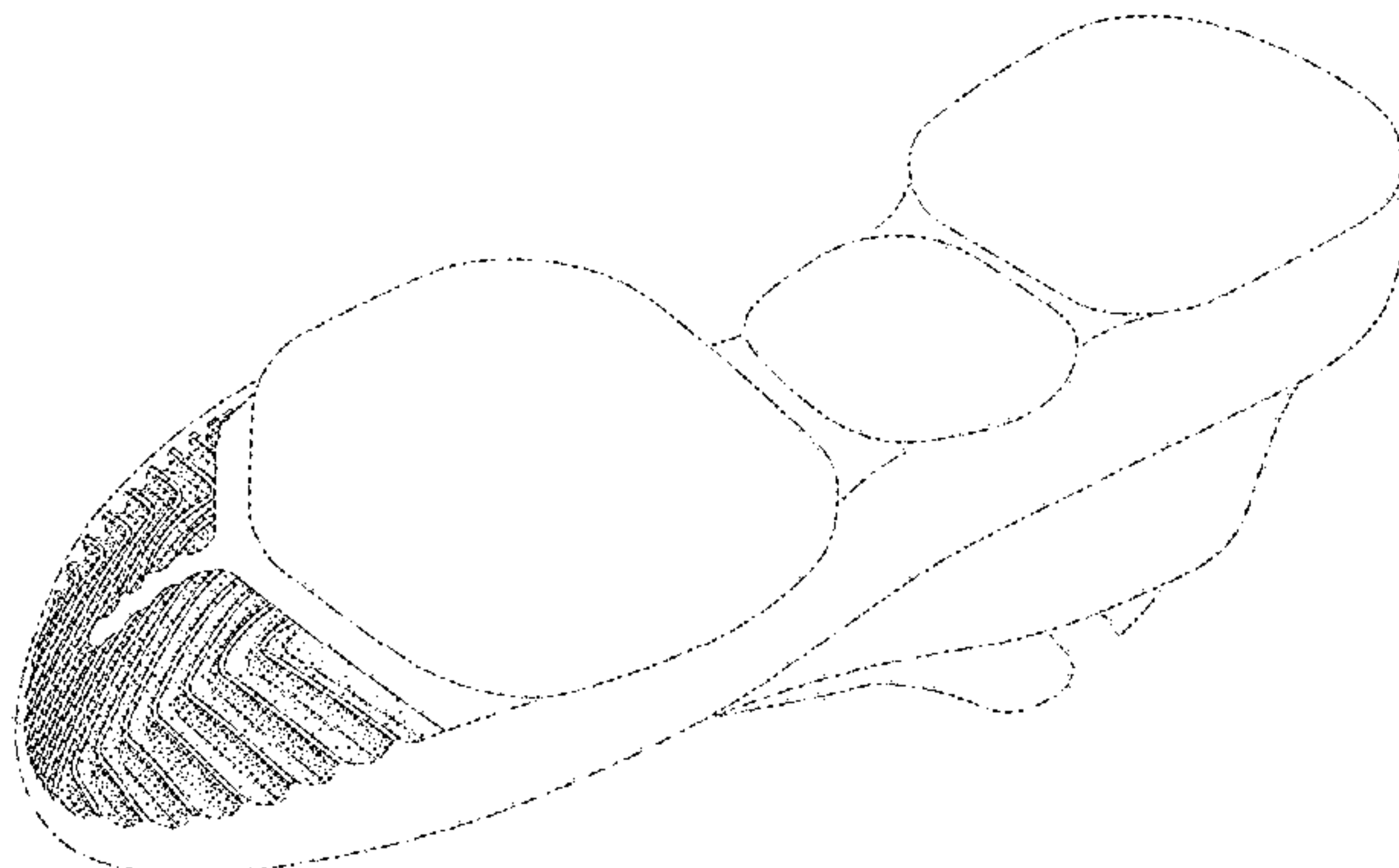
The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing my new design;
FIG. 2 is a bottom view thereof;
FIG. 3 is a rear perspective view thereof;
FIG. 4 is a second front perspective view thereof;
FIG. 5 is an enlarged view of FIG. 1 with environment removed for clarity;
FIG. 6 is an enlarged view of FIG. 2 with environment removed for clarity;
FIG. 7 is an enlarged view of FIG. 3 with environment removed for clarity; and,
FIG. 8 is an enlarged view of FIG. 4 with environment removed for clarity.
The broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

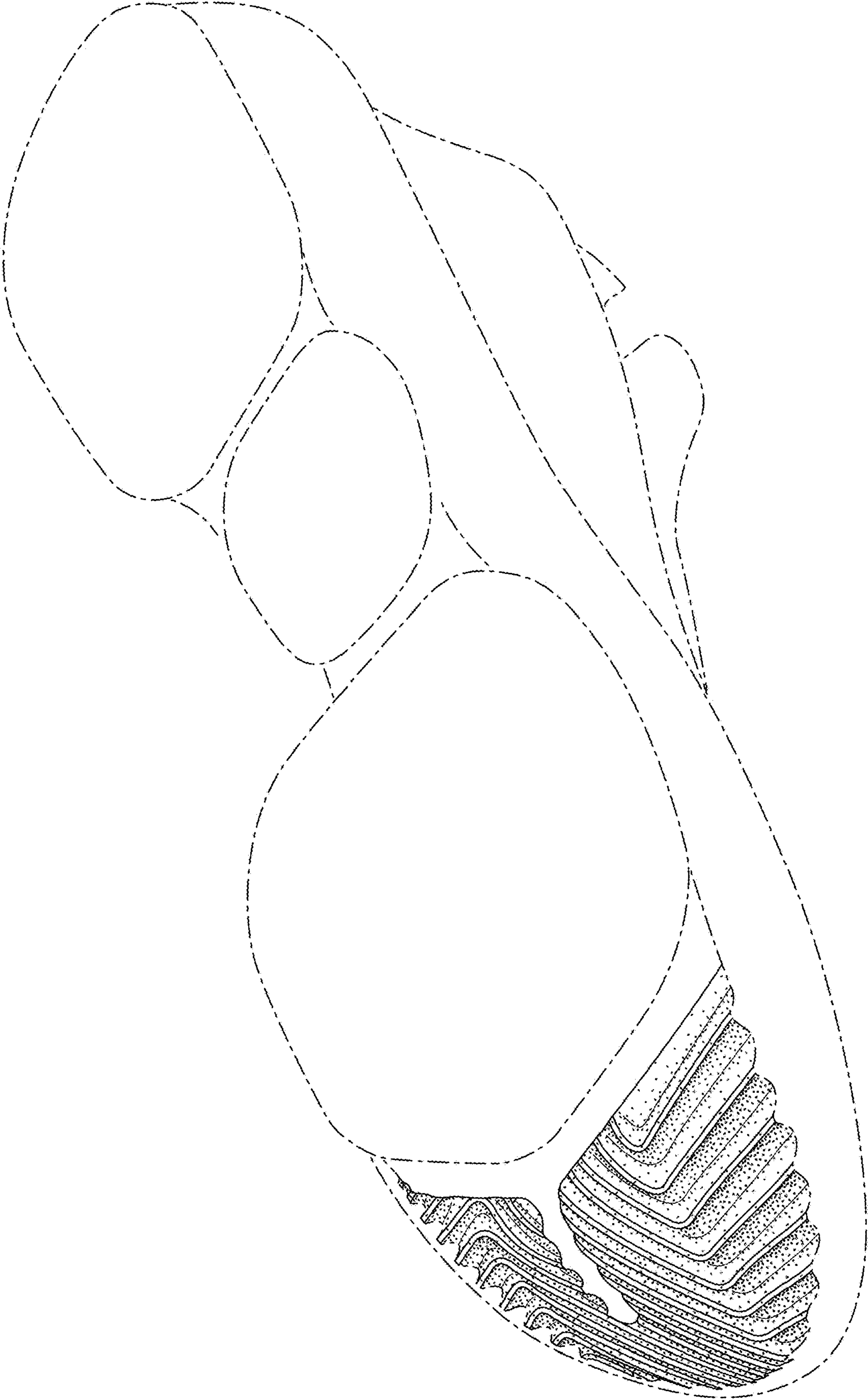

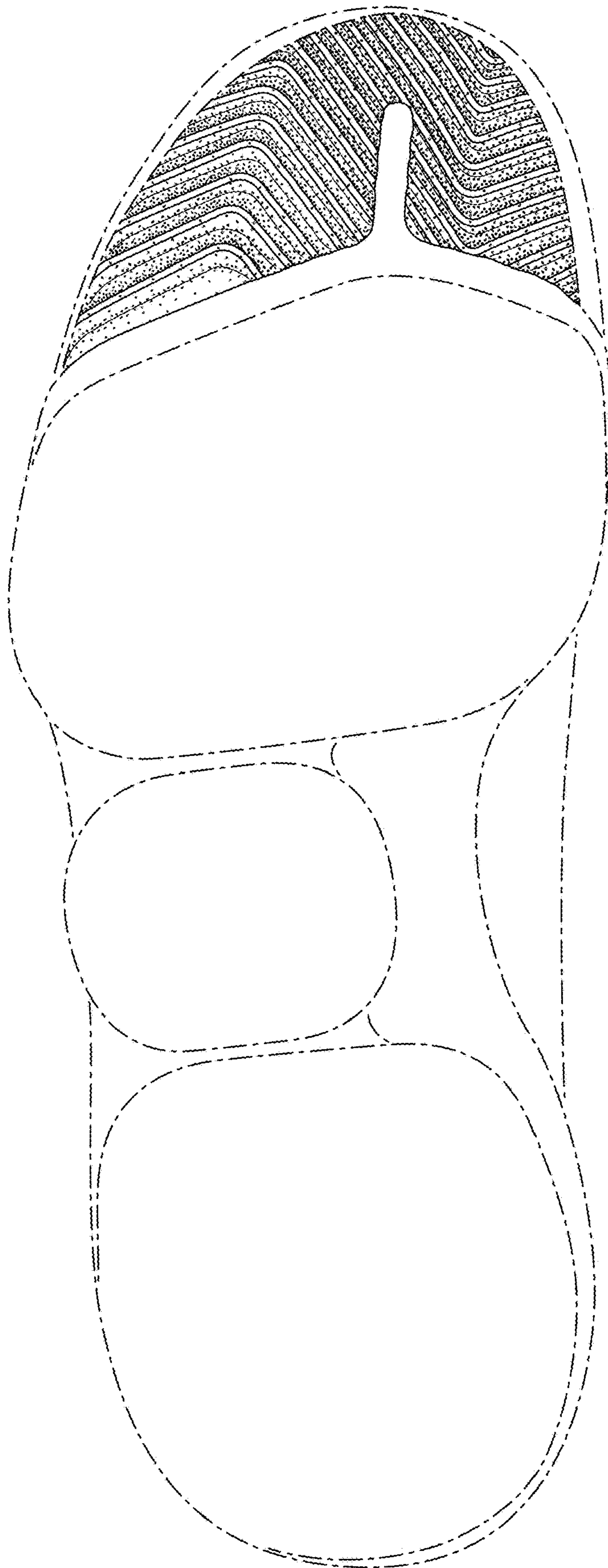

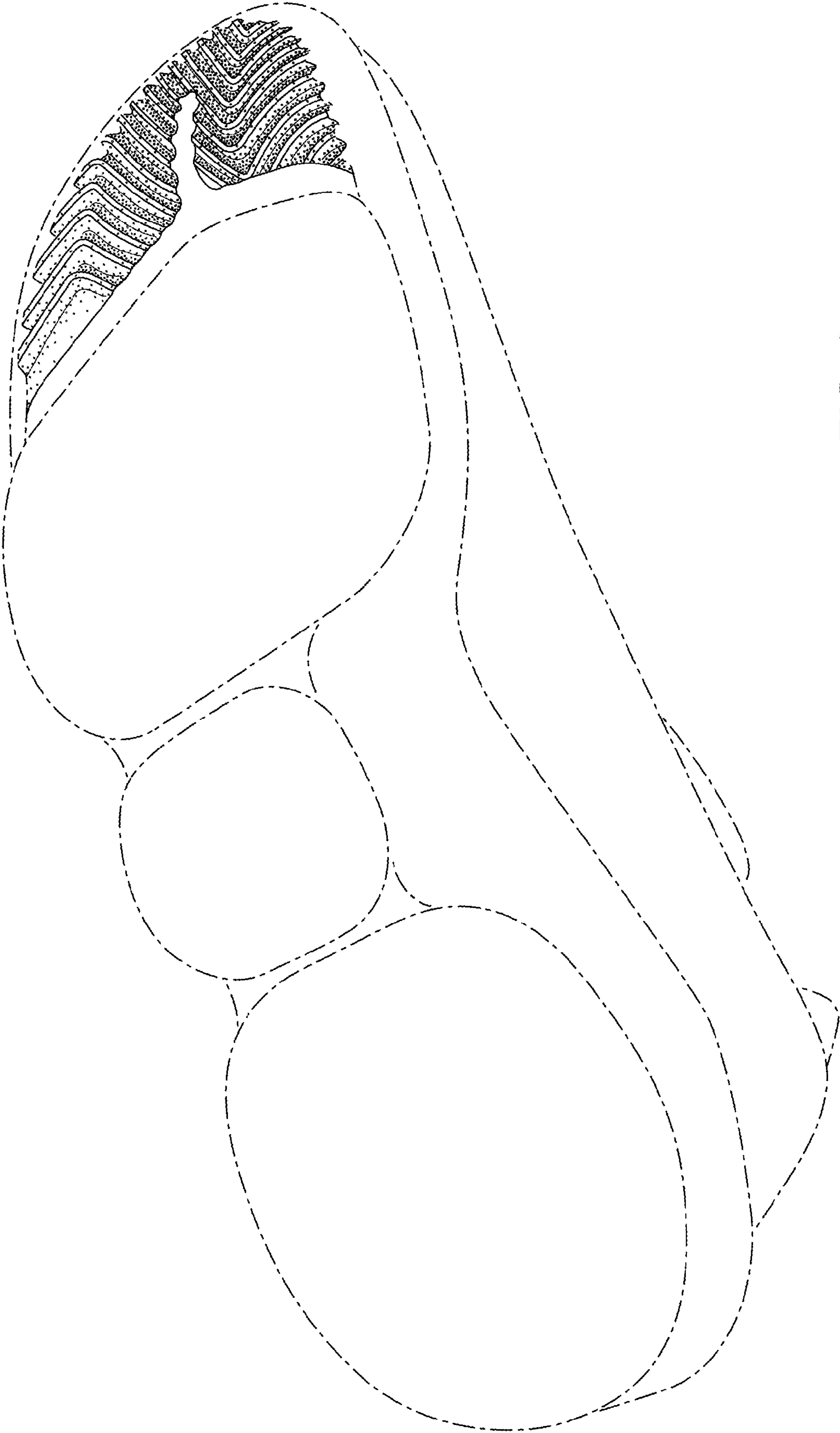

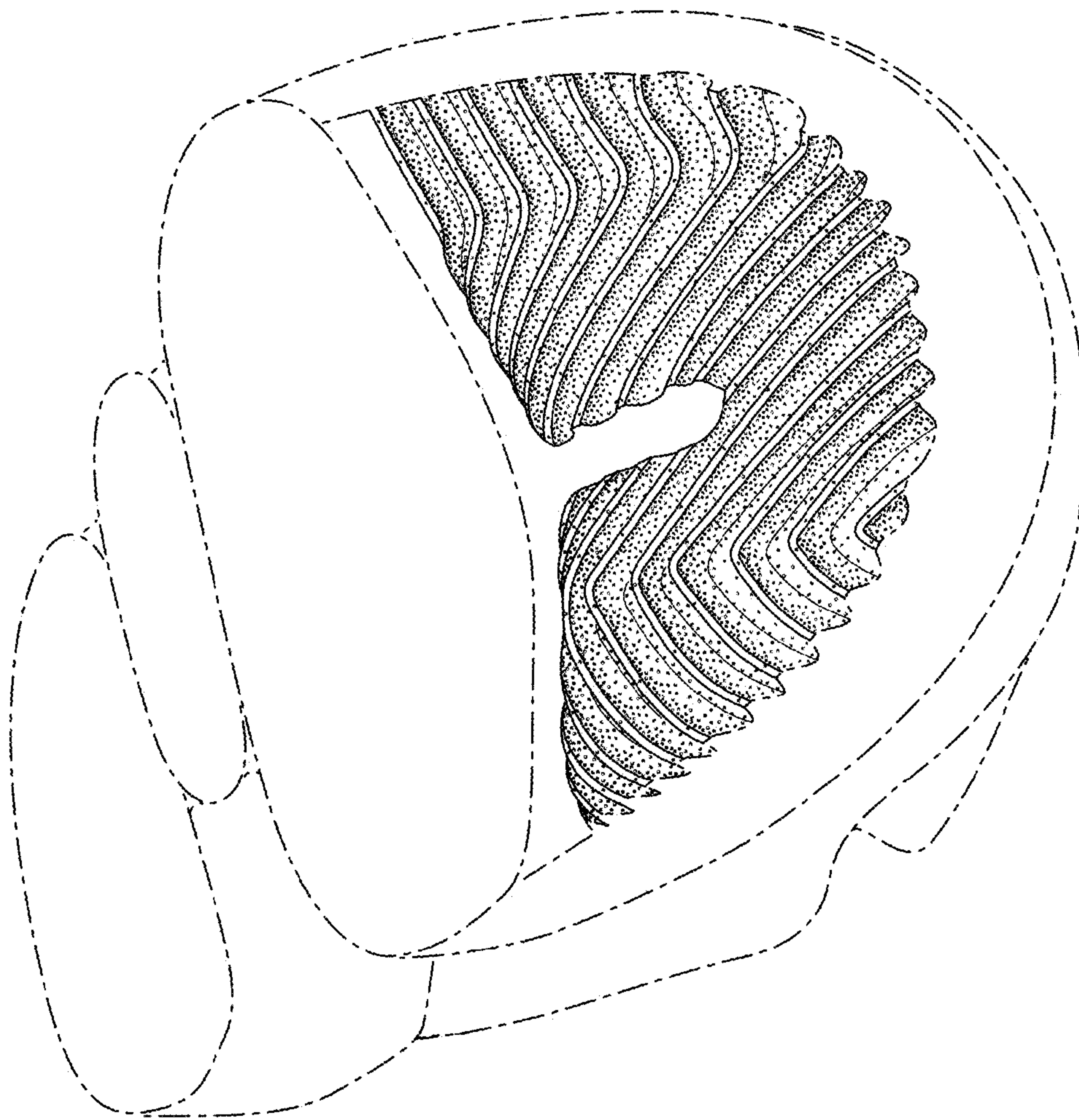

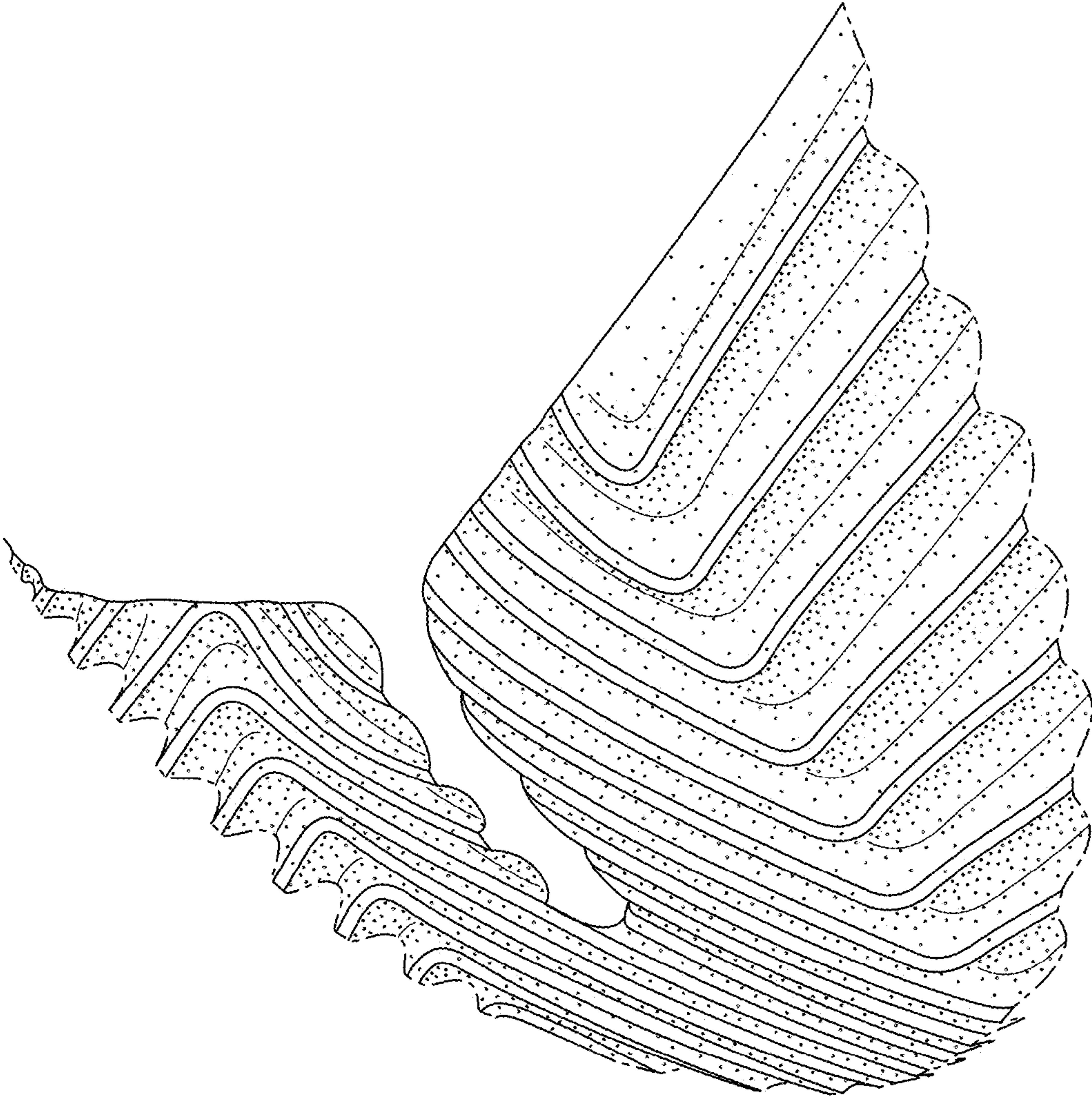

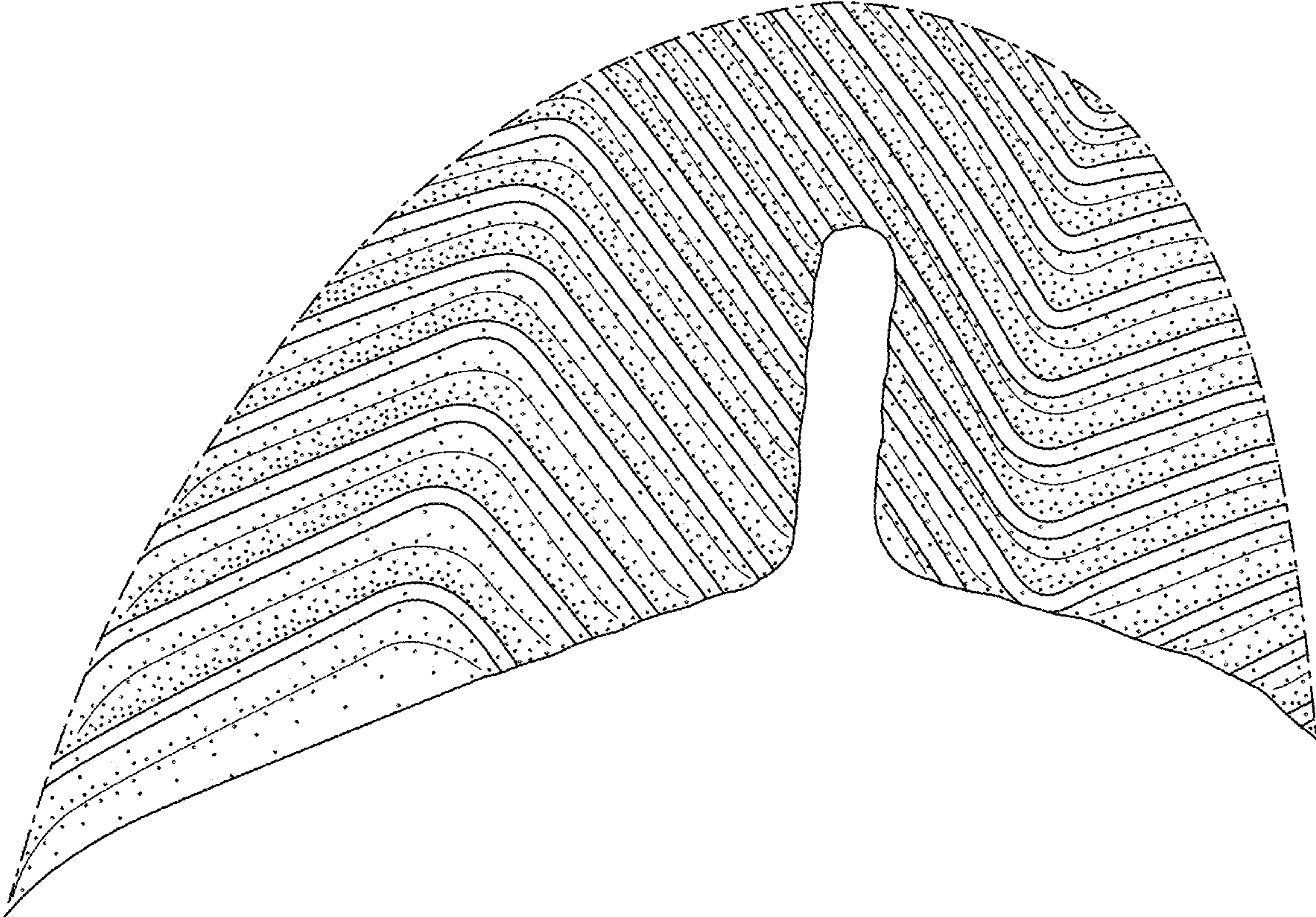

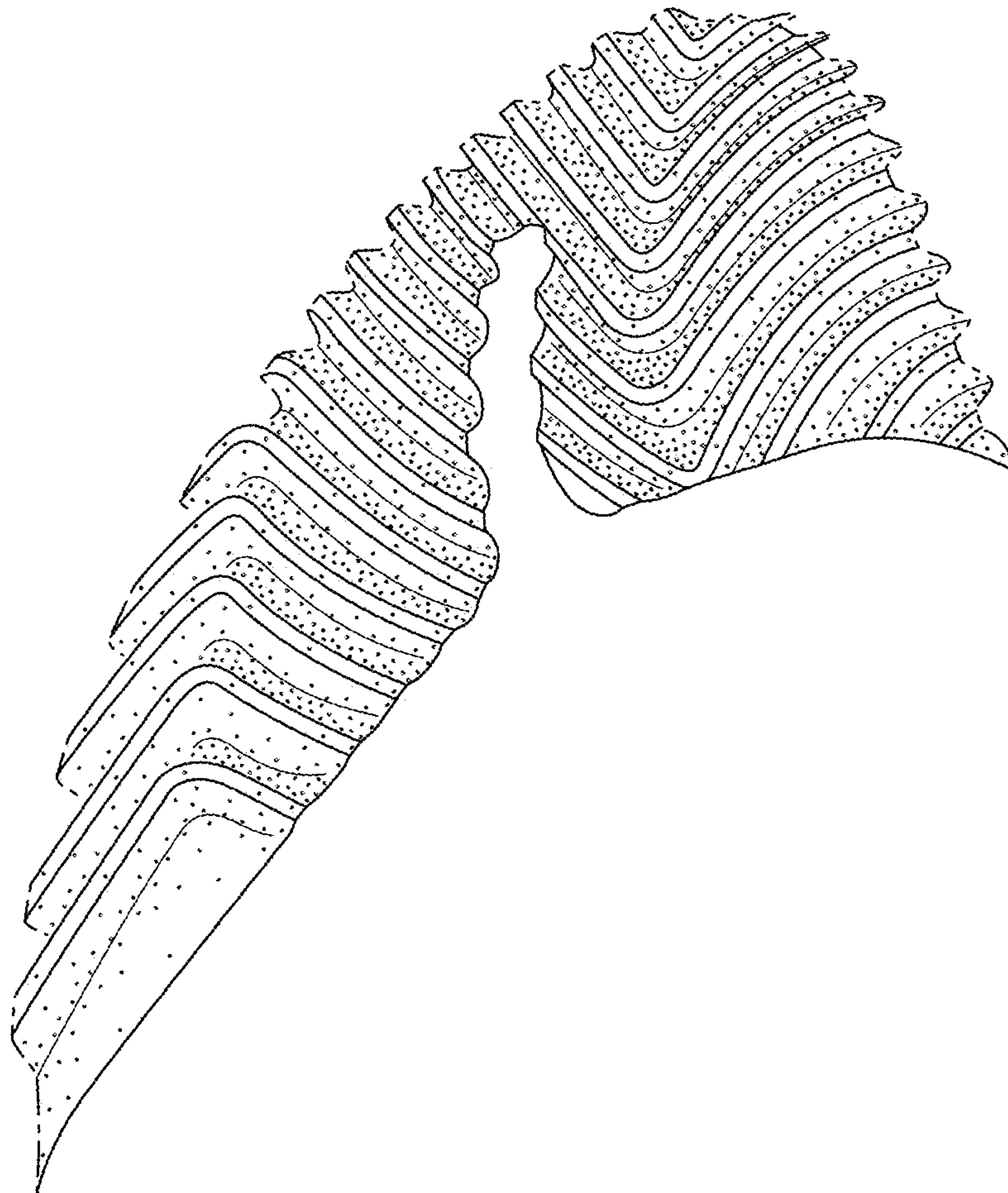

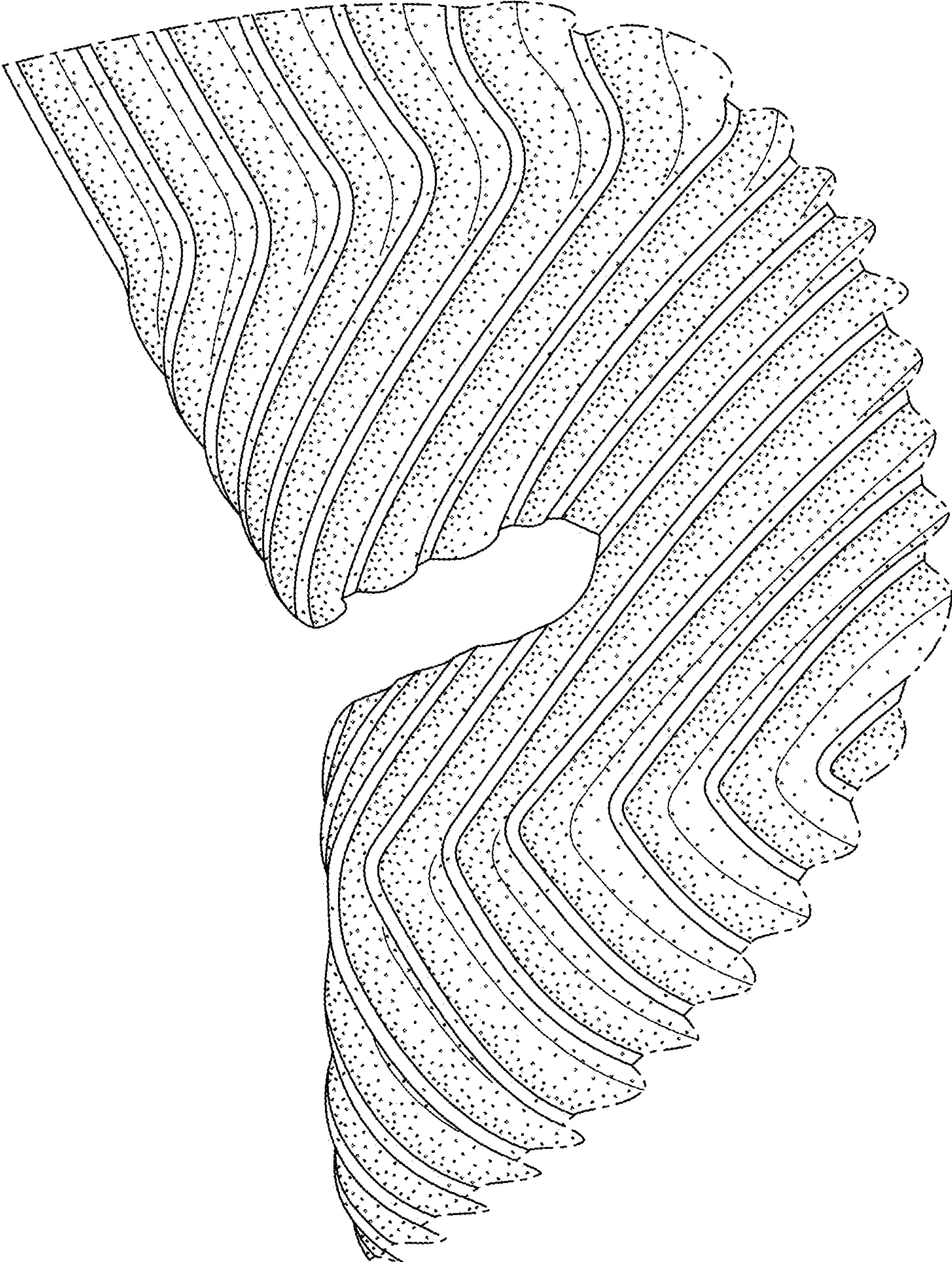
