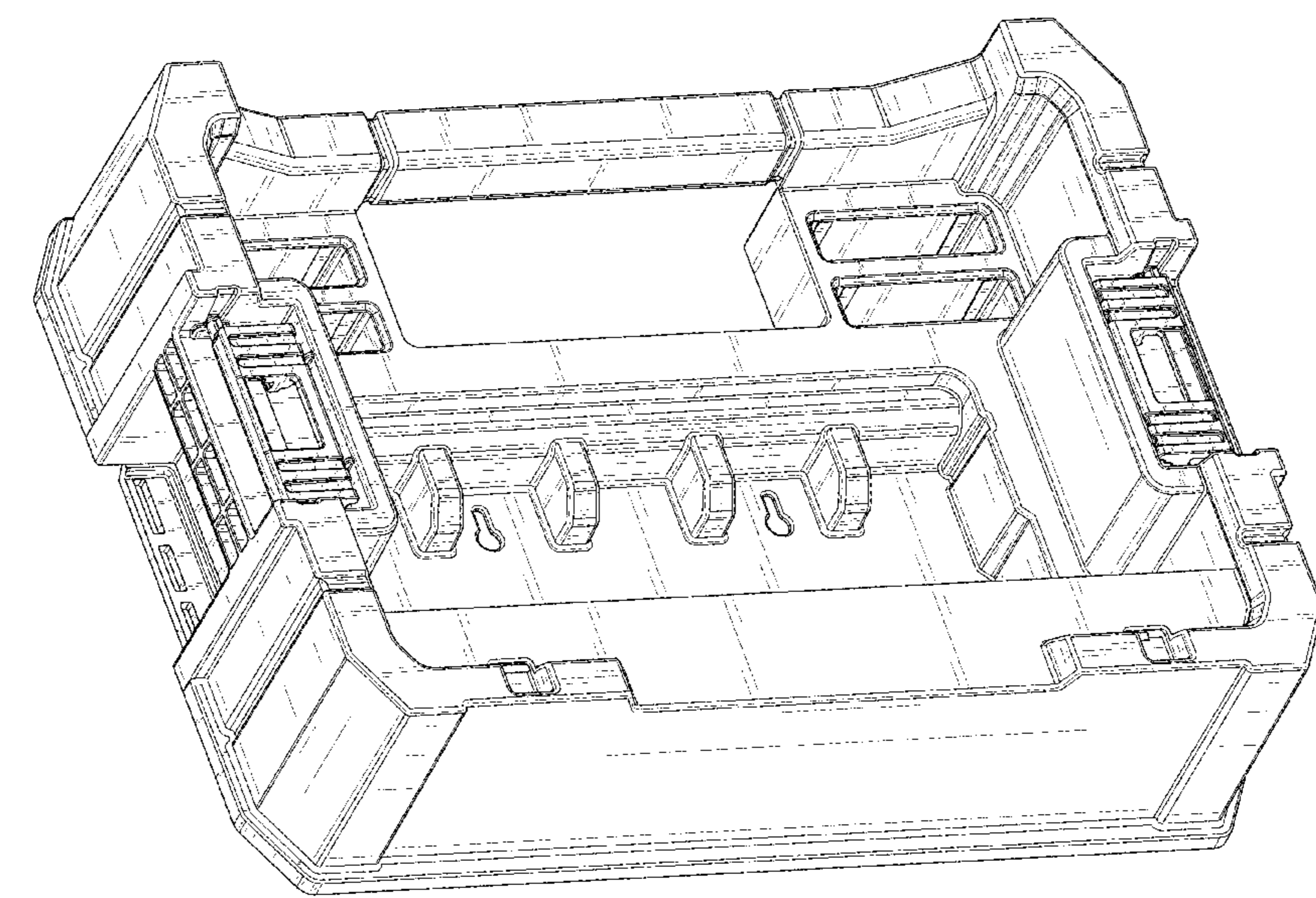
The ornamental design for a tool container, as shown and described.

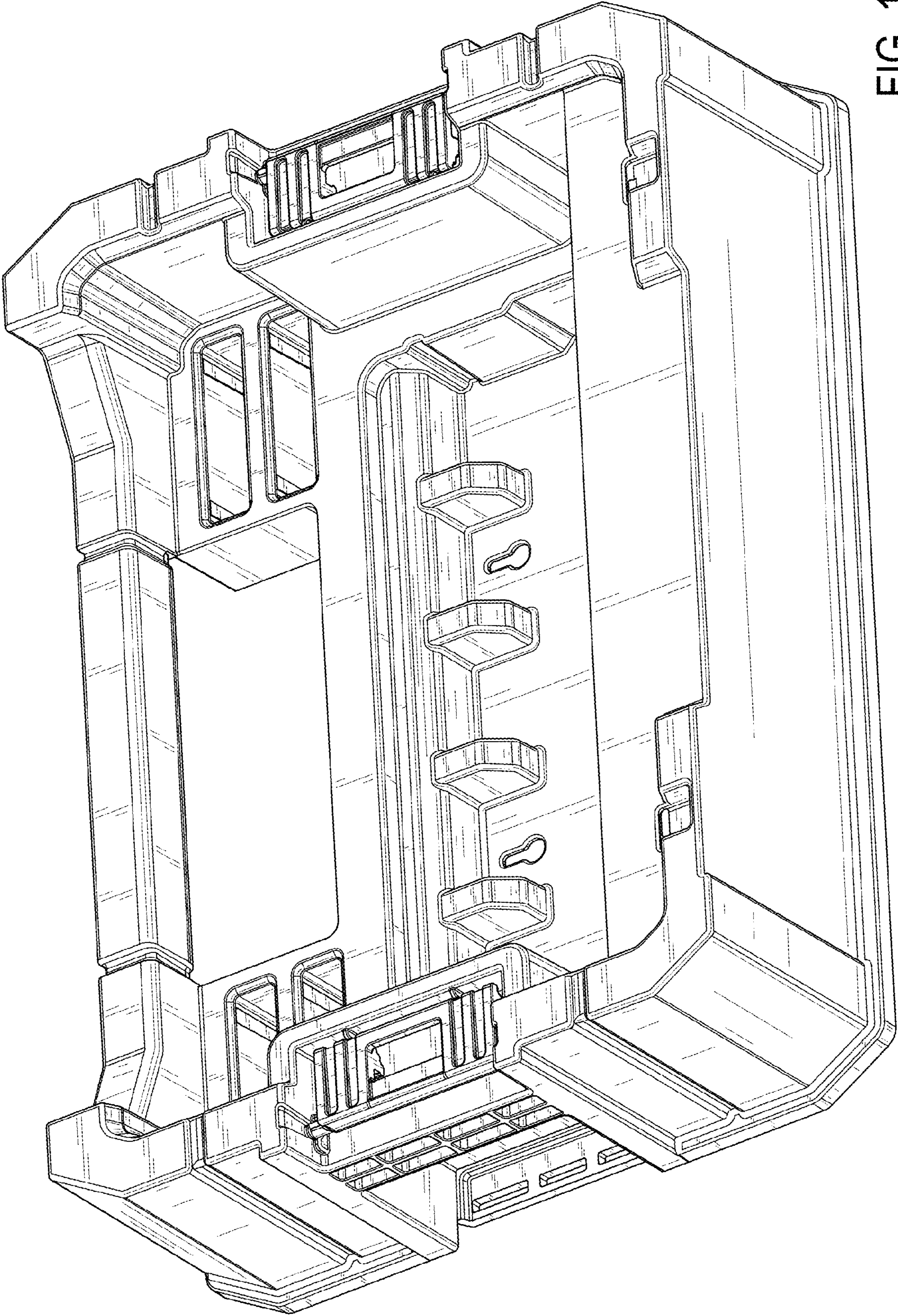

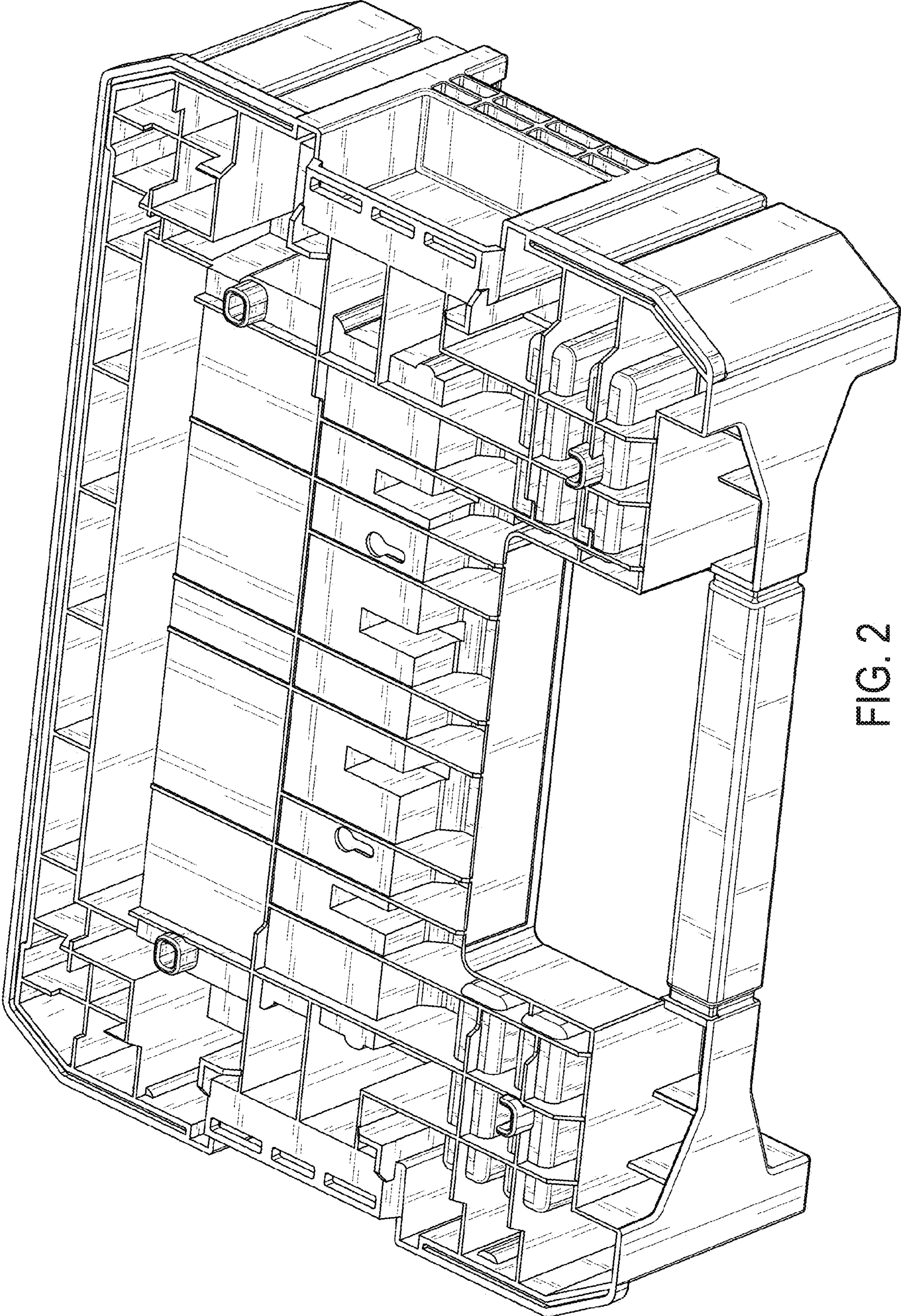

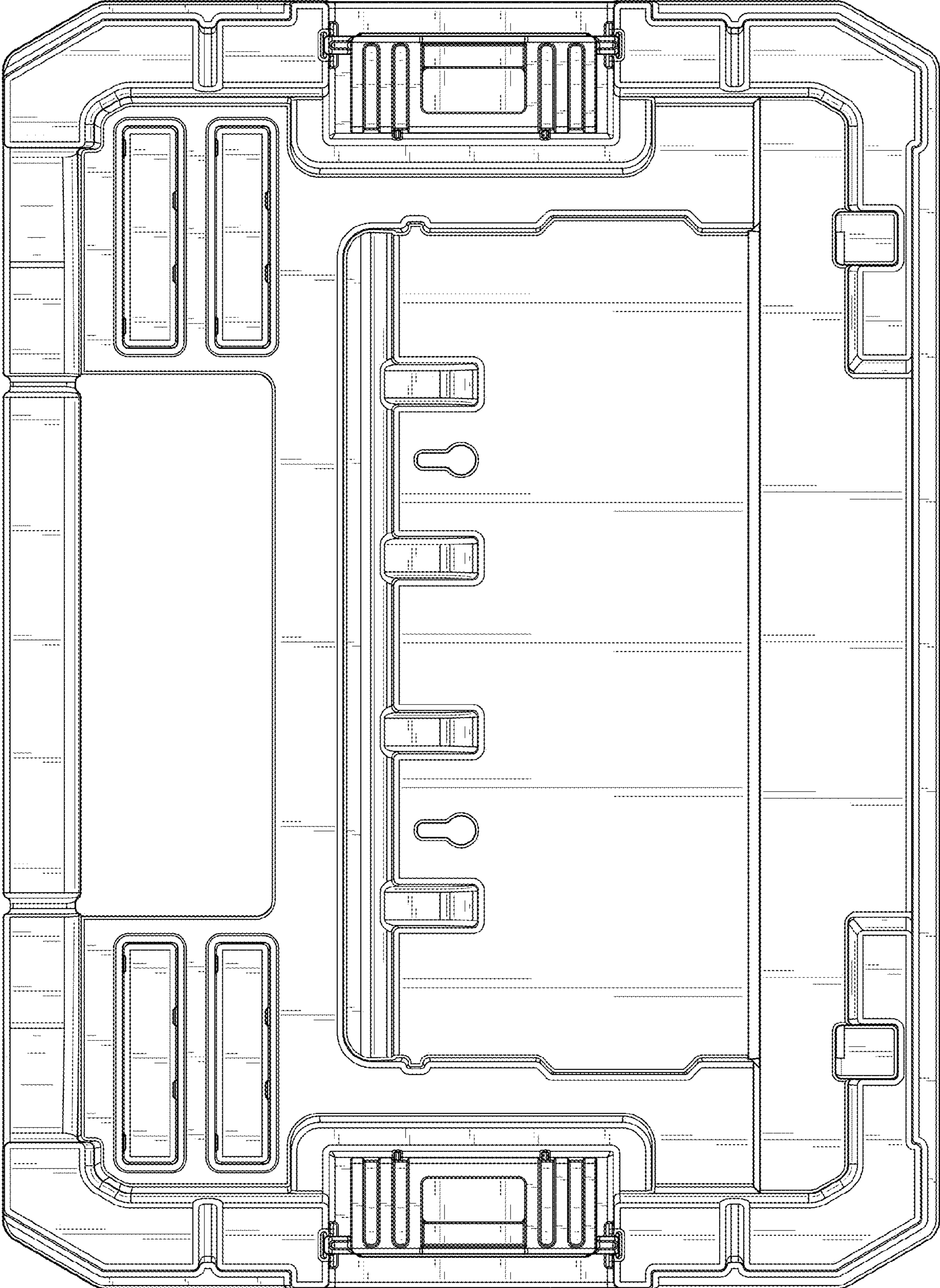

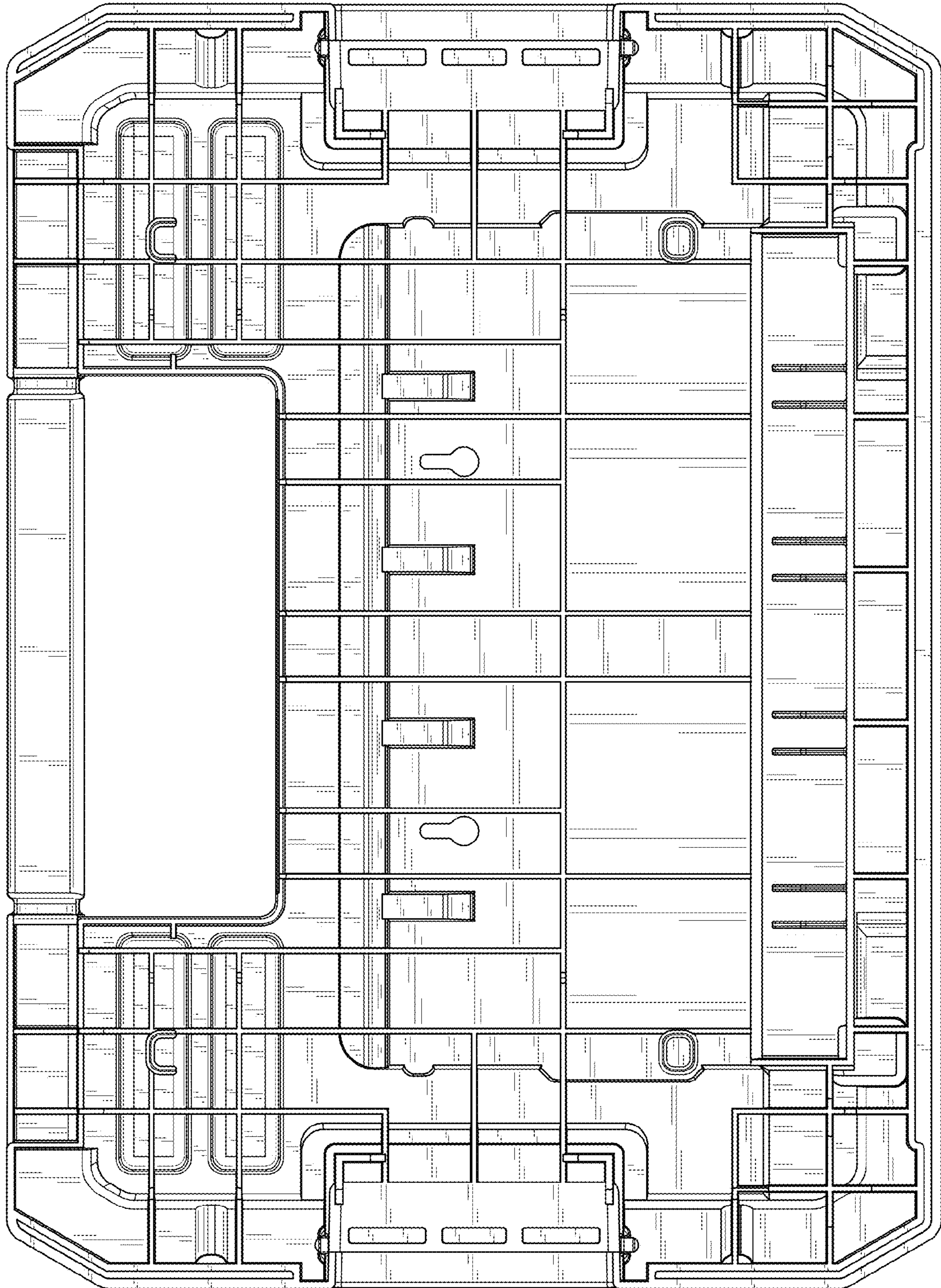

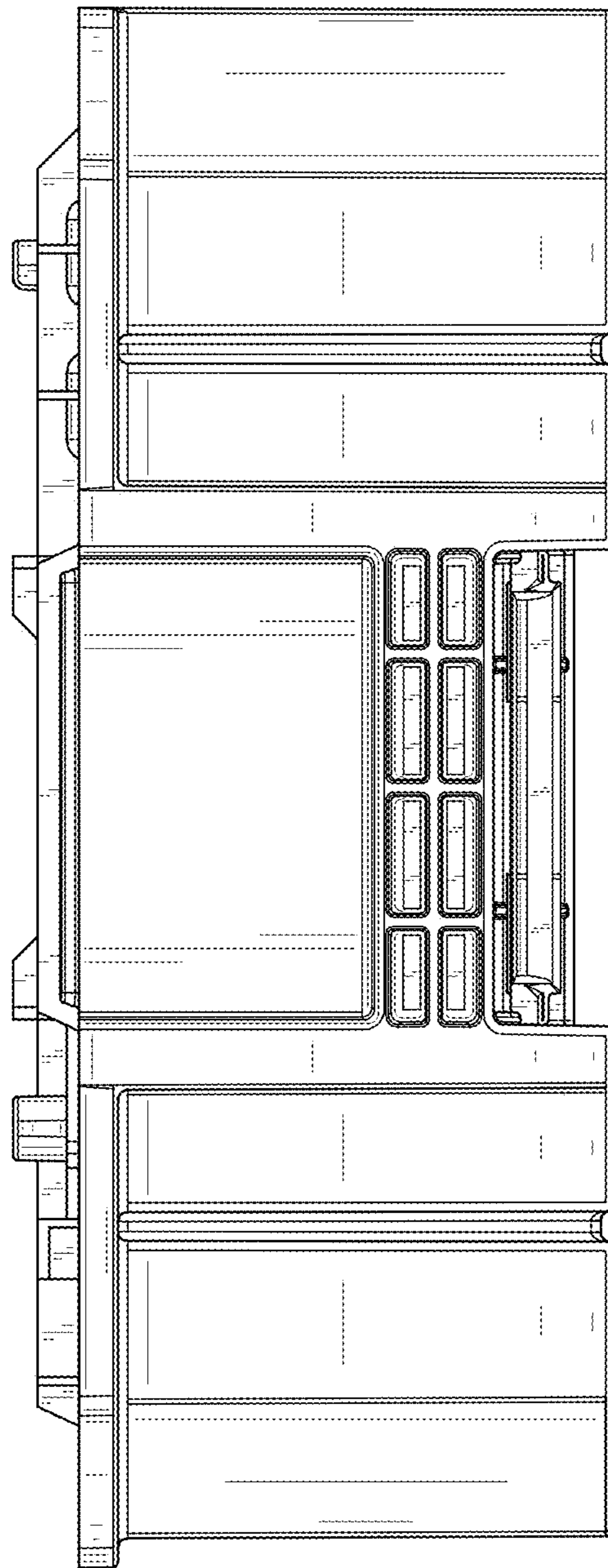

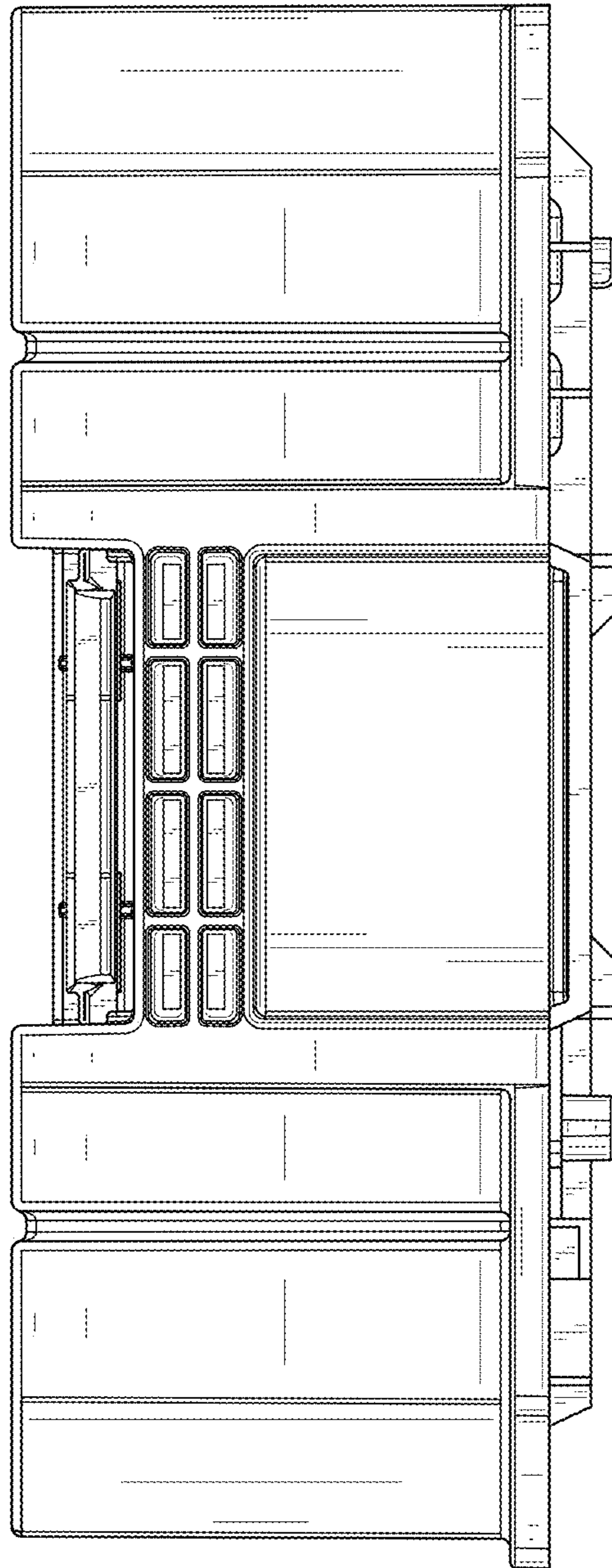

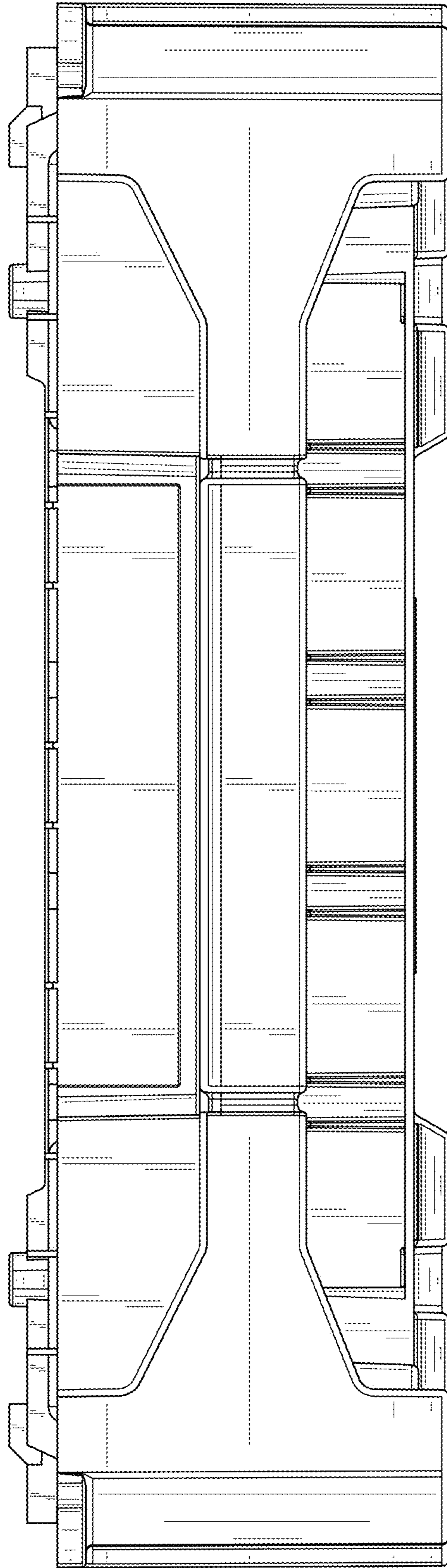

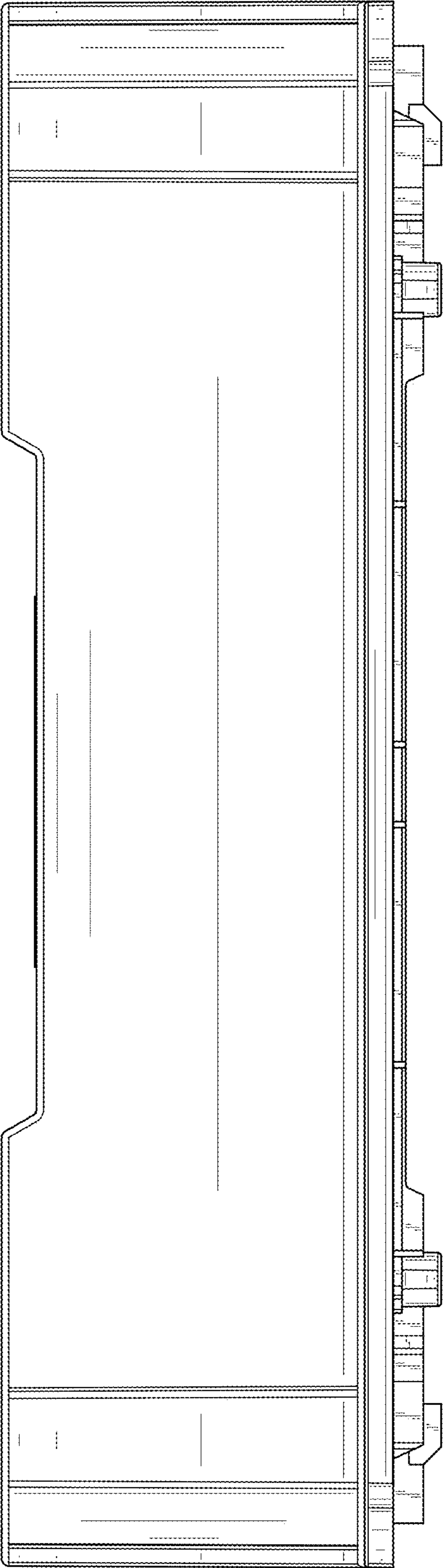
