The ornamental design for a metal guard set for electronic
device case, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and right perspective view of metal
guard set for electronic device case showing claimed design;

FIG. 5 is a bottom view thereof;

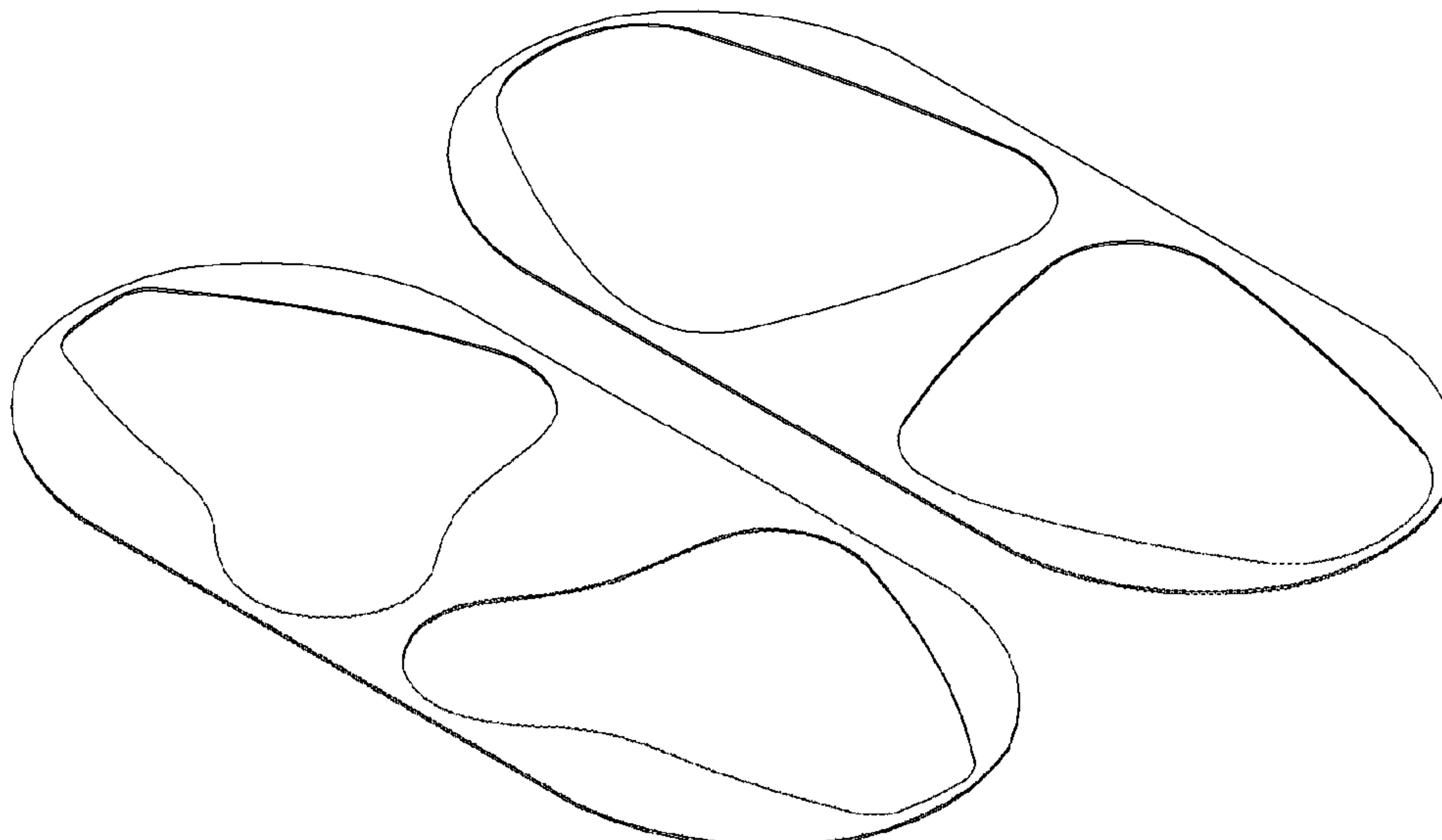
FIG. 6 is a first reference view thereof, which shows the

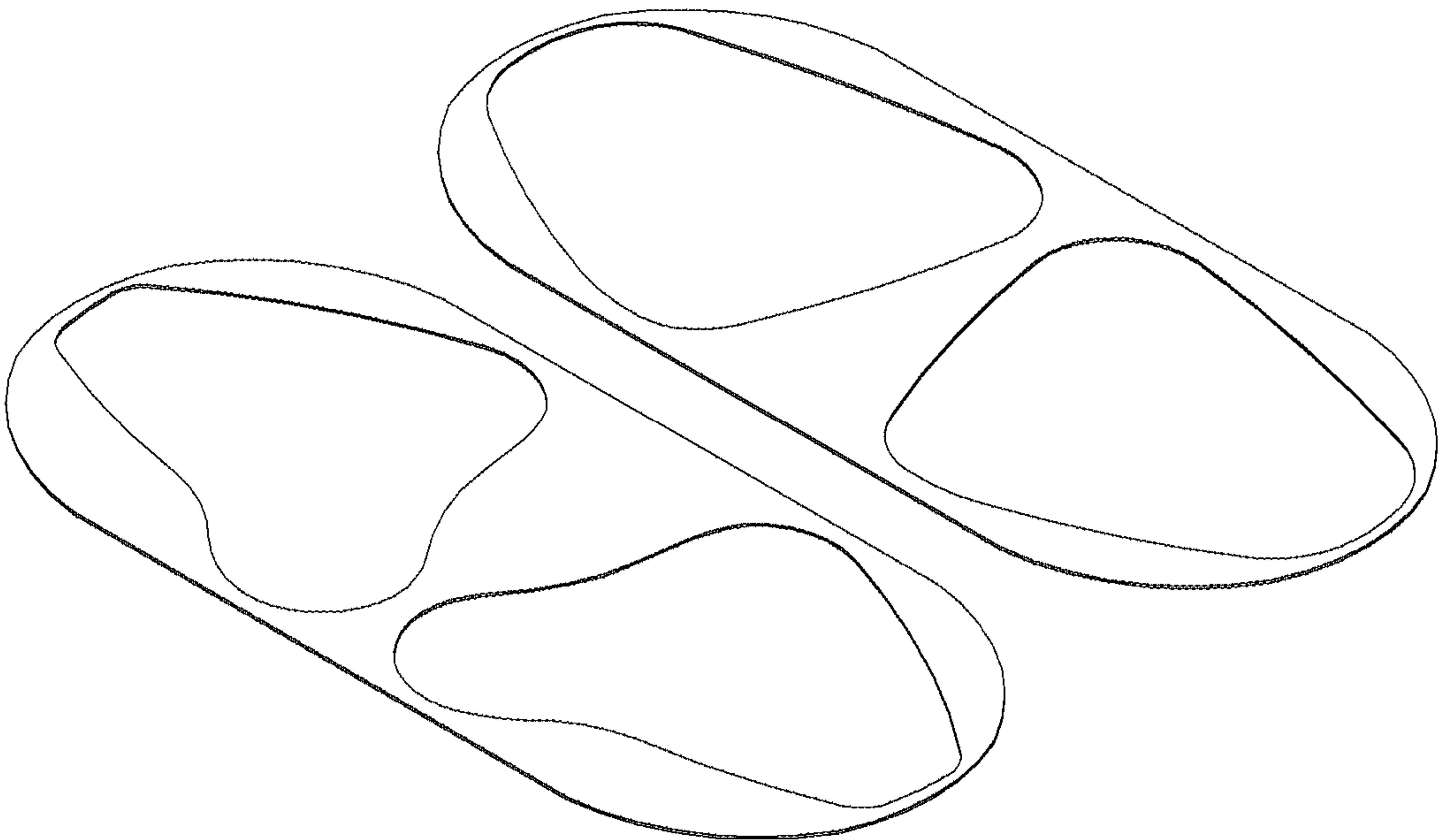

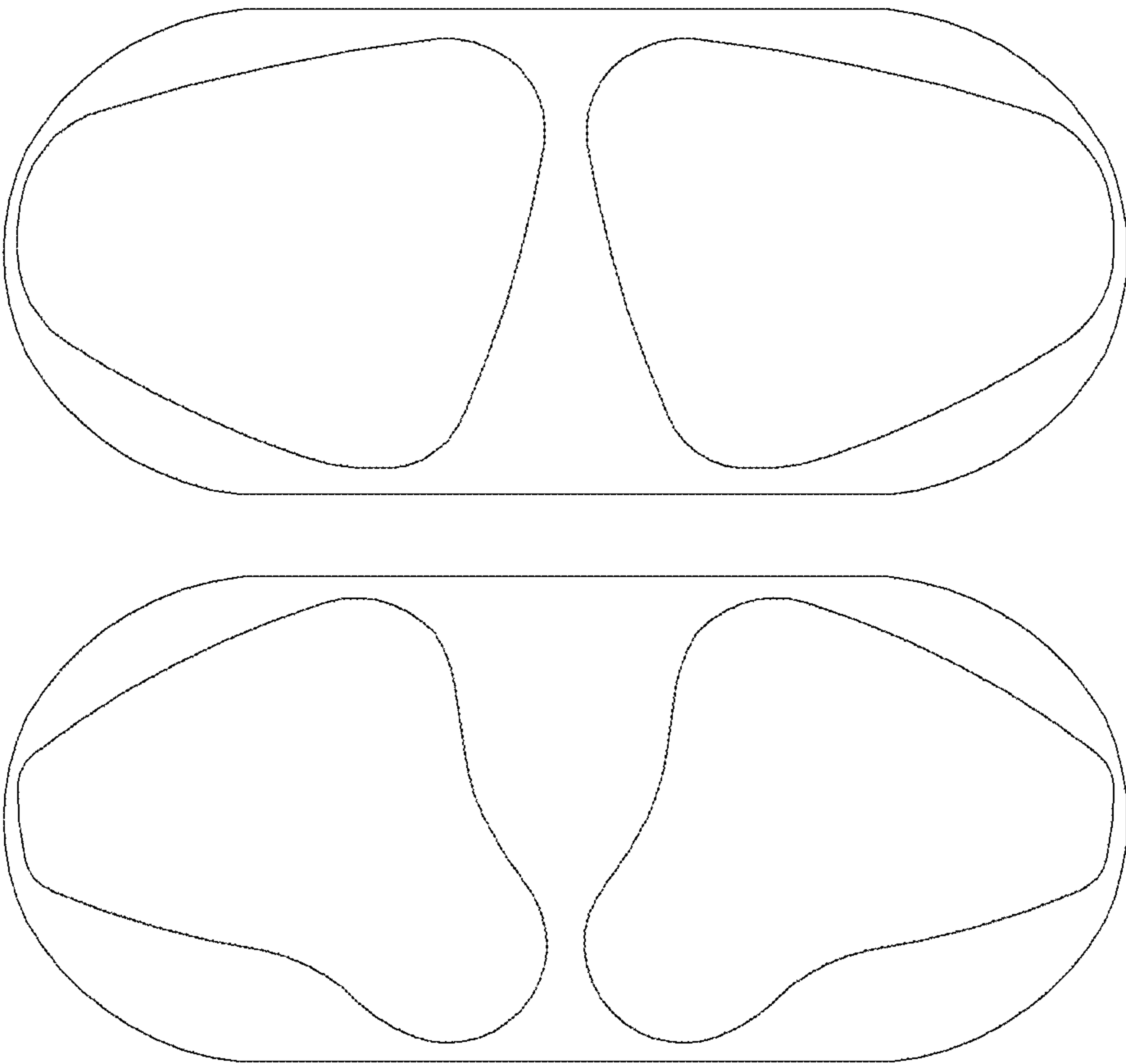

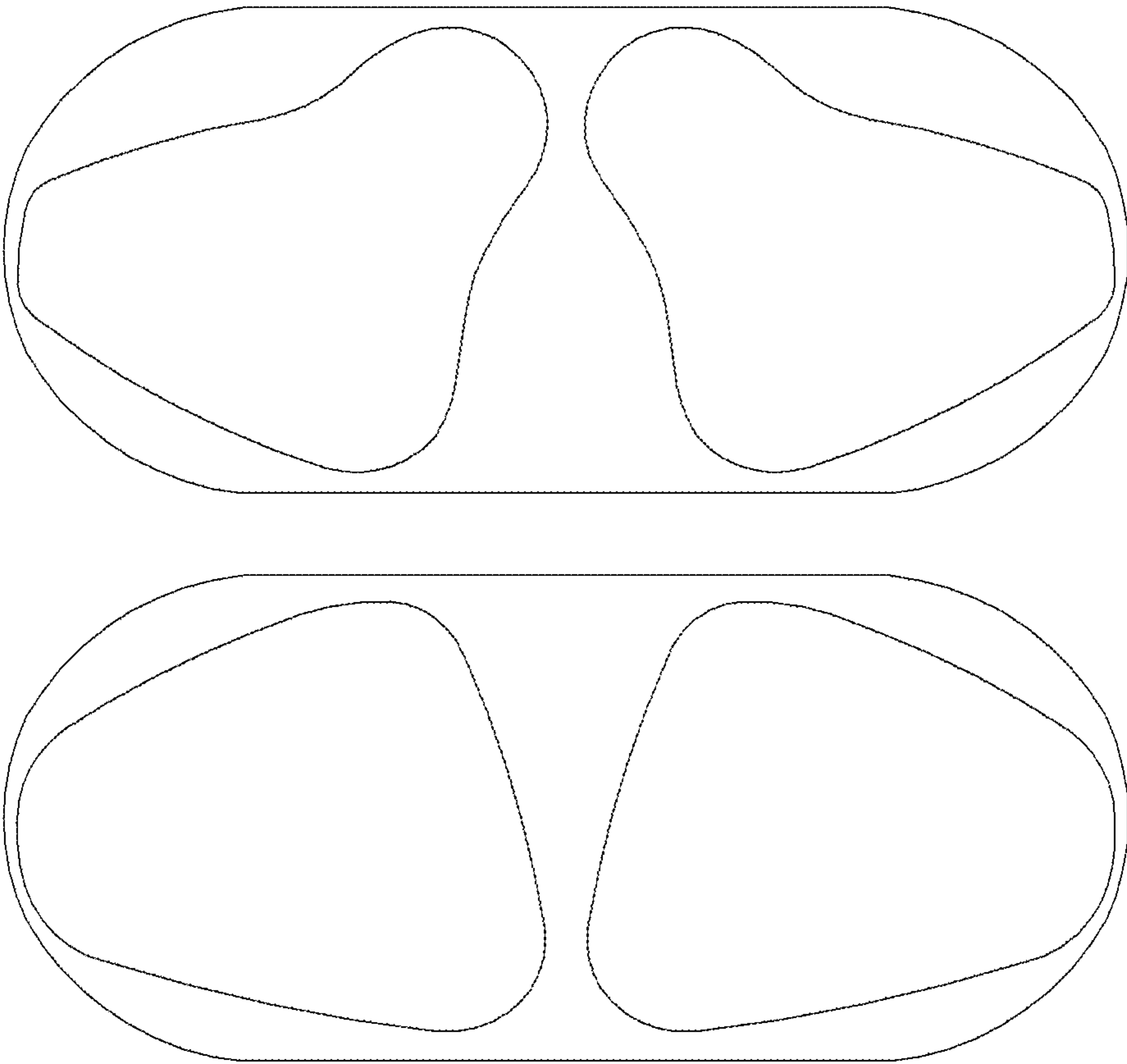

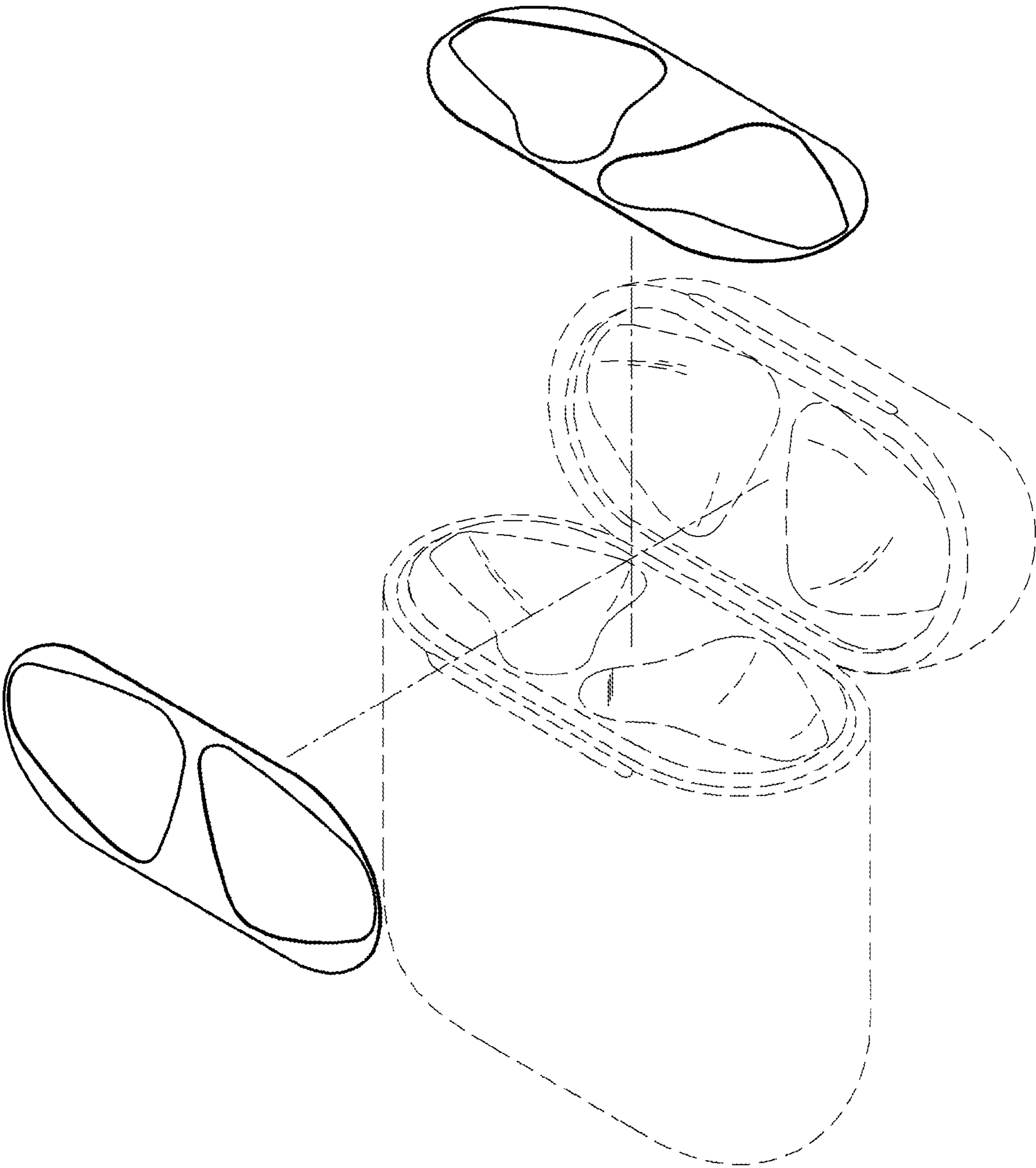

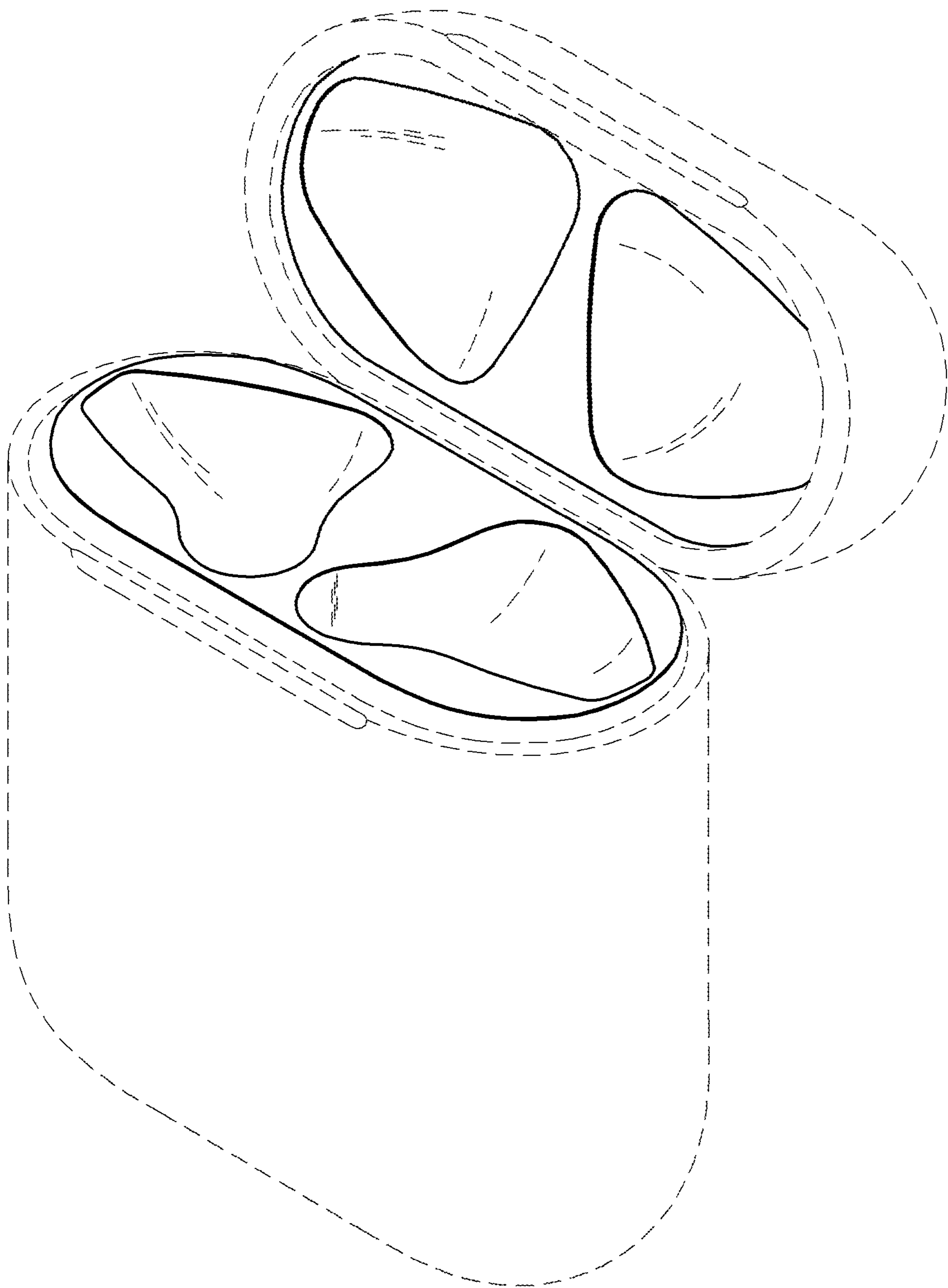
