DESCRIPTION

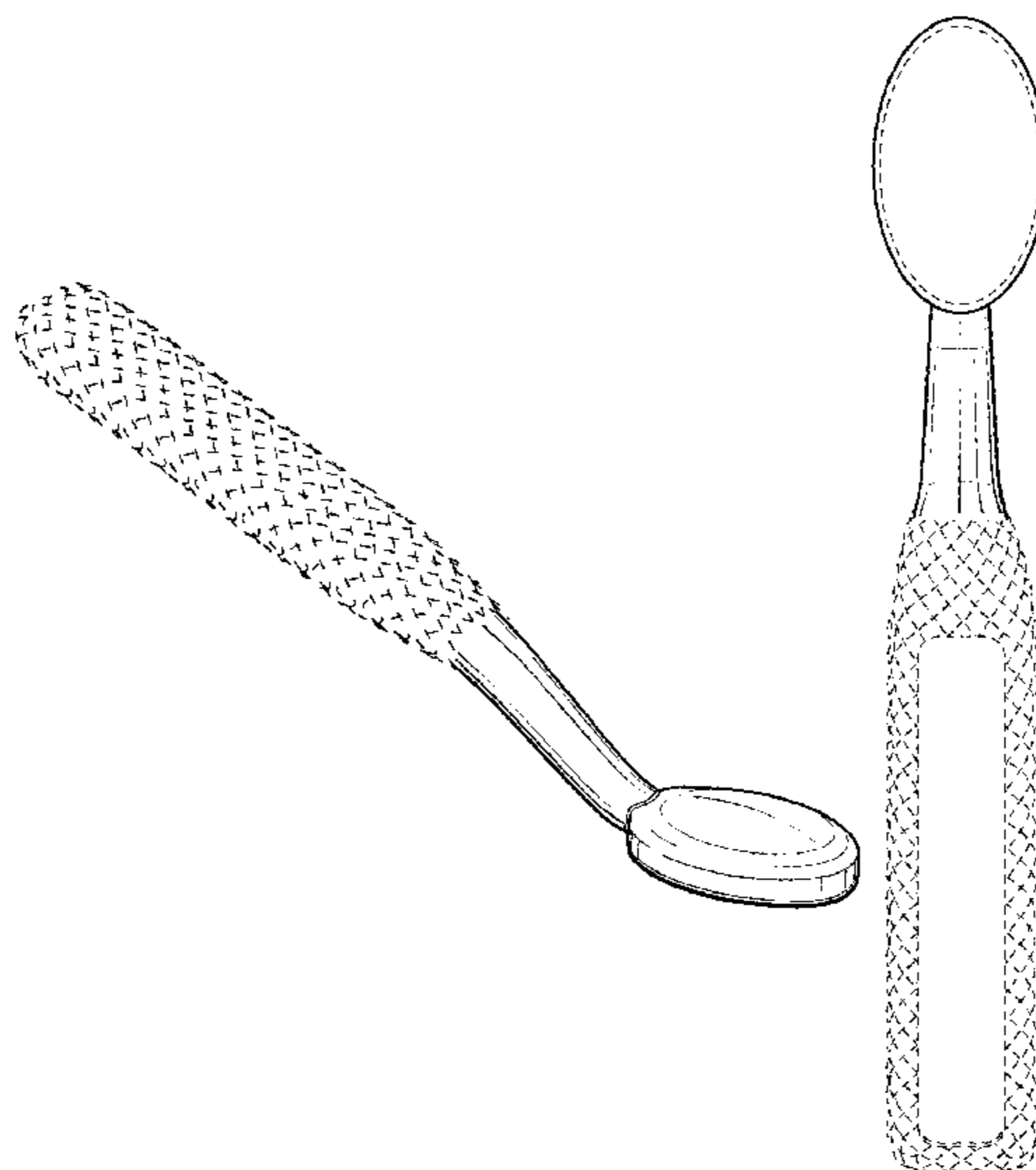
FIG. 1 is a top perspective view of a make-up brush body;

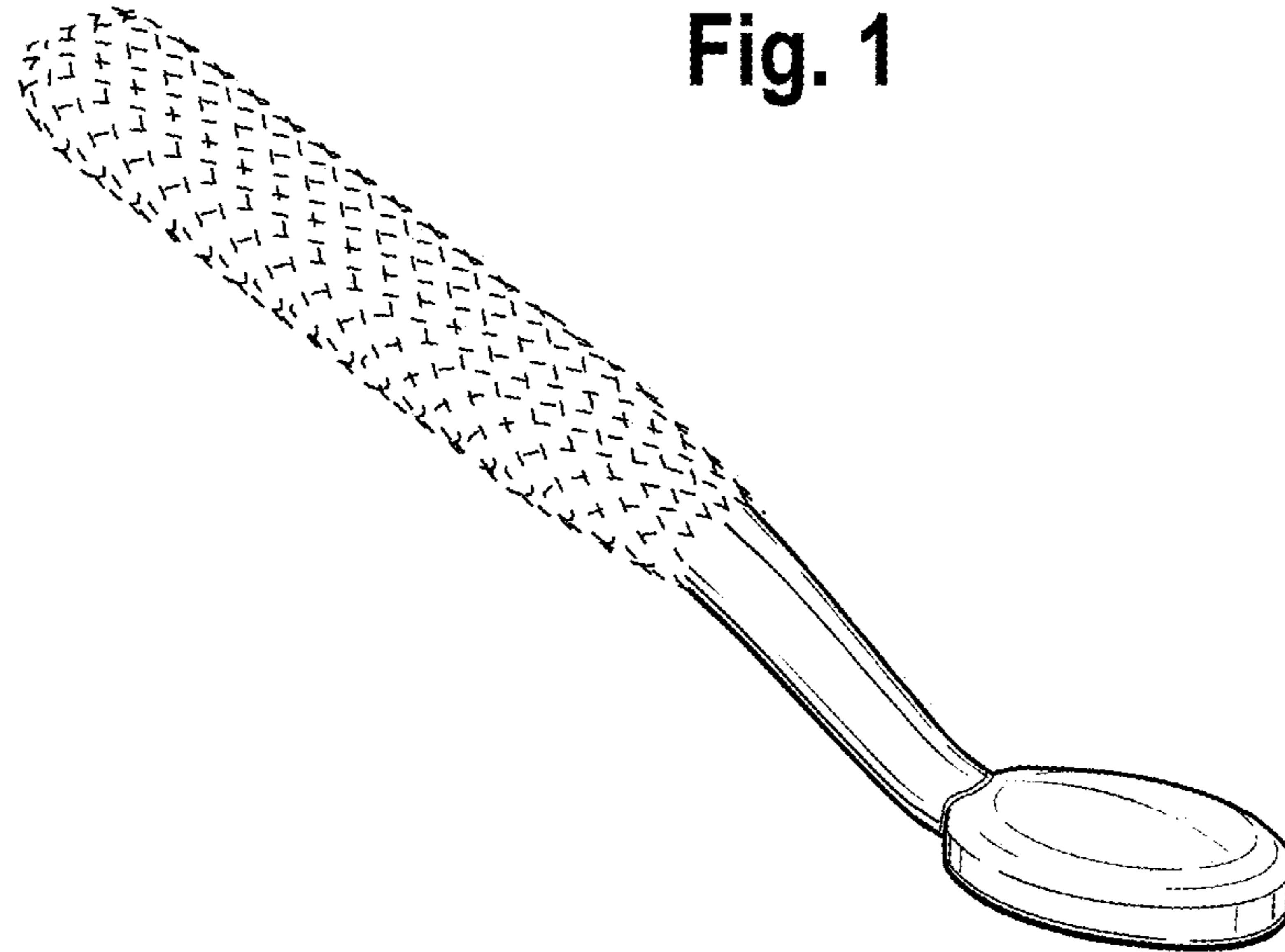

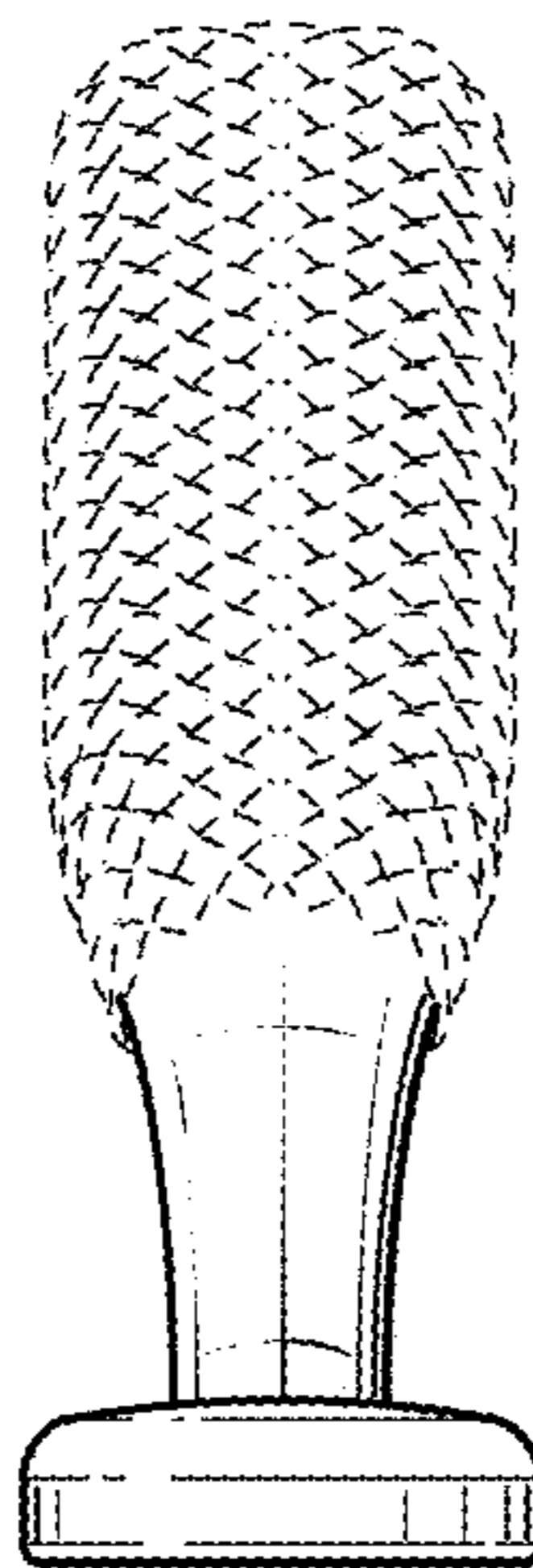

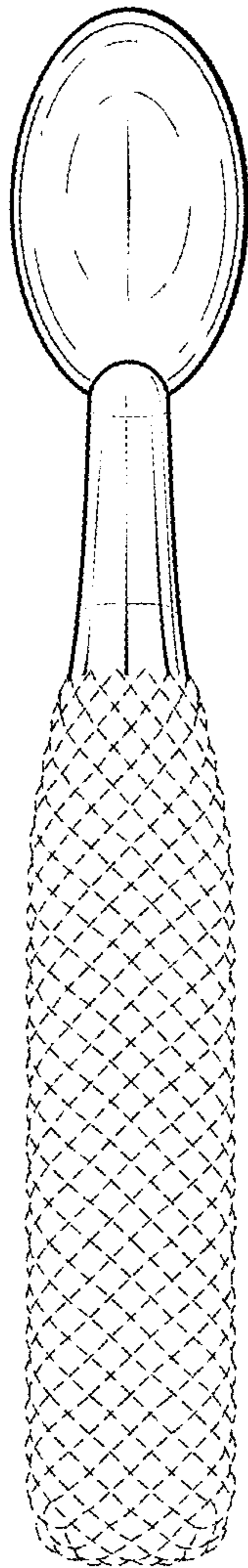

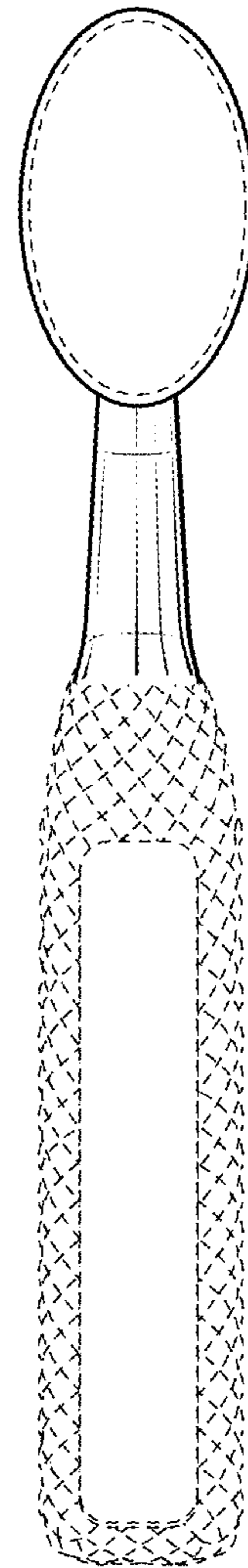

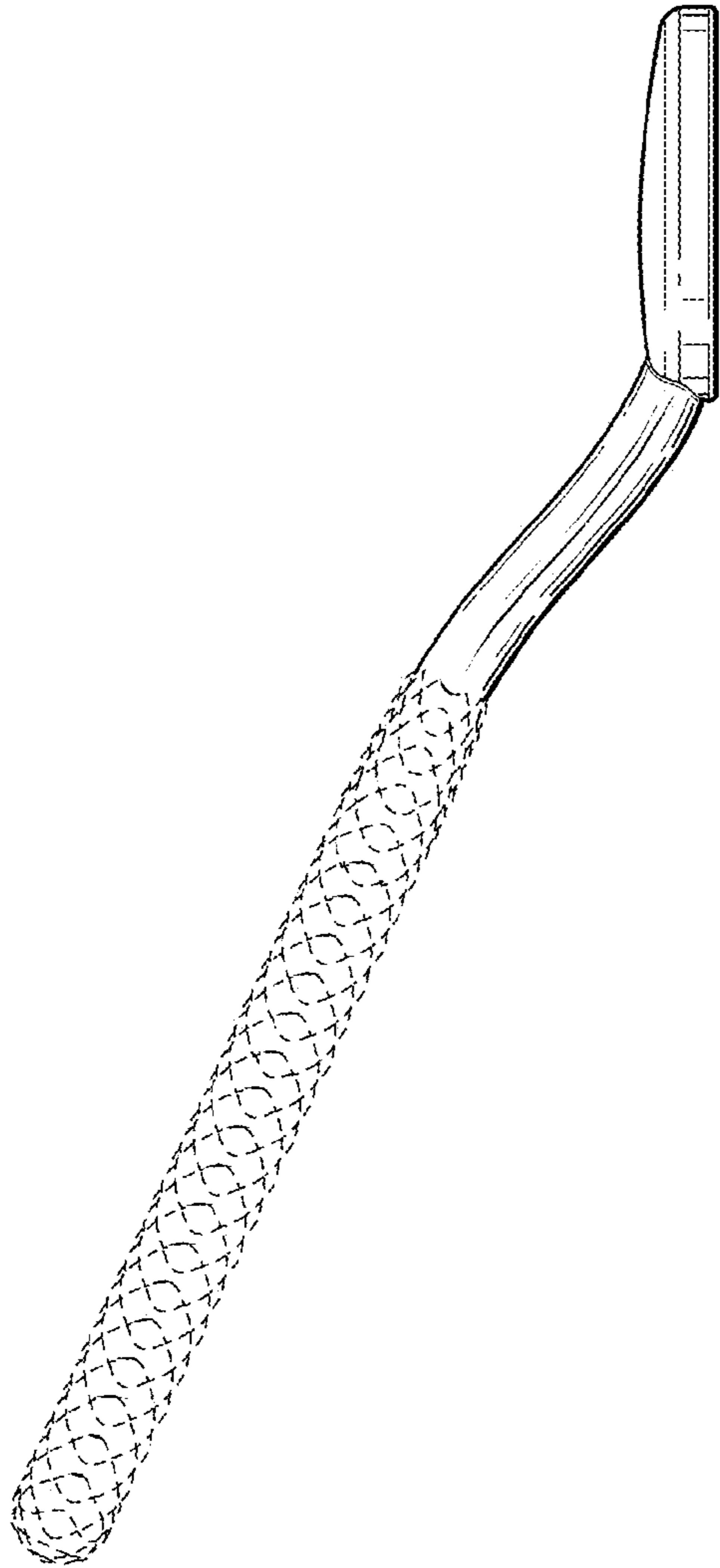

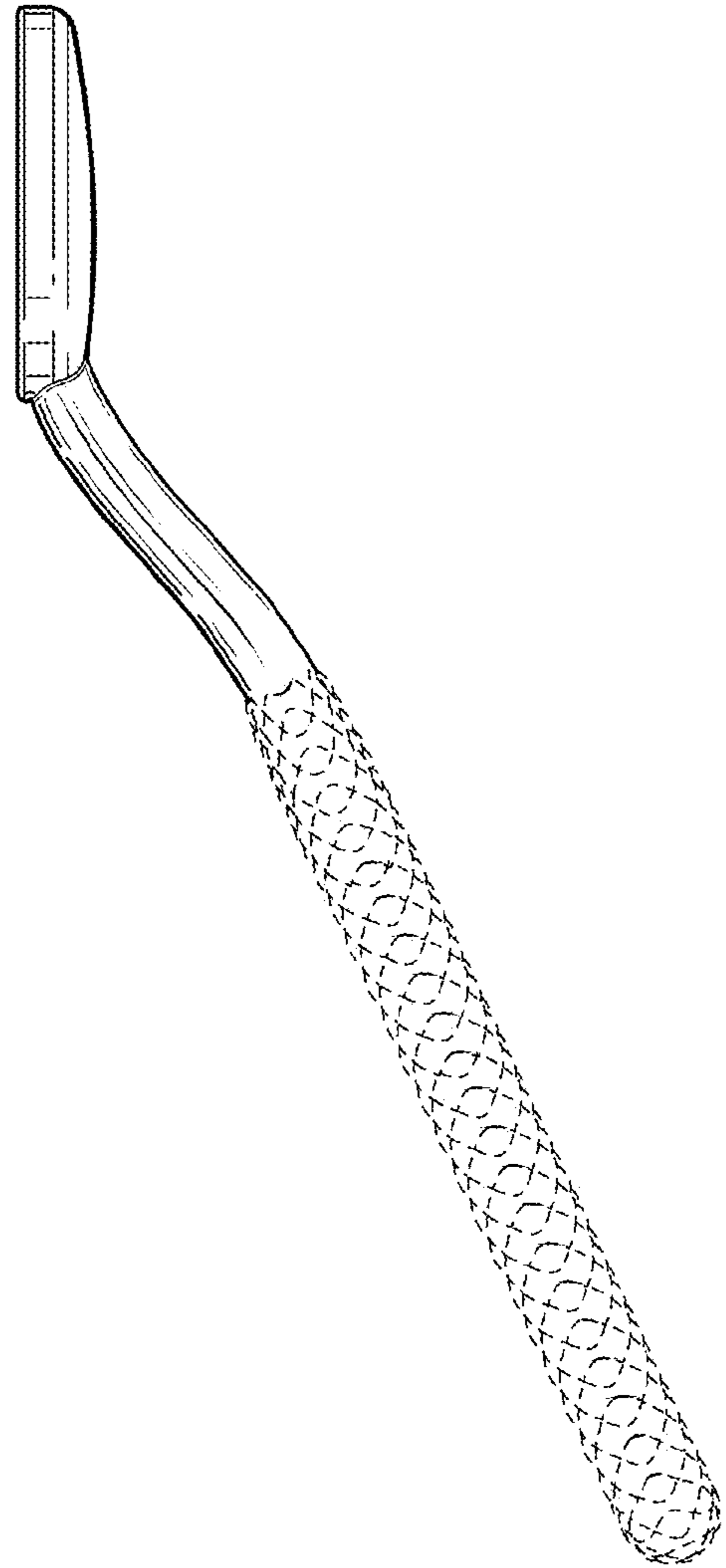

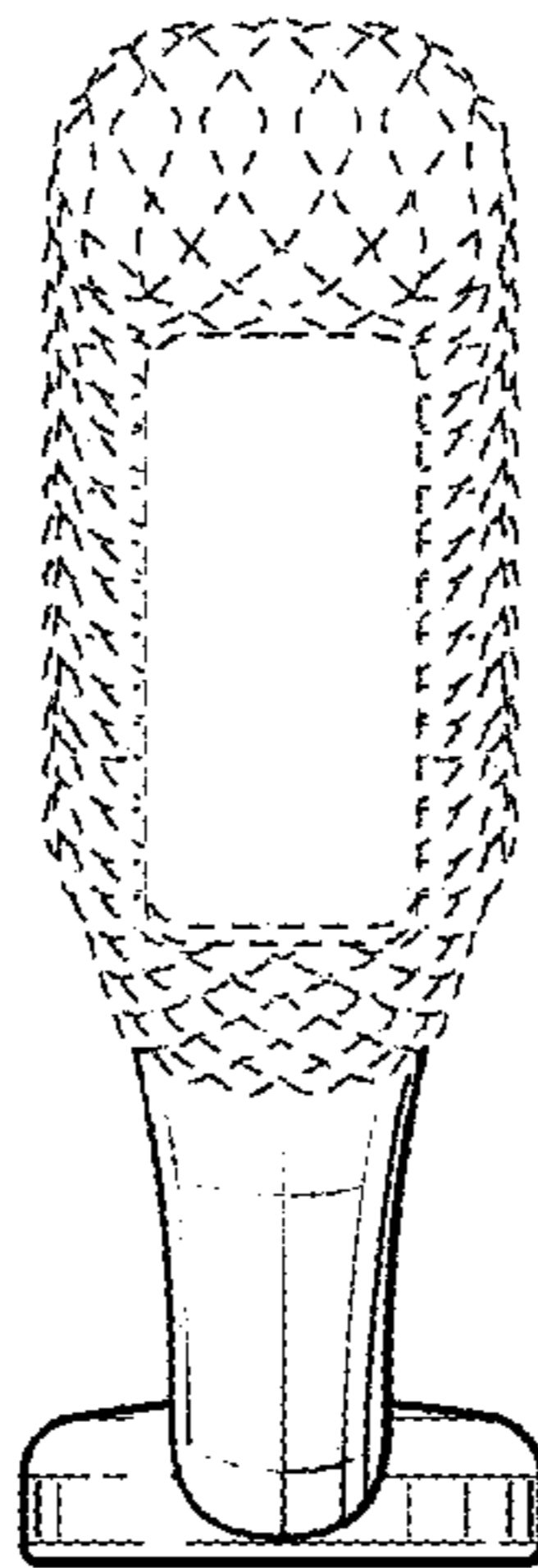
