The ornamental design for a garment hanger, as shown and described.

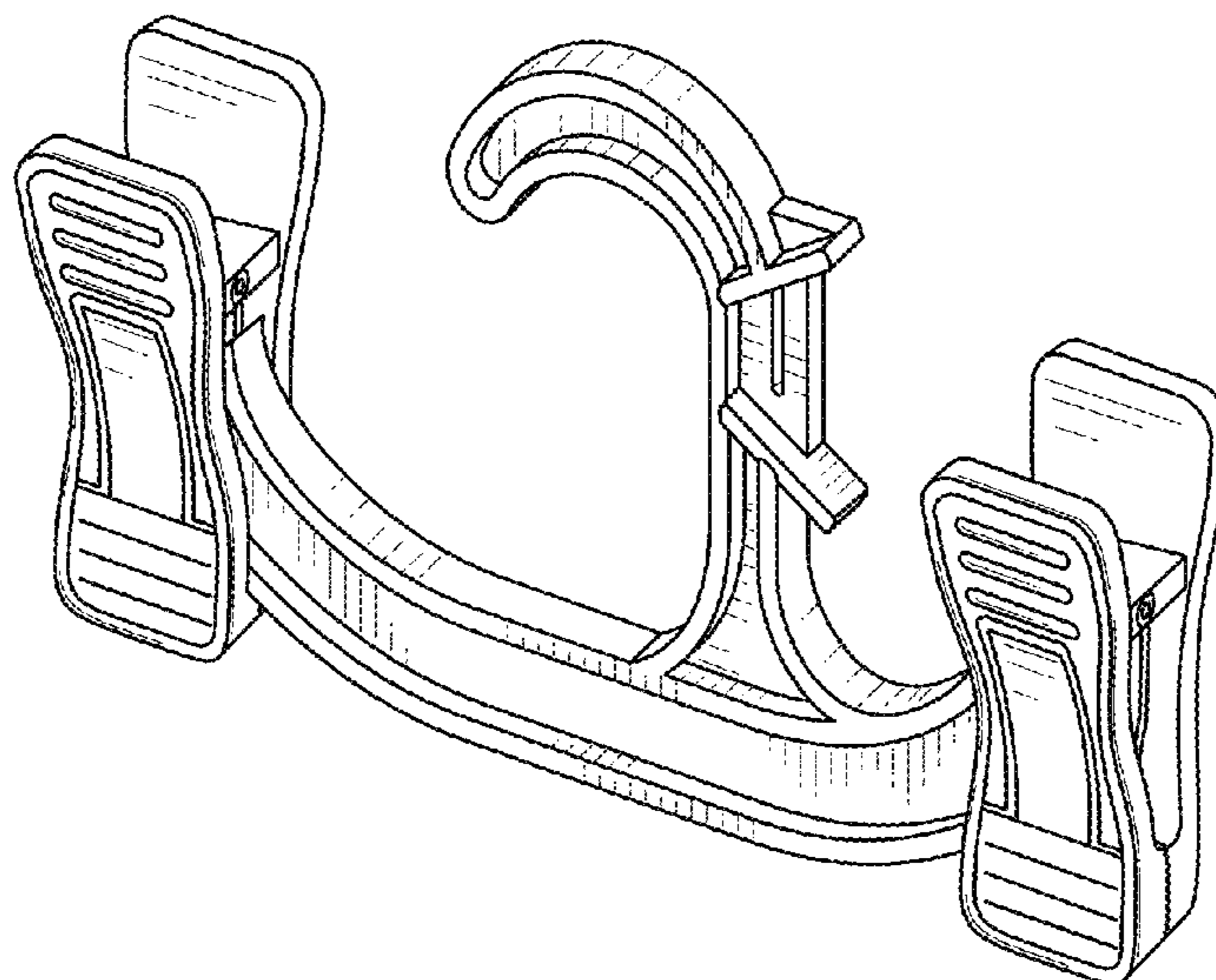
DESCRIPTION

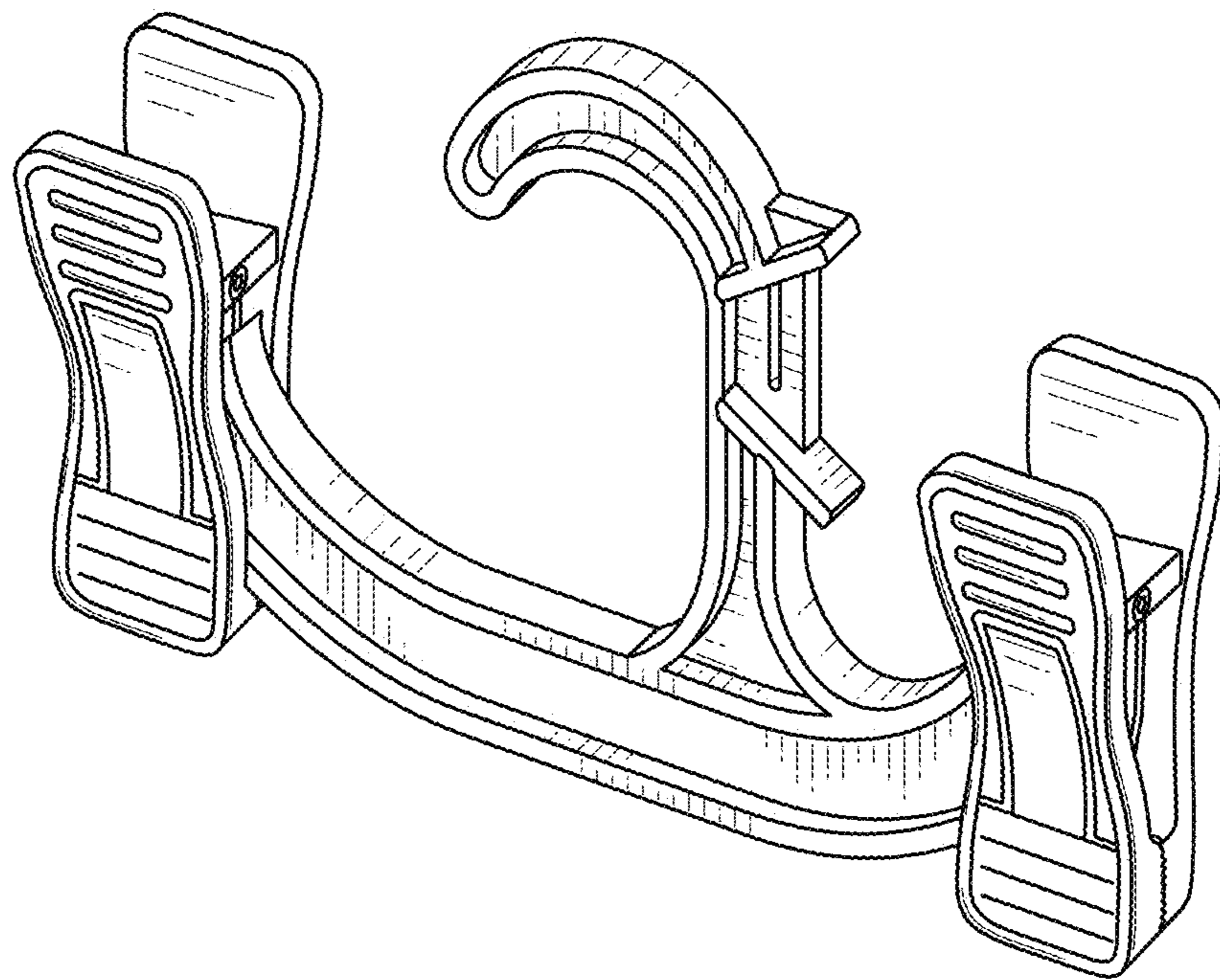

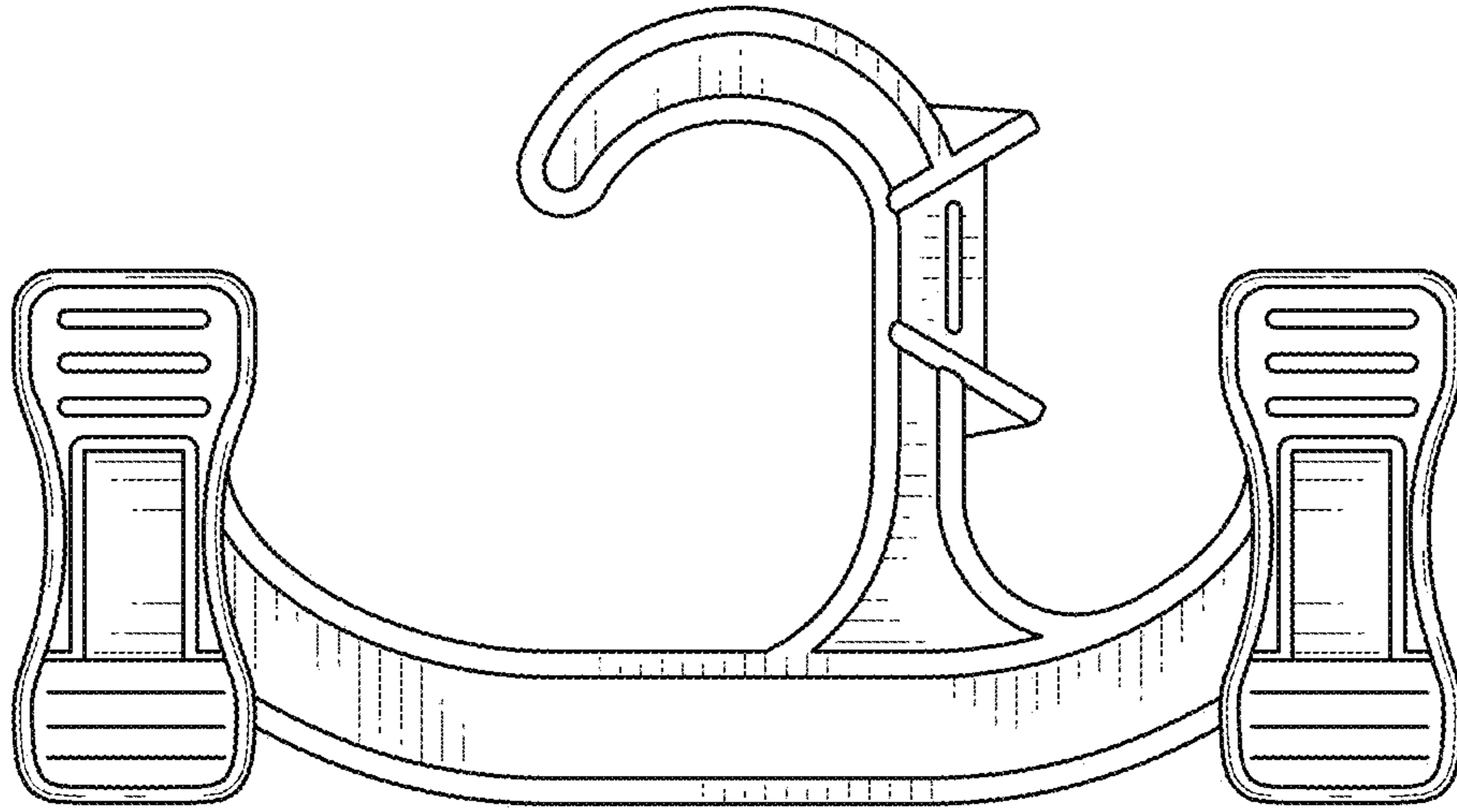

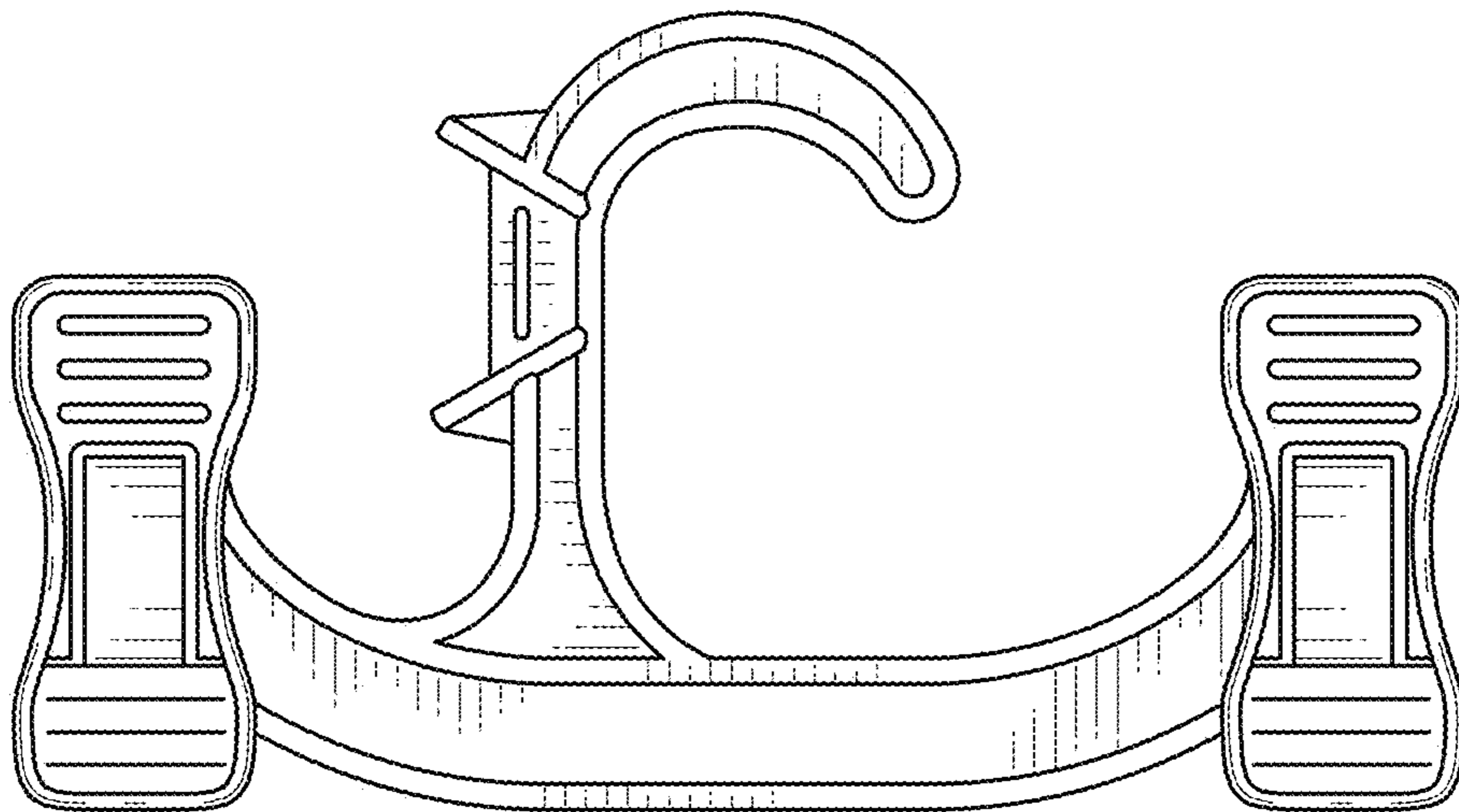

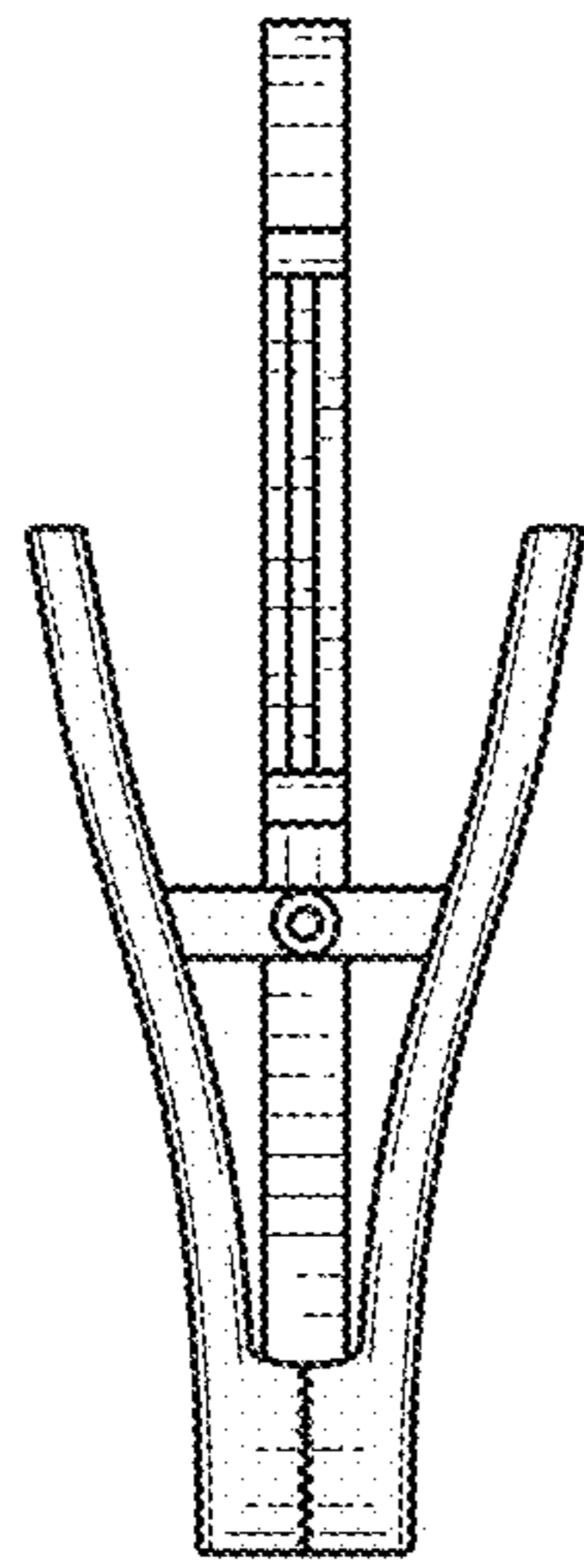

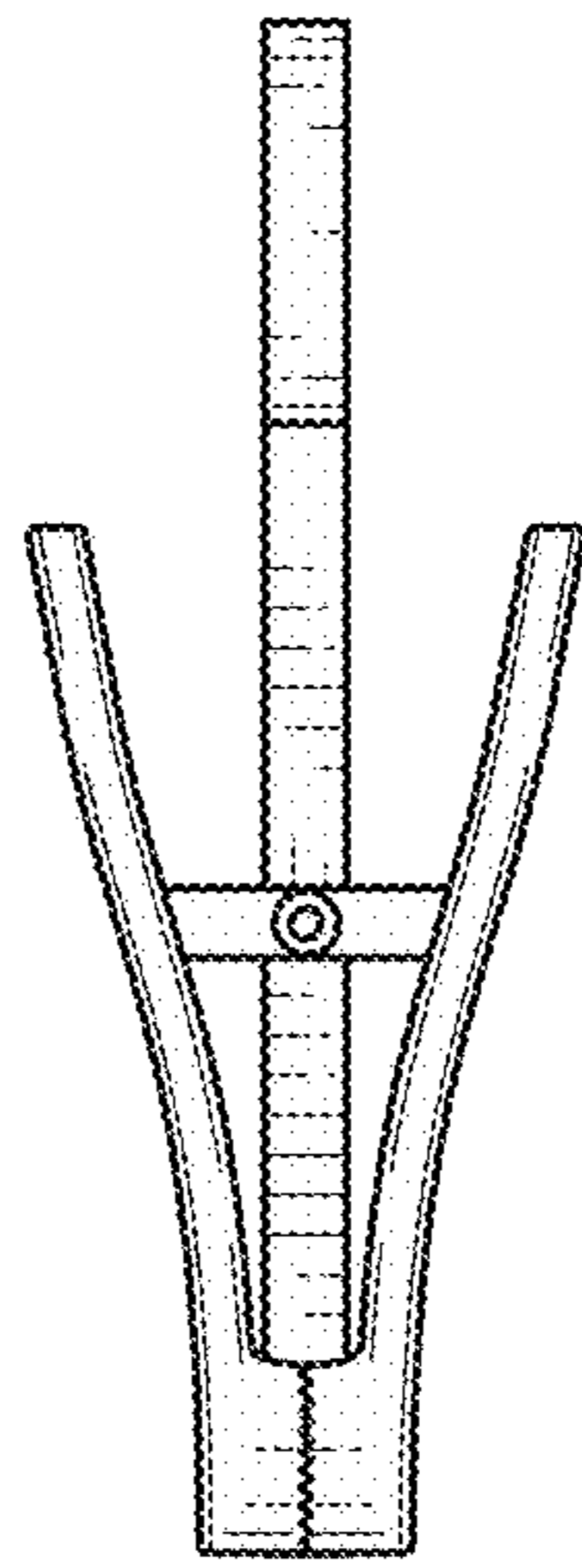

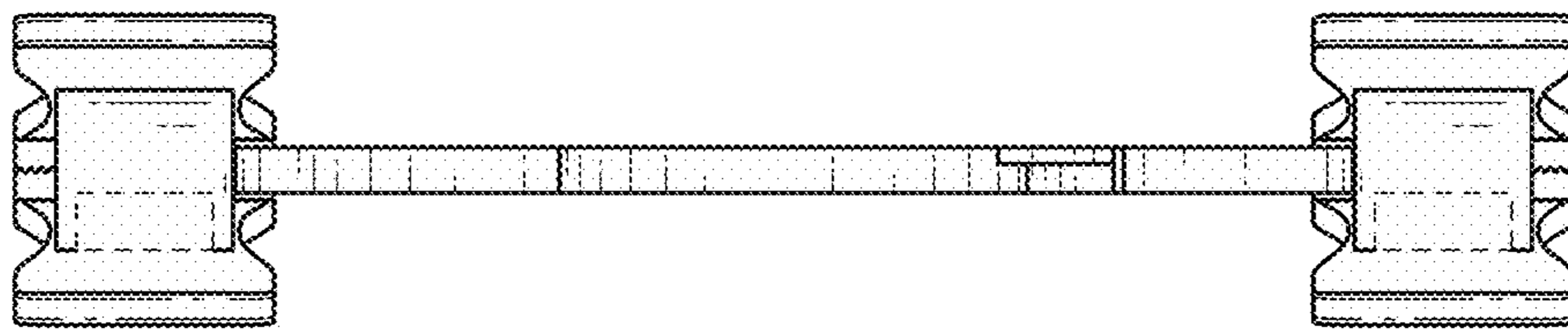

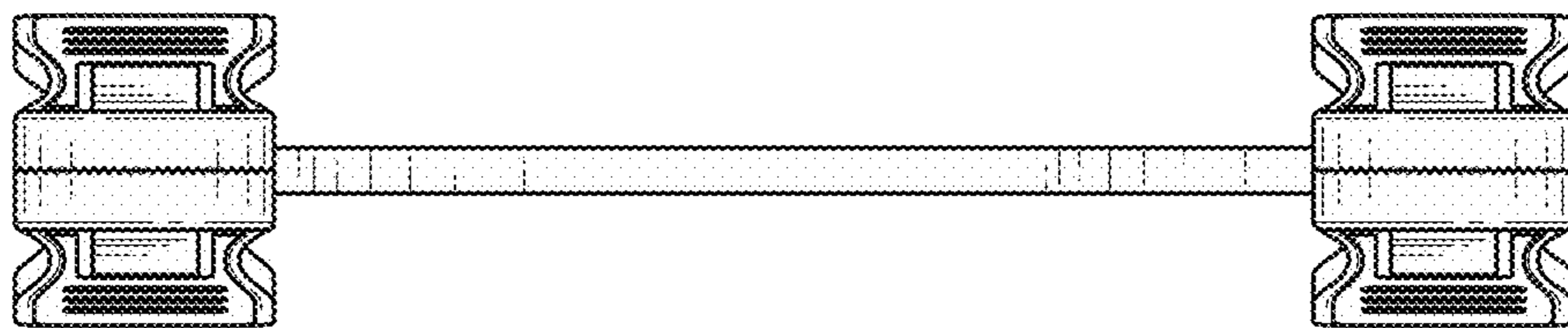
