I claim the ornamental design for a console, as shown and described.

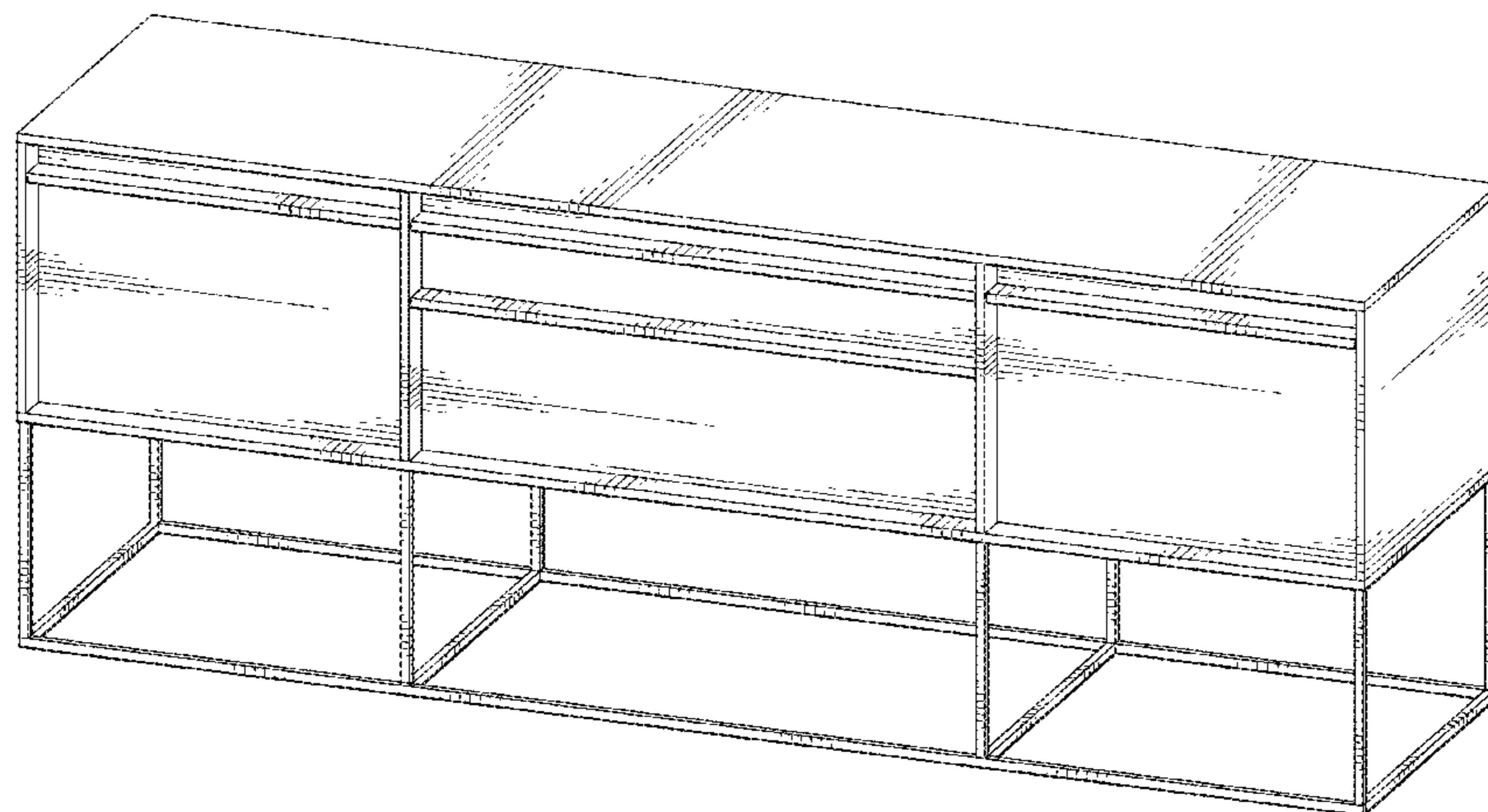
DESCRIPTION

FIG. 1 is an upper front right perspective view of a console of Applicant's design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a top plan view thereof;

FIG. 6 is a right-side elevational view thereof, the left-side elevational view being a mirror image thereof; and,

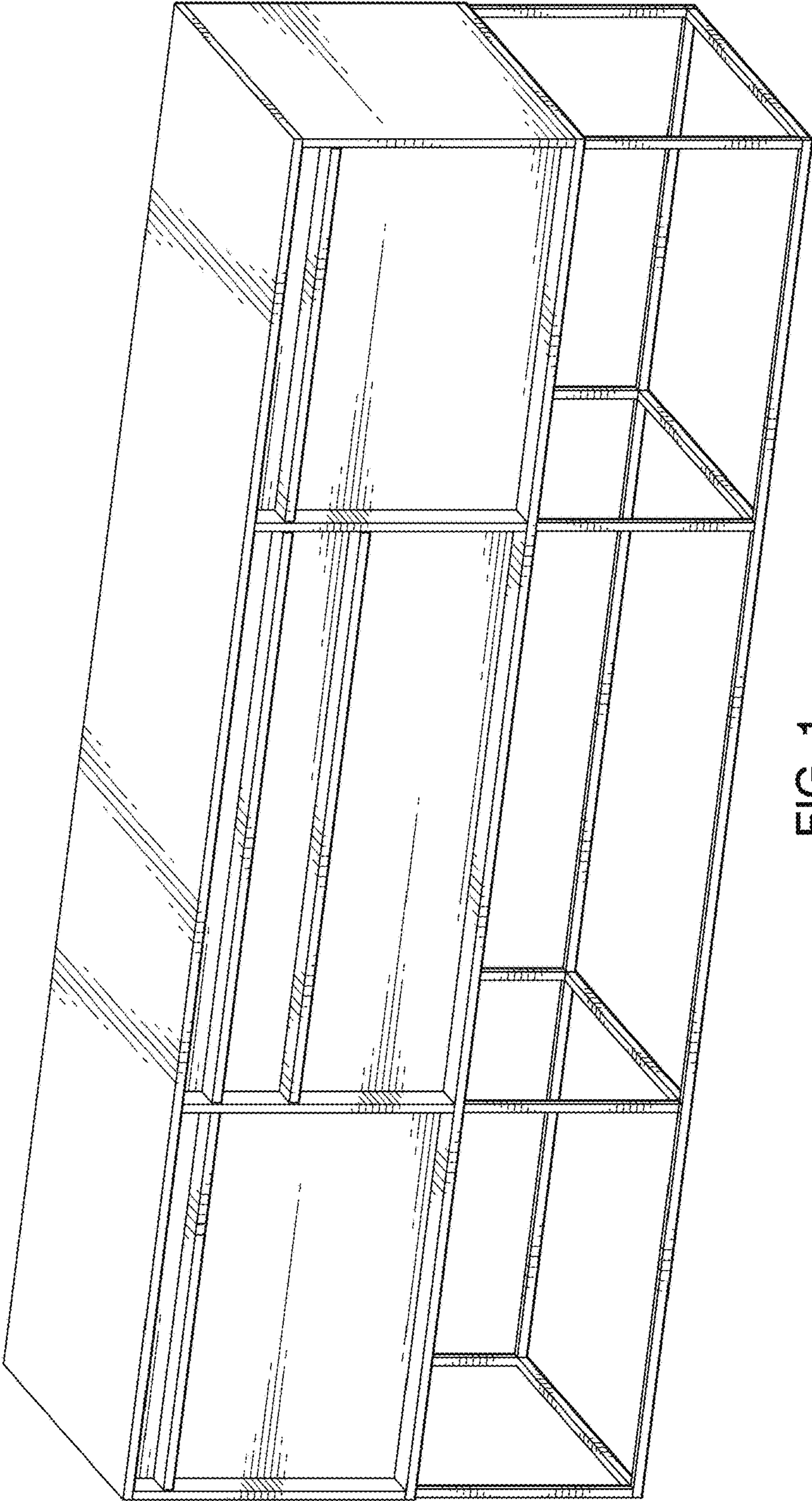

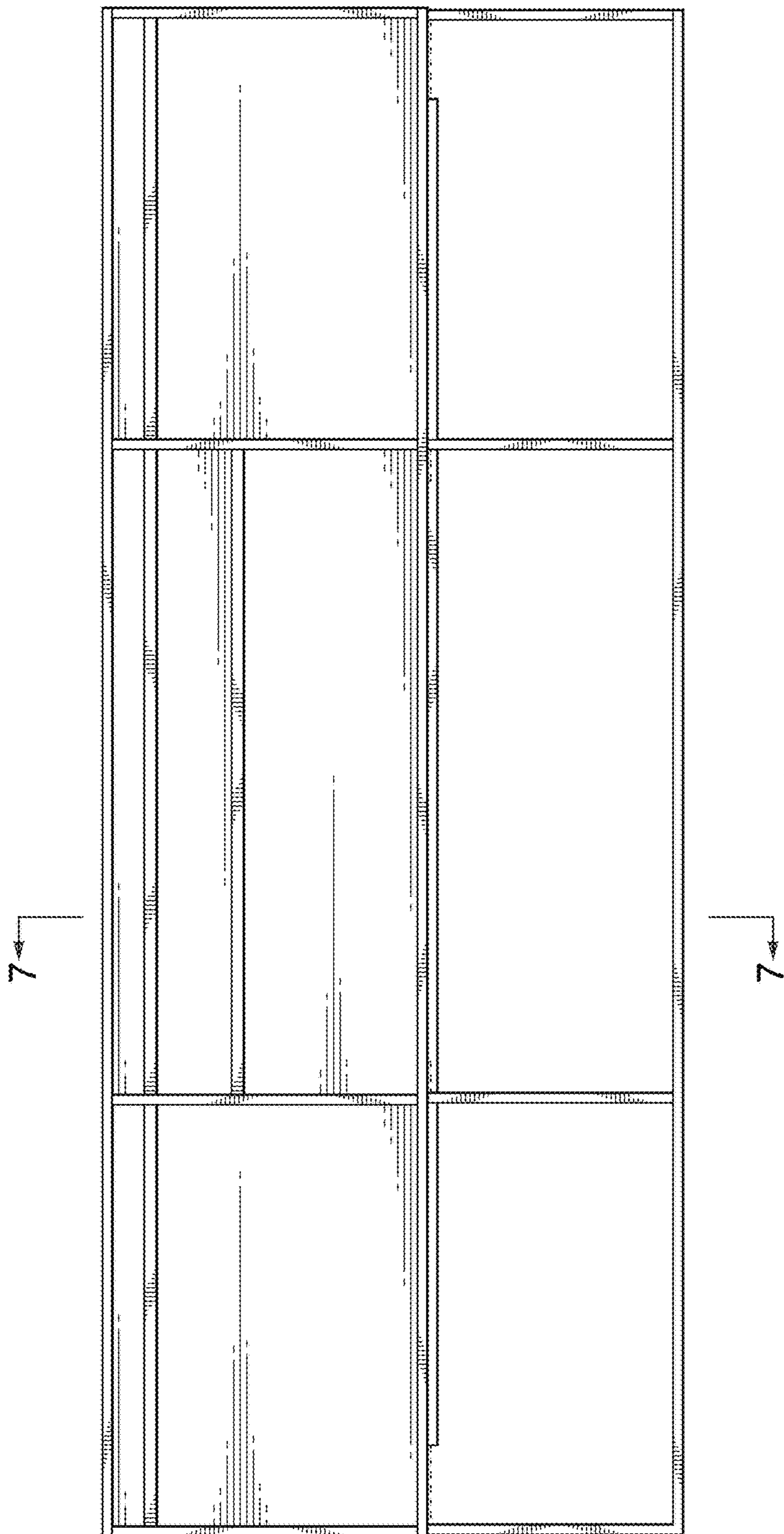

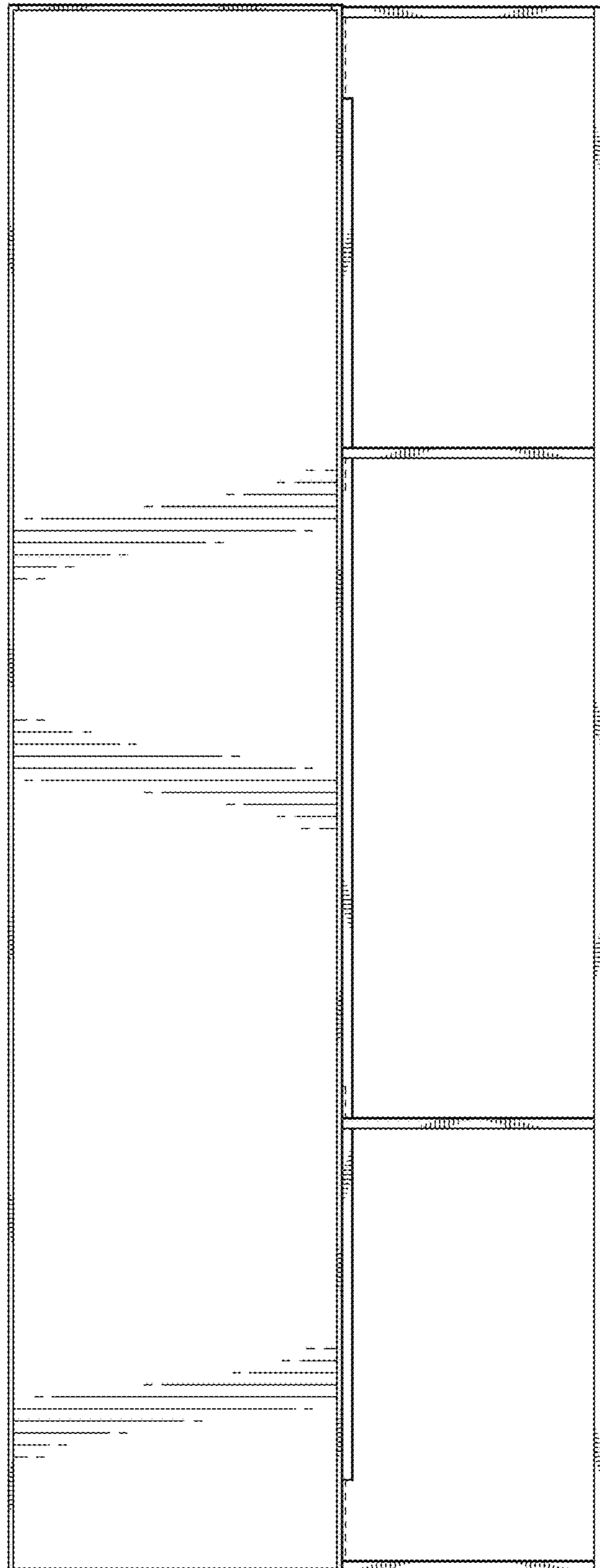

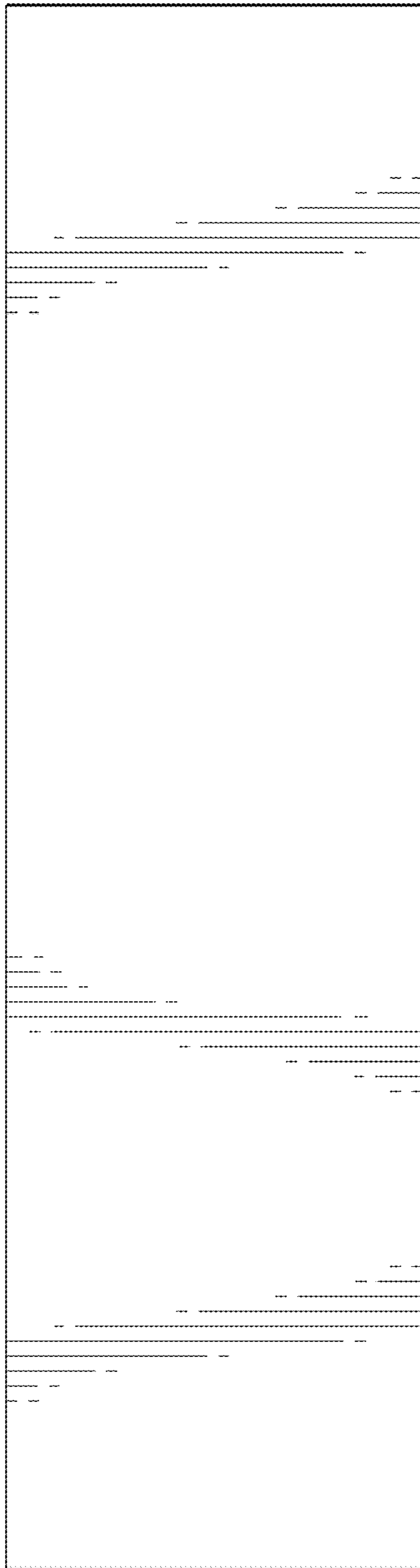

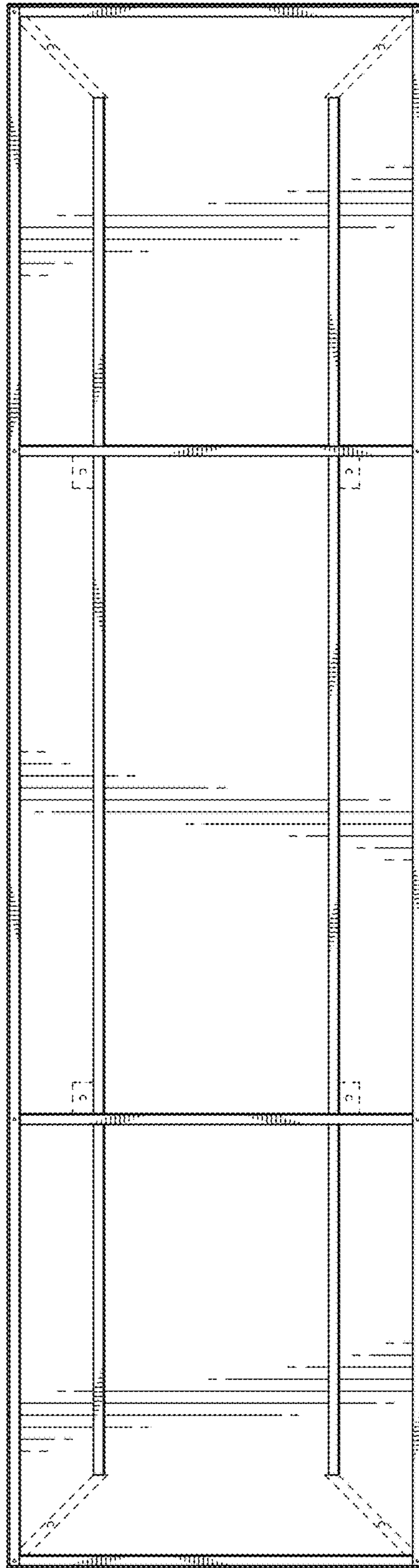

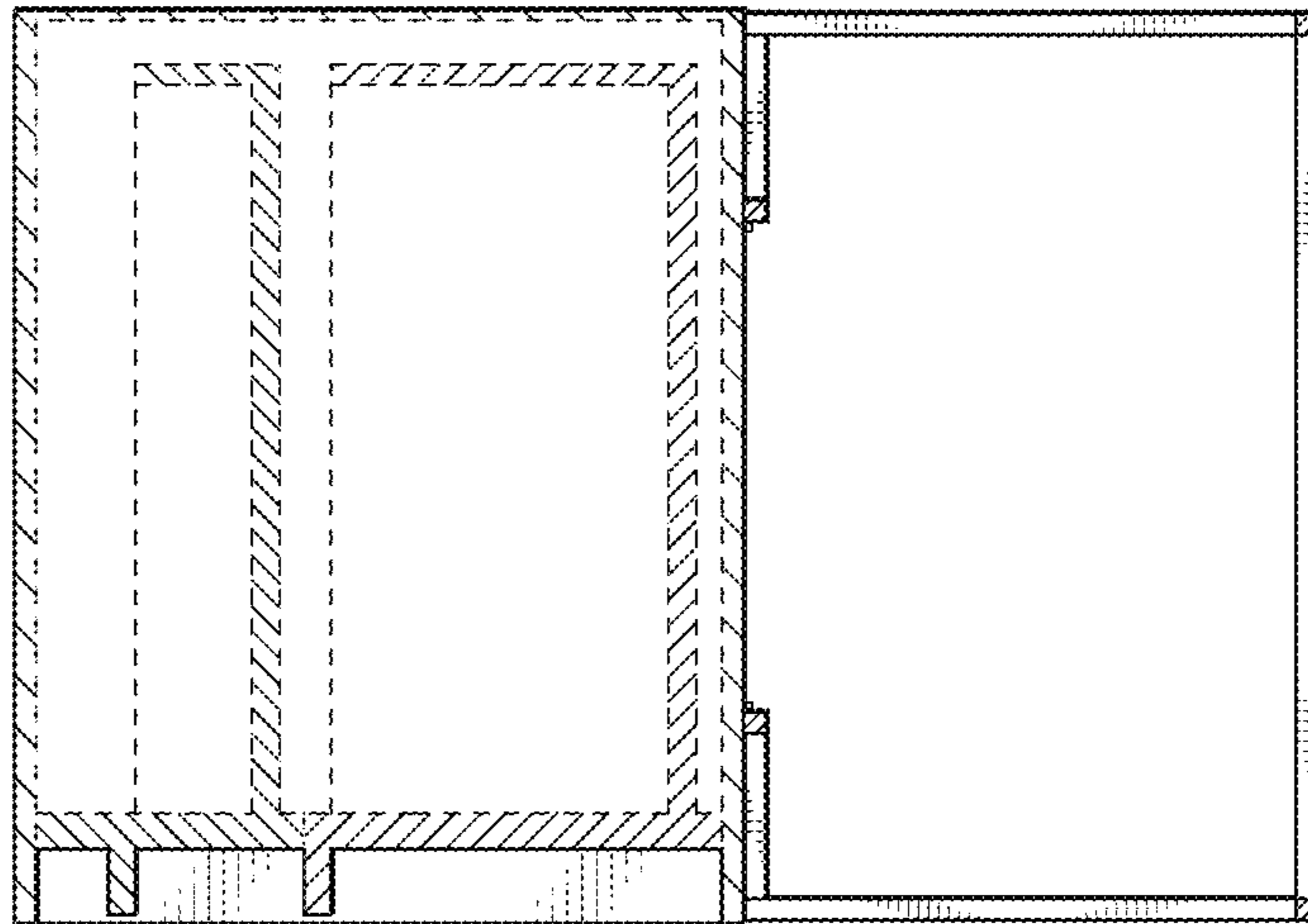

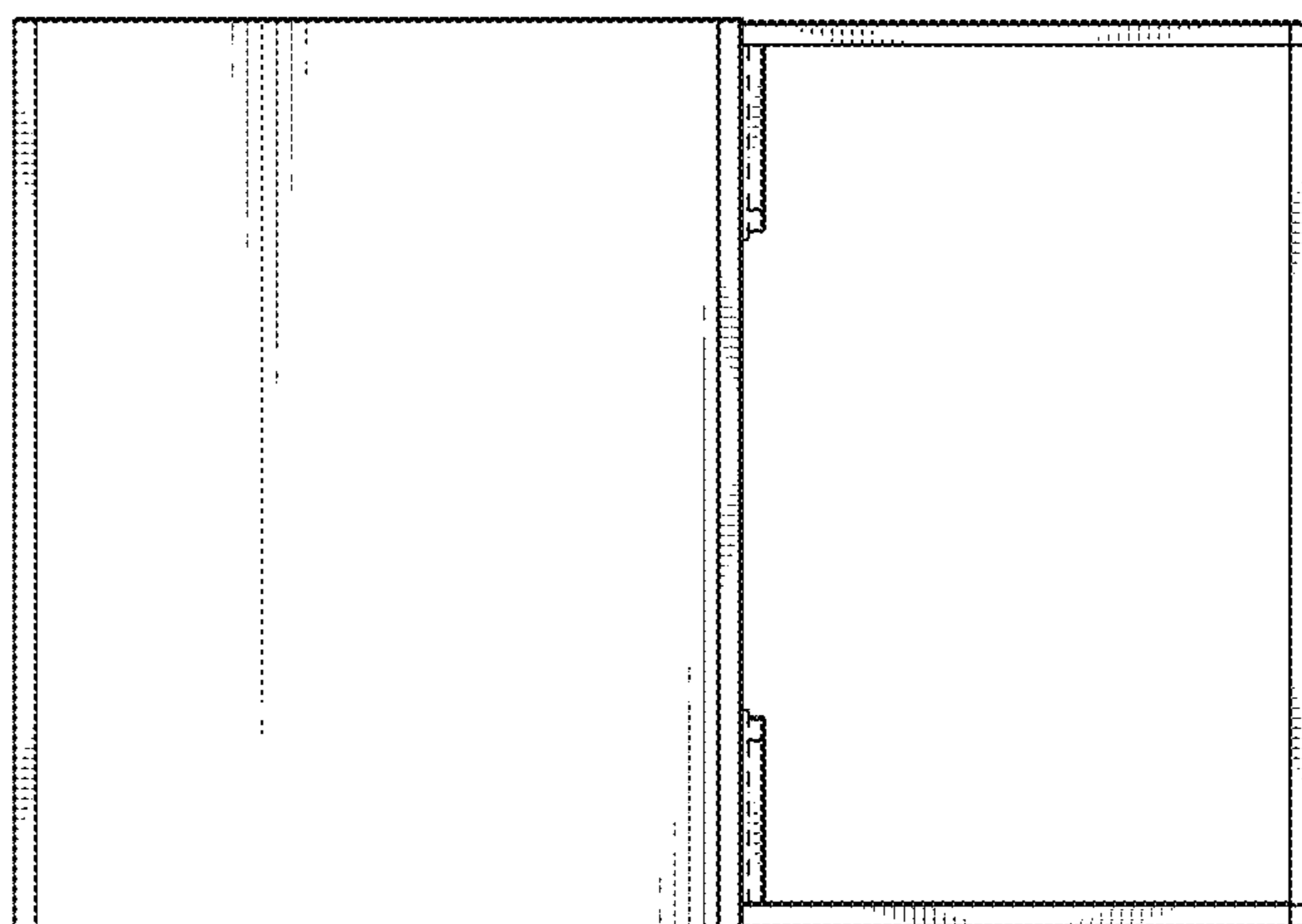
