The ornamental design for a side table, as shown and described.

DESCRIPTION

FIG. 1 is perspective view of the first embodiment of a side table showing my new design;
FIG. 2 is a front elevation view thereof;

FIG. 5 is a perspective view of the second embodiment of a side table showing my new design;

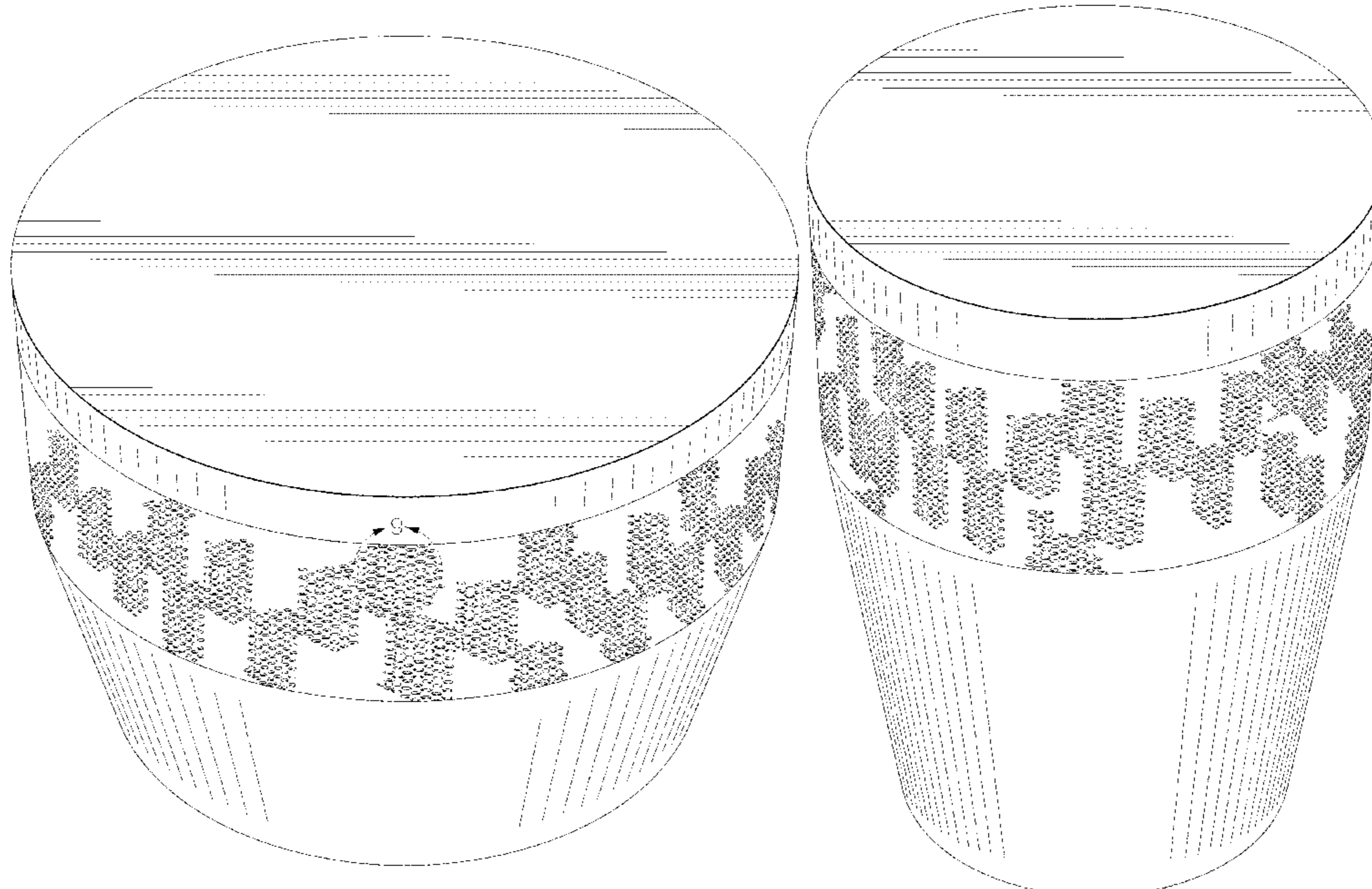

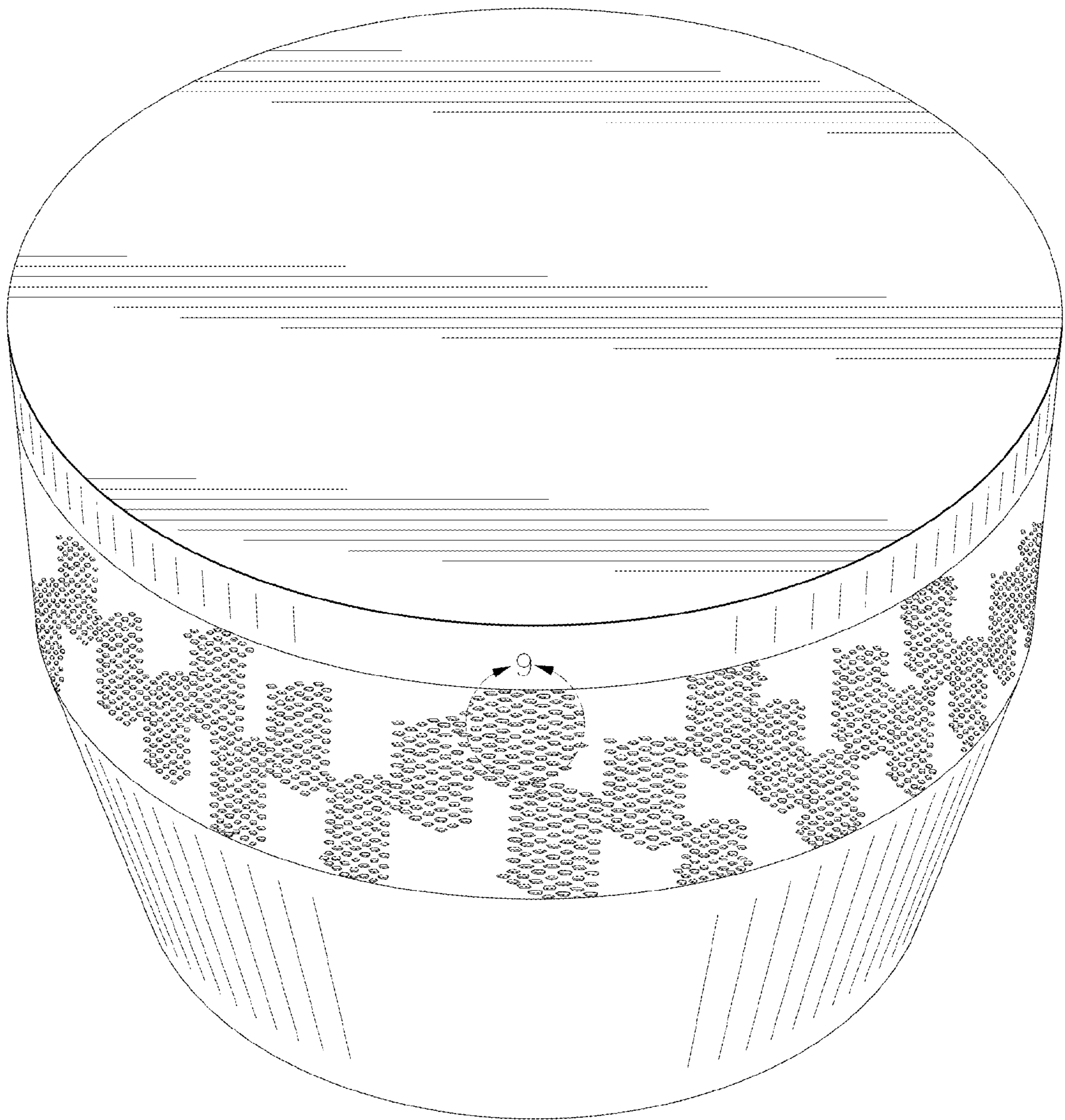

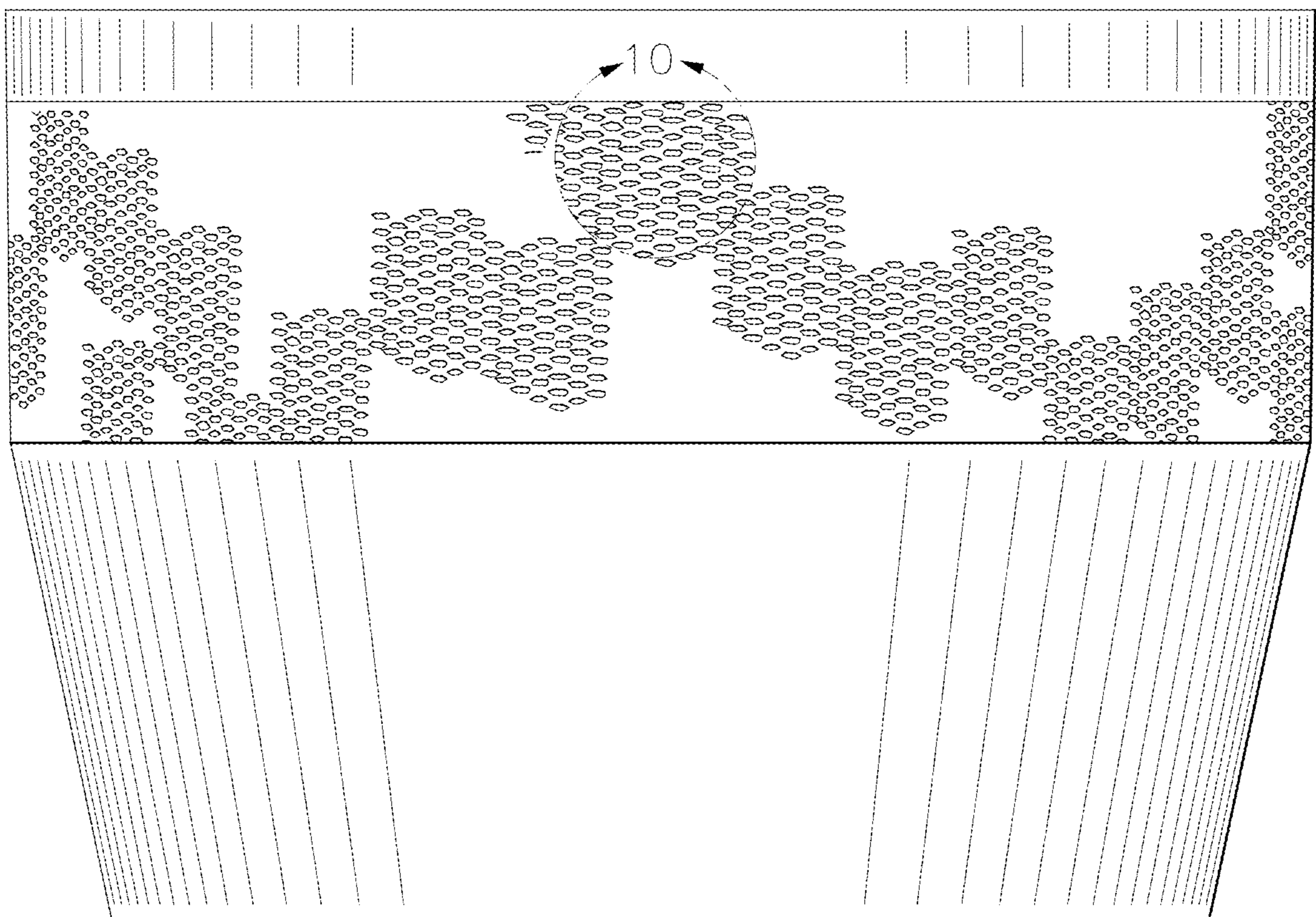

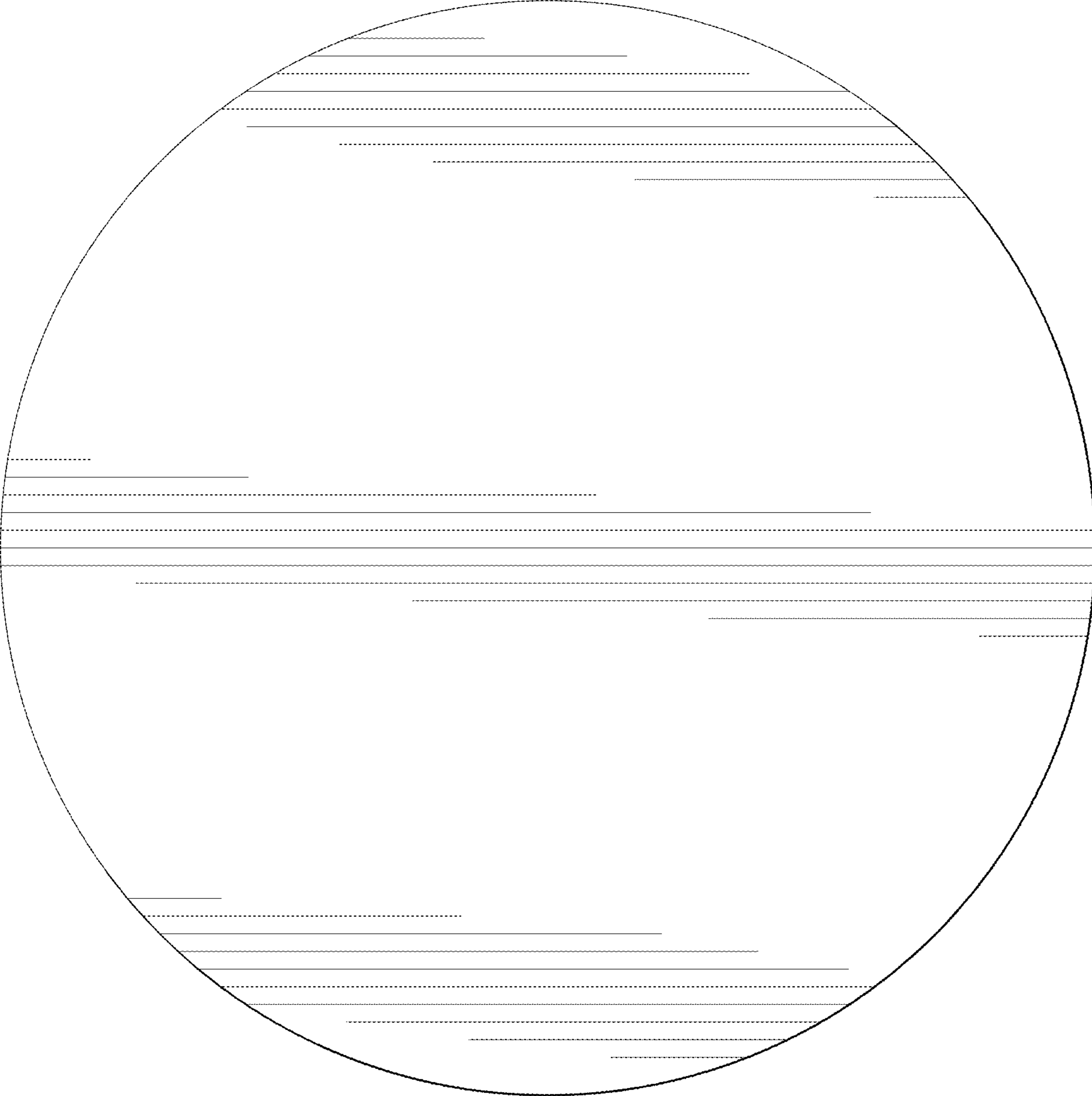

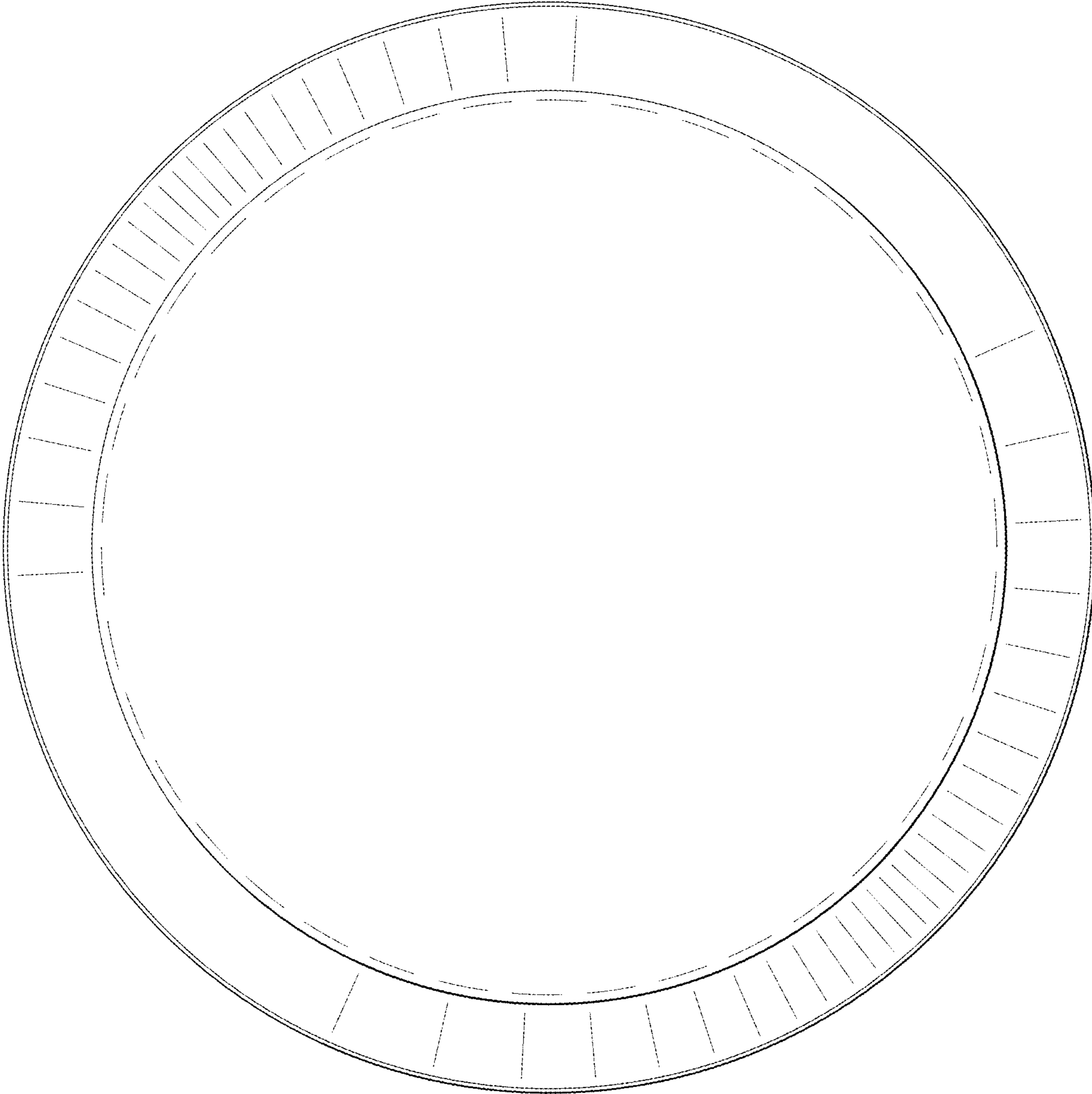

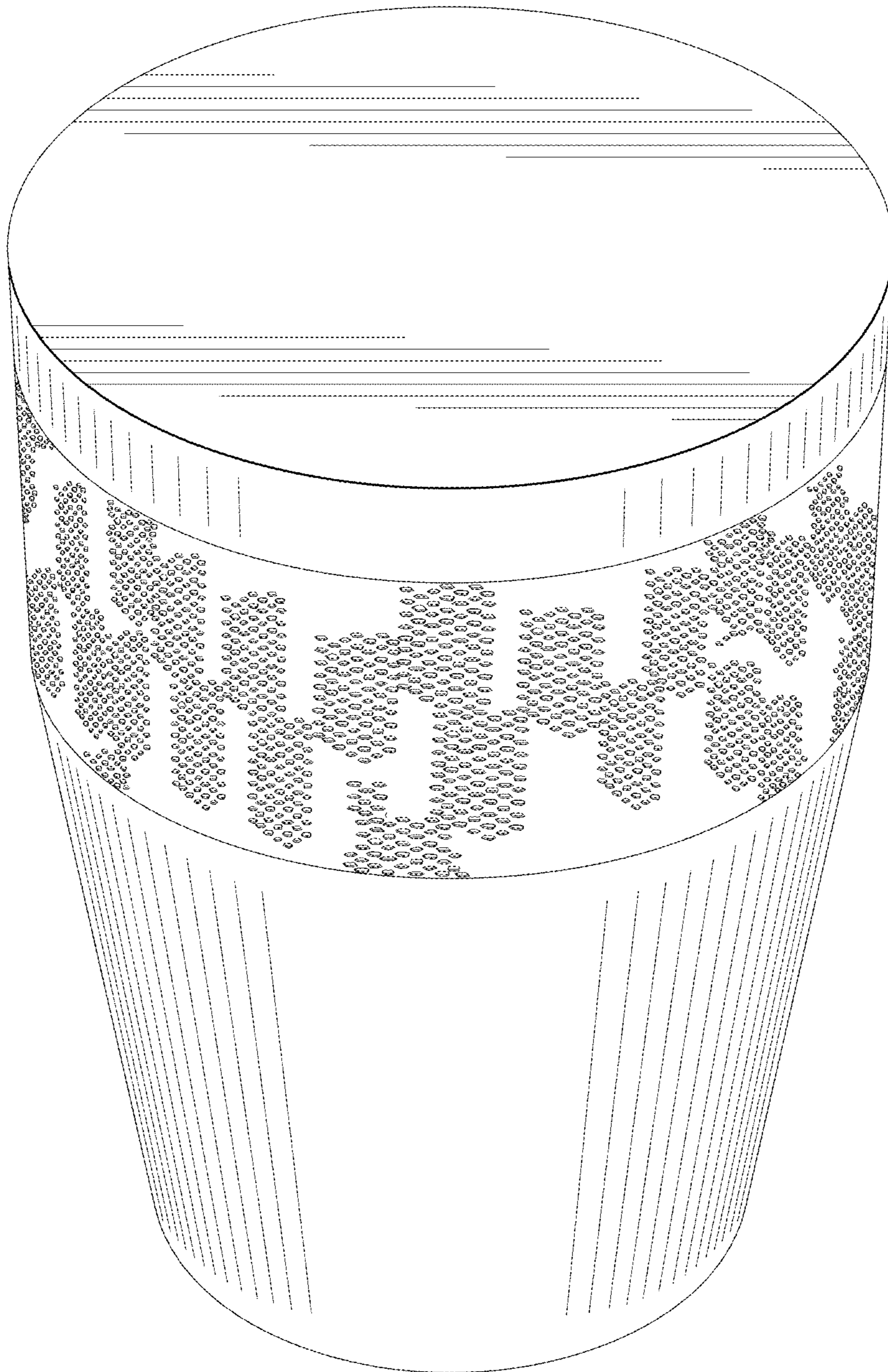

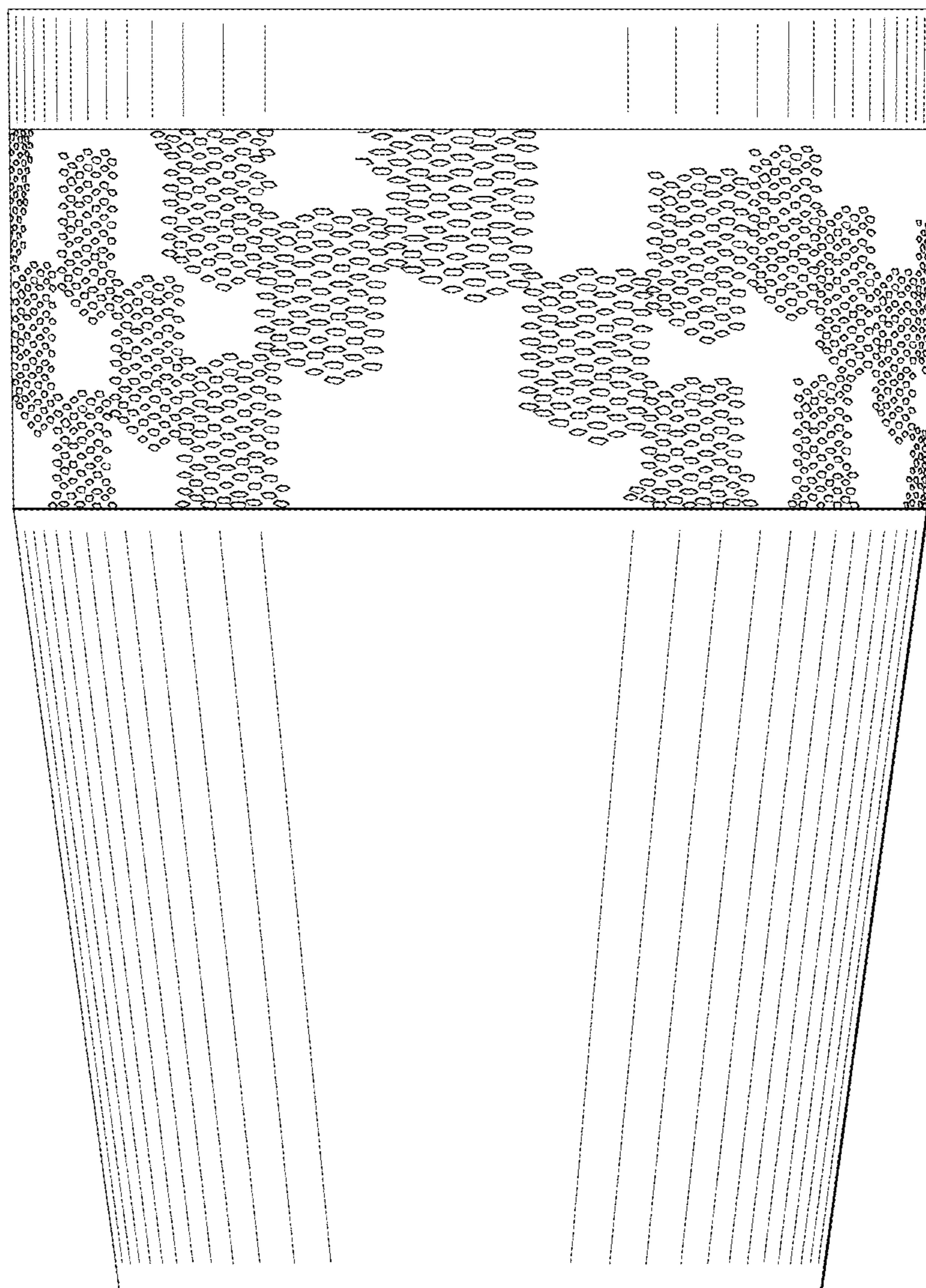

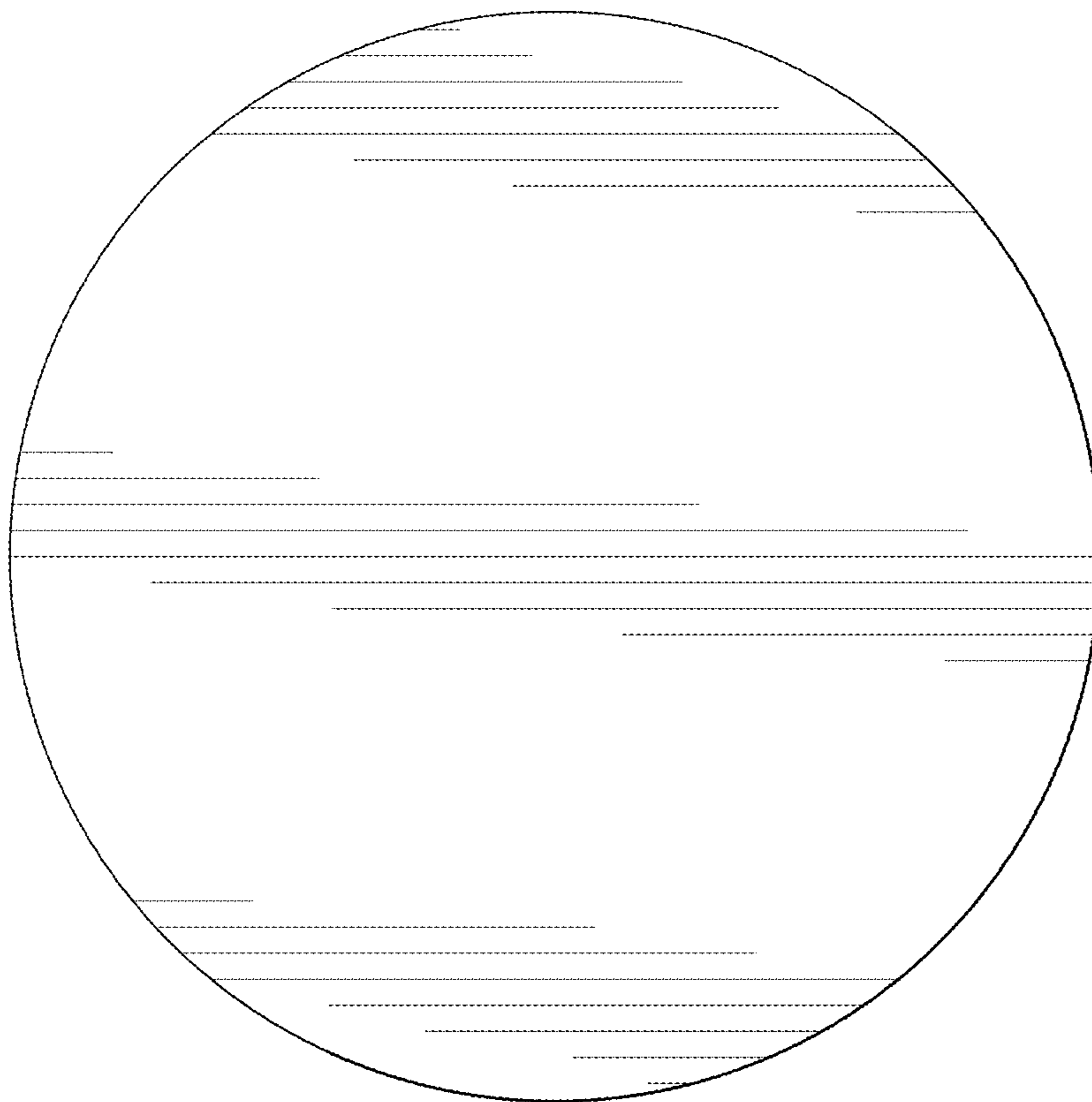

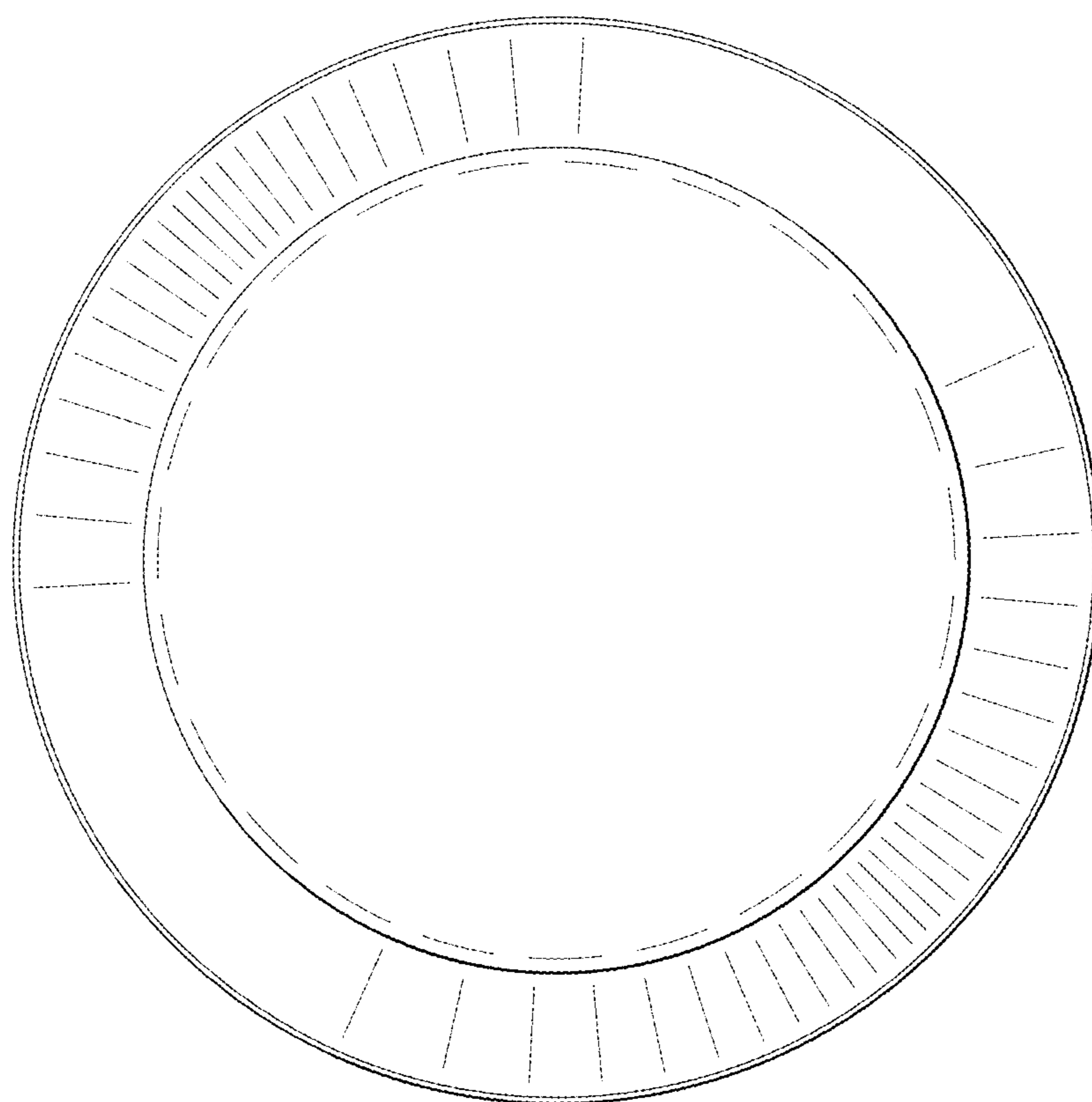

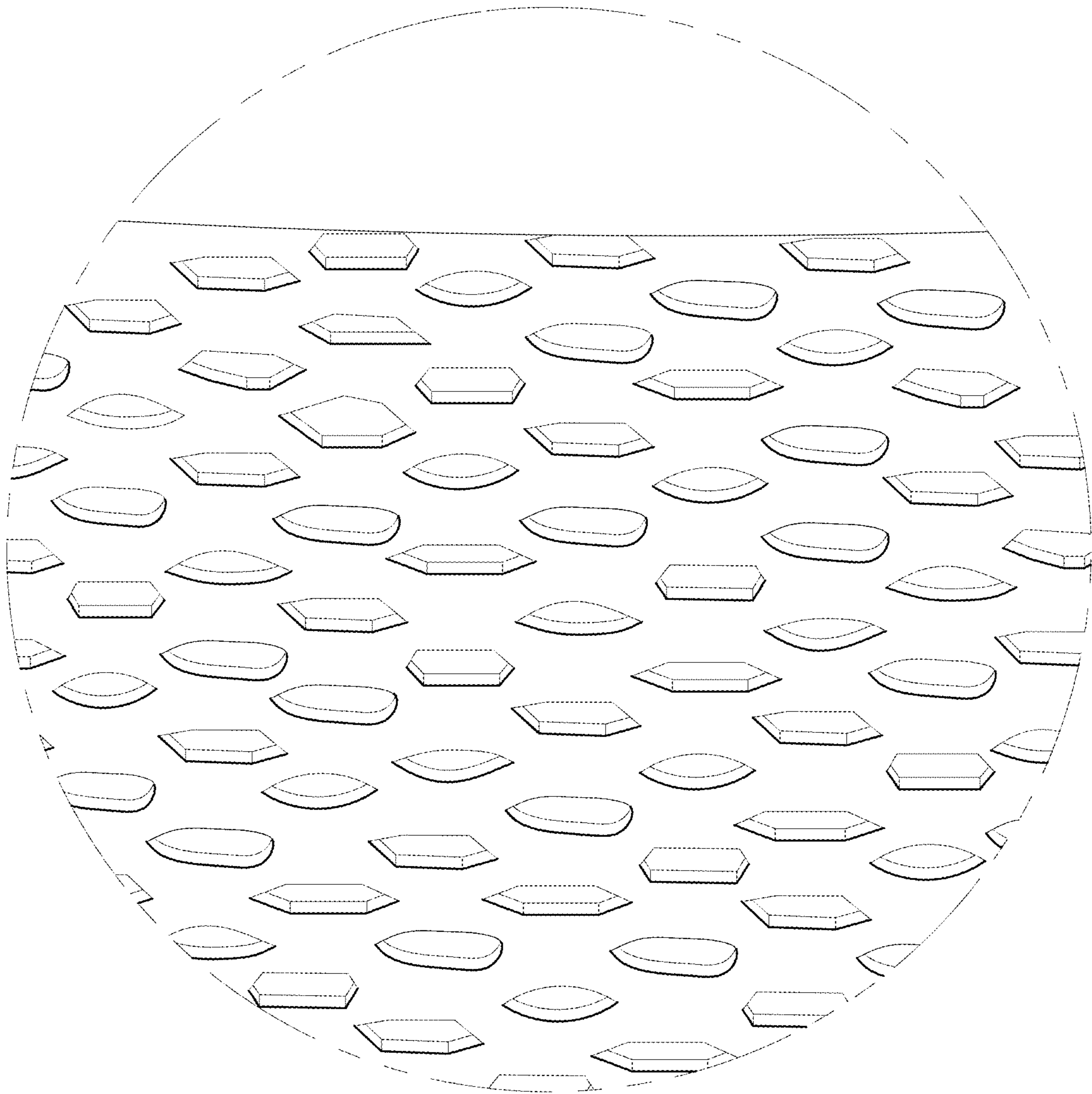
