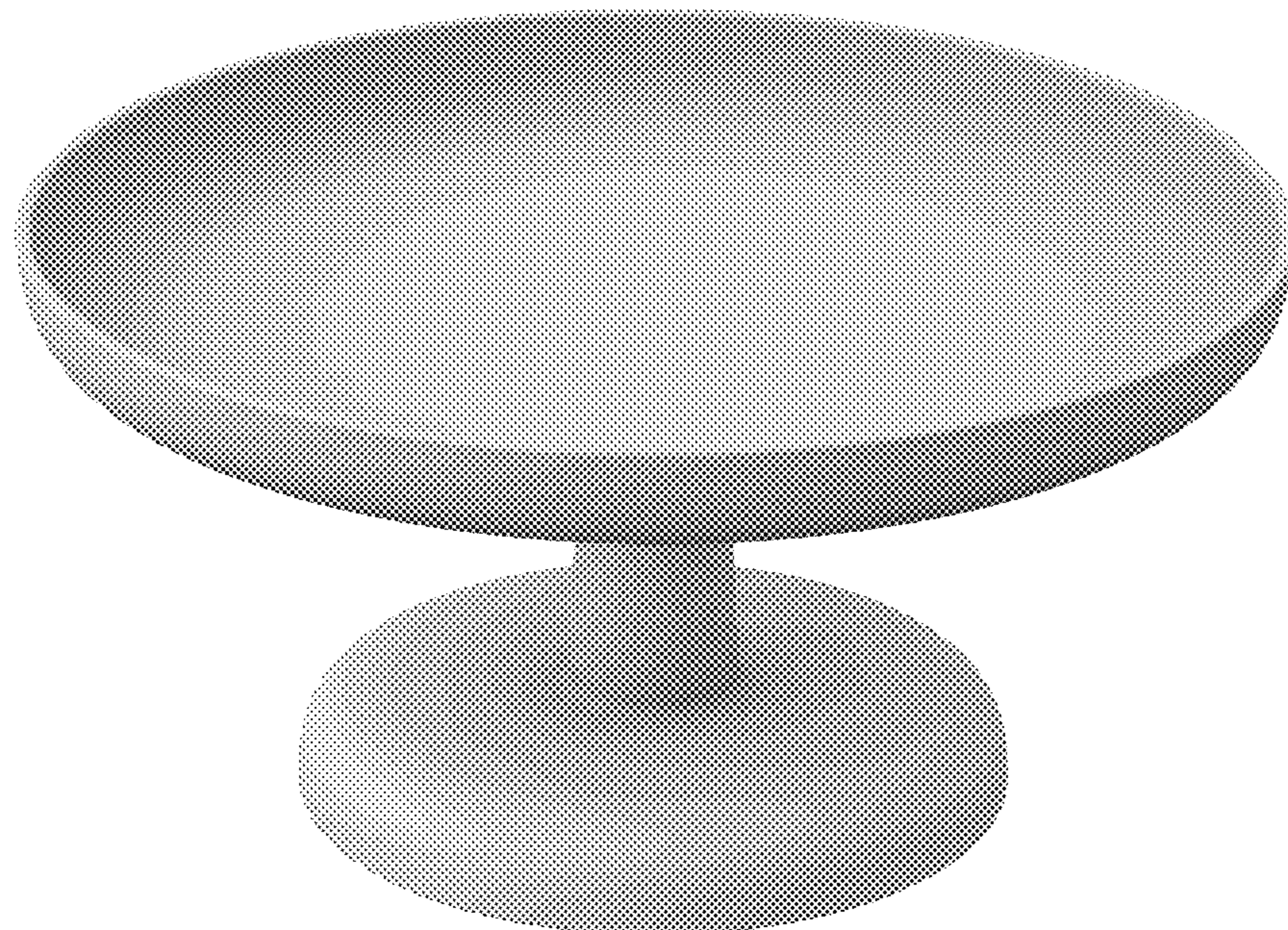
The ornamental design of a bowl, as shown and described.

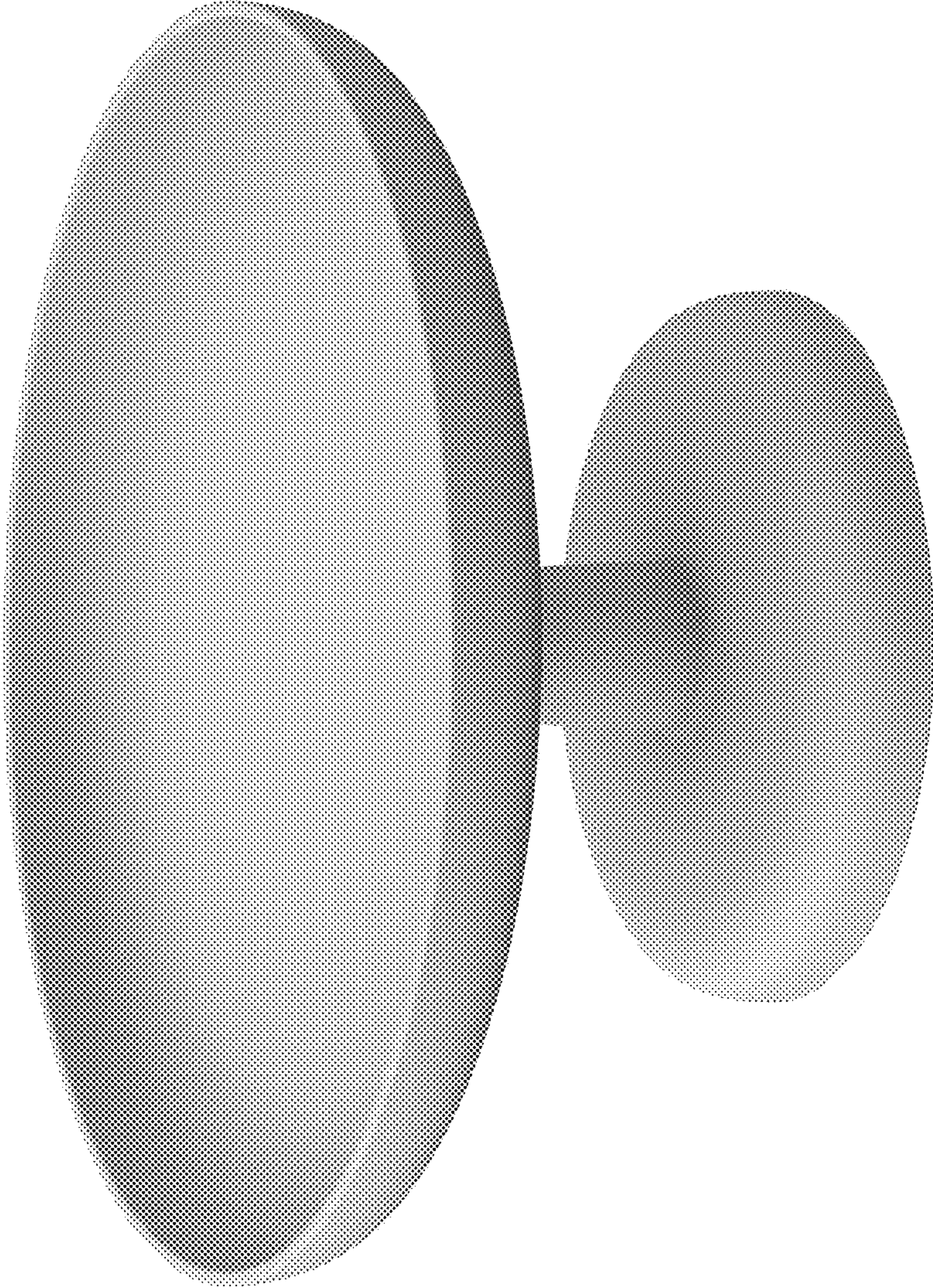

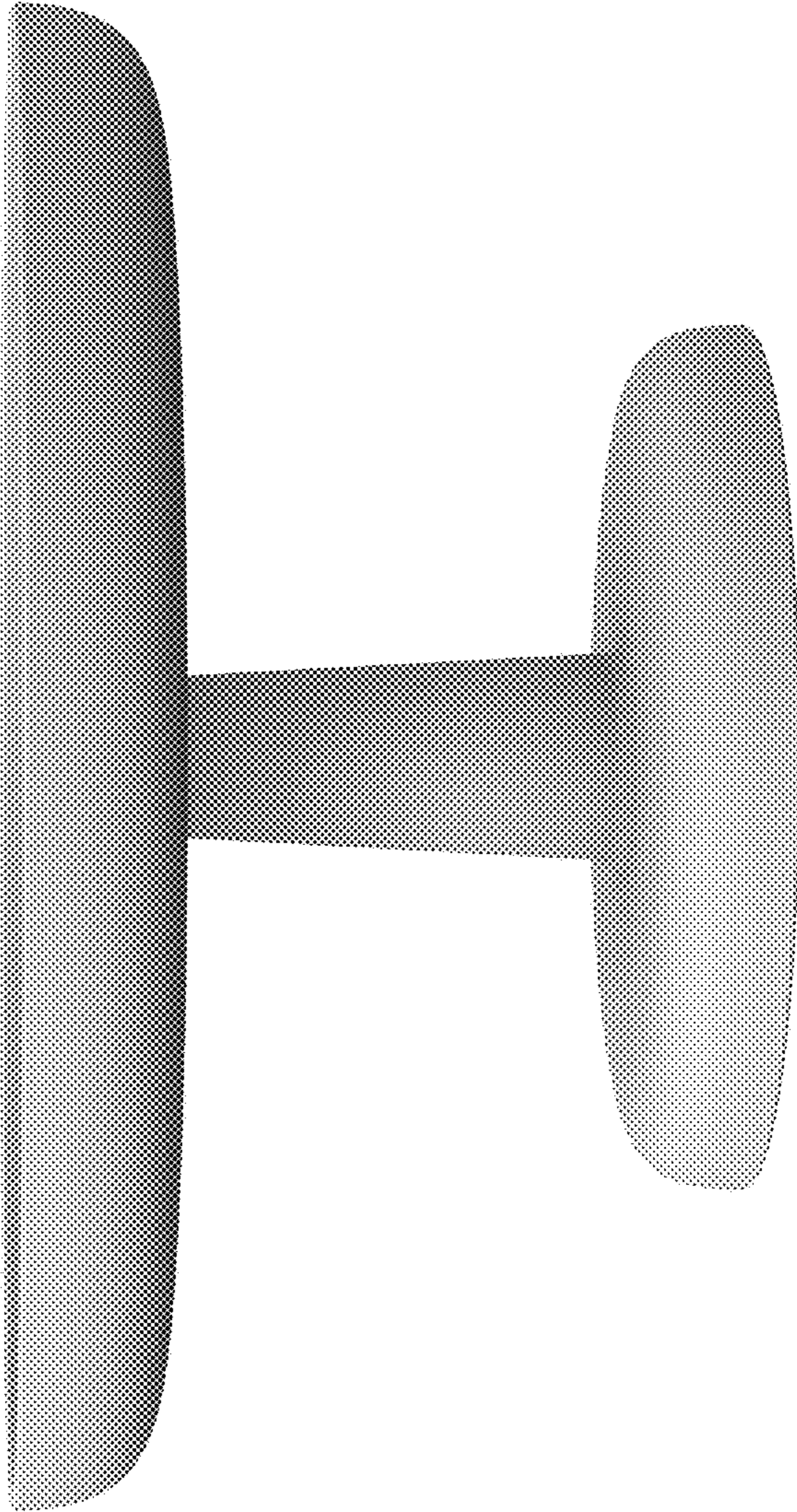

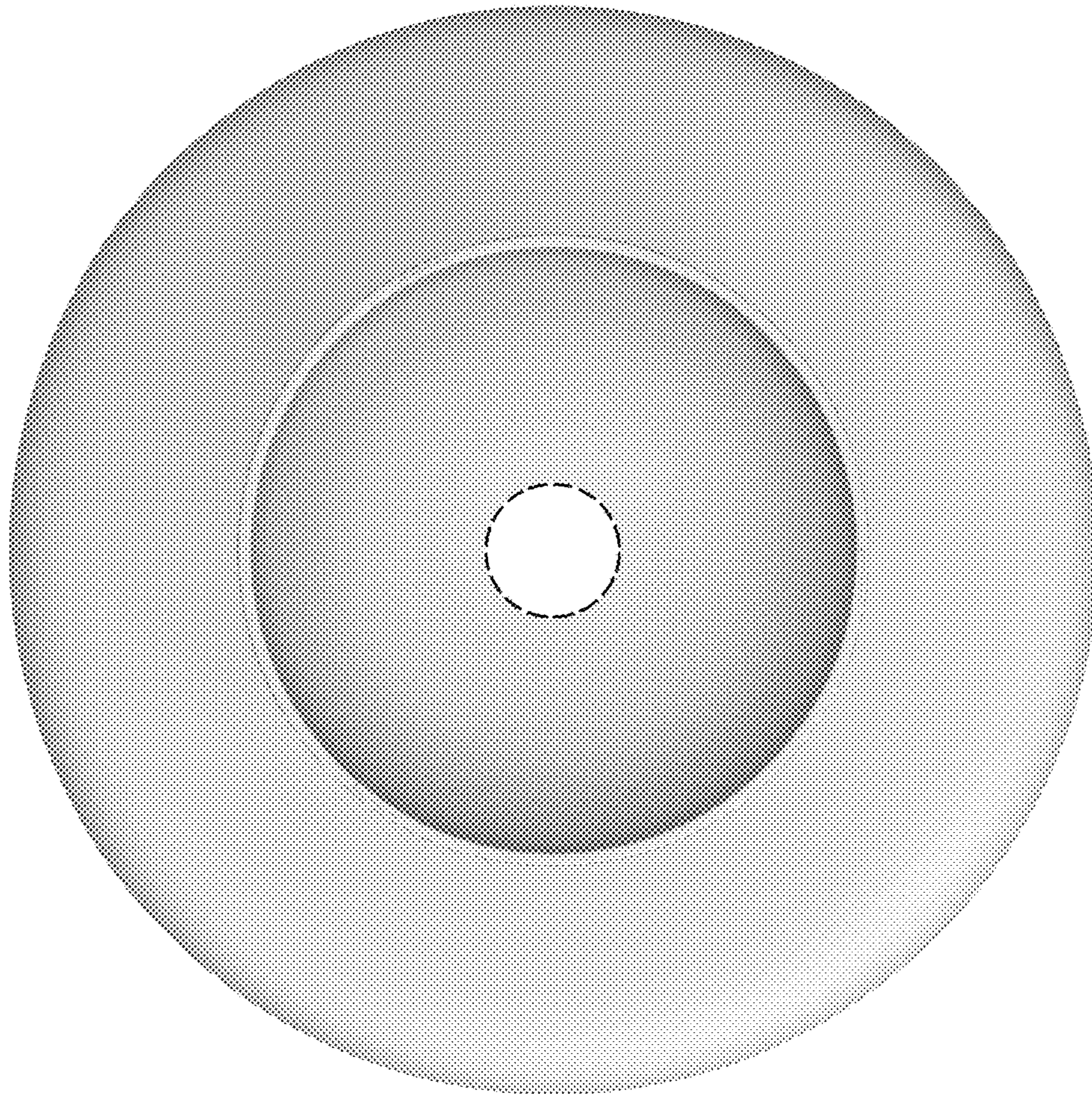
