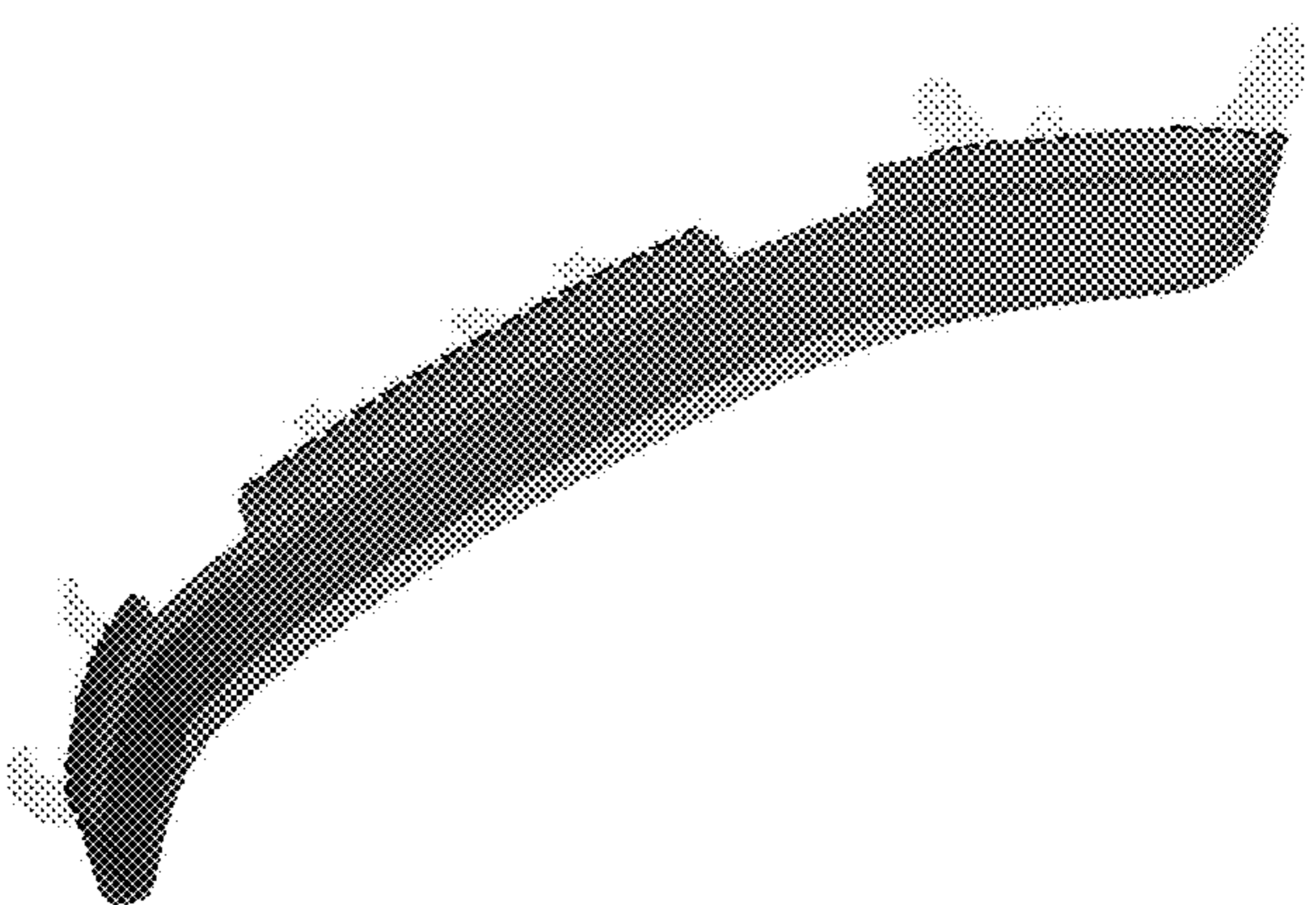
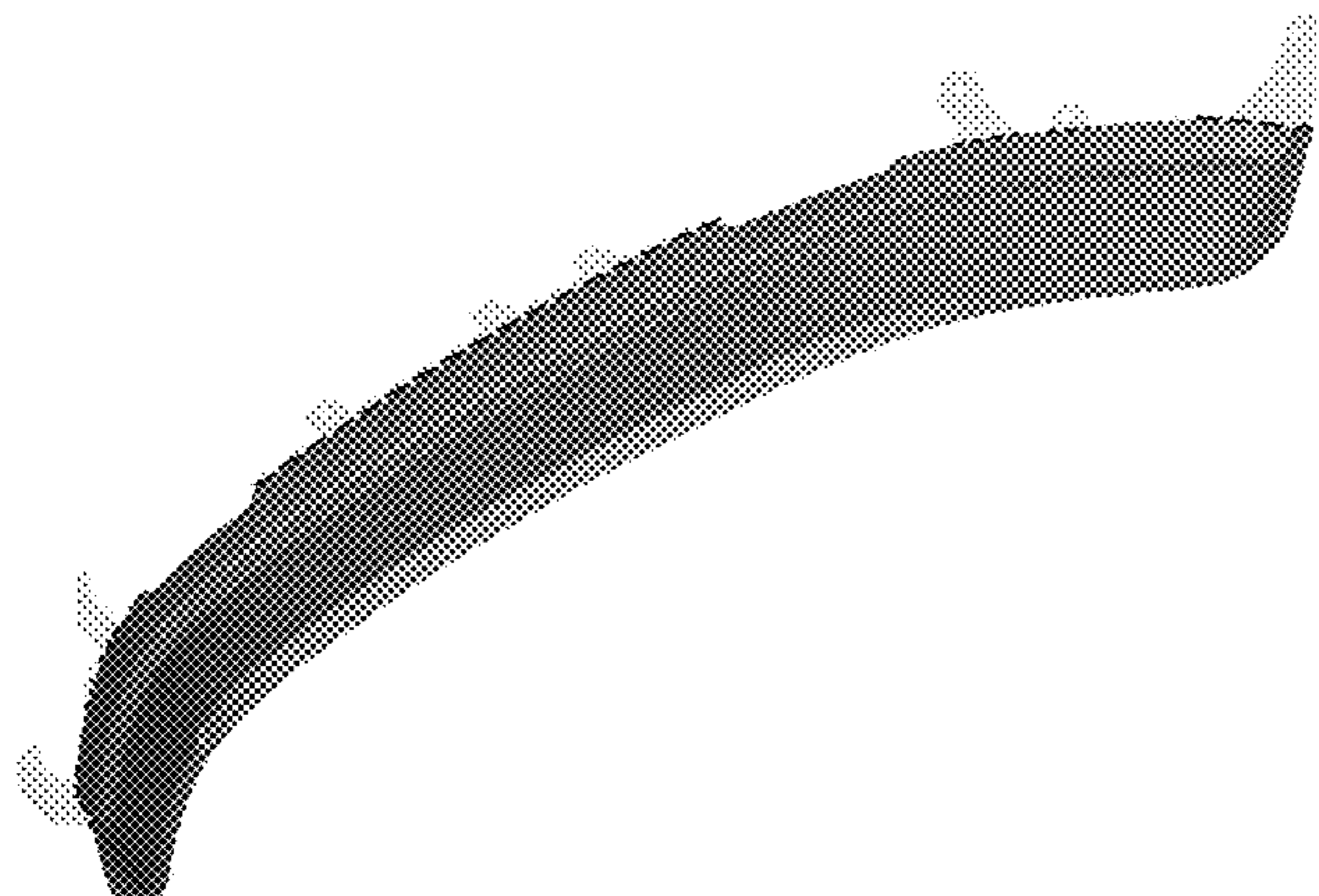
FIG. 1 is a front elevational view of a vehicle front valance, showing our new design;

Neither the broken line itself, comprising the top edge of the vehicle front valance, nor the attachment tabs and rear surface of the vehicle front valance shown in half-tone shading form any part of the claimed design.

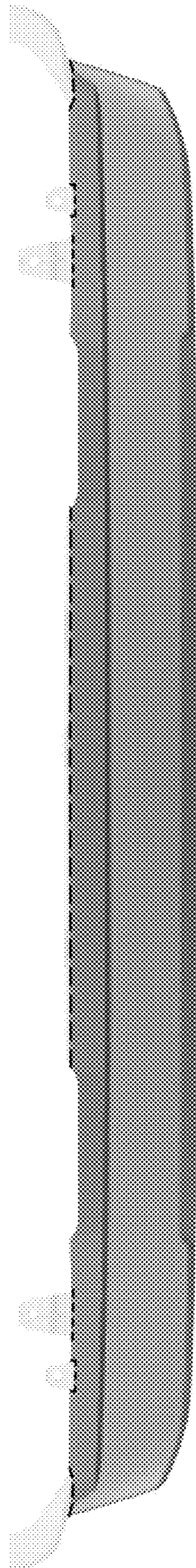

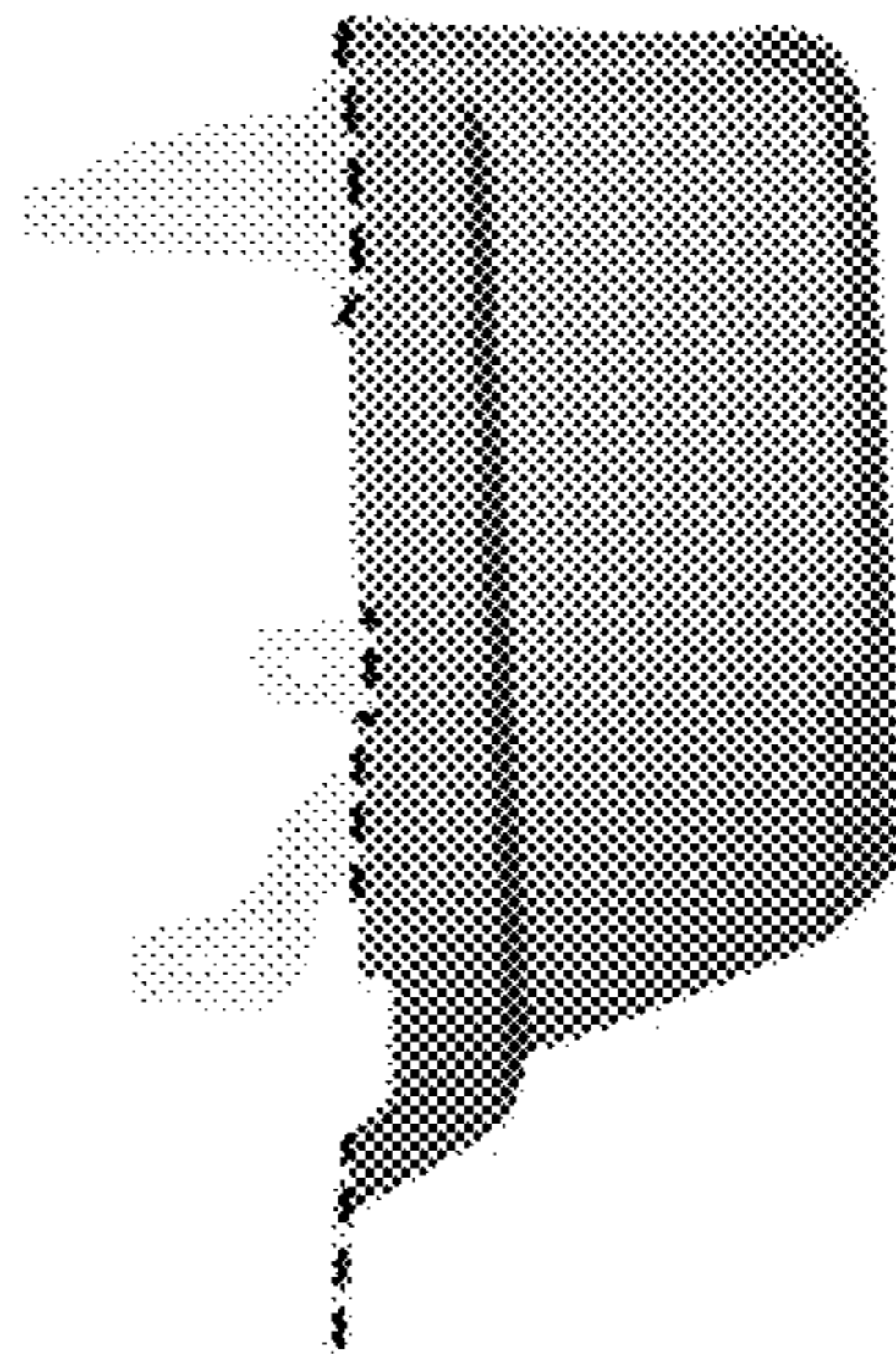

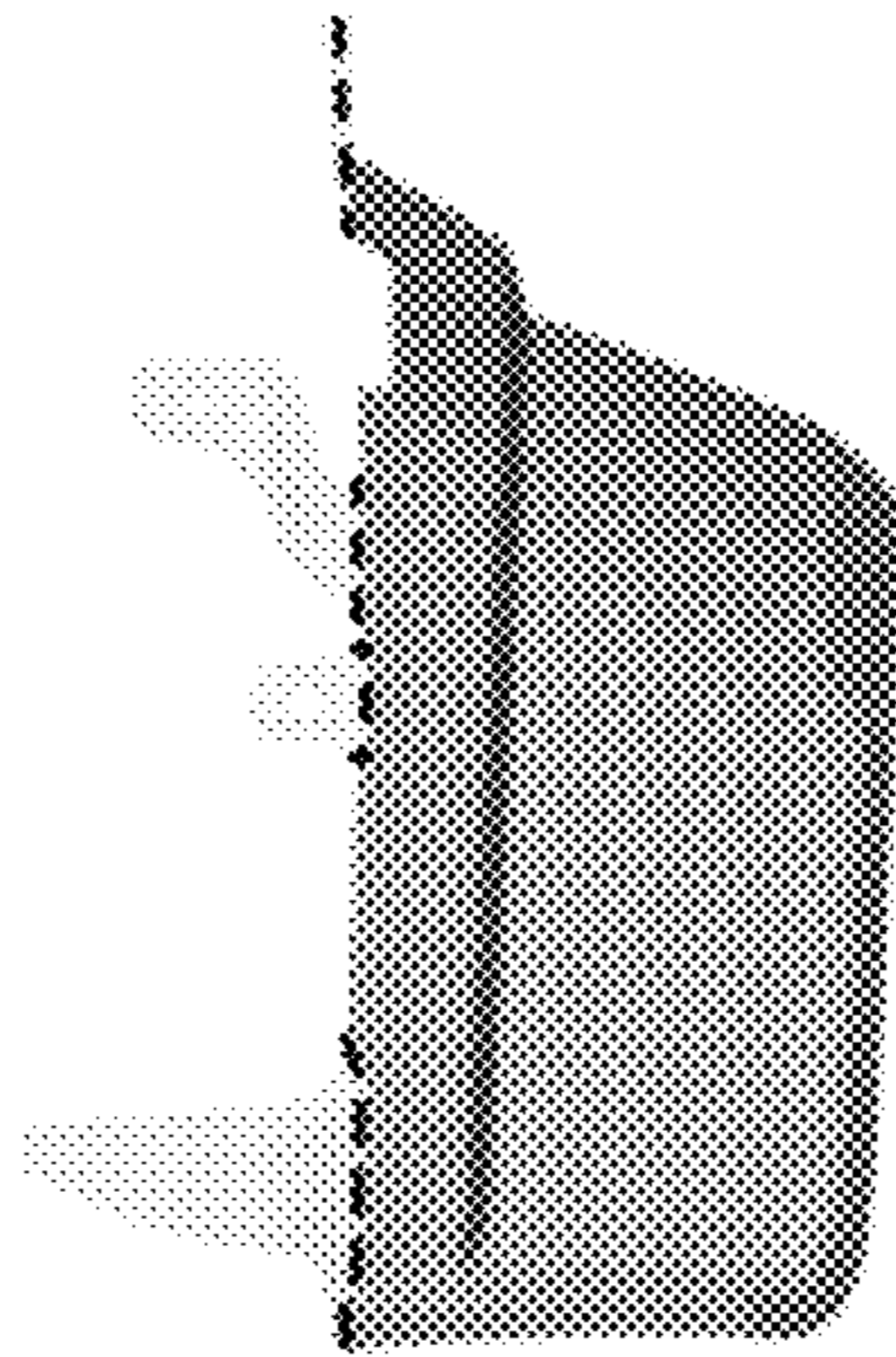

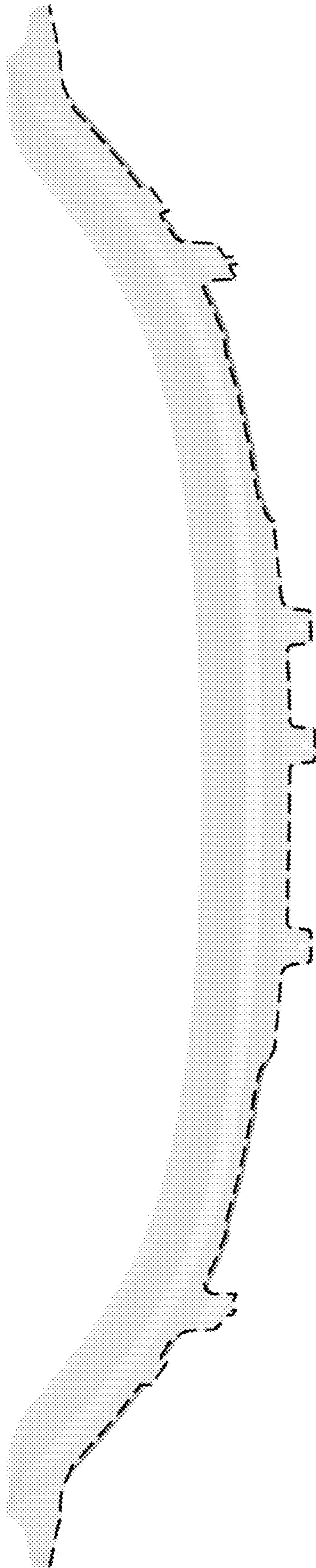
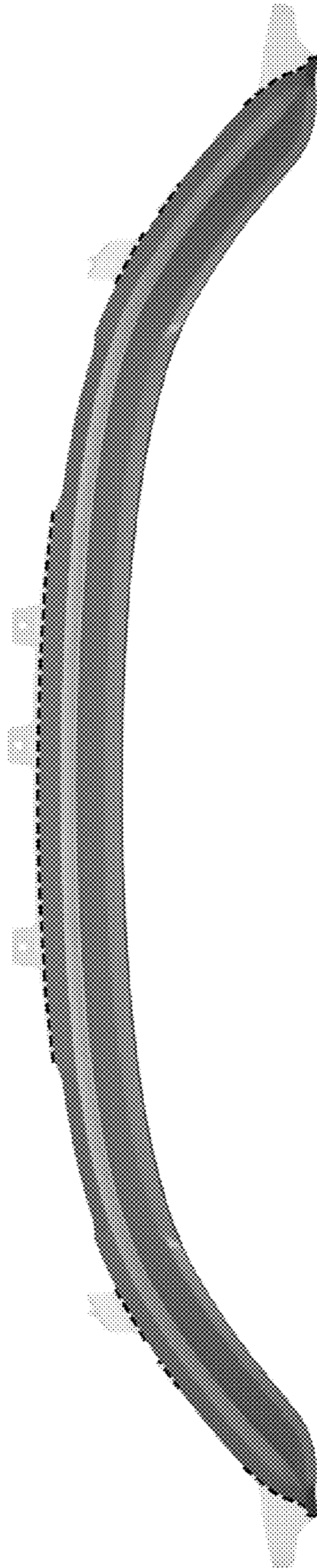

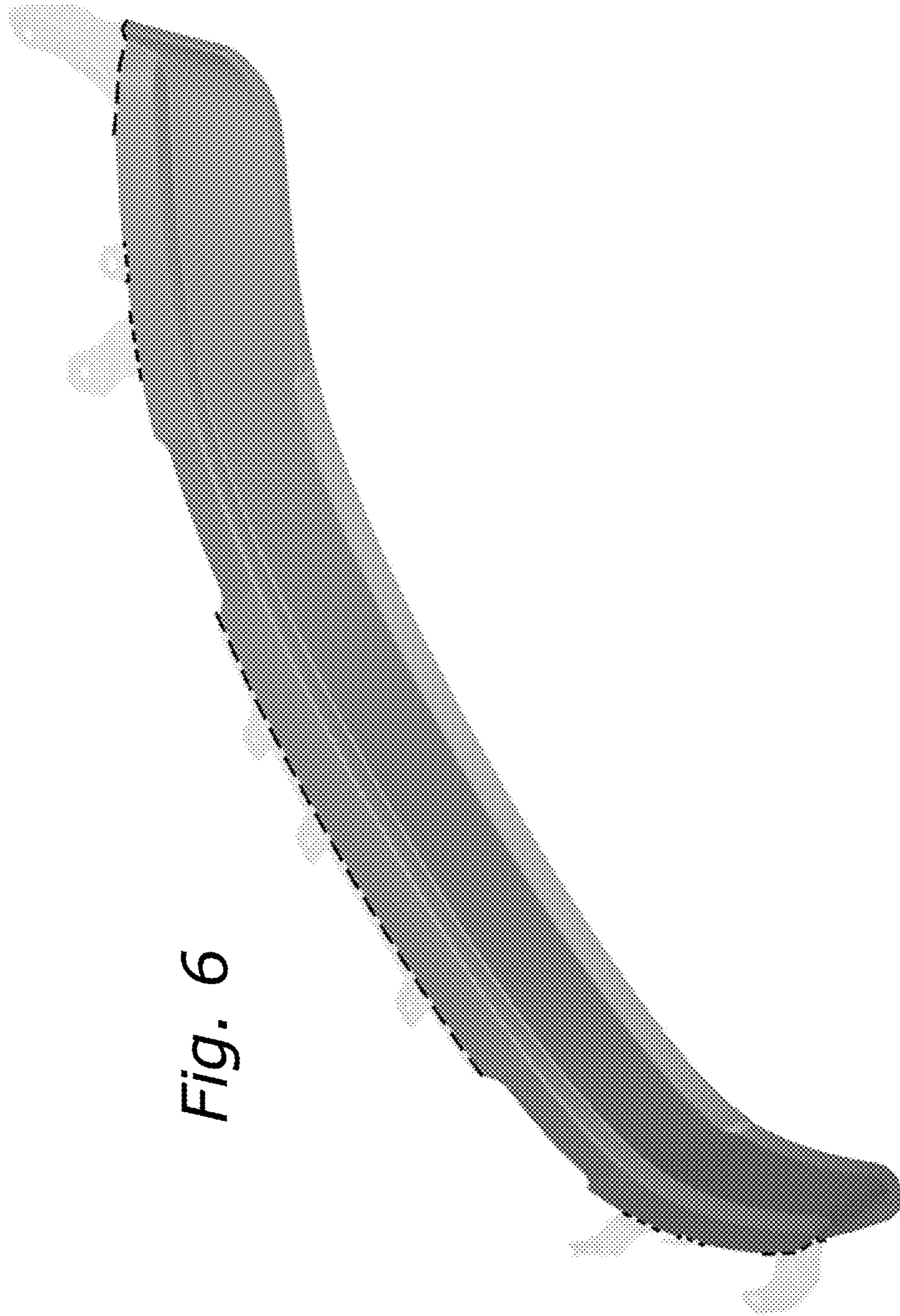

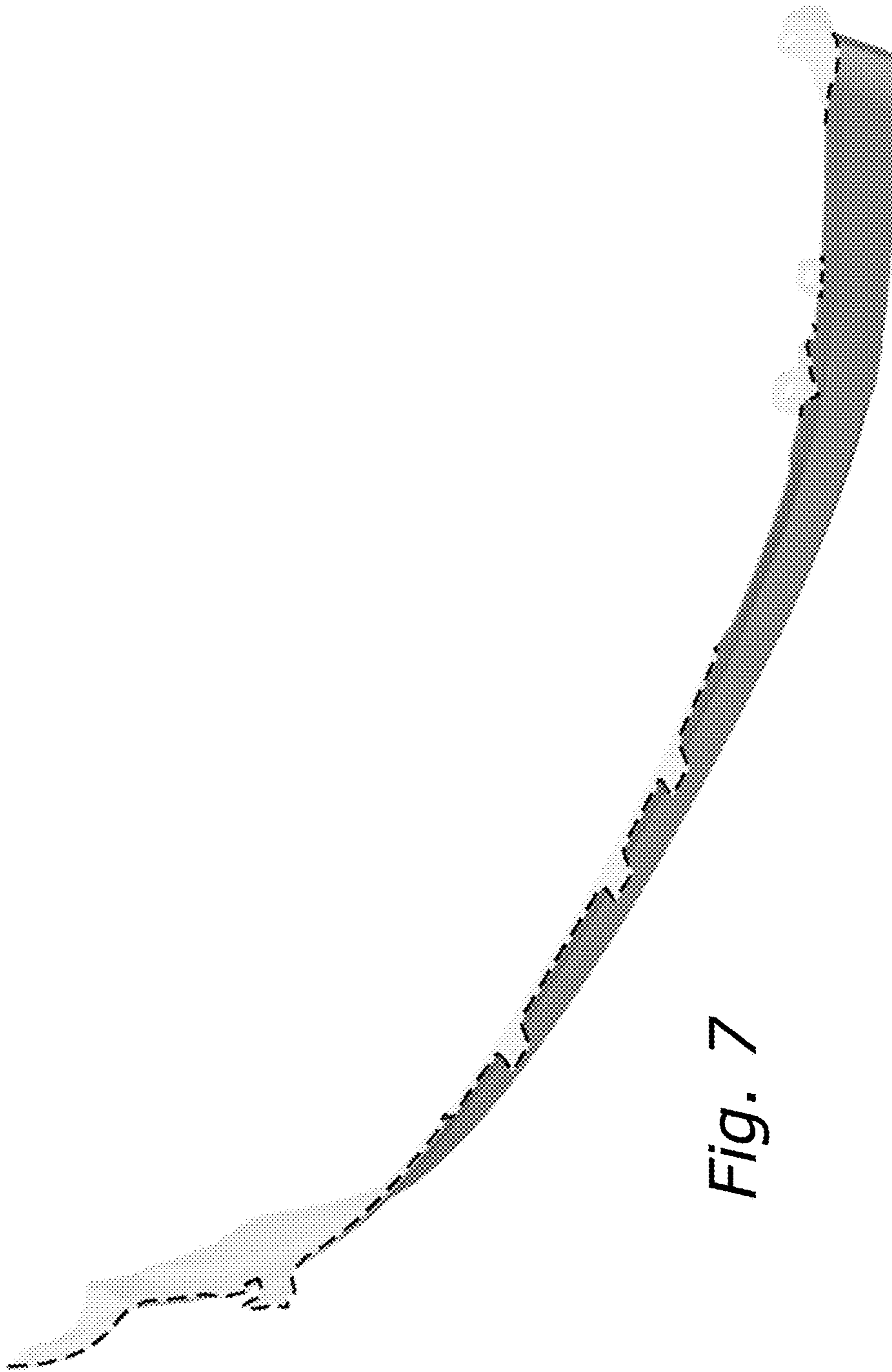

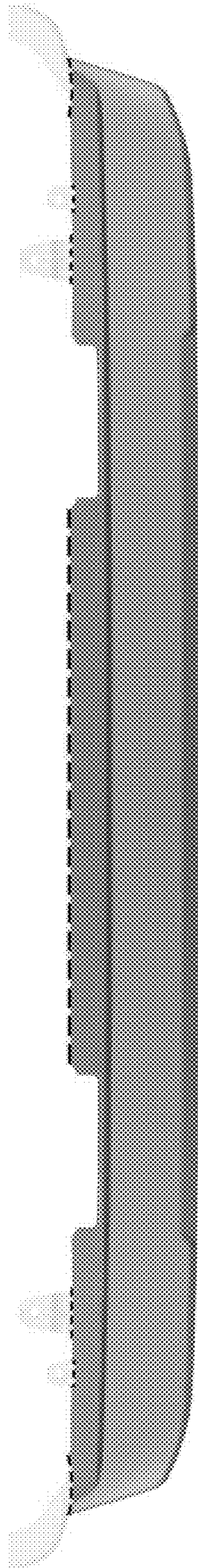

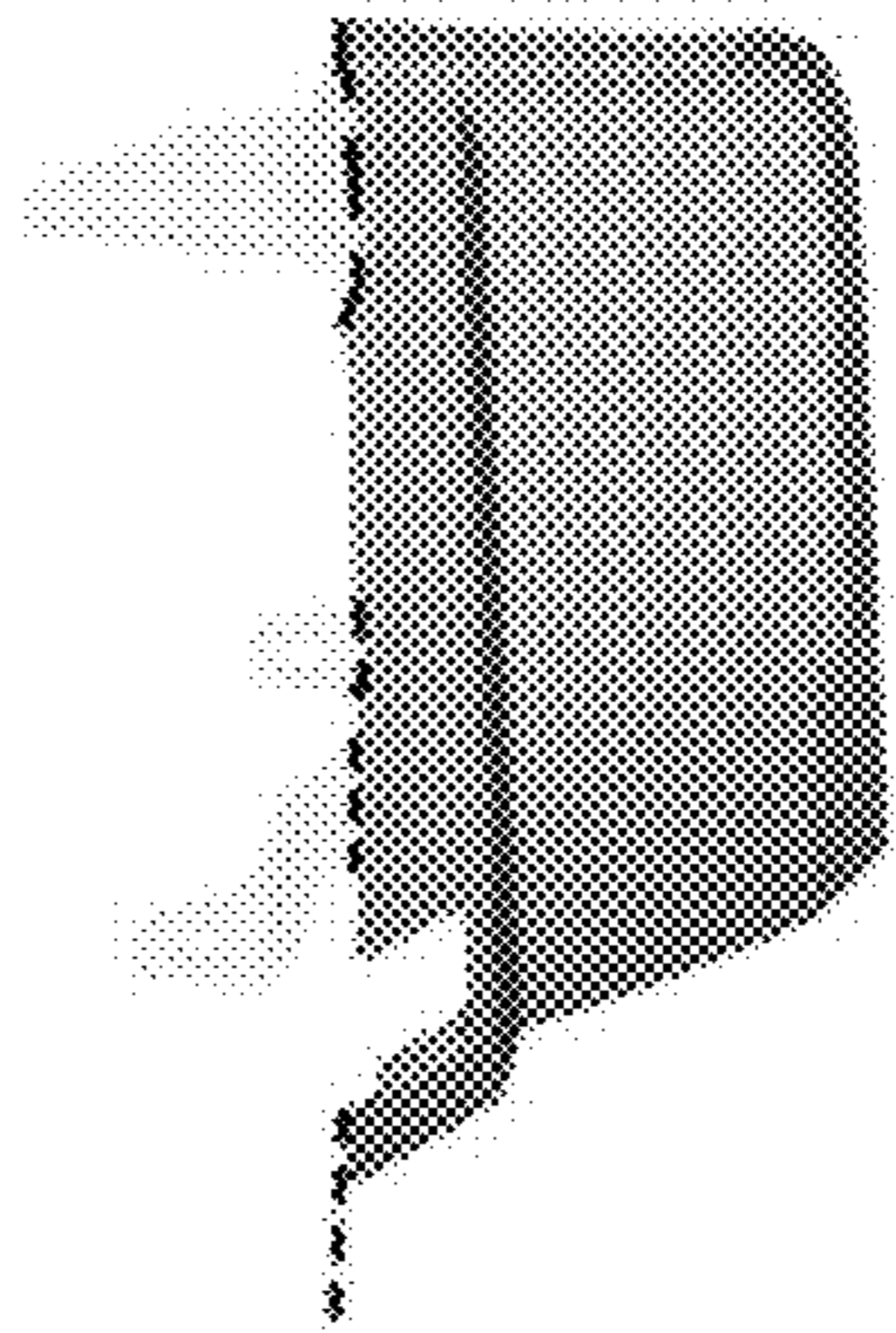

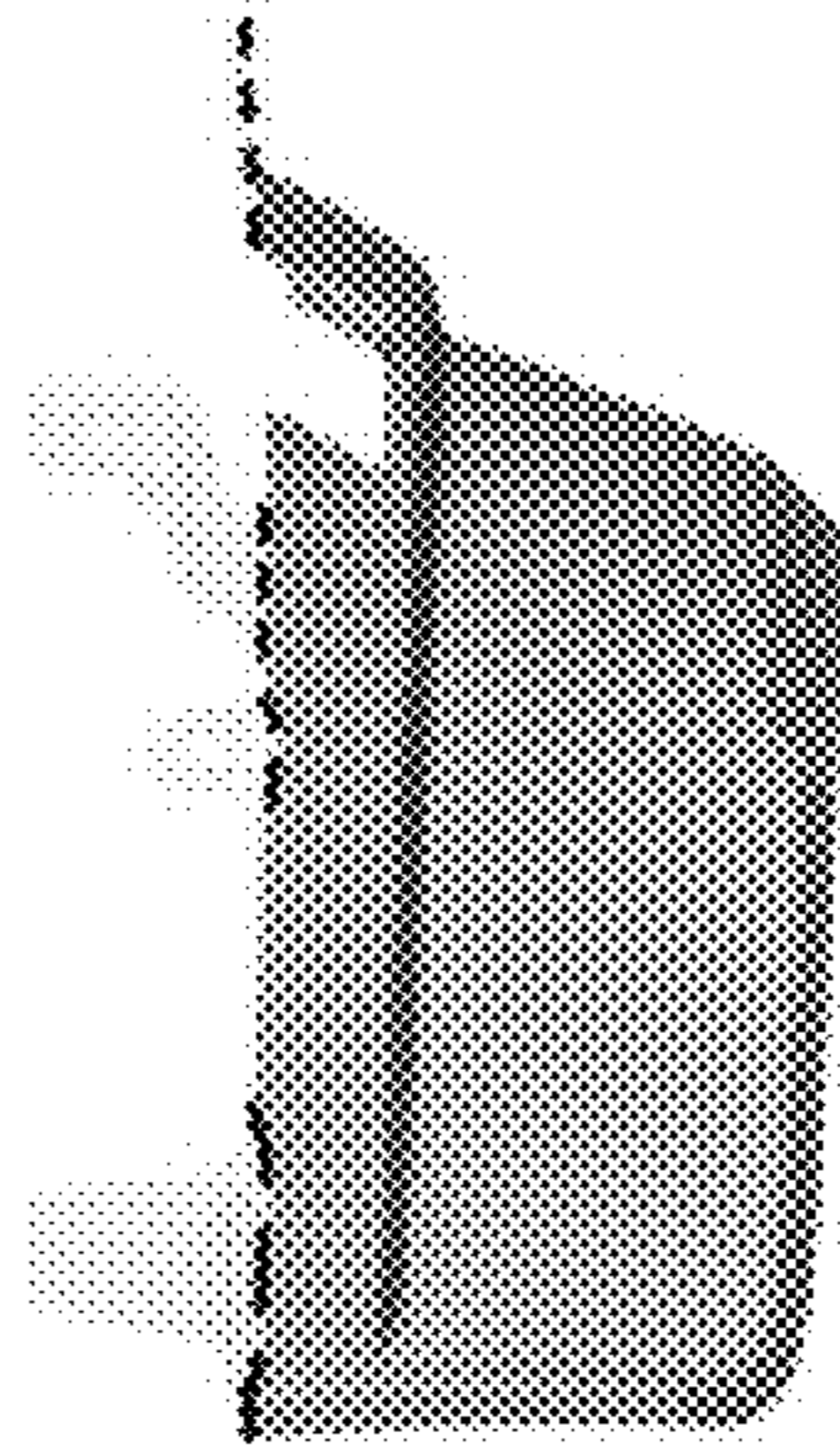

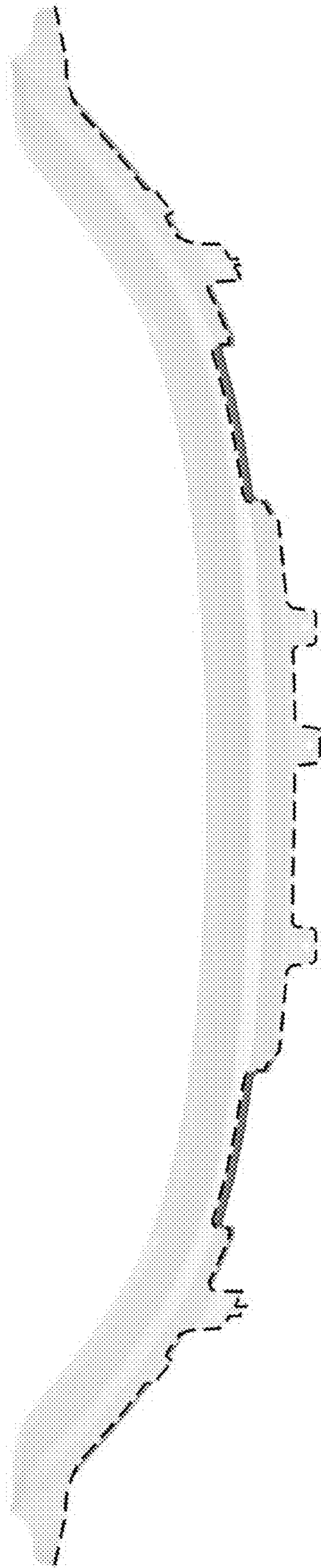
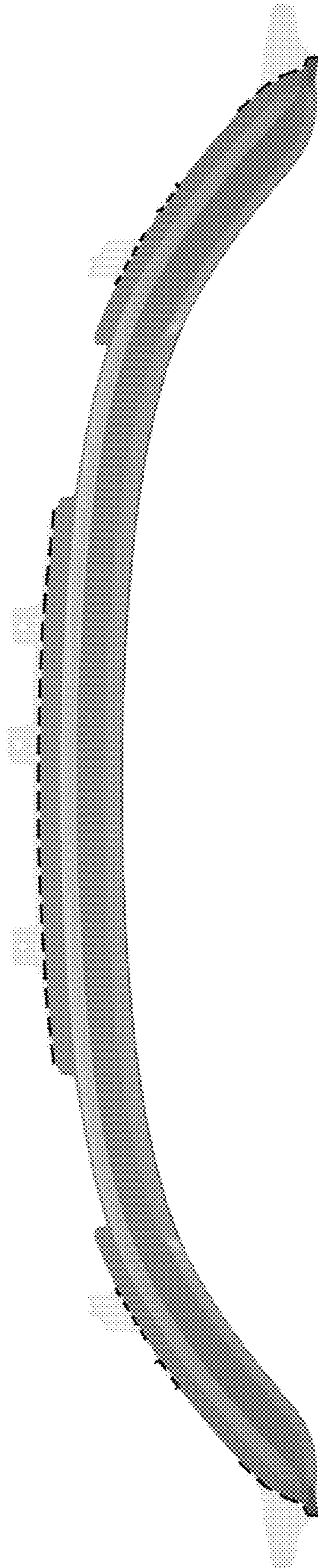

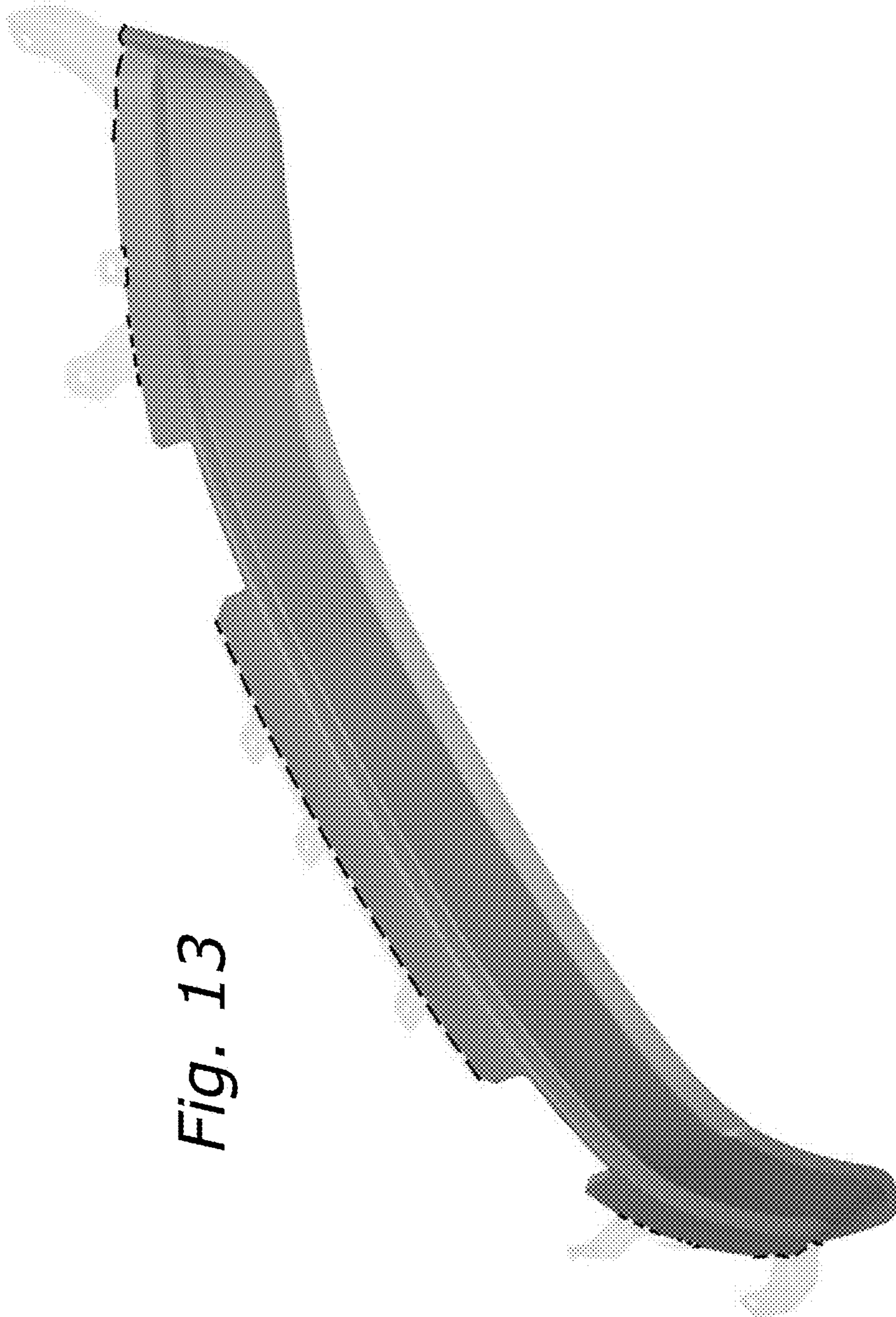

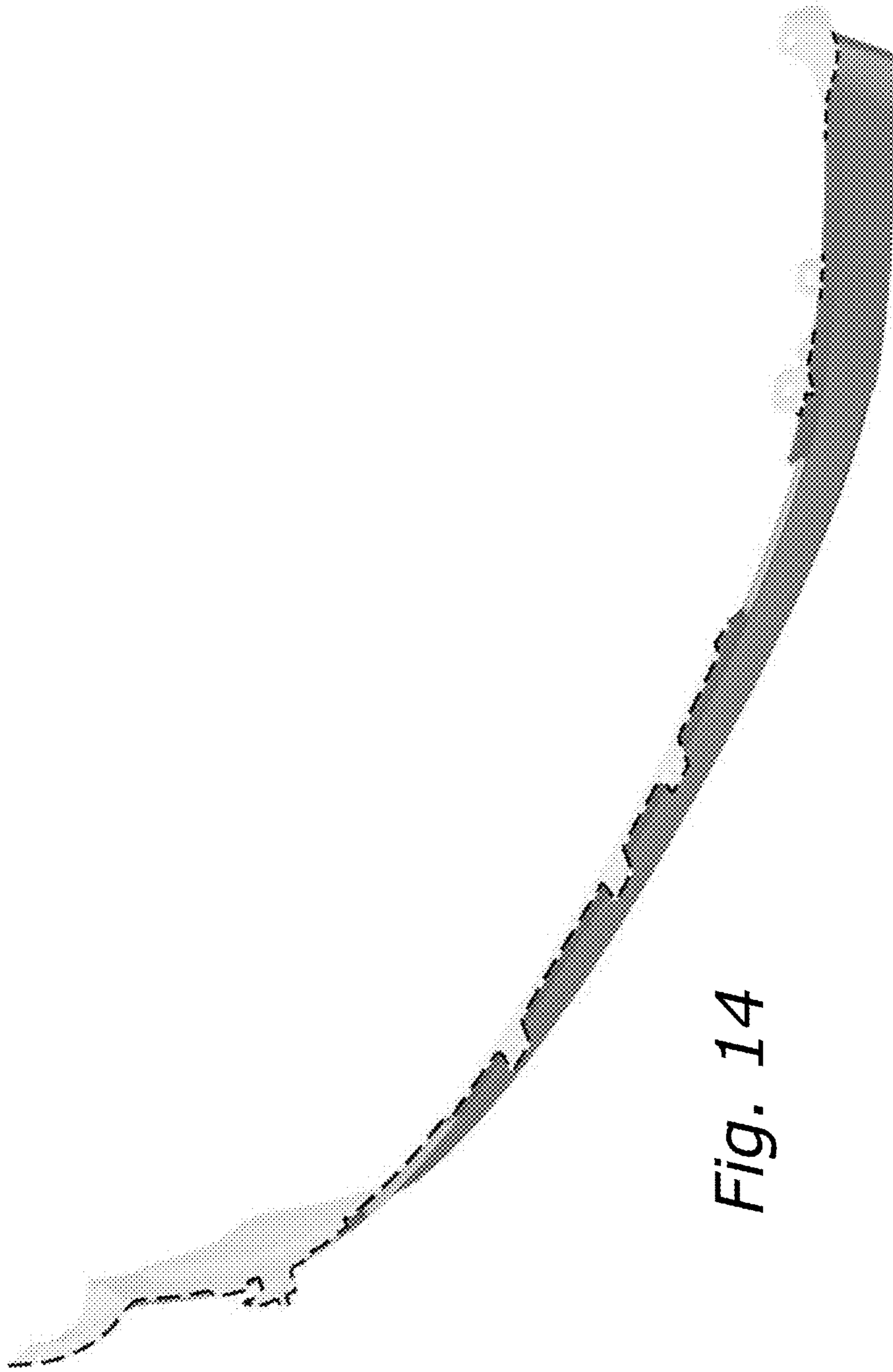
