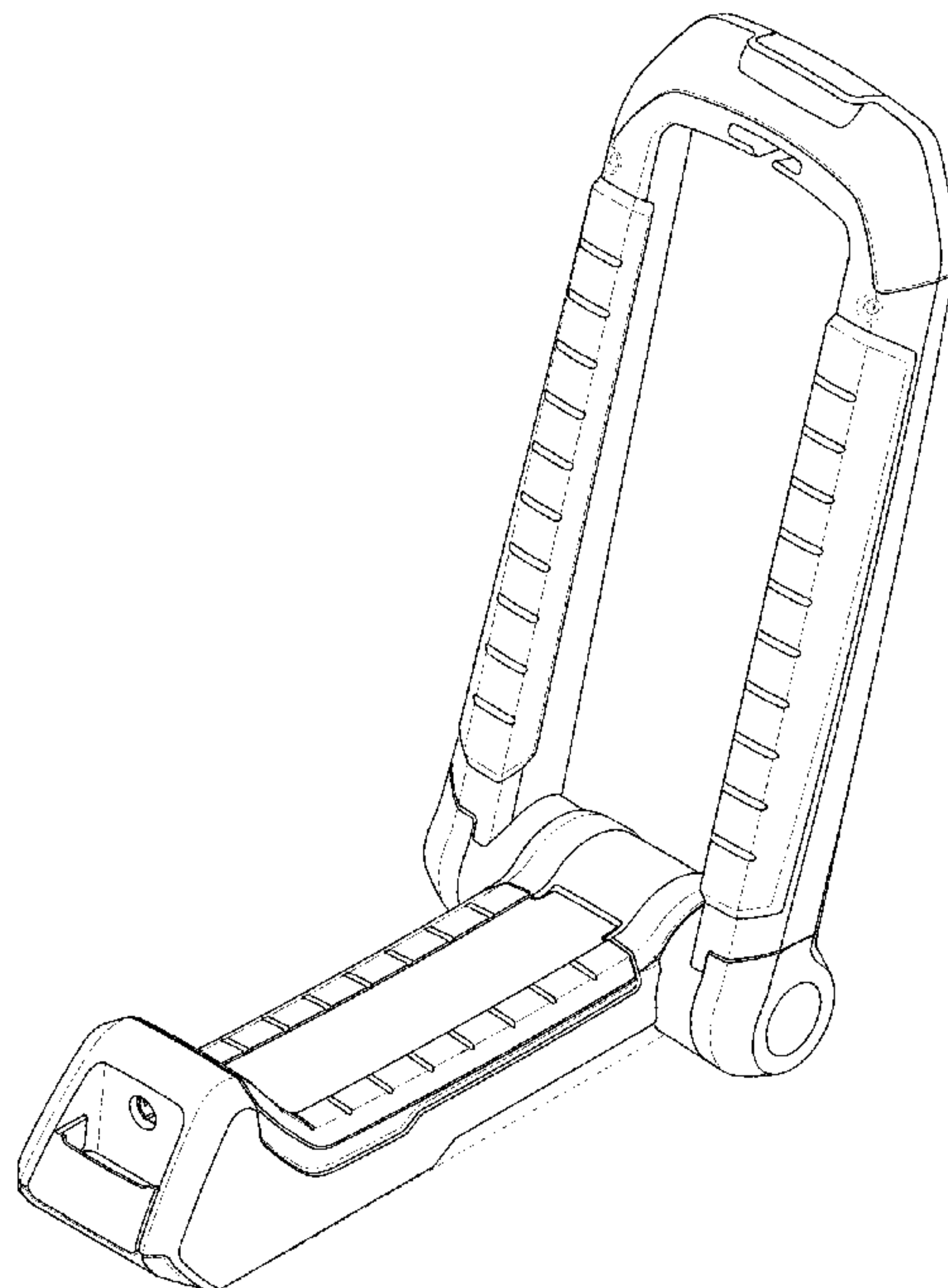
(57) **CLAIM**

The ornamental design for a carrier, as shown and described.

**DESCRIPTION**

FIG. 1 is a top front perspective view of a carrier showing the claimed design;  
FIG. 2 is a bottom rear perspective view thereof;

FIG. 4 is a rear view thereof;  
FIG. 5 is a left side view thereof;

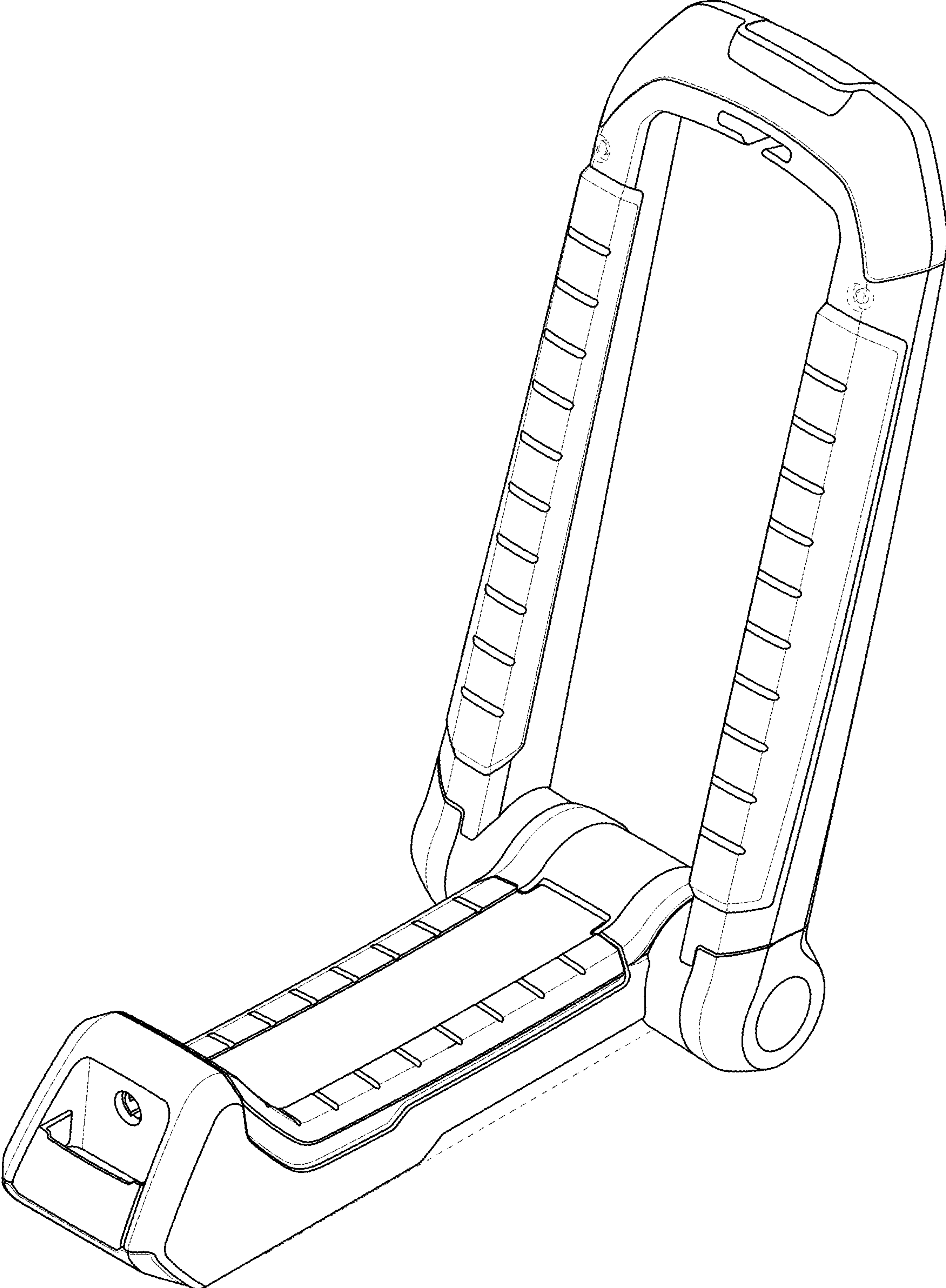
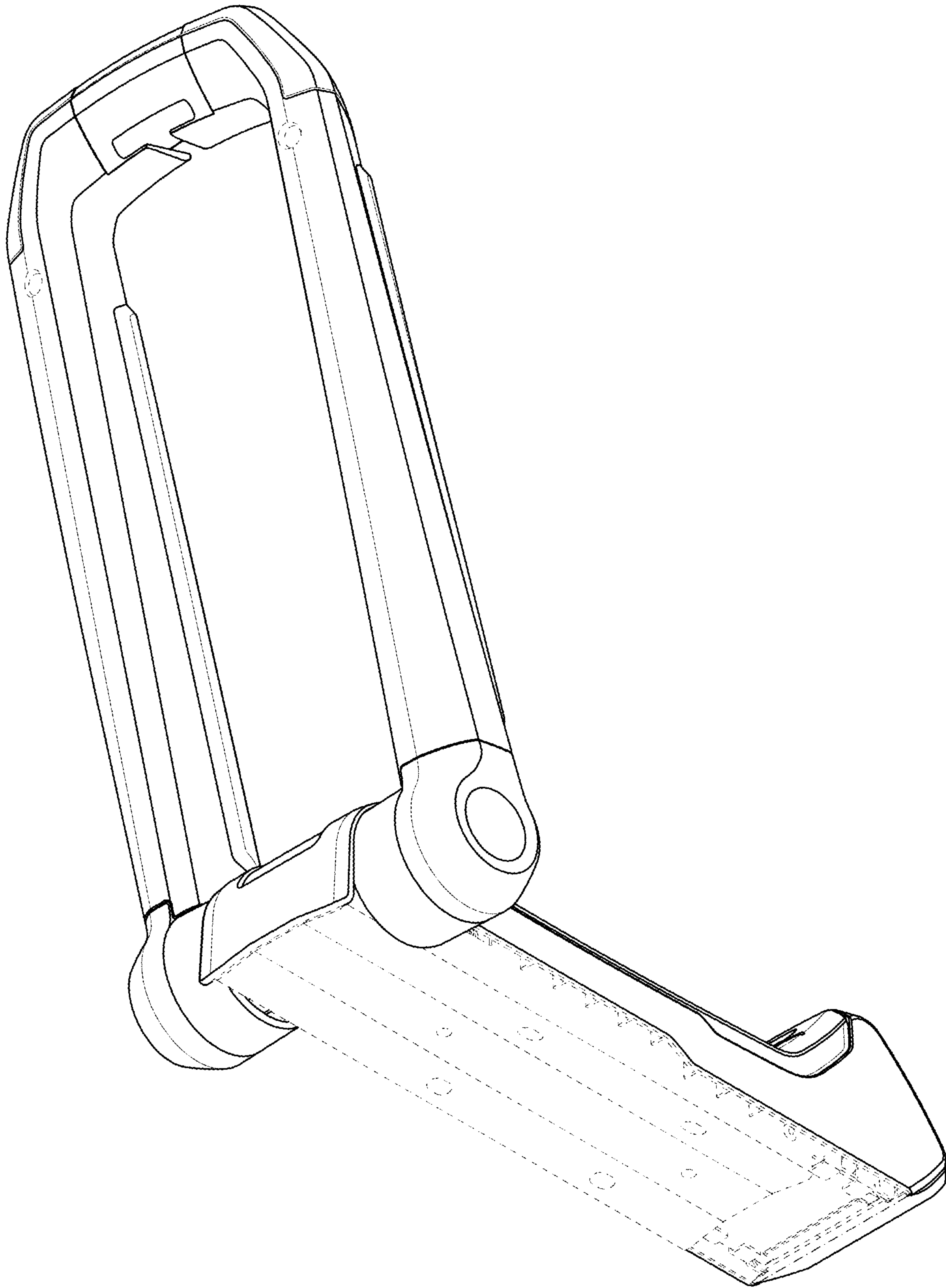
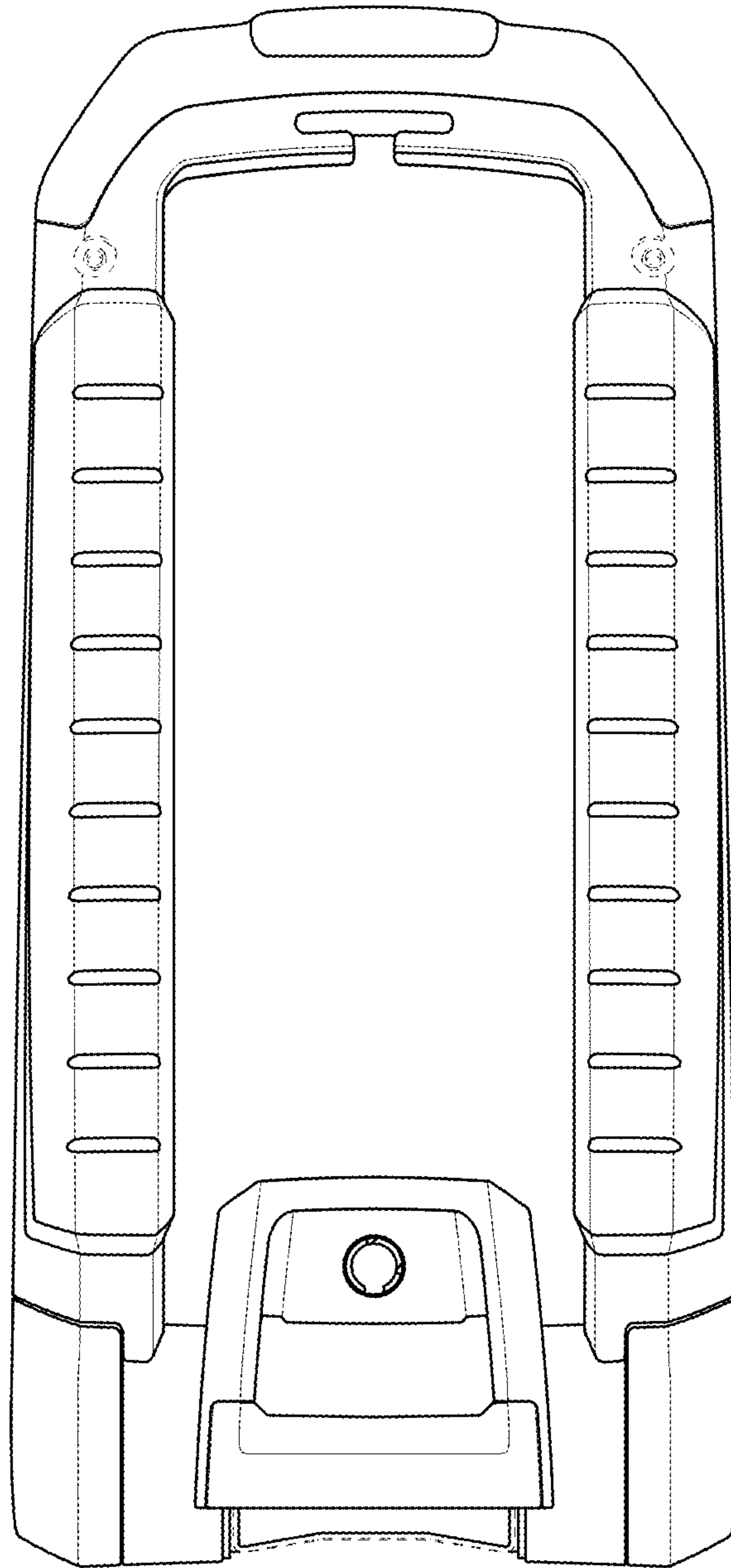

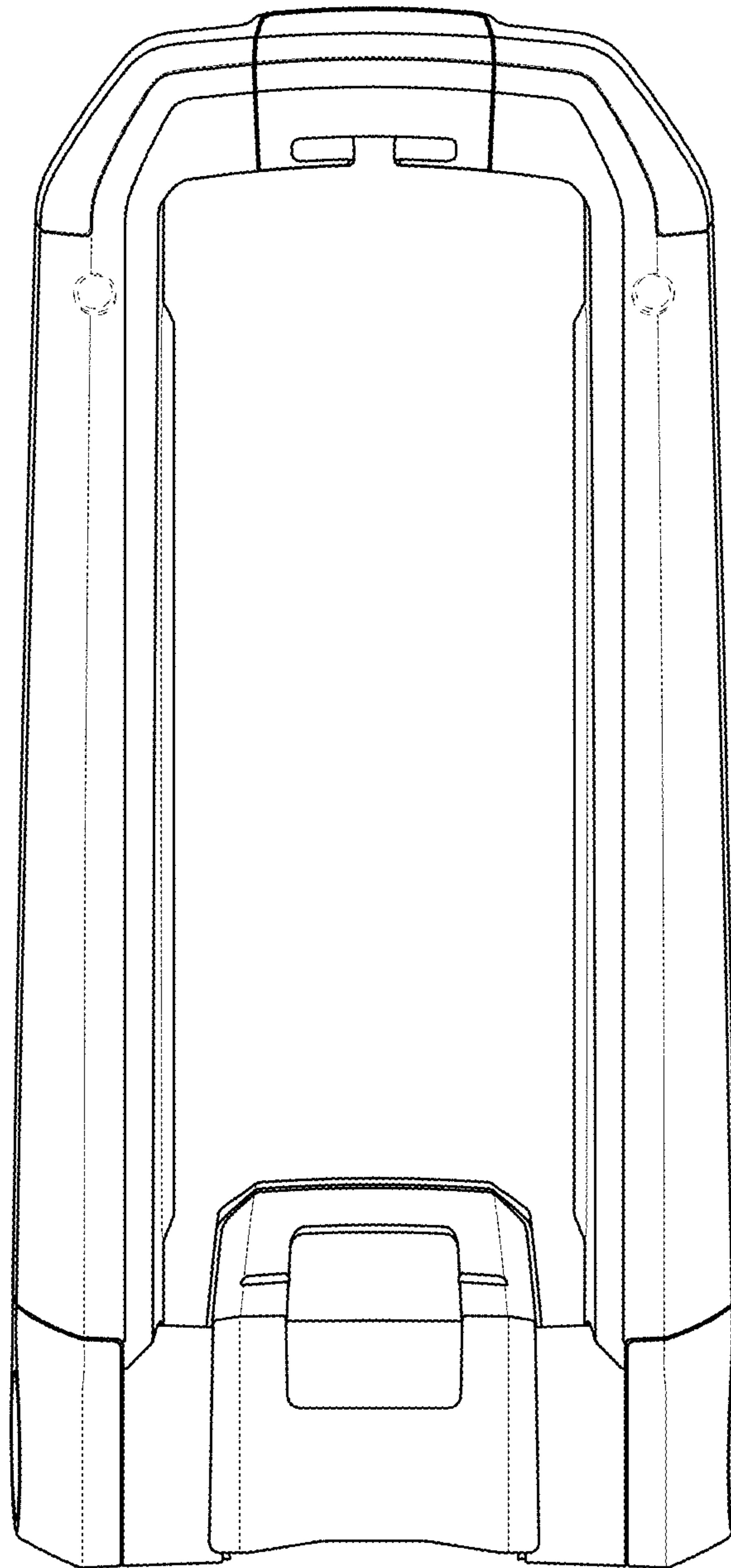

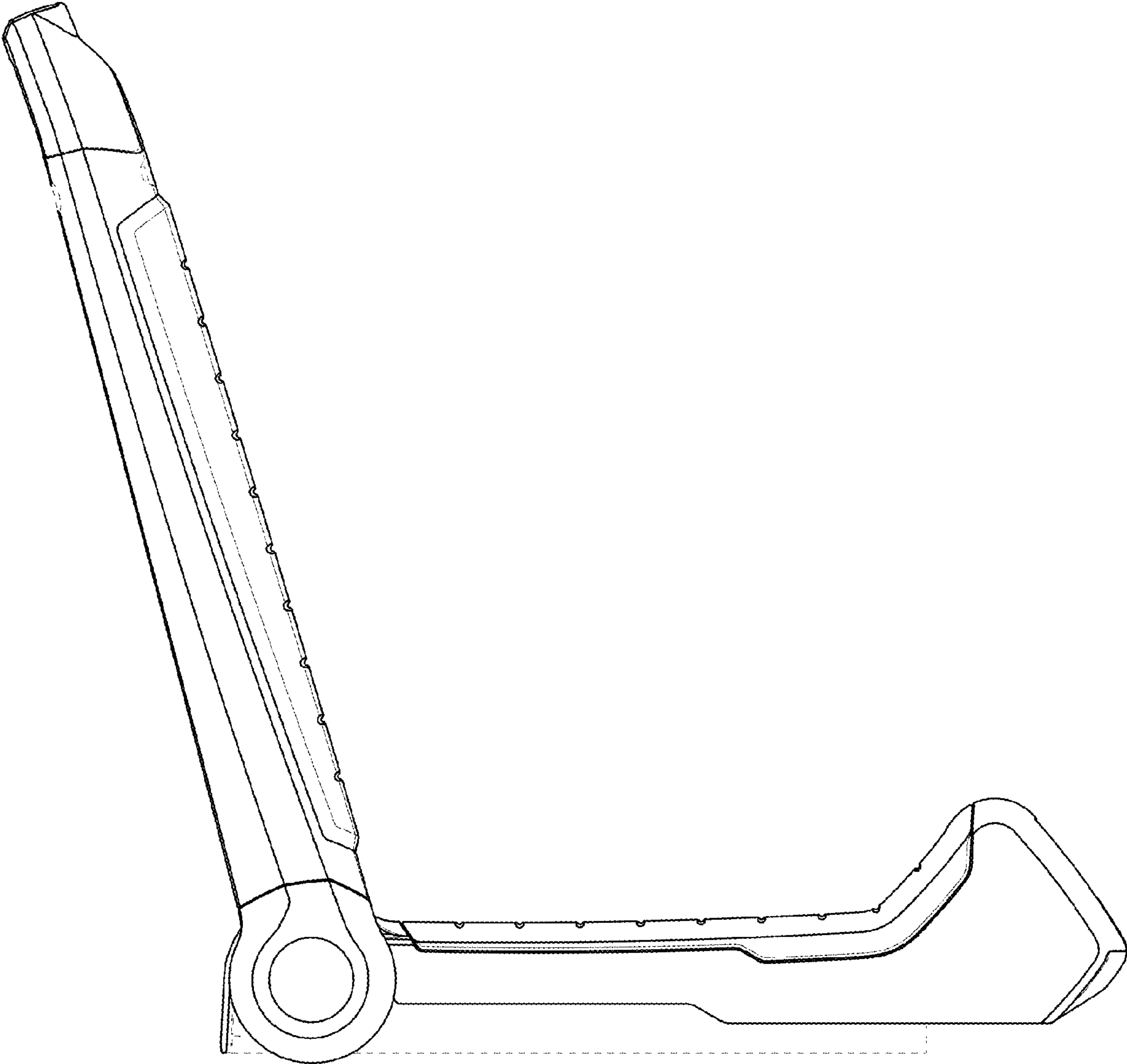
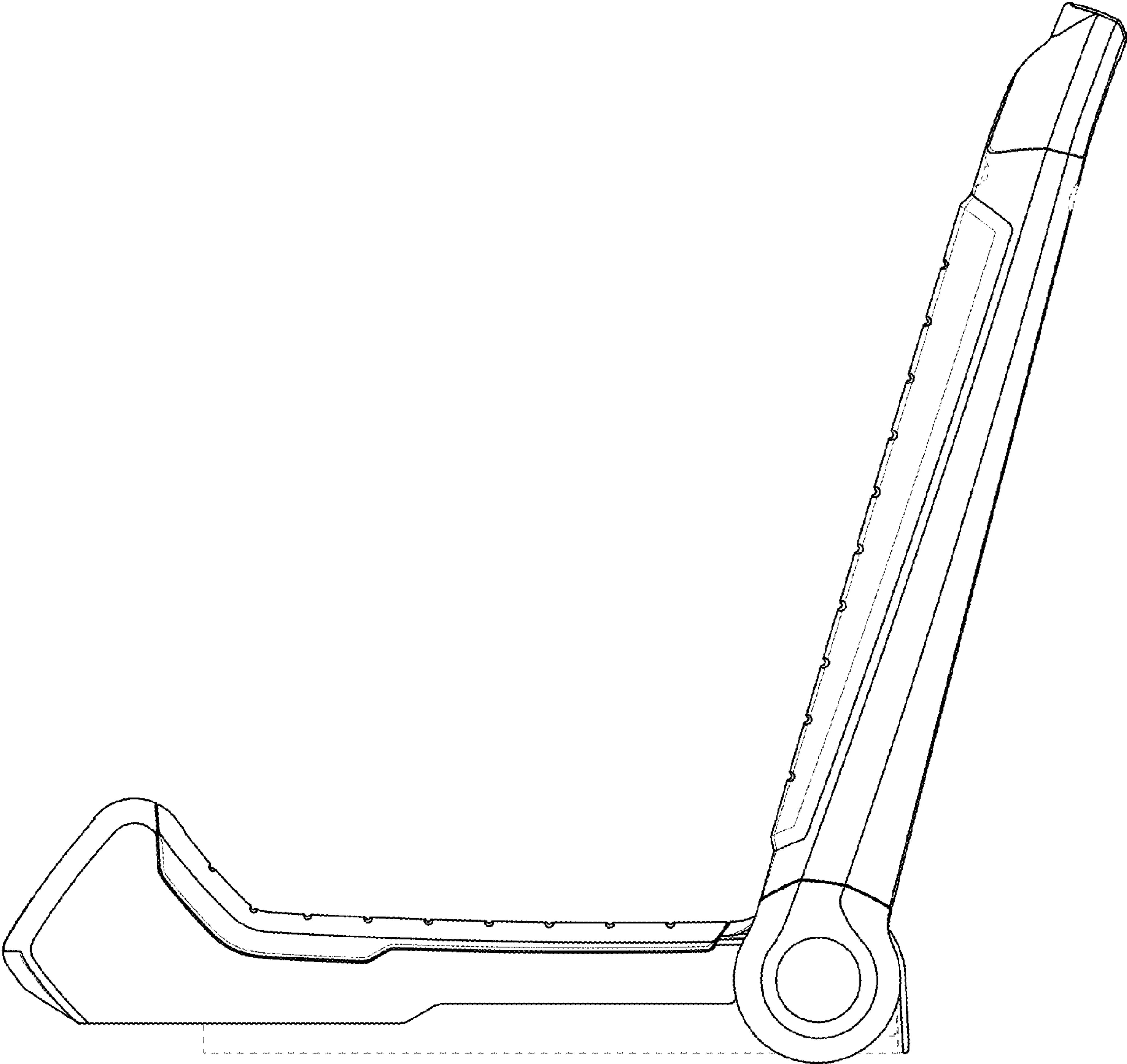
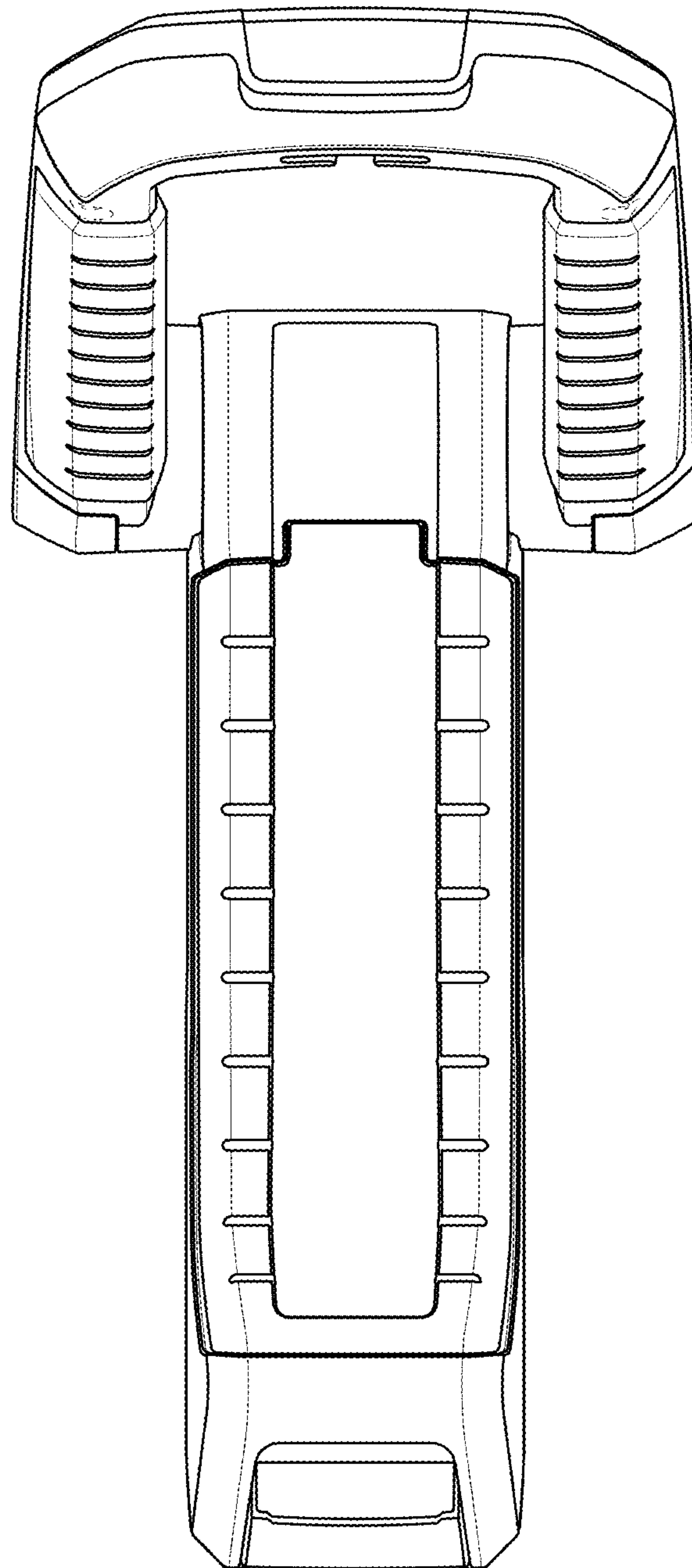

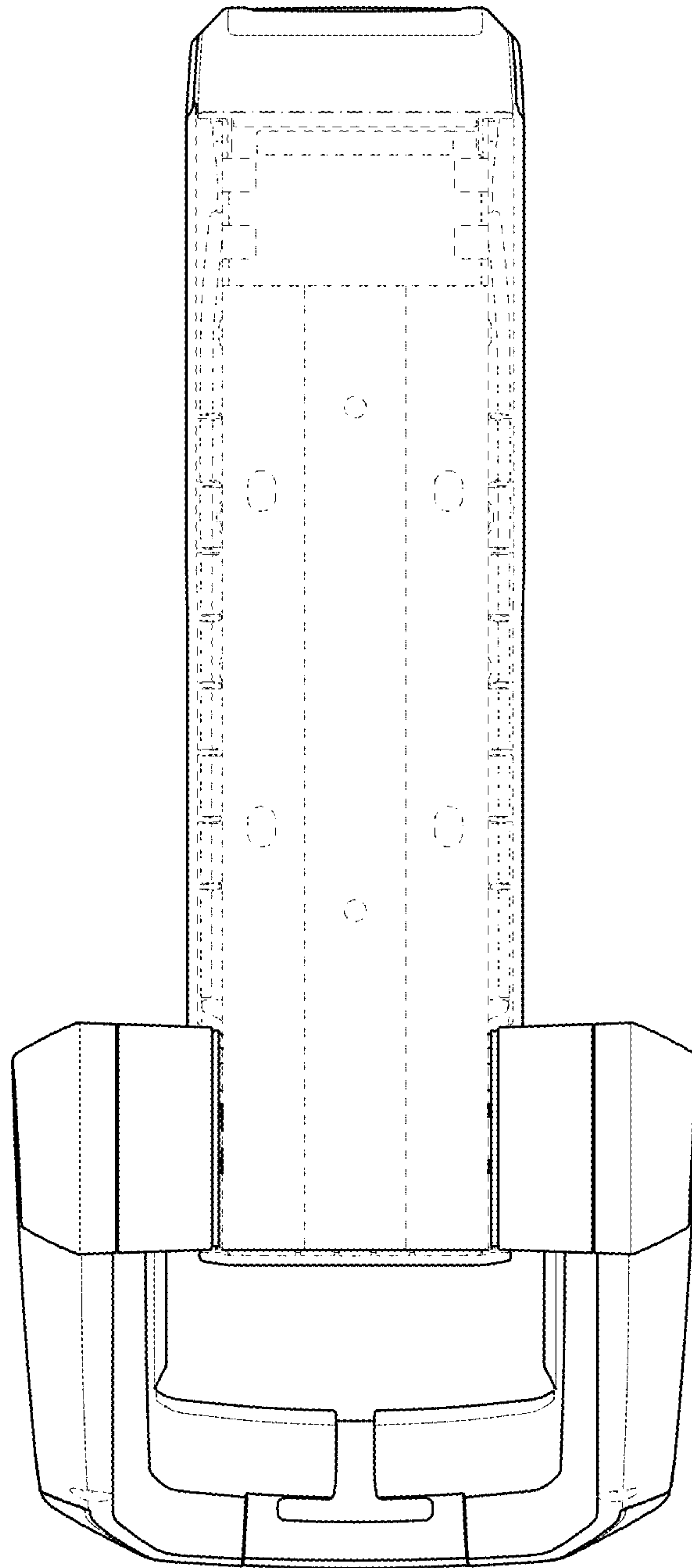
