**1.1** is a perspective view of a speaker showing the new design;

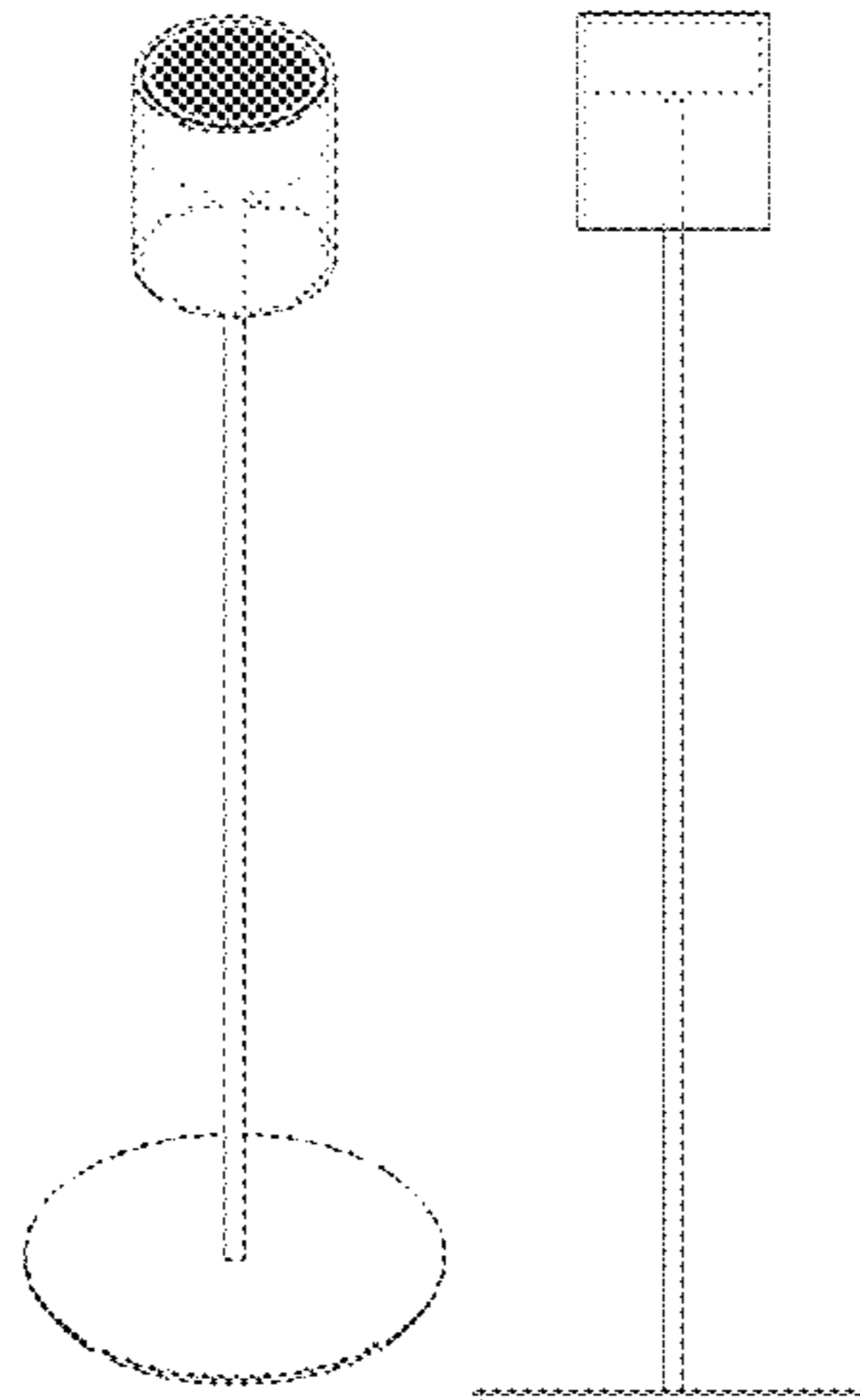

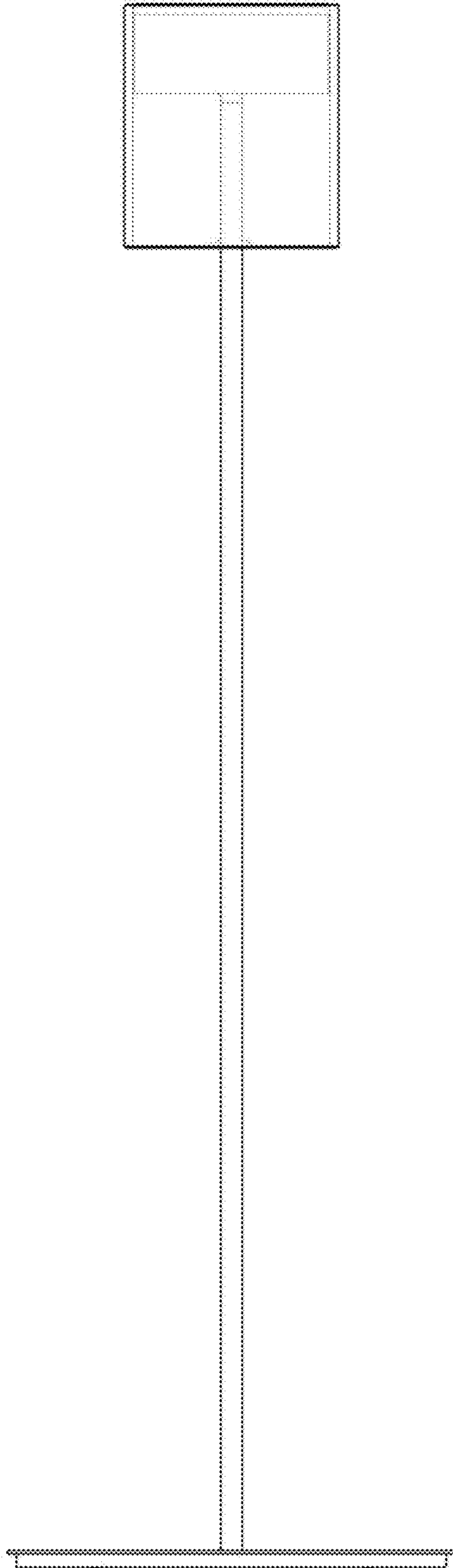

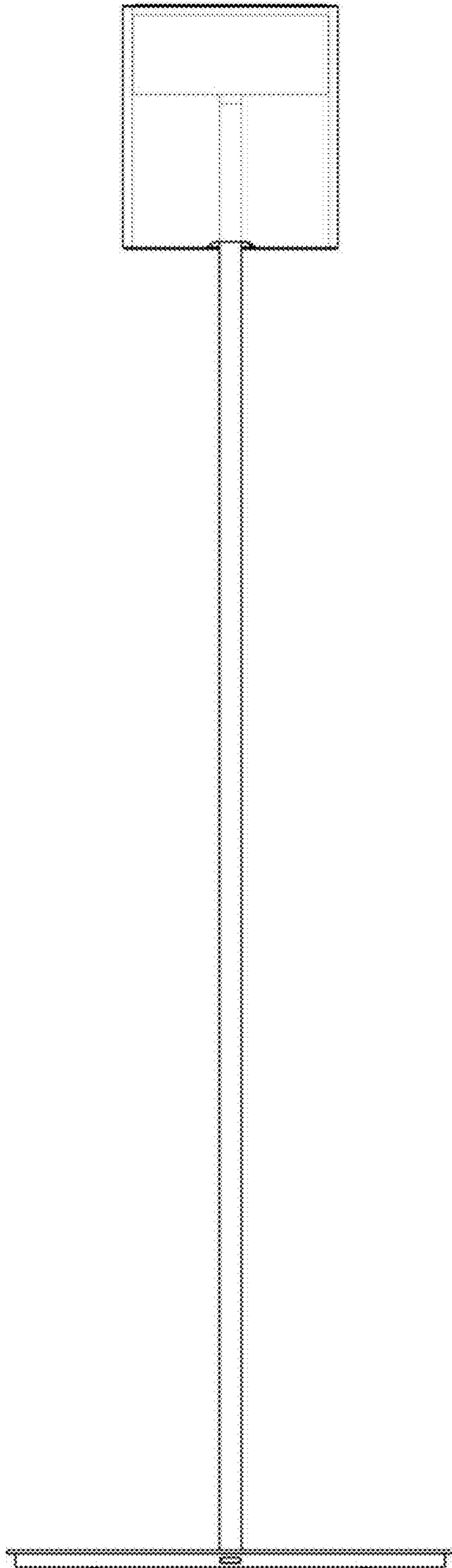

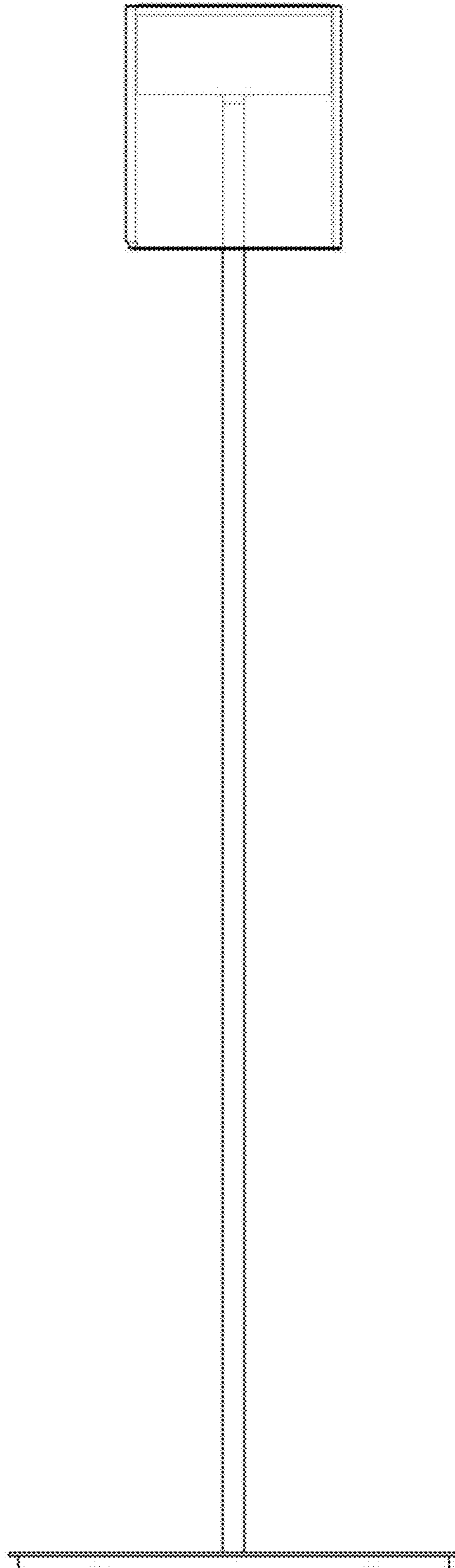

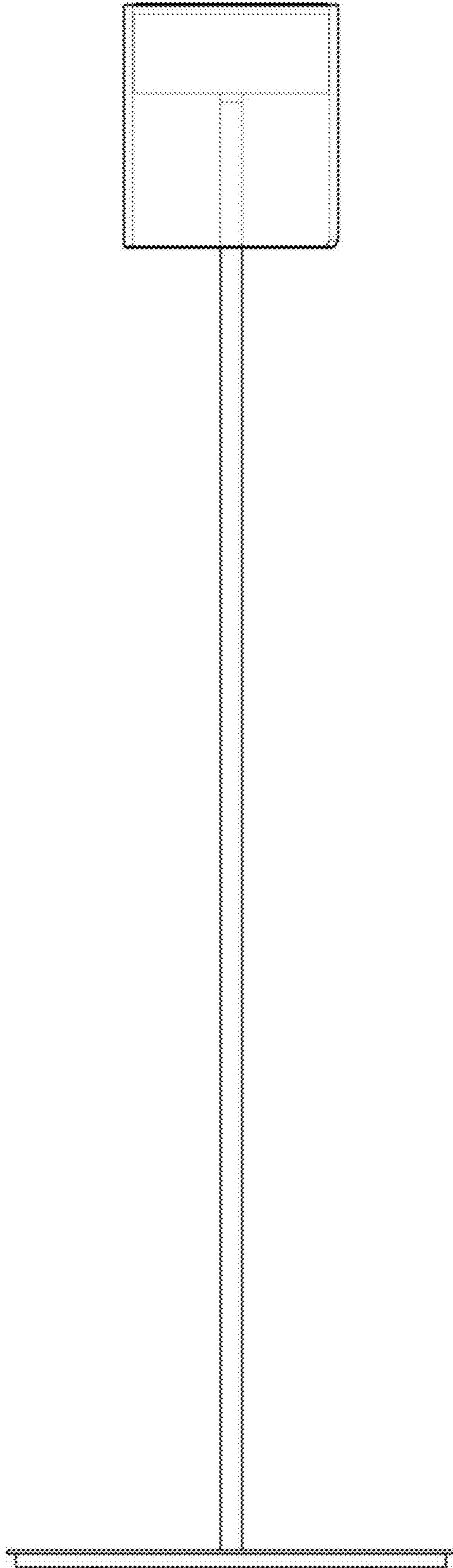

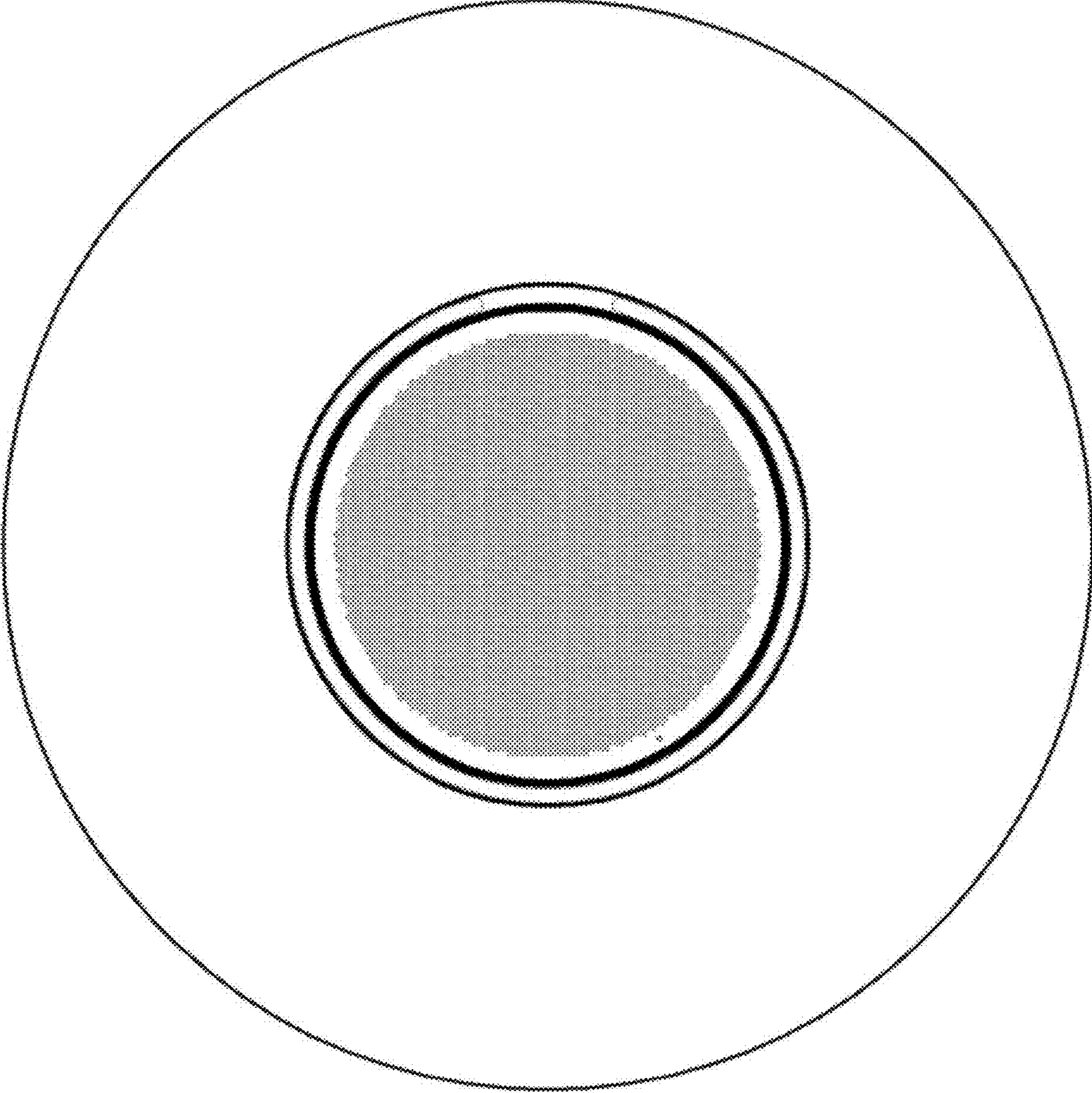
