**DESCRIPTION**

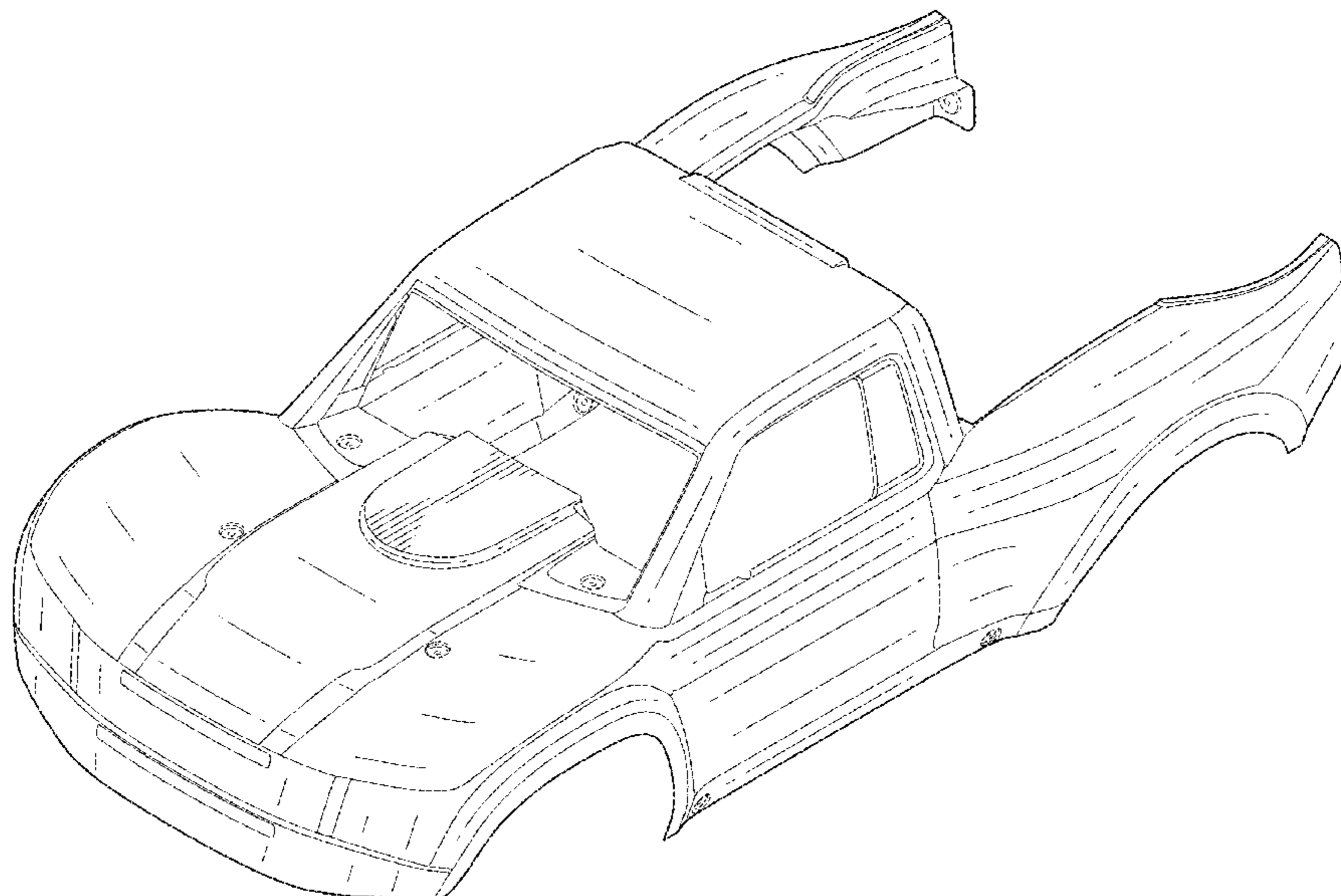
FIG. 1 is a top, left, front perspective view of a body for a model vehicle;

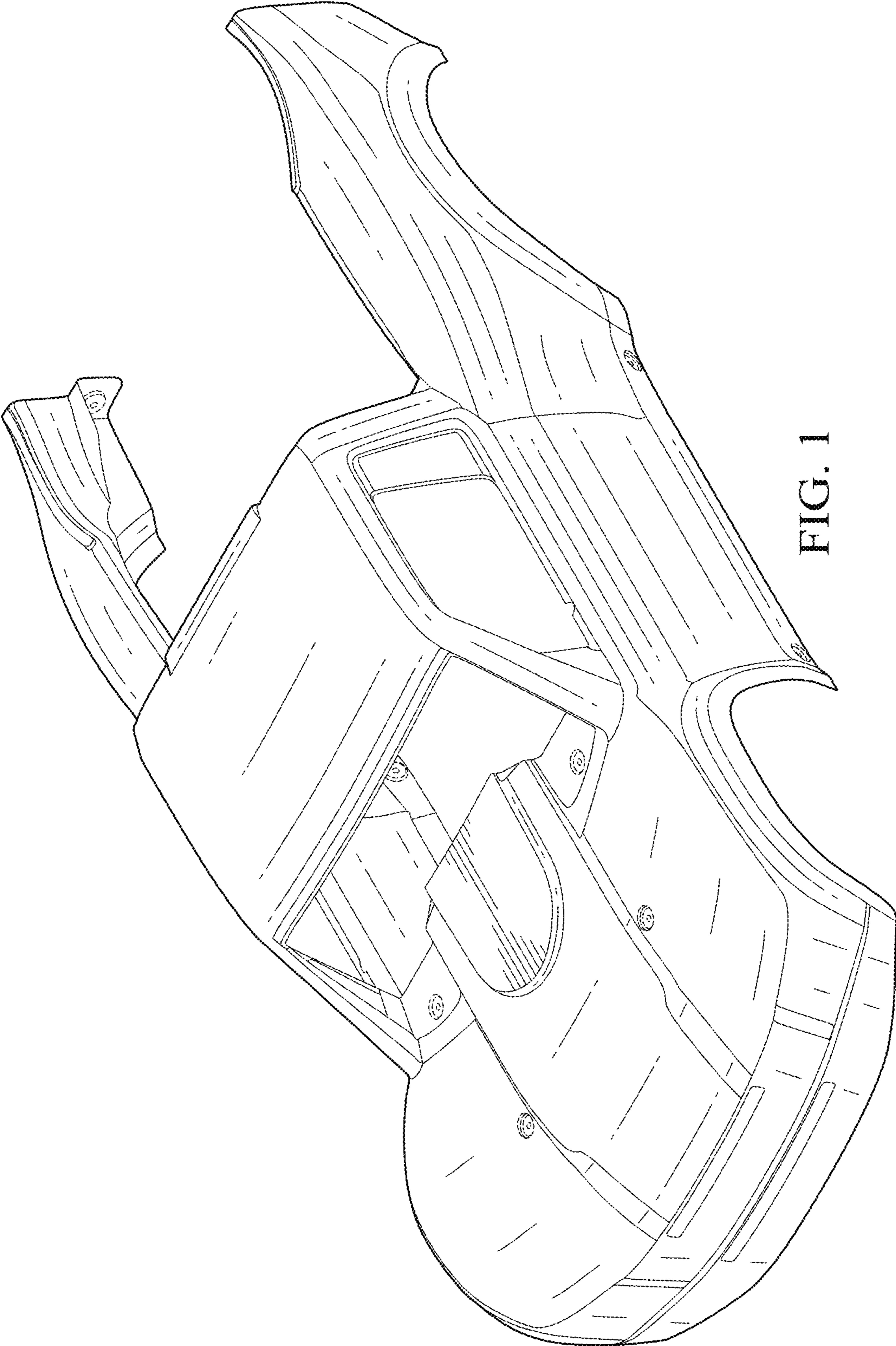

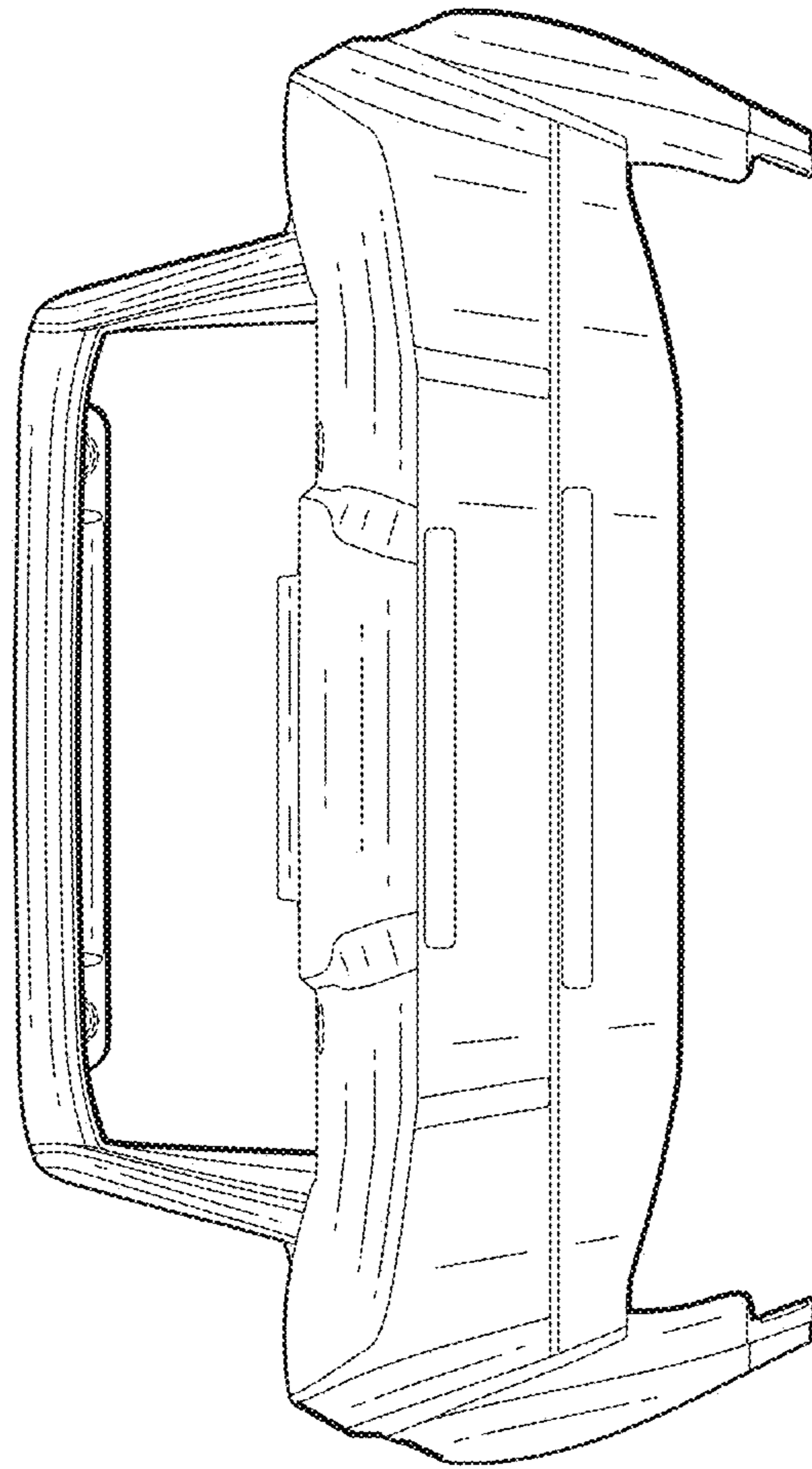

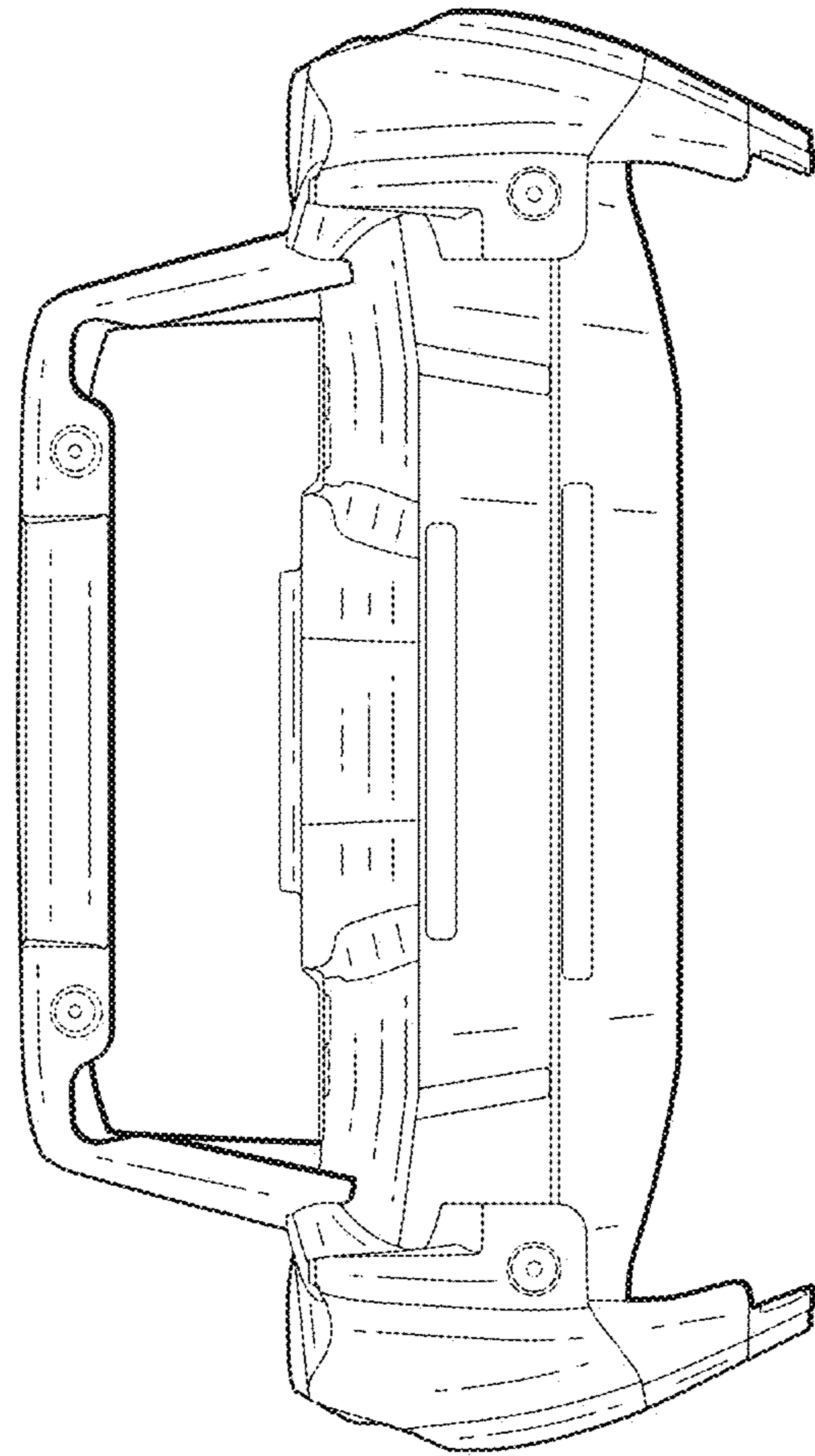

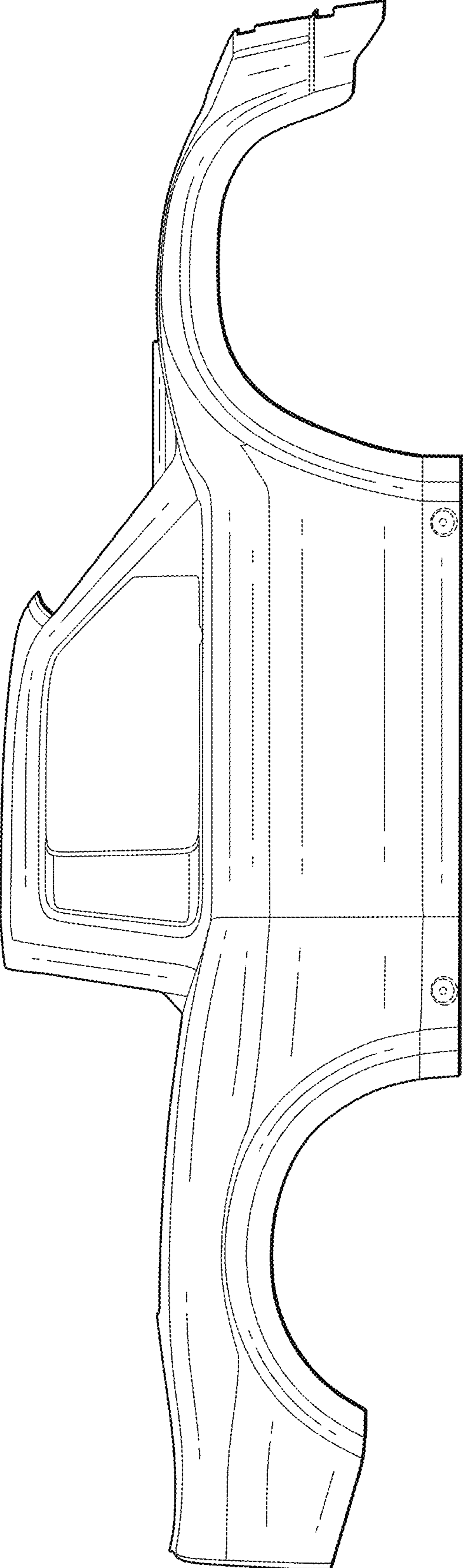

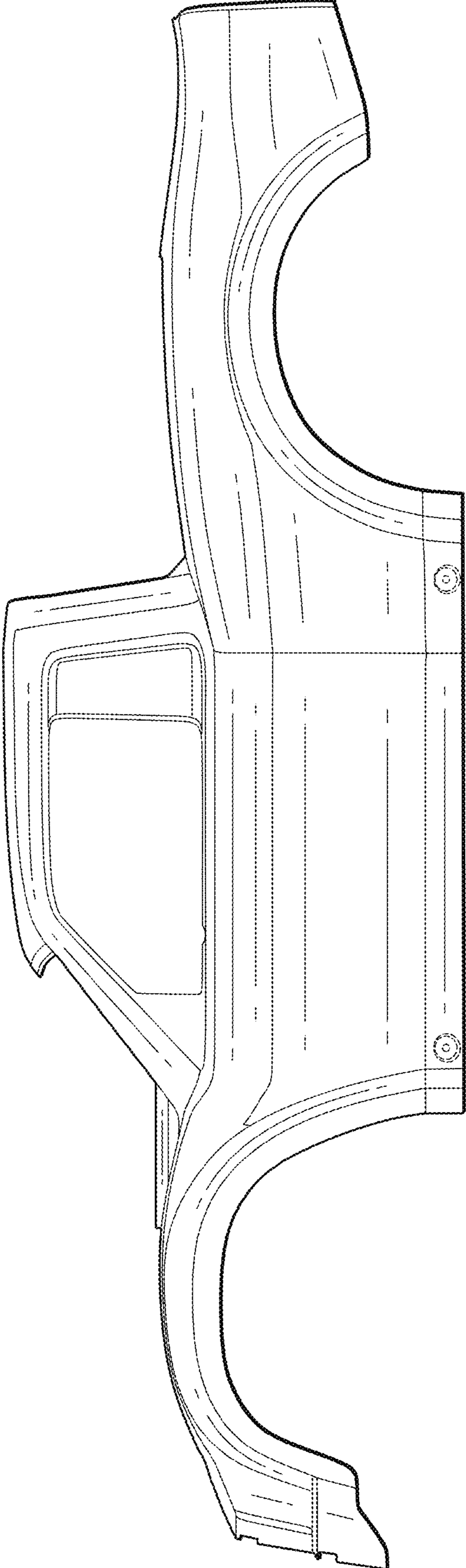

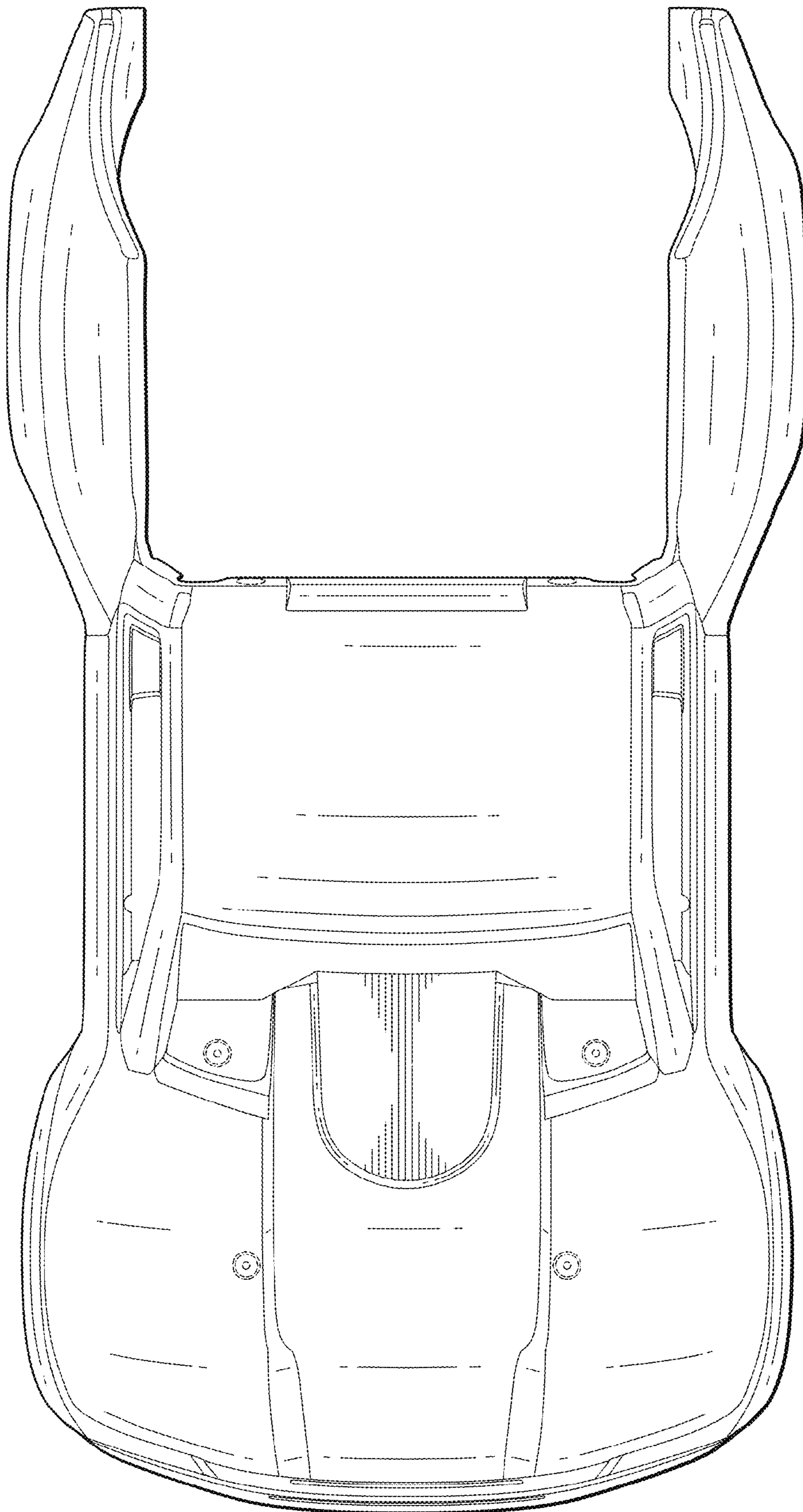

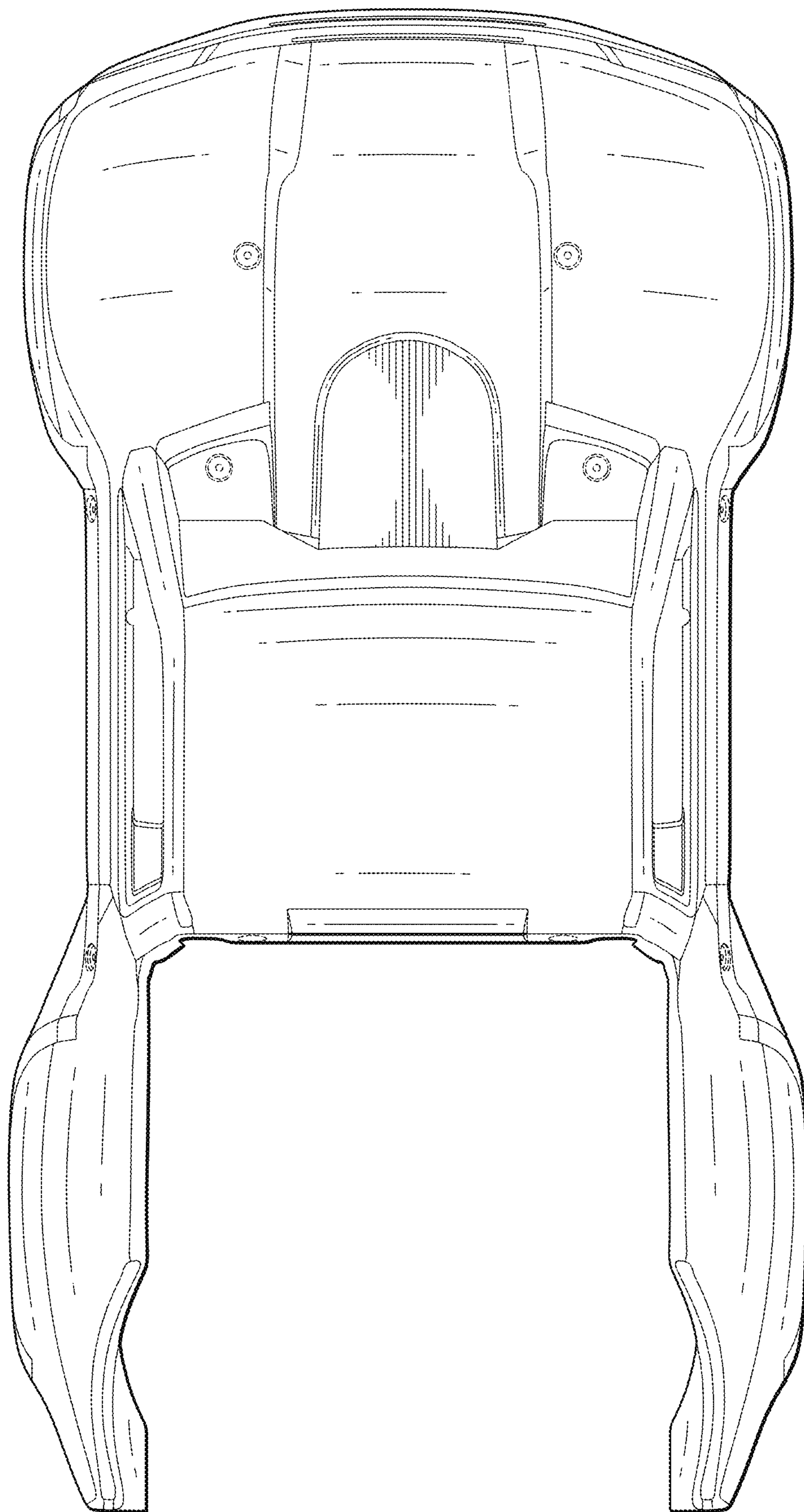

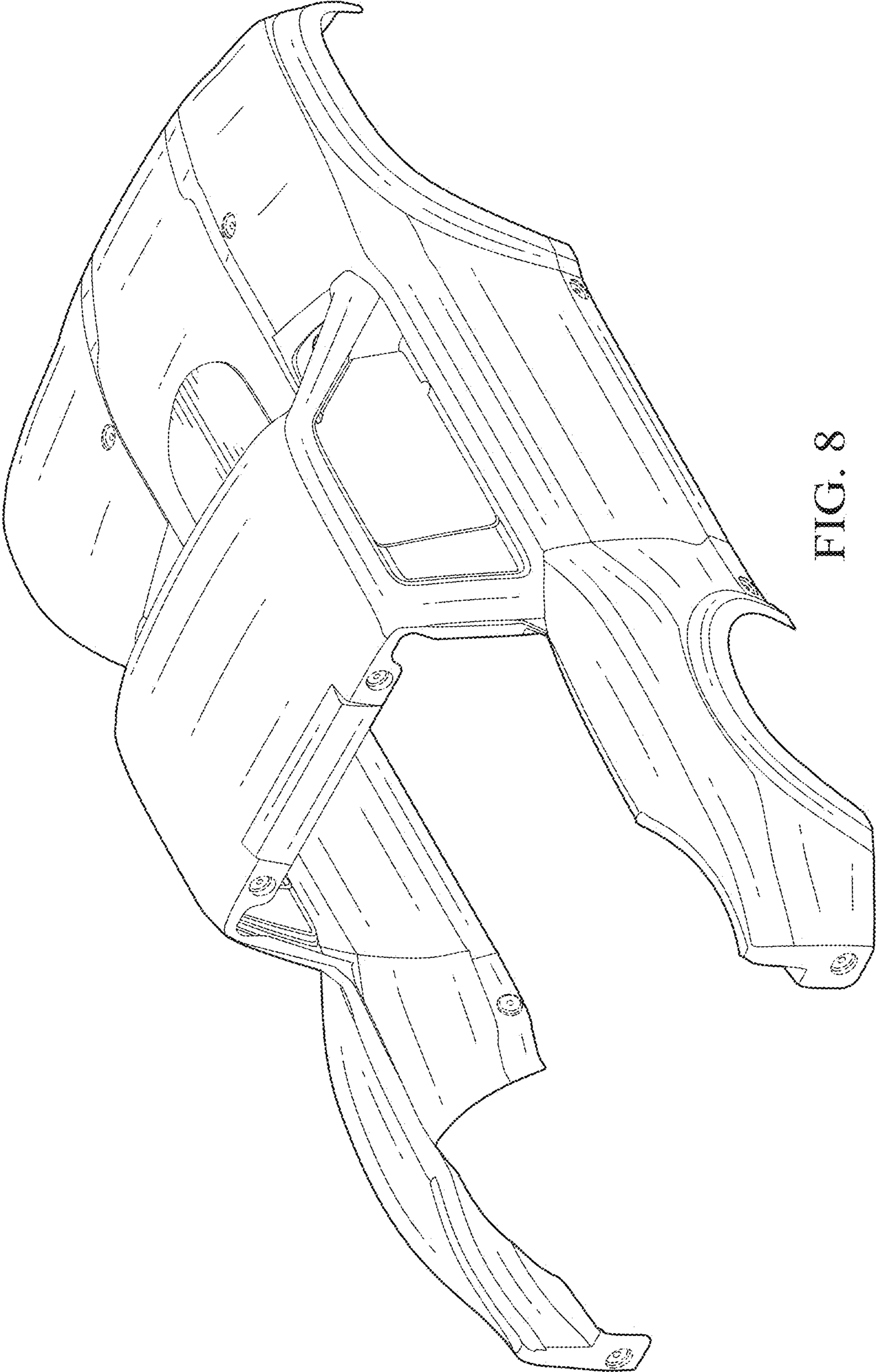

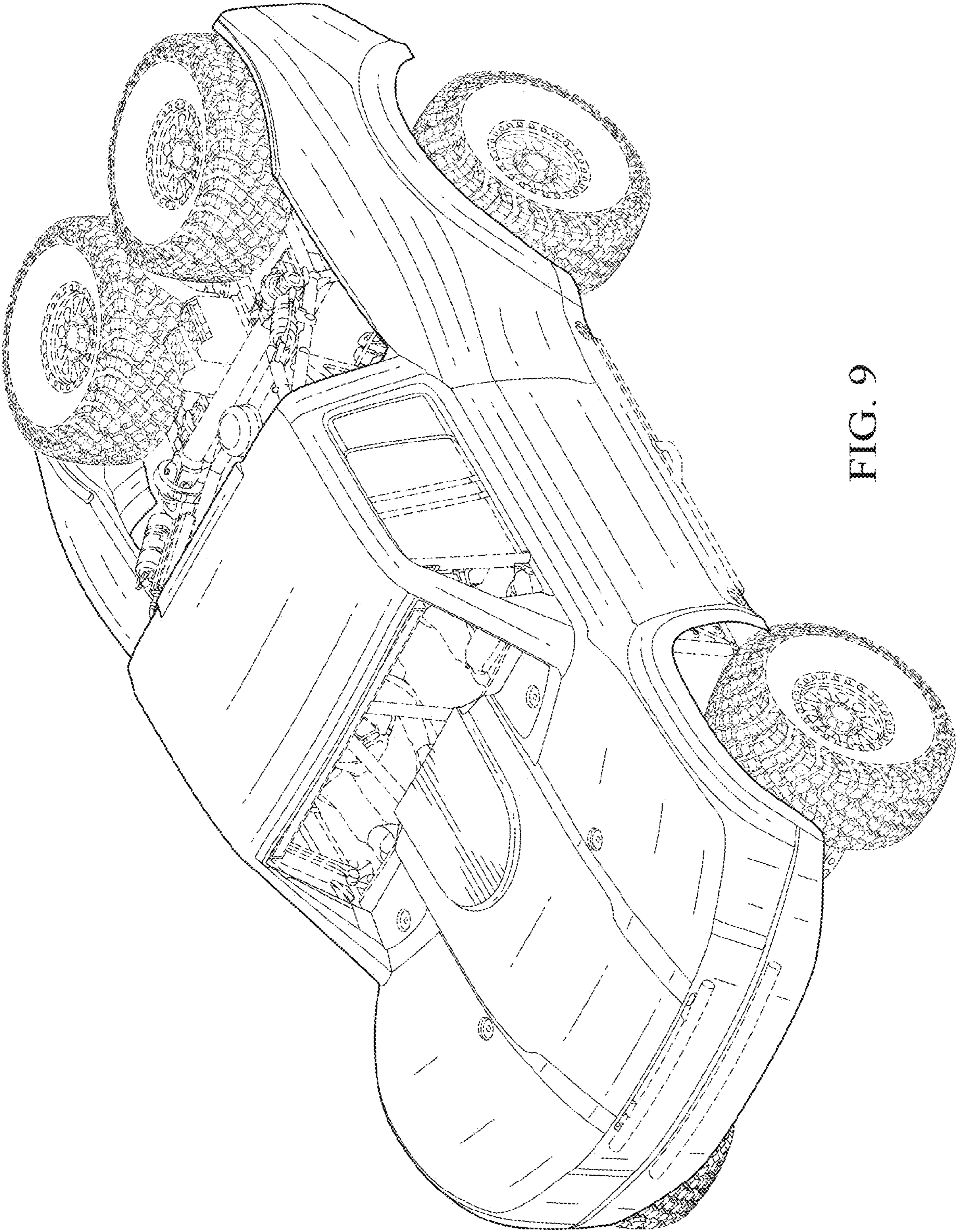
