**DESCRIPTION**

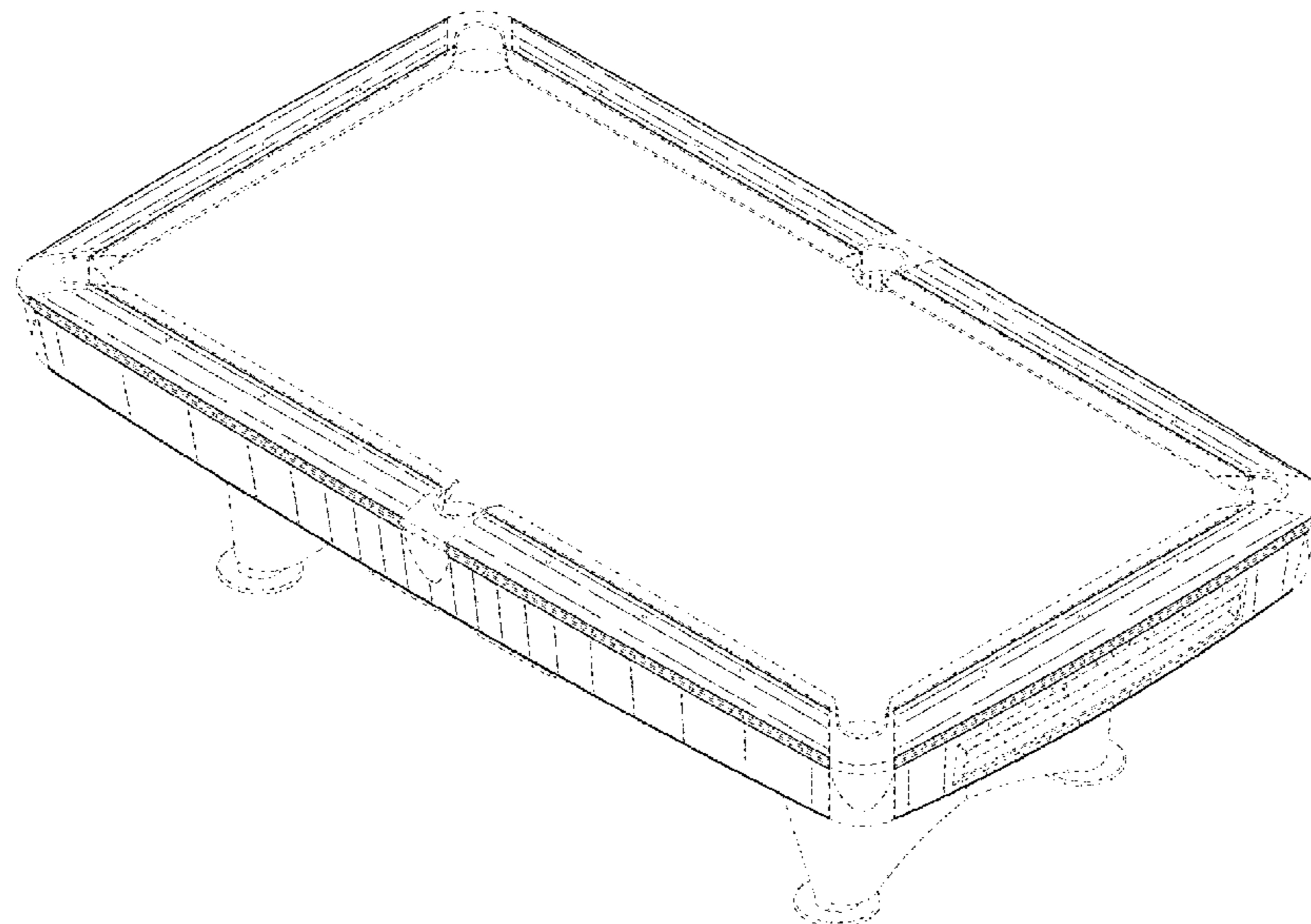
FIG. 1 is a perspective view of a billiard table showing our new design;  
 FIG. 2 is a side elevation view of the length of the billiard table thereof;  
 FIG. 3 is an opposite side elevation thereof;  
 FIG. 4 is an end elevation view of the width of the billiard table in FIG. 1;  
 FIG. 5 is an opposite end elevation view thereof;  
 FIG. 6 is a top plan view of FIG. 1; and,  
 FIG. 7 is a bottom plan view thereof.  
 The broken lines shown in the drawings depict portions of the billiard table that form no part of the claimed design.

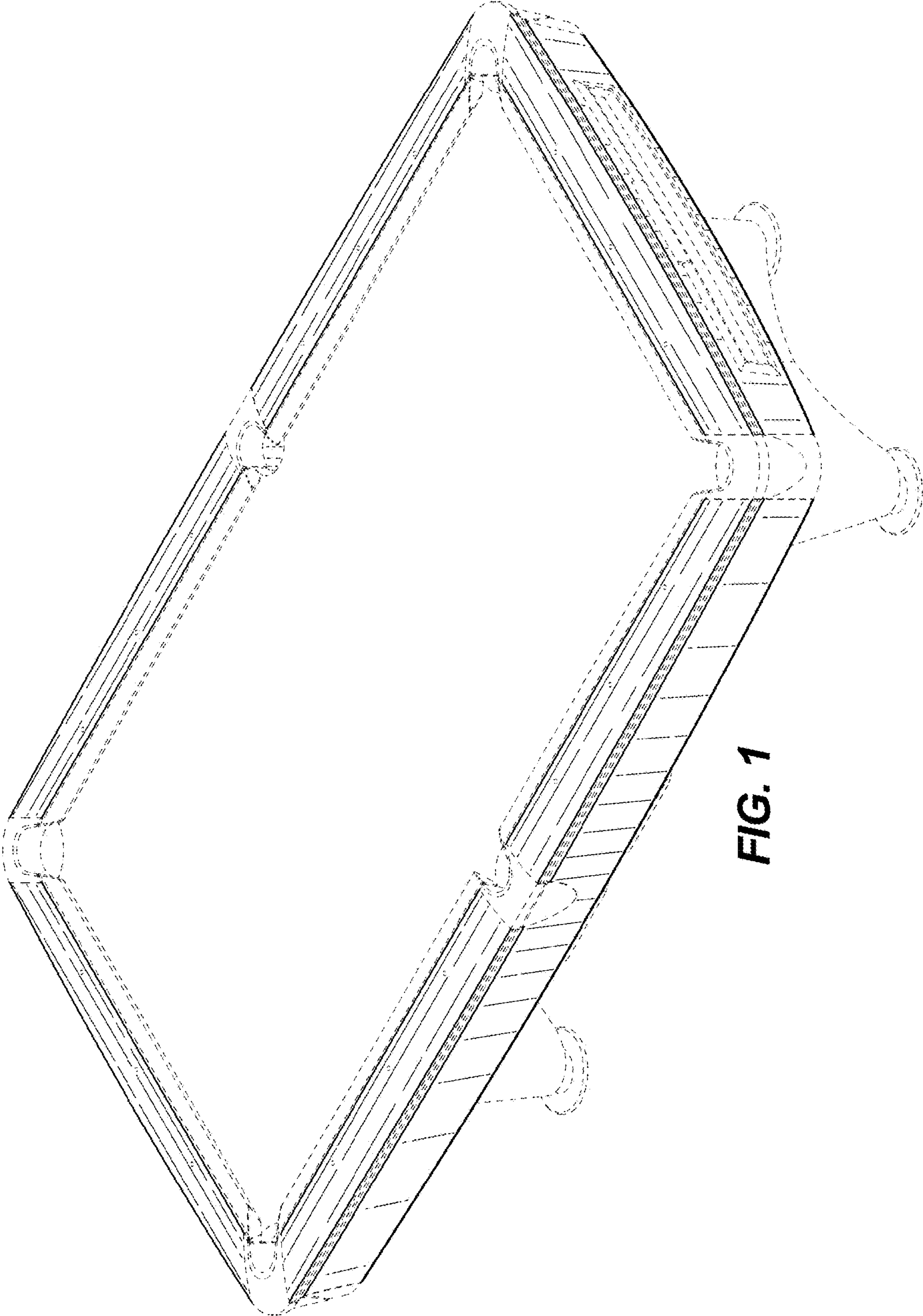

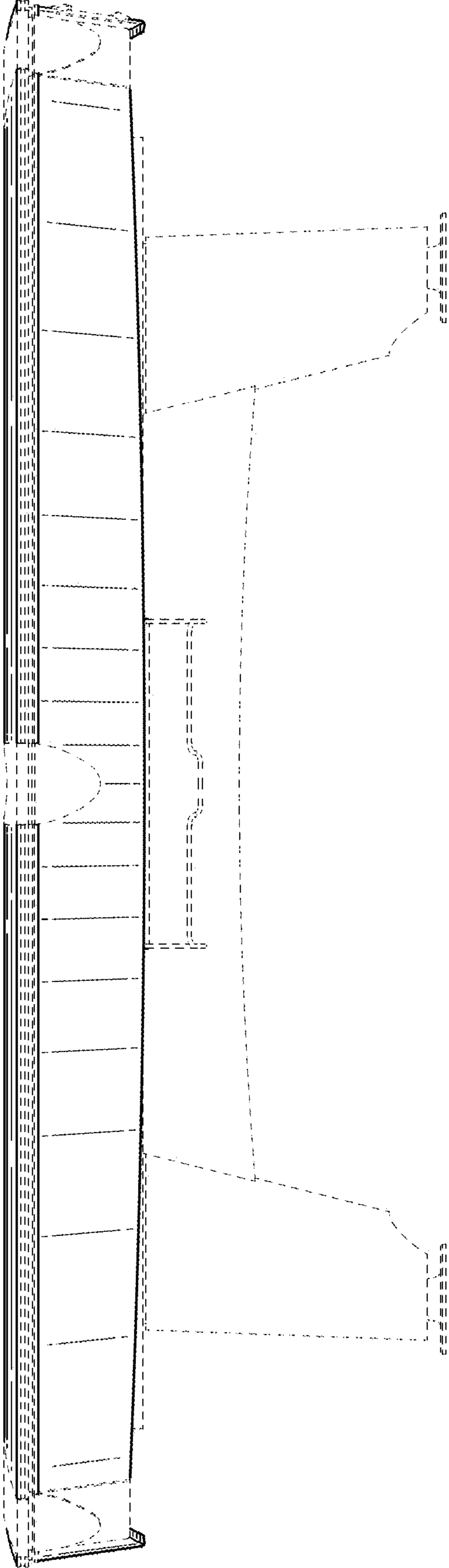

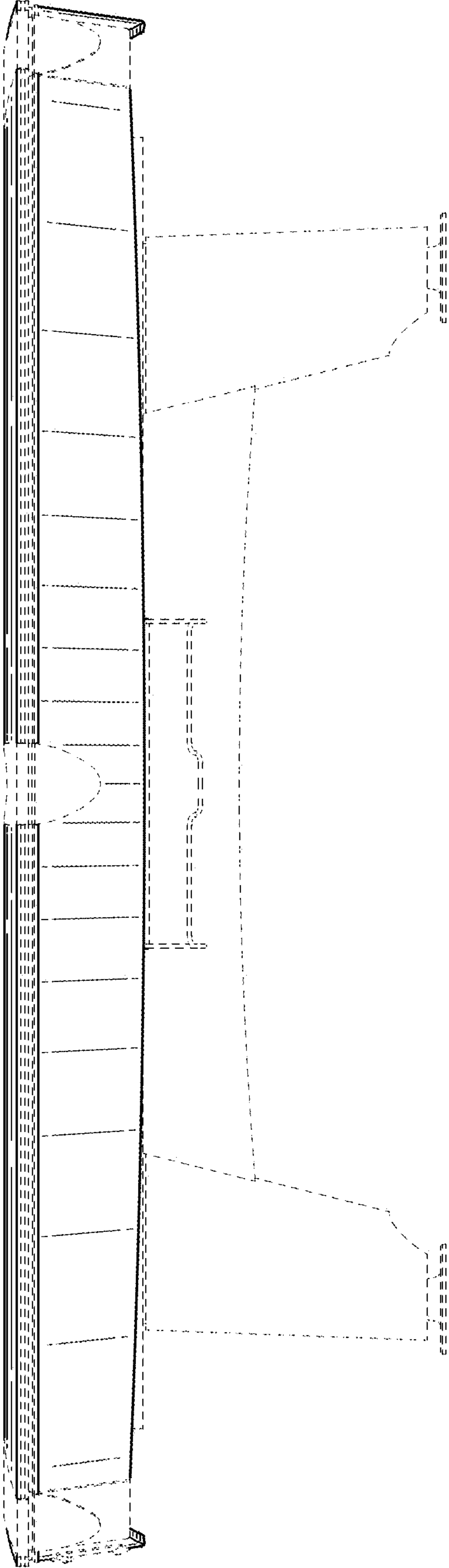
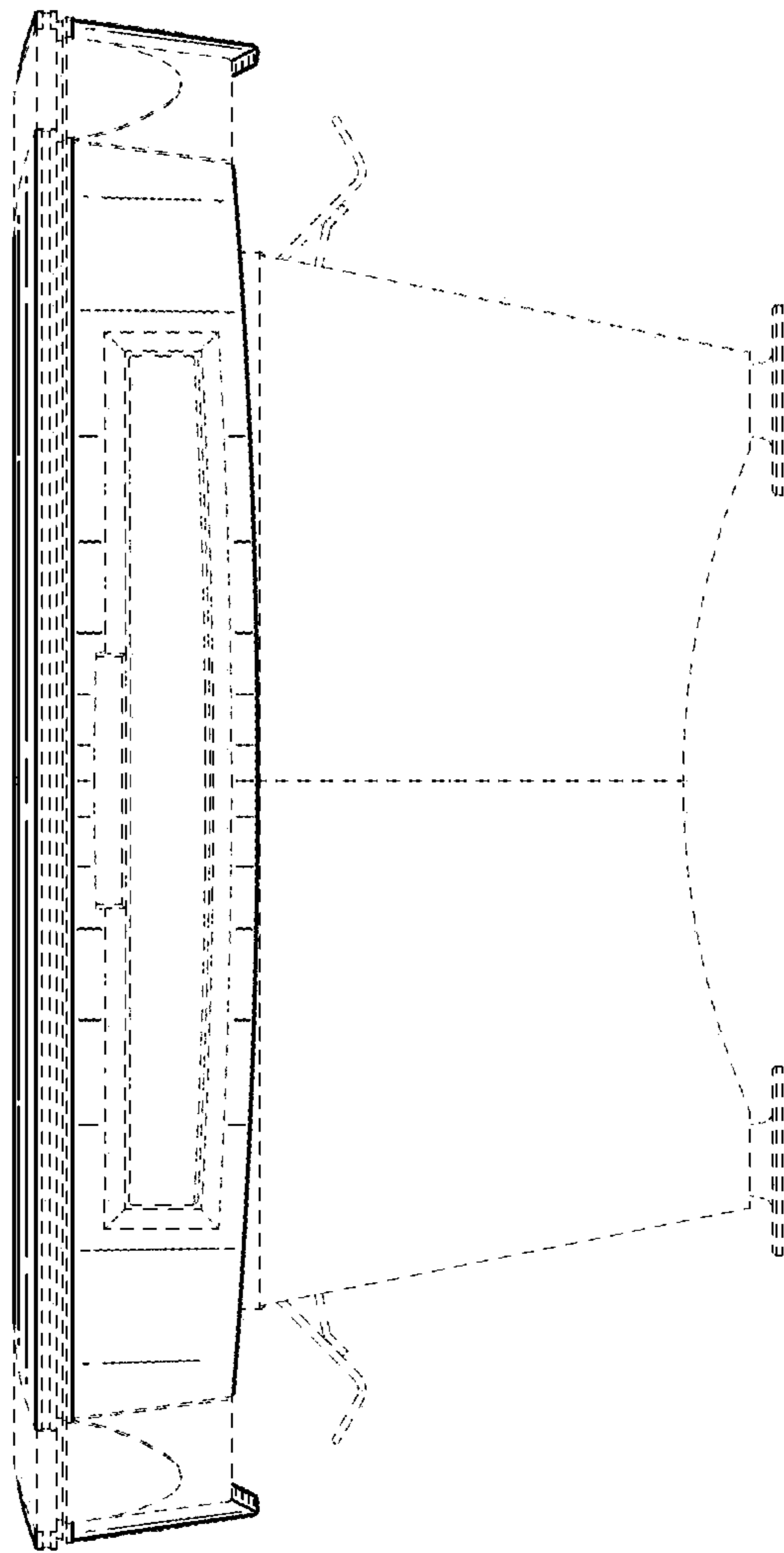
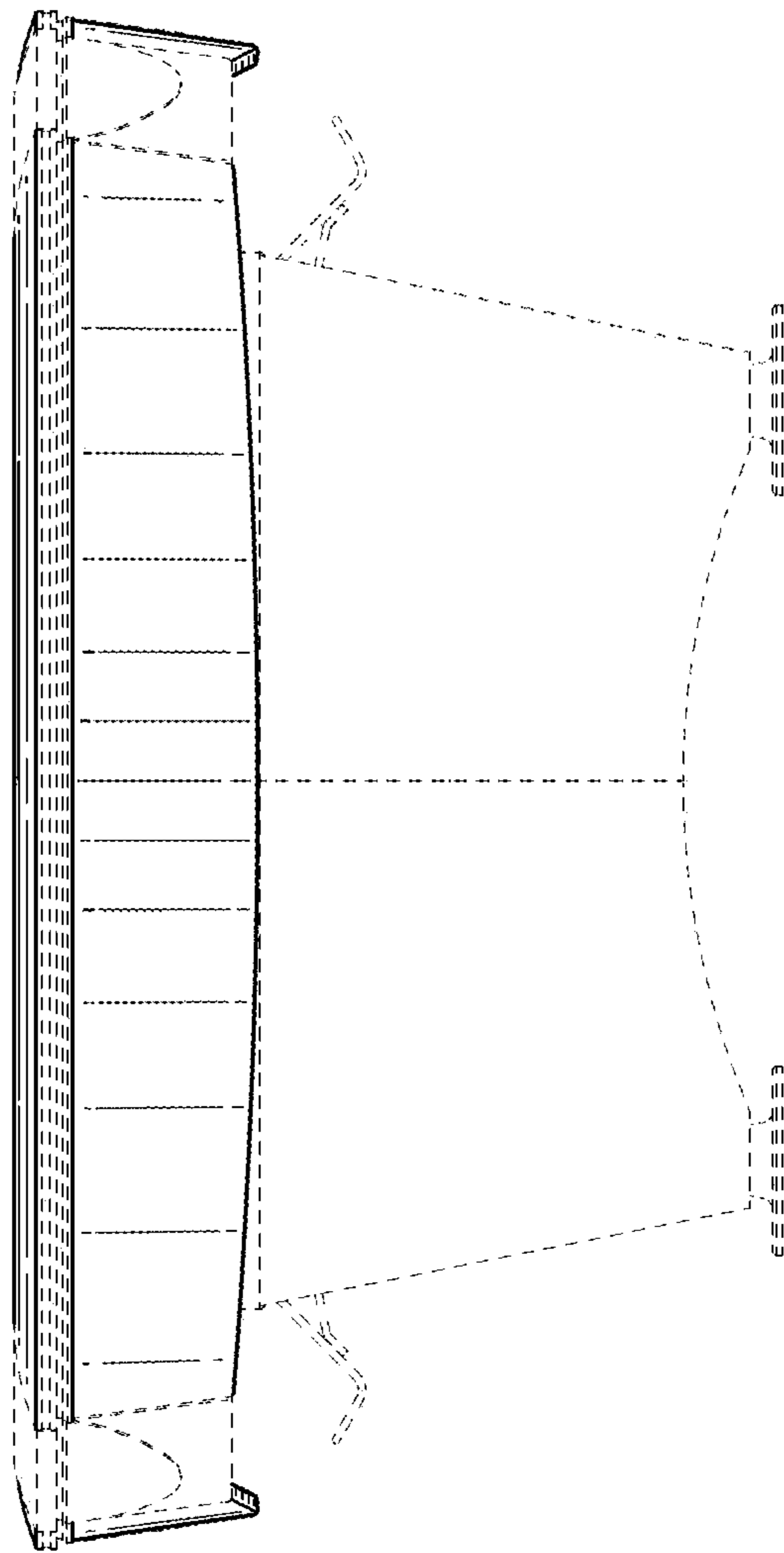


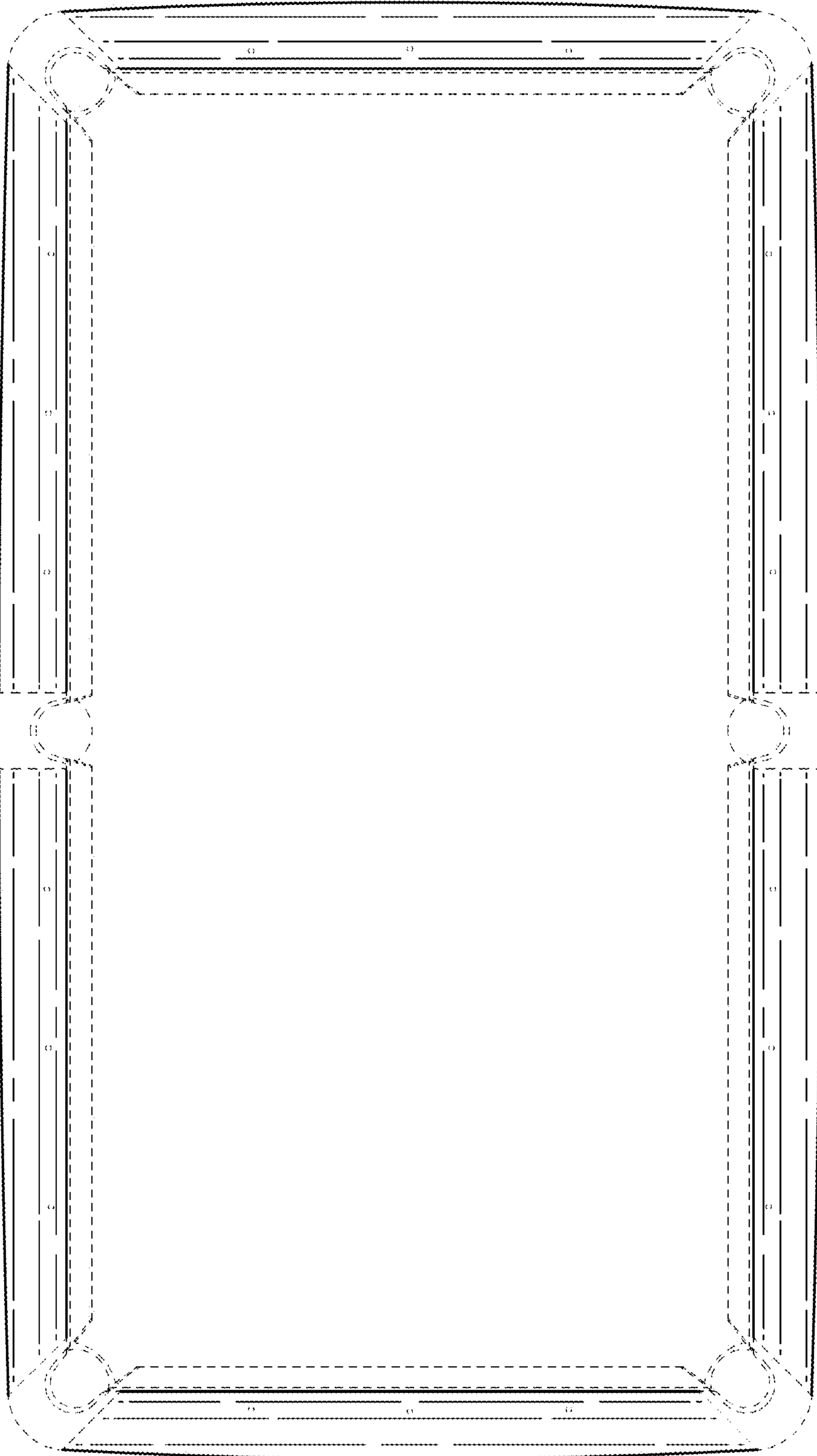

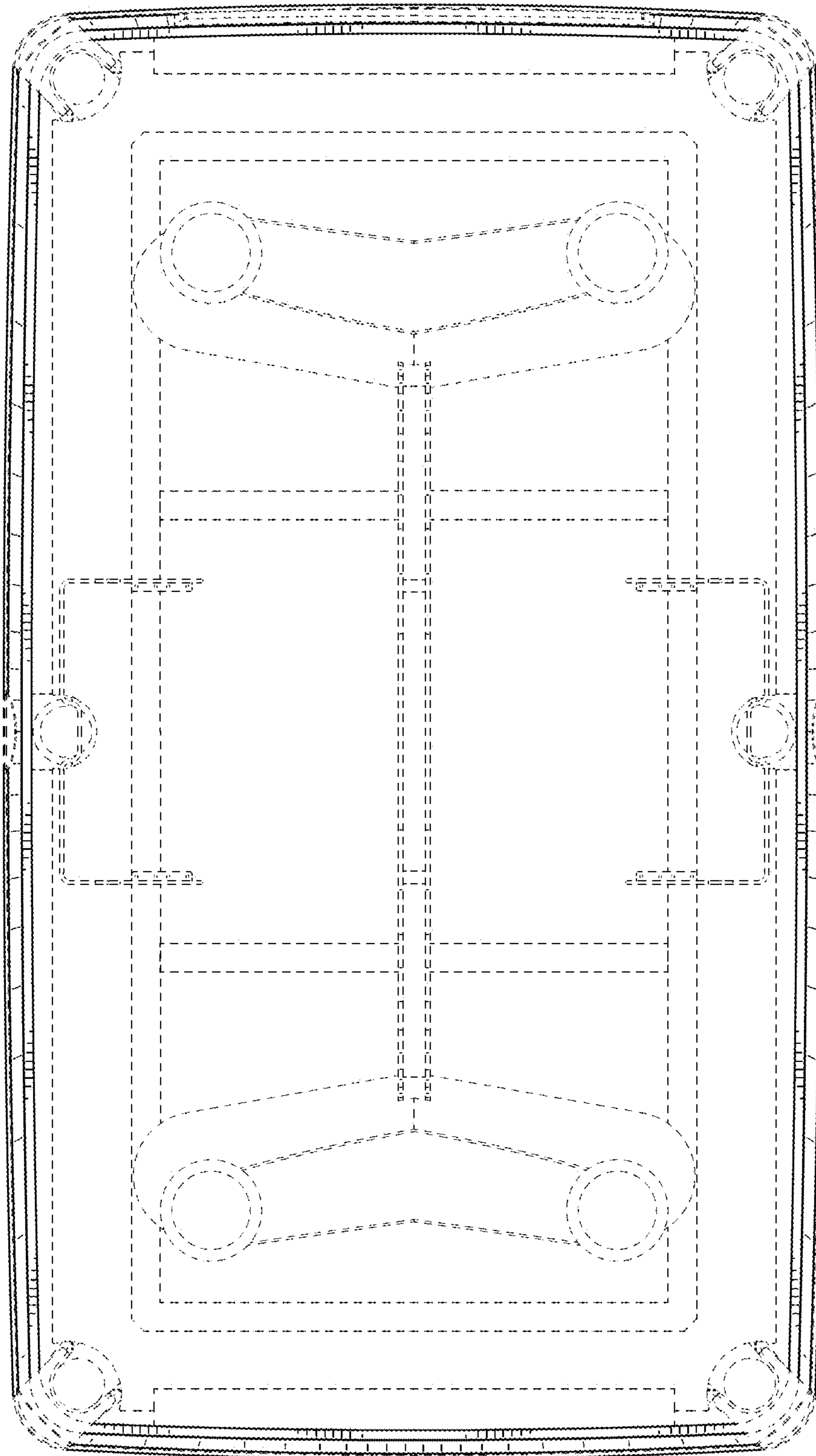
