(57) **CLAIM**

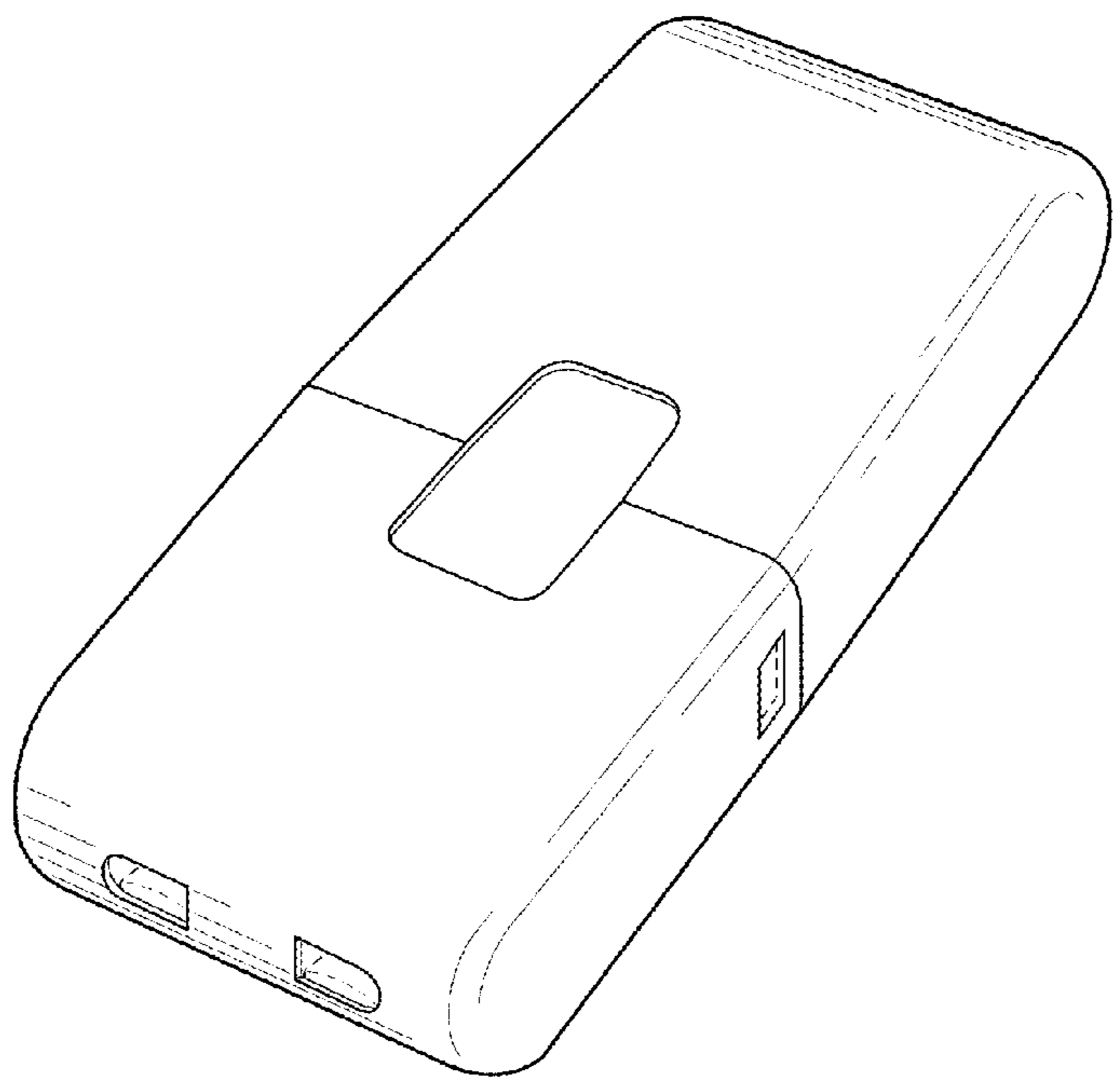
I claim the ornamental design for a vaporizer cartridge, as shown and described.

DESCRIPTION

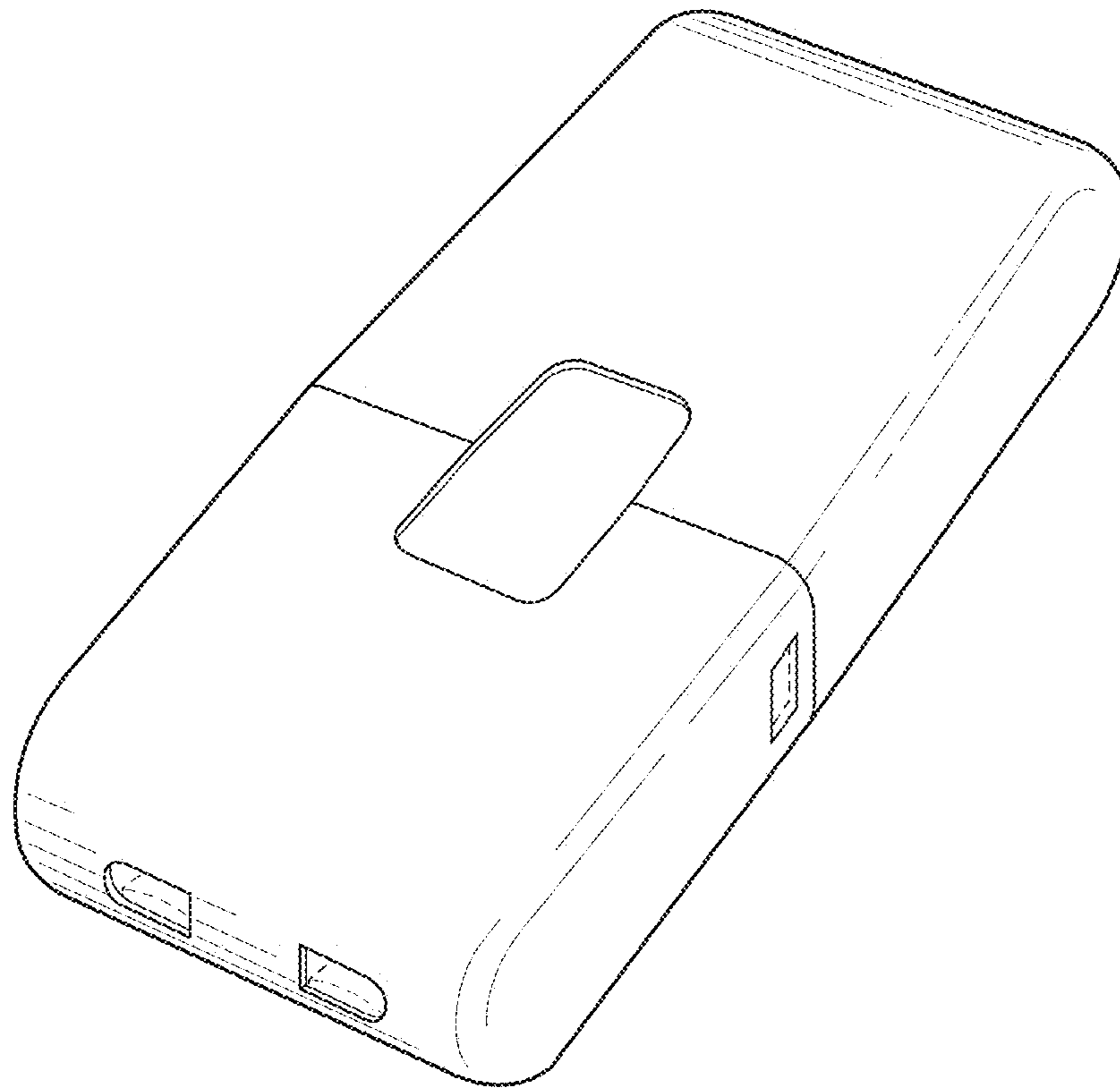

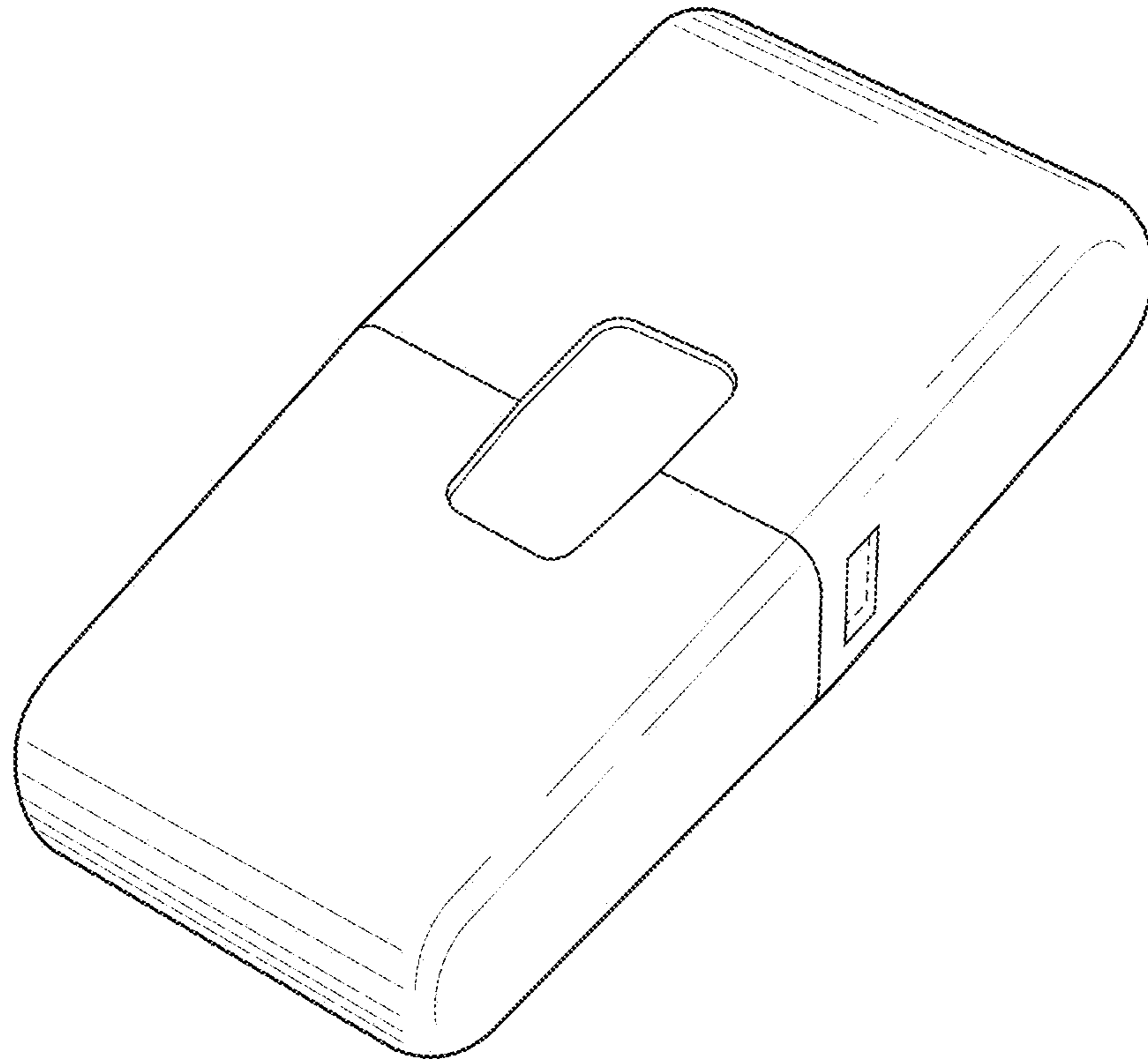

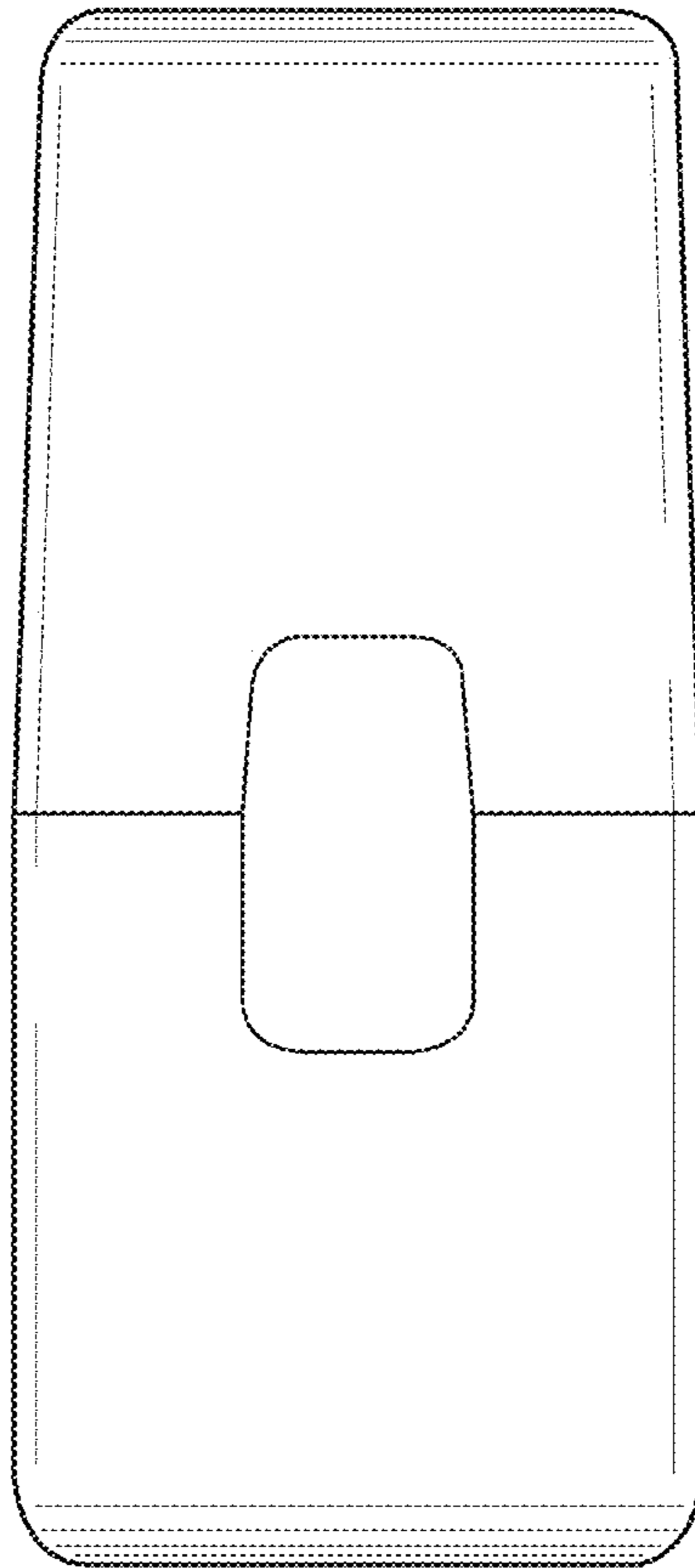

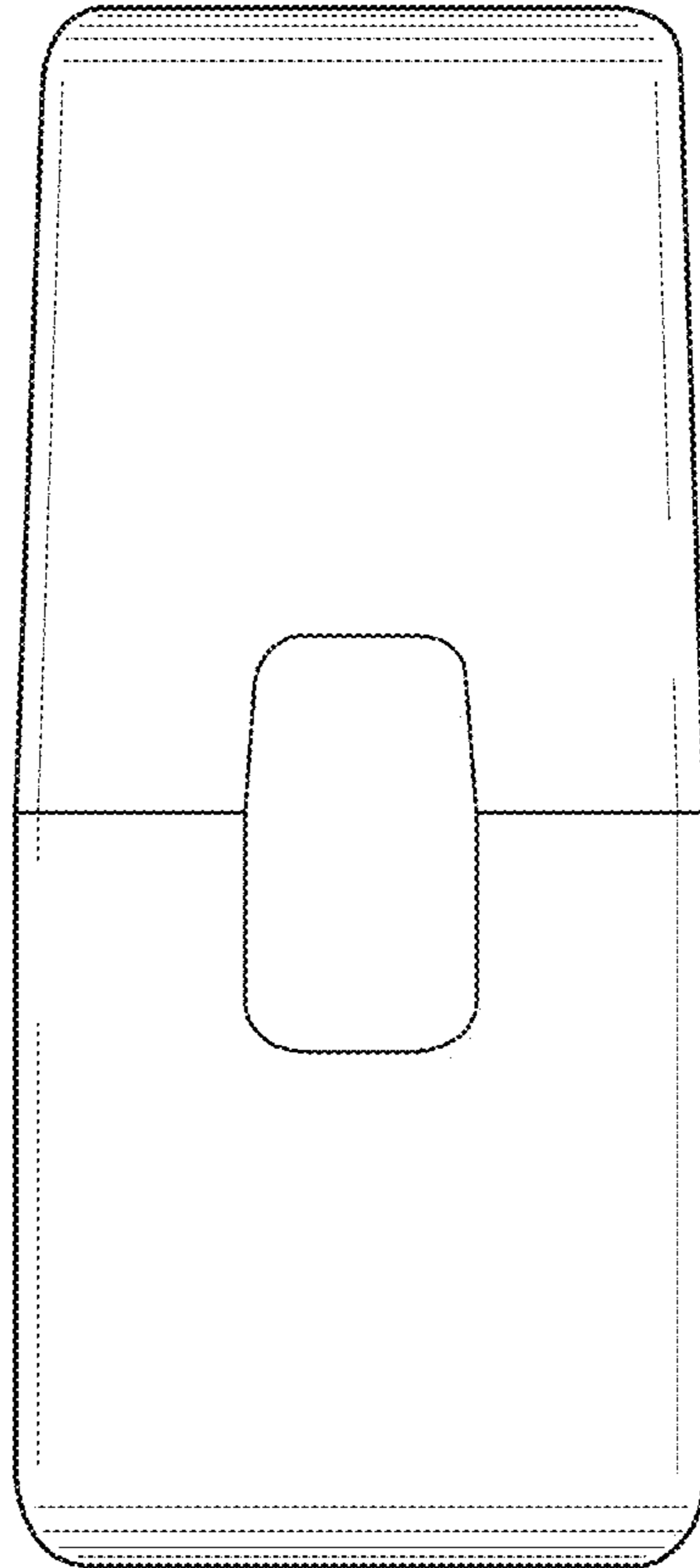

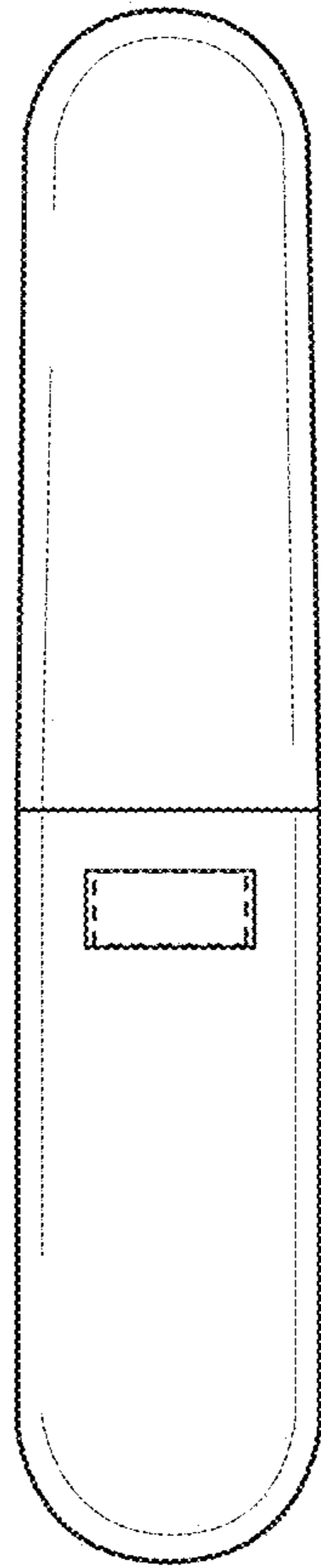

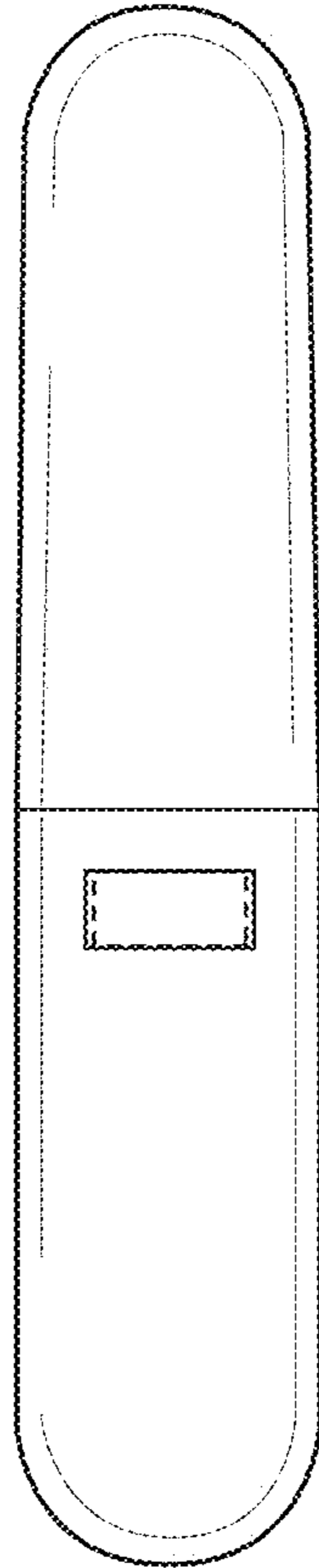

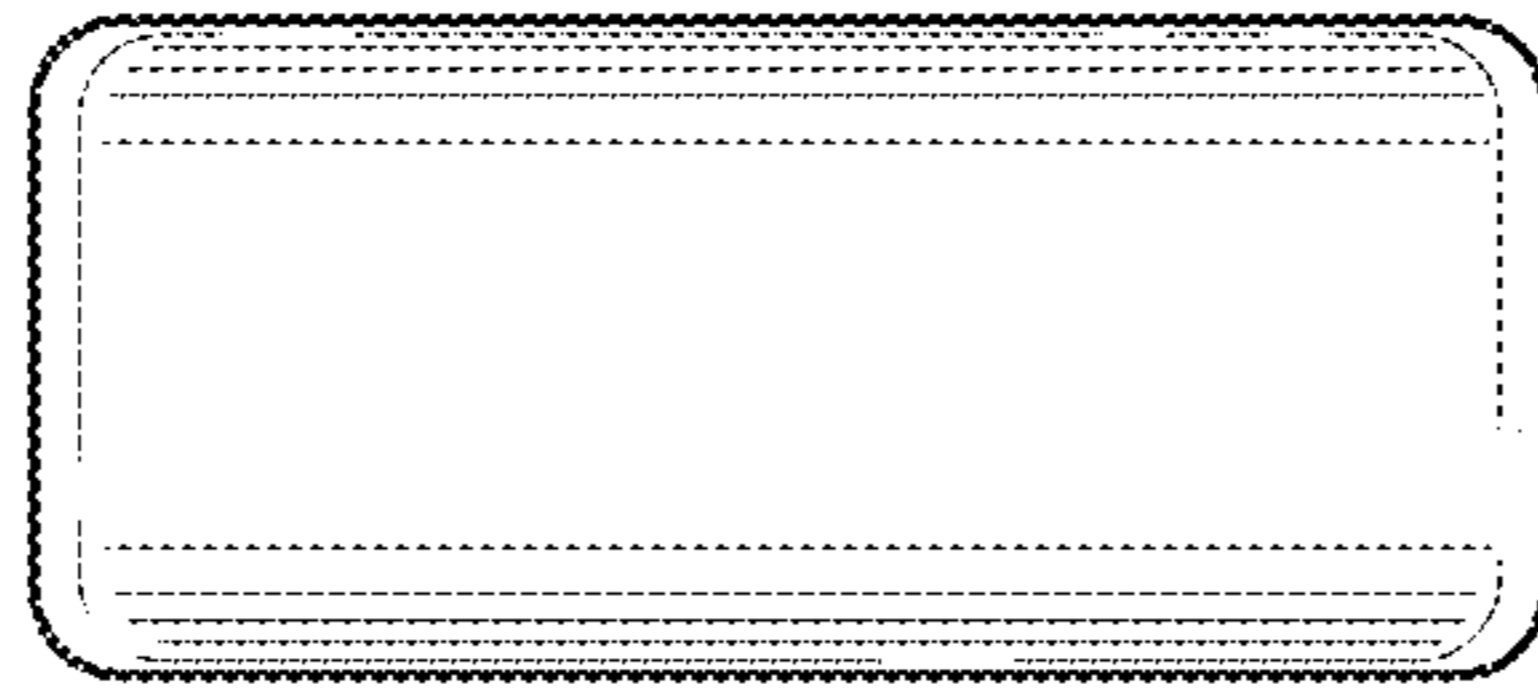

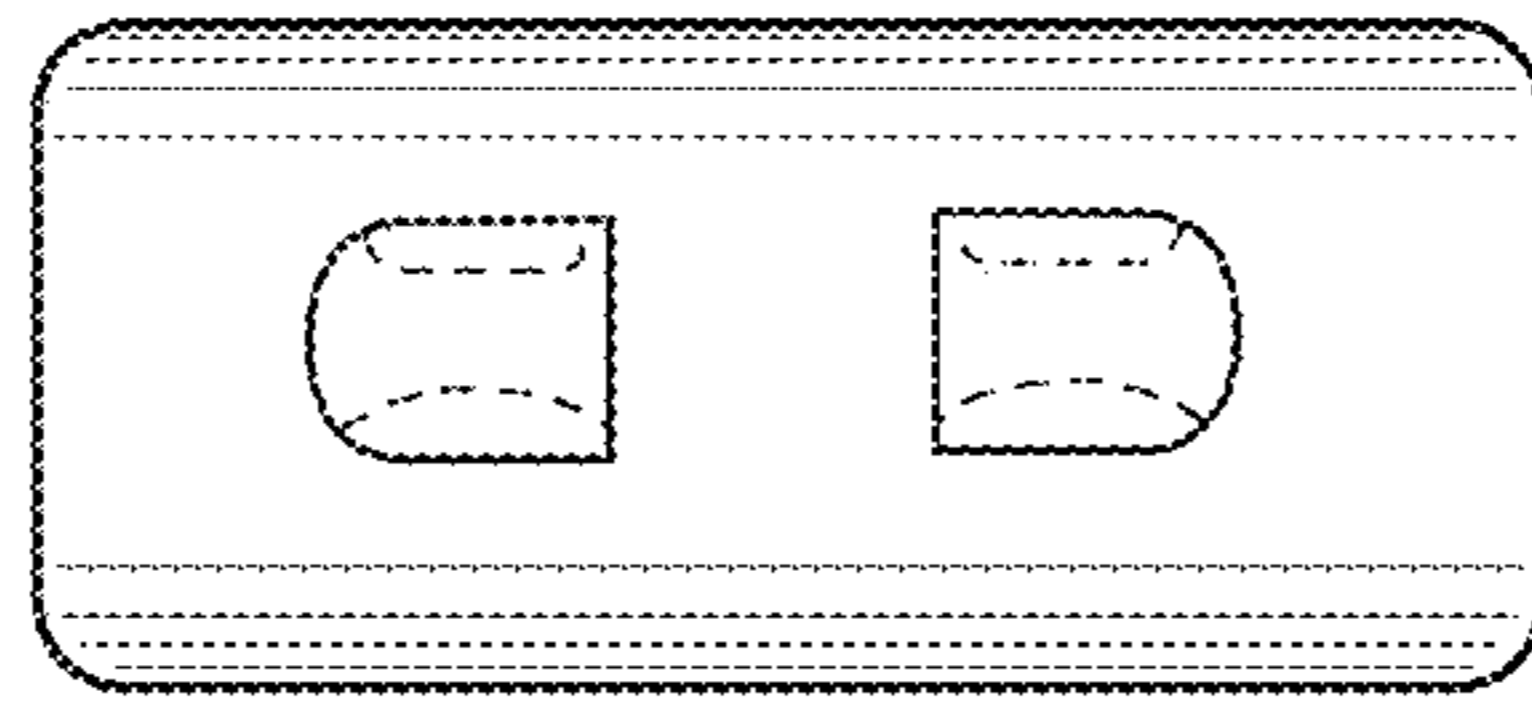

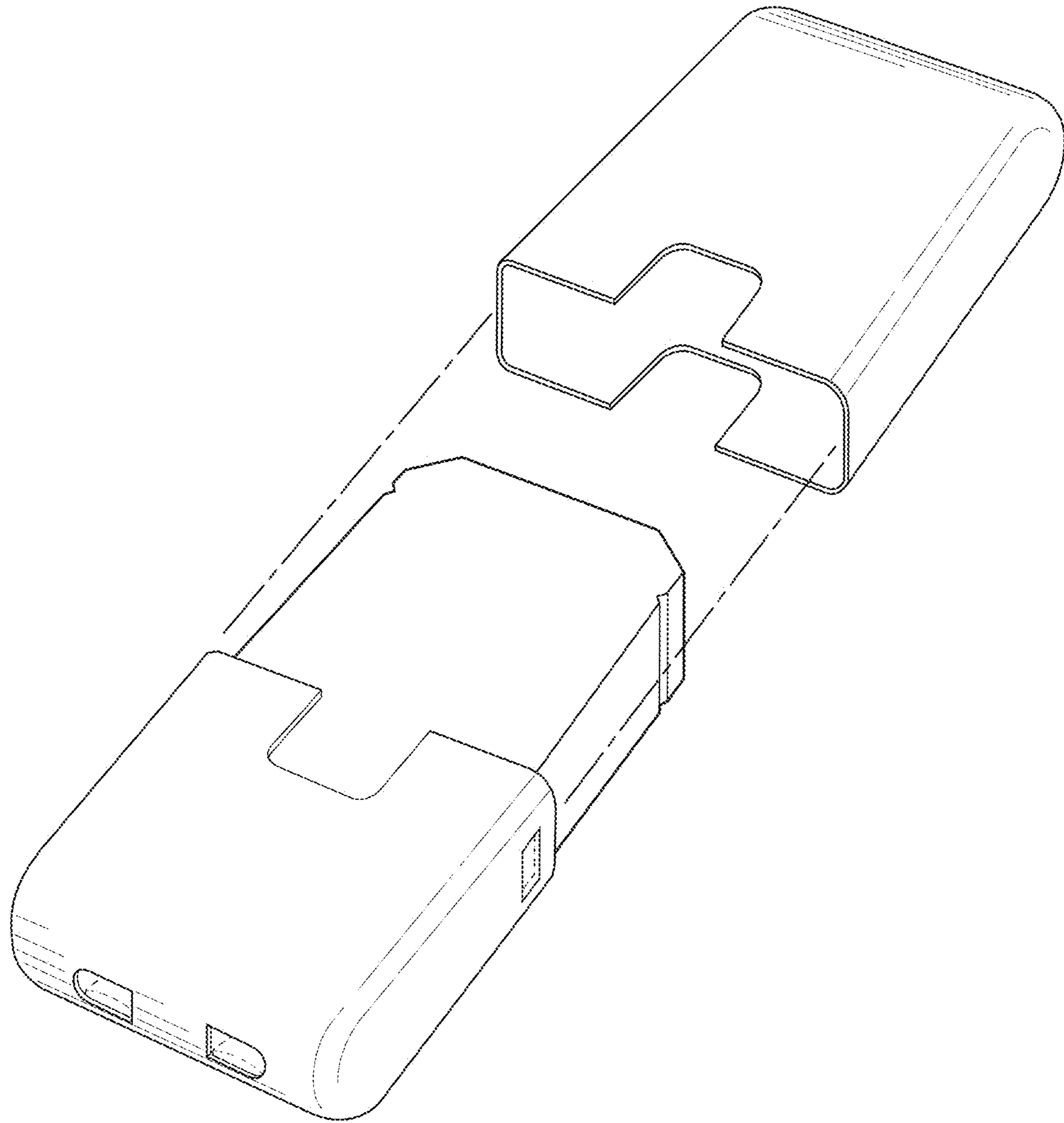

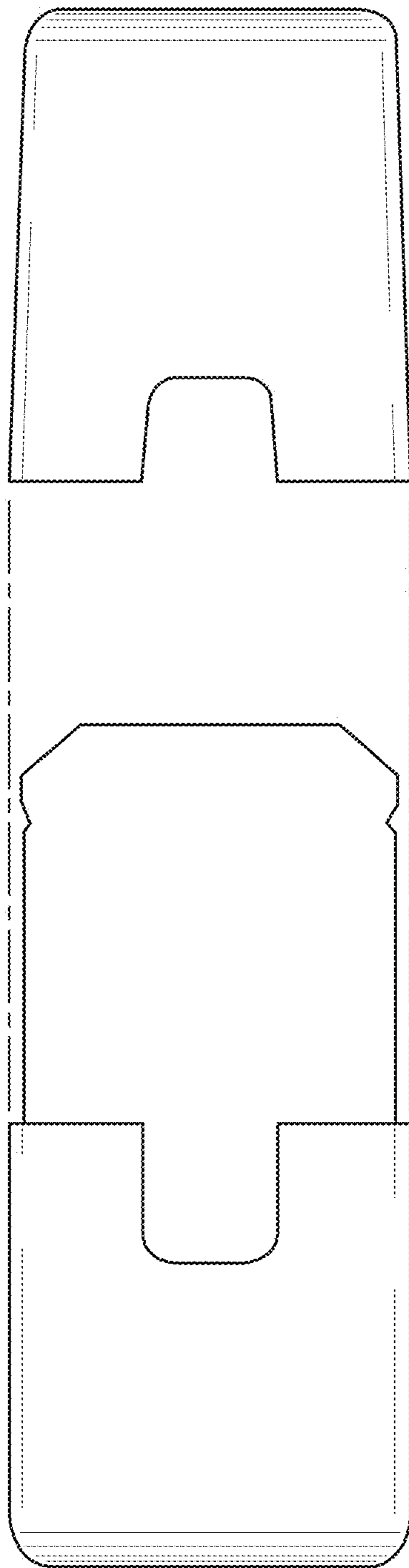

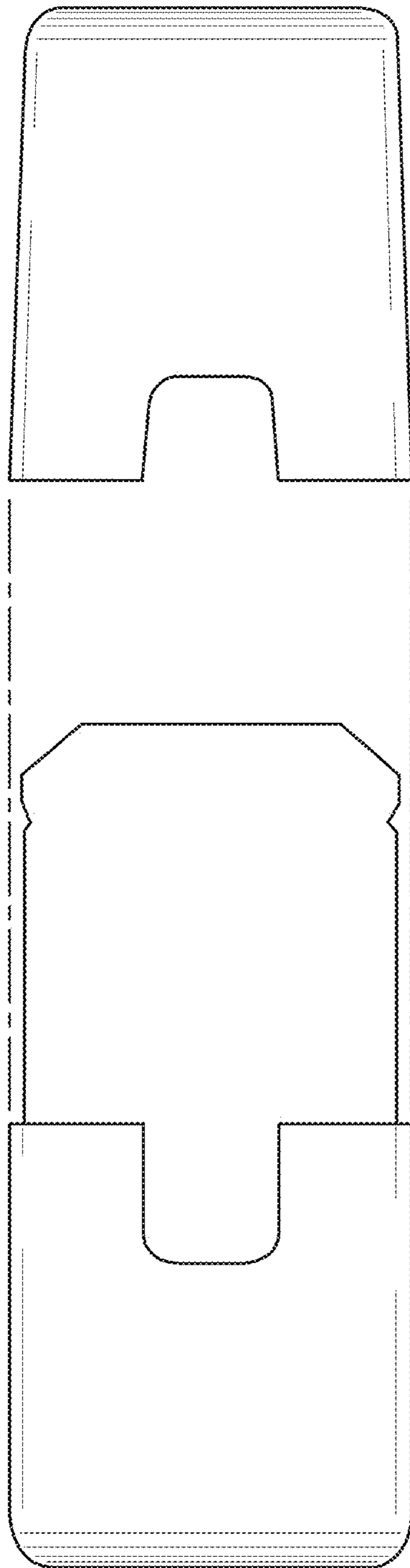

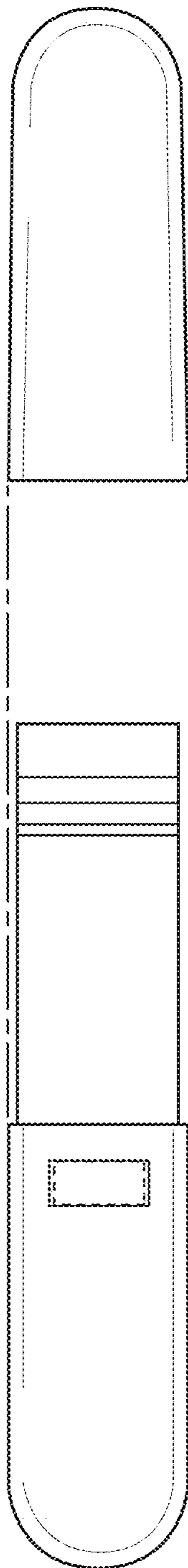

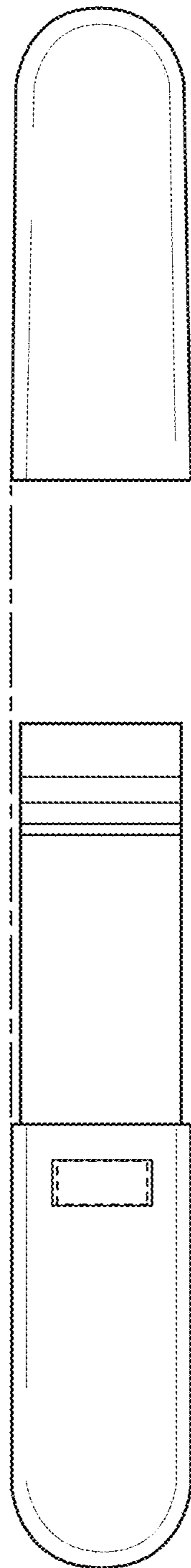
