**DESCRIPTION**

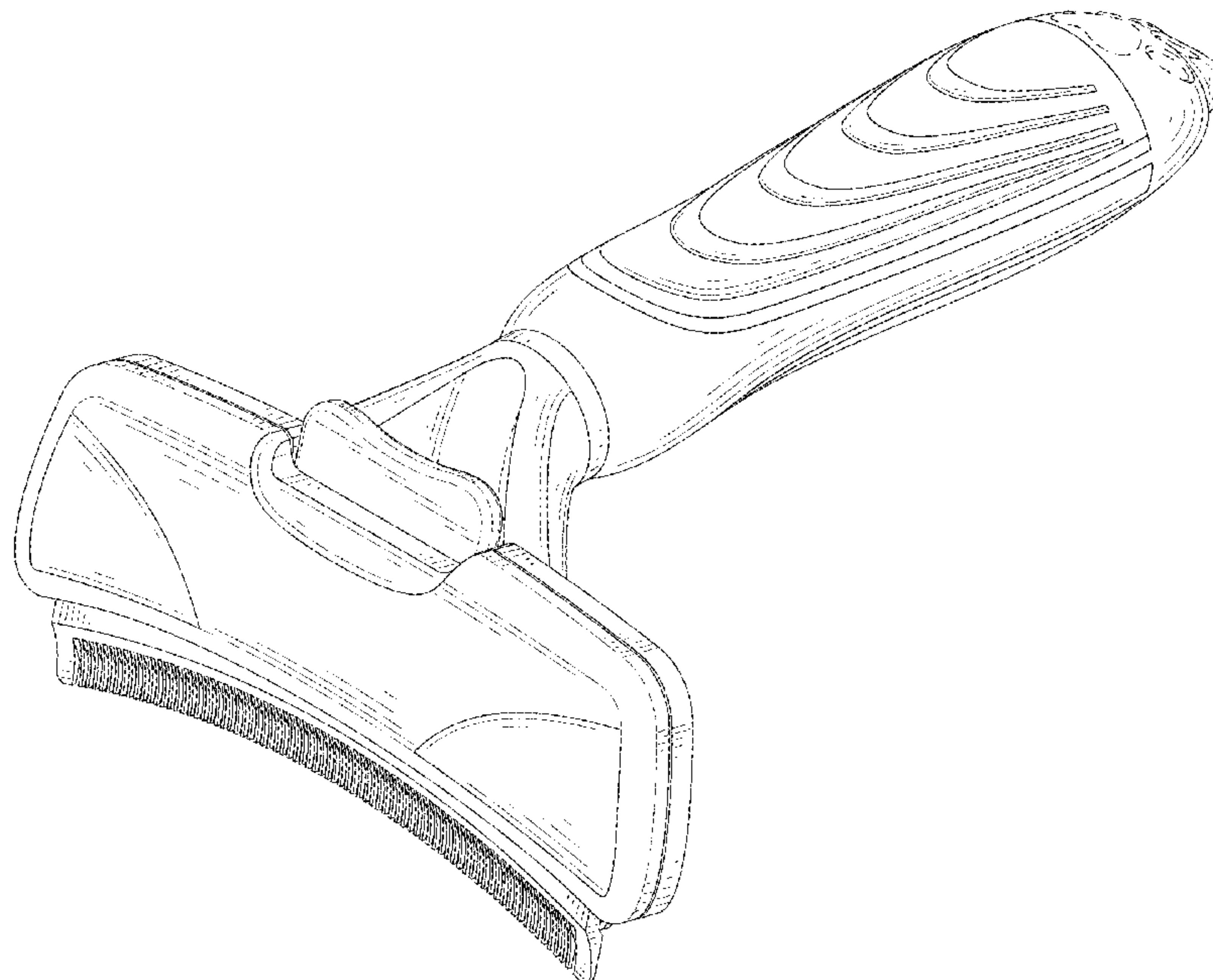
FIG. 1 is a top, front and right side perspective view of a pet comb showing our new design;

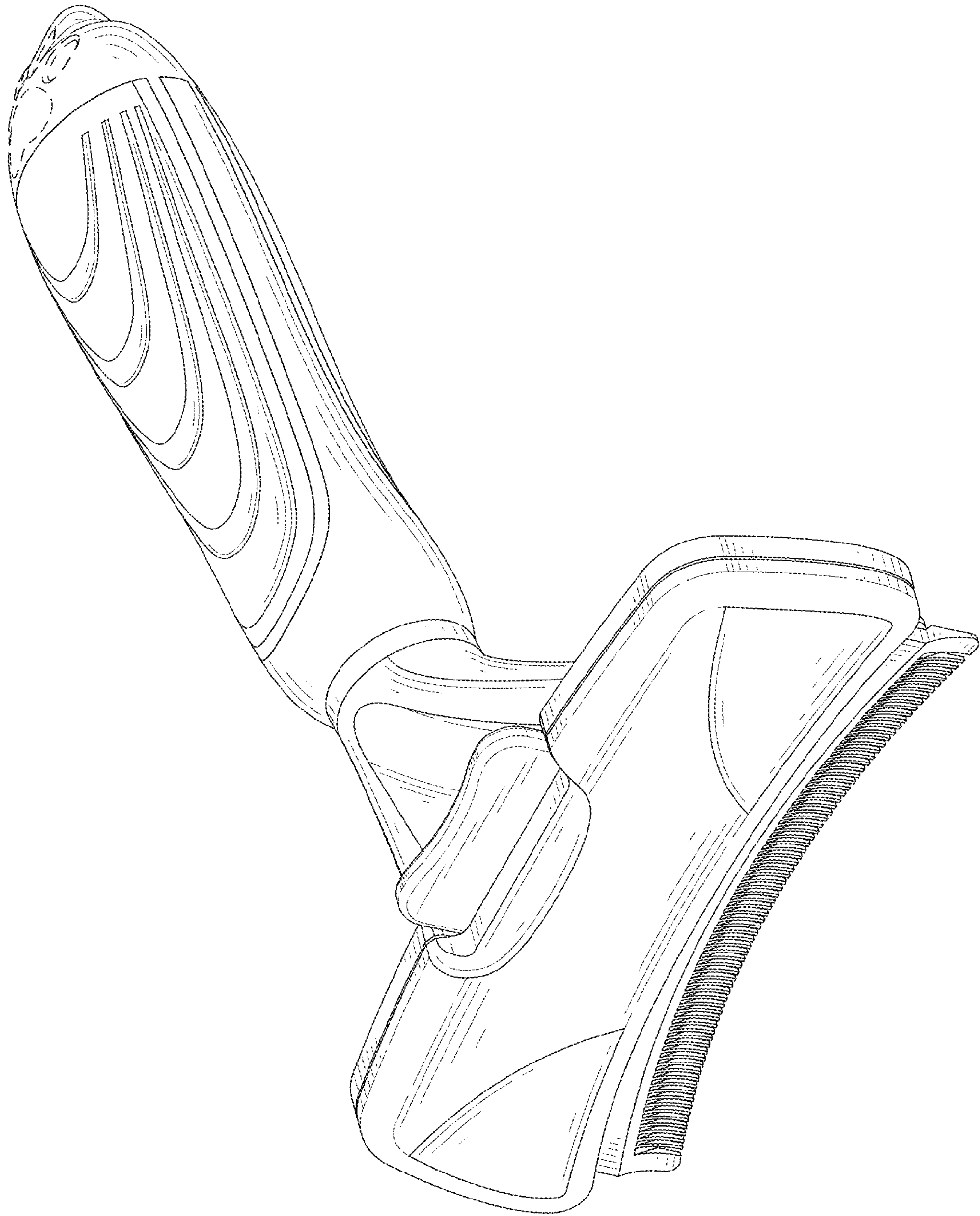

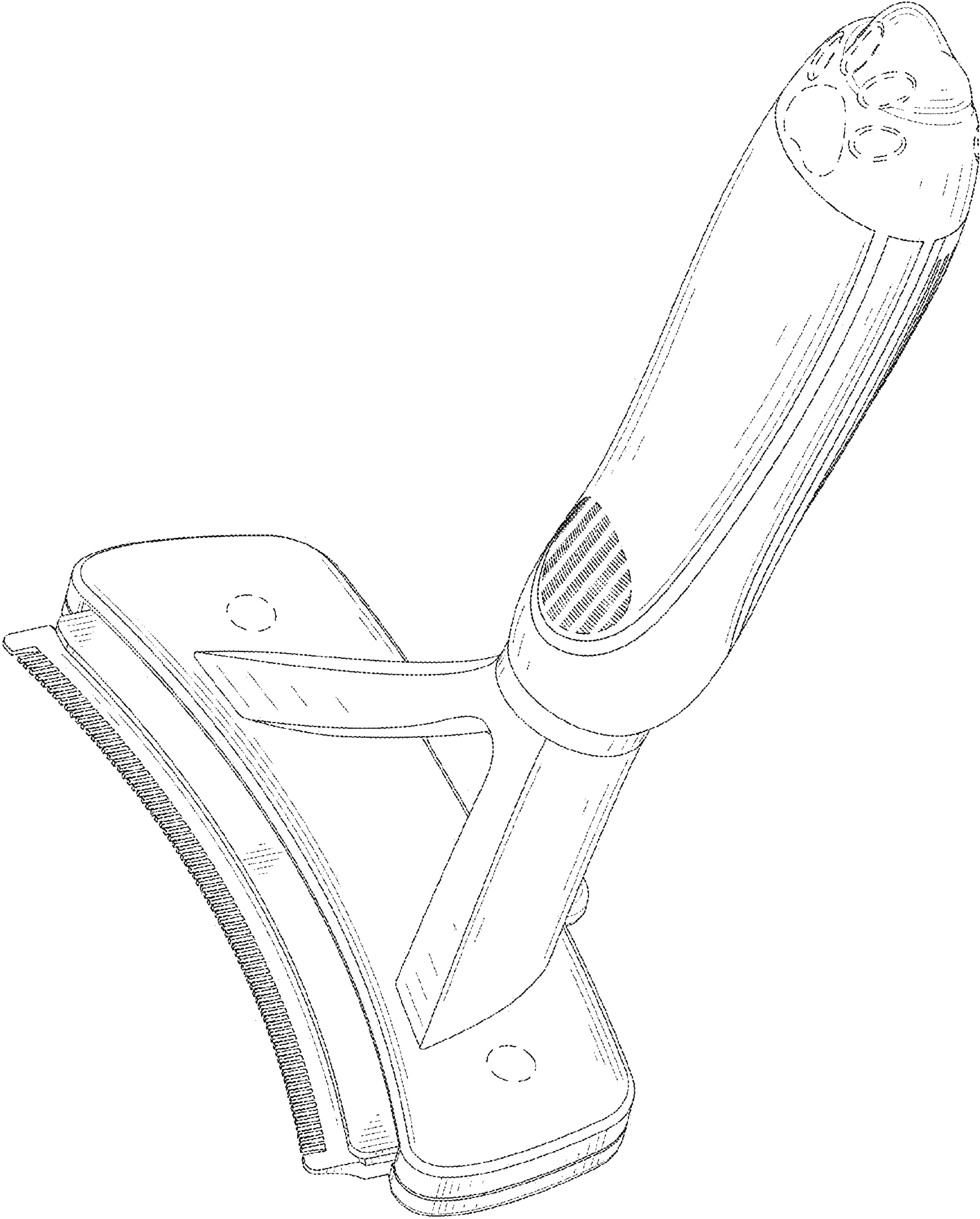

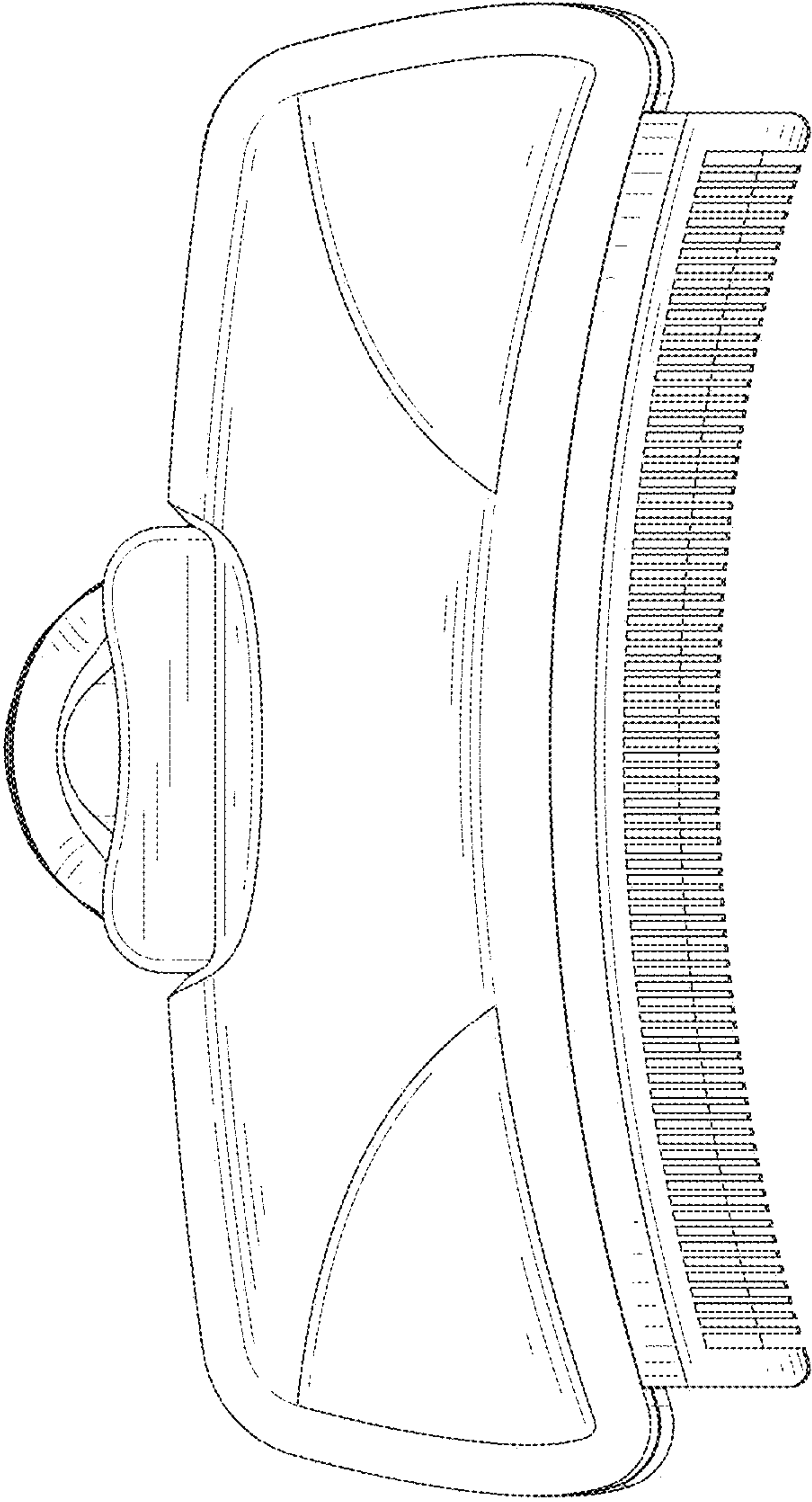

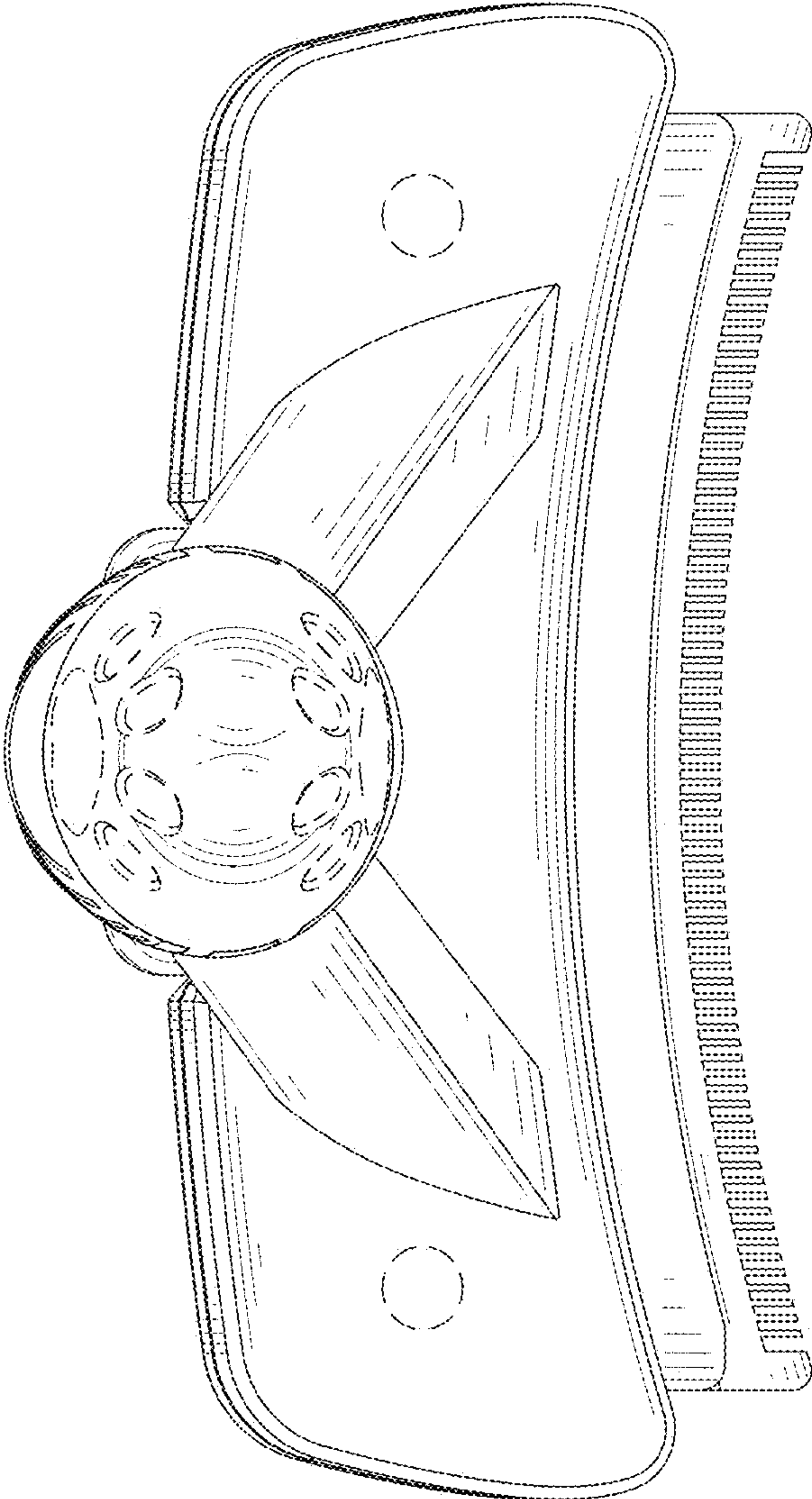

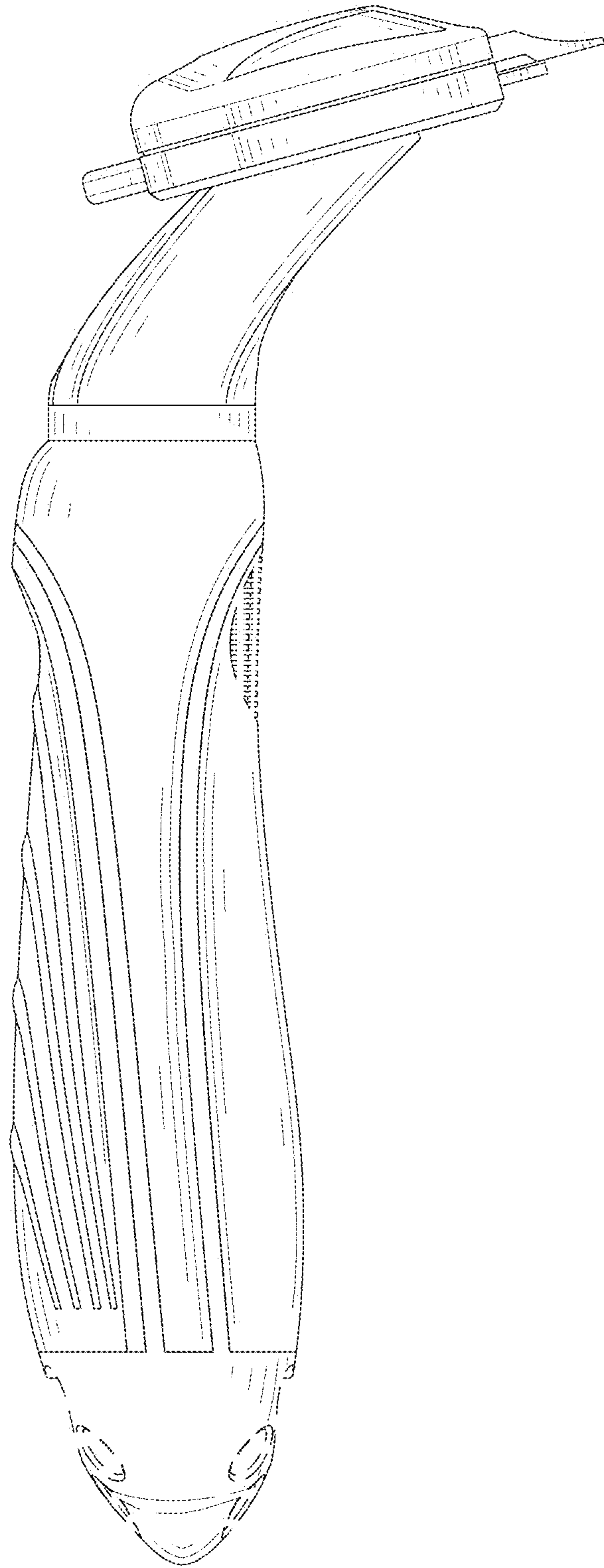

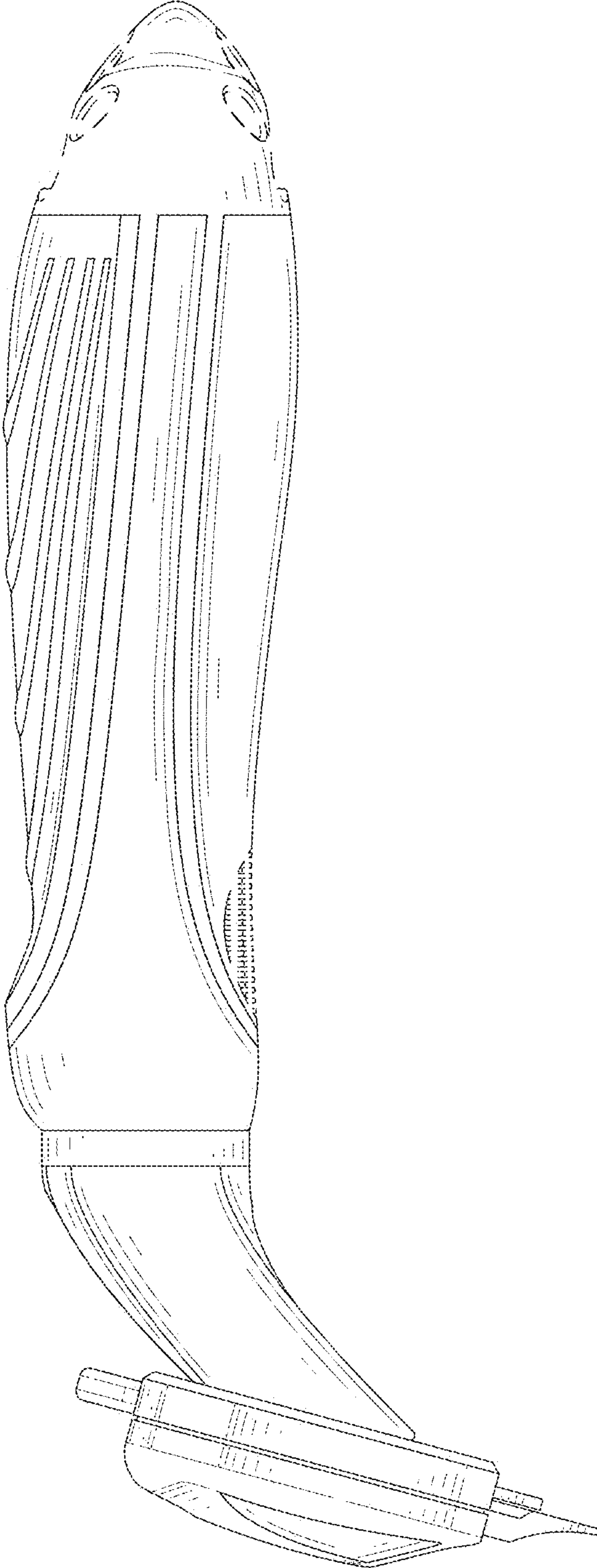

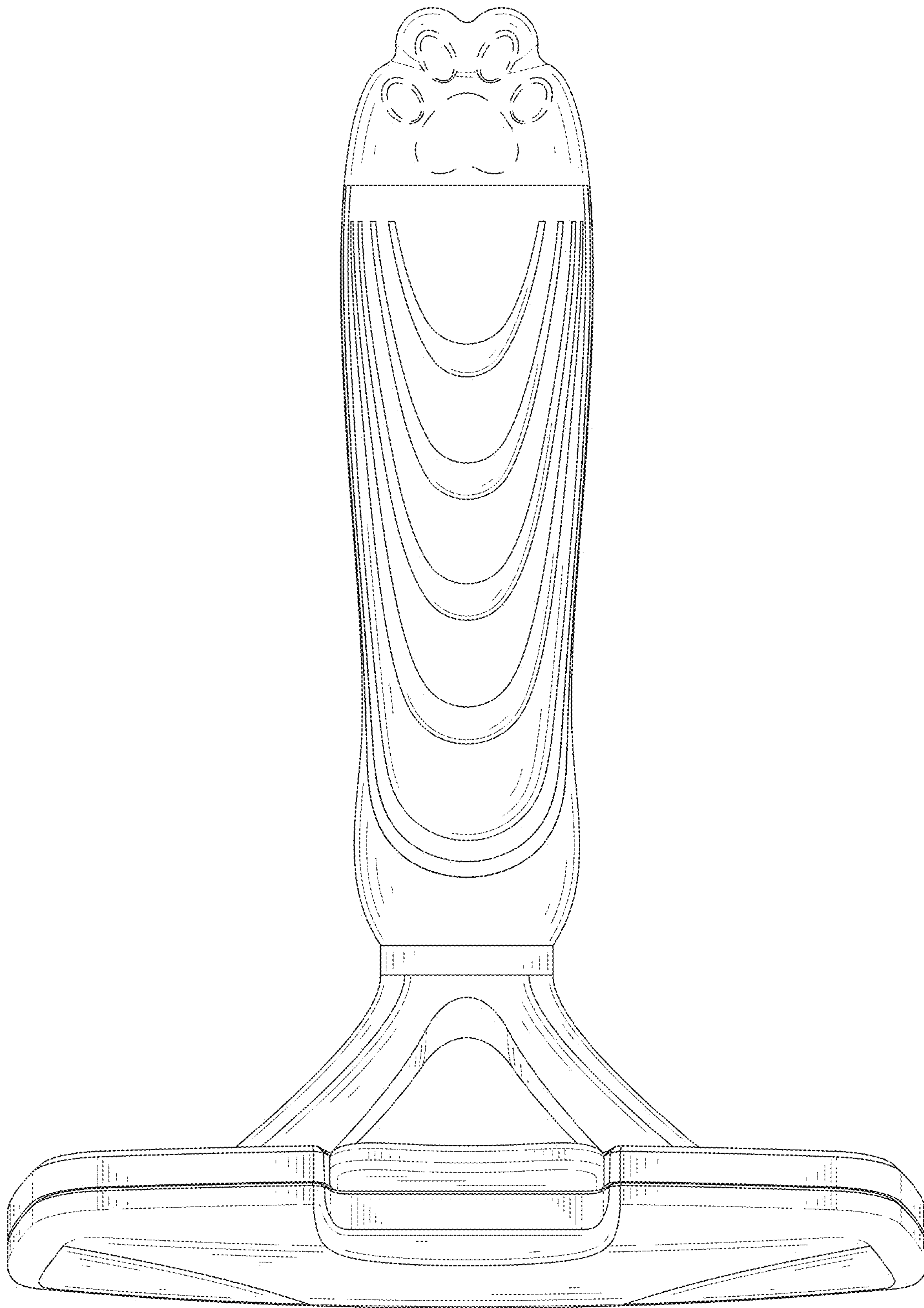

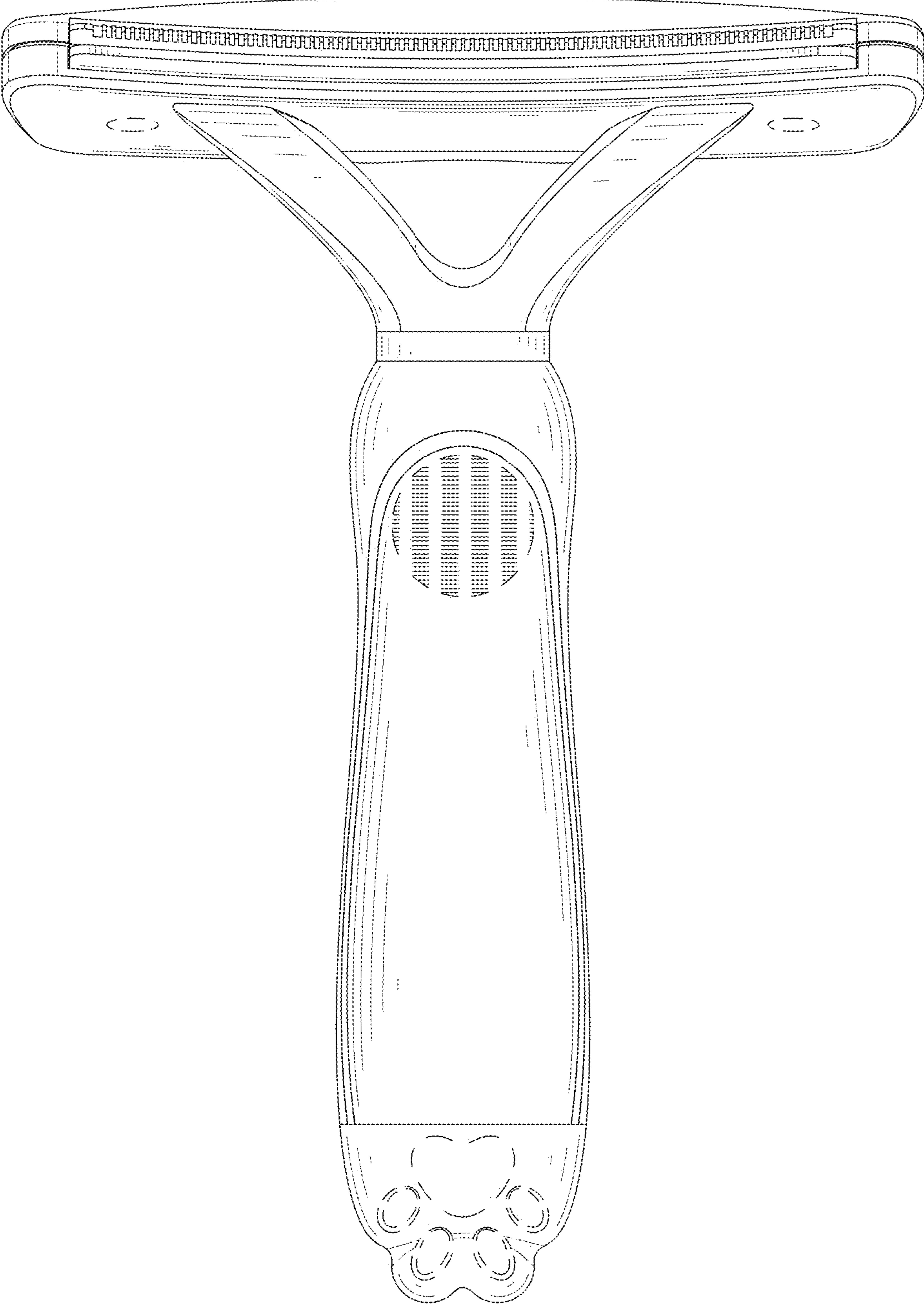
