(57) **CLAIM**

The ornamental design for a cleansing palette, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a front, top, and right side of an ornamental design for a cleansing palette;

FIG. 2 is a top plan view of the of the cleansing palette of FIG. 1;

FIG. 3 is a bottom plan view of the cleansing palette of FIG. 1;

FIG. 4 is a rear elevational view of the cleansing palette of FIG. 1;

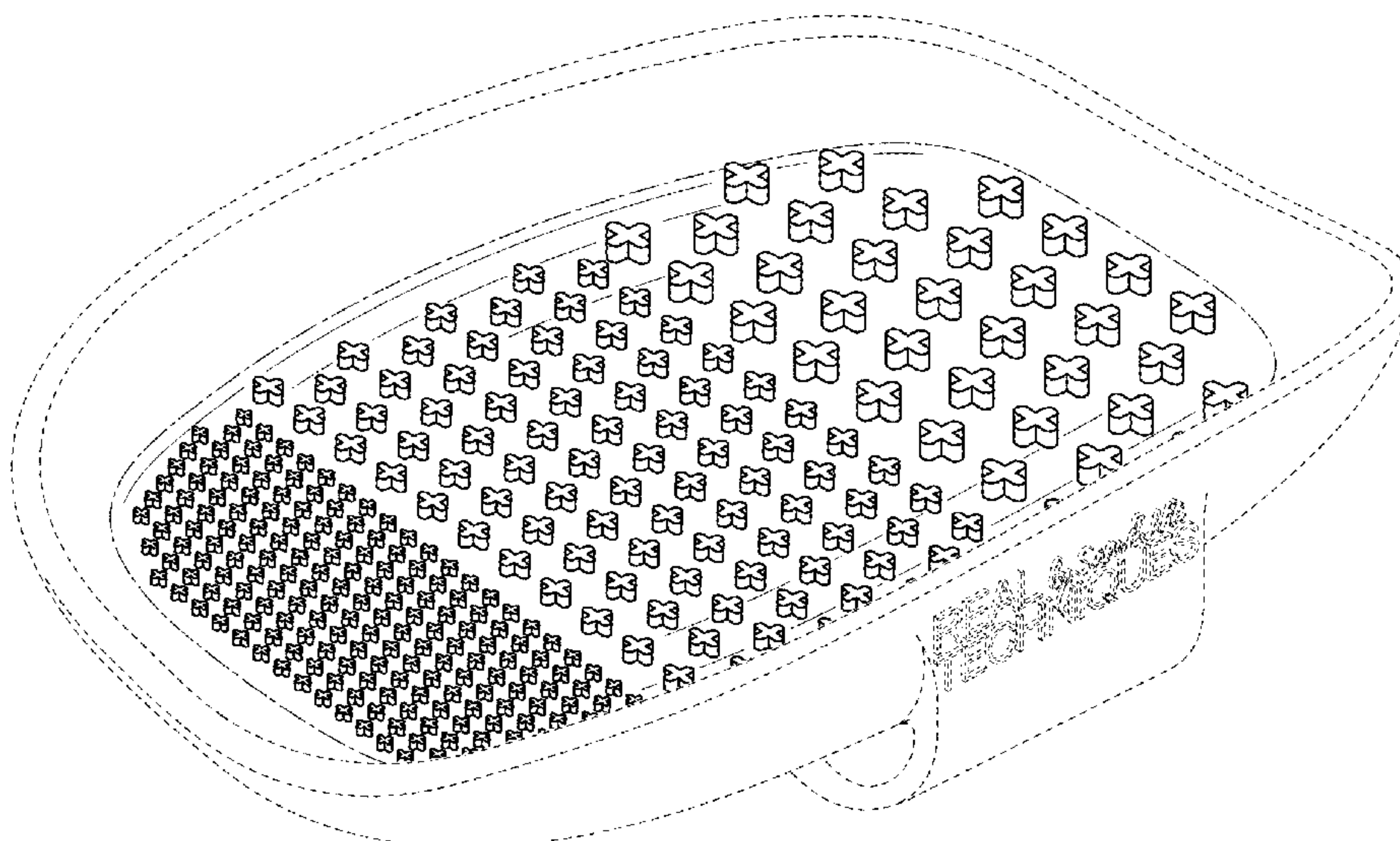
FIG. 5 is a front elevational view of the cleansing palette of FIG. 1;

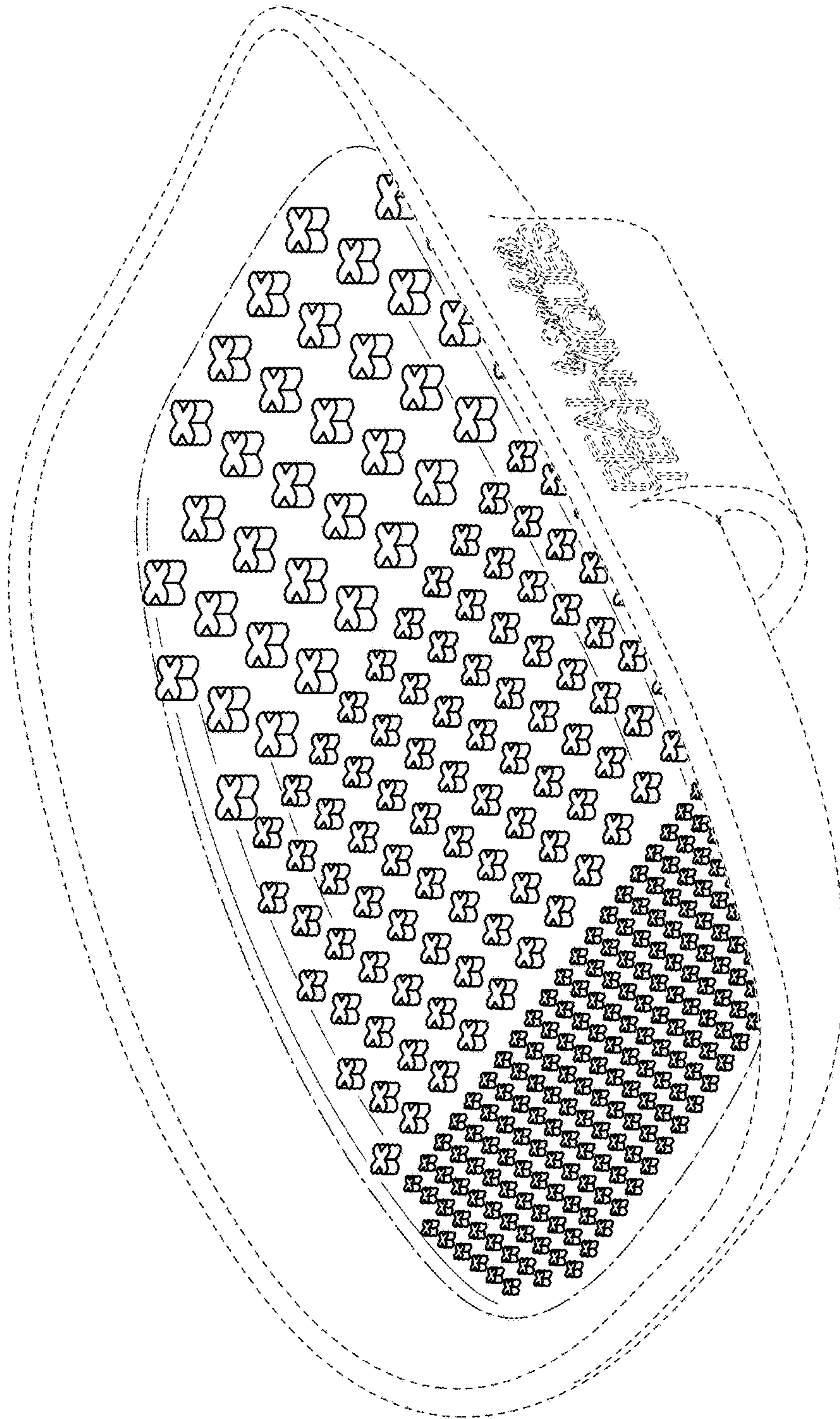

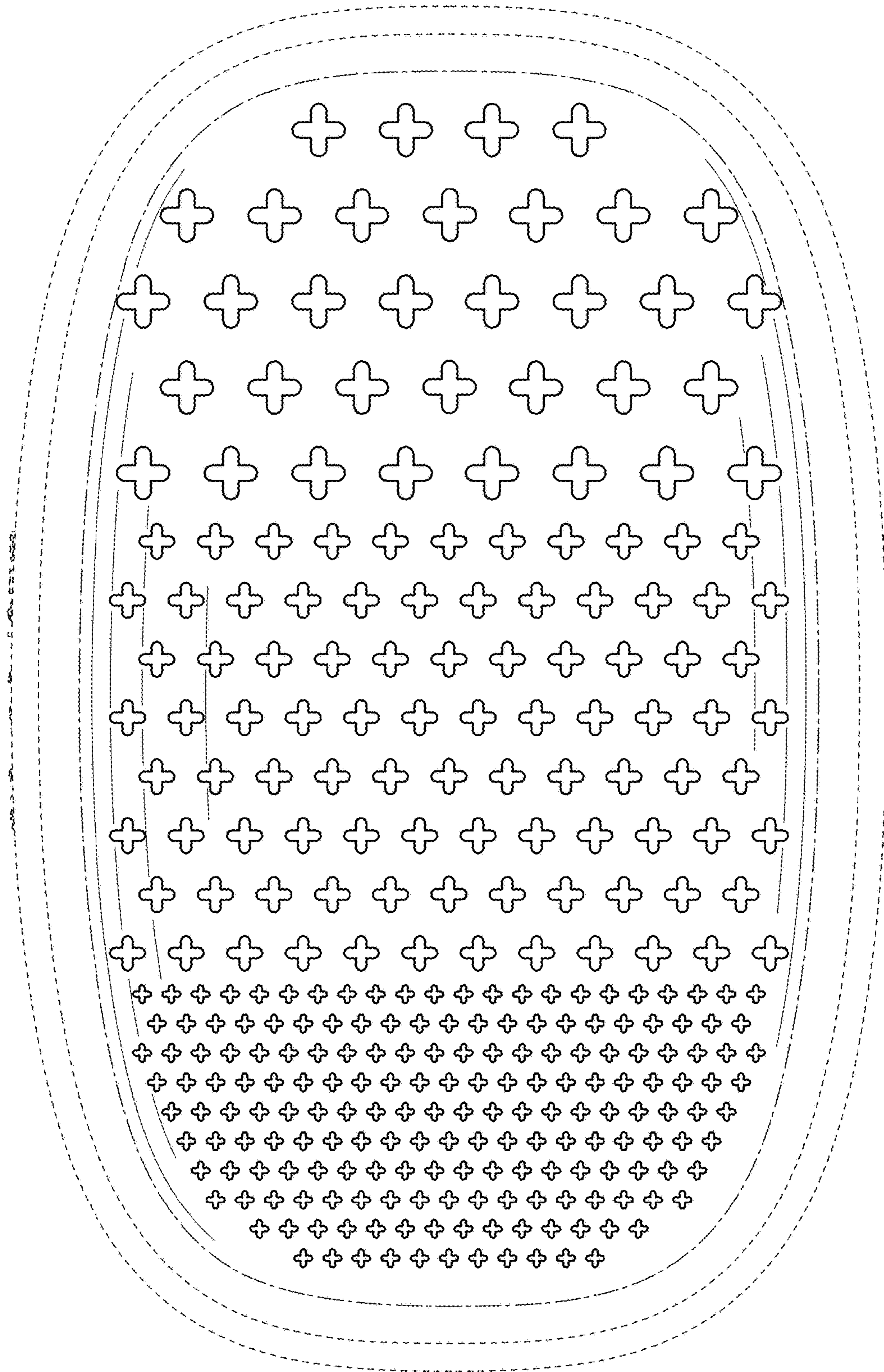

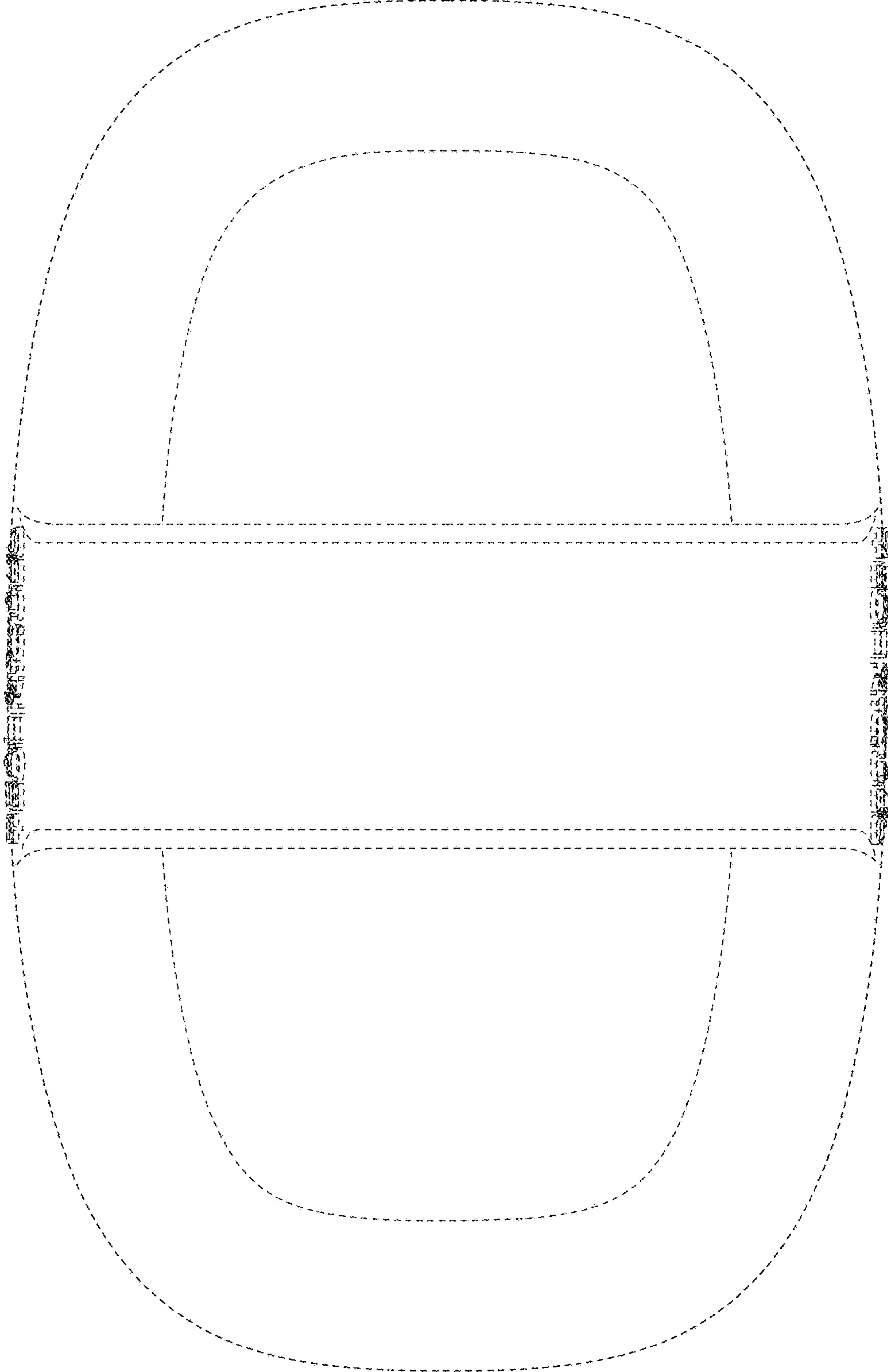

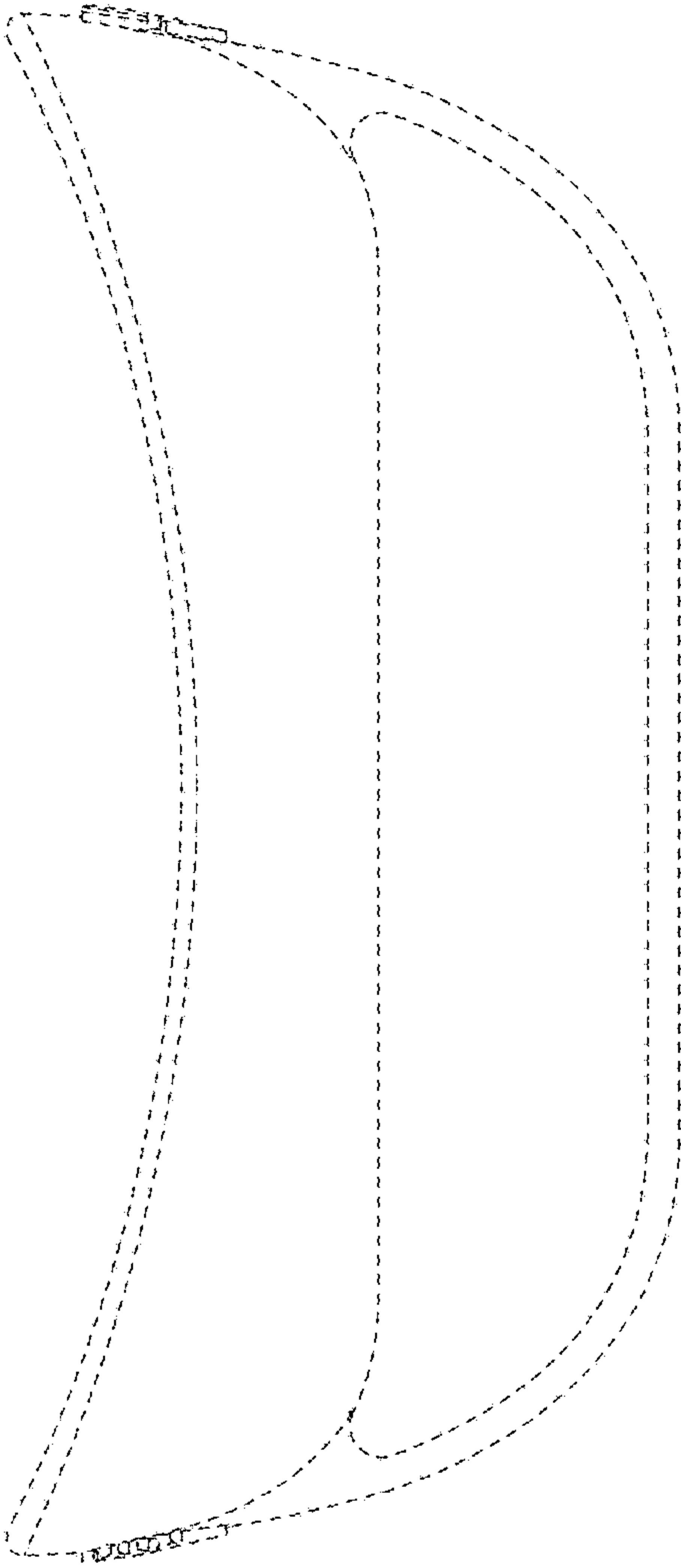

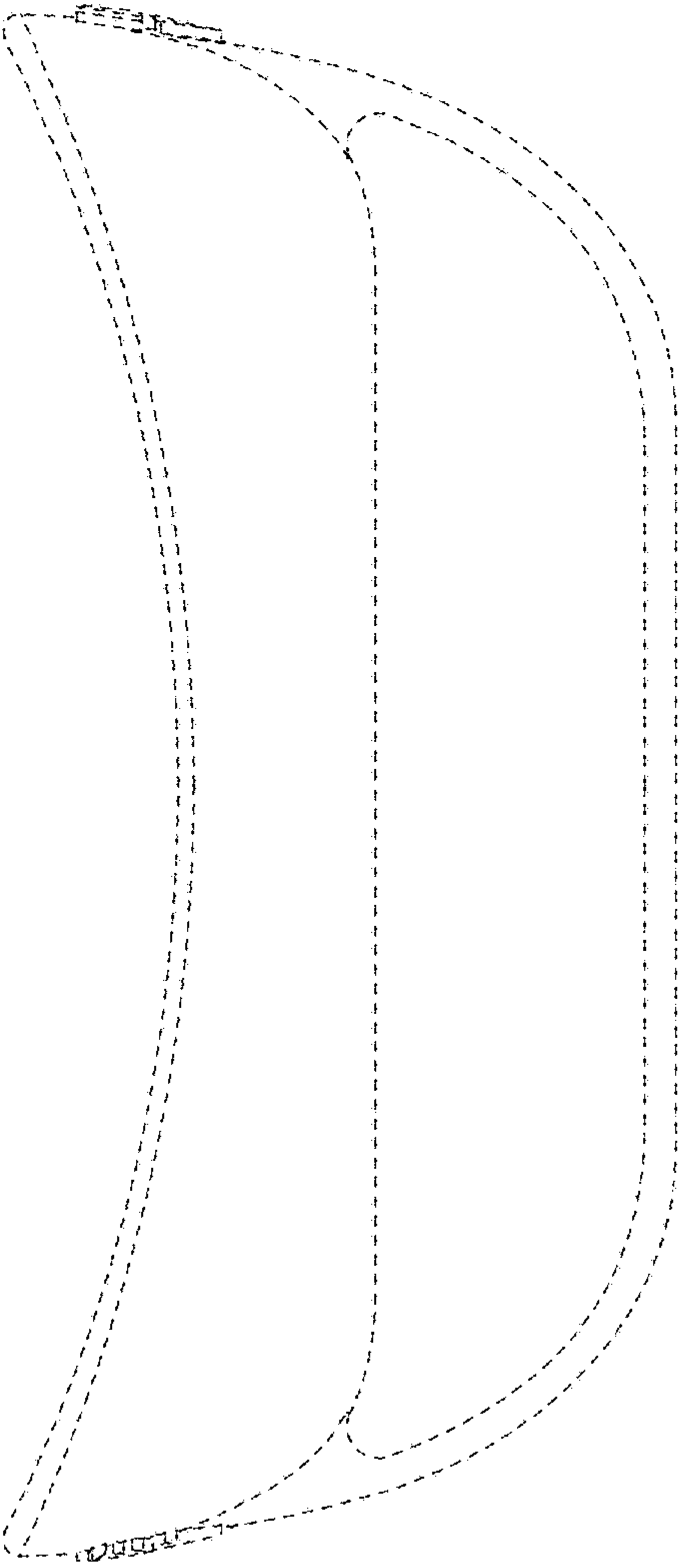

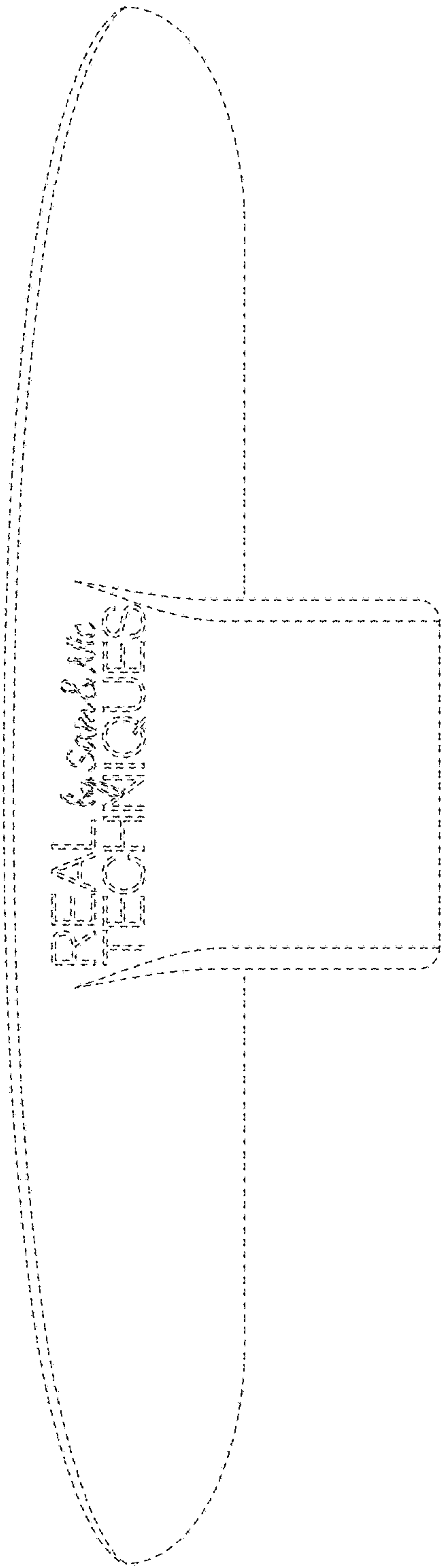

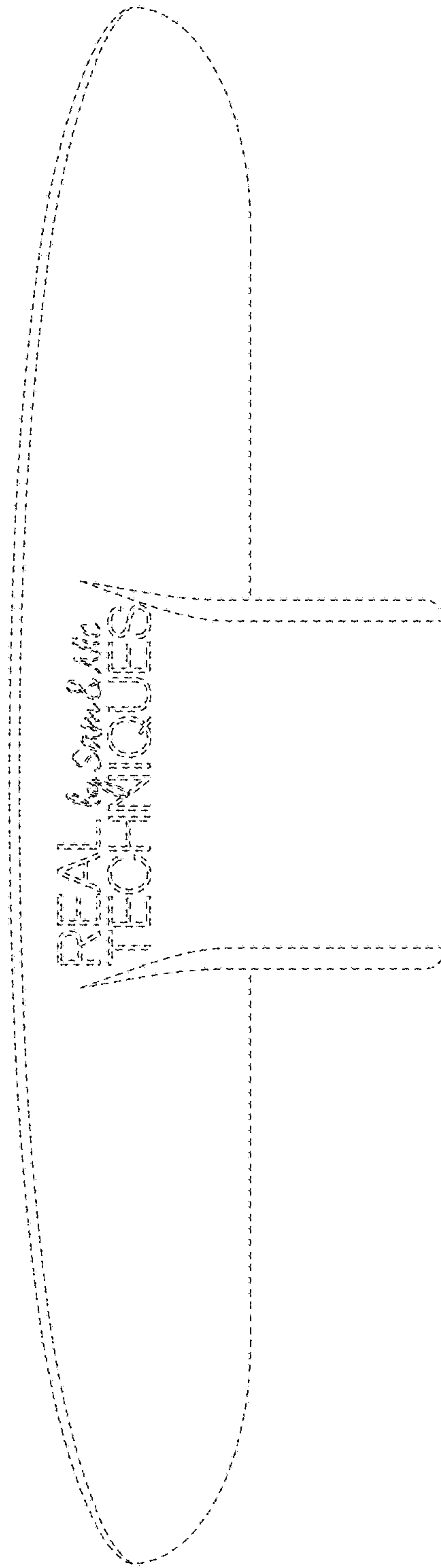
