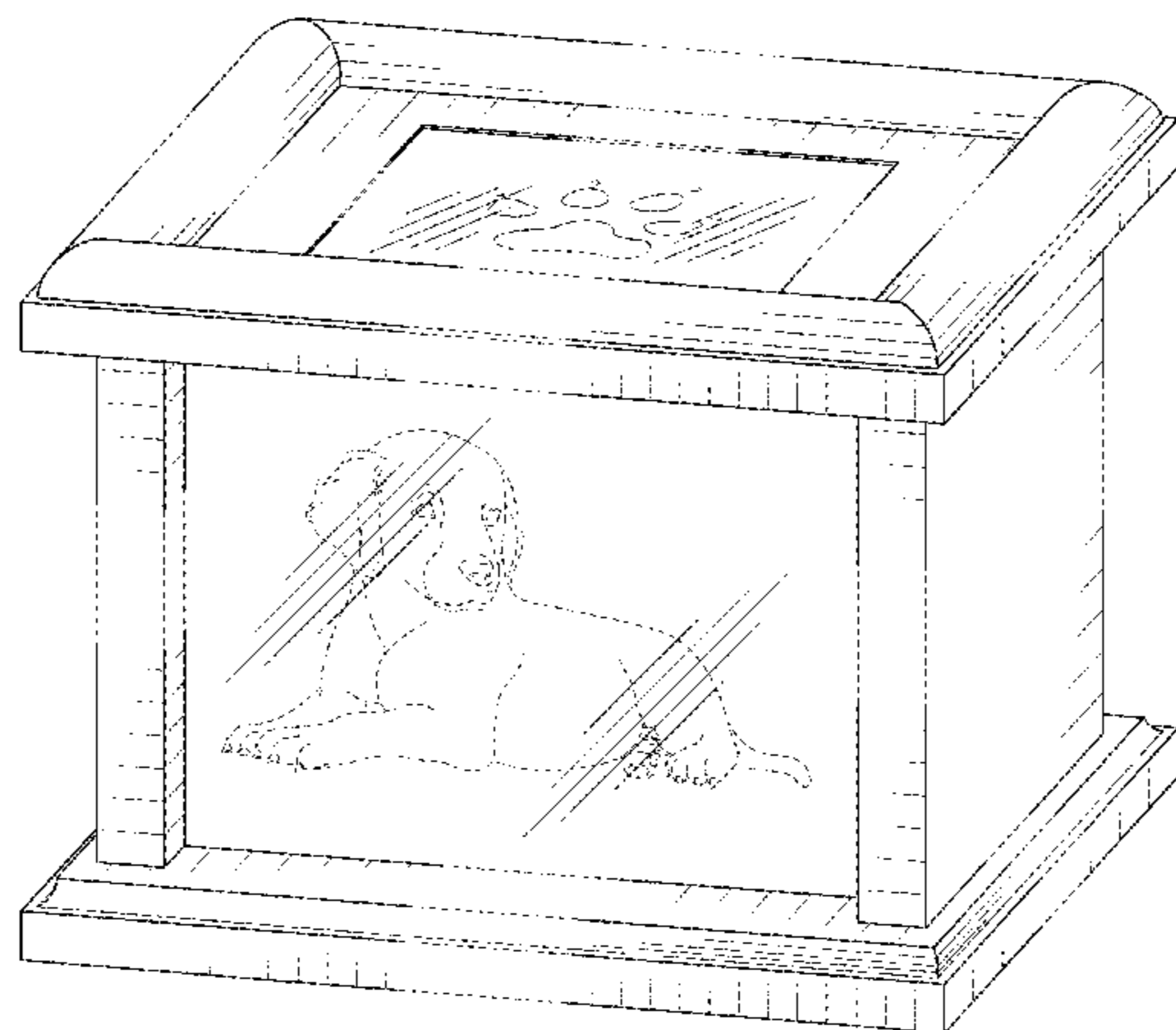

(57) **CLAIM**  
The ornamental design for a cremation urn, as shown and described.

**DESCRIPTION**  
FIG. 1 is a perspective view of a cremation urn depicting a first embodiment of a new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a side view thereof, the opposite side view being identical thereto;  
FIG. 4 is a top plan view thereof; and,  
FIG. 5 is a bottom plan view thereof.  
The broken lines immediately adjacent the shaded areas represent the bounds of the claimed design while all other broken lines are directed to environment and are for illustrative purposes only; the broken lines form no part of the claimed design.

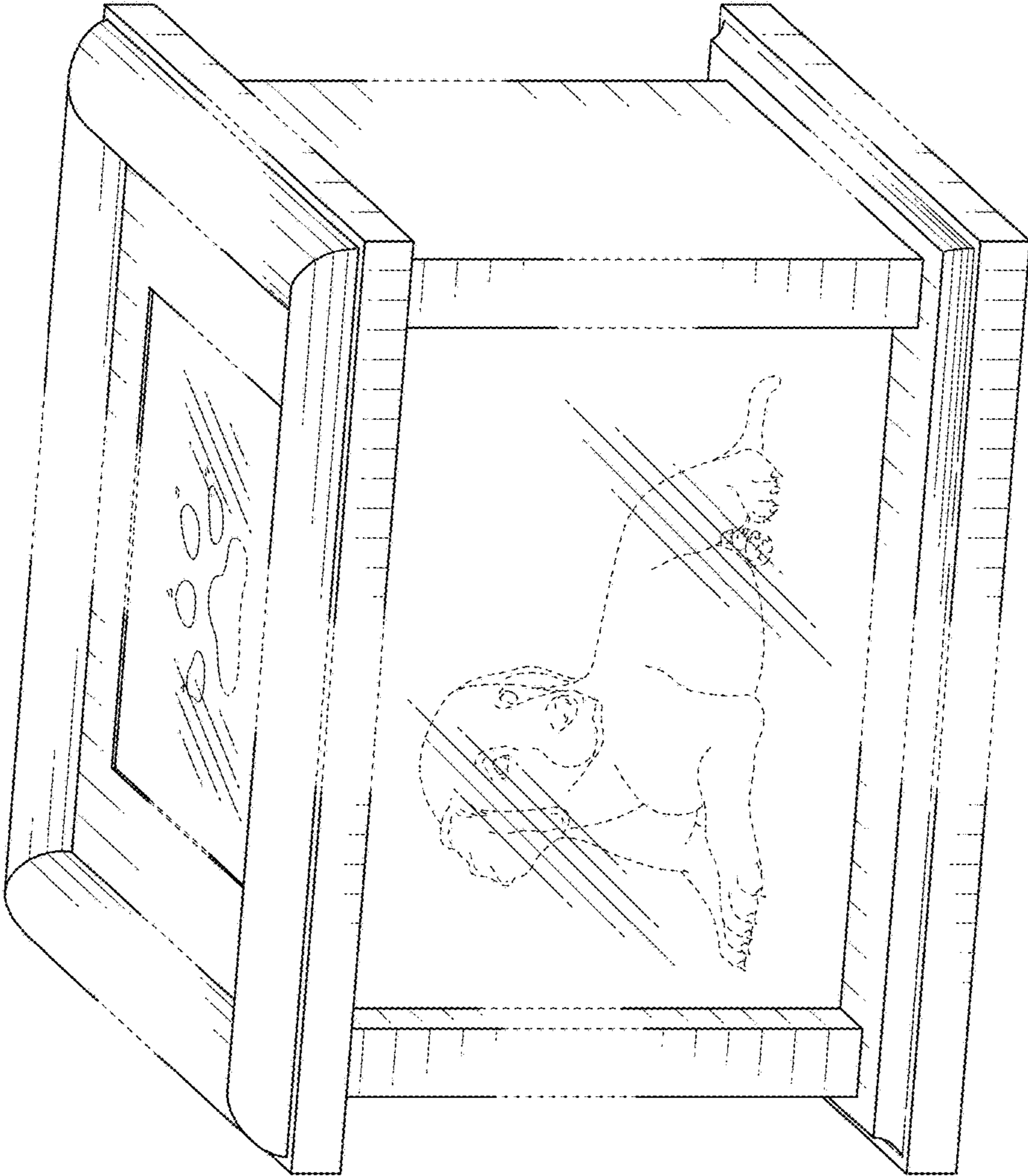

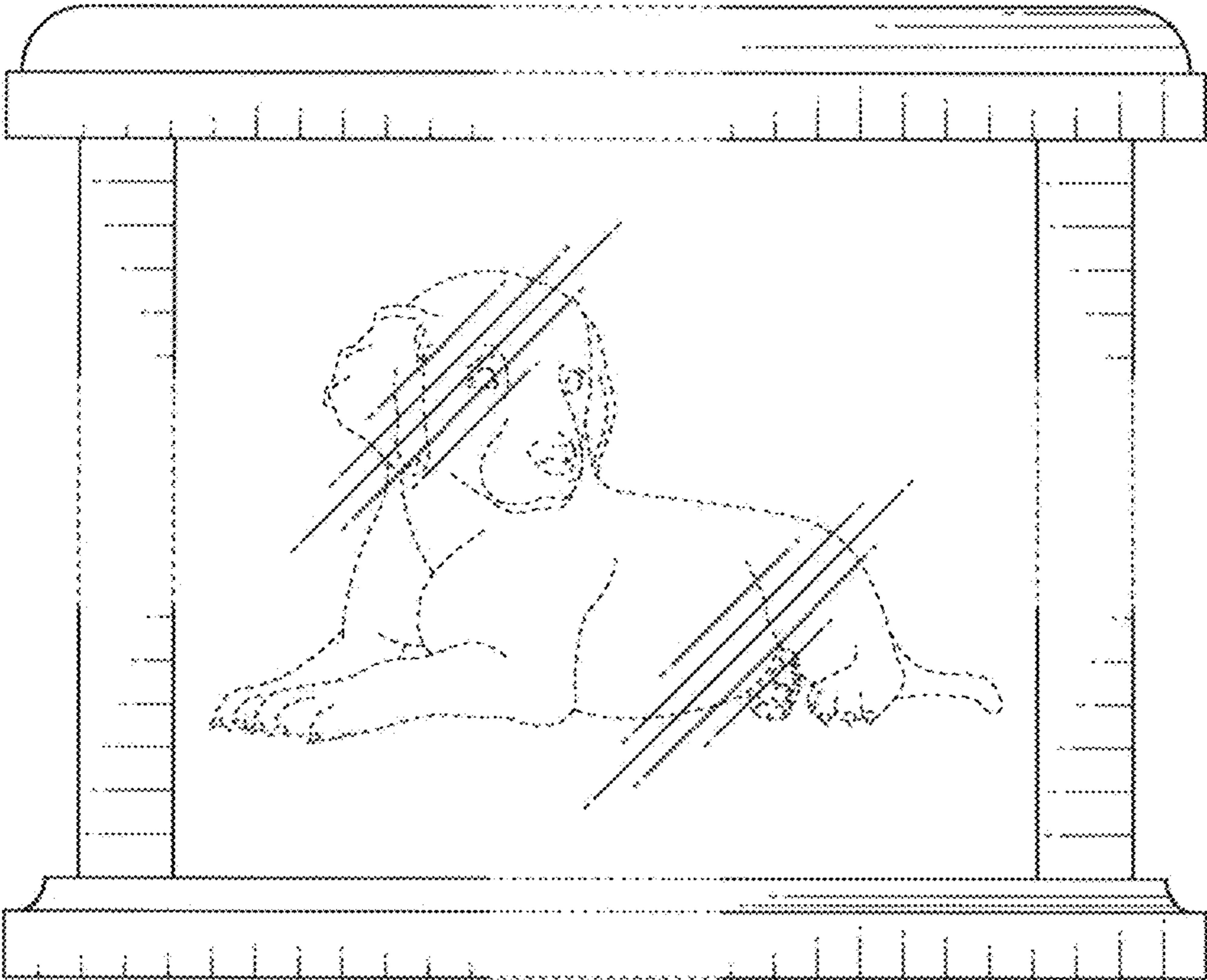

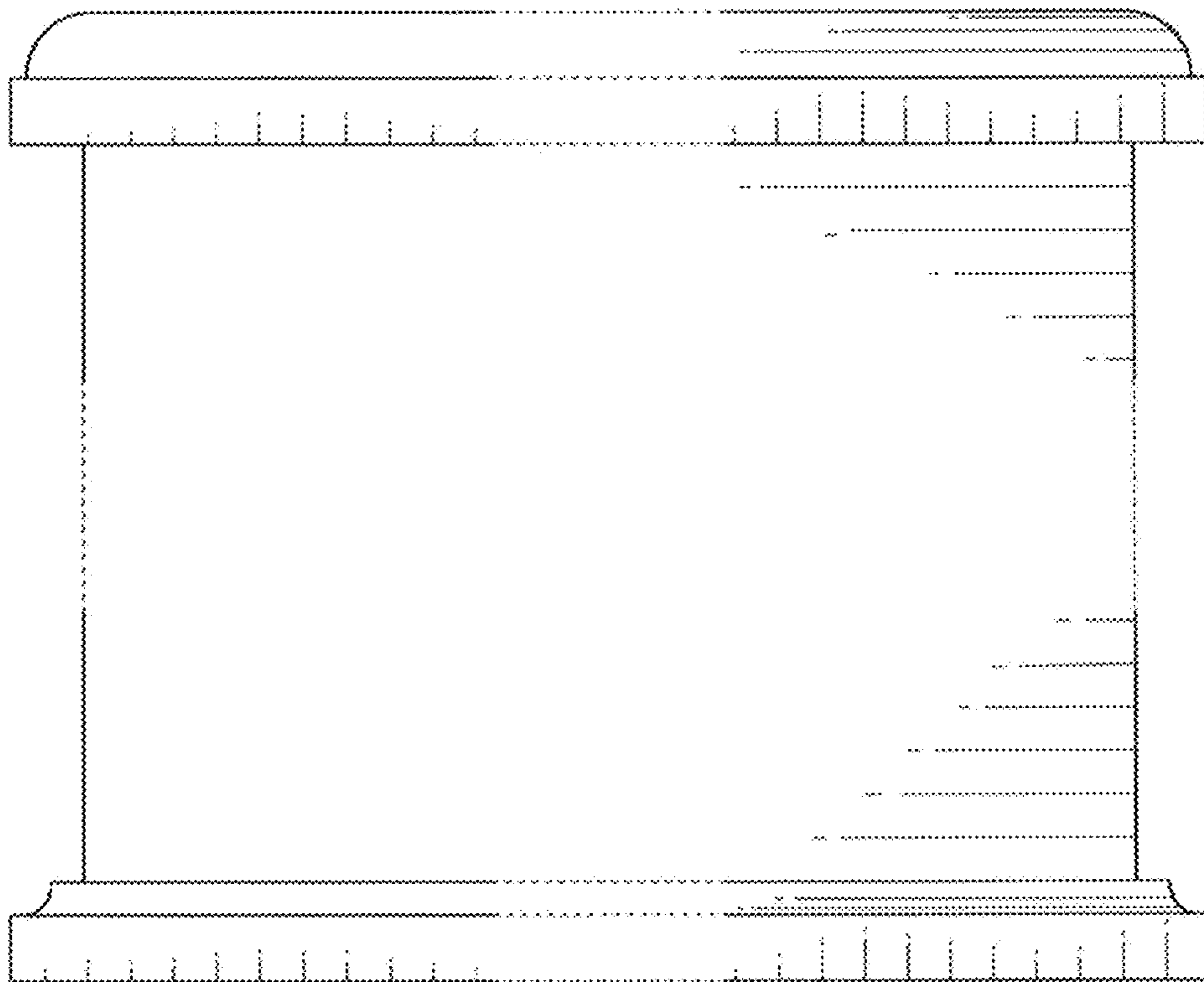

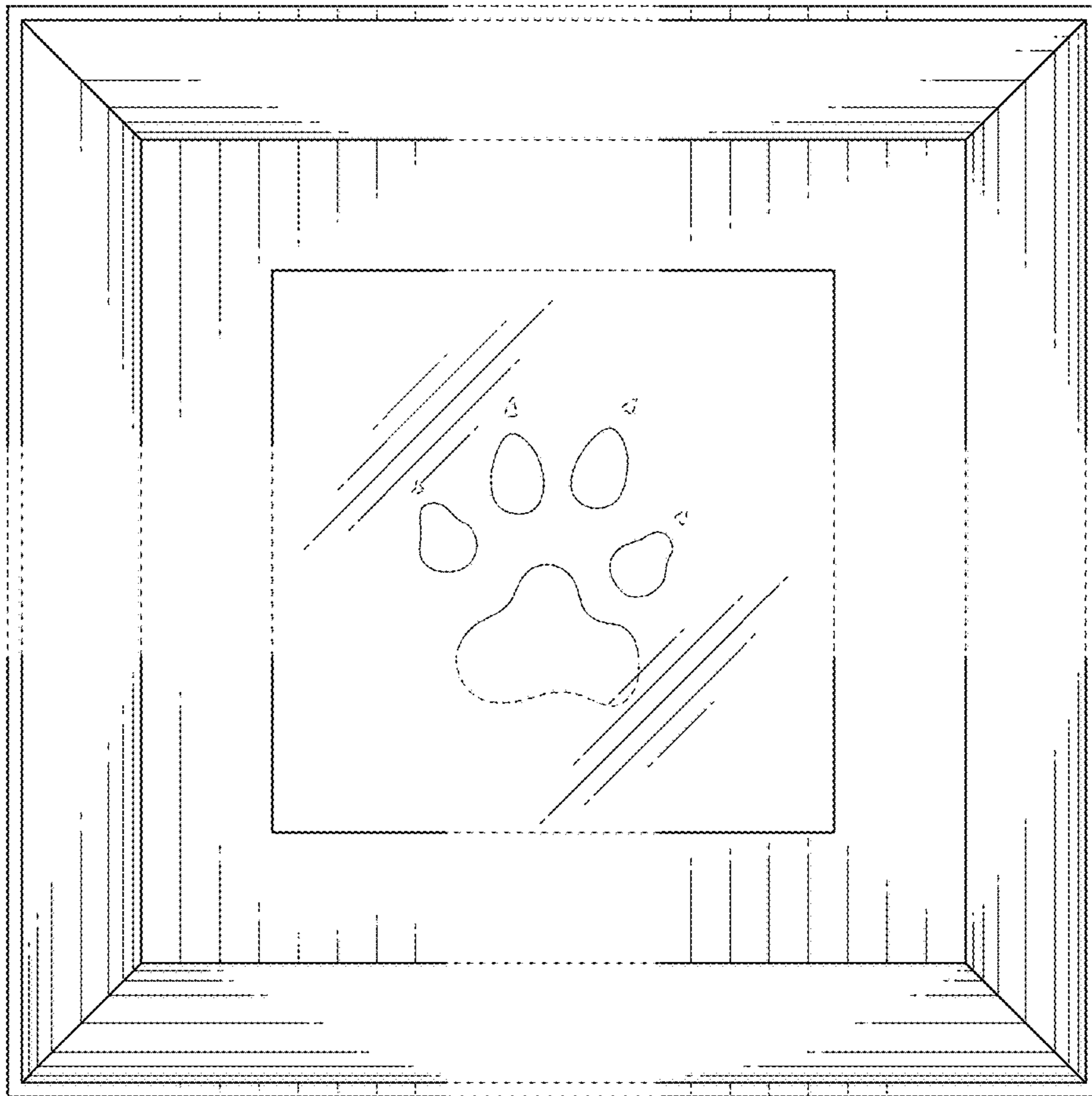

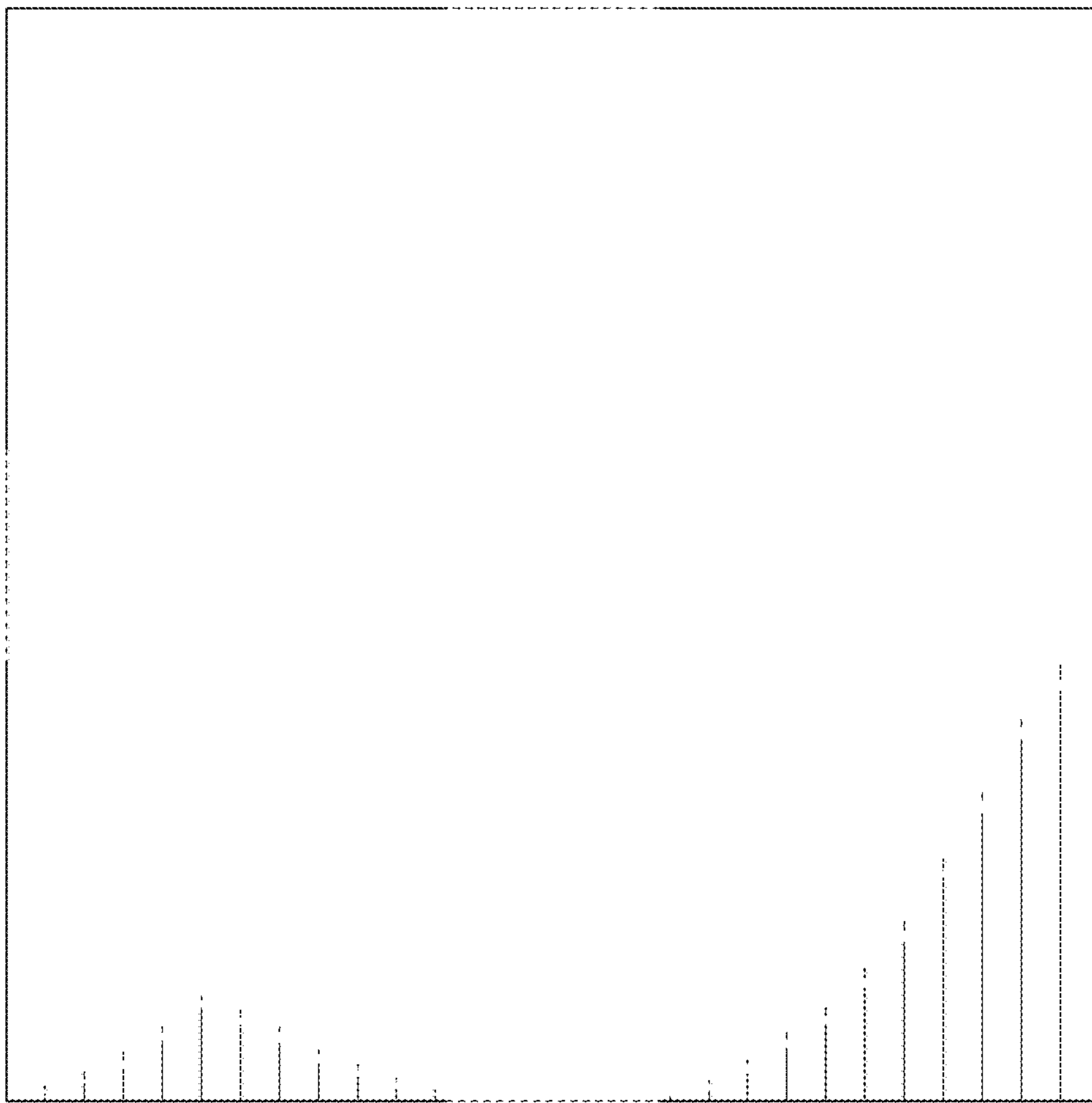
