The ornamental design for a pocketed swimsuit, as shown and described.

DESCRIPTION

FIG. 1 is a front, left perspective view of the first embodiment of the pocketed swimsuit showing my new design; FIG. 2 is a front, right perspective view of the pocketed swimsuit;

FIG. 3 is a front view thereof;

FIG. 4 is a rear view thereof;

FIG. 5 is a sectional view according to the section specified in FIG. 3;

FIG. 6 is a top view thereof;

FIG. 7 is a bottom view thereof;

FIG. 8 is an exploded view of the pocket shown in FIG. 1; FIG. 9 is a front, left perspective view of the second embodiment of the pocketed swimsuit;

FIG. 12 is a rear view thereof;

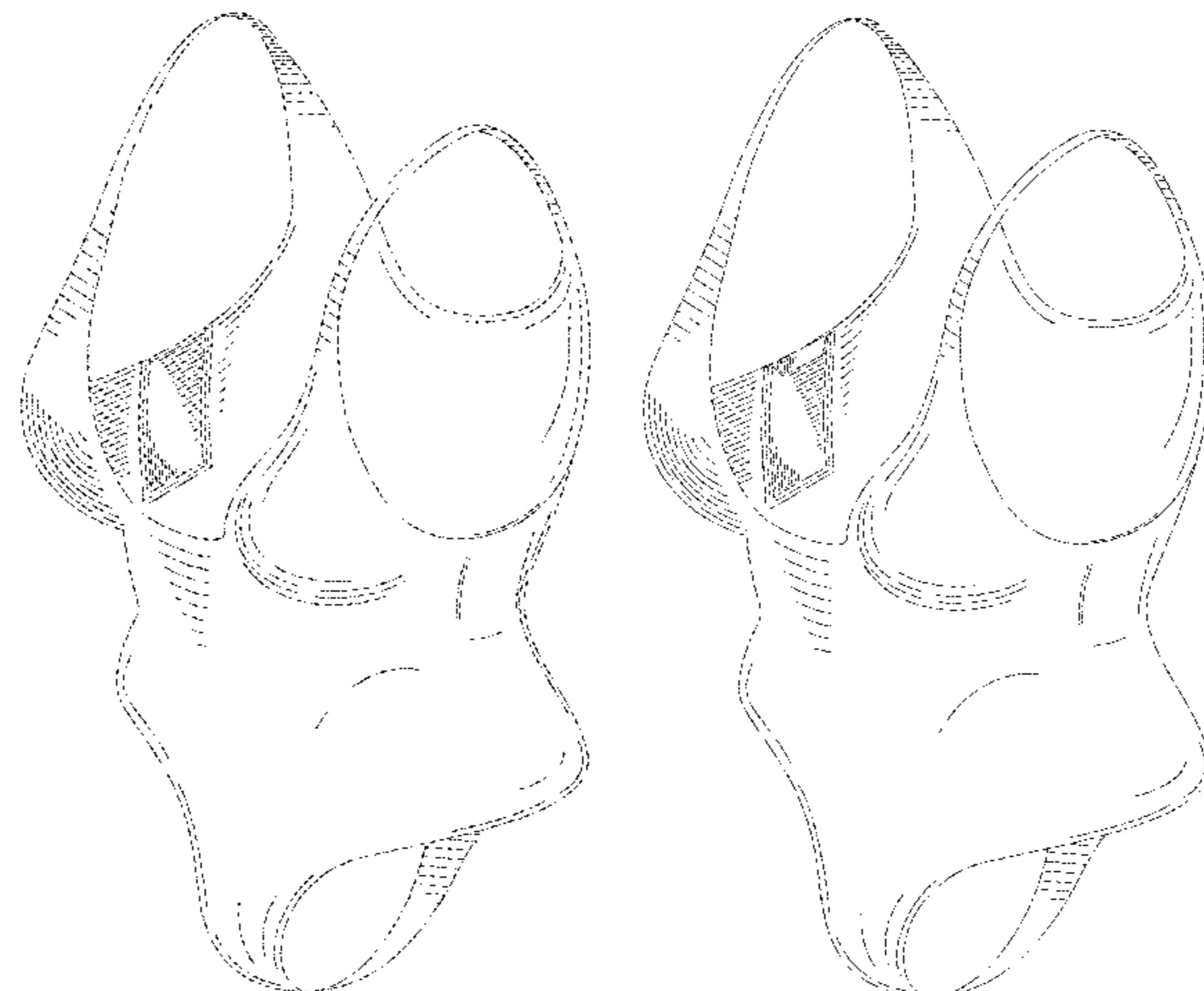
FIG. 13 is a sectional view according to the section specified in FIG. 11;

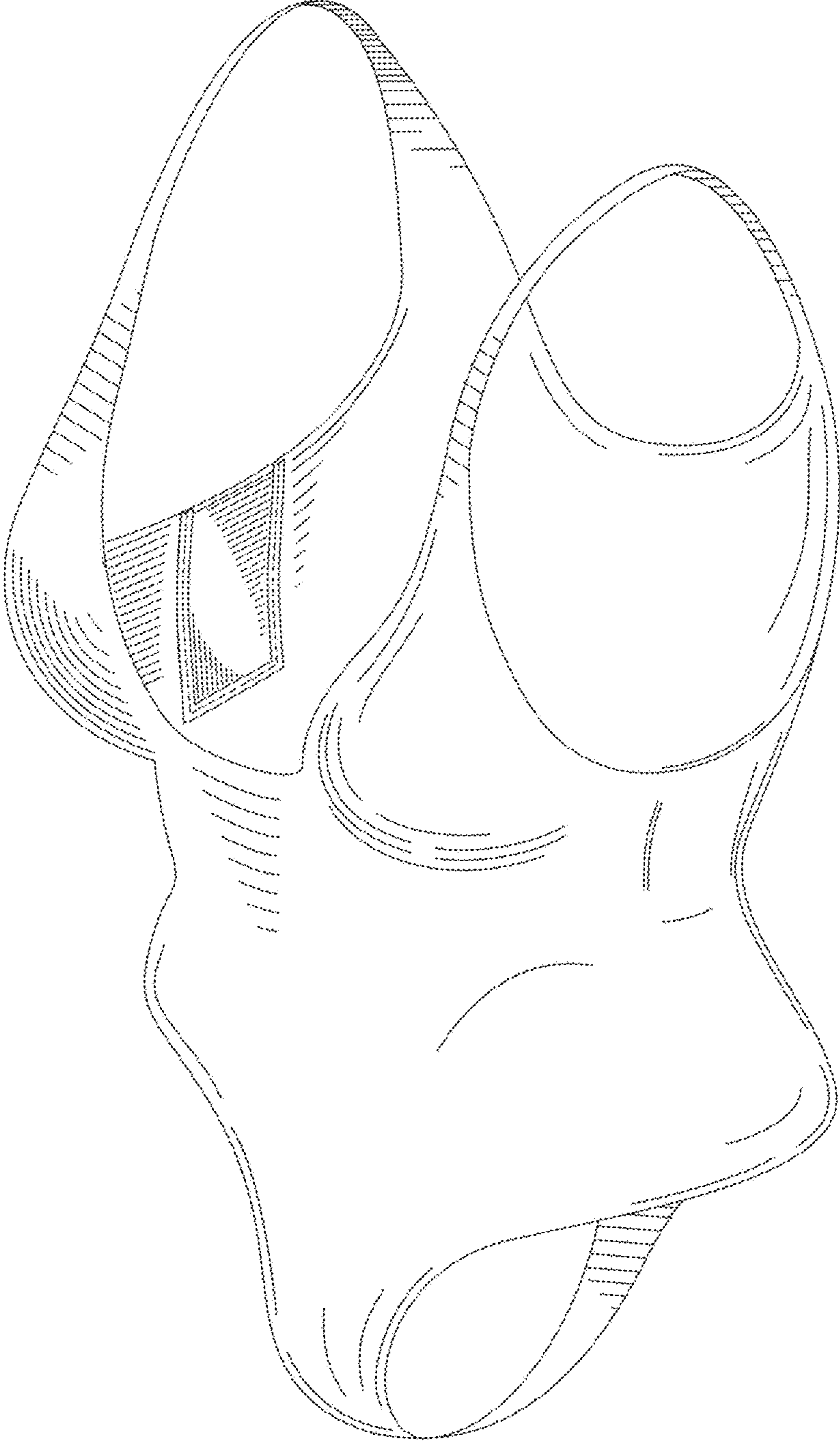

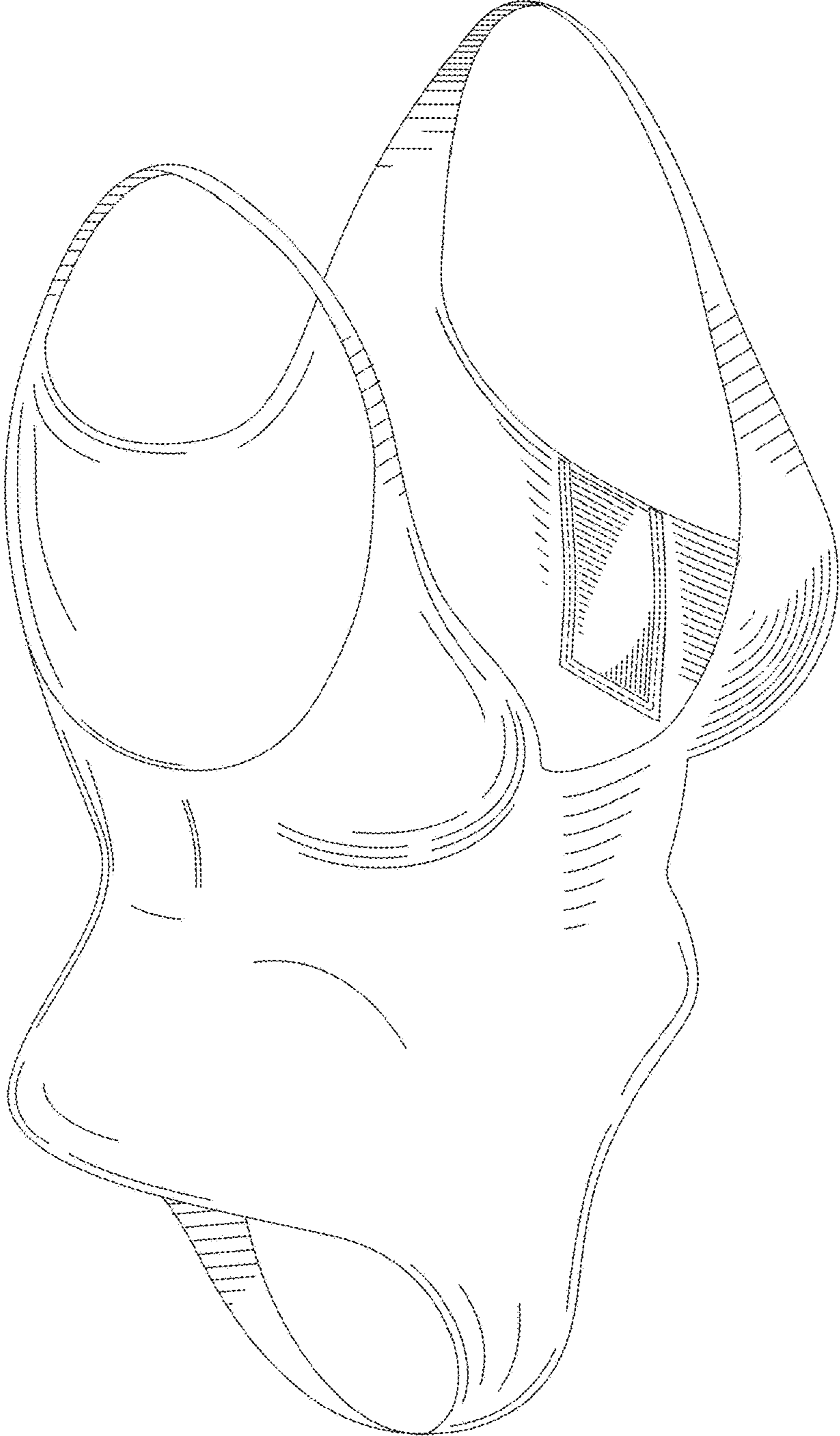

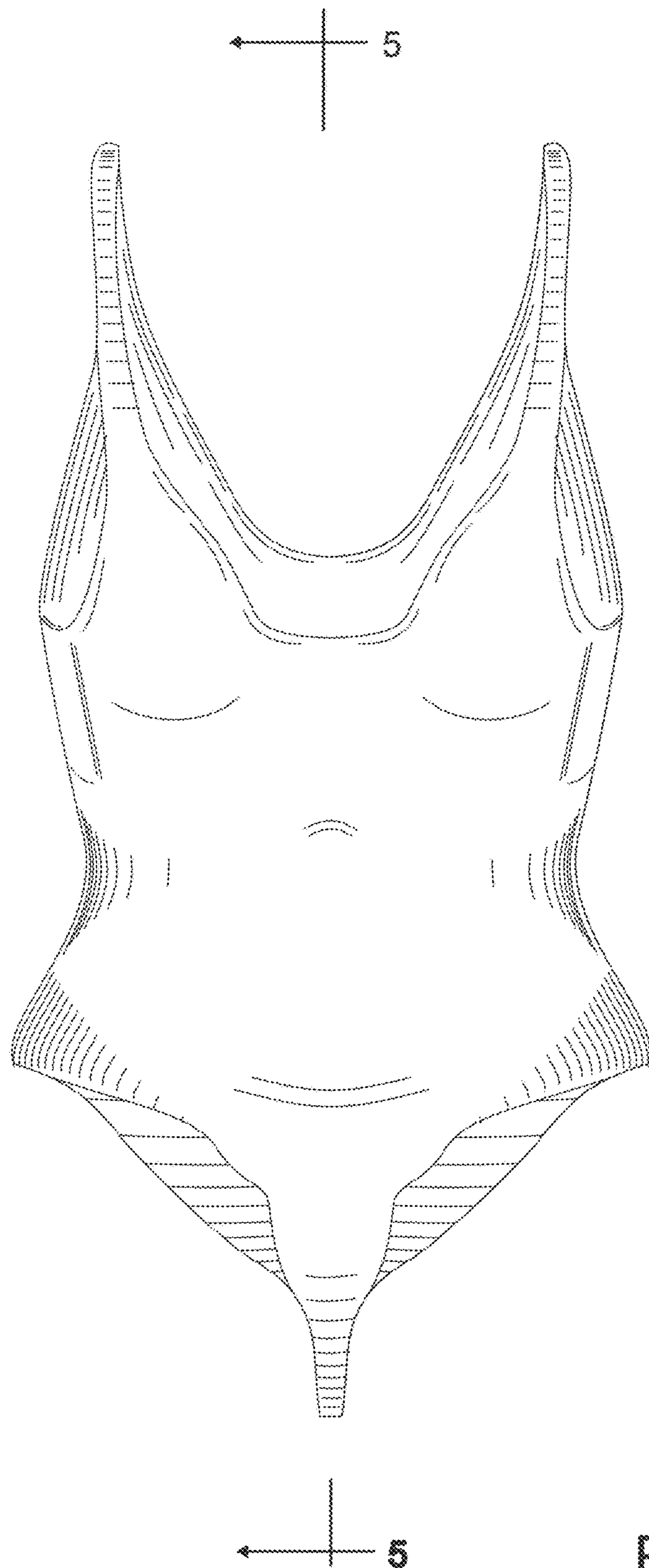

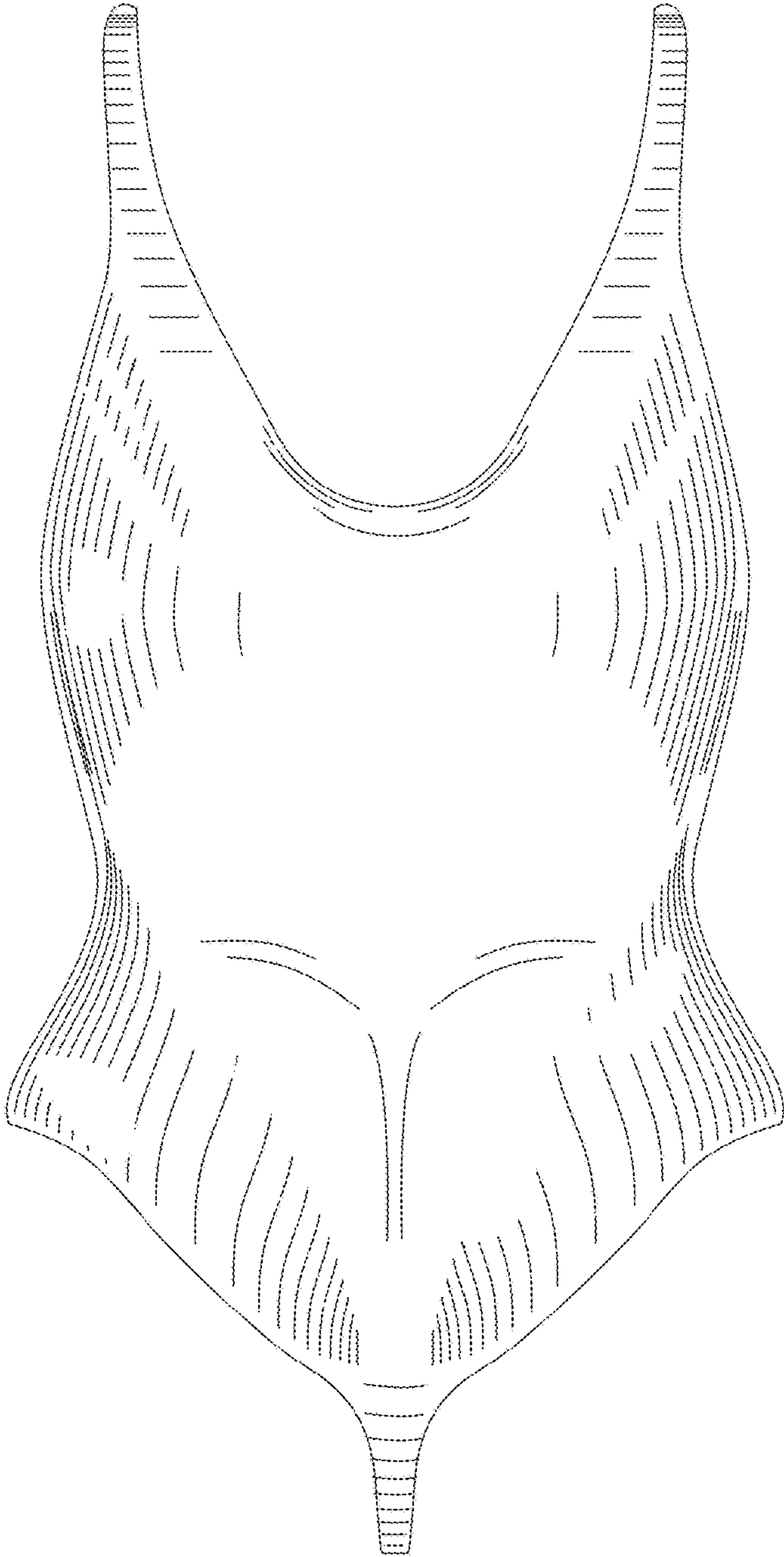

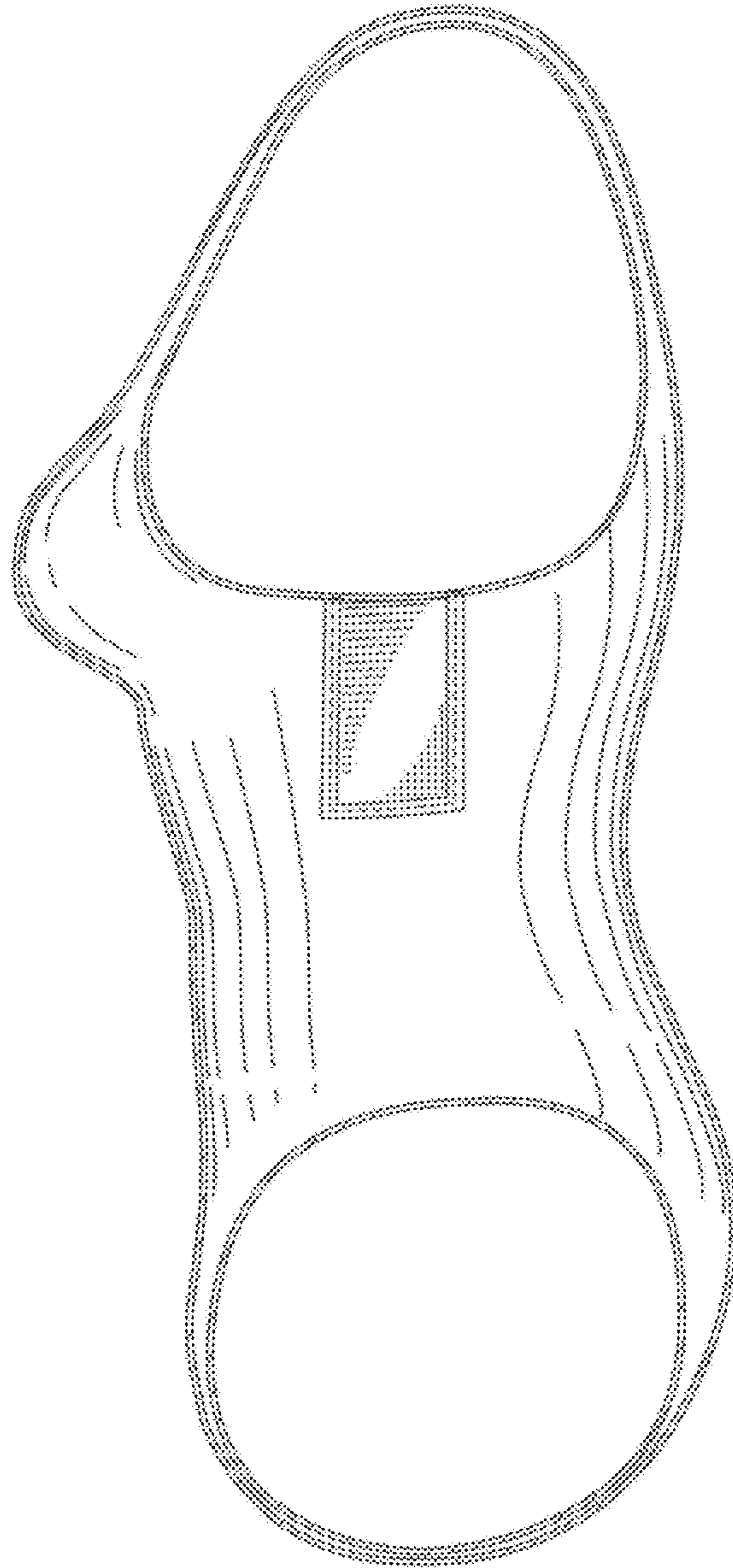

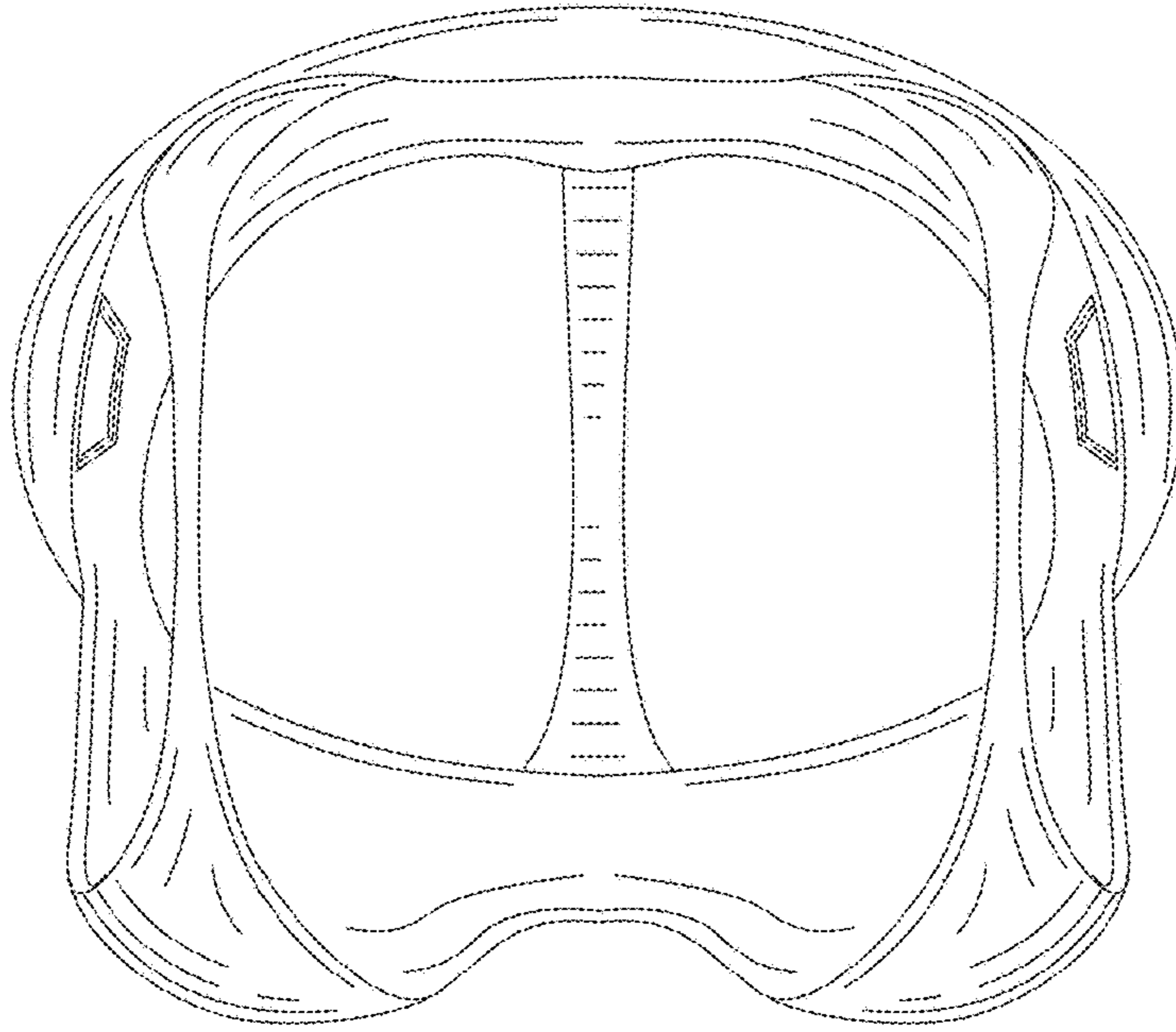

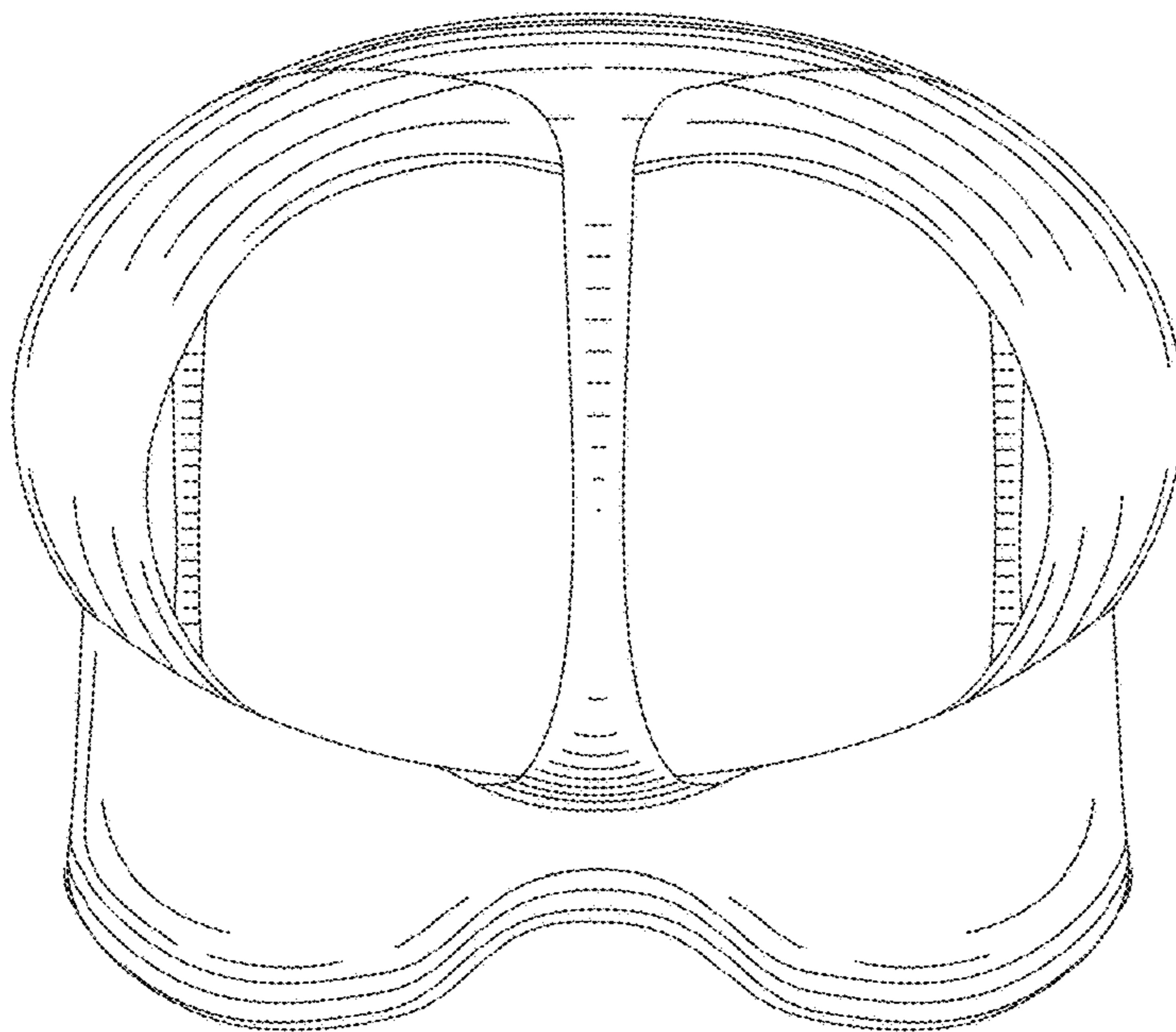

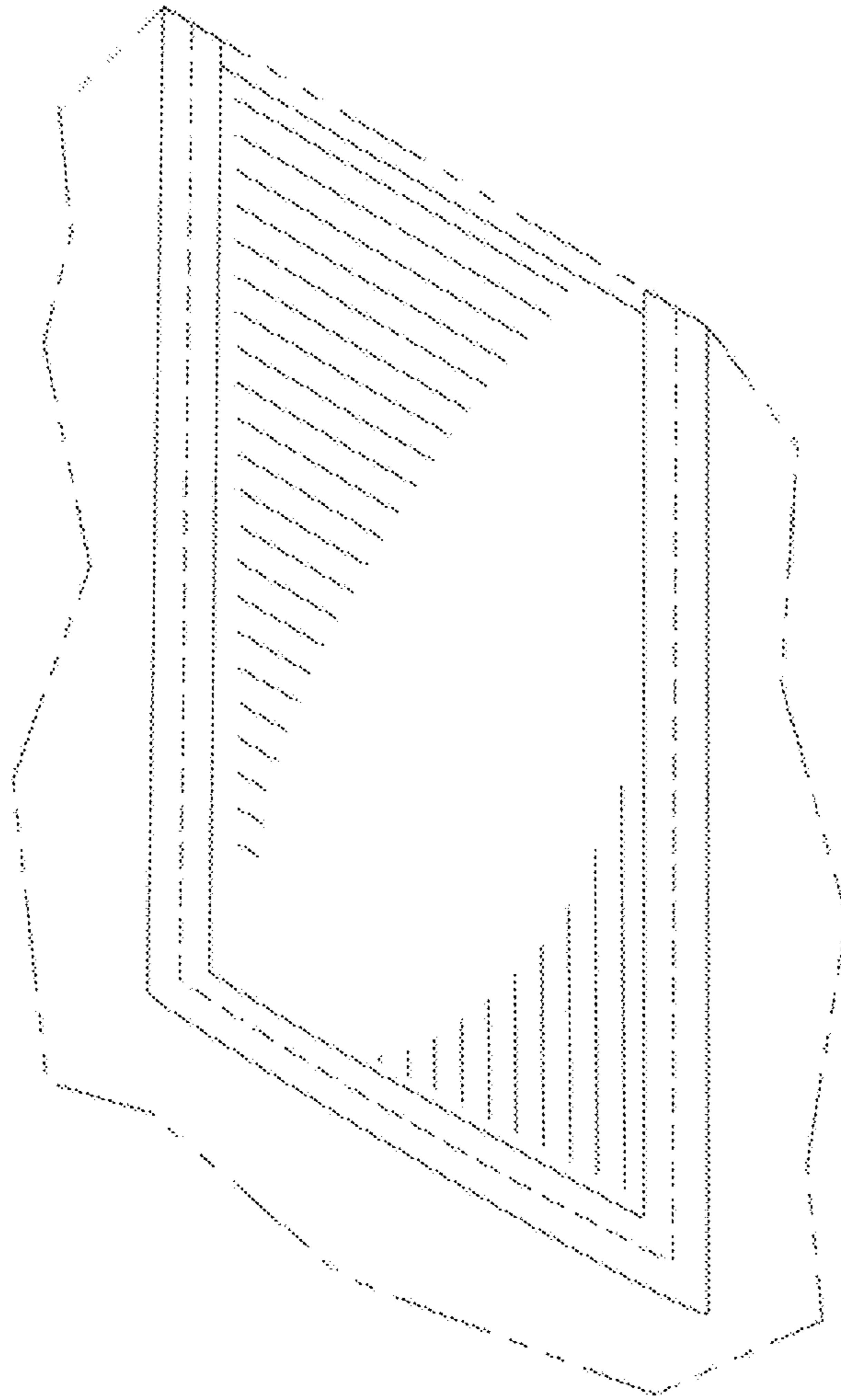

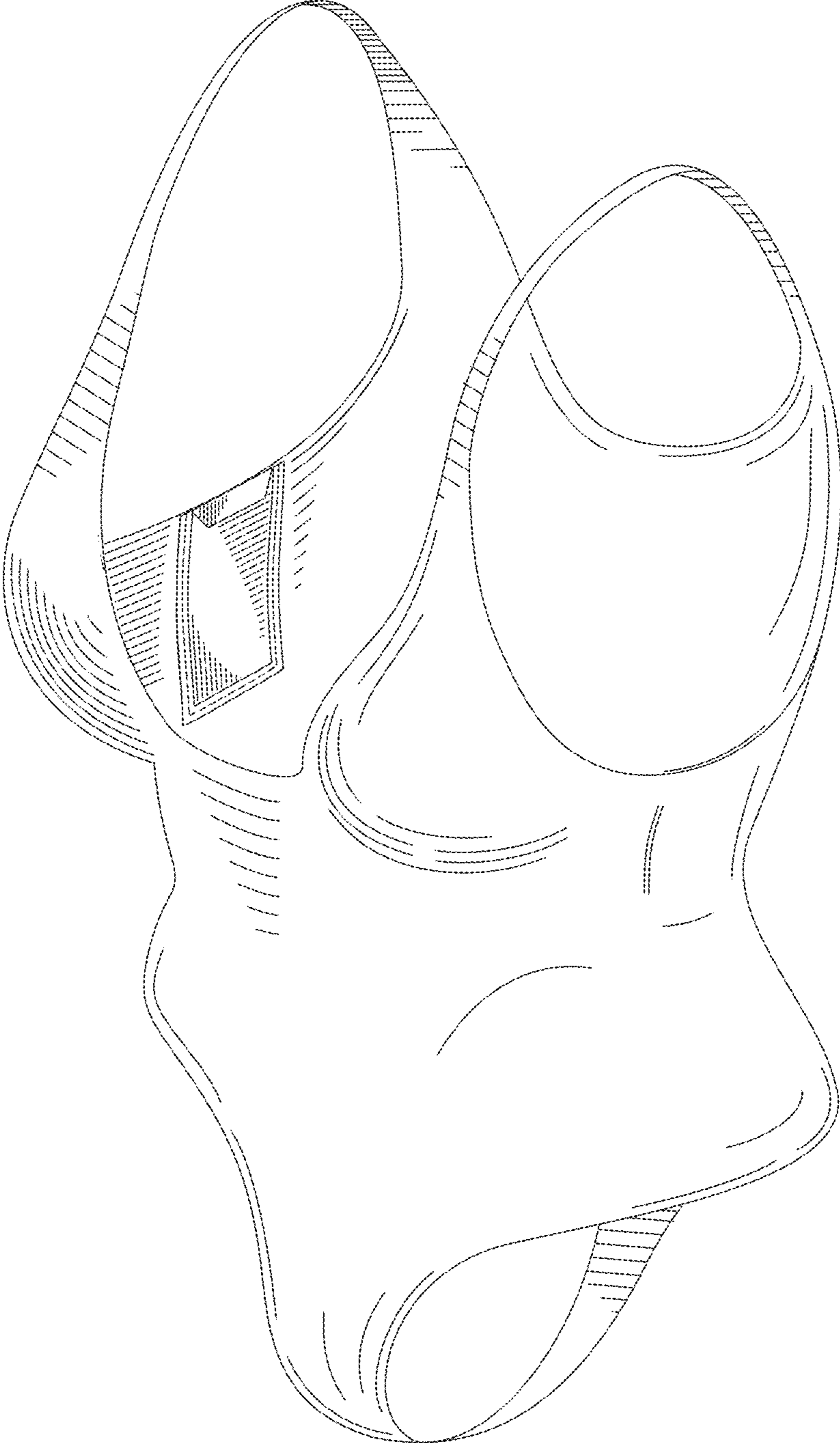

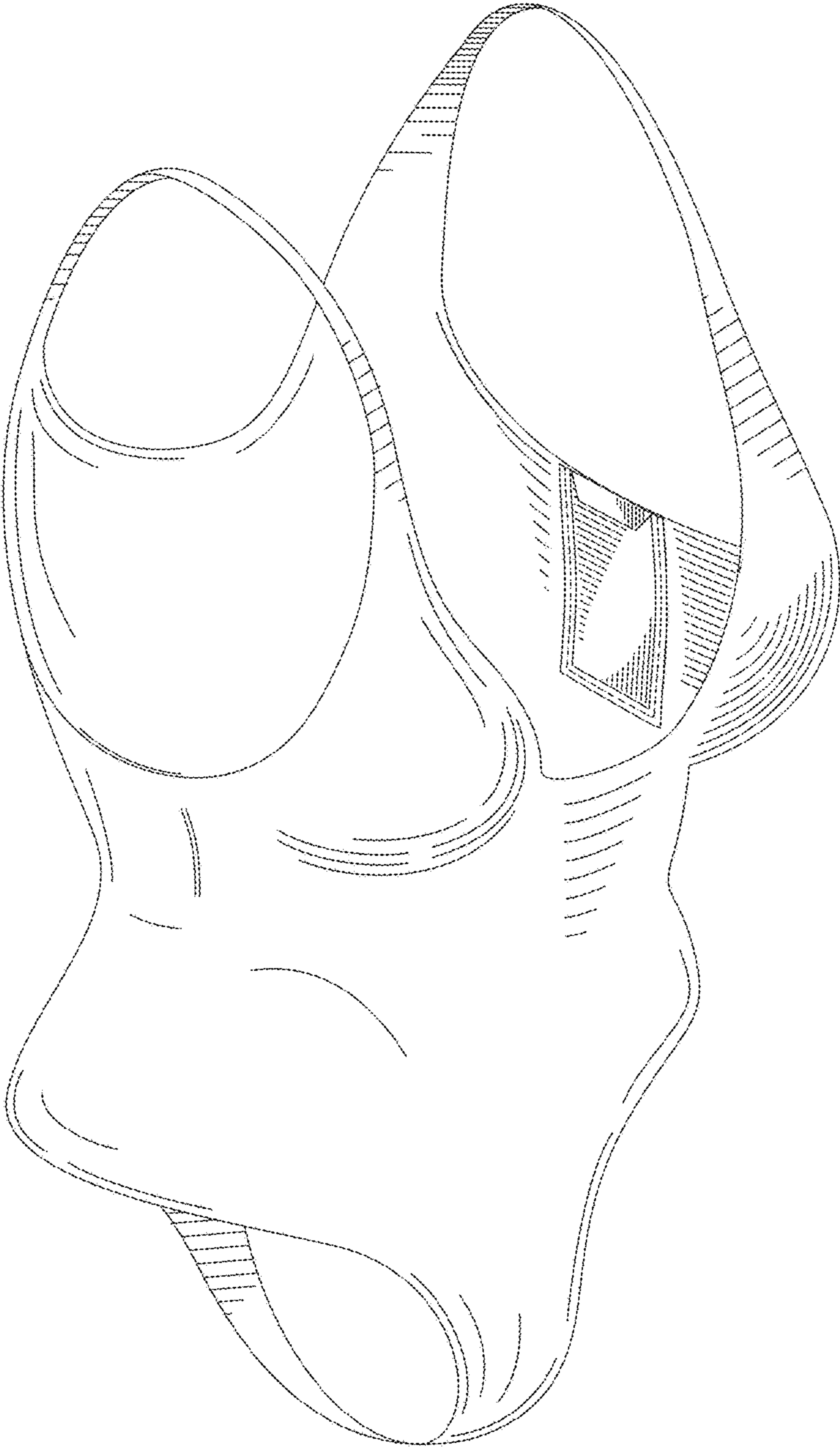

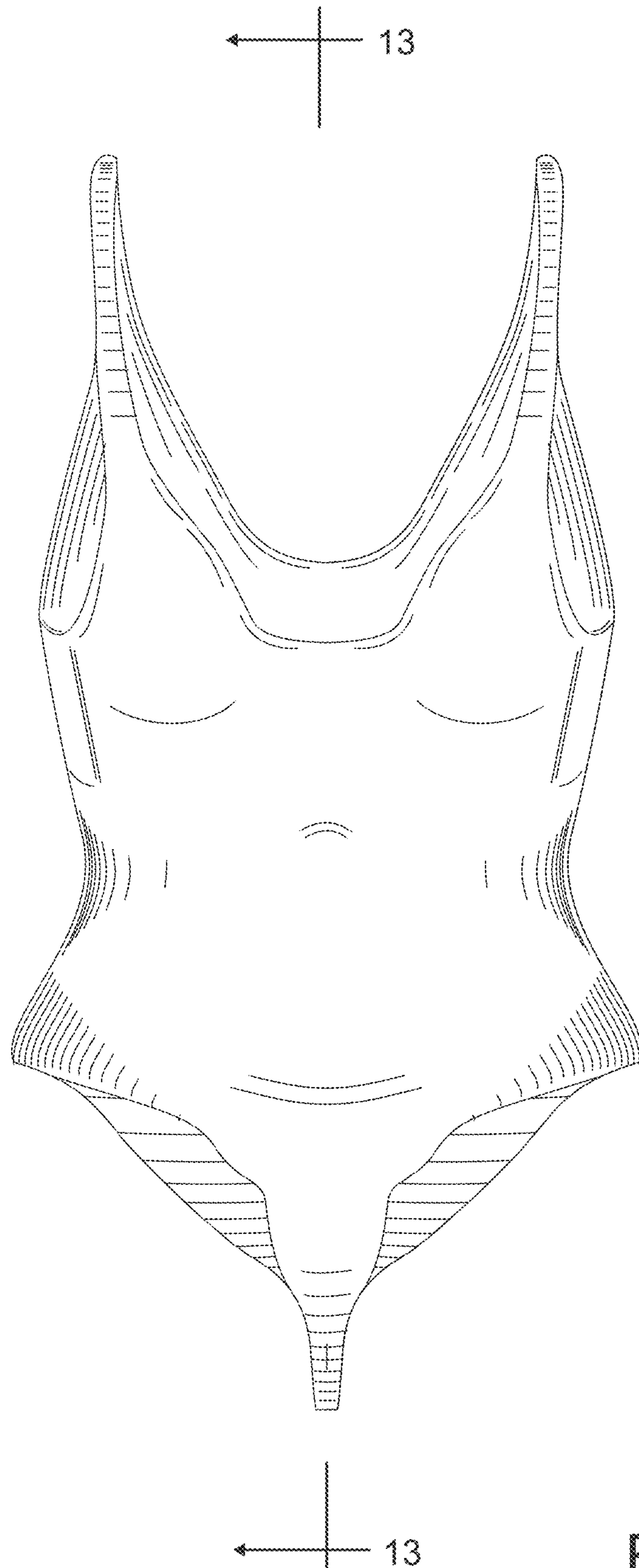

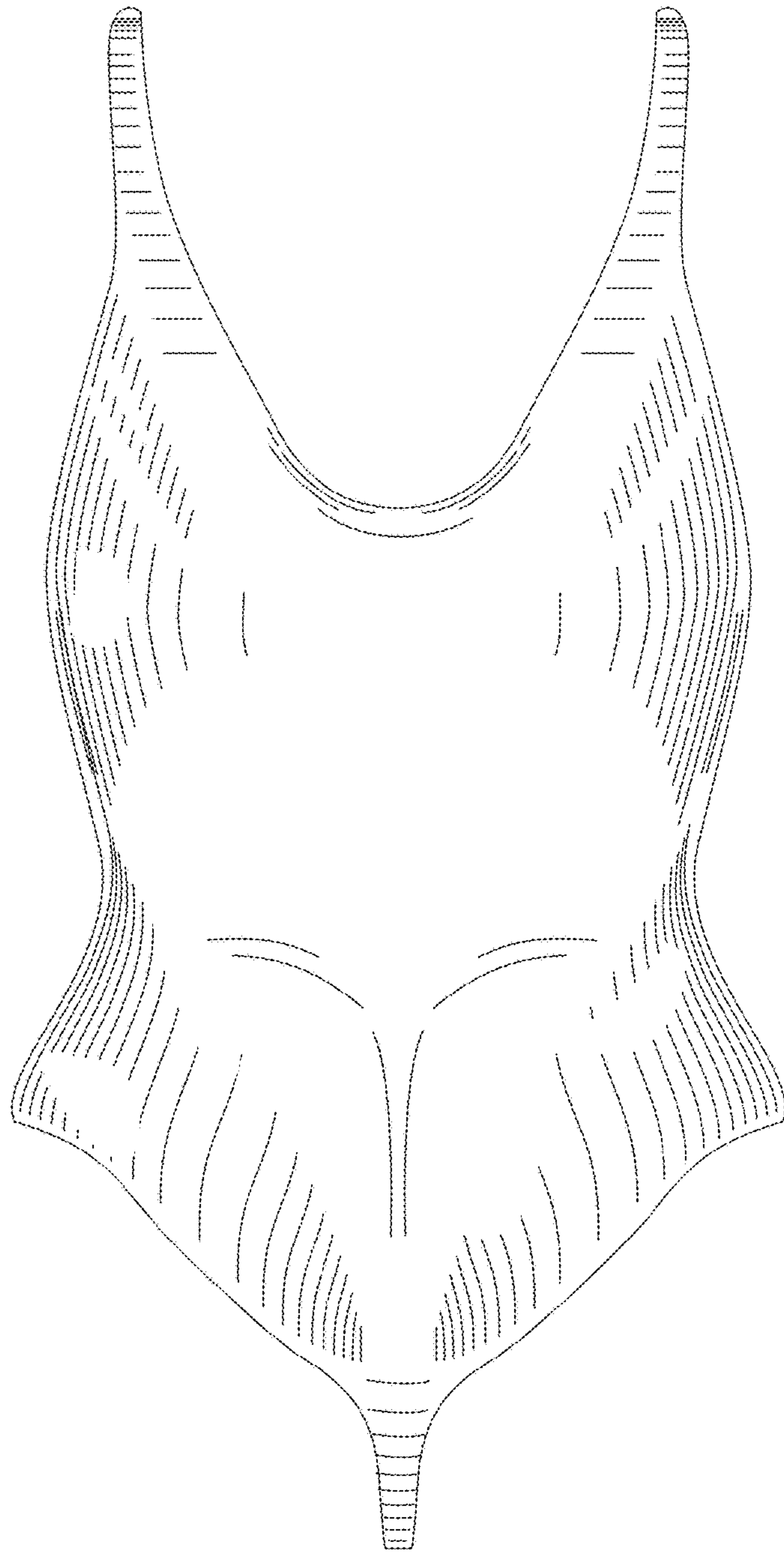

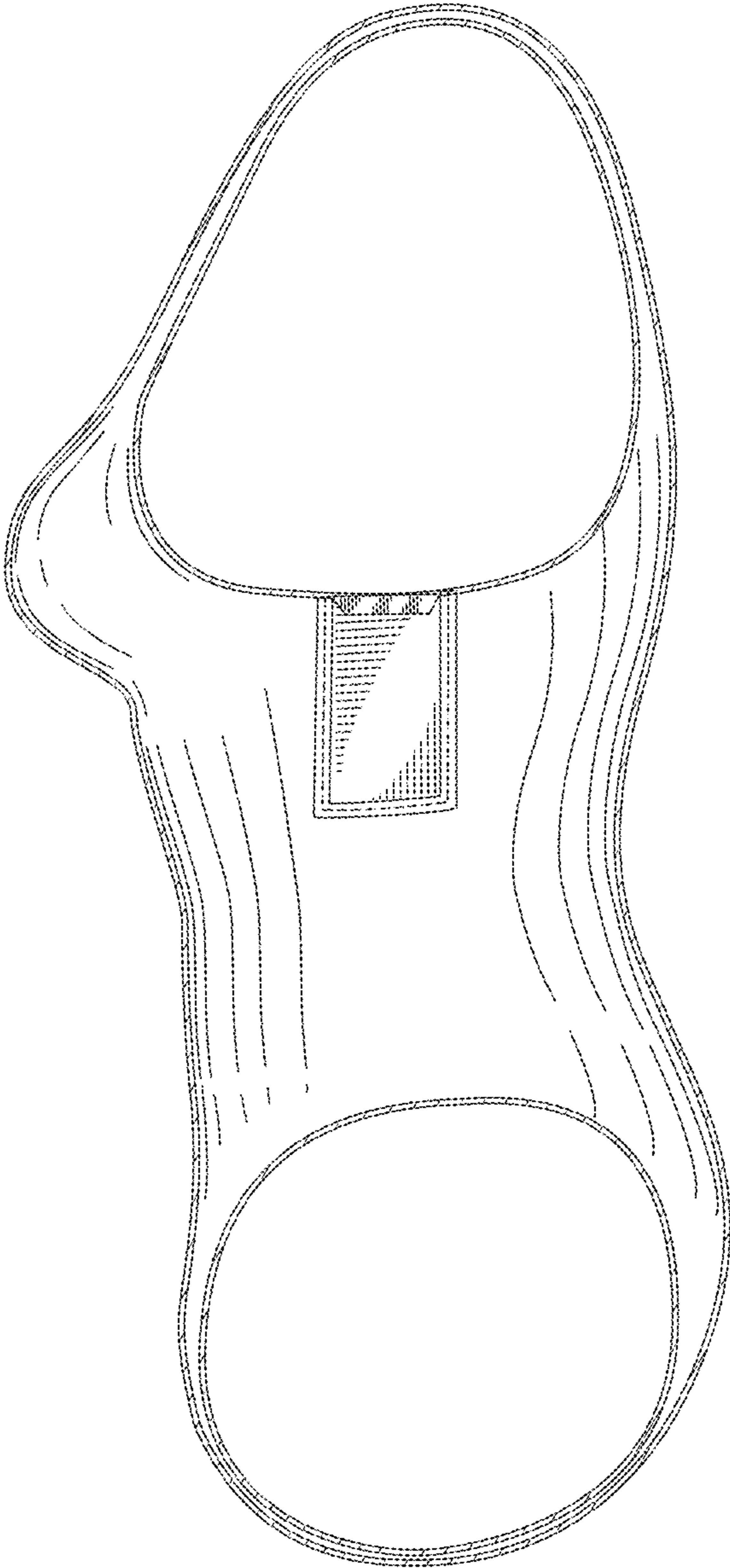

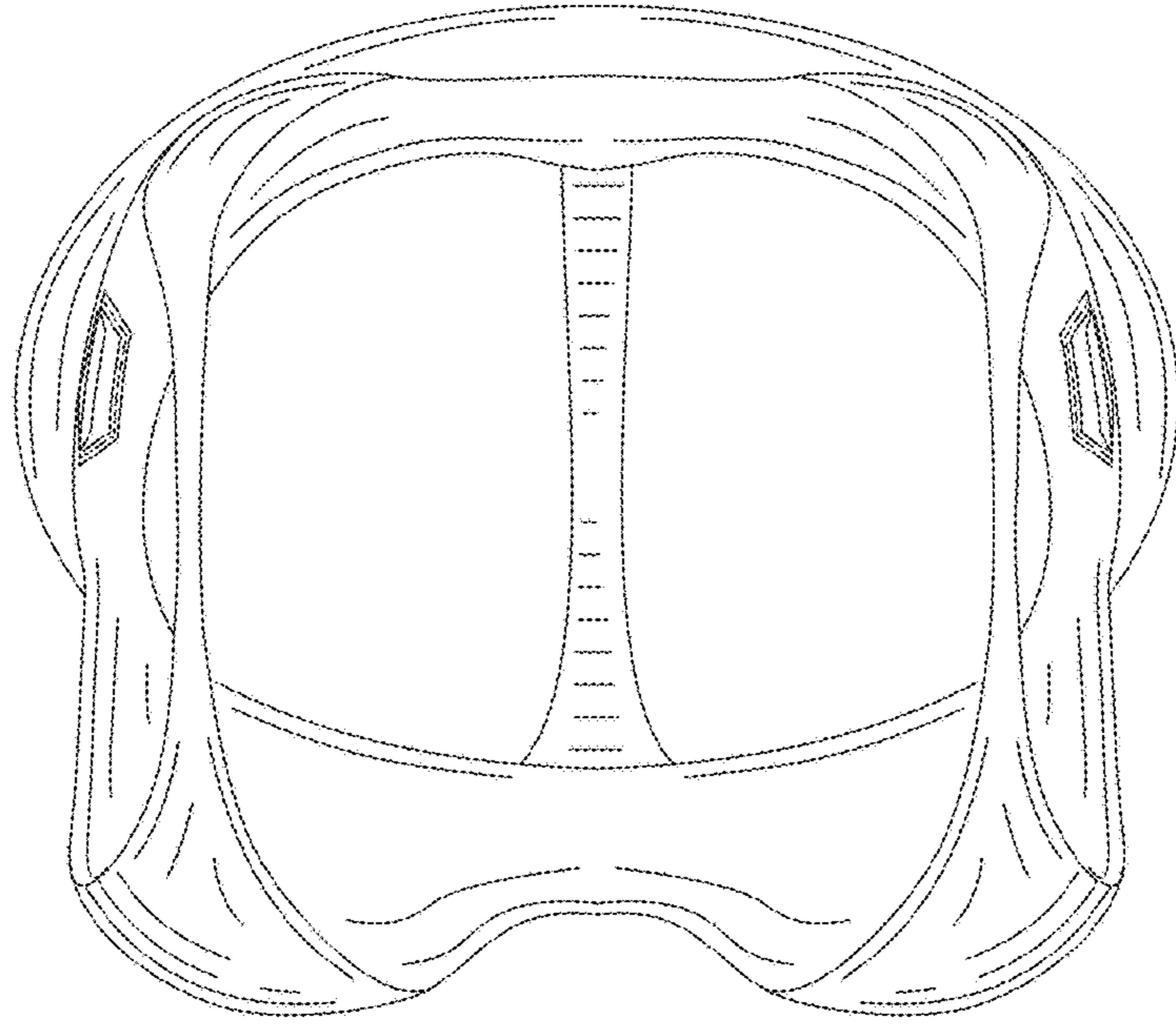

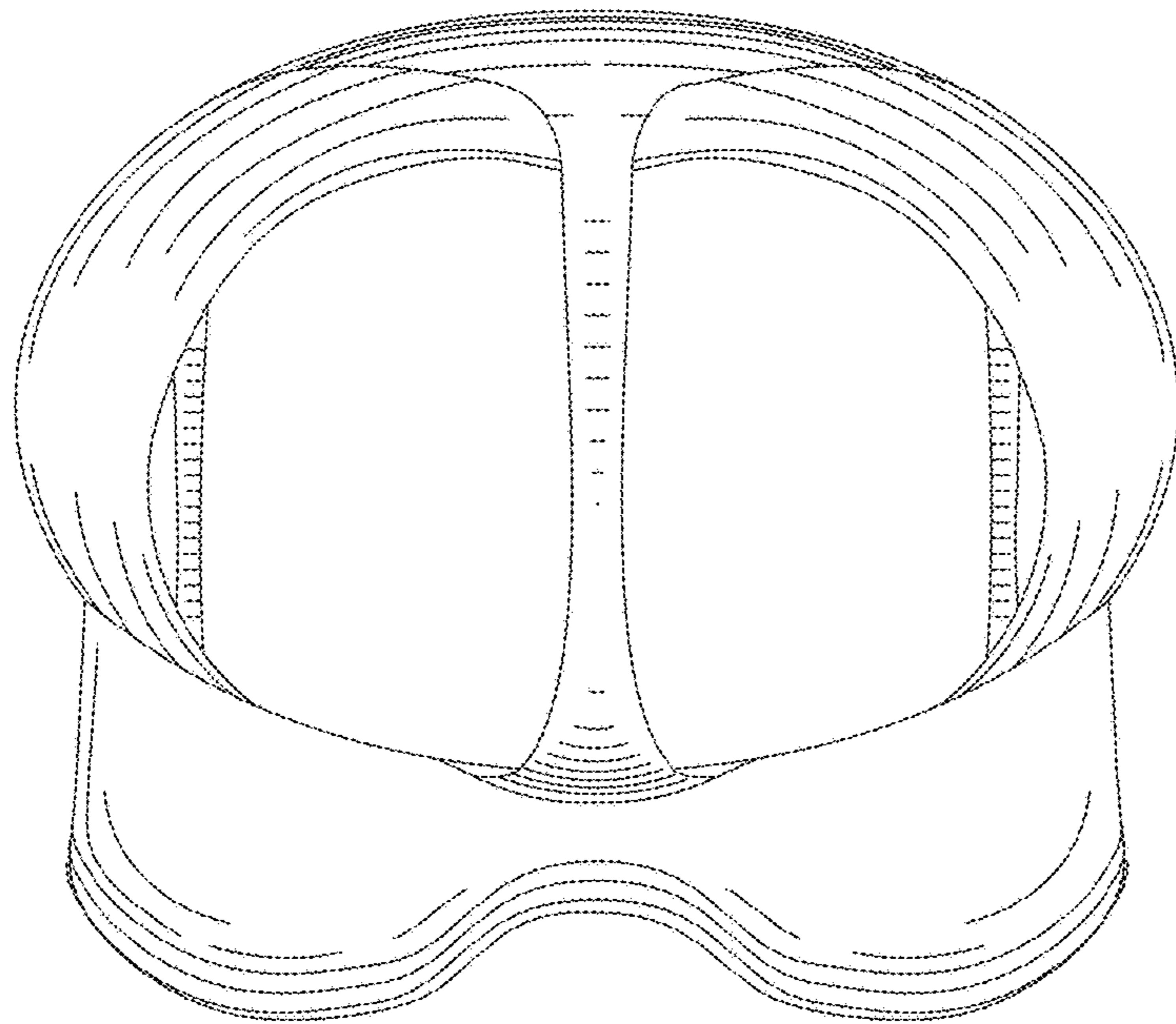

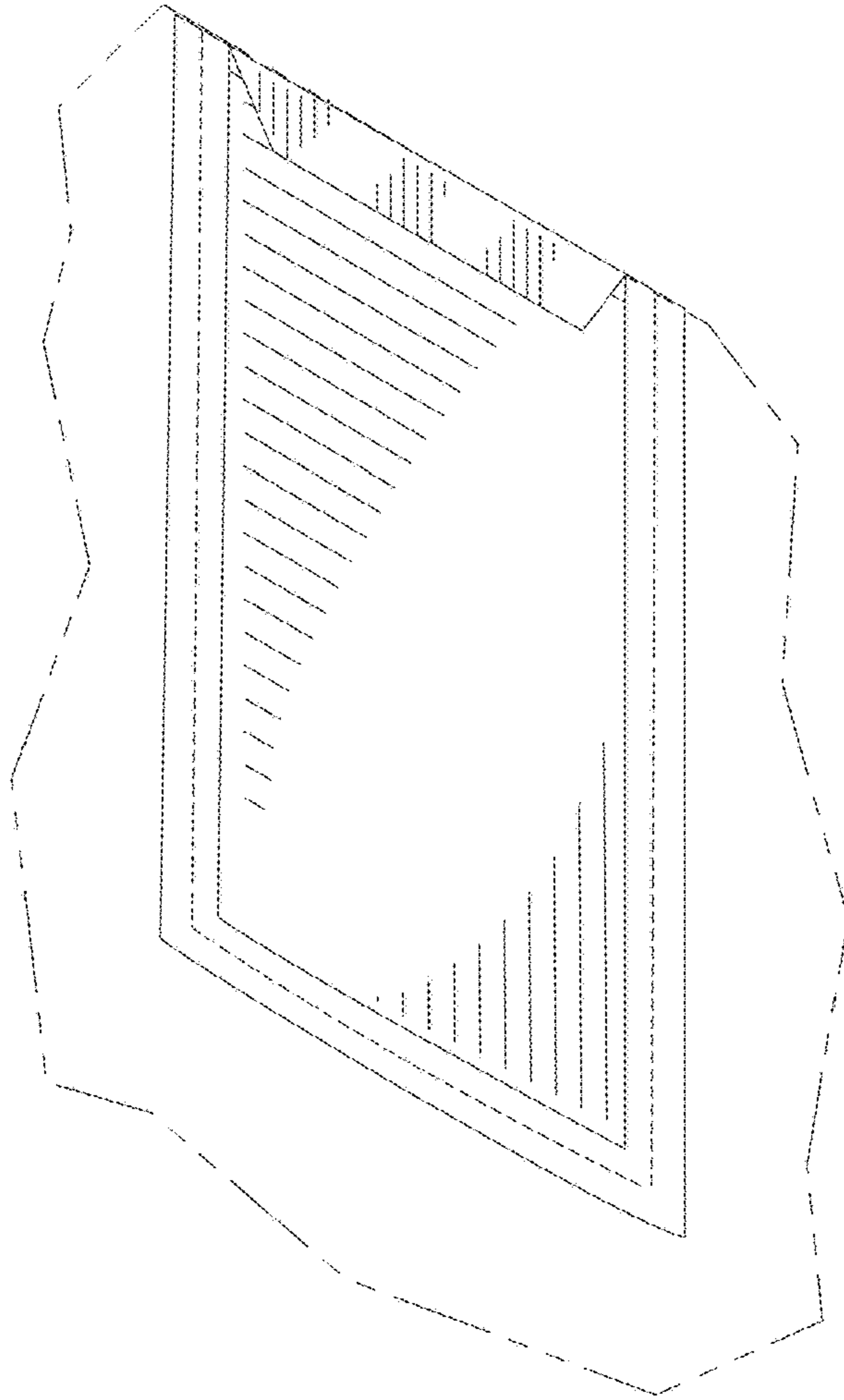
