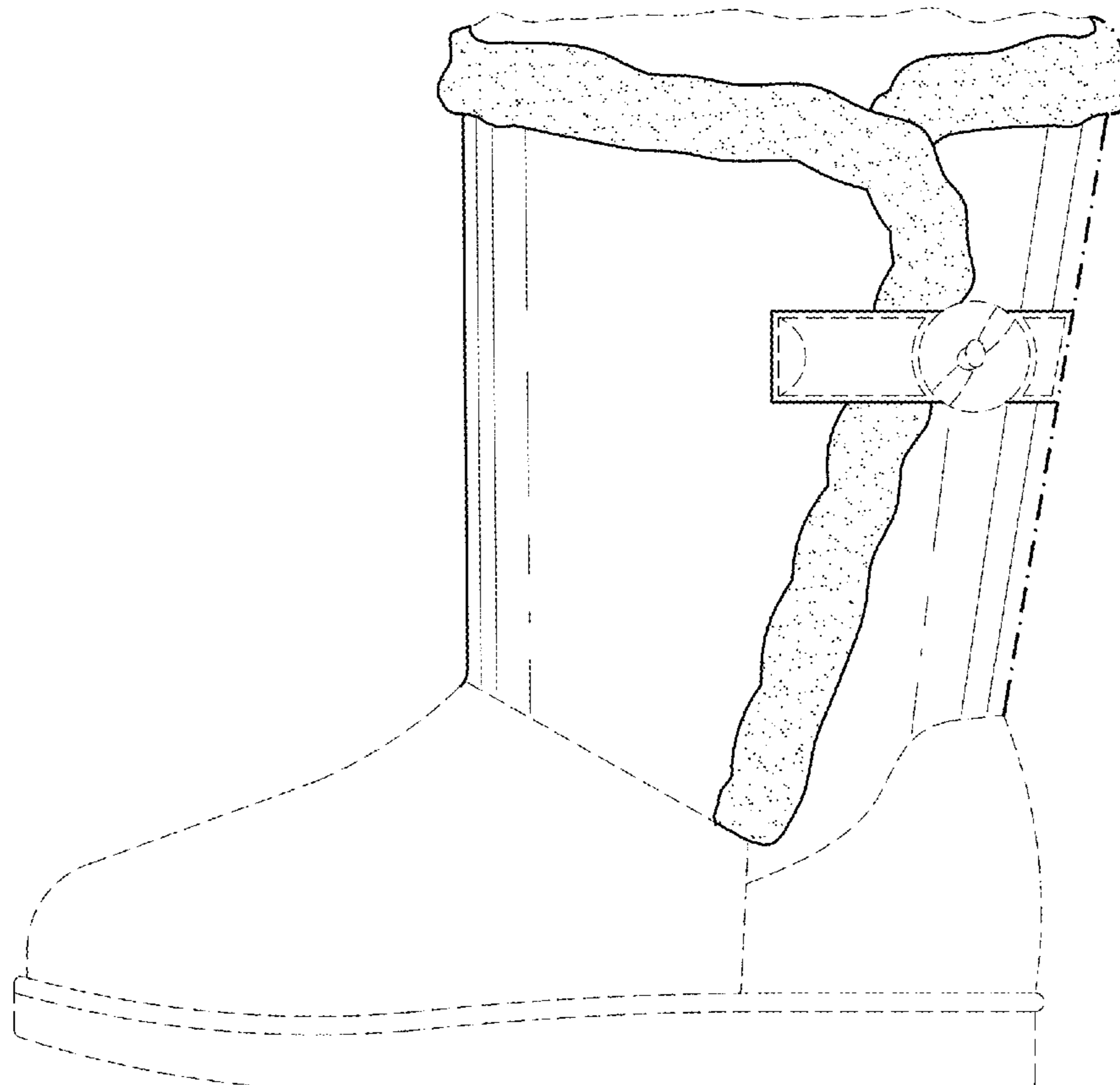
(57) **CLAIM**

The ornamental design for a boot upper, as shown and described.

**DESCRIPTION**

FIG. 1 is a side elevational view of a boot upper according to the present invention; and,  
FIG. 2 is a perspective view of the boot upper.
