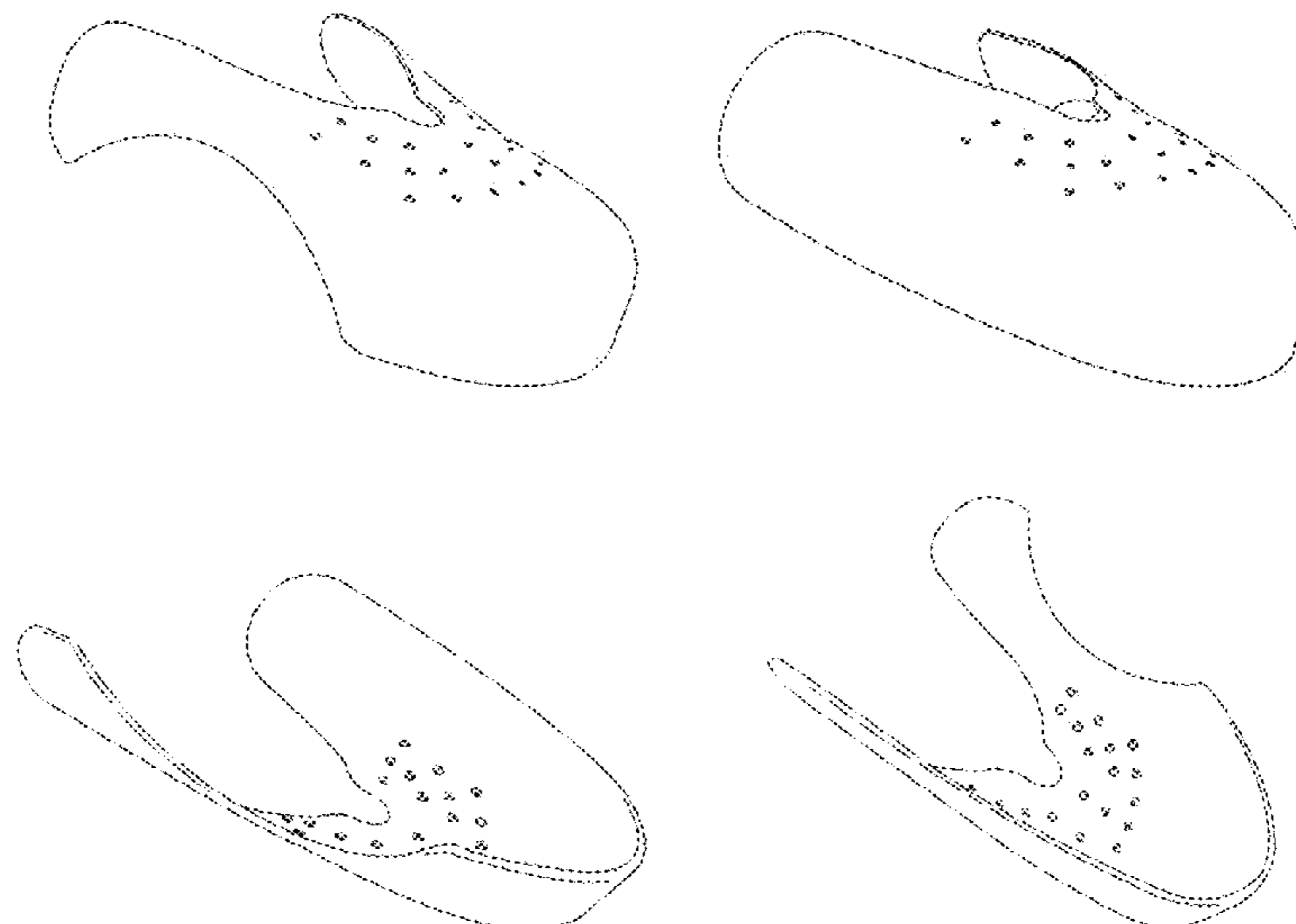
(57) **CLAIM**

We claim the ornamental design for a pair of shoe shapers, as shown and described.

DESCRIPTION

FIG. 1 is a top-right perspective view of a pair of shoe shapers, showing the our design;
 FIG. 2 is a bottom-left perspective view thereof;
 FIG. 3 is a top-left perspective view thereof; and
 FIG. 4 is a bottom-right perspective view thereof.
 FIG. 5 is a top view of the left pair of shoe shapers of FIG. 1;
 FIG. 6 is a front view thereof;
 FIG. 7 is a left side view thereof; and
 FIG. 8 is a right side view thereof.
 FIG. 9 is a top view of the right pair of shoe shapers of FIG. 1;
 FIG. 10 is a front view thereof;
 FIG. 11 is a left side view thereof; and
 FIG. 12 is a right side view thereof.
 FIG. 13 is a bottom view of the pair of shoe shapers of FIG. 1; and,
 FIG. 14 is a back view thereof.
 The symmetric left and the right sides of the pair of shoe shapers are being shown separately in FIGS. 6 through 12 for convenience of illustration.

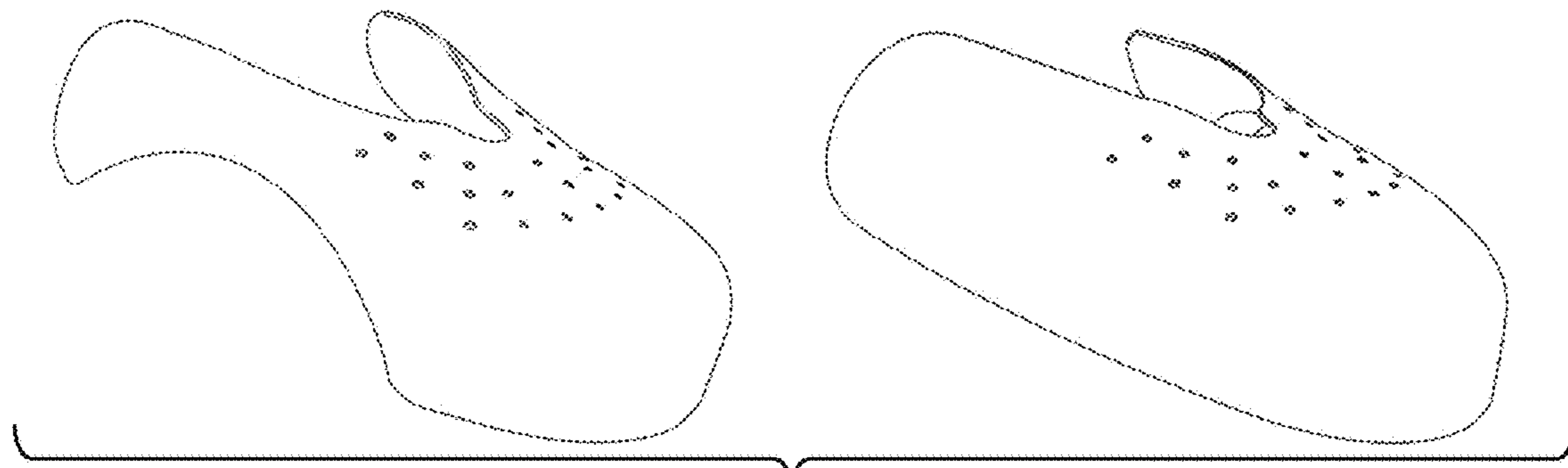

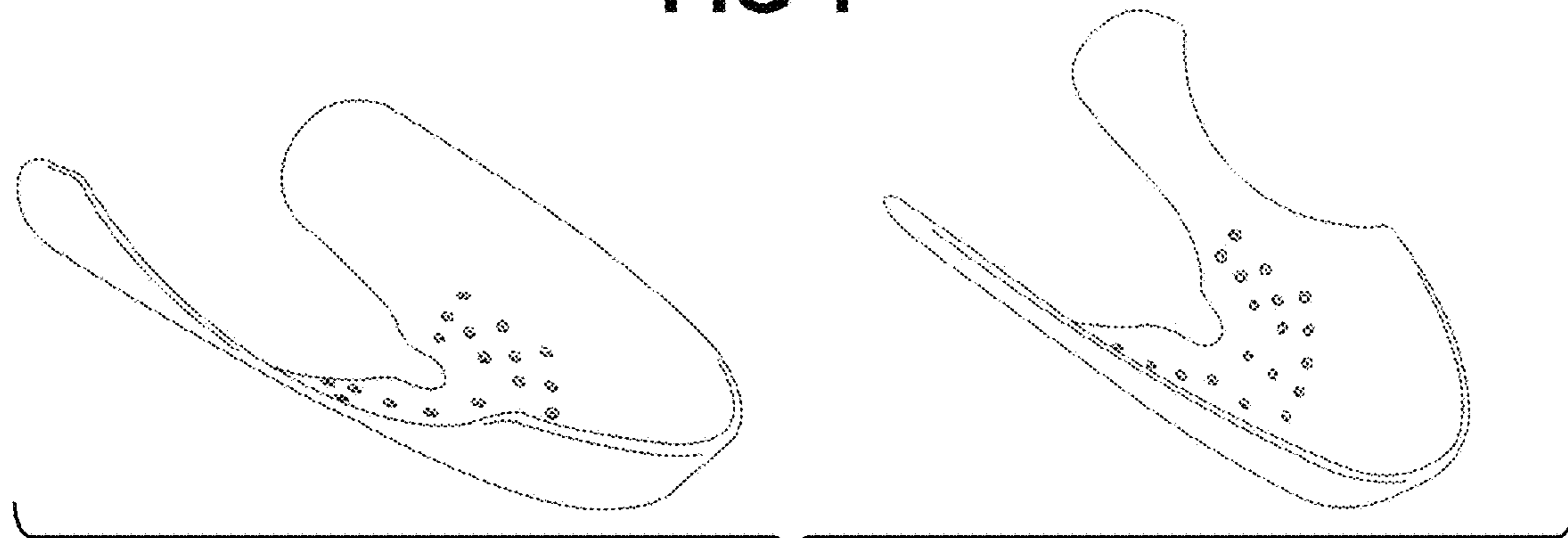

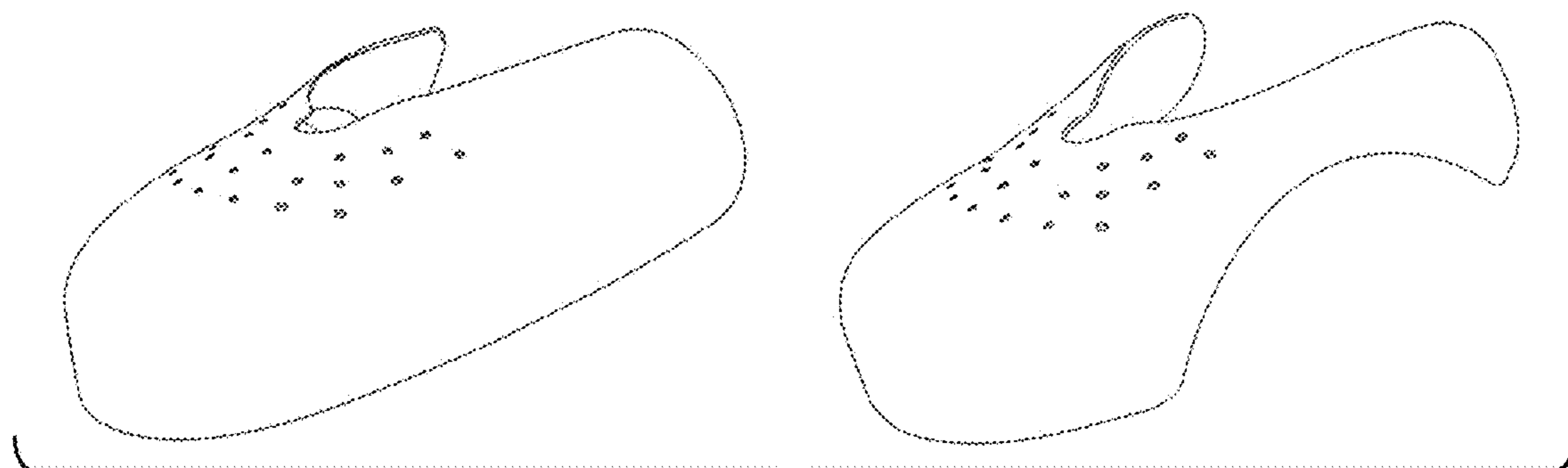

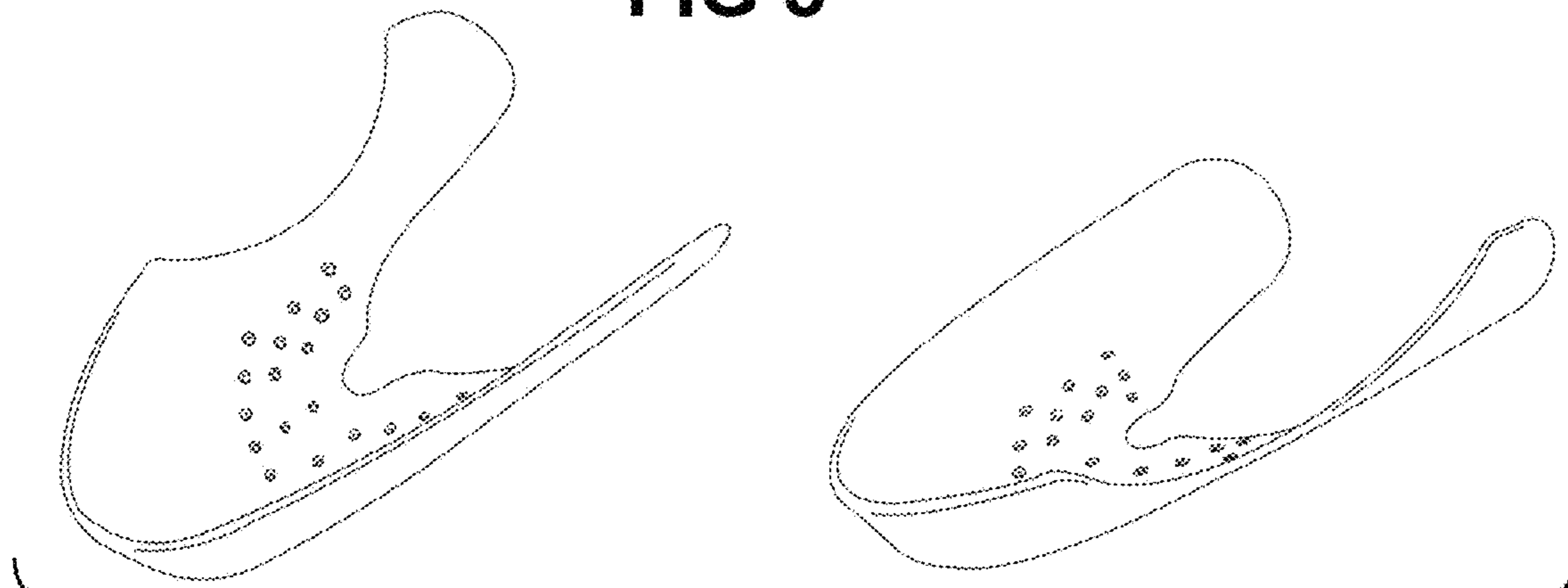

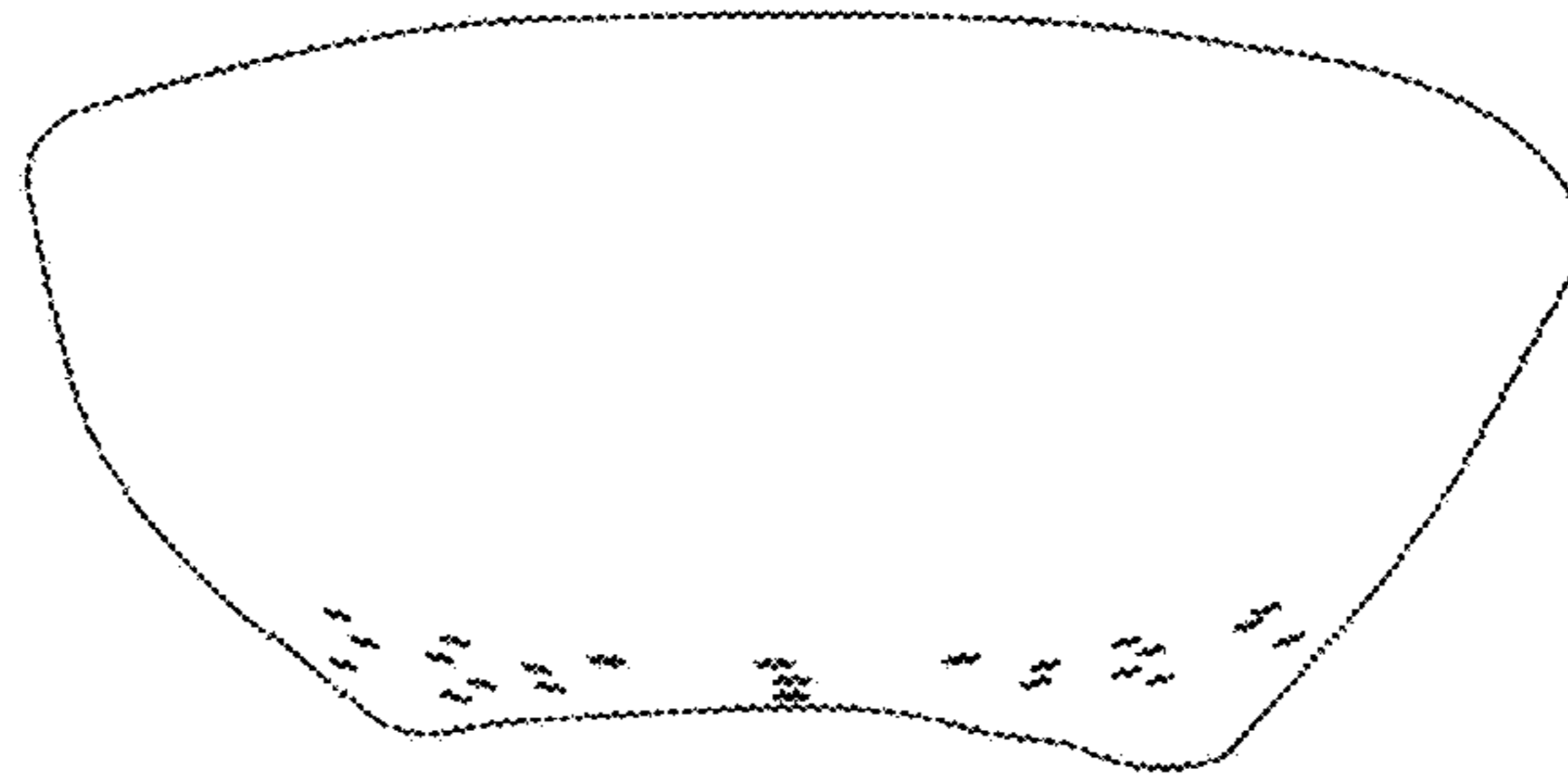

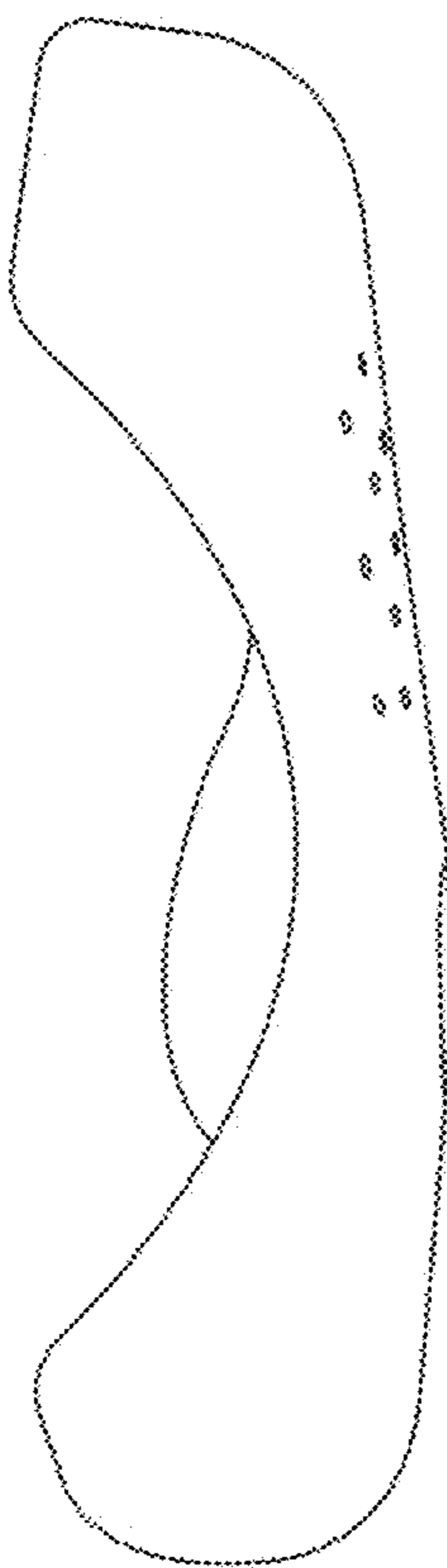

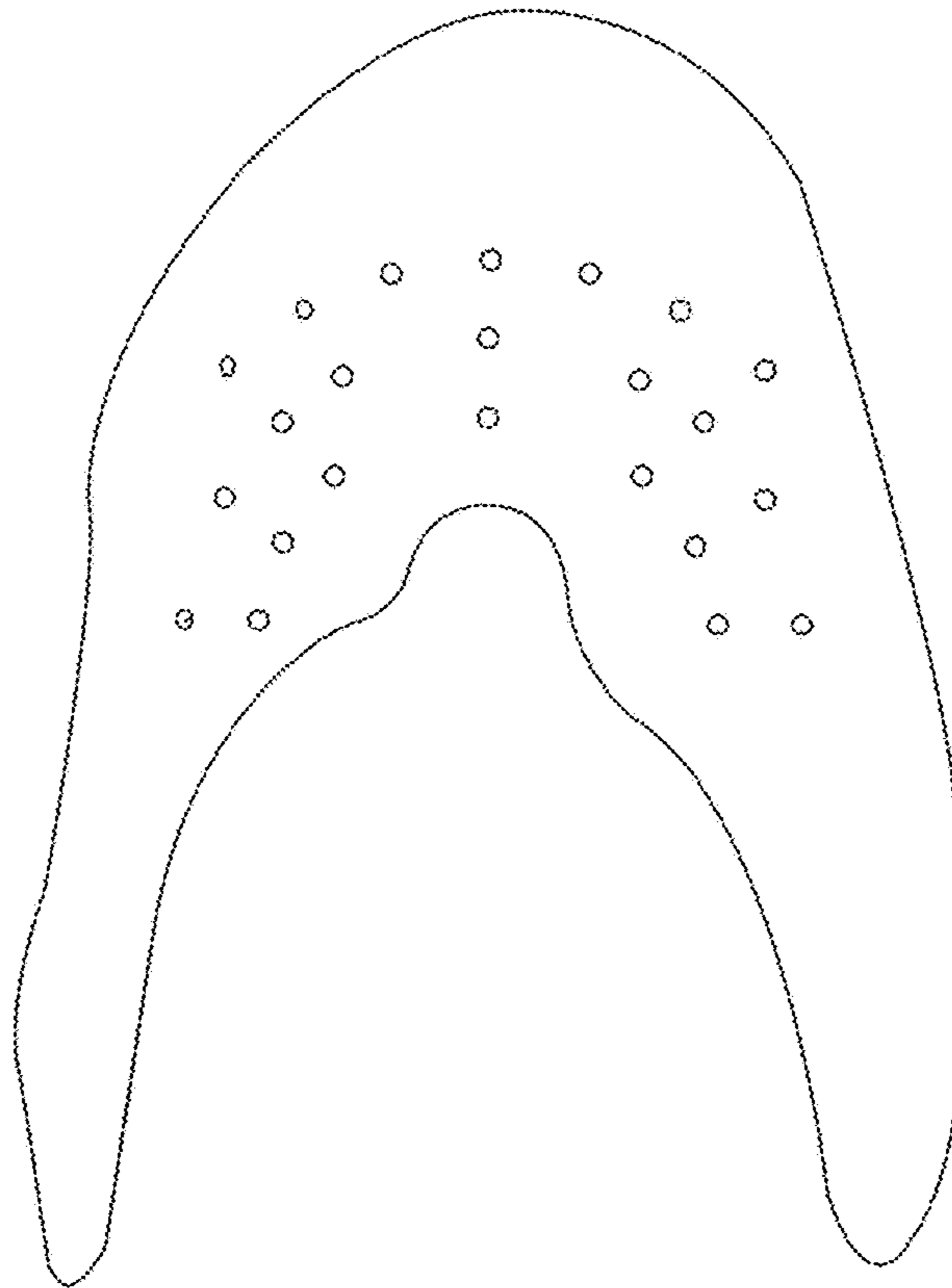

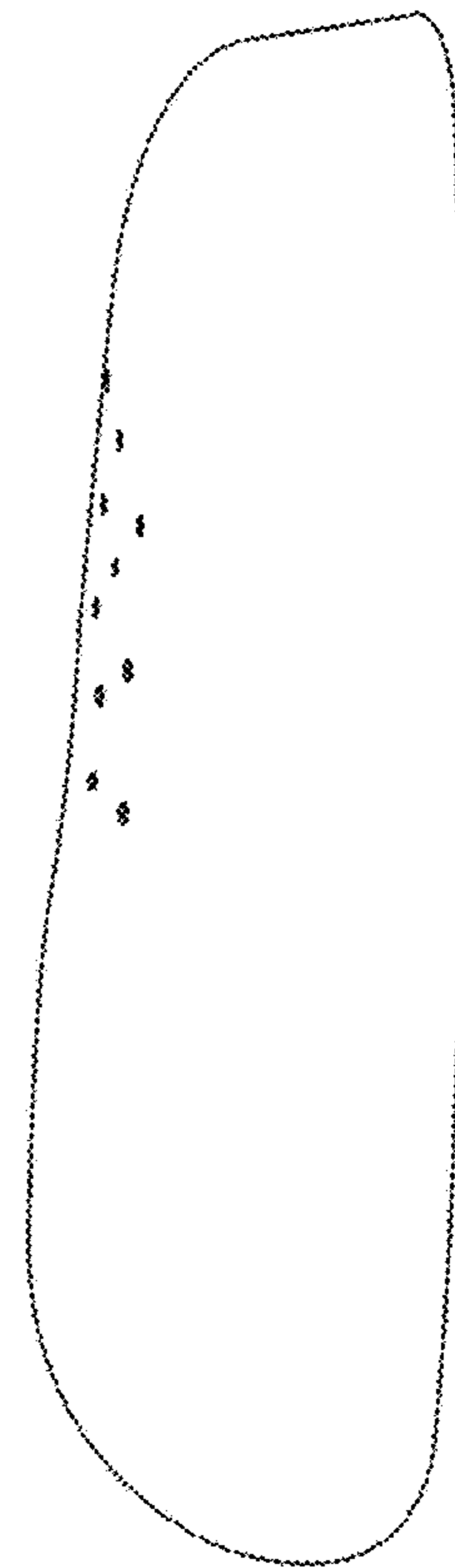

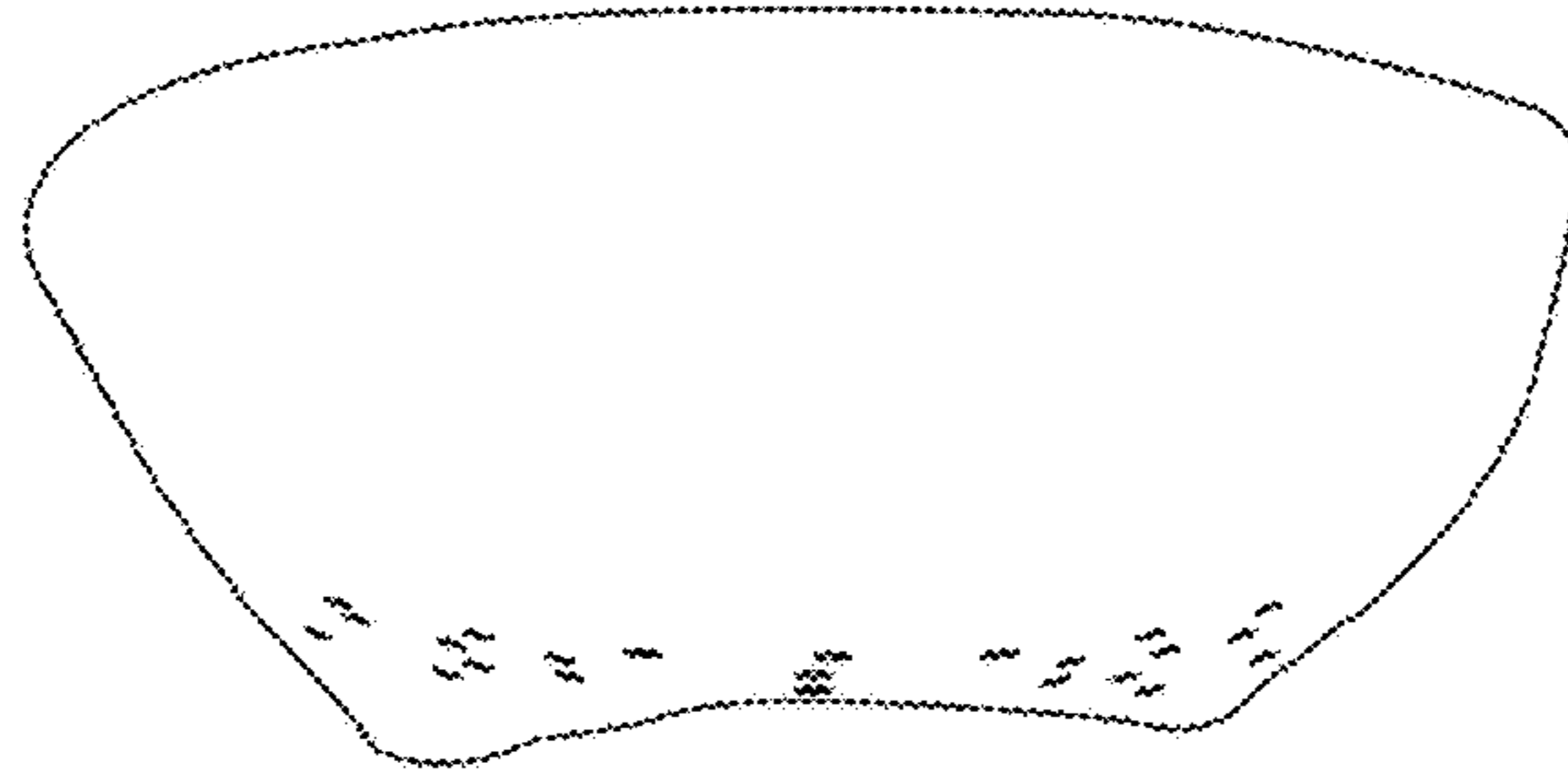

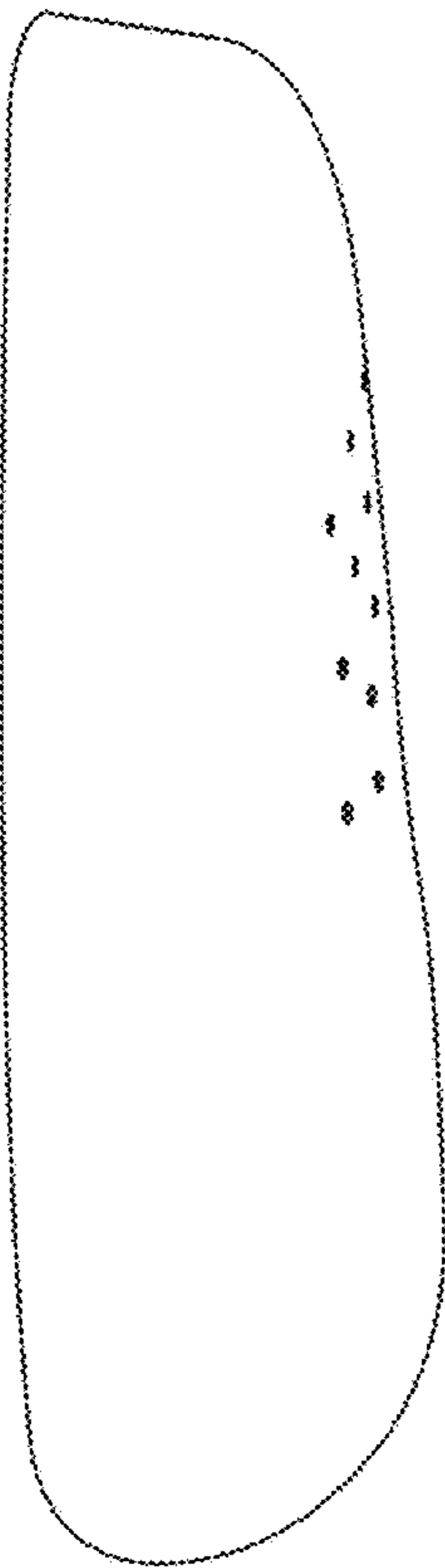

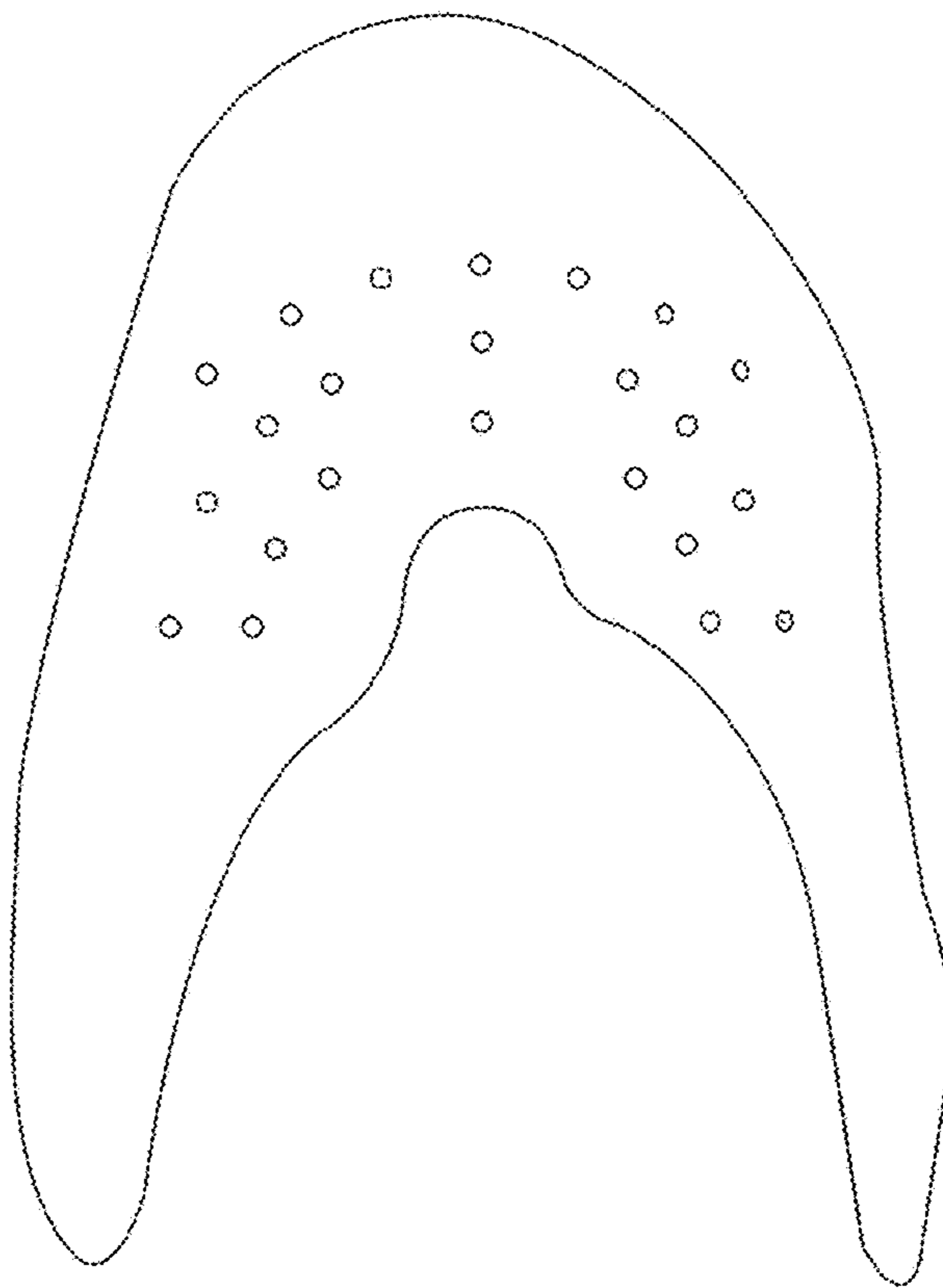

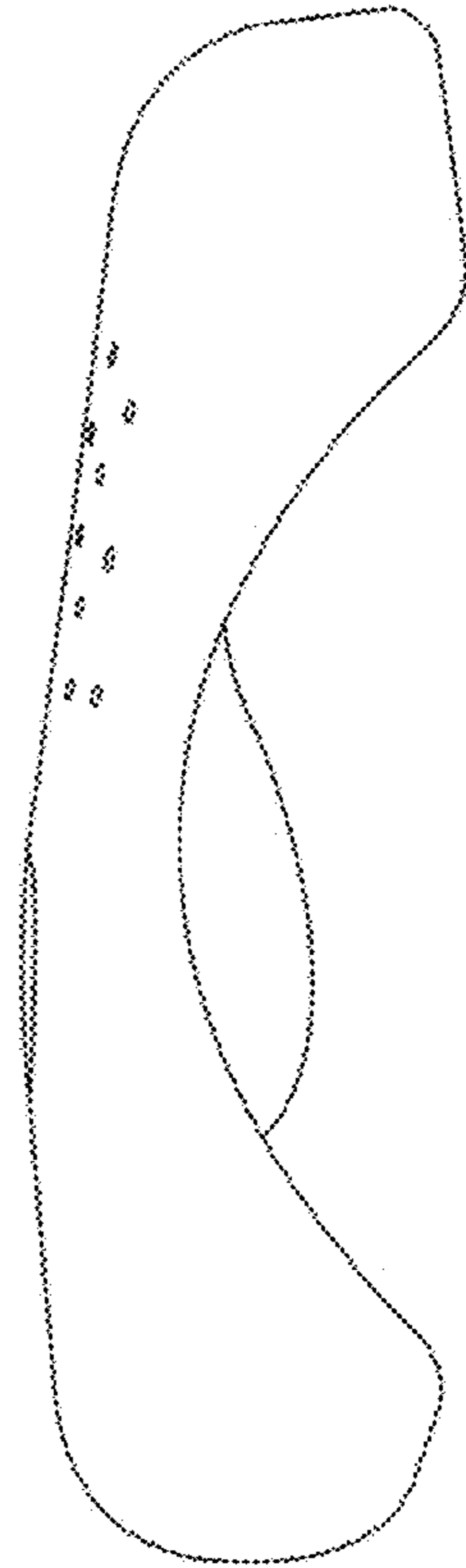

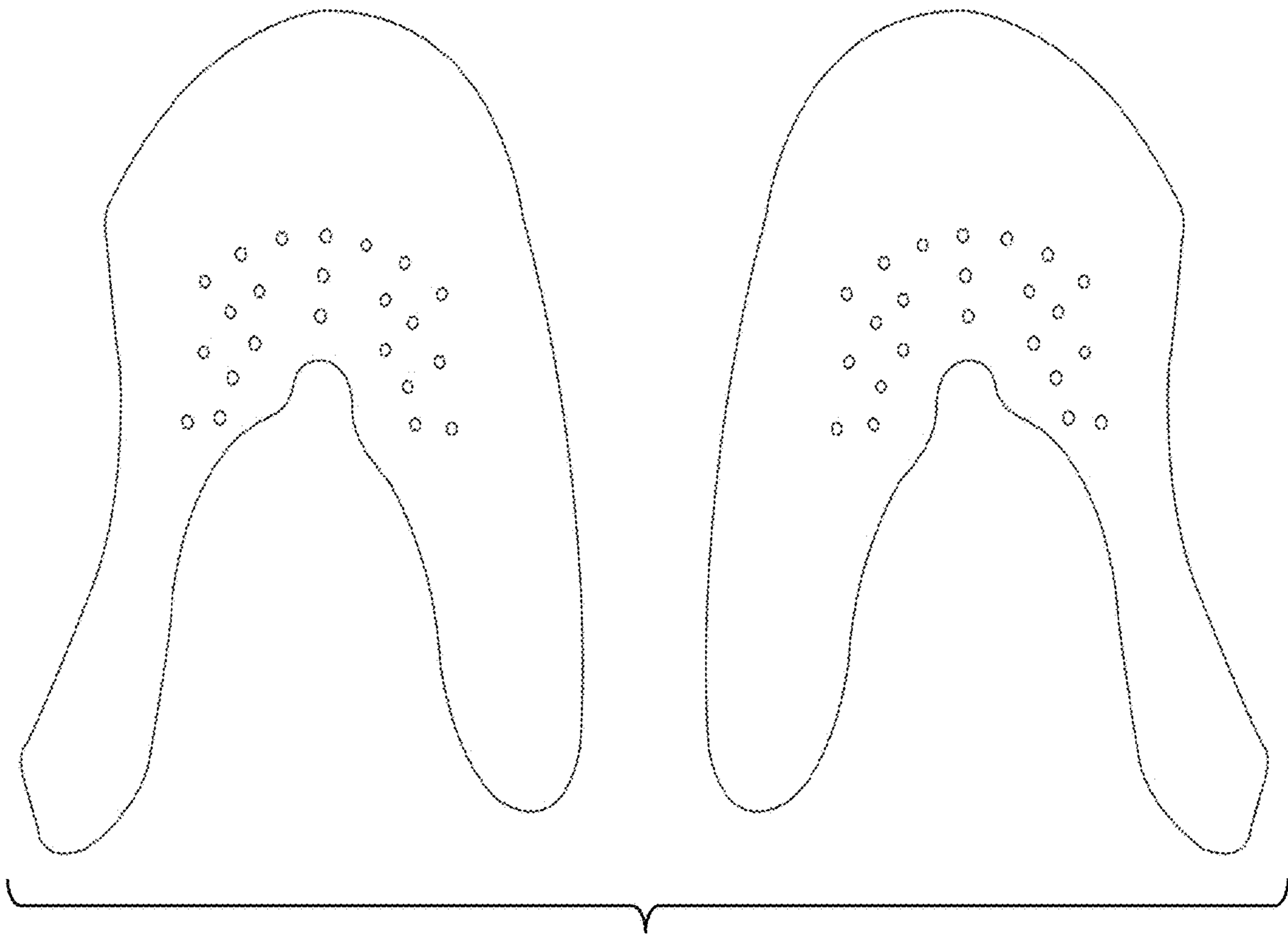

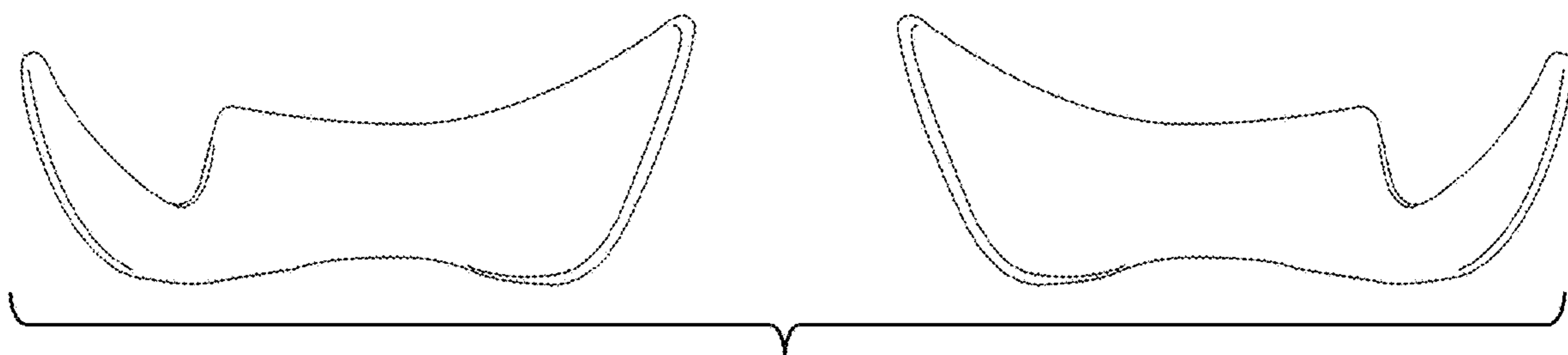
