The ornamental design for a handbag hardware, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a handbag hardware showing our new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a right side elevational view thereof;  
FIG. 5 is a left side elevational view thereof;  
FIG. 6 is a top plan view thereof;  
FIG. 7 is a bottom plan view thereof;  
FIG. 8 is another perspective view thereof; and,  
FIG. 9 is yet another perspective view thereof.  
The broken lines shown in FIGS. 1-9 illustrate unclaimed portions of the handbag hardware and form no part of the claimed design.

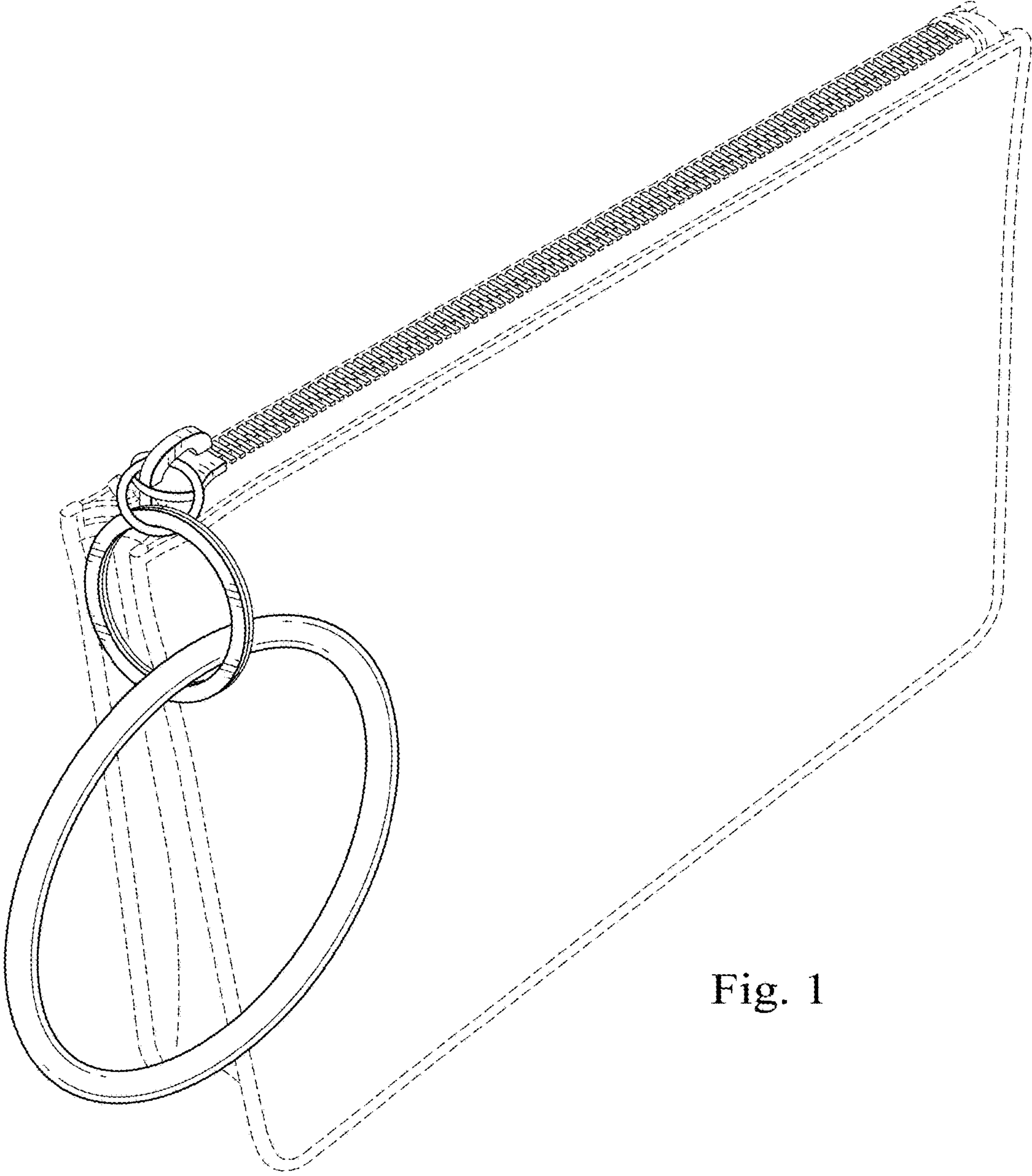

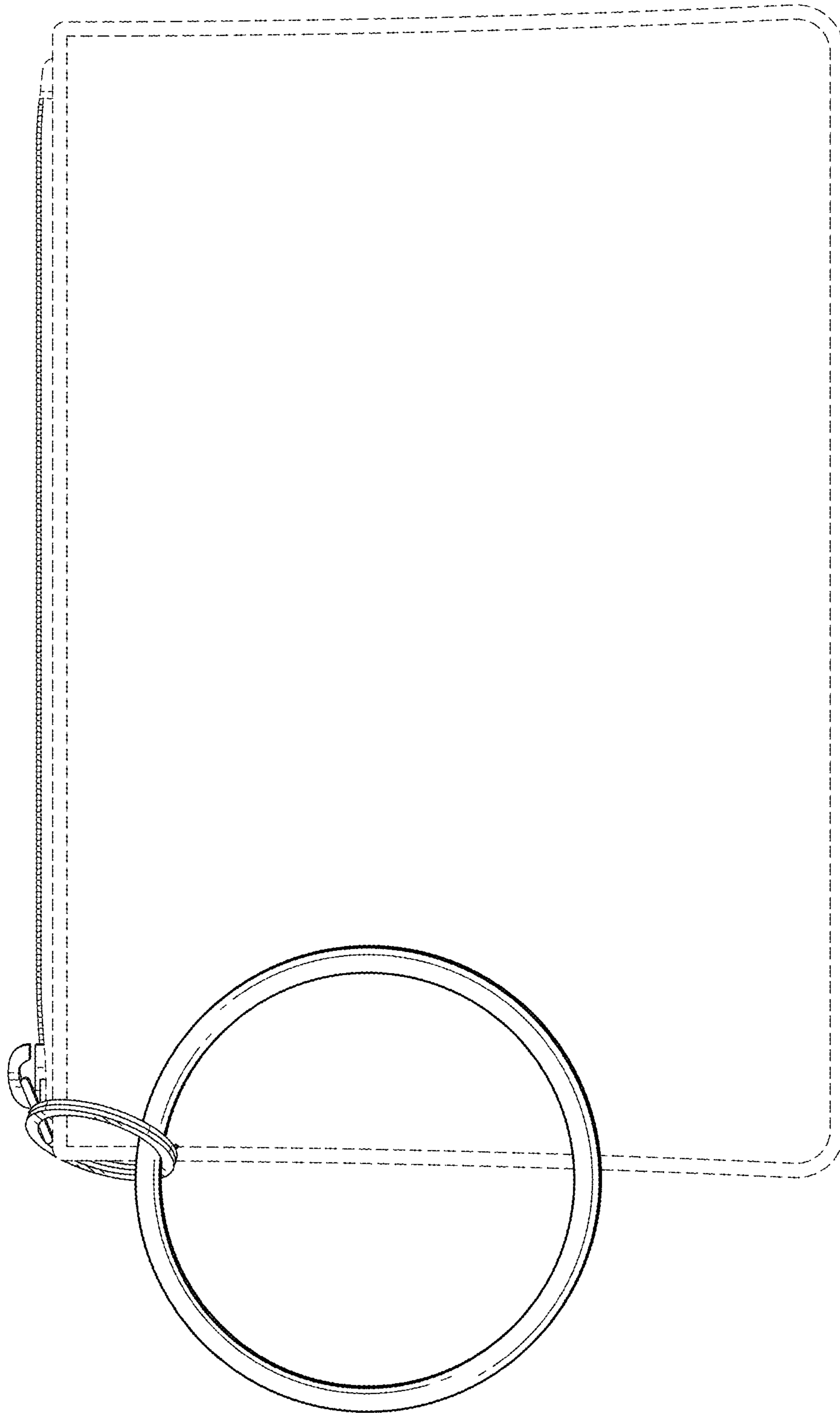

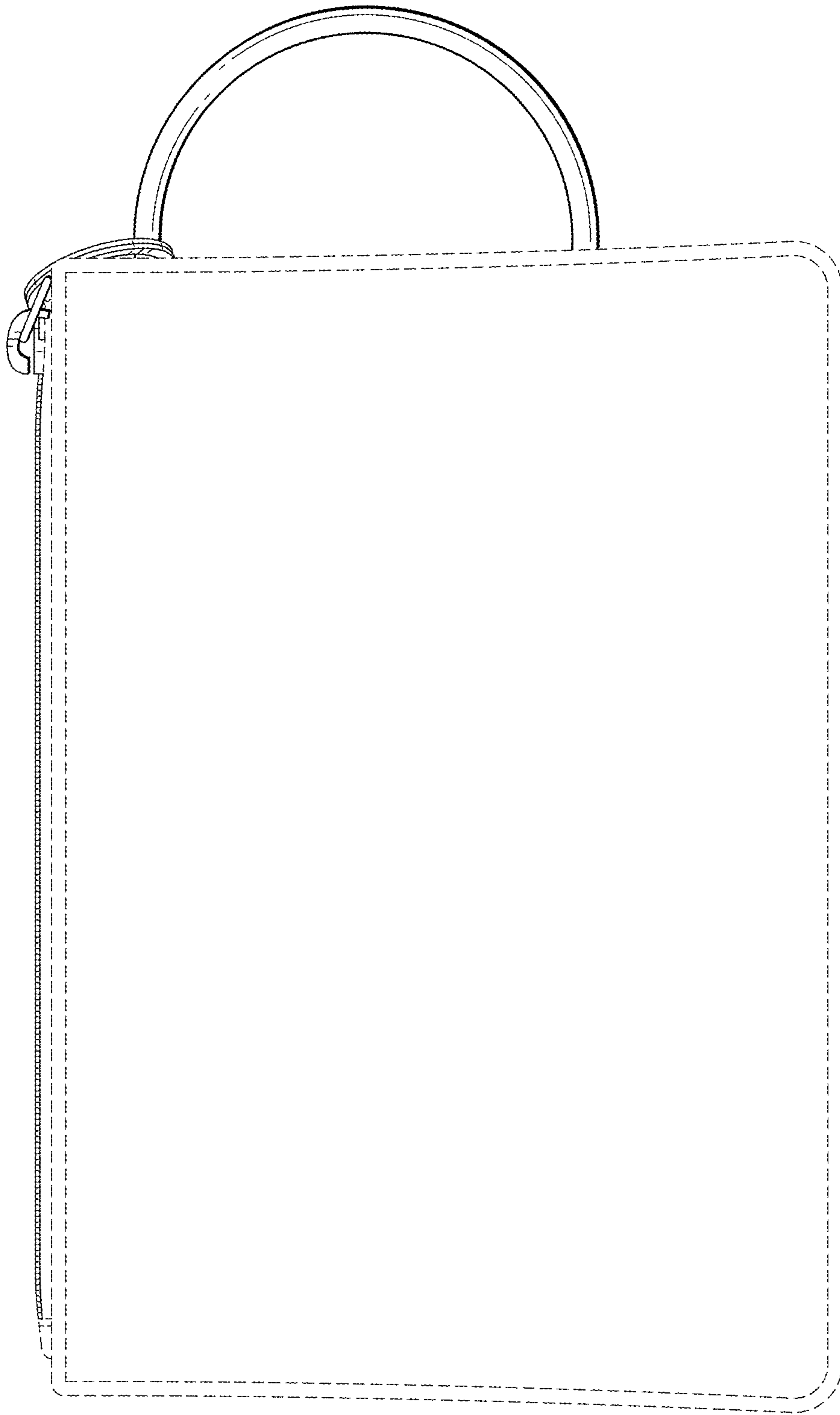

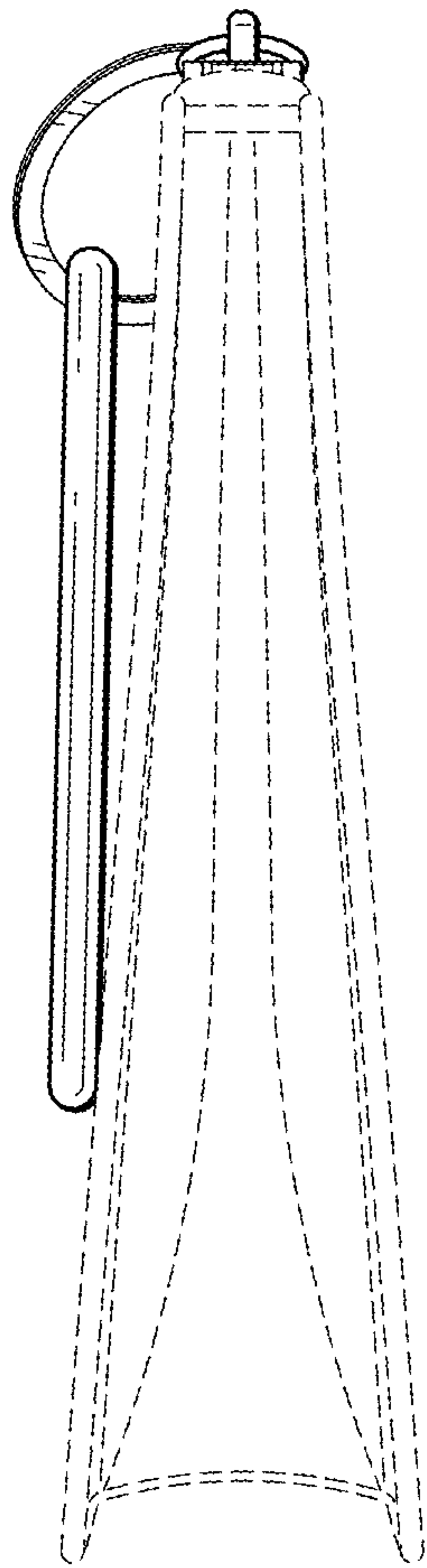

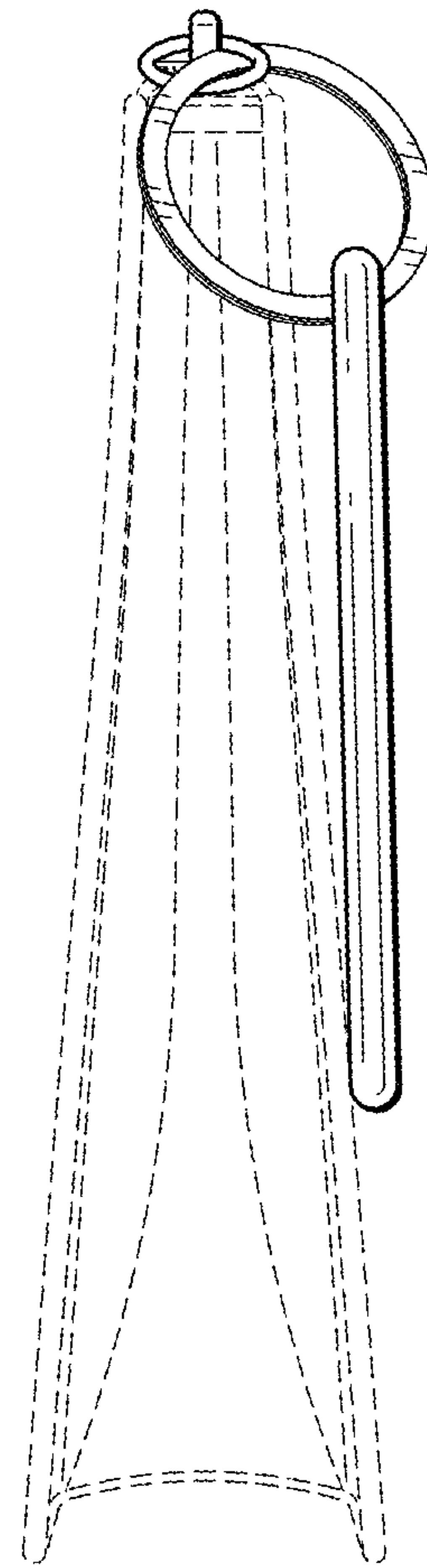

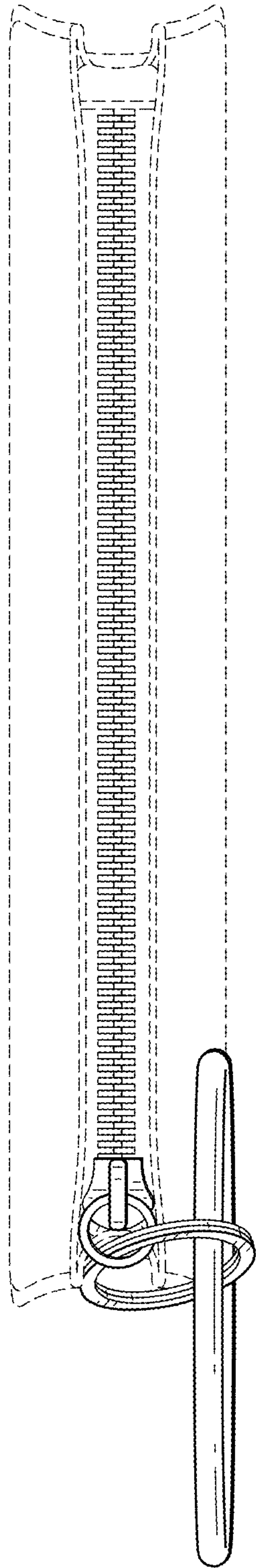

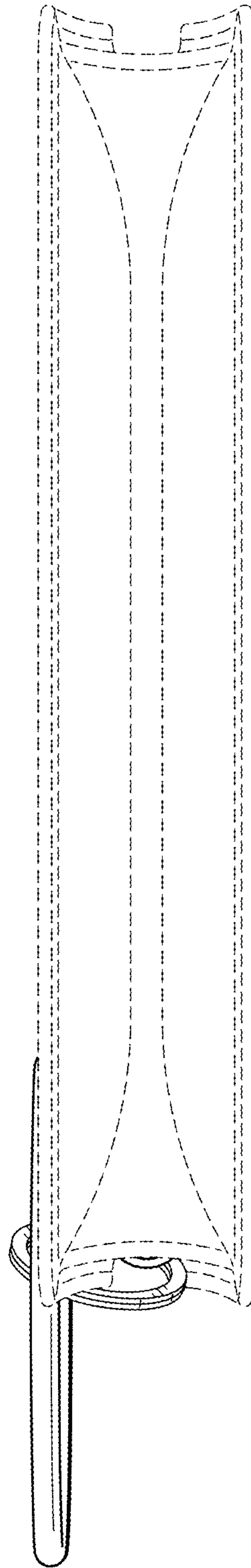

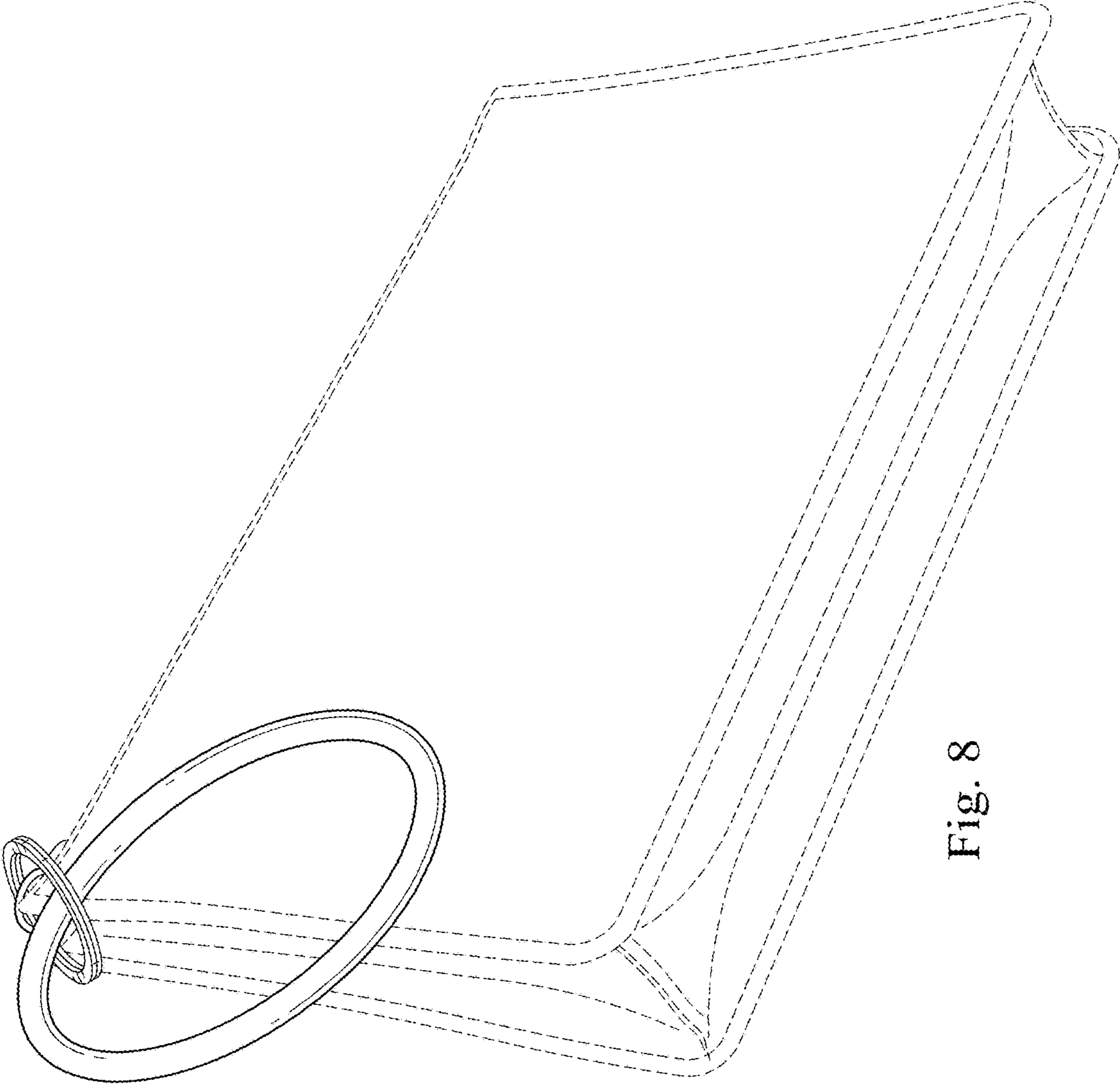

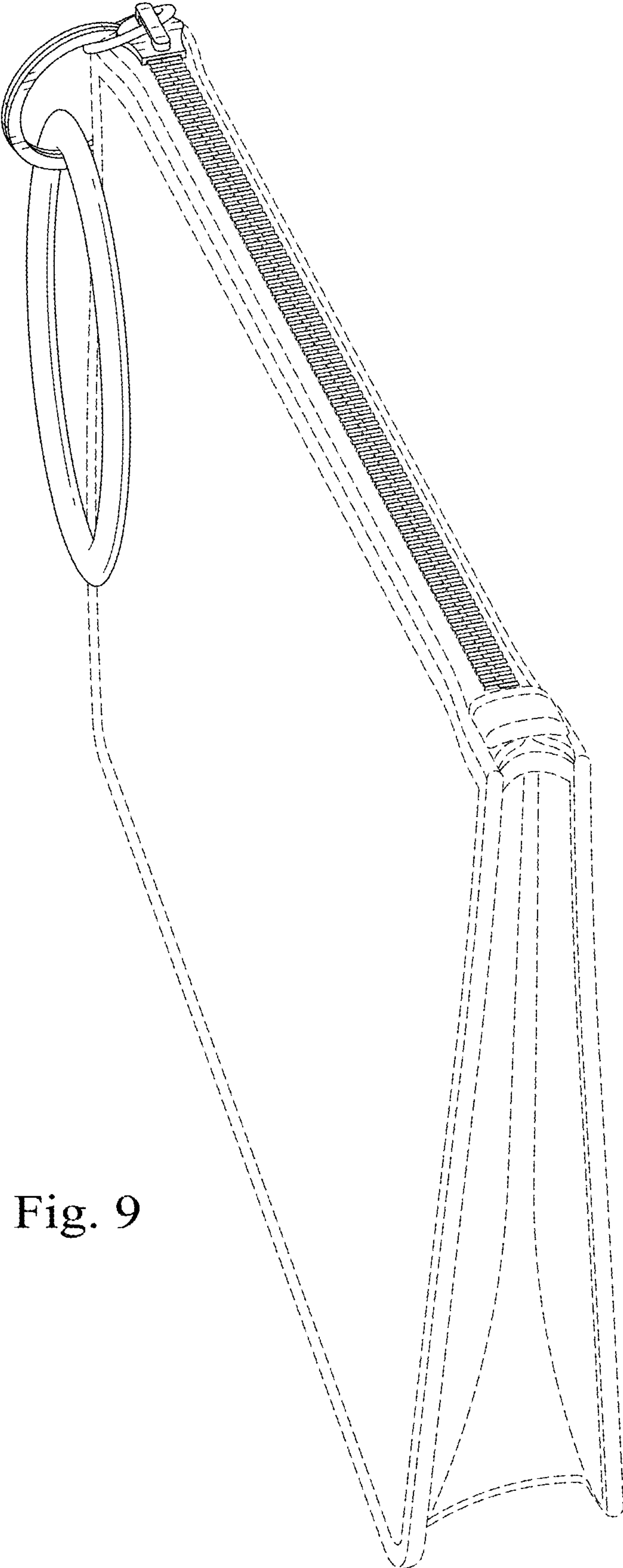
